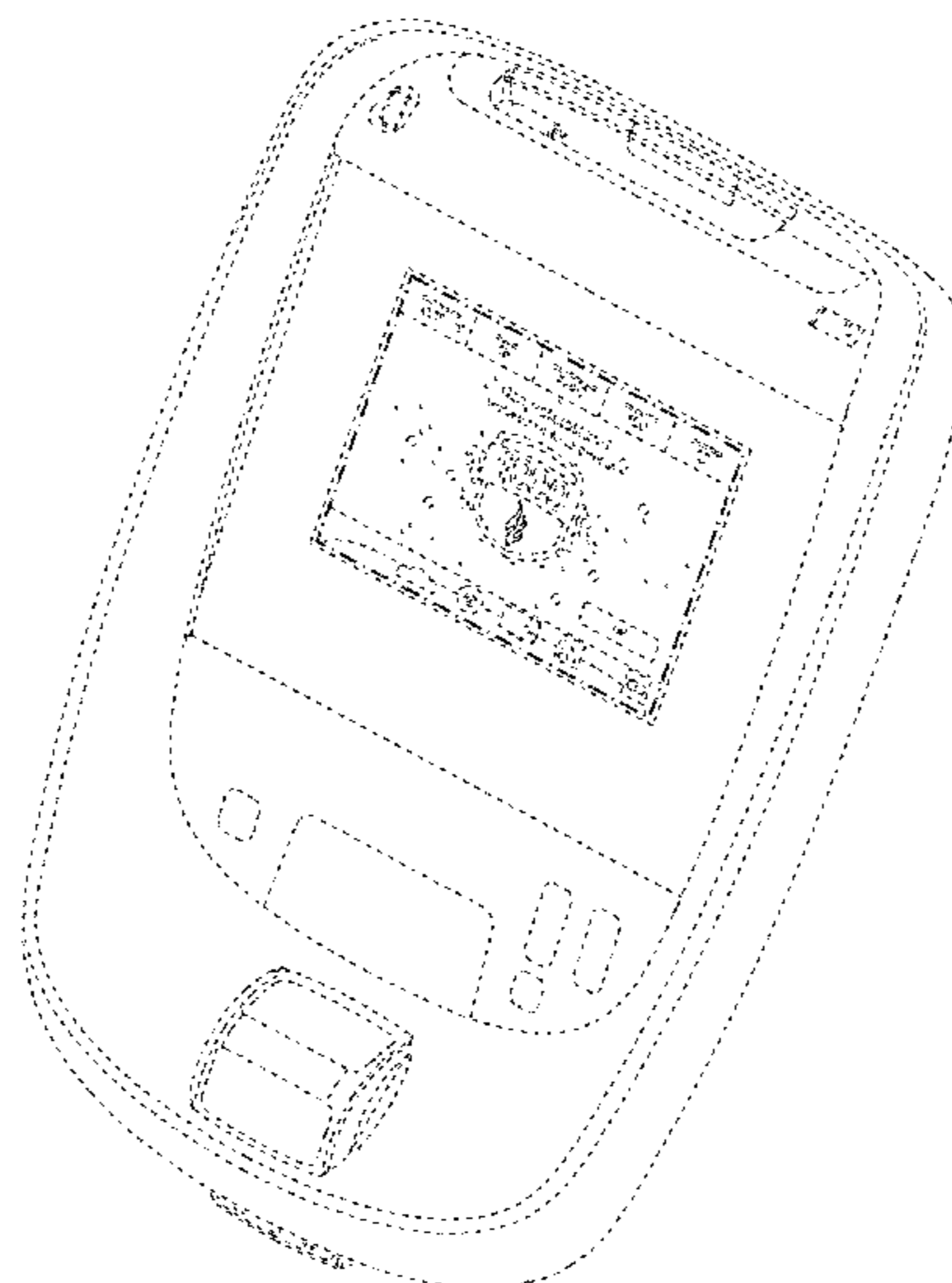
We claim the ornamental design for fitness equipment display screen with icon, as shown and described.

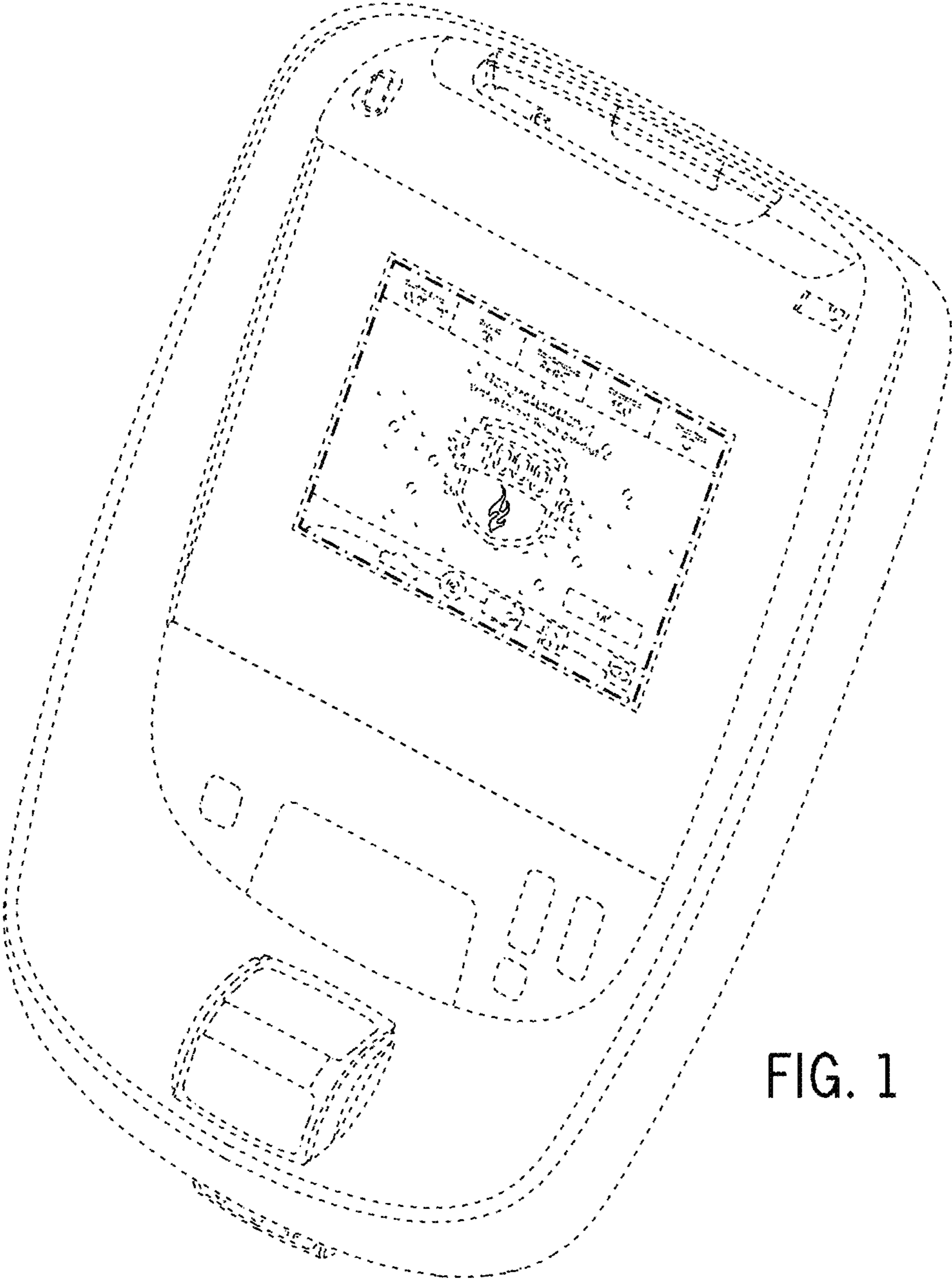

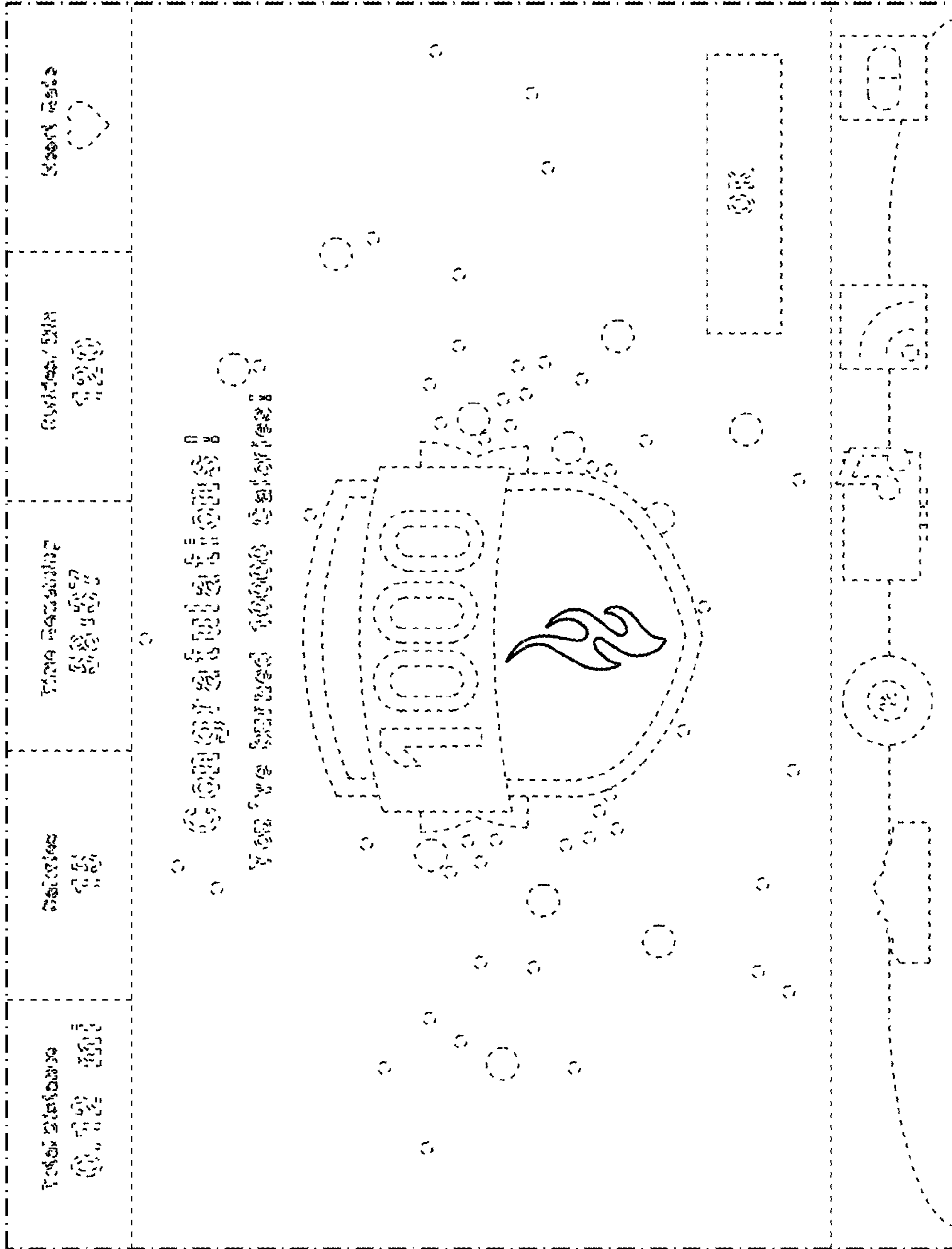
