(57) **CLAIM**

The ornamental design for a display panel or screen with a graphical user interface, as shown and described.

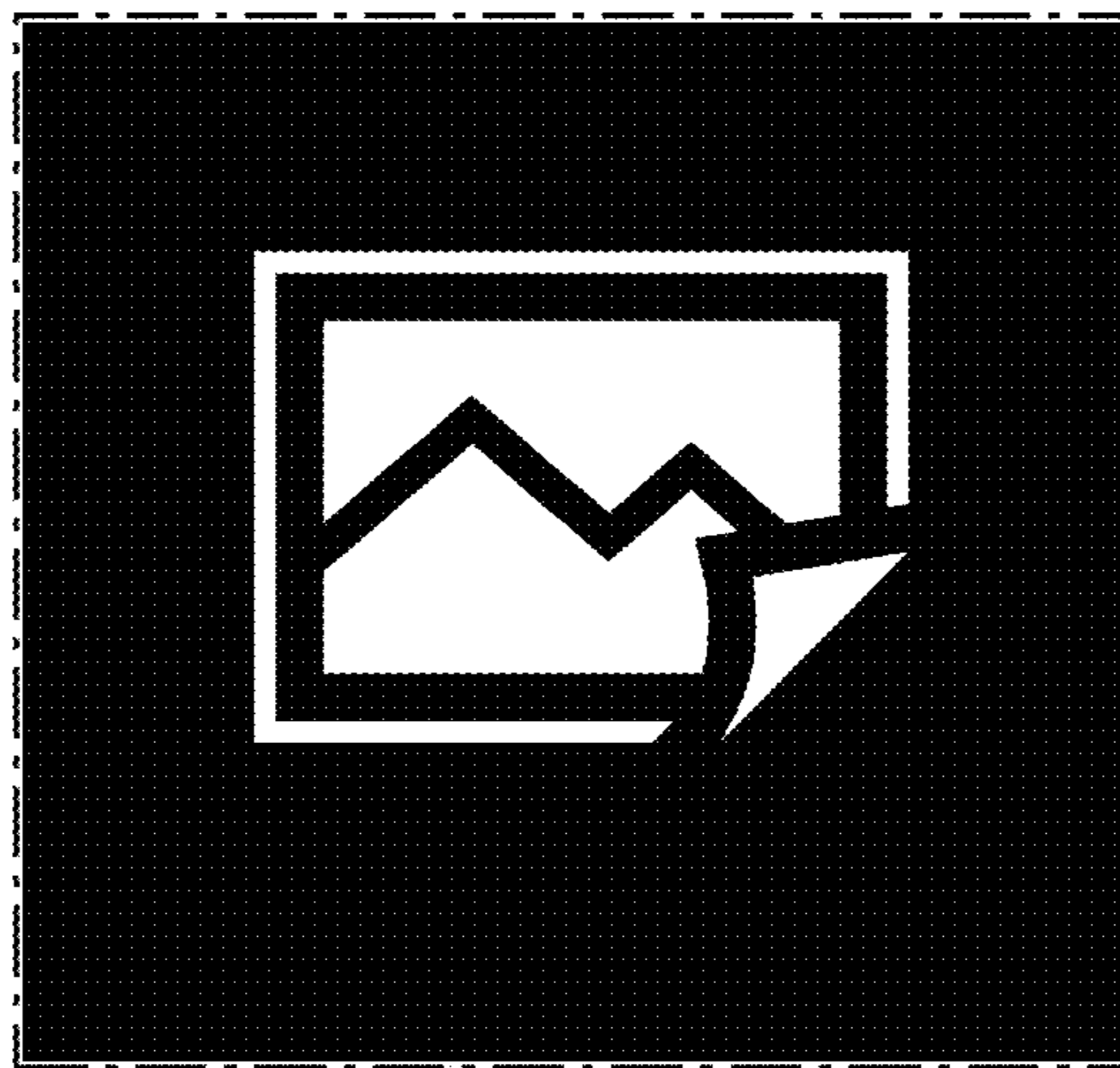
