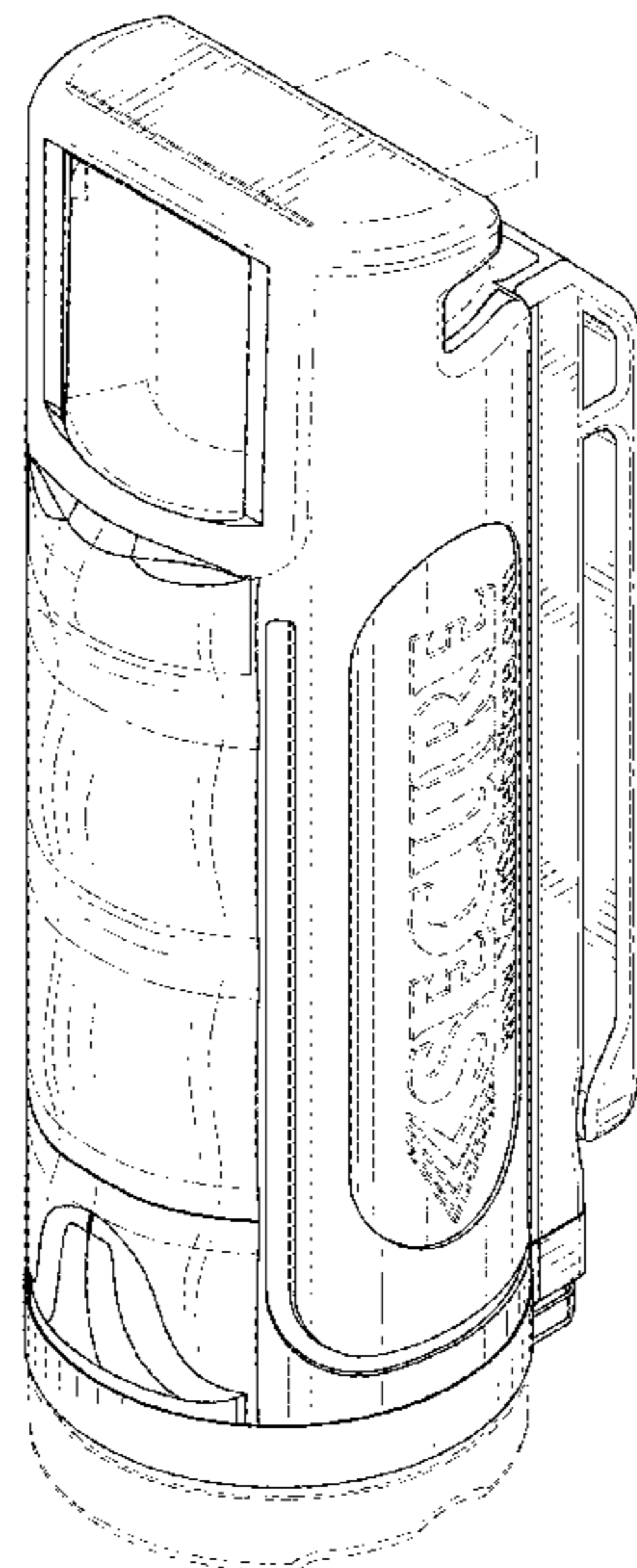
(57) **CLAIM**

The ornamental design for the case for handheld finger grip aerosol dispenser, shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an case for handheld finger grip aerosol dispenser according to the invention; FIG. 2 is a front view of the case for handheld finger grip aerosol dispenser of FIG. 1; FIG. 3 is rear view of the case for handheld finger grip aerosol dispenser of FIG. 1; FIG. 4 is a right-side view of the case for handheld finger grip aerosol dispenser of FIG. 1; FIG. 5 is a left-side view of the case for handheld finger grip aerosol dispenser of FIG. 1; FIG. 6 is a top-plan view of the case for handheld finger grip aerosol dispenser of FIG. 1; and, FIG. 7 is a bottom-plan view of the case for handheld finger grip aerosol dispenser of FIG. 1. 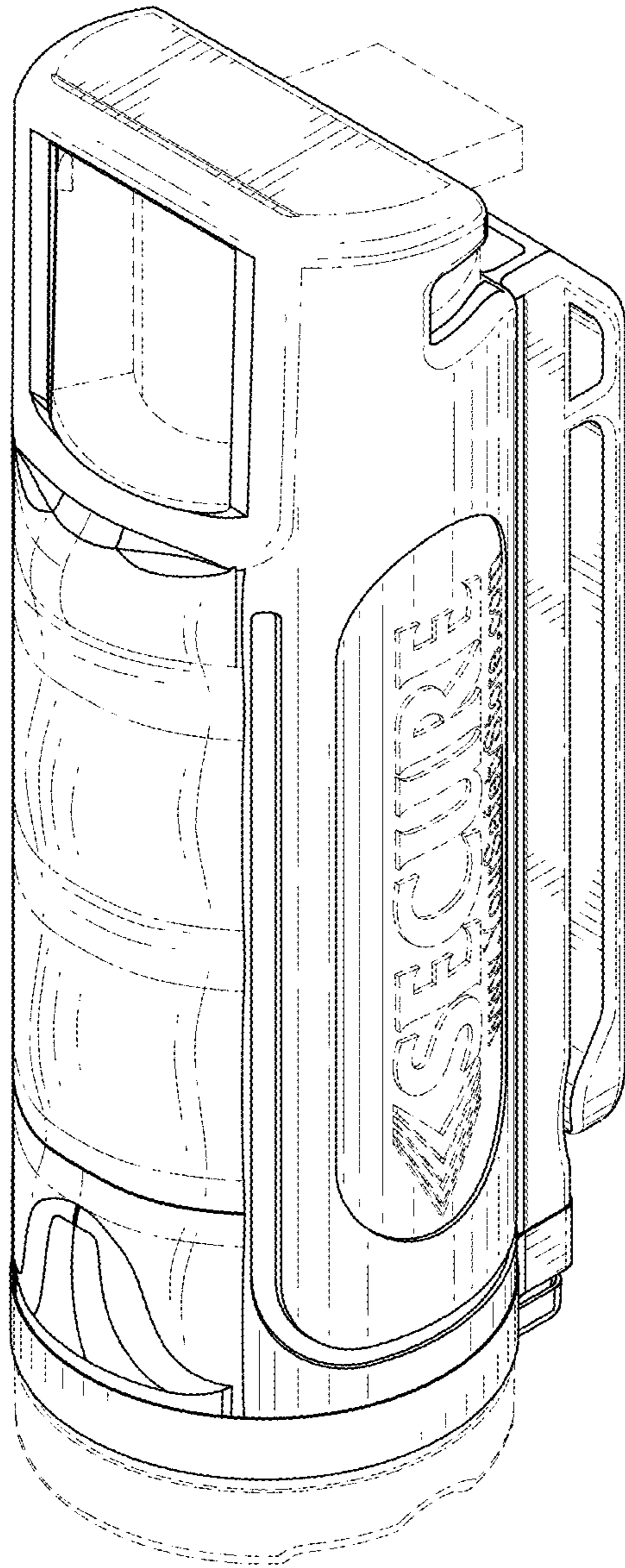

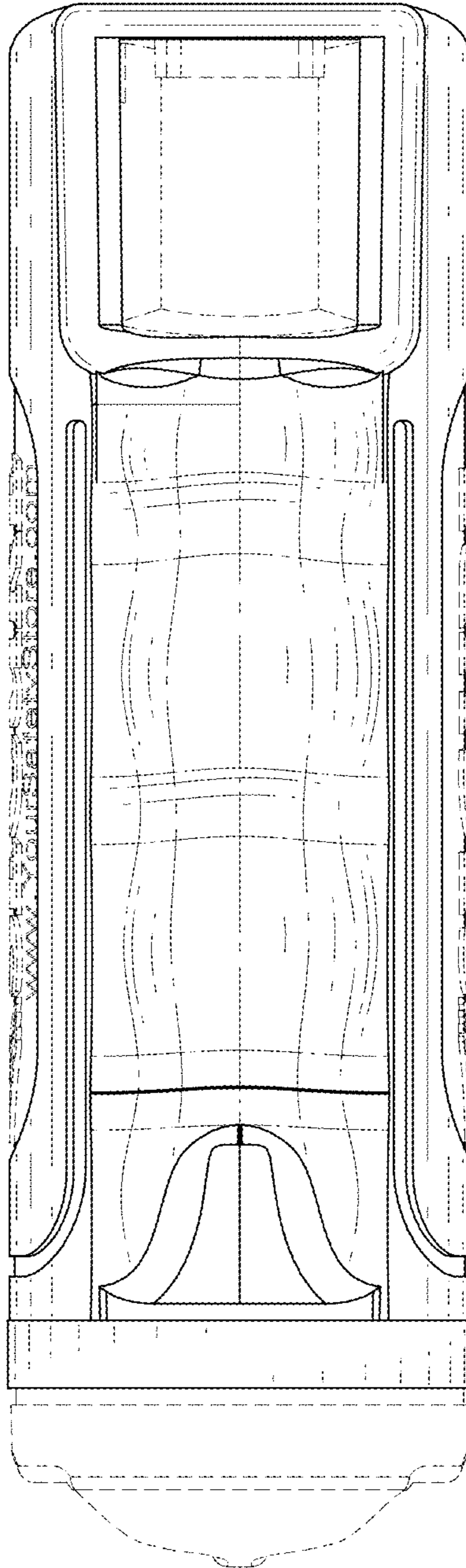

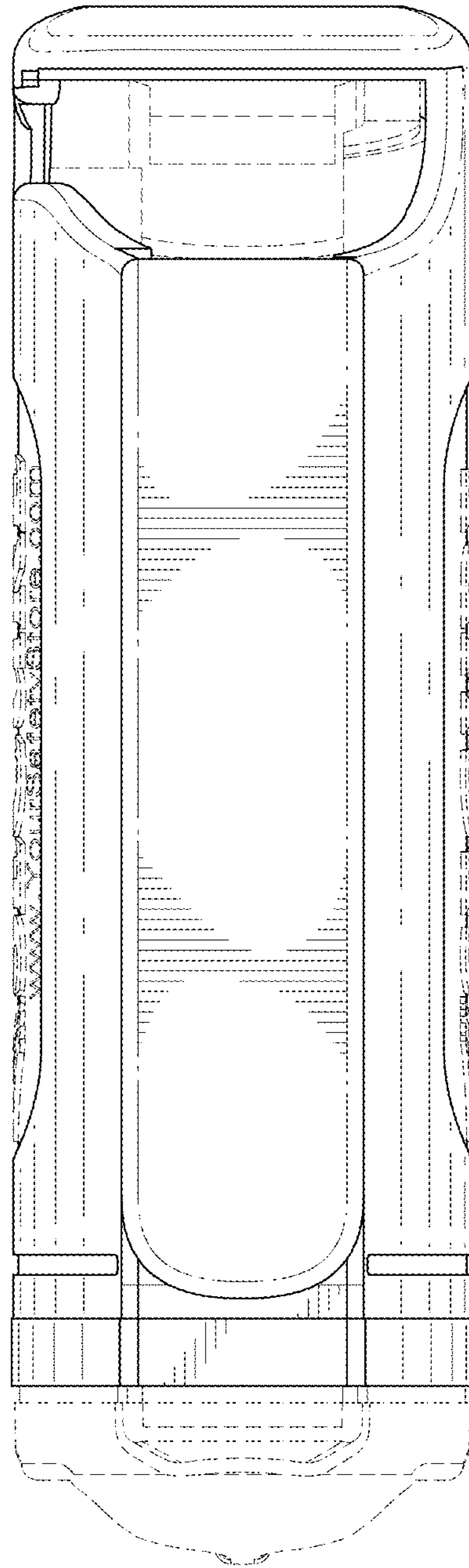

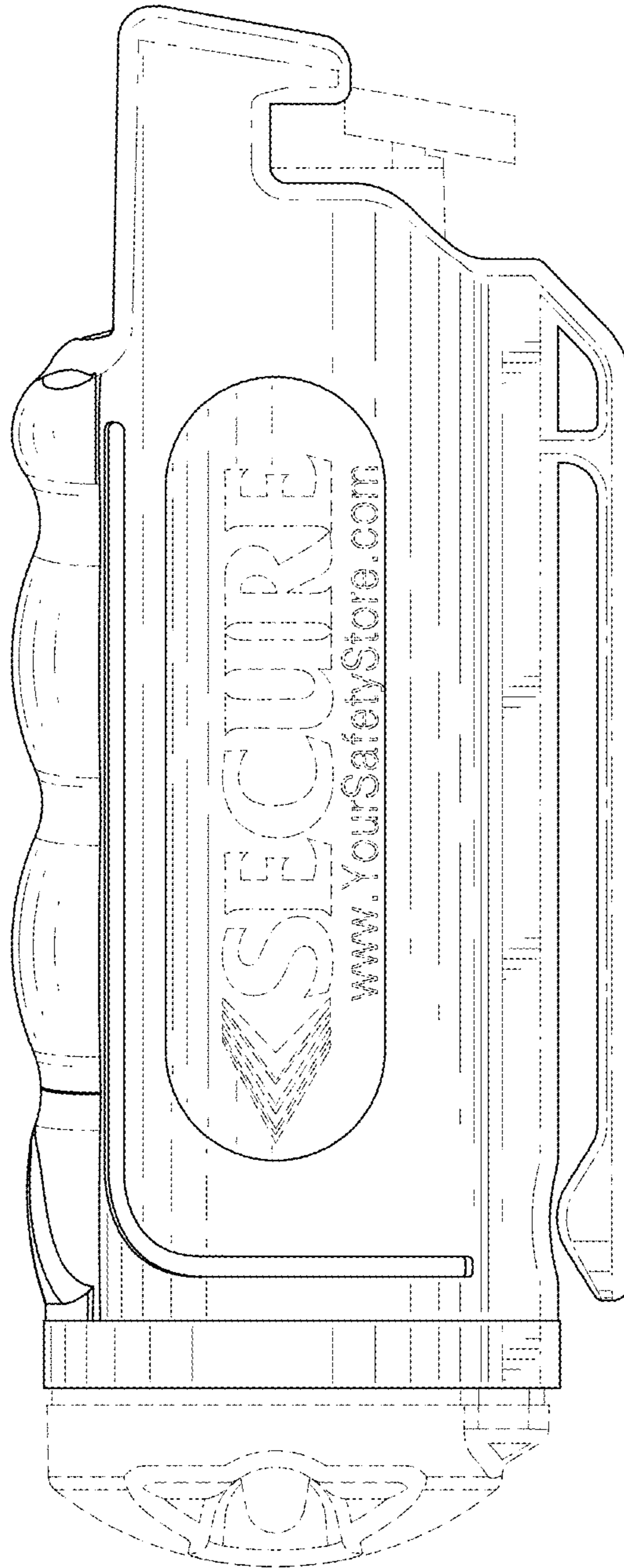

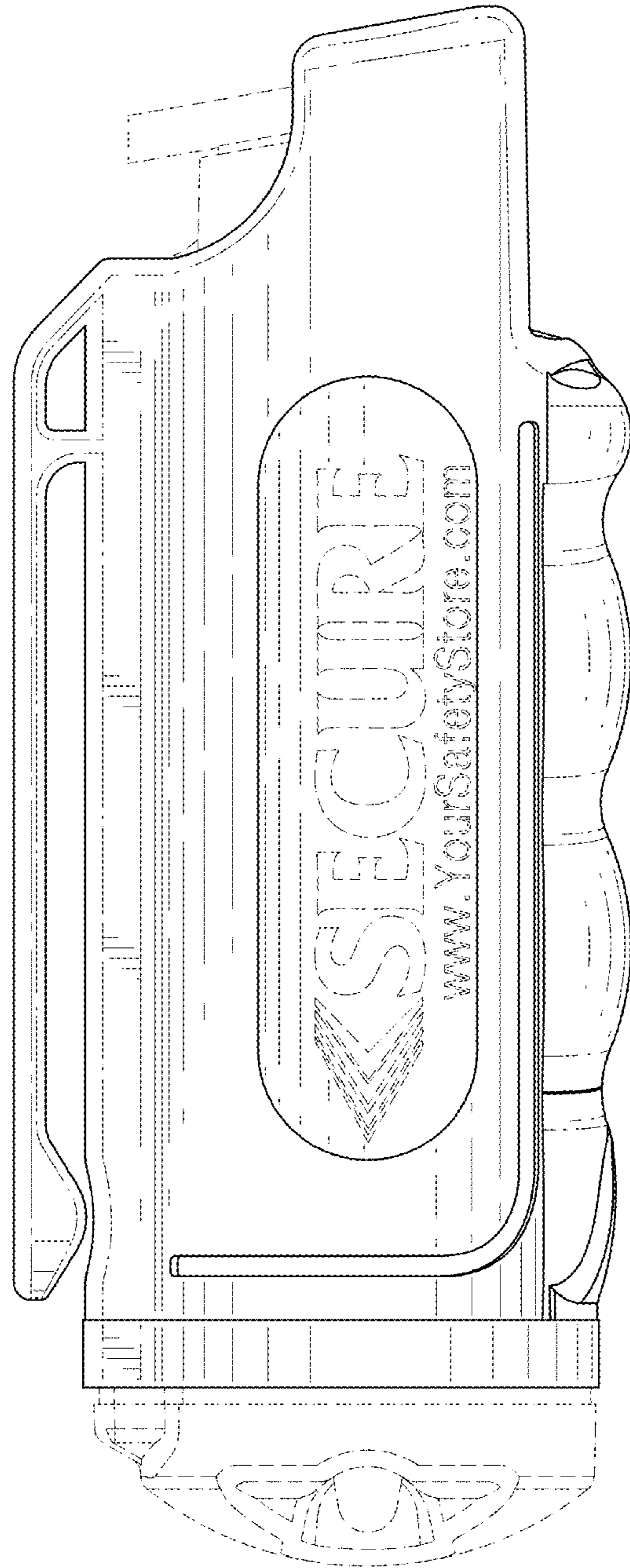

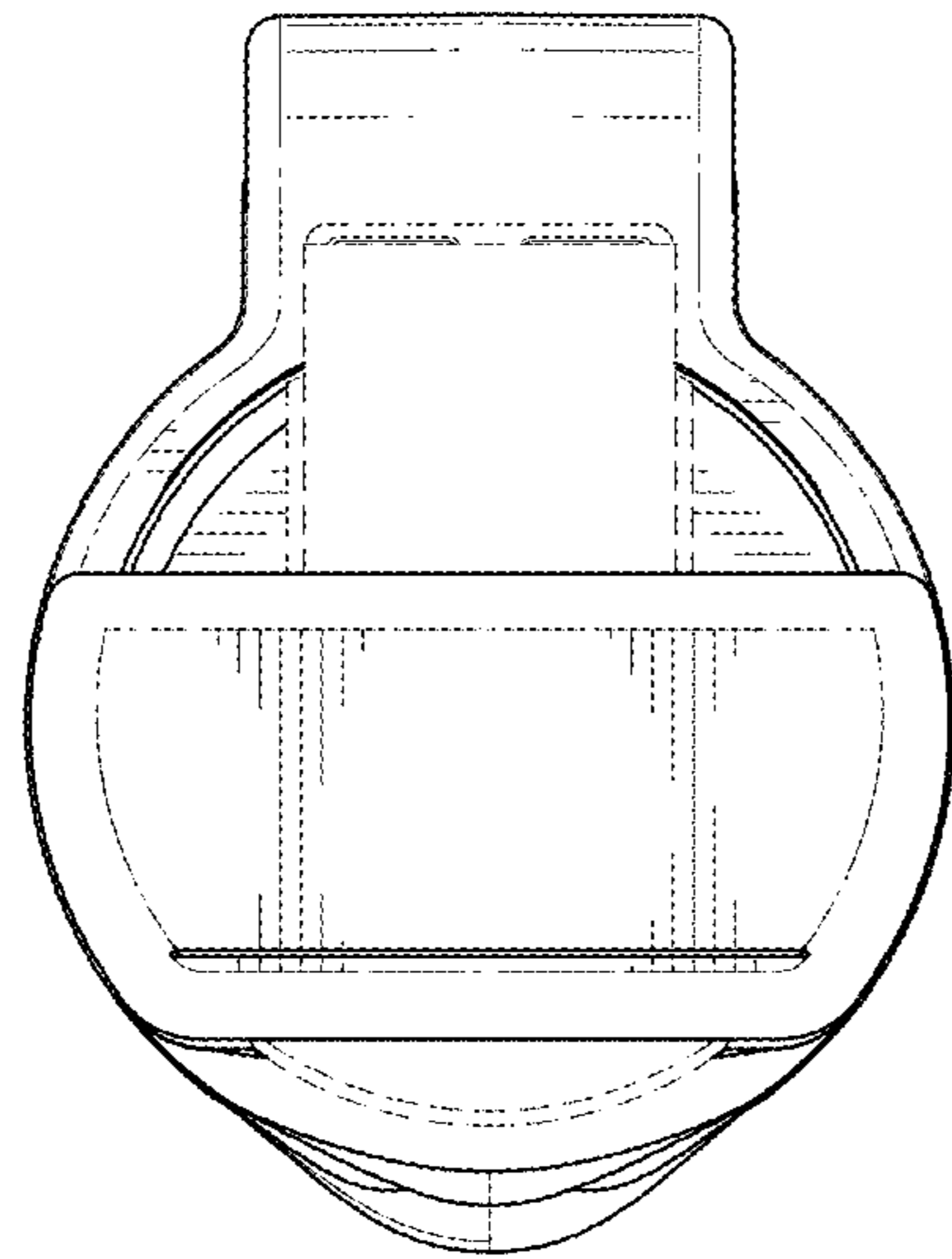

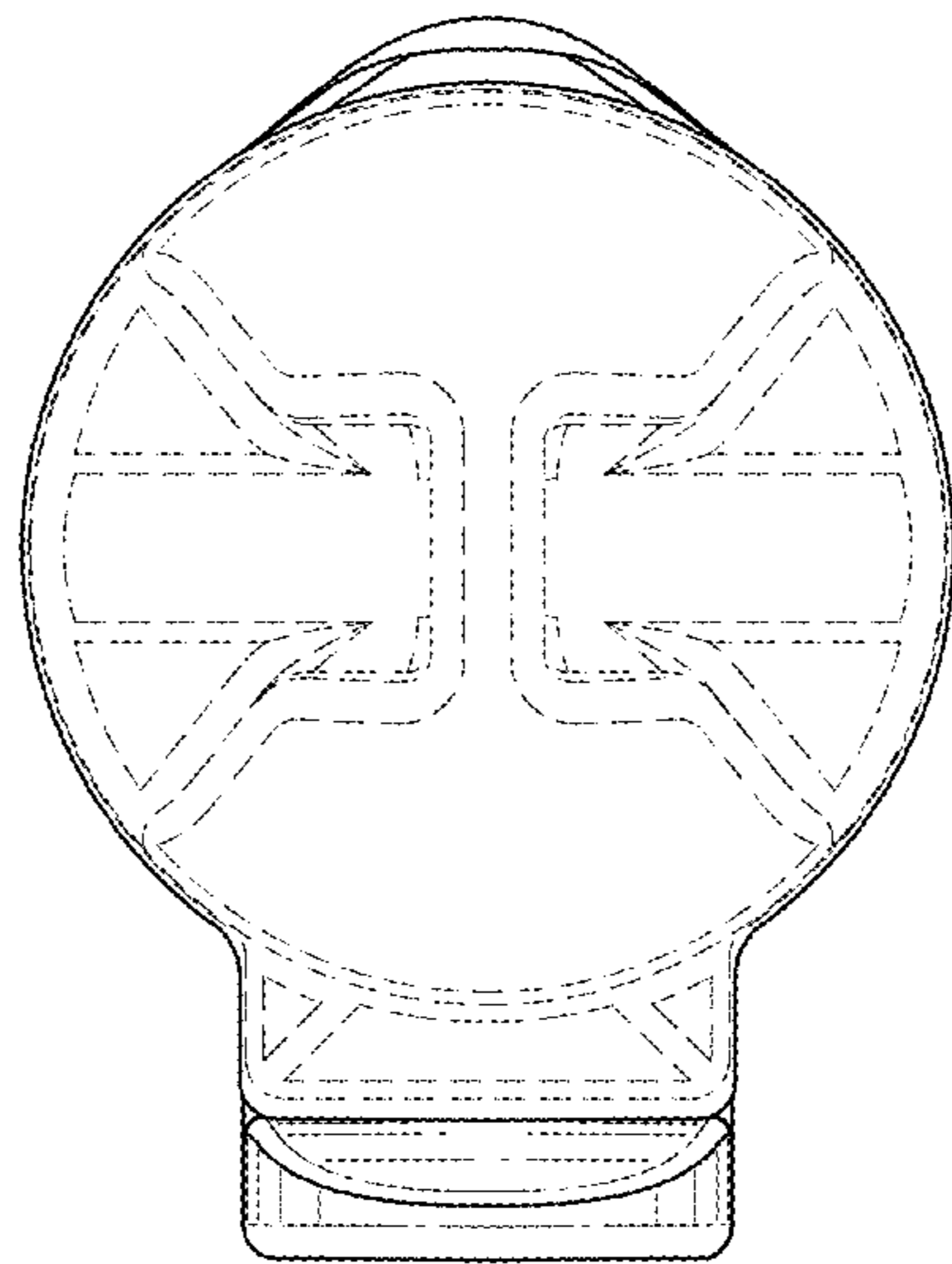
