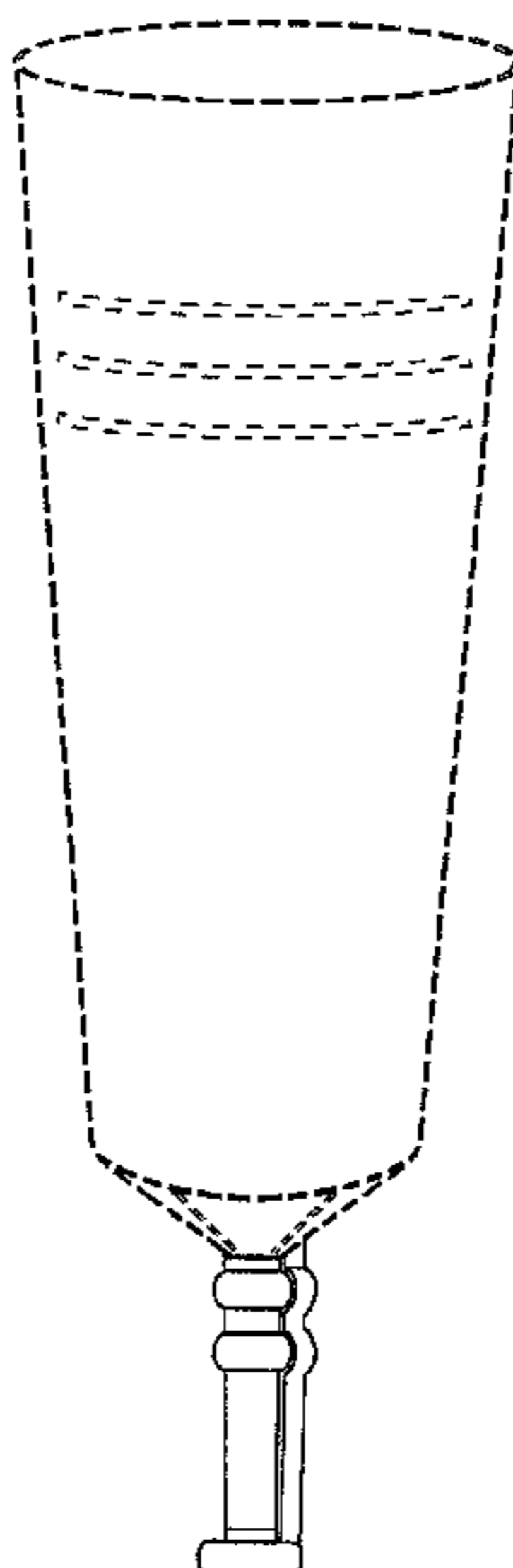
(57) **CLAIM**

The ornamental design for a biological fluid container, as shown and described.

**DESCRIPTION**

FIG. 1 is a side elevation view of a biological fluid container, embodying the new design;  
FIG. 2 is an opposite side elevation view thereof;  
FIG. 3 is an end elevation view thereof;  
FIG. 4 is an opposite end elevation view thereof;  
FIG. 5 is a bottom plan view thereof; and,  
FIG. 6 is a top plan view thereof.  
The features shown in broken lines depict environmental structure only and form no part of the claimed design.

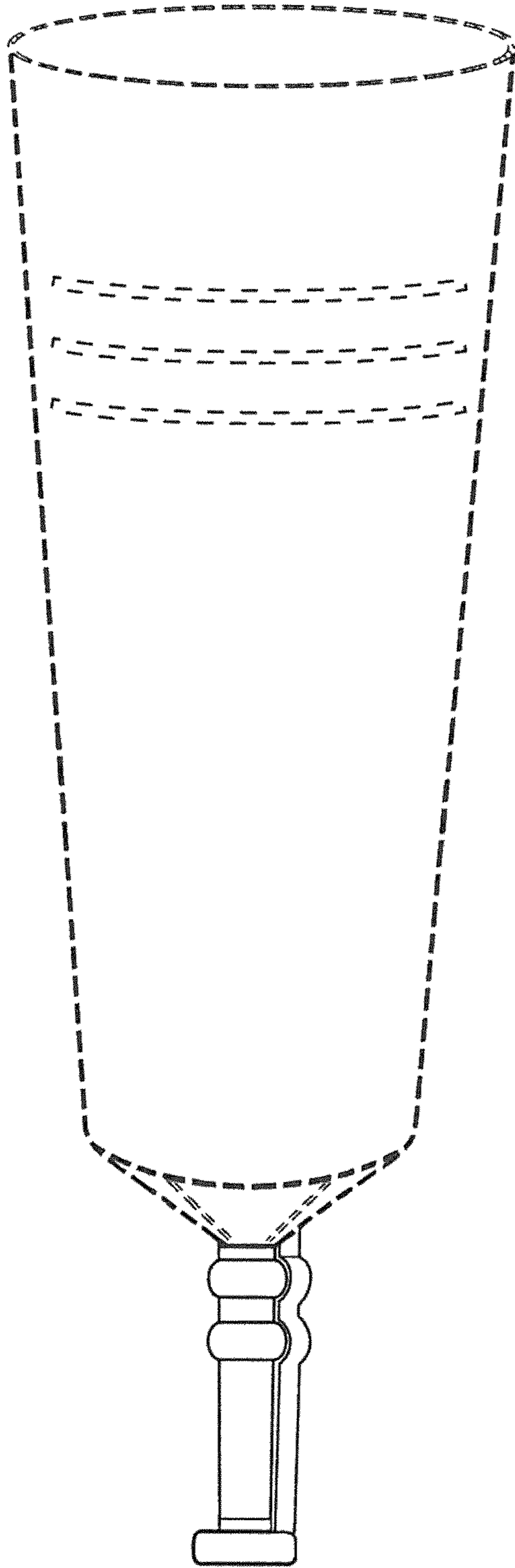

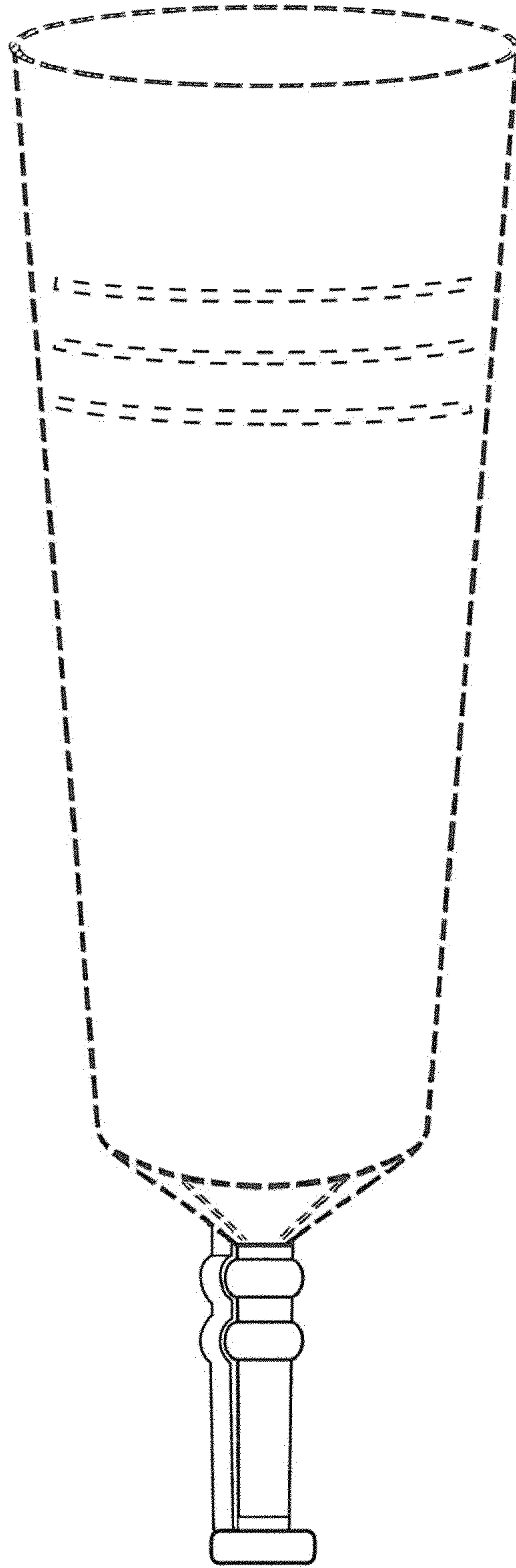

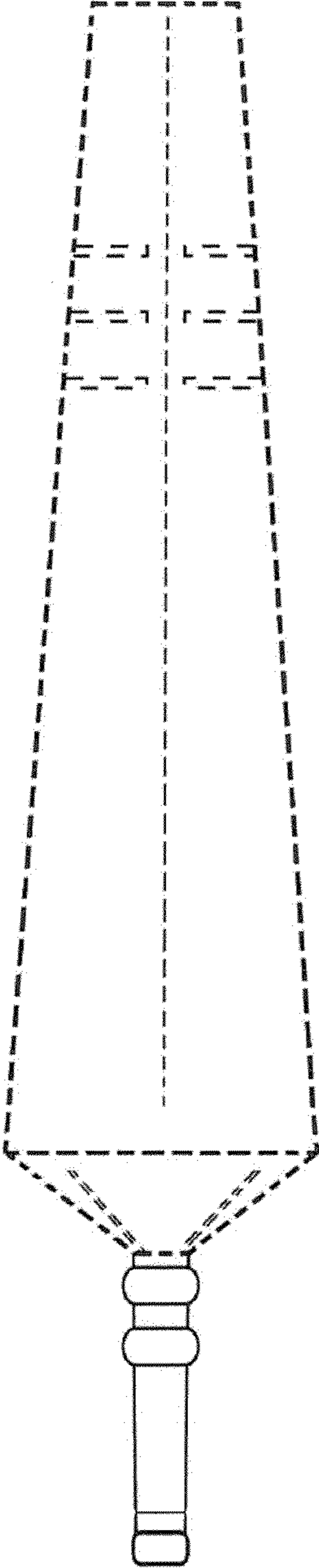

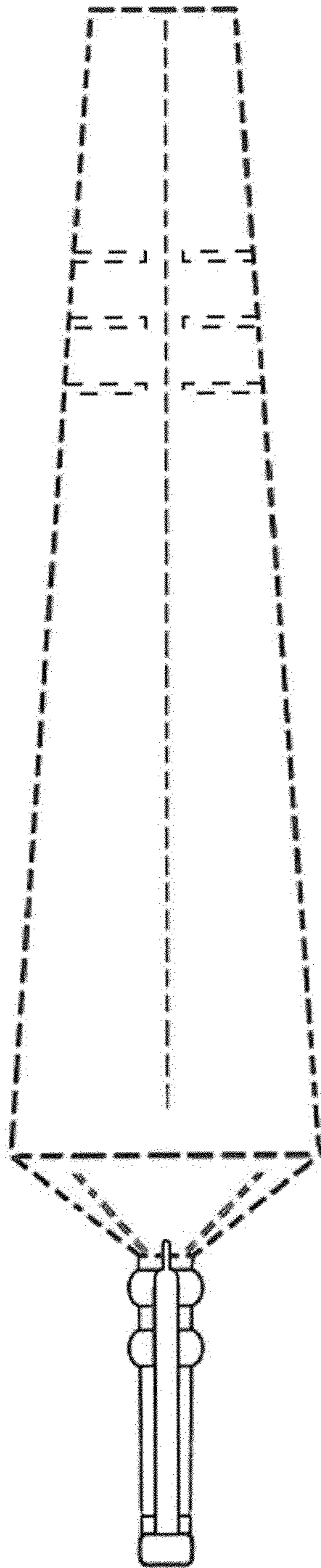

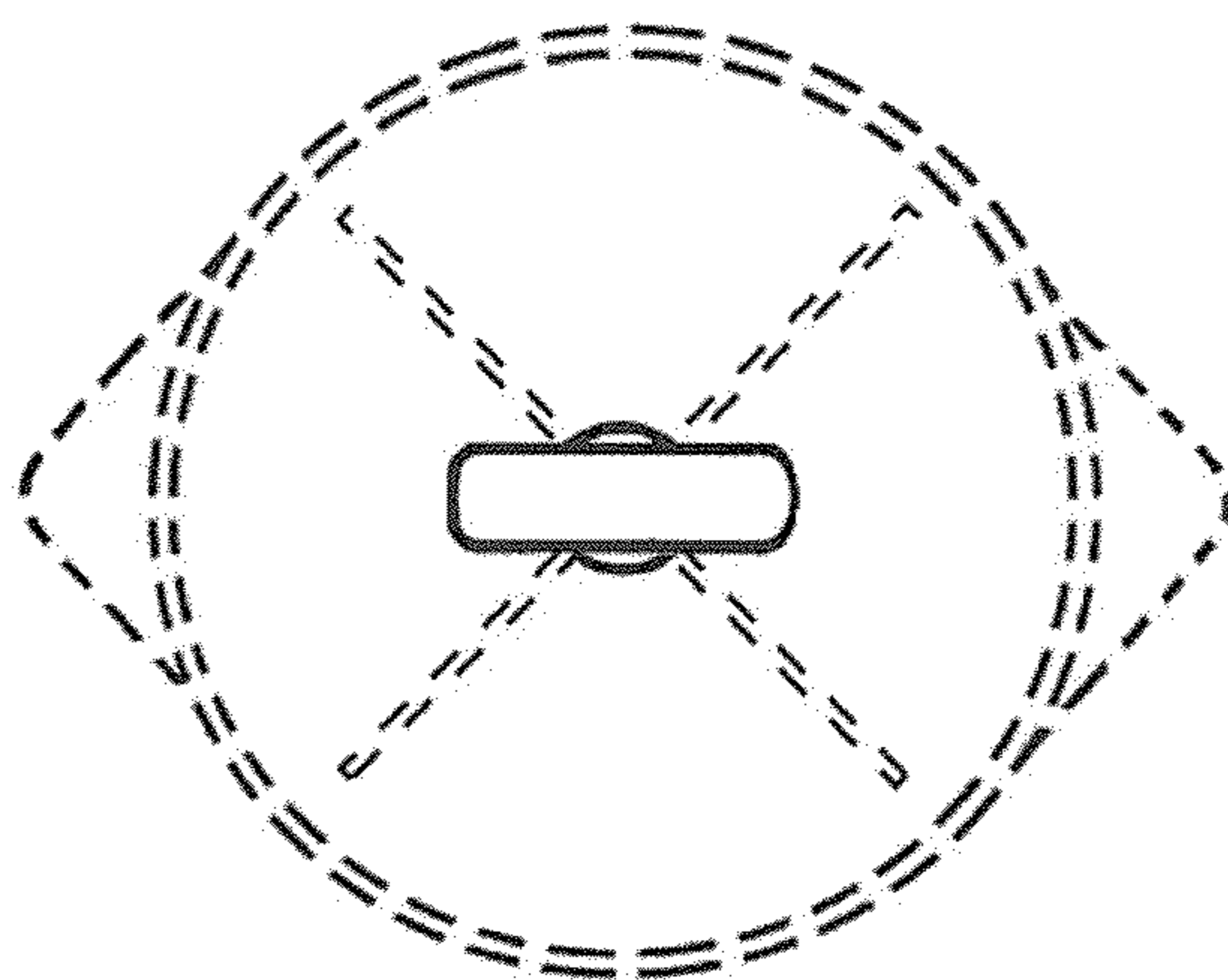

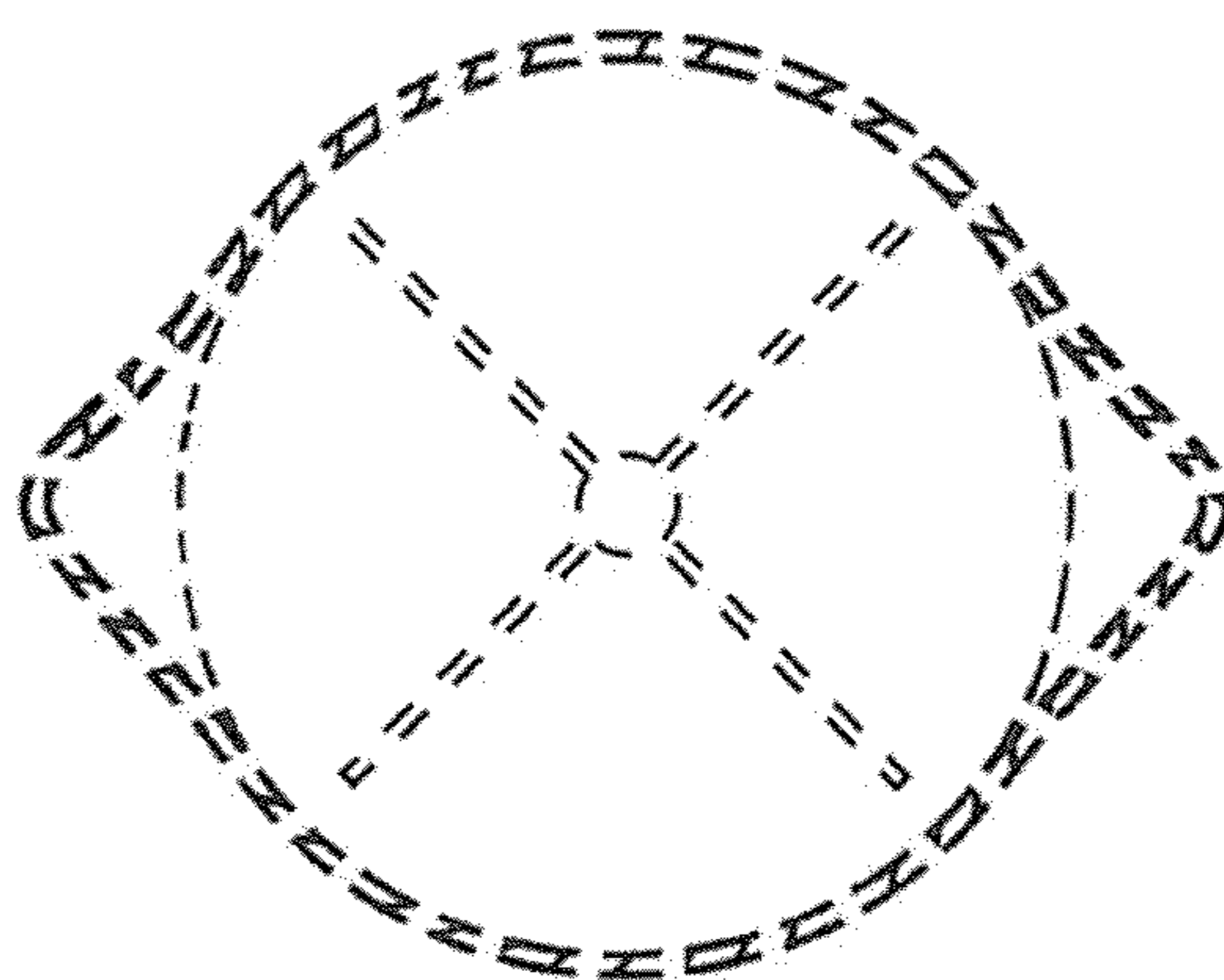
