(57) **CLAIM**

We claim the ornamental design for a wall panel, as shown and described.

DESCRIPTION

FIG. 1 is a front top and right side perspective view of a wall panel, showing the new design;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a rear elevation view thereof;

FIG. 4 is a left side elevation view thereof;

FIG. 5 is a right side elevation view thereof;

FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom plan view thereof;

FIG. 8 is another front elevation view thereof showing the wall panel in use with surrounding environmental features;


FIG. 9 is another front top and right side perspective view thereof showing the wall panel in use with surrounding environmental clip features;

FIG. 10 is a front top and right side perspective view of a second embodiment of the wall panel in FIG. 1, the only difference being the configuration of side grooves, it being understood that all other surfaces are the same as those of the first embodiment;

FIG. 11 is a left side elevation view of the embodiment of FIG. 10; and,

FIG. 12 is a right side elevation view of the embodiment of FIG. 10.



















