(57) **CLAIM**

The ornamental design for an animal chew toy, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the animal chew toy;
 FIG. 2 is a top view thereof;
 FIG. 3 is a bottom view thereof;
 FIG. 4 is a right side view thereof, the left side view is identical to the right side view shown; and,
 FIG. 5 is a front view thereof, the rear view is identical to the front view shown.

The broken lines are for illustration only and form no part of the claimed design.

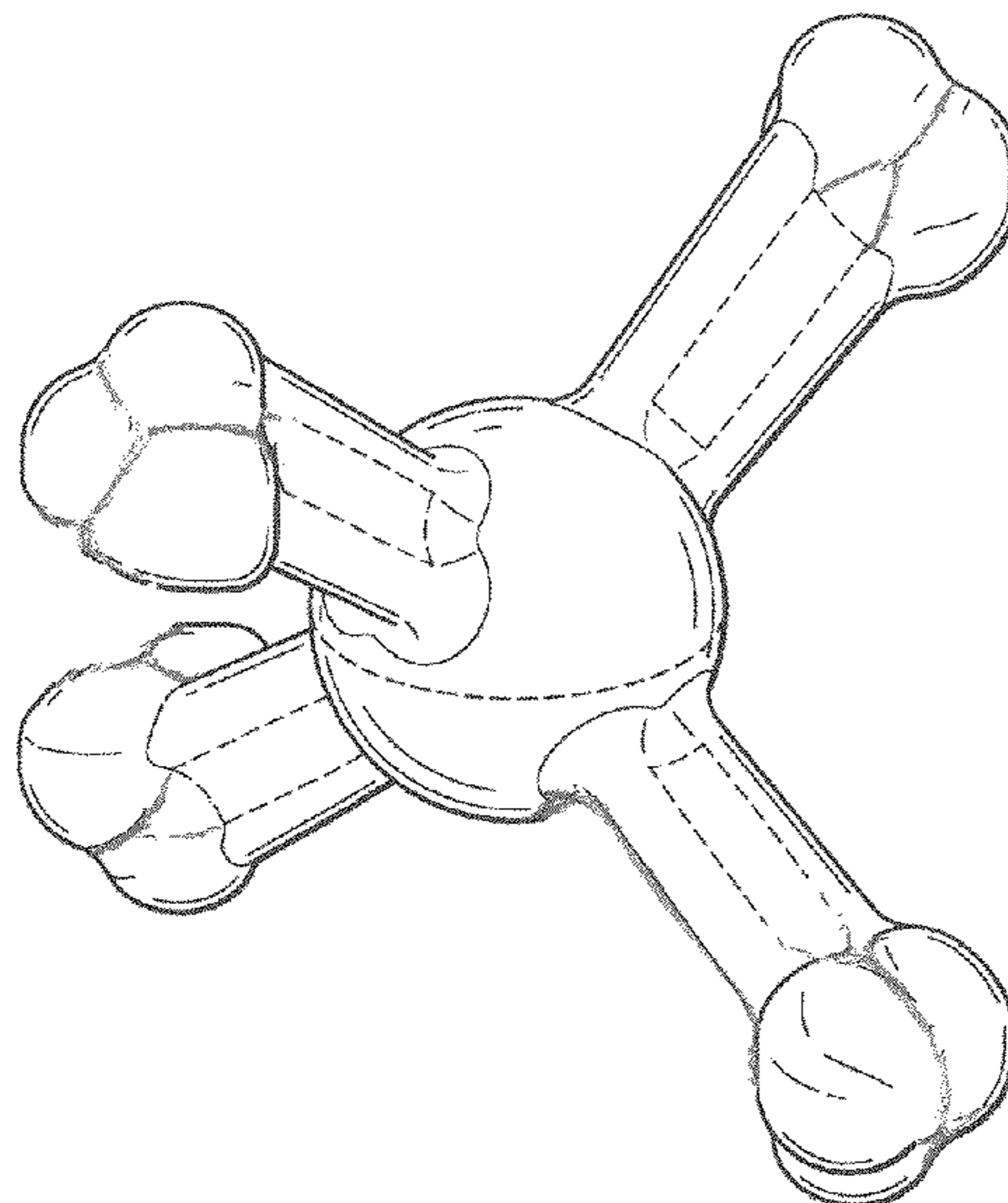
The nature and intended use of the article in which the design is embodied is an animal chew toy having two pieces that are assembled together before the chew toy is given to the animal.

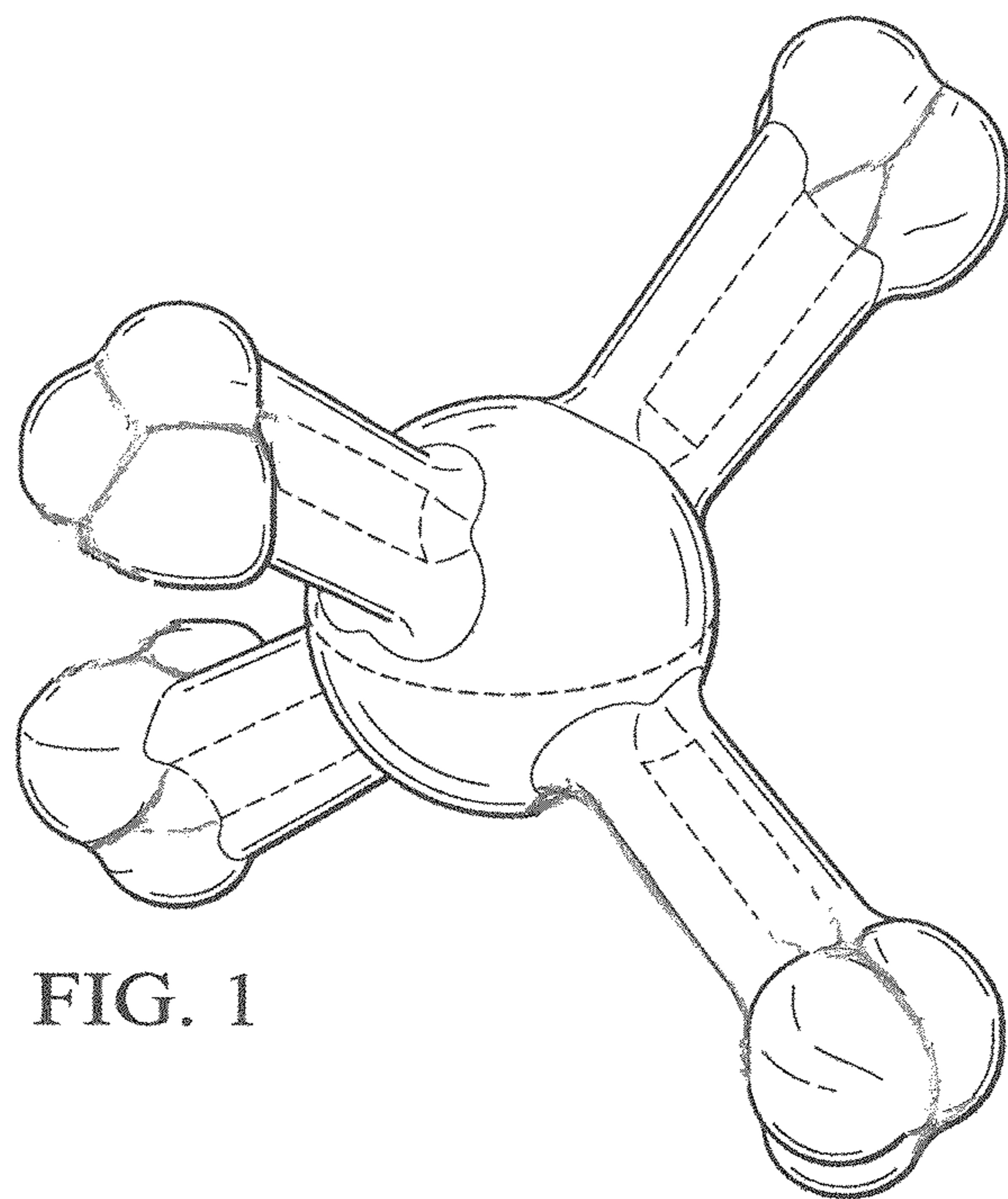

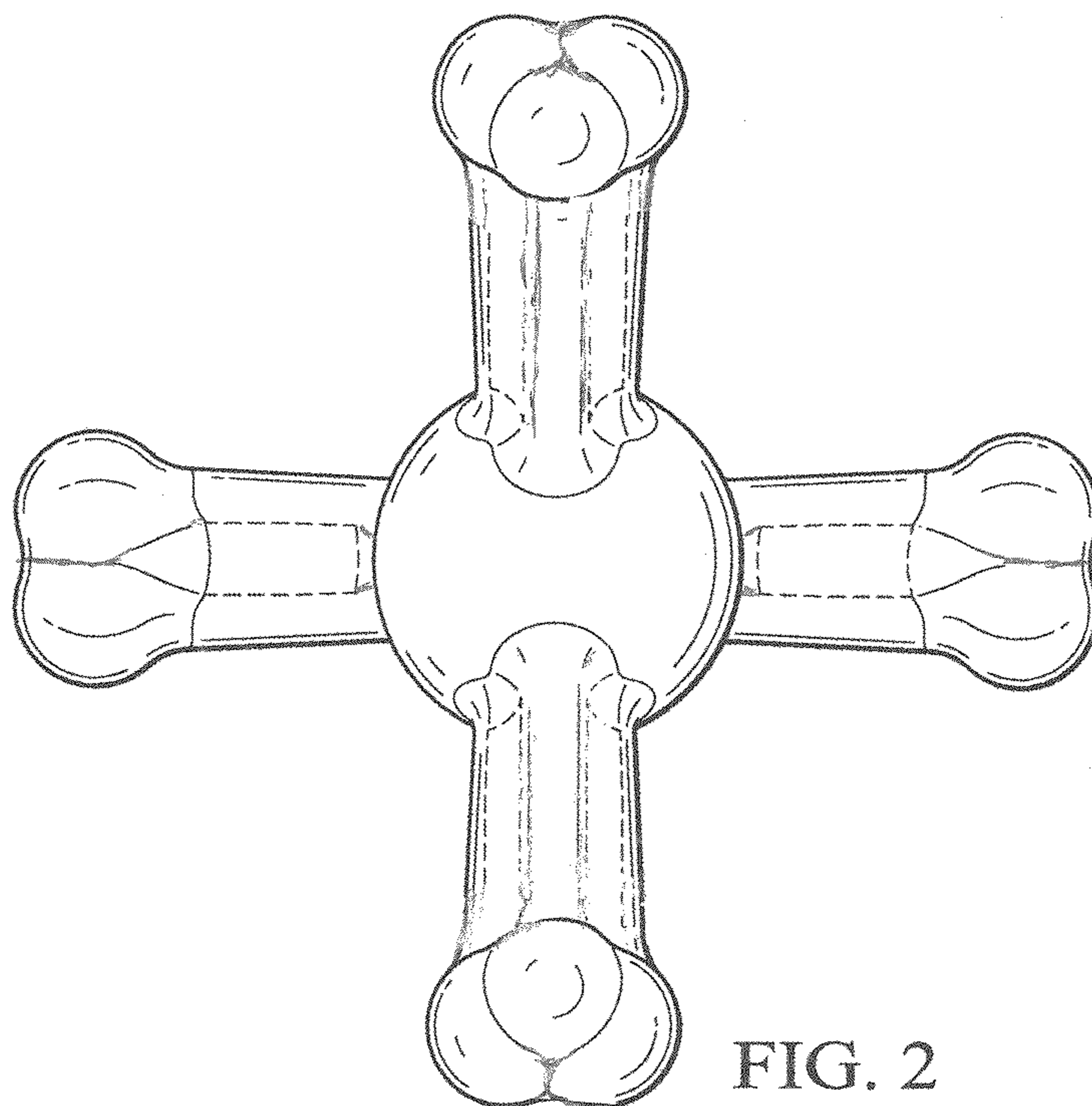

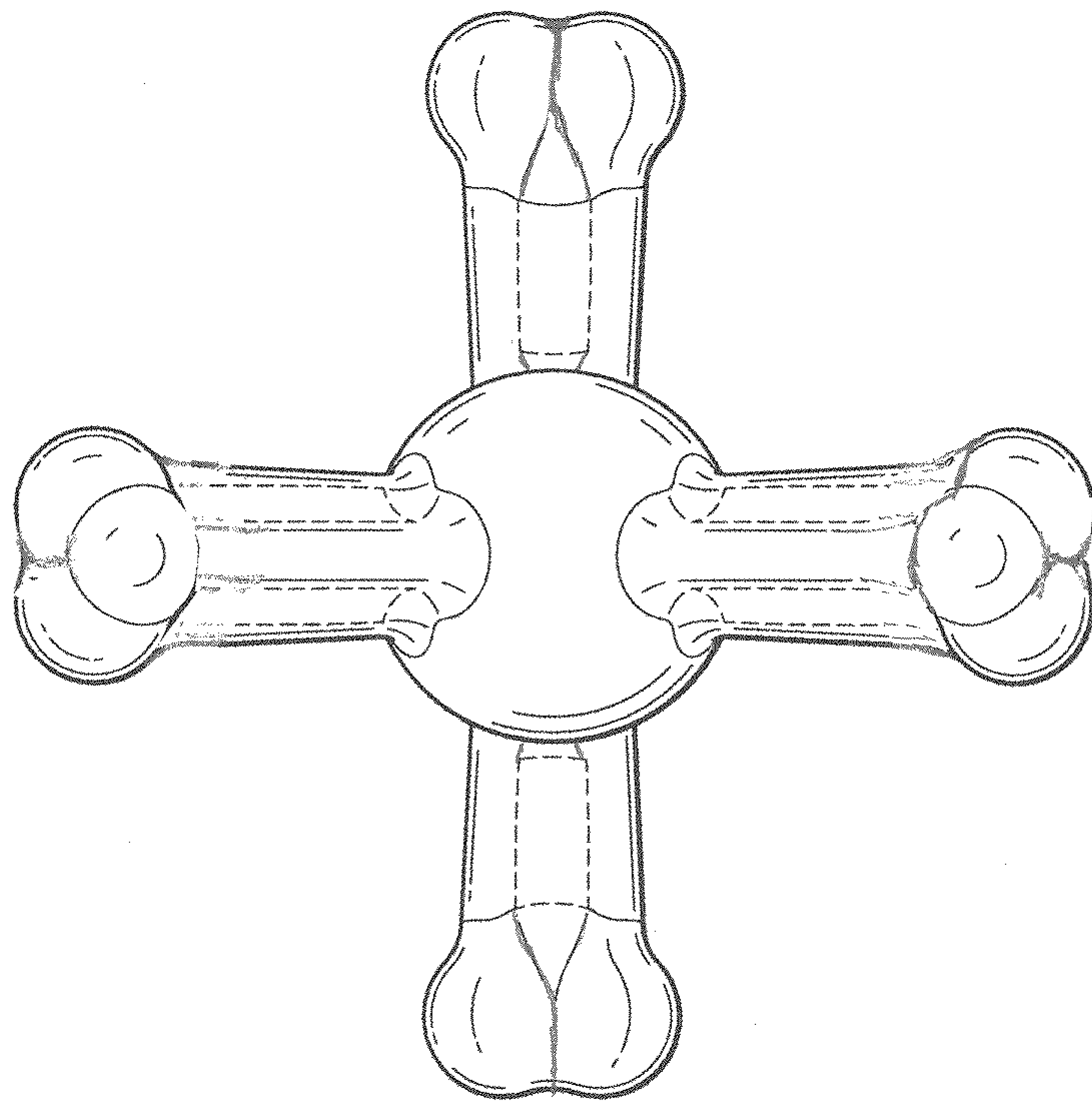

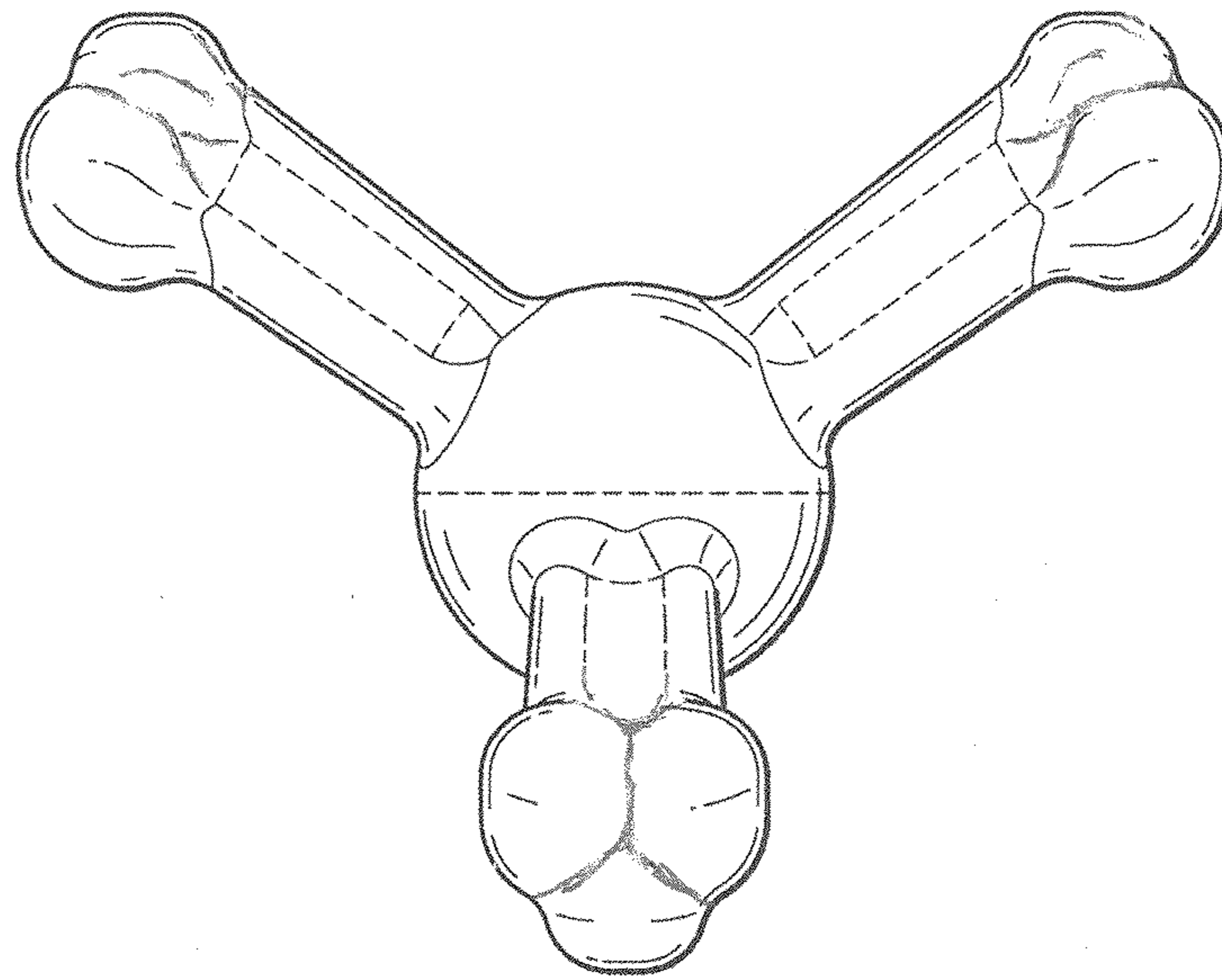

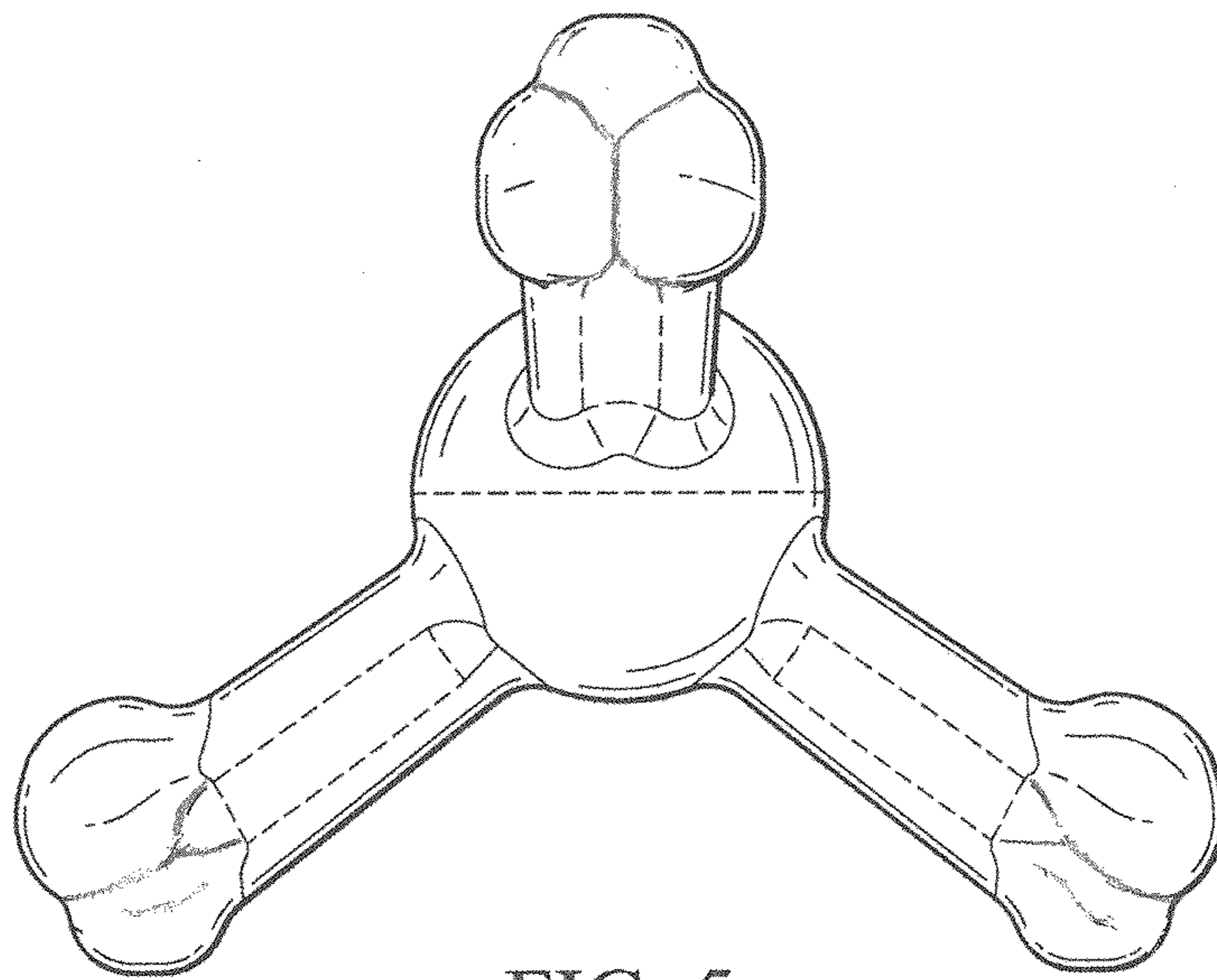
