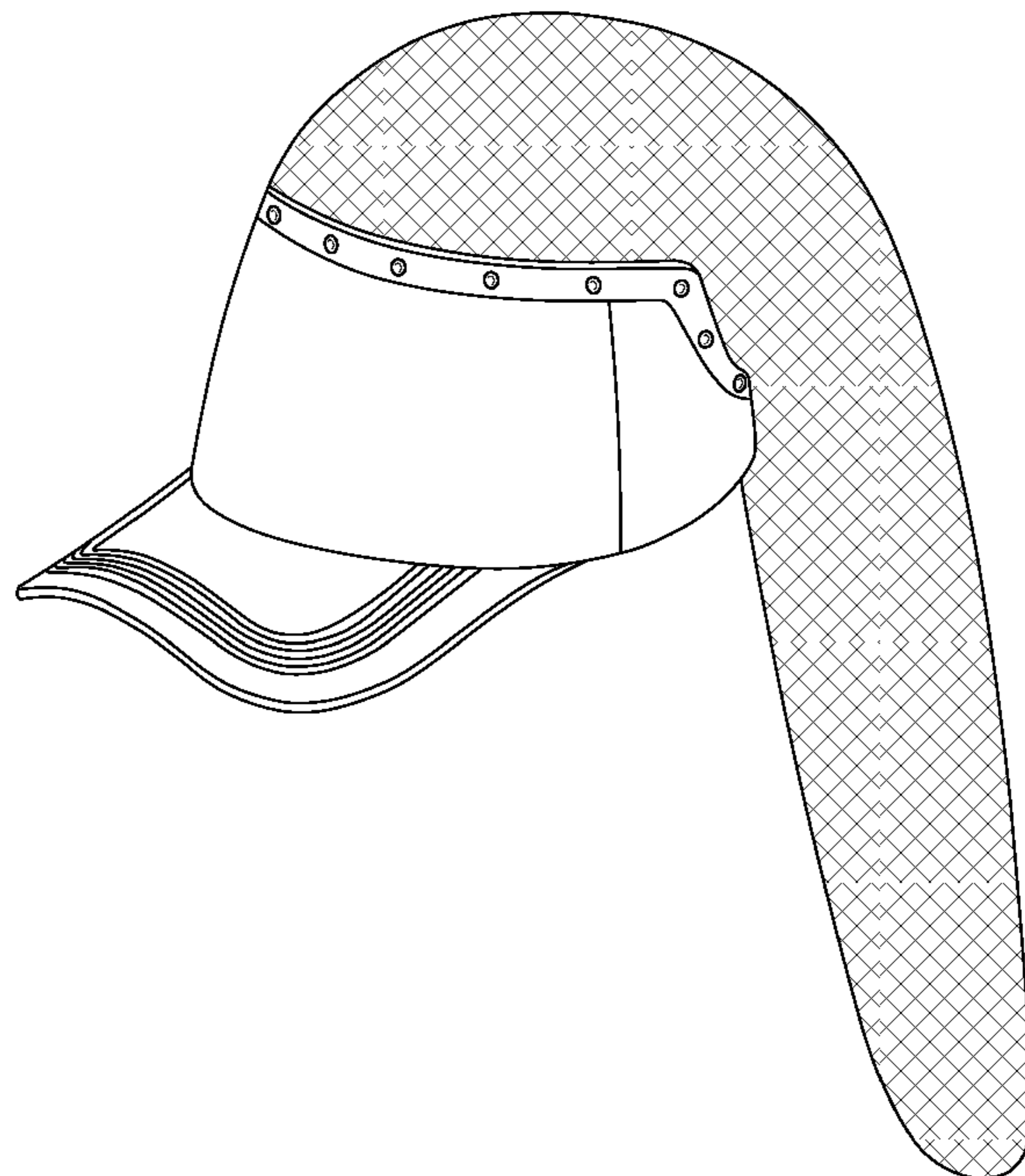
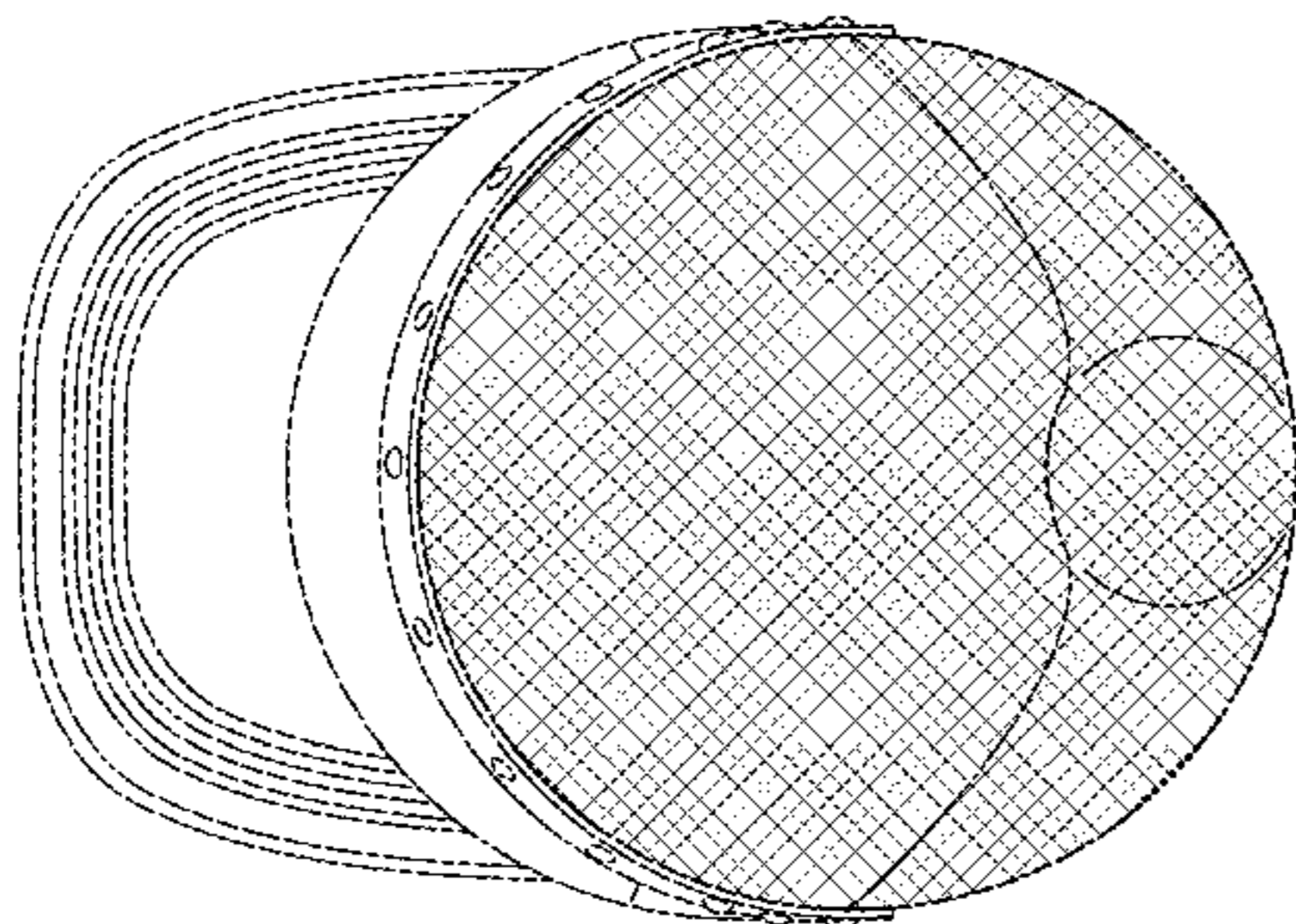
(57) **CLAIM**

The ornamental design for a cap with a net material, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, plan view of the cap with a net material, showing my new design;

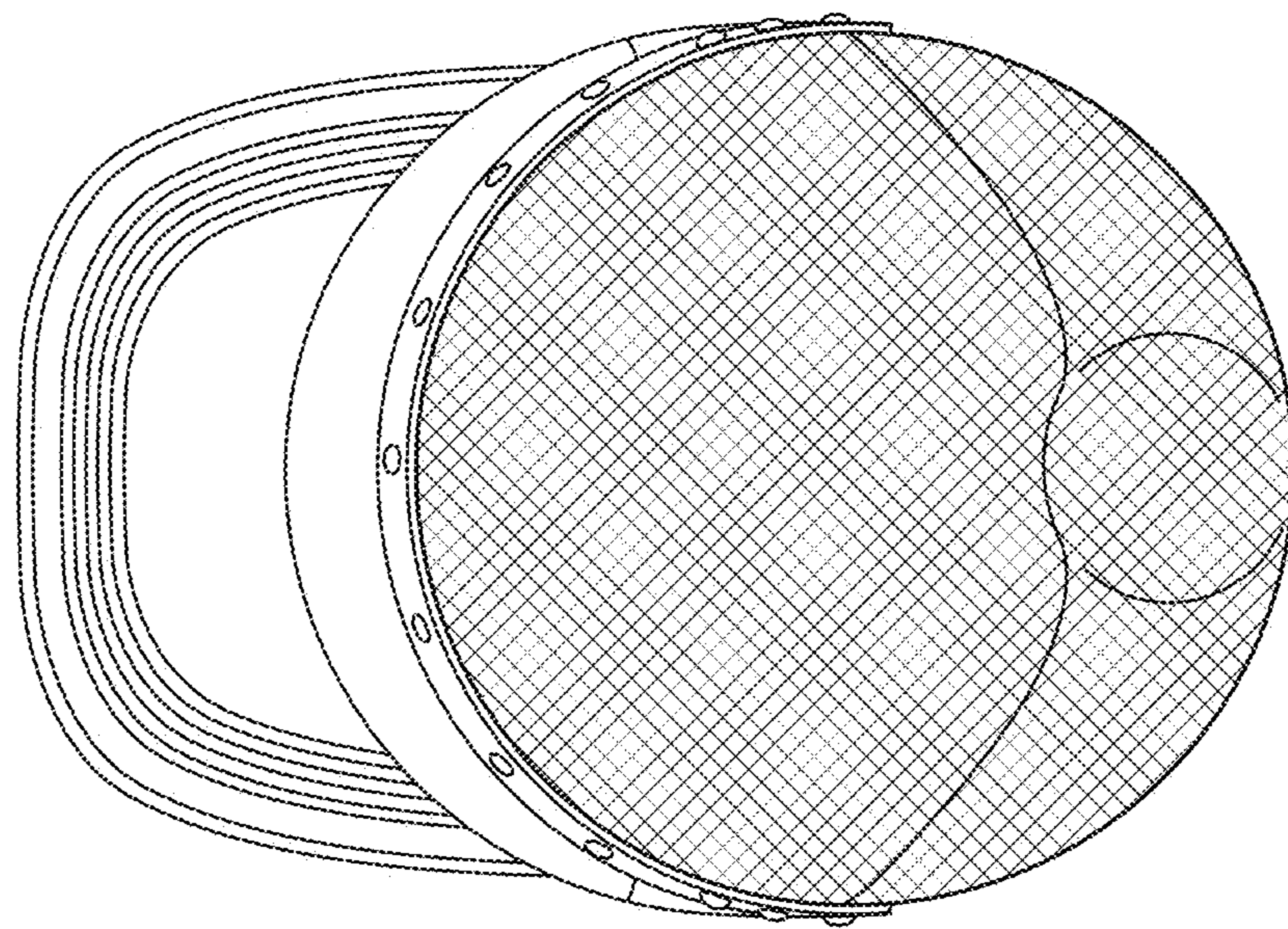

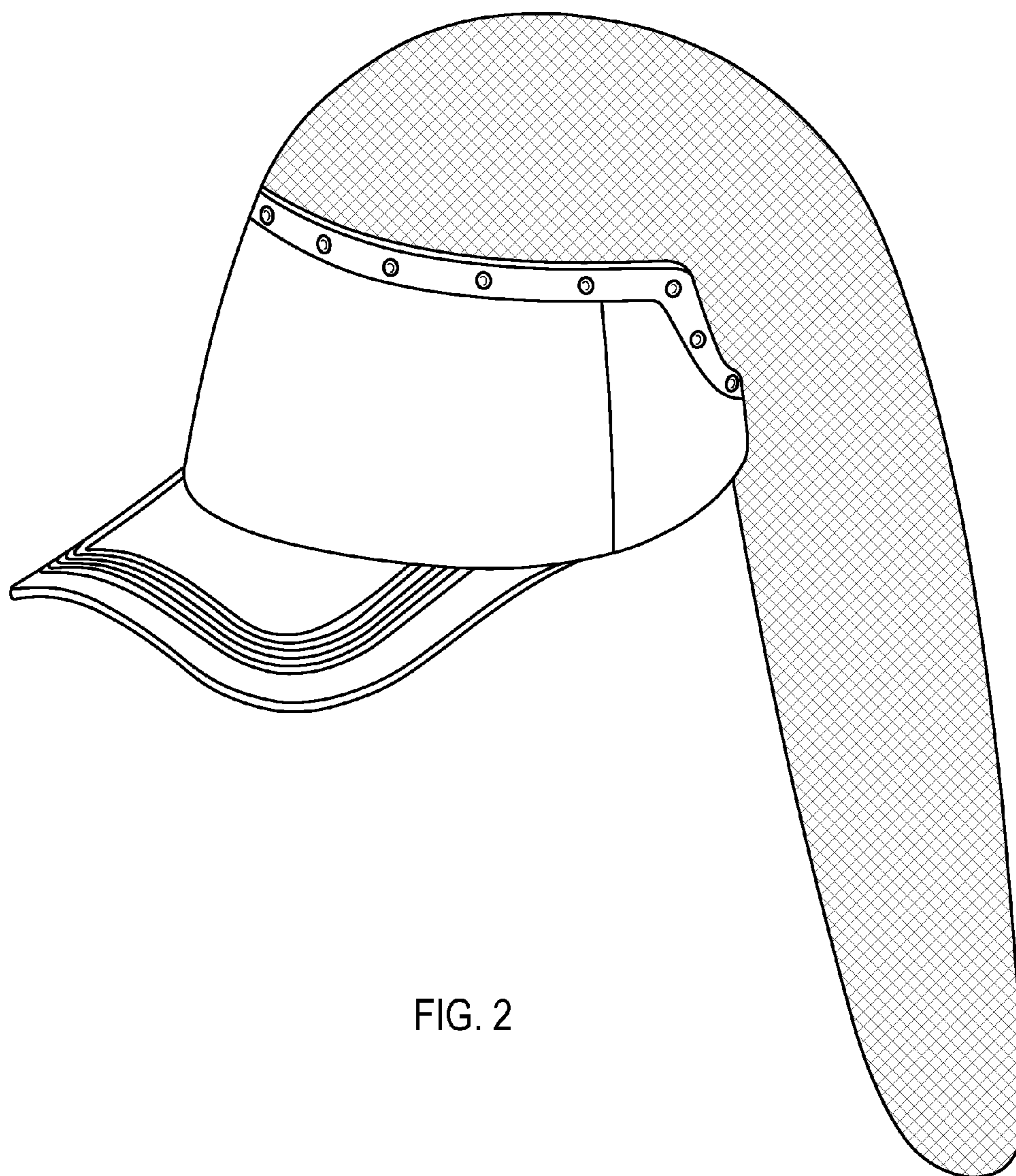

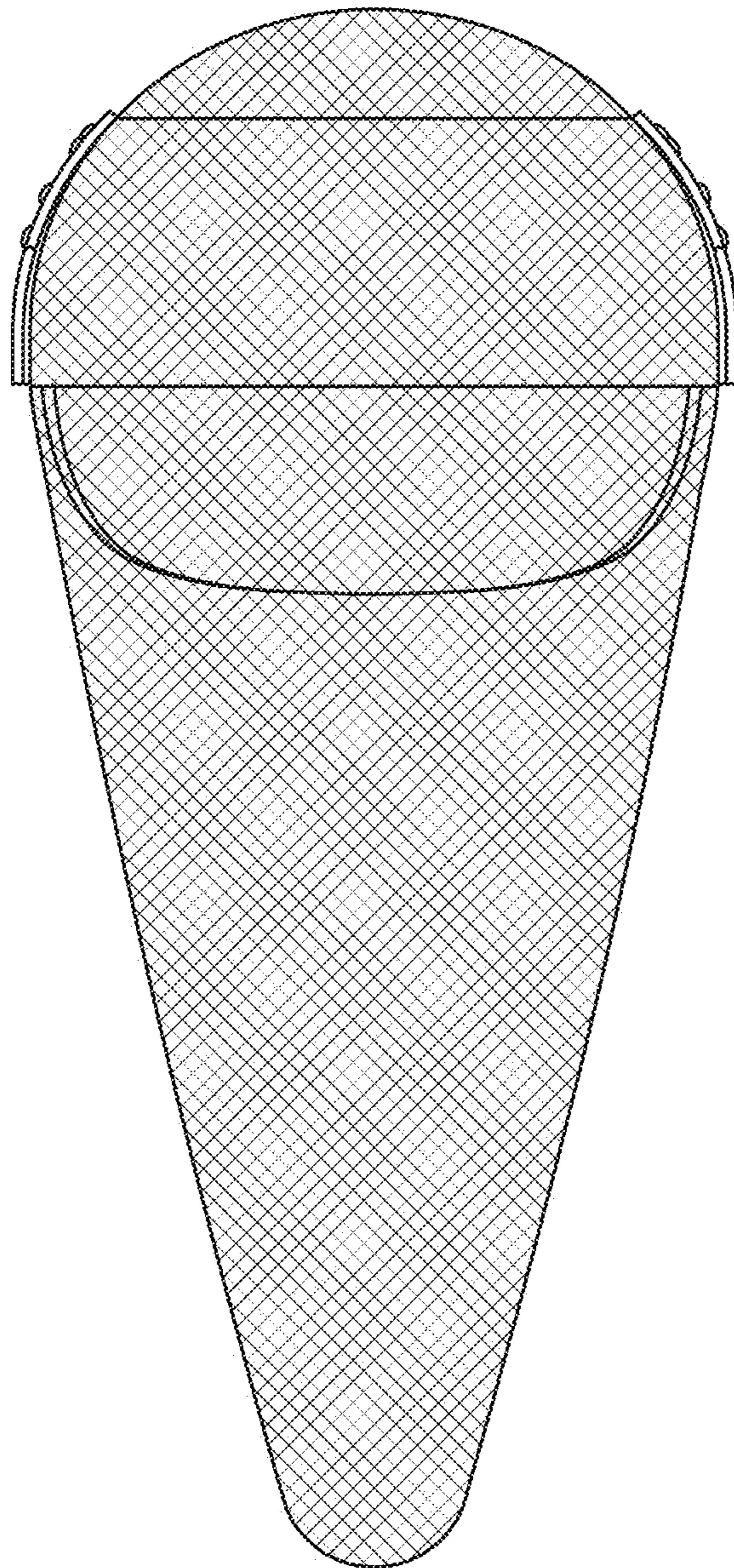
