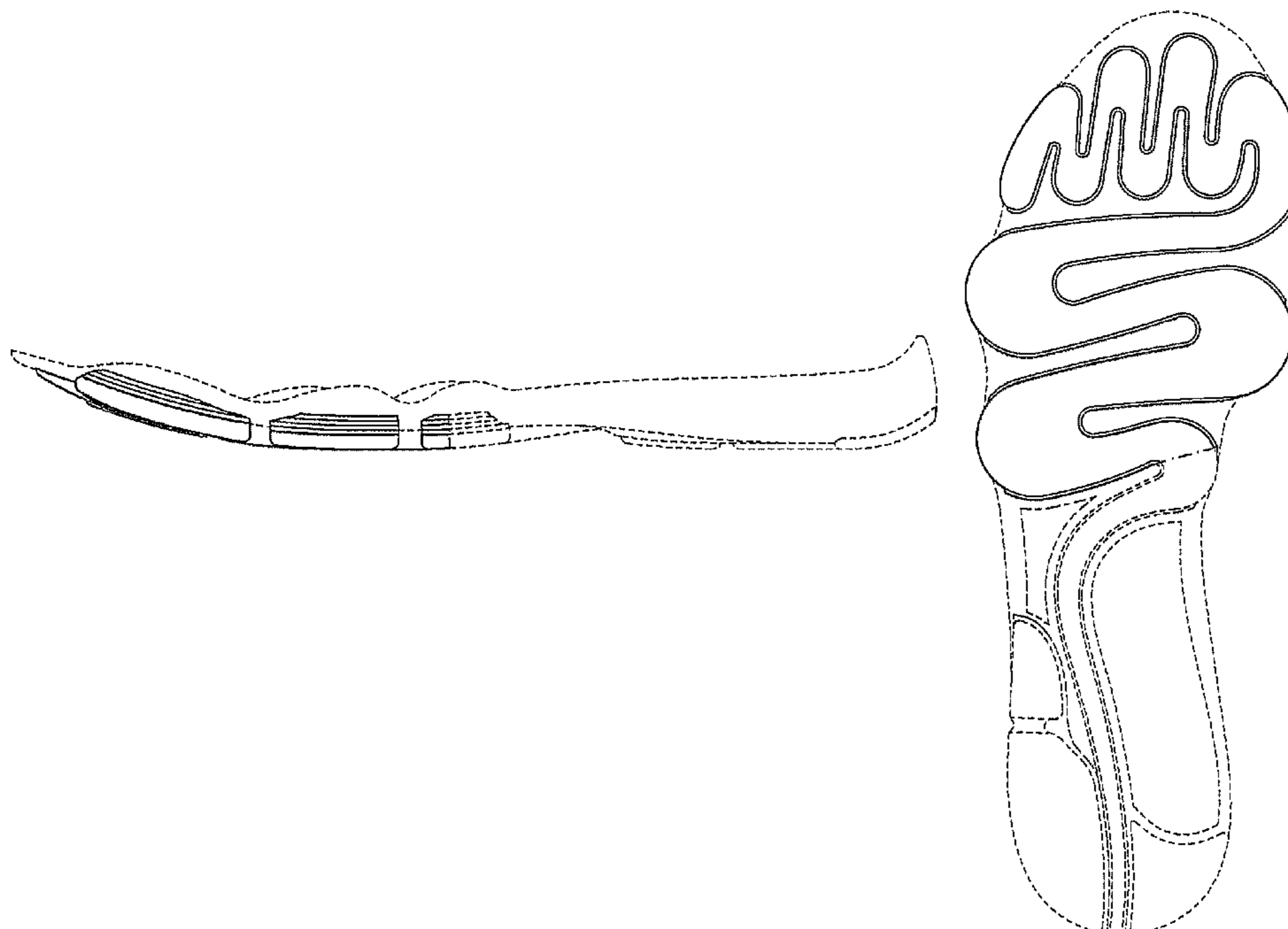
(57) **CLAIM**

The ornamental design for a shoe sole, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of shoe sole;  
FIG. 2 is a front view of the shoe sole of FIG. 1;  
FIG. 3 is a rear view of the shoe sole of FIG. 1;  
FIG. 4 is a left side view of the shoe sole of FIG. 1;  
FIG. 5 is a right side view of the shoe sole of FIG. 1;  
FIG. 6 is a top plan view of the shoe sole of FIG. 1; and,  
FIG. 7 is a bottom plan view of the shoe sole of FIG. 1.  
The broken lines in the figures are for purposes of illustrating portions of the shoe sole that form no part of the claimed design.

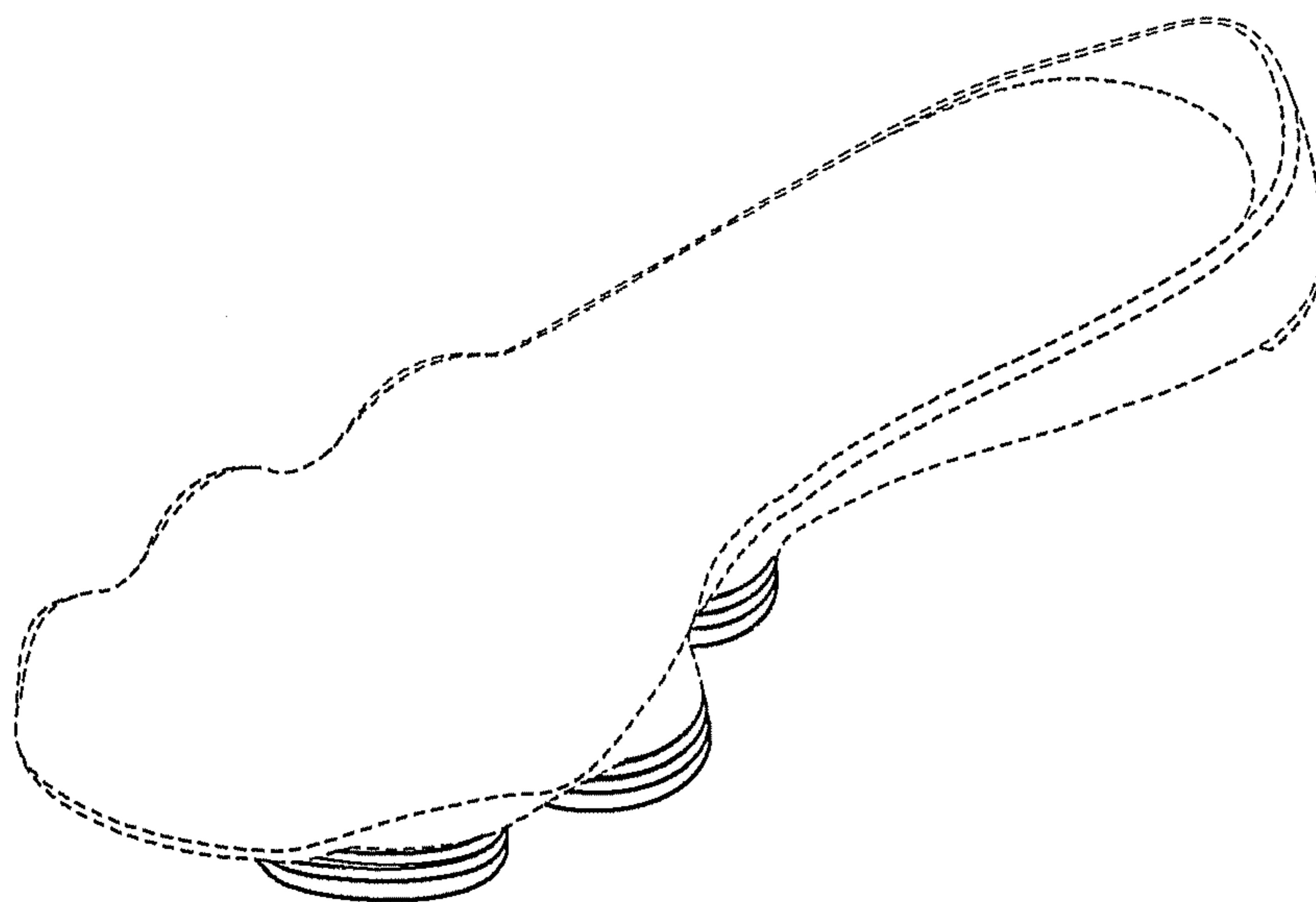

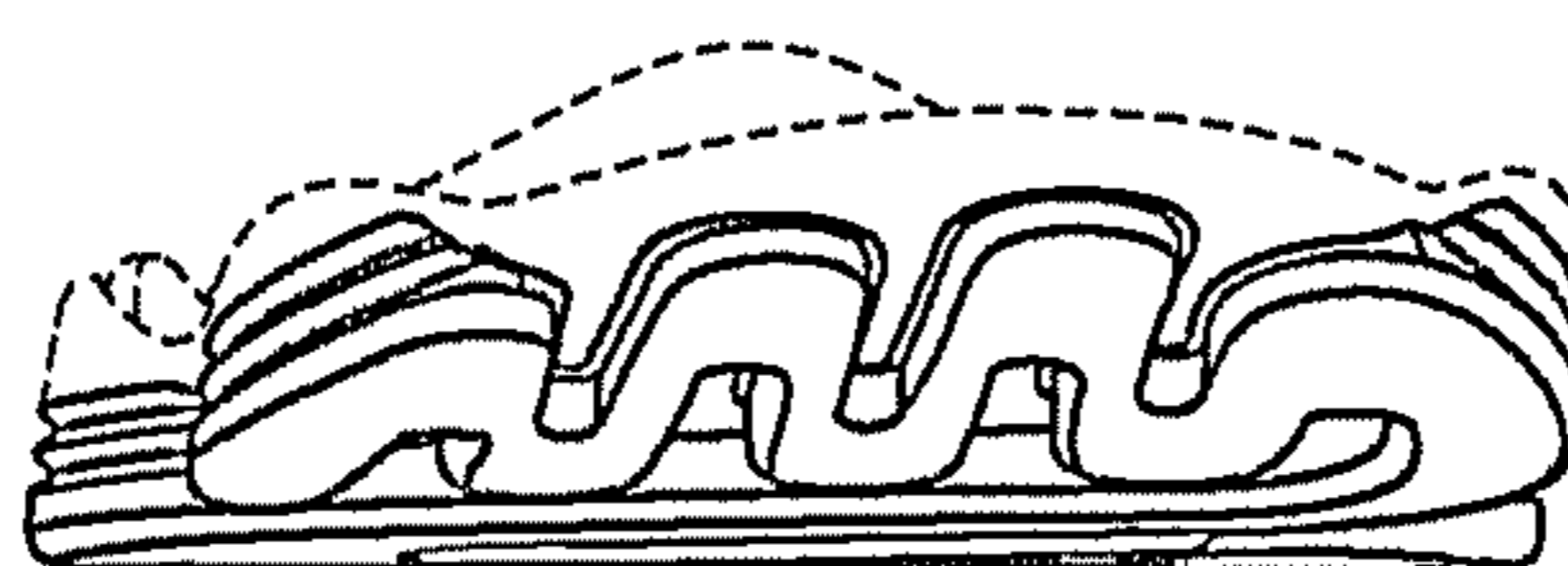

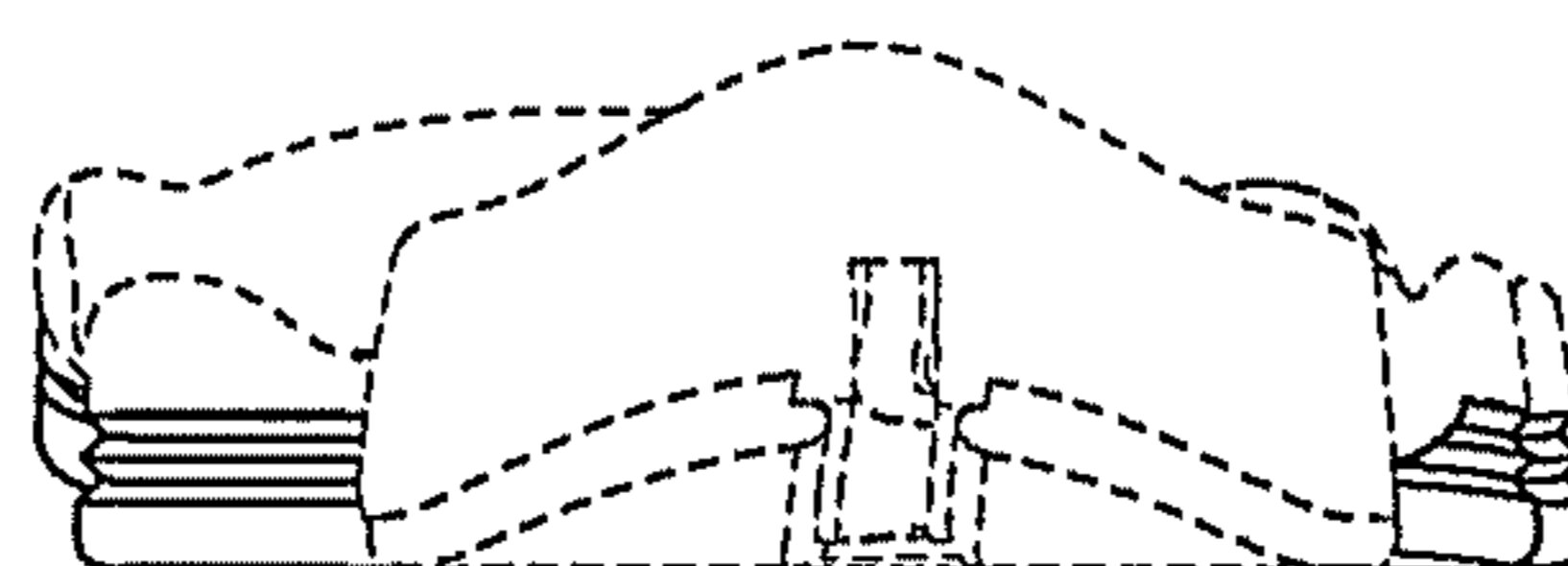

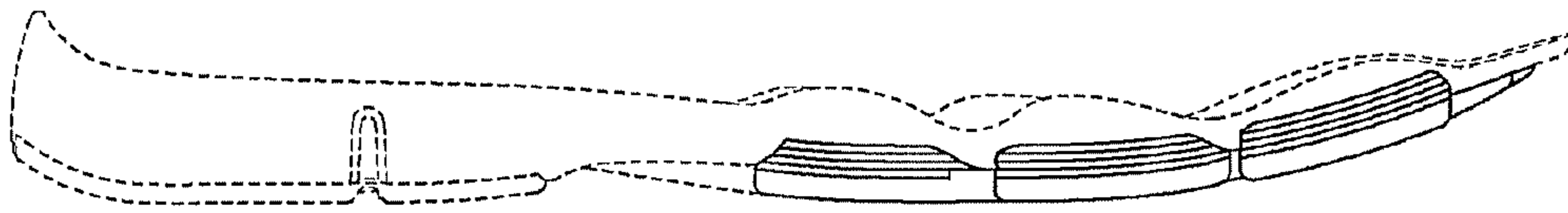

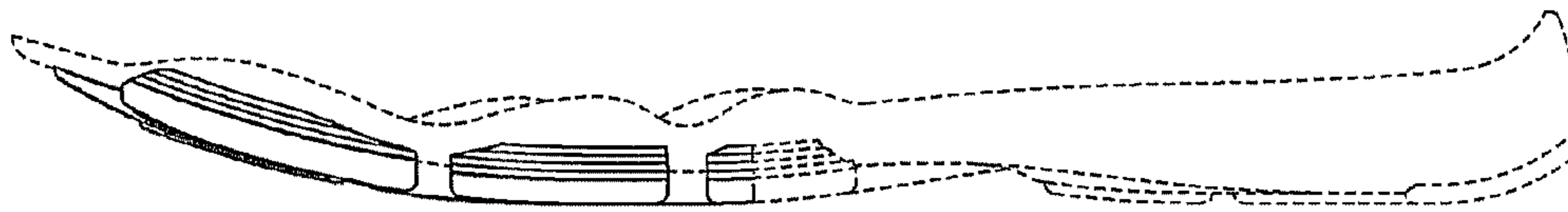

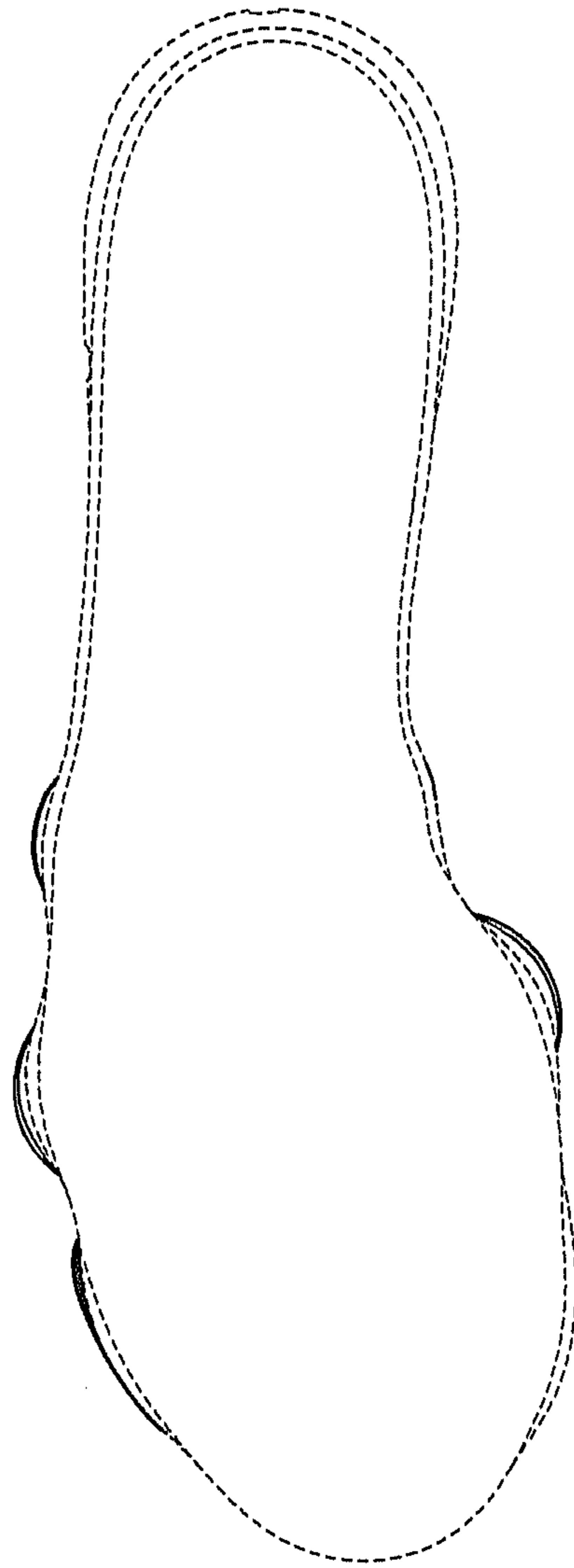

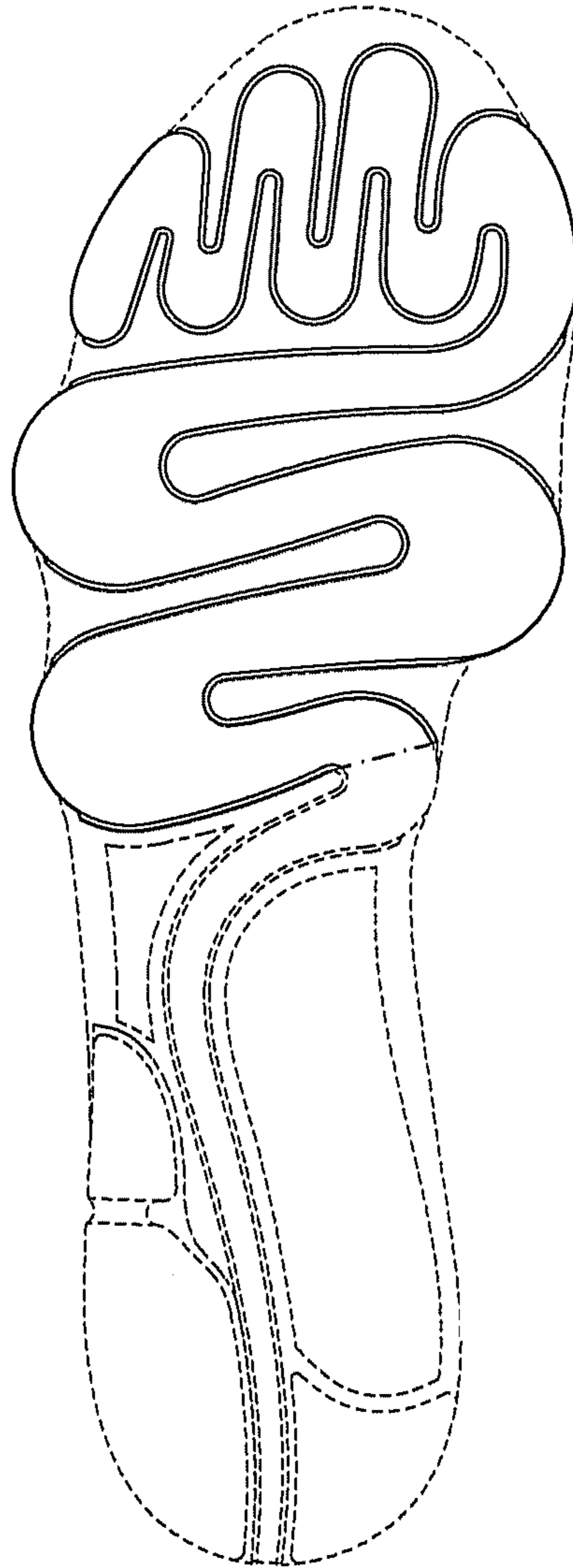
