DESCRIPTION

FIG. 1 is a perspective view of footwear, showing my new design;

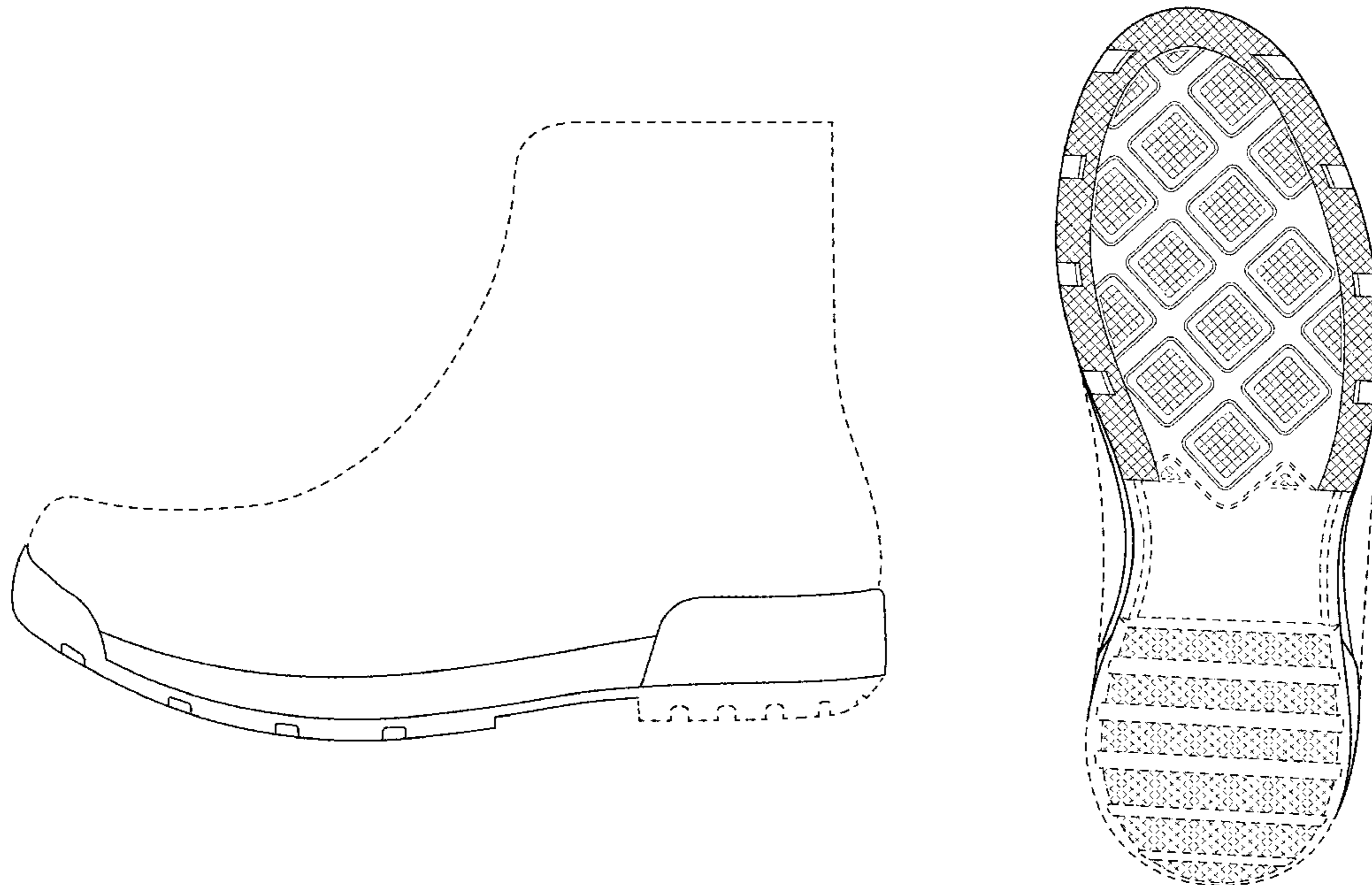

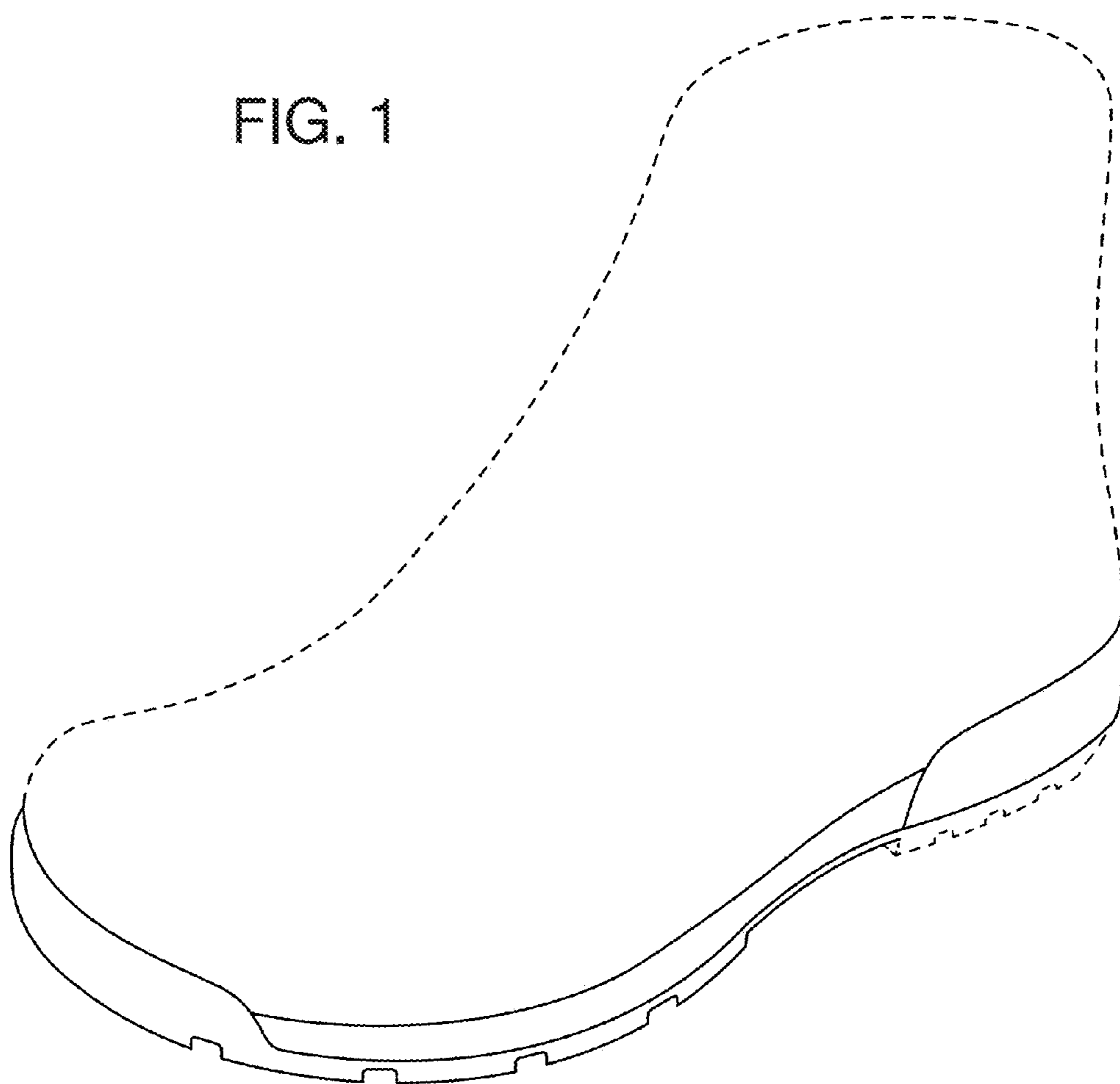
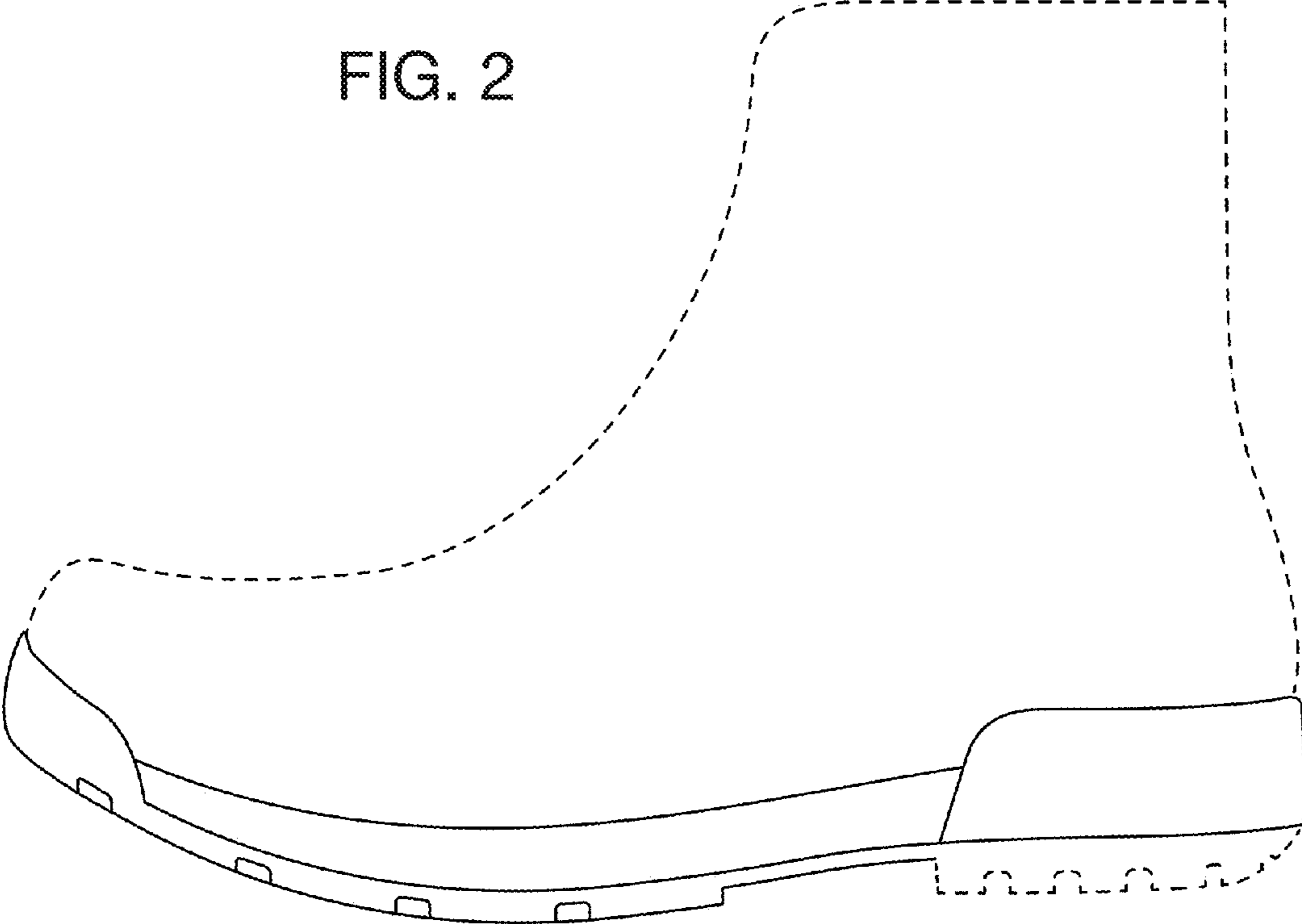
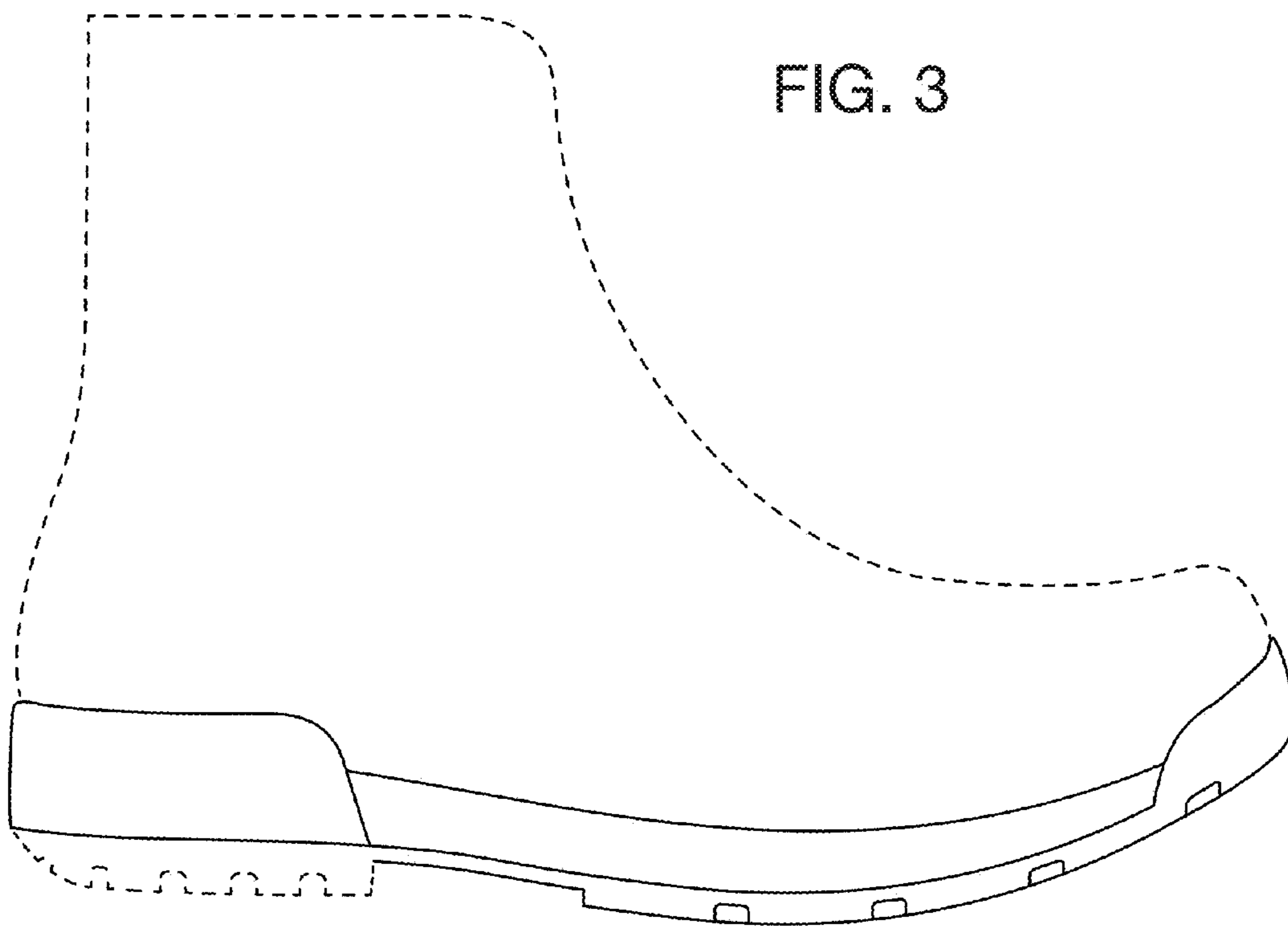

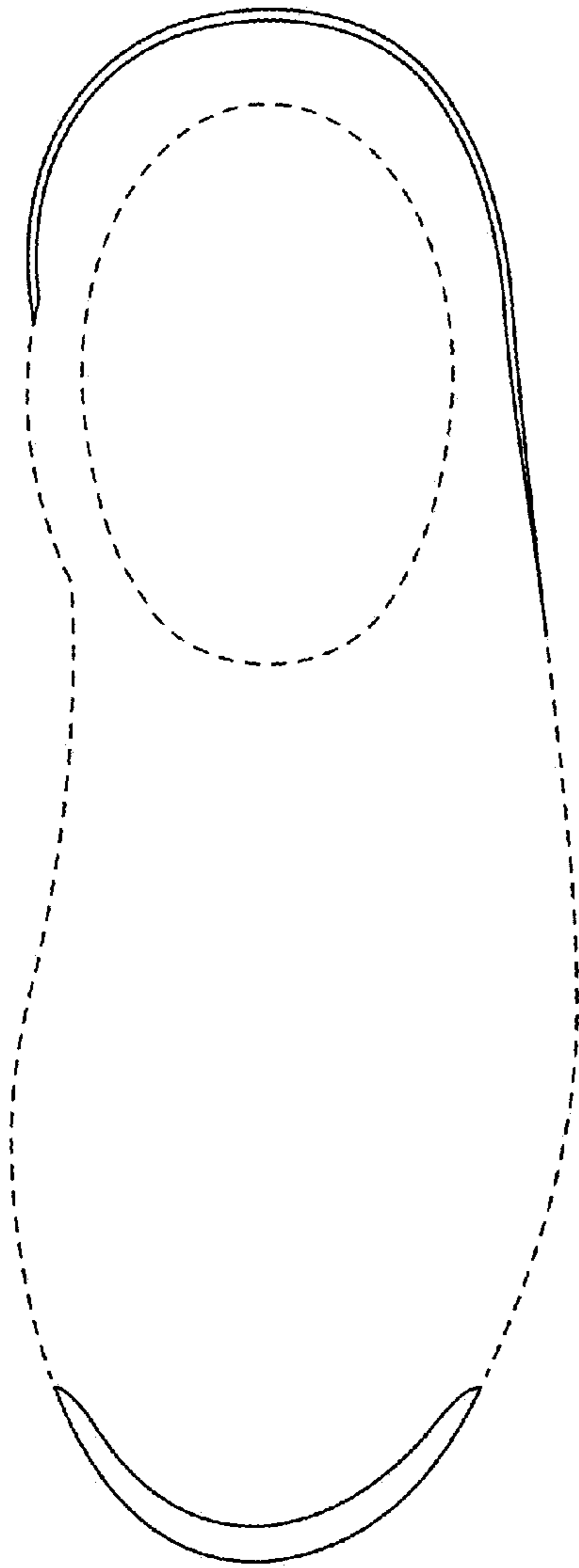

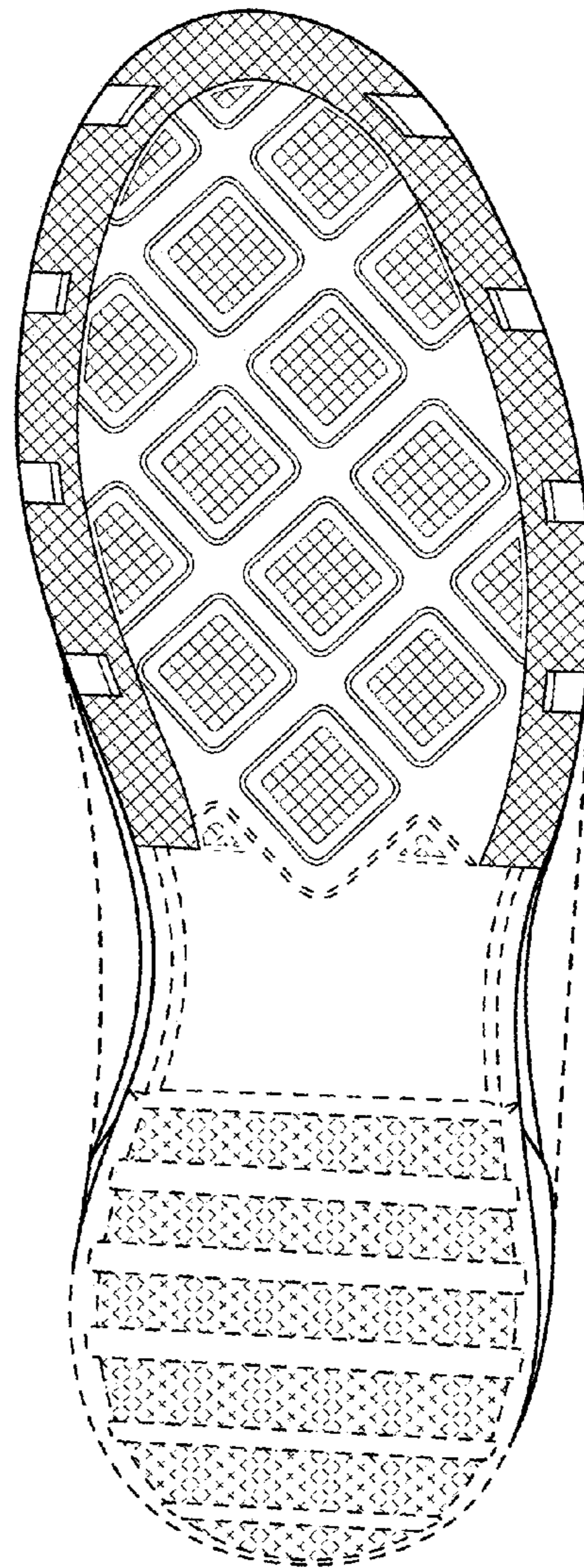

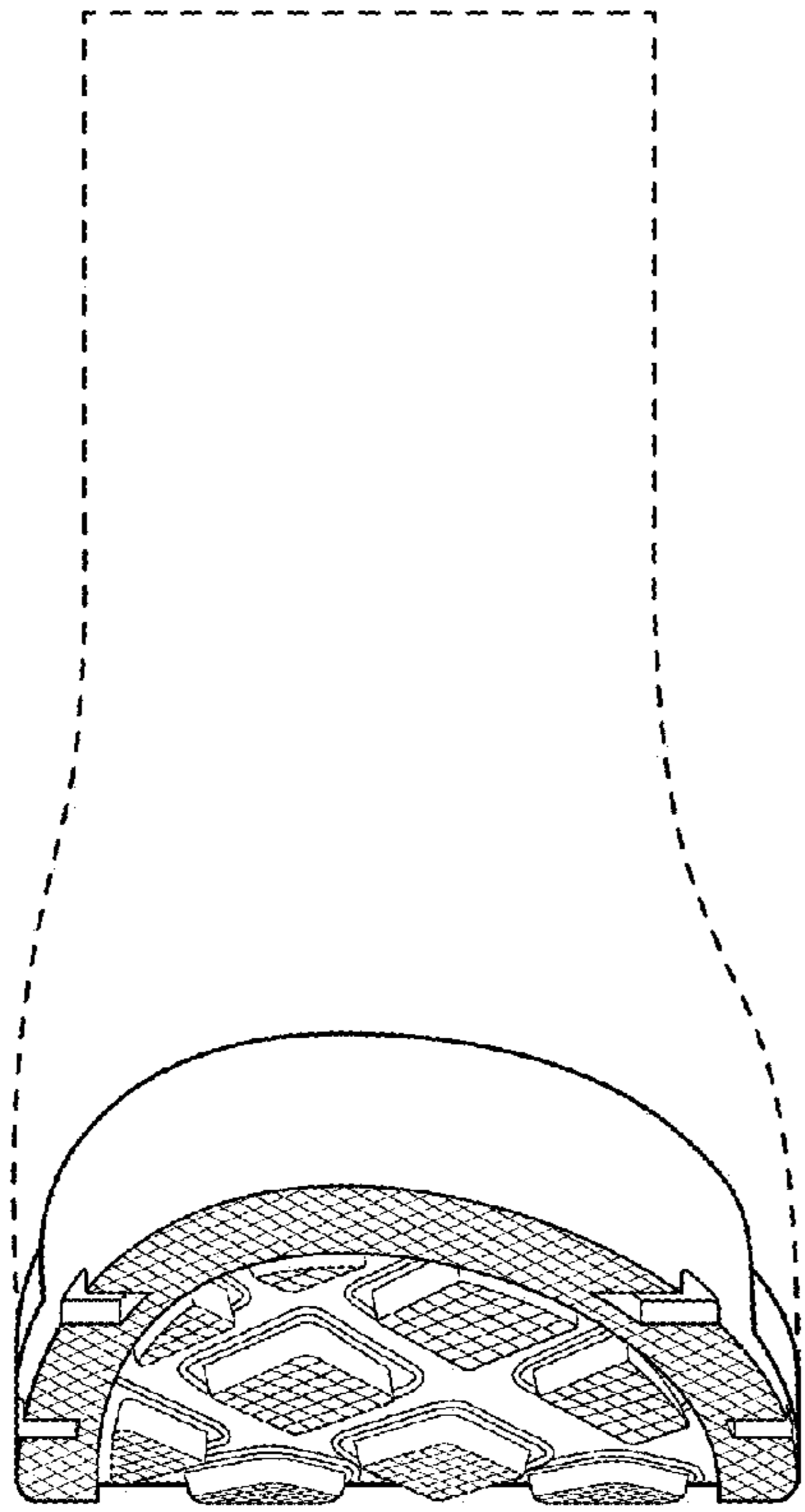
