The ornamental design for a portion of a slab, as shown and described.

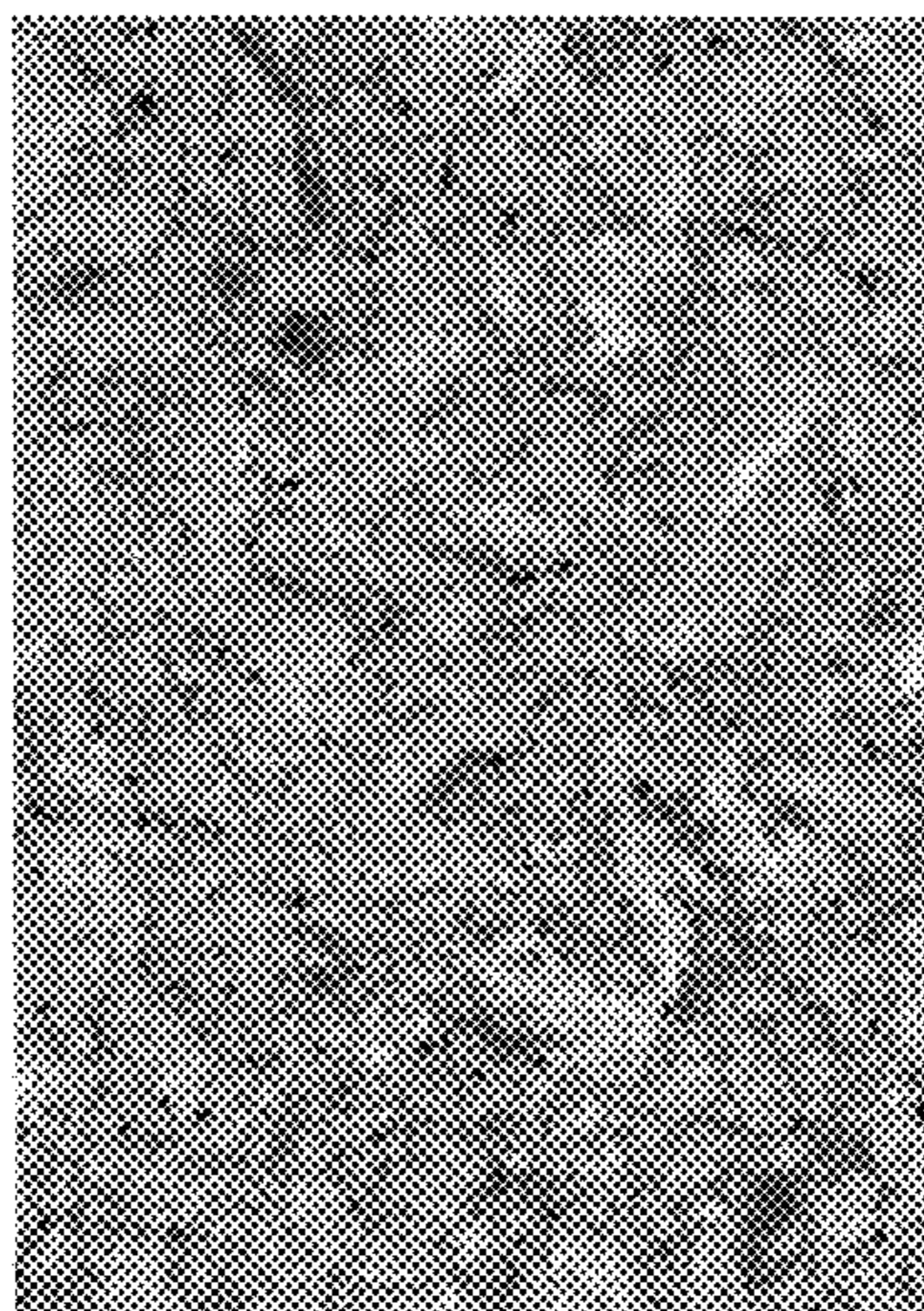
DESCRIPTION
