(57) **CLAIM**

The ornamental design for a storage container lid, as shown and described.

DESCRIPTION

FIG. 1 is a Top view of the lid and the surface ornamentation. The dashed line areas form no part of the claimed design. A solid line parallel to a dashed line marks the boundary between the claimed design and the unclaimed portion, and that solid, parallel line is not included in the claim.

FIG. 2 is a view of a detail of the lid, and the surface ornamentation.

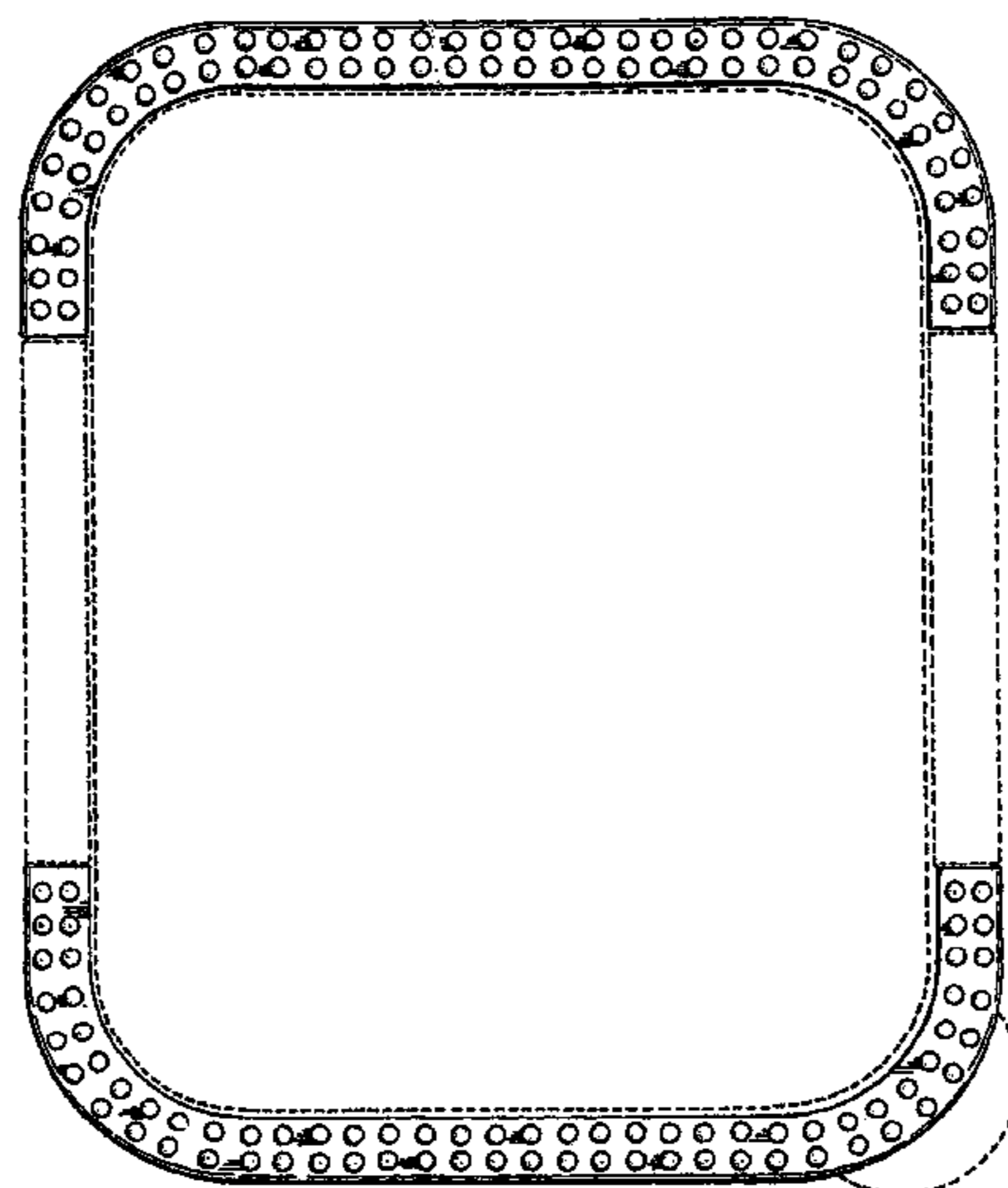
FIG. 3 is a Side view of the lid and surface ornamentation. FIG. 3 is a view of the side shown in detail in FIG. 2. The dashed line areas form no part of the claimed design.

FIG. 4 is a Side view of the lid and surface ornamentation. The dashed line areas form no part of the claimed design.

FIG. 5 is a Side view of the lid and surface ornamentation. FIG. 5 is a view of the side that extends between what is shown in FIGS. 3 and 4. The dashed line areas form no part of the claimed design. A solid line parallel to a dashed line marks the boundary between the claimed design and the unclaimed portion, and that solid, parallel line is not included in the claim; and,

FIG. 6 is a Side view of the lid and surface ornamentation. FIG. 6 also is a view of the side that extends between what is shown in FIGS. 3 and 4. The dashed line areas form no part of the claimed design. A solid line parallel to a dashed line marks the boundary between the claimed design and the unclaimed portion, and that solid, parallel line is not included in the claim.

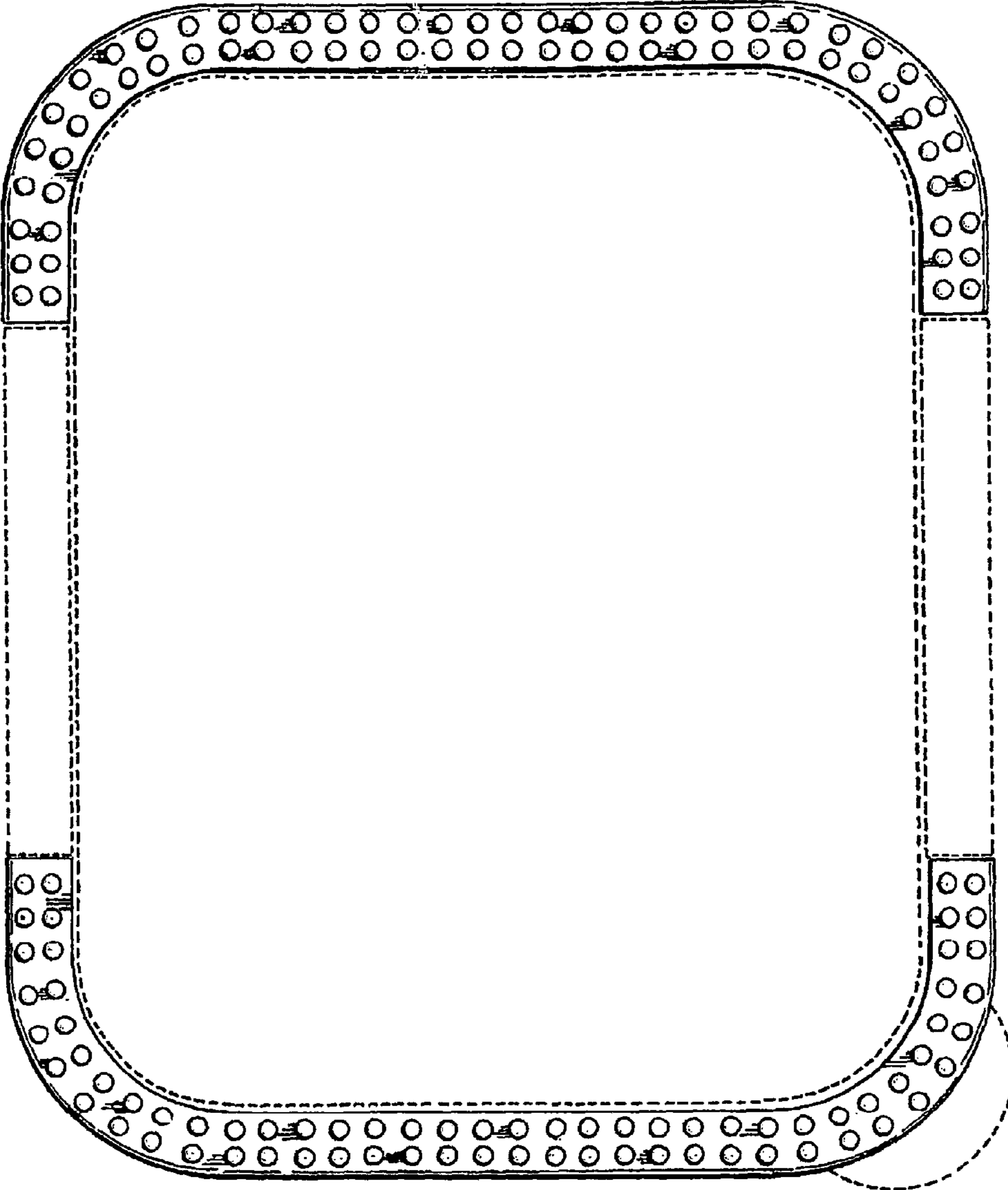

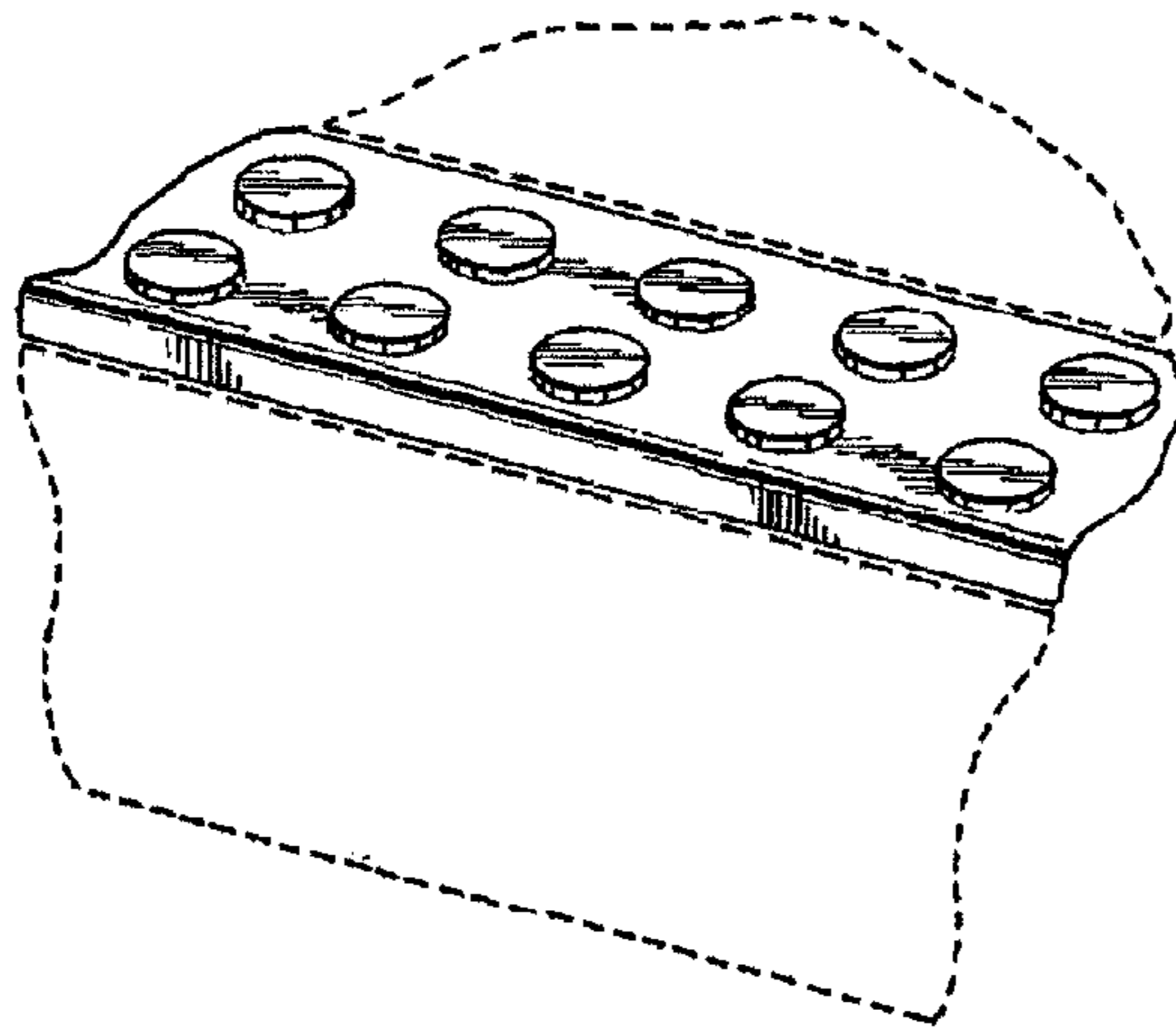

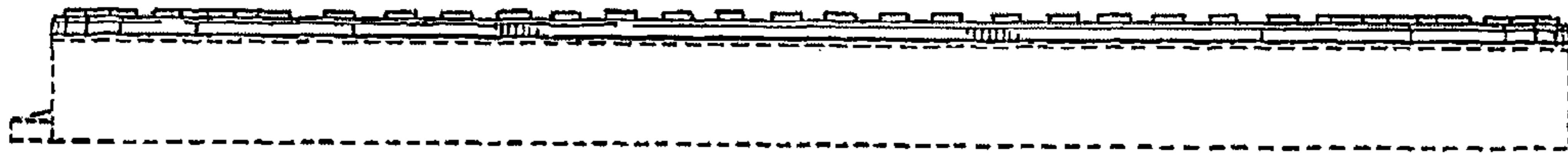

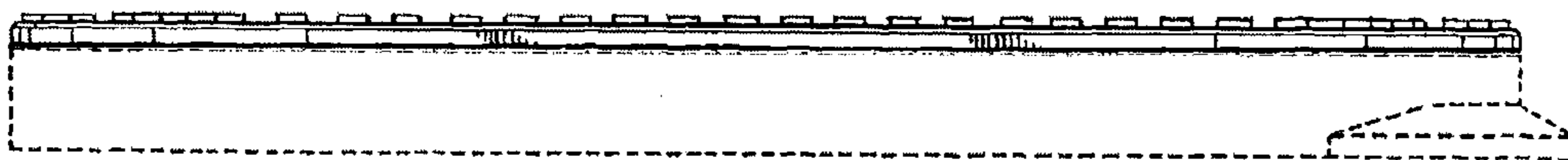

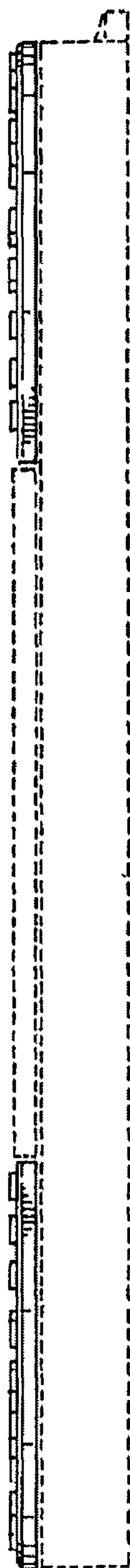

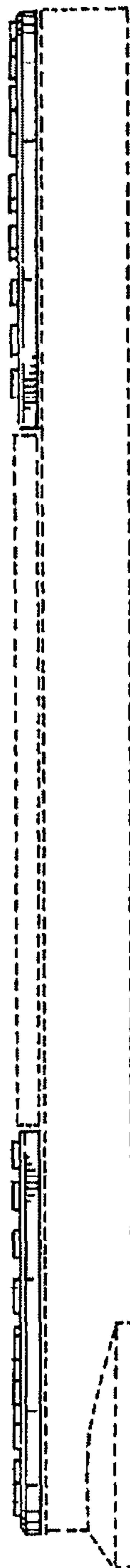
