(57) **CLAIM**

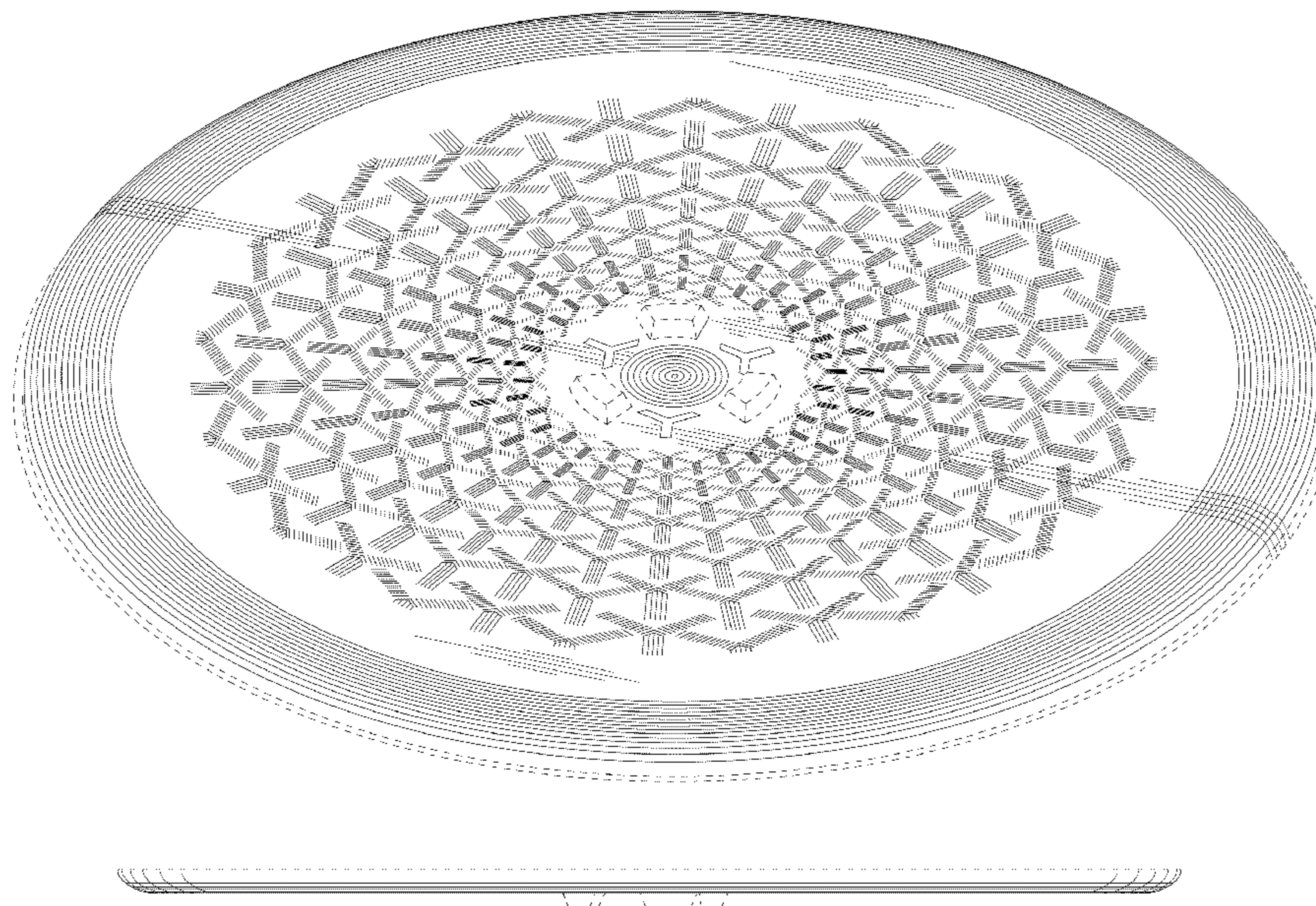
The ornamental design for a tray for microwave oven, as shown and described.

DESCRIPTION

FIG. 1 is a bottom, front perspective view of a tray for microwave oven showing my new design;
FIG. 2 is a front elevational view thereof;

FIG. 4 is a left side elevational view thereof;

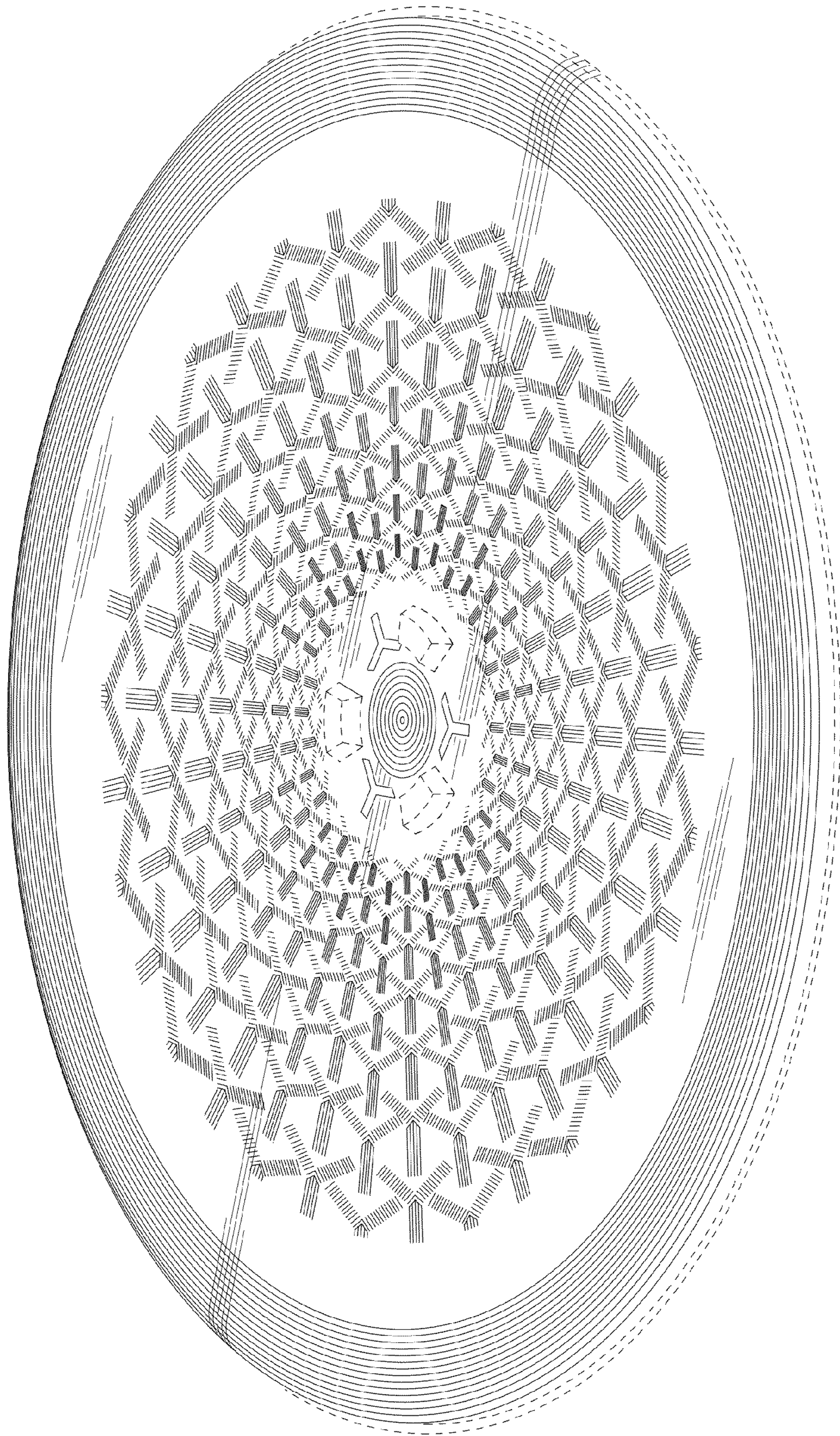

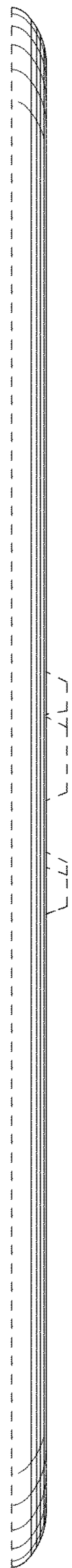

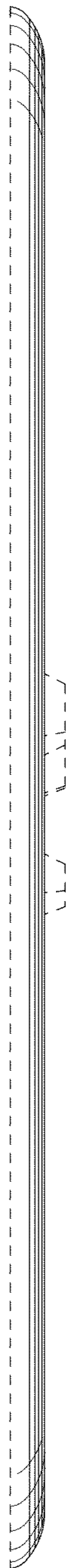

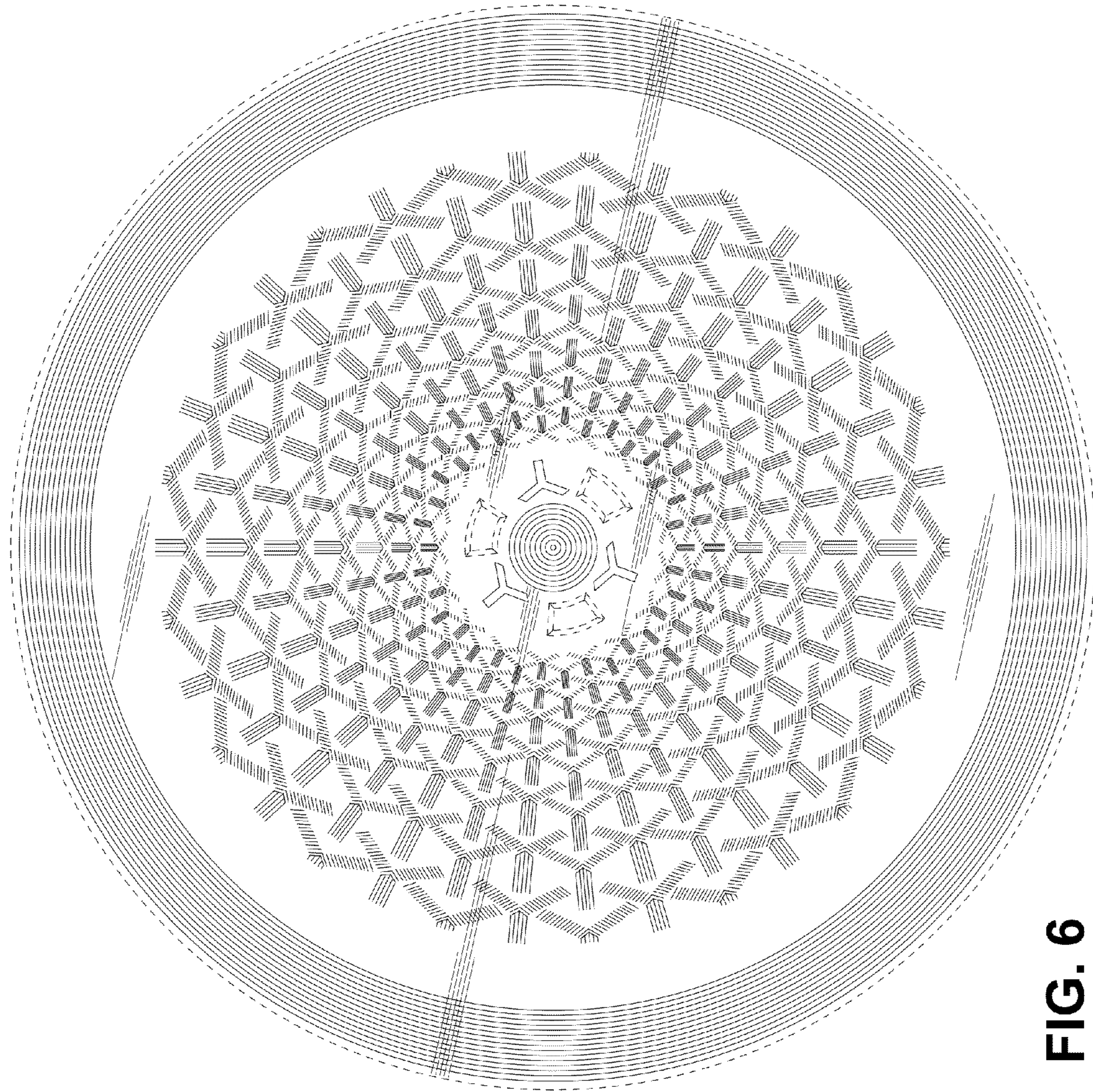
