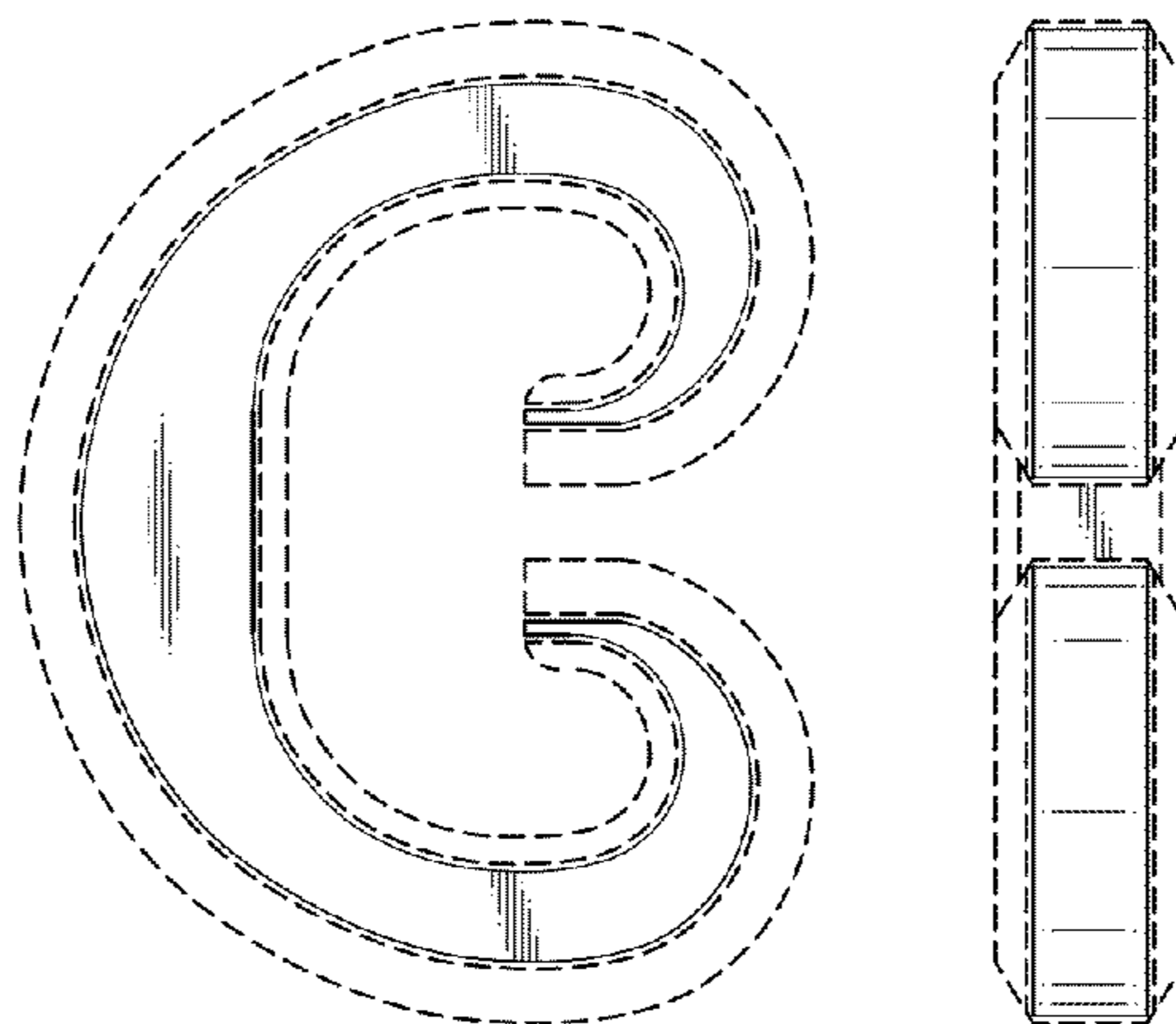
(57) **CLAIM**

The ornamental design for a clip for securing elastic bands, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the clip for securing elastic bands.  
 FIG. 2 is a front view of the clip.  
 FIG. 3 is a side view of the clip.  
 FIG. 4 is a back view of the clip.  
 FIG. 5 is another side view of the clip.  
 FIG. 6 is a bottom view of the clip; and,  
 FIG. 7 is a top view of the clip.  
 The dot-dash lines adjacent the shaded areas represent the boundaries of the claim. They indicate that the four unshaded chamfers are not part of the claimed design.

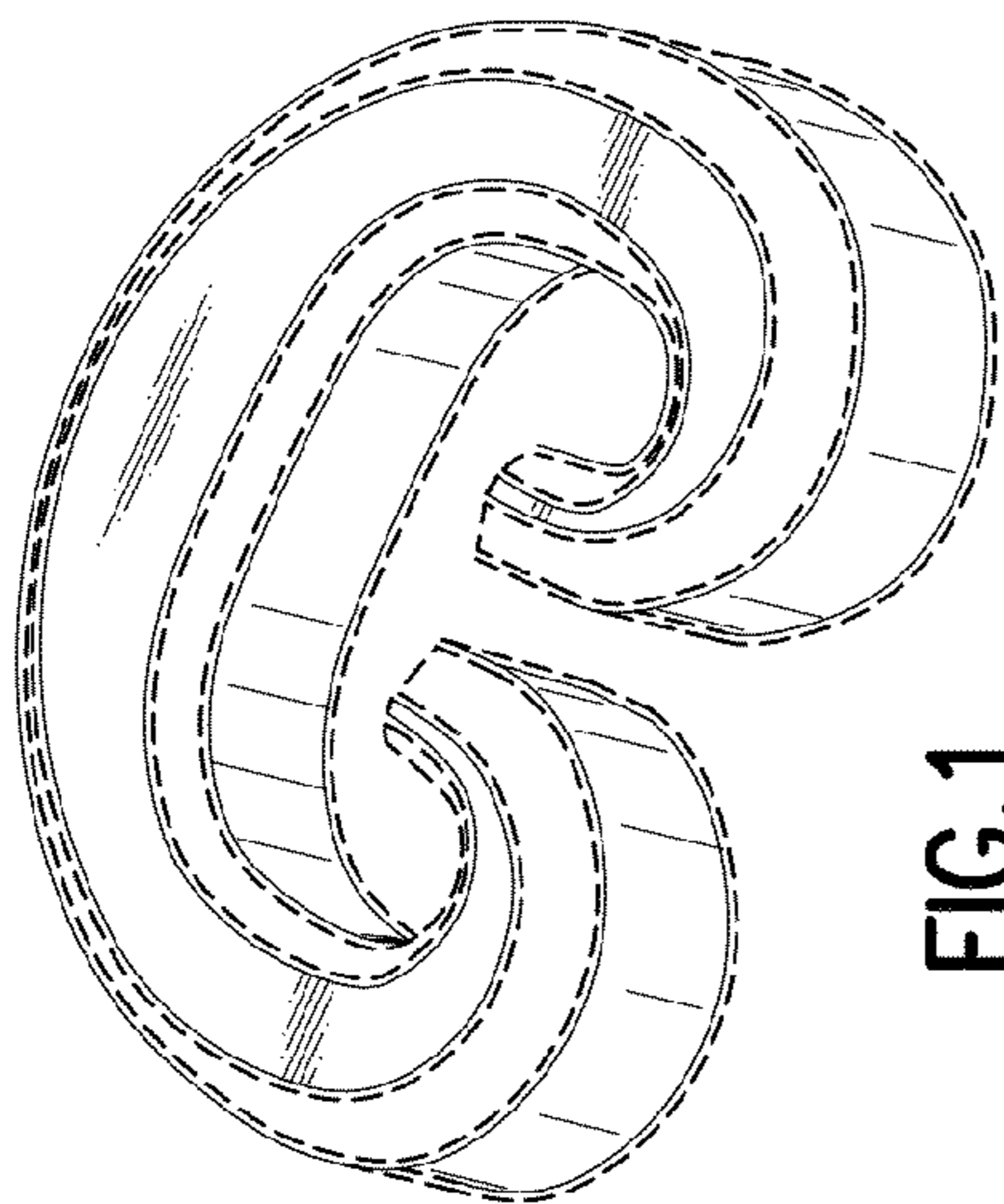

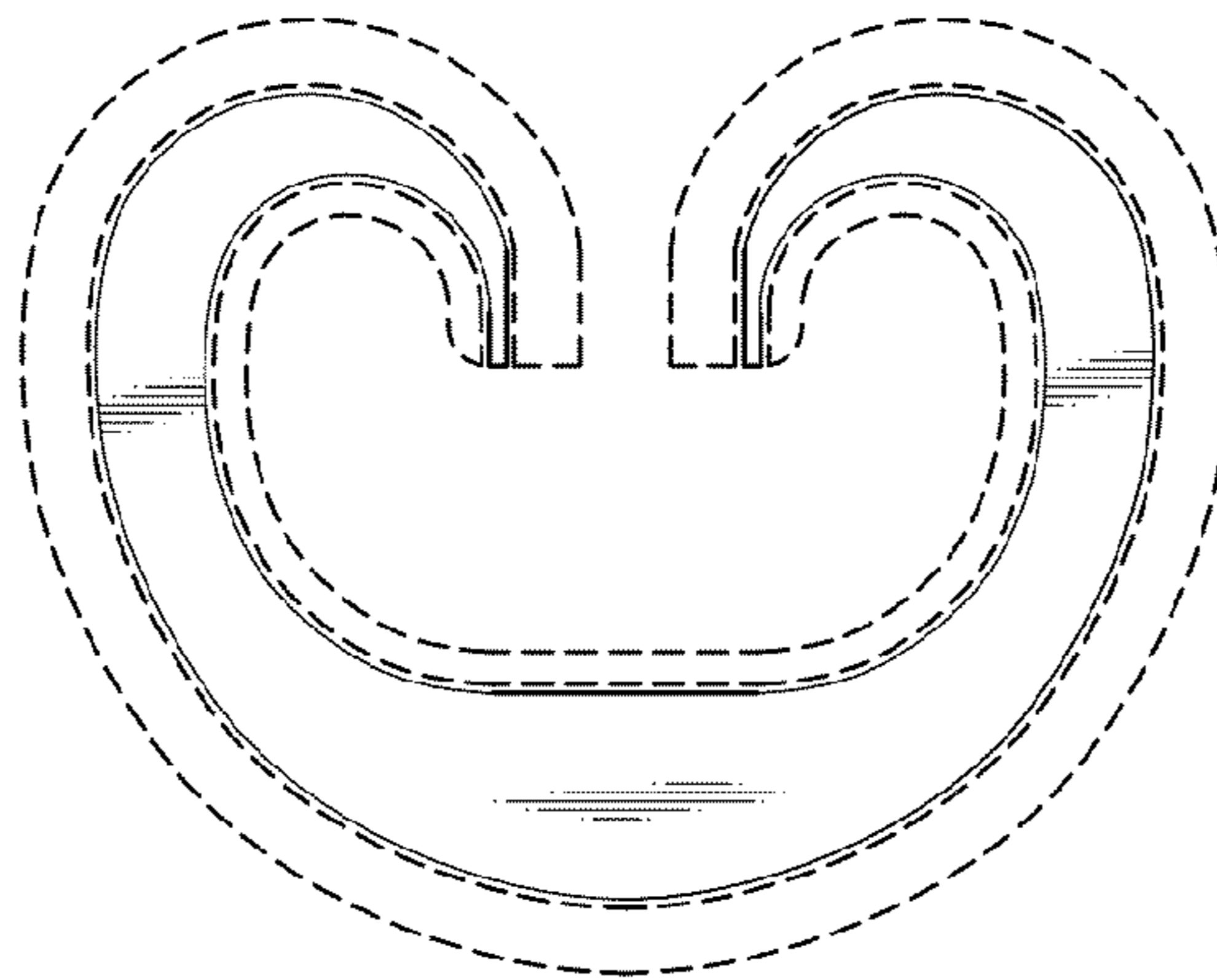

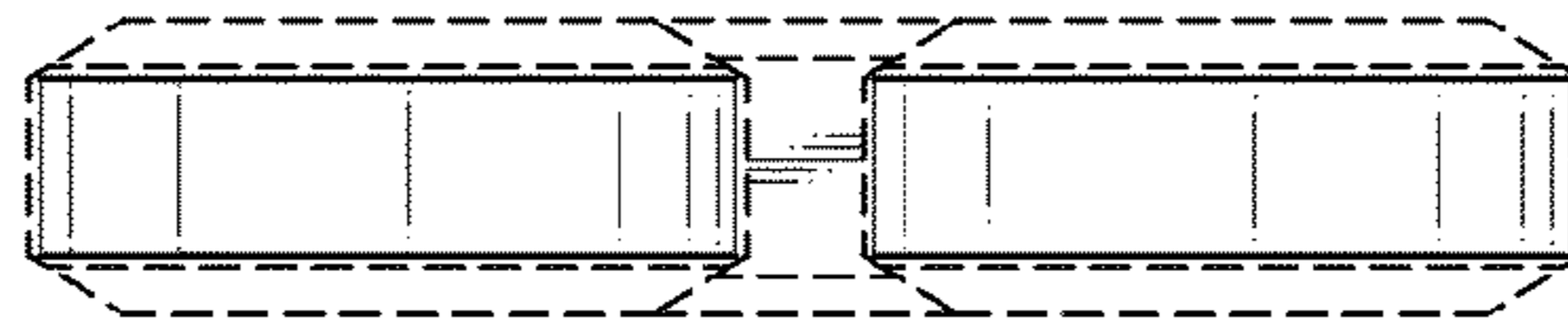

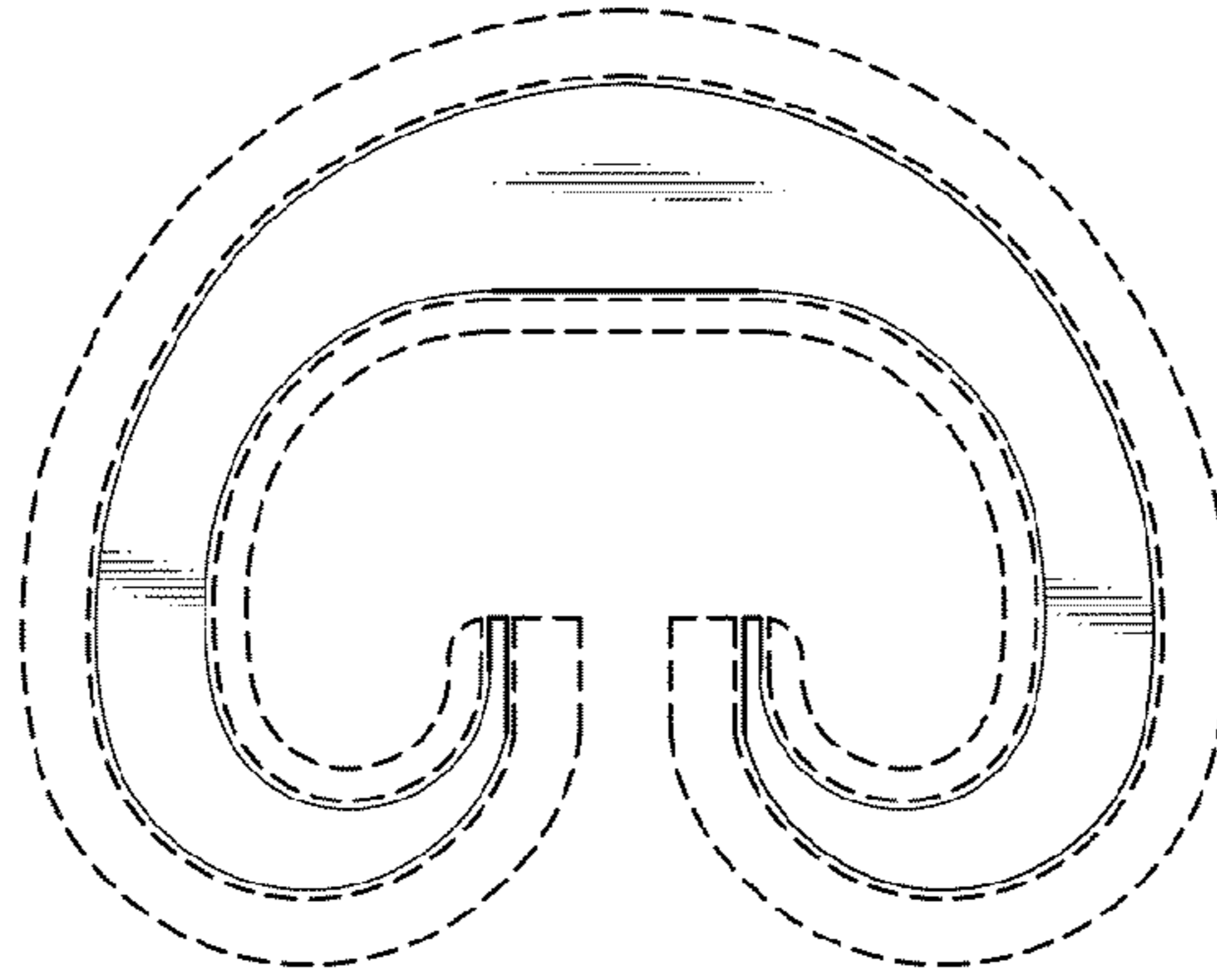

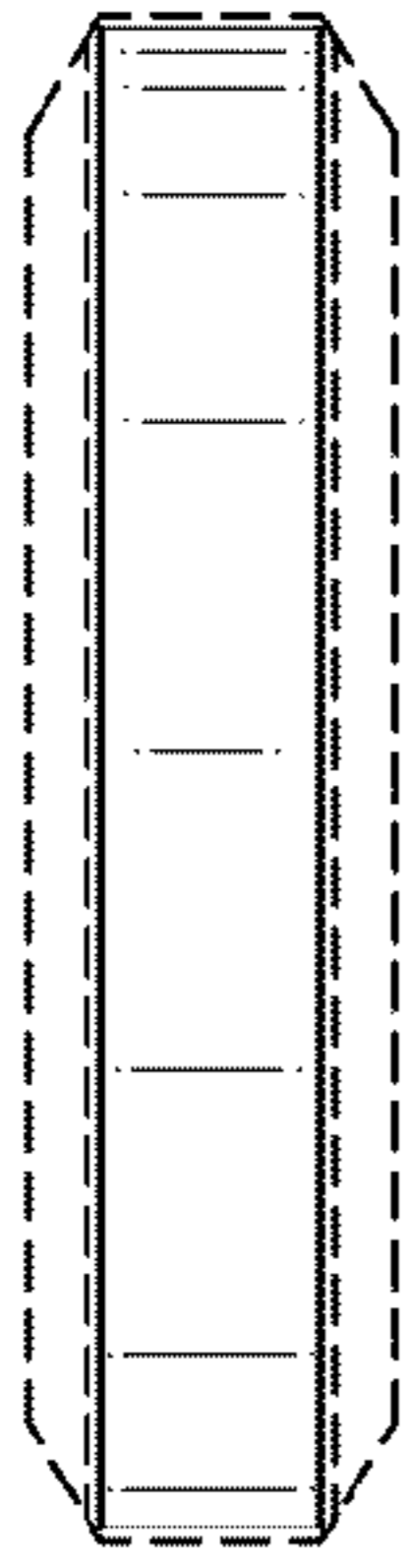

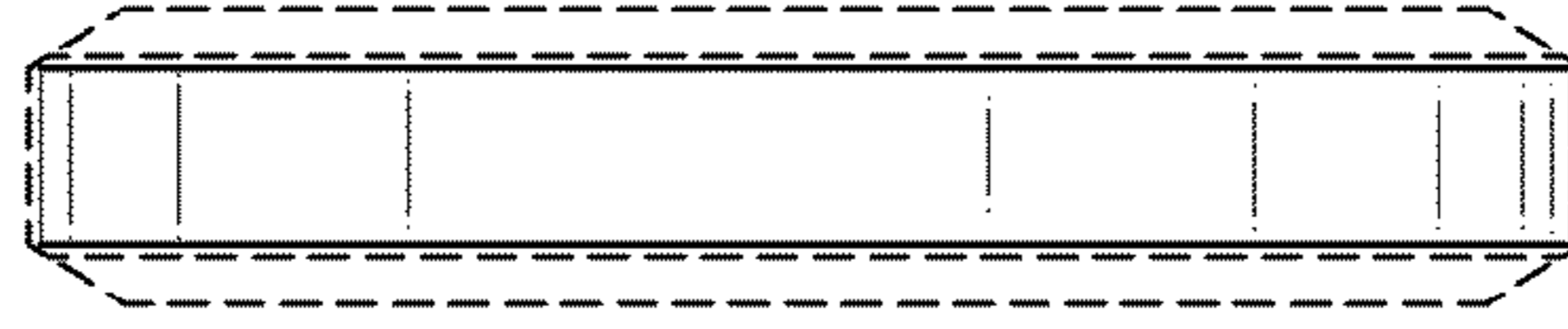
