(57) **CLAIM**

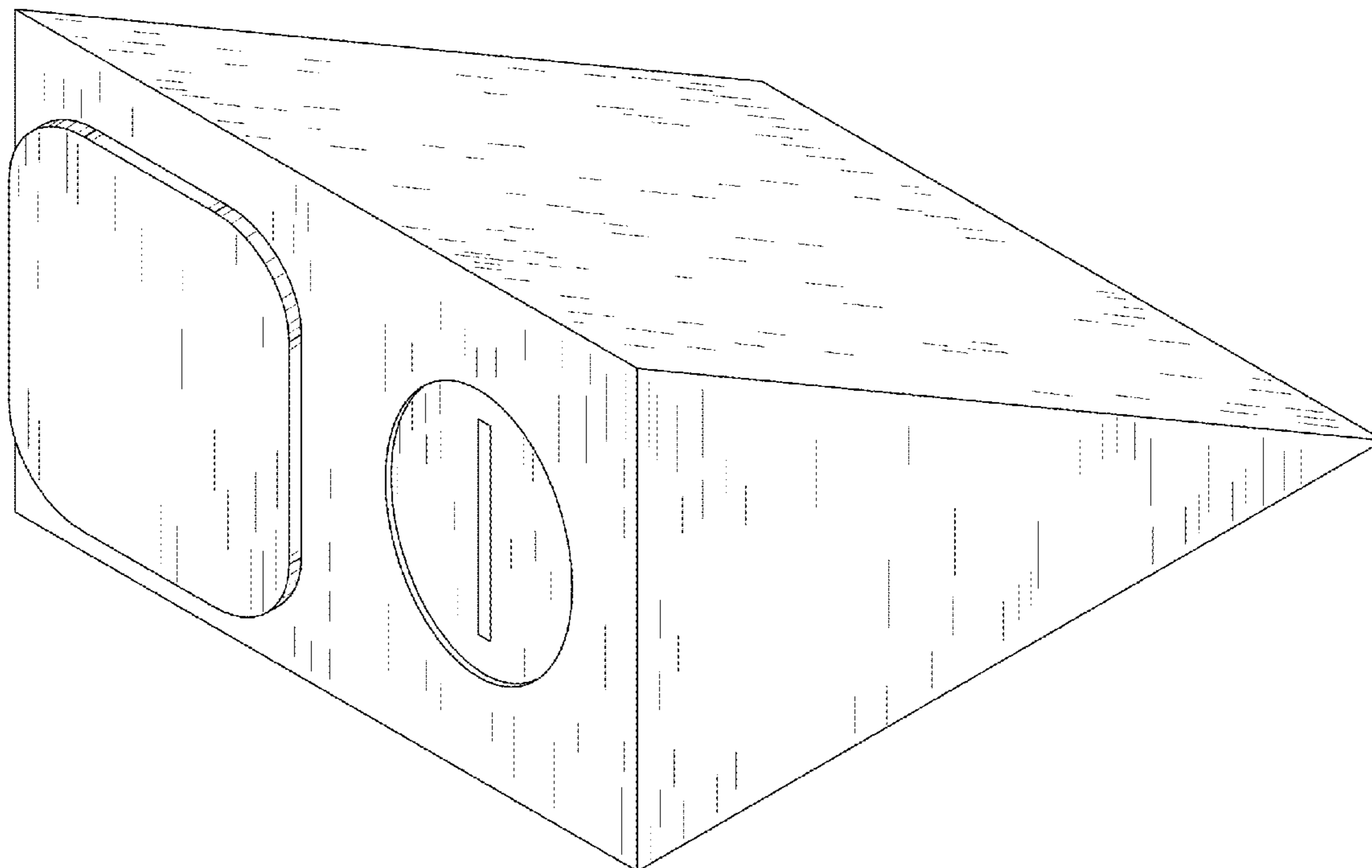
The ornamental design for a triangular wedge shaped tissue and wet wipe container, as shown and described.

**DESCRIPTION**

FIG. 1 is a left-side elevational view of a triangular wedge shaped tissue and wet wipe container;

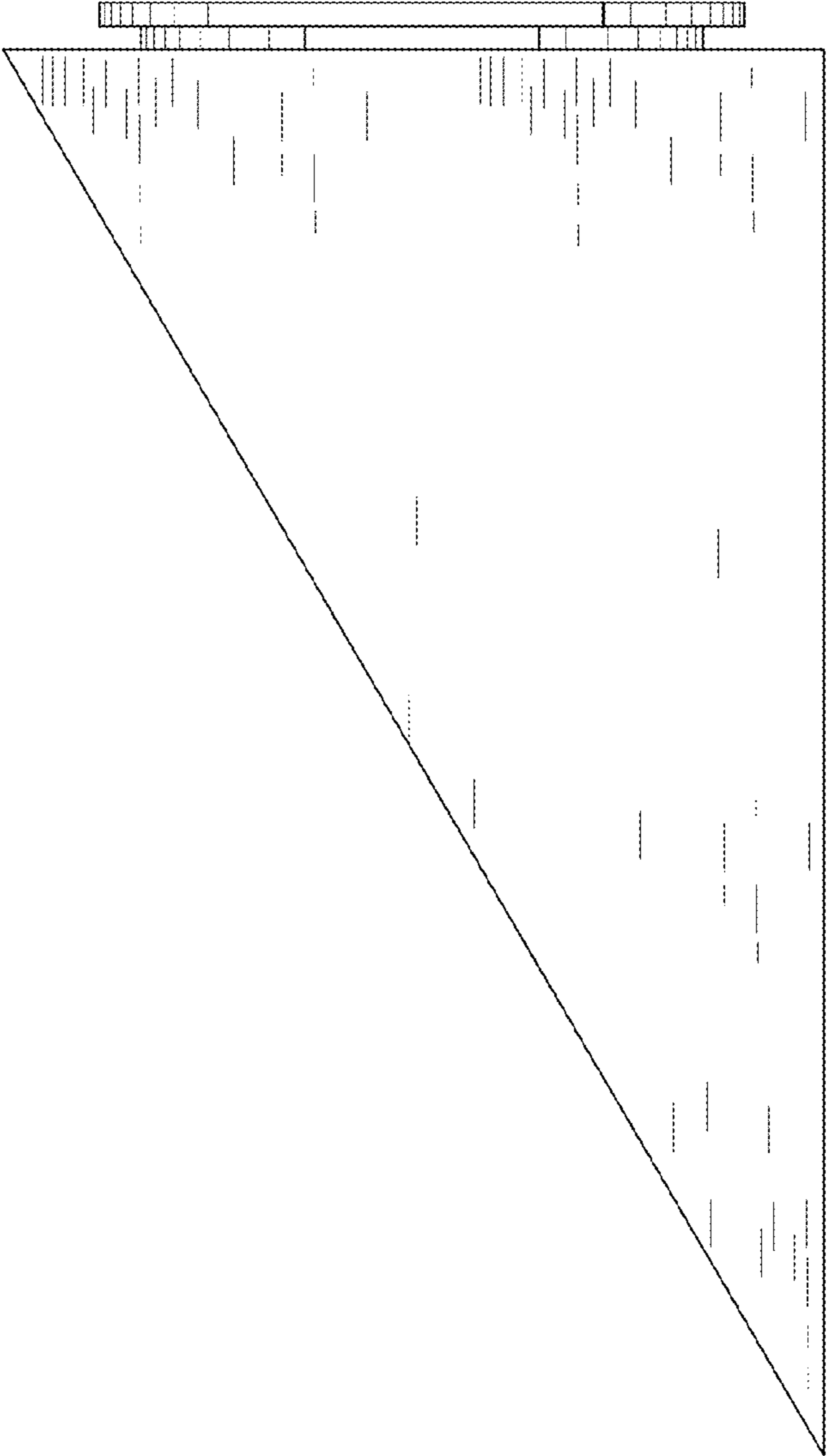

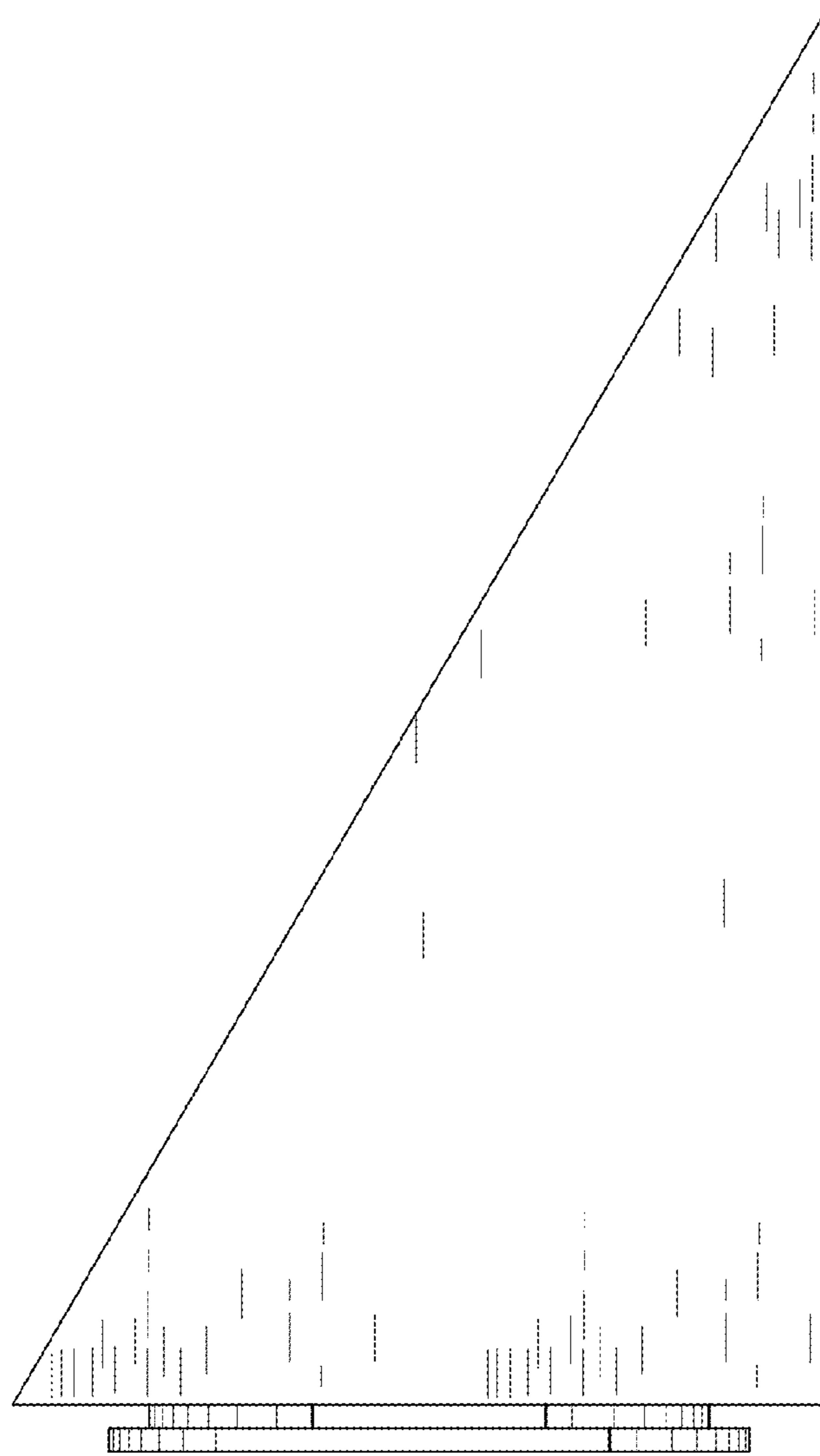

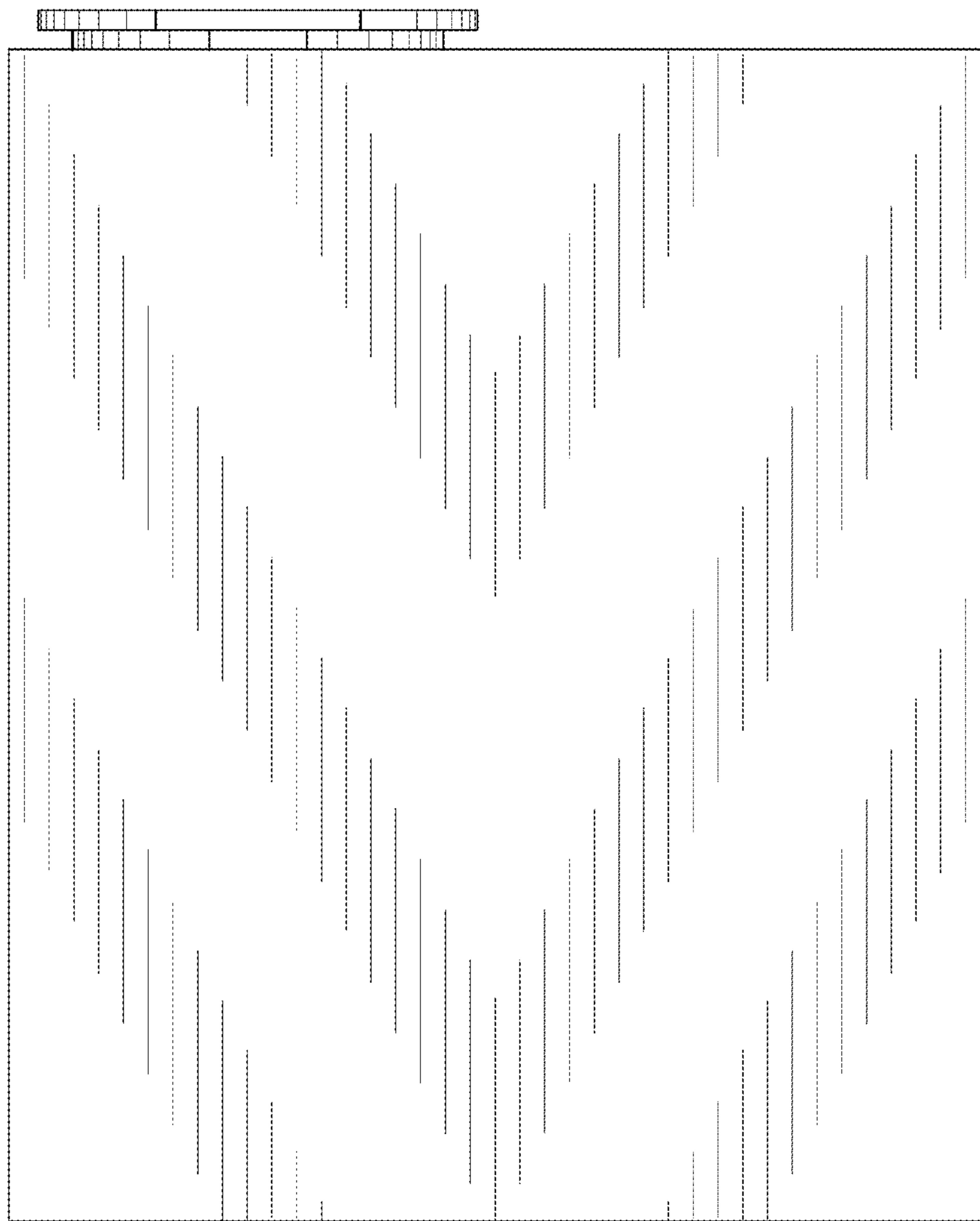

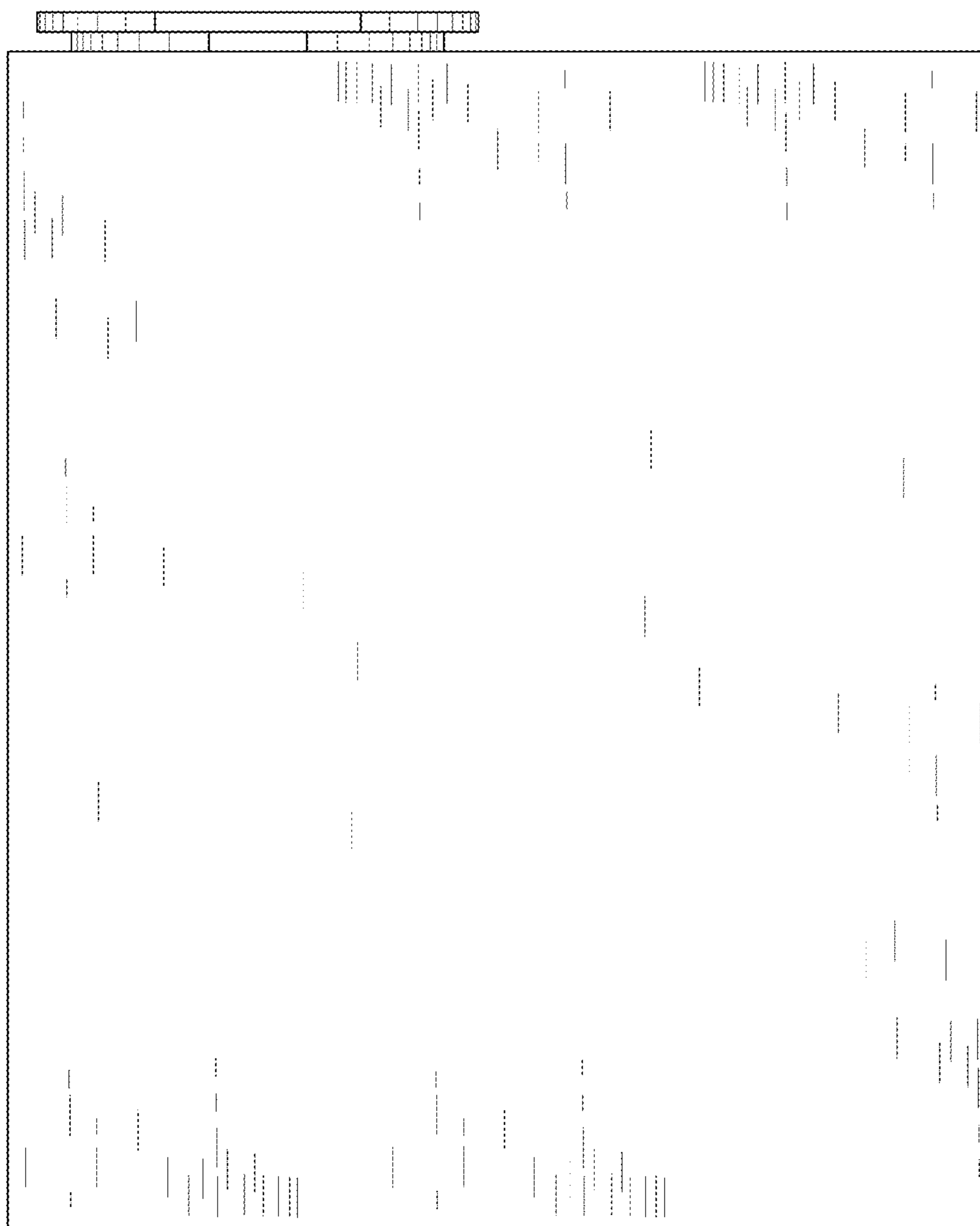

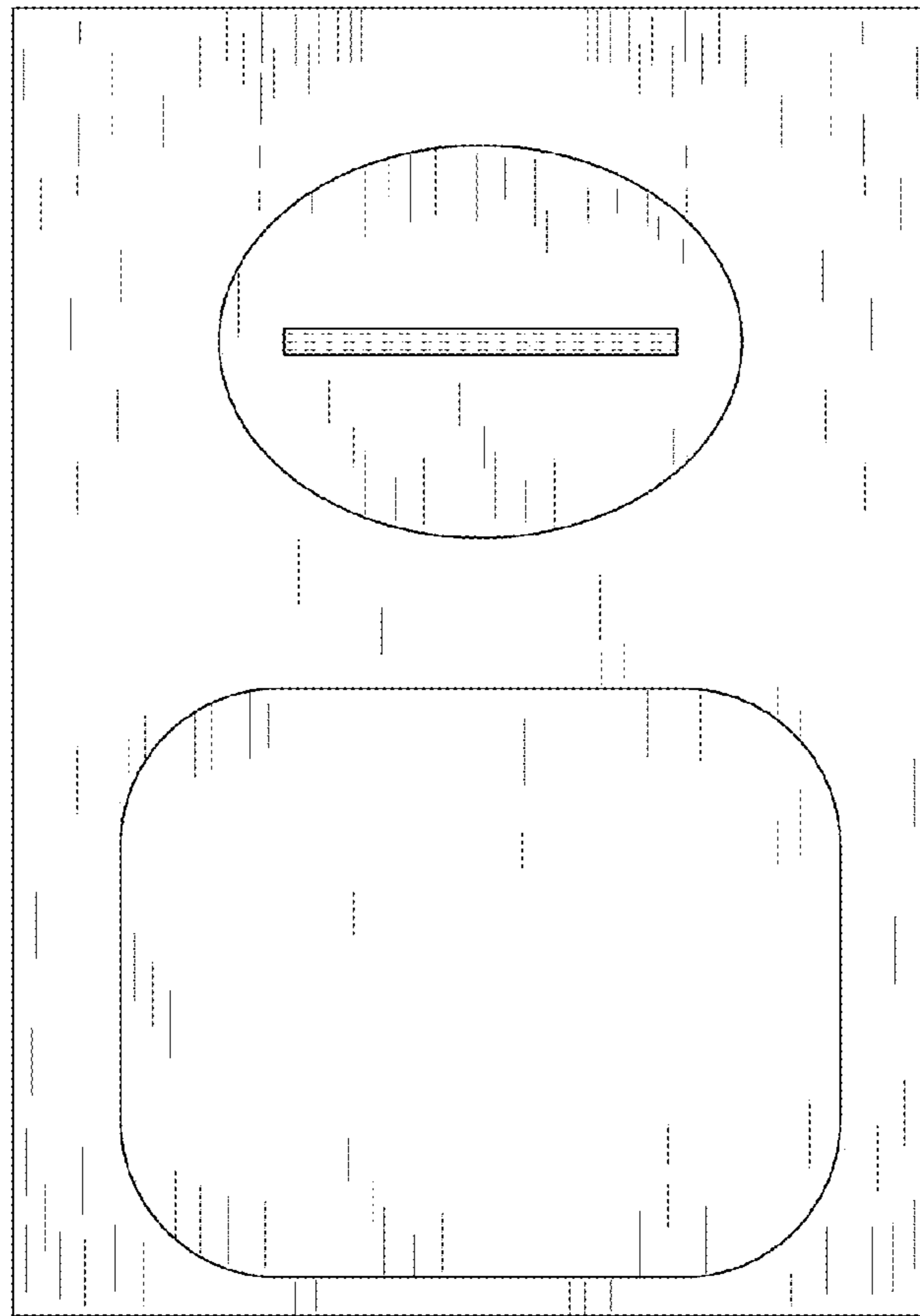

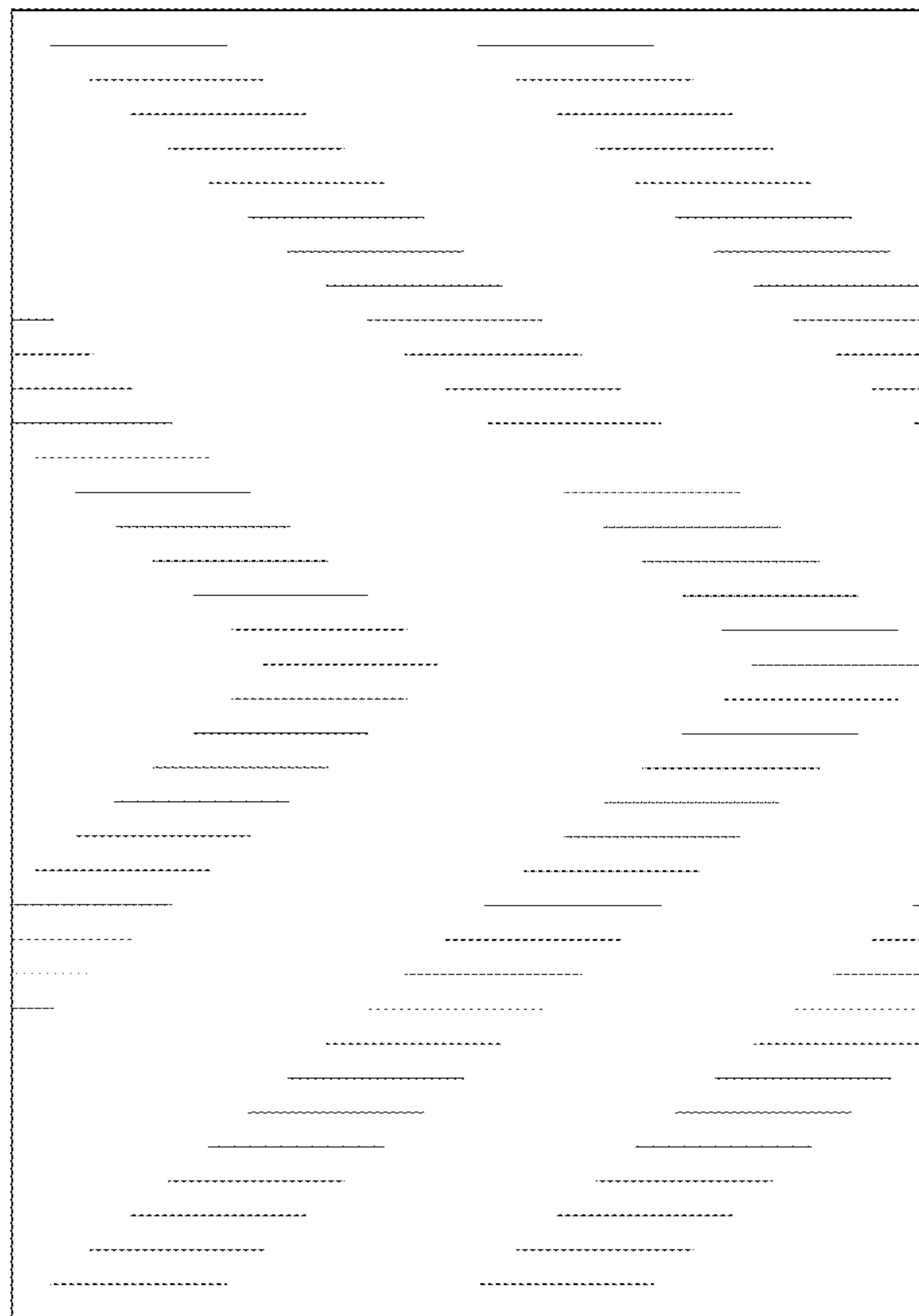

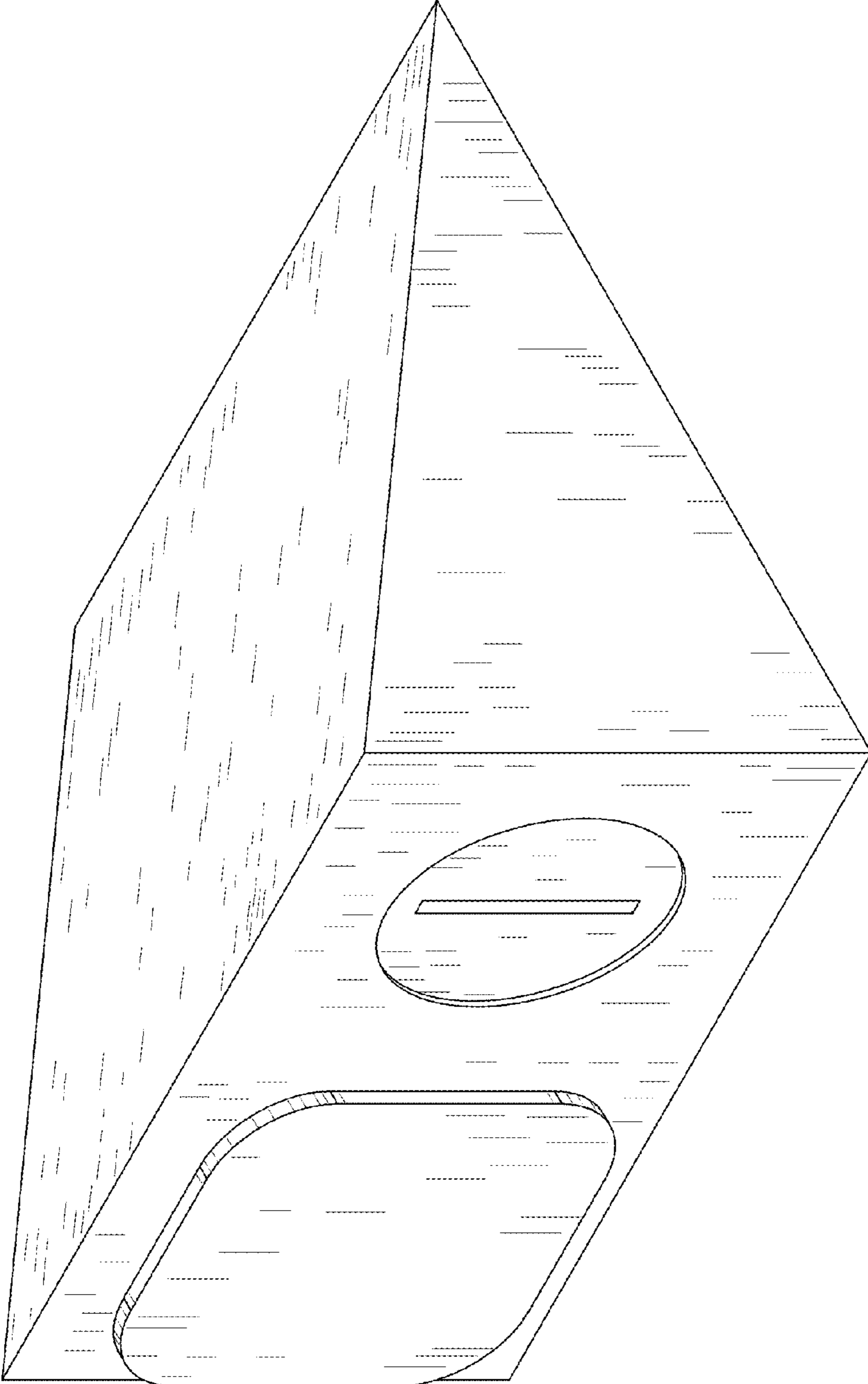
