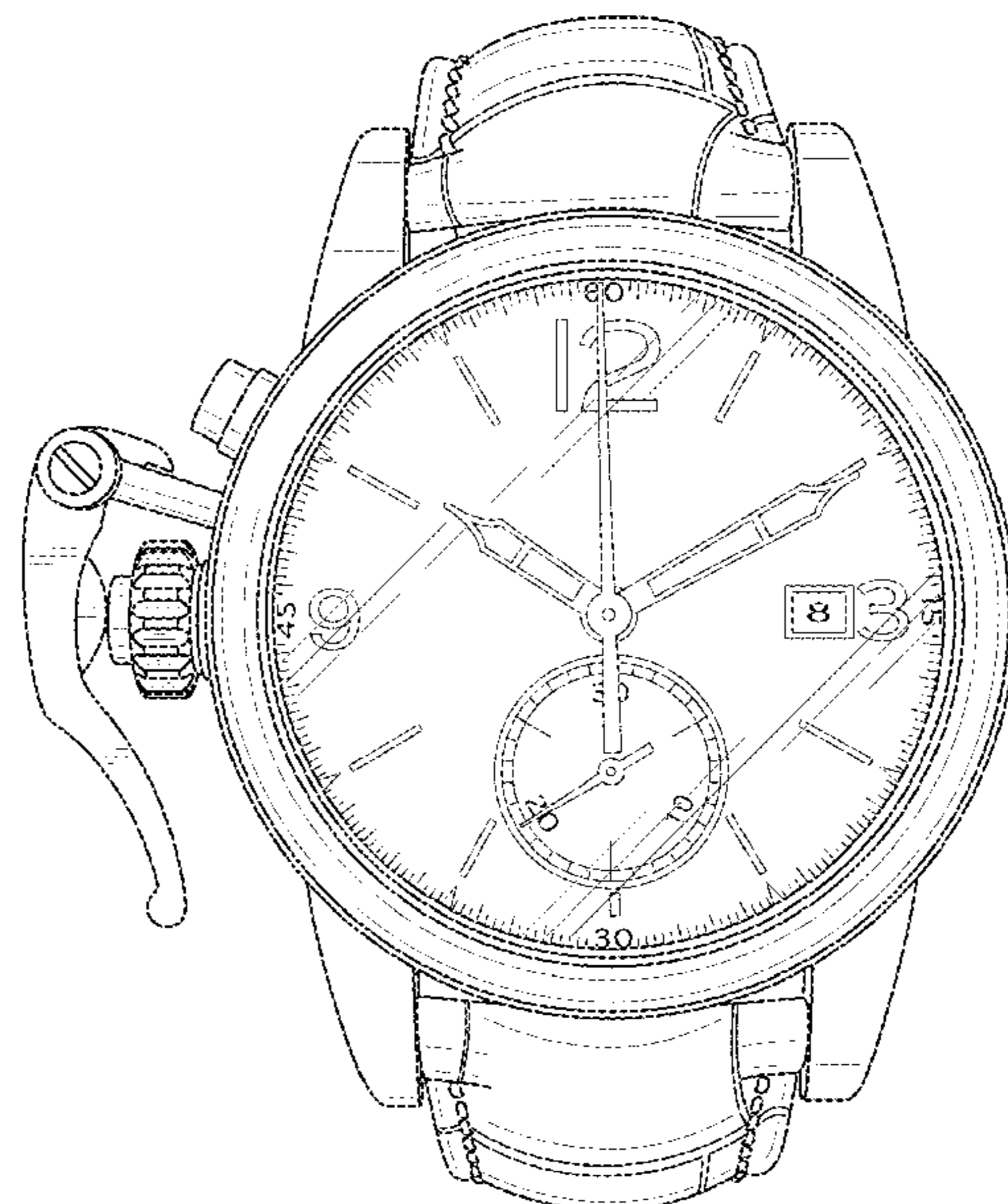
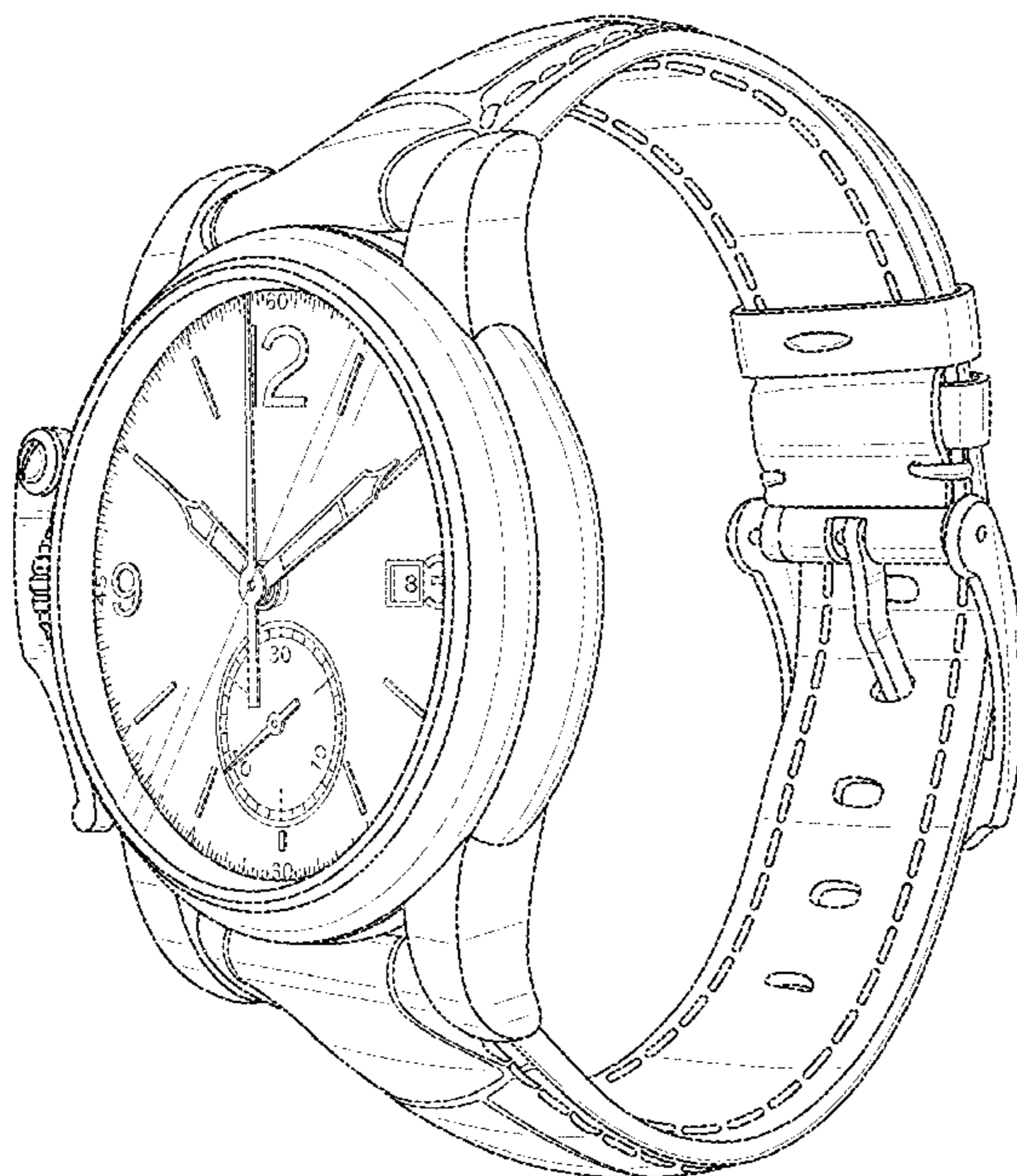
(57) **CLAIM**

The ornamental design for a wristwatch, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the front and right side of a wristwatch showing my new design; FIG. 2 is a perspective view of the rear and left side thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a left side elevational view thereof; FIG. 6 is a right side elevational view thereof; FIG. 7 is a top plan view thereof; and, FIG. 8 is a bottom plan view thereof. The broken lines are used in FIGS. 2, 4, 5, 6, 7 and 8 in the drawings to show portions of the rear of the watch case that do not form part of the claimed design.

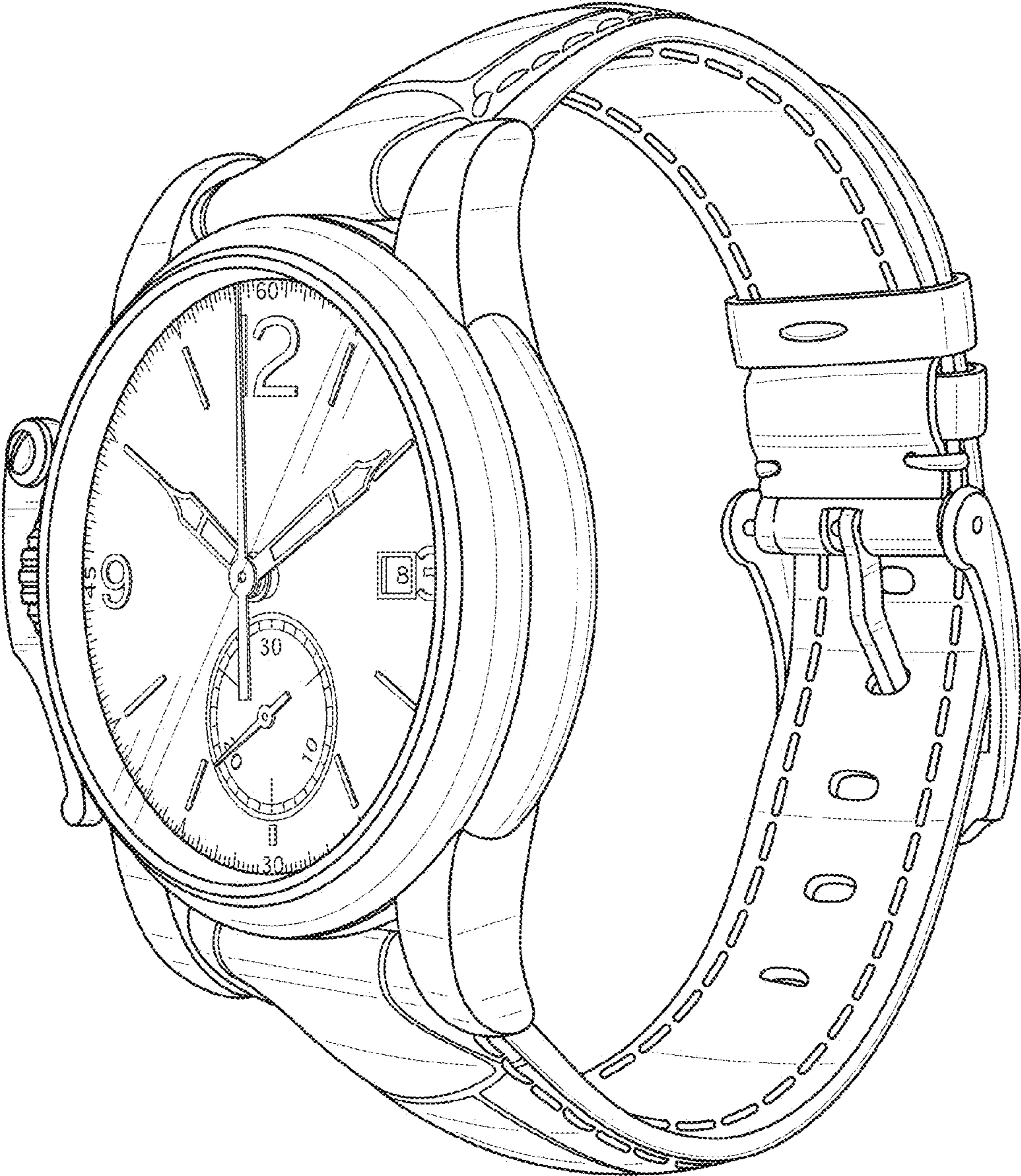

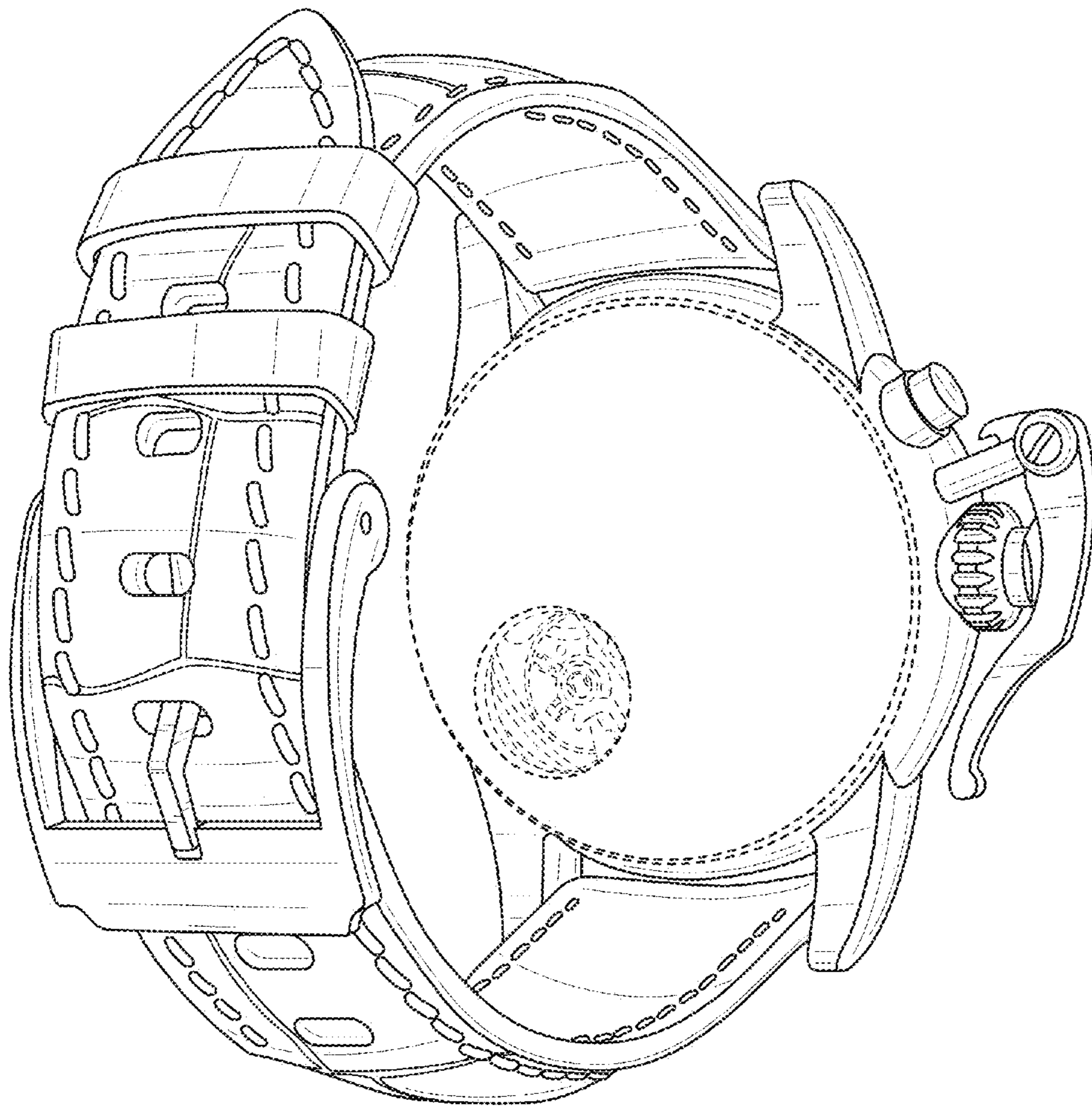

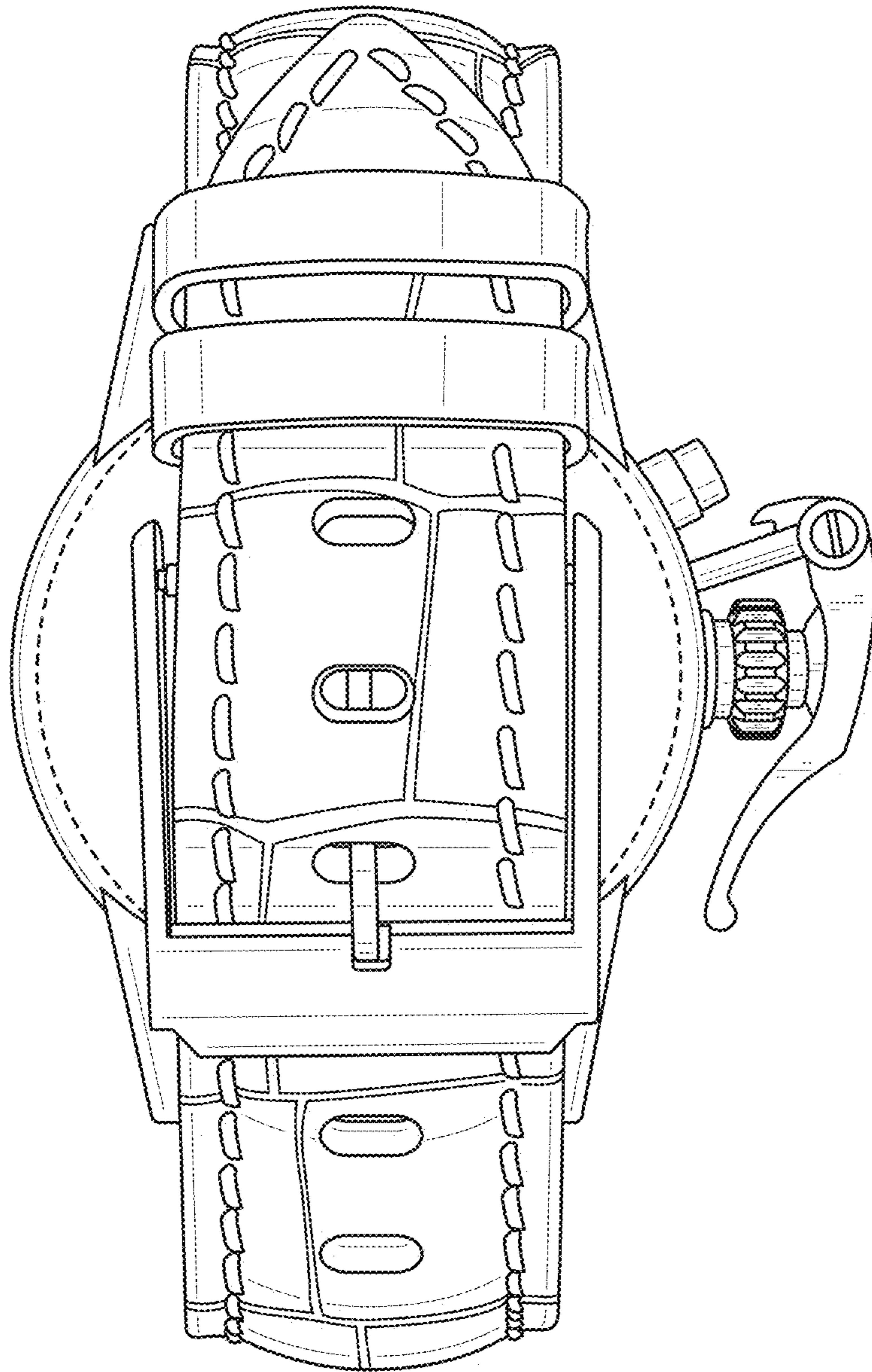

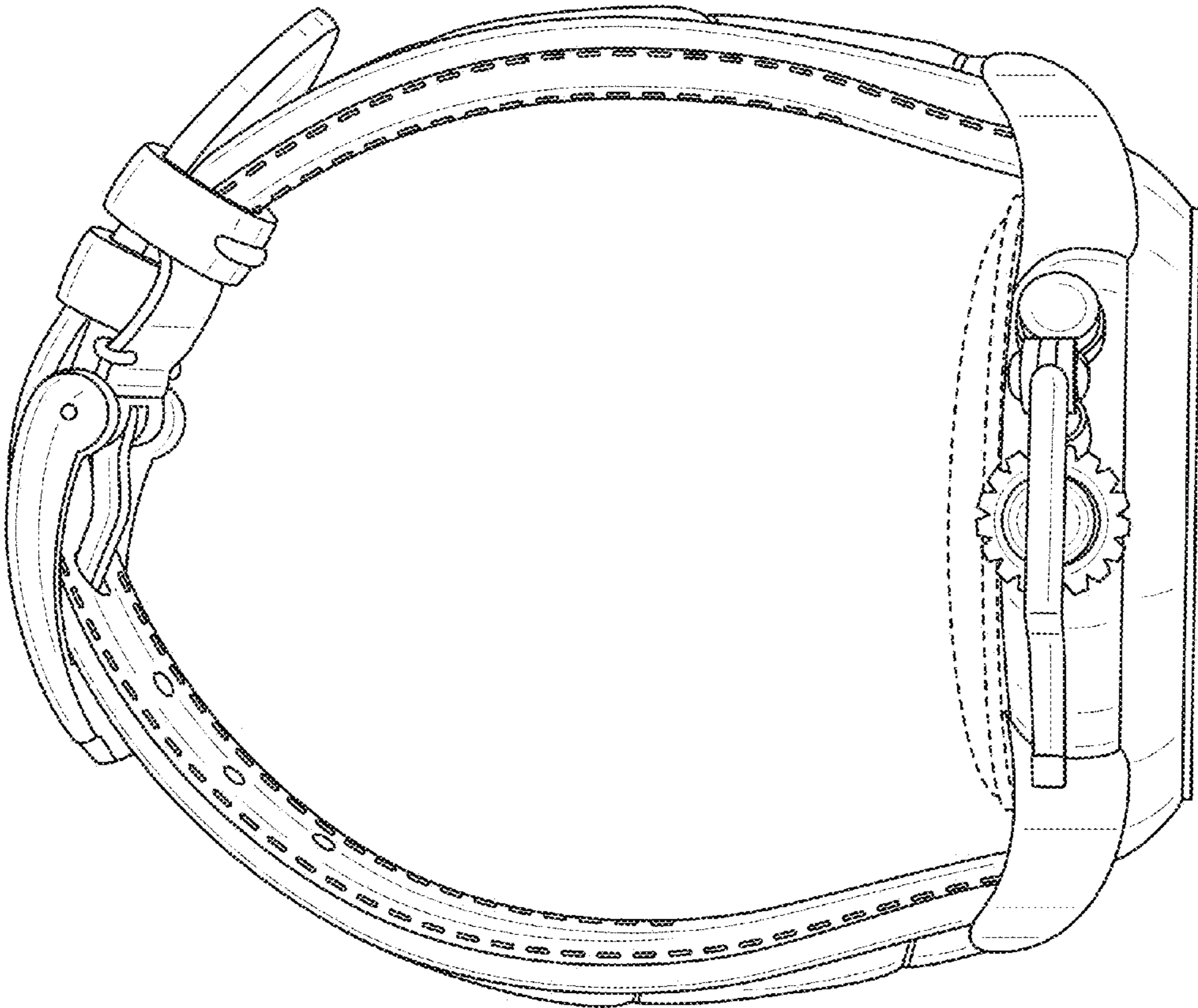

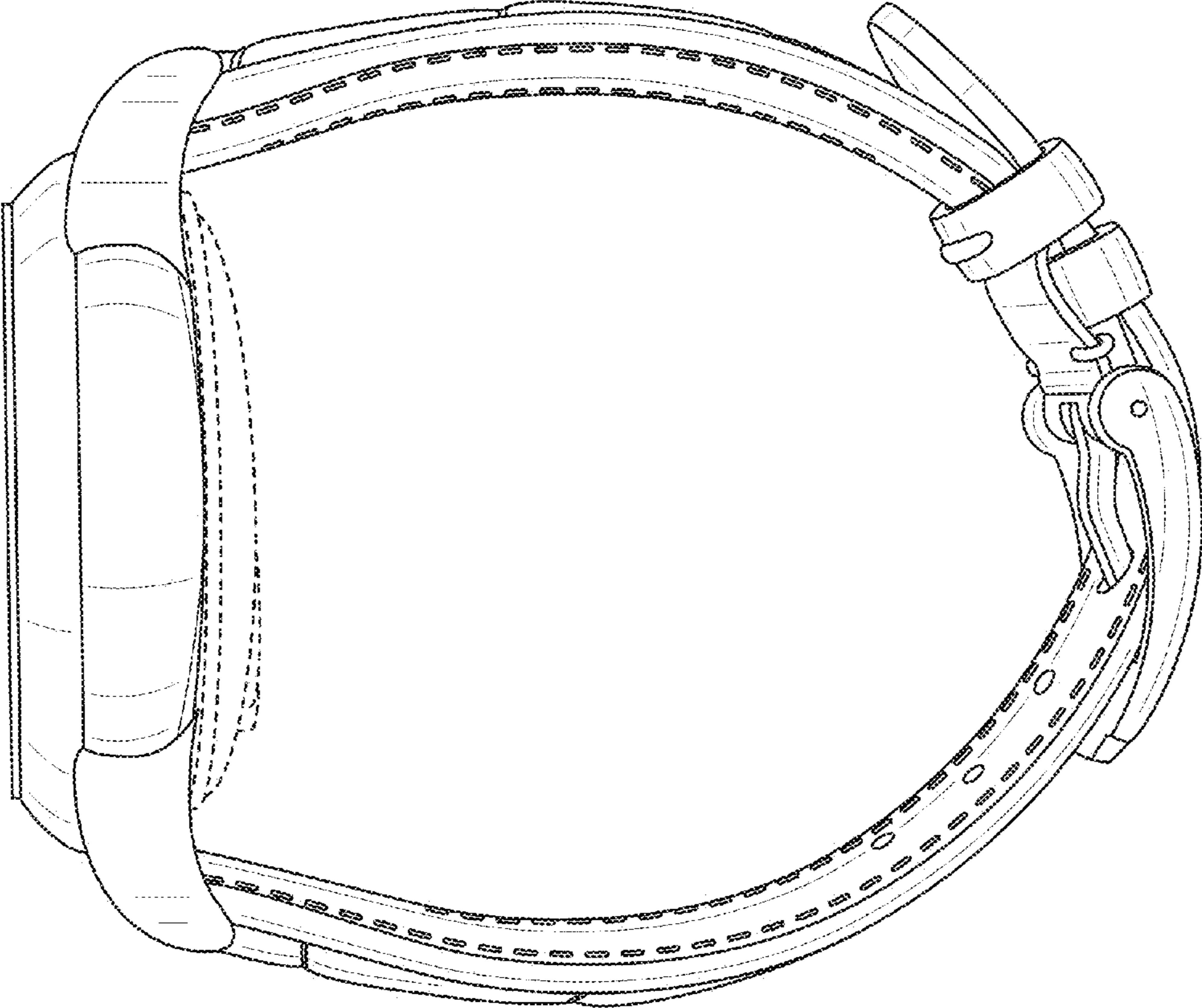

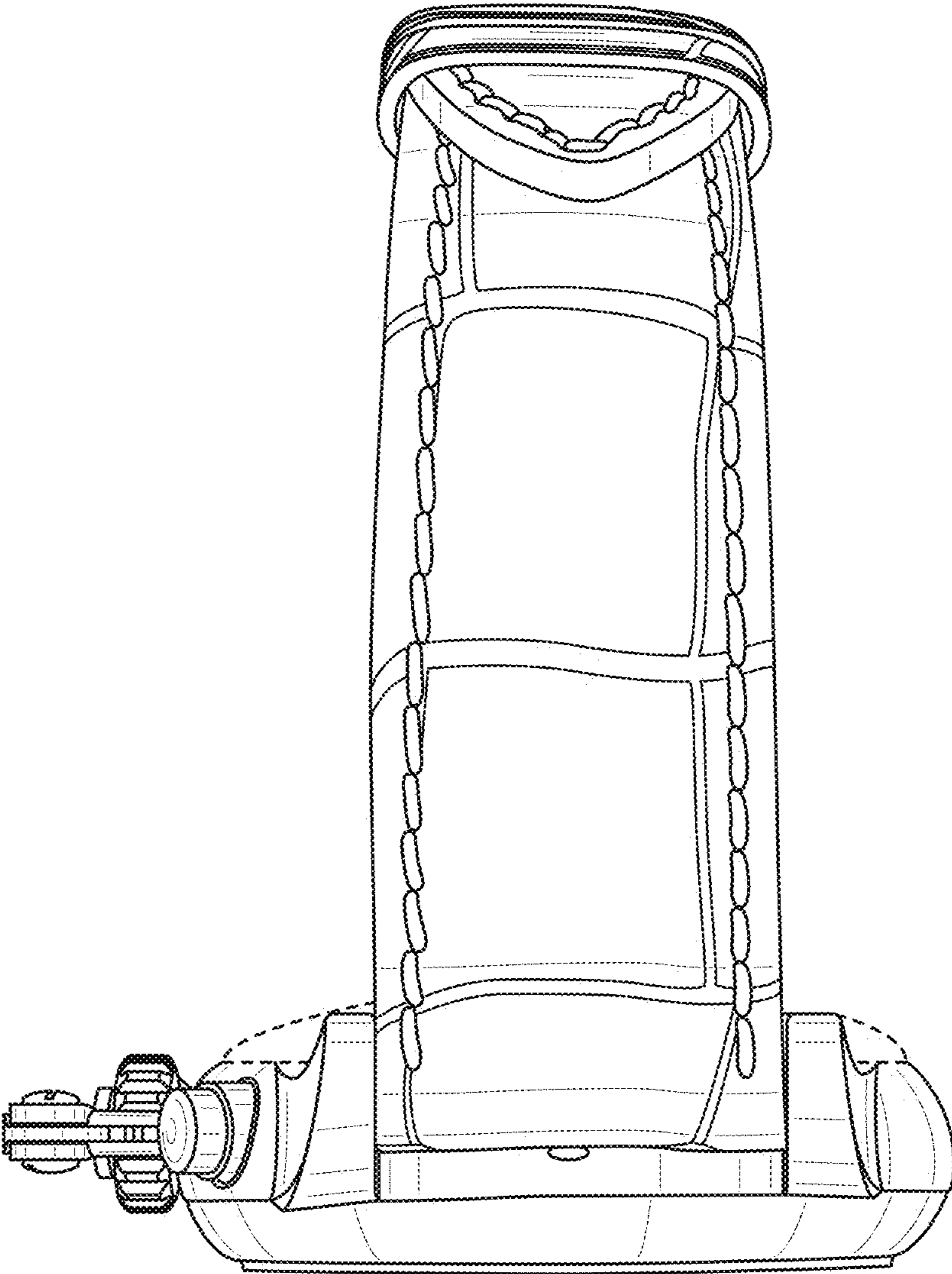

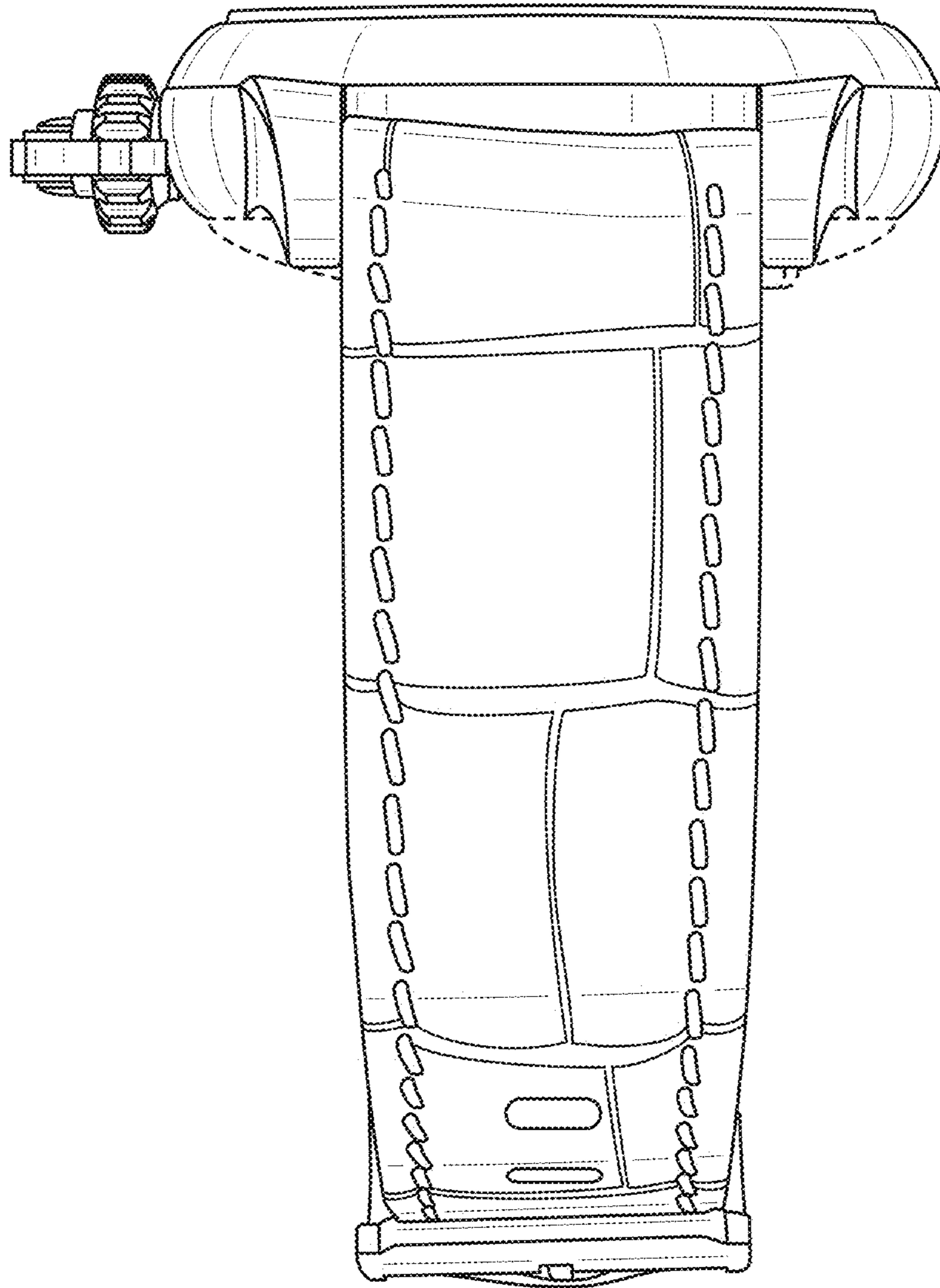
