FIG. 3 is a left, front perspective view thereof;

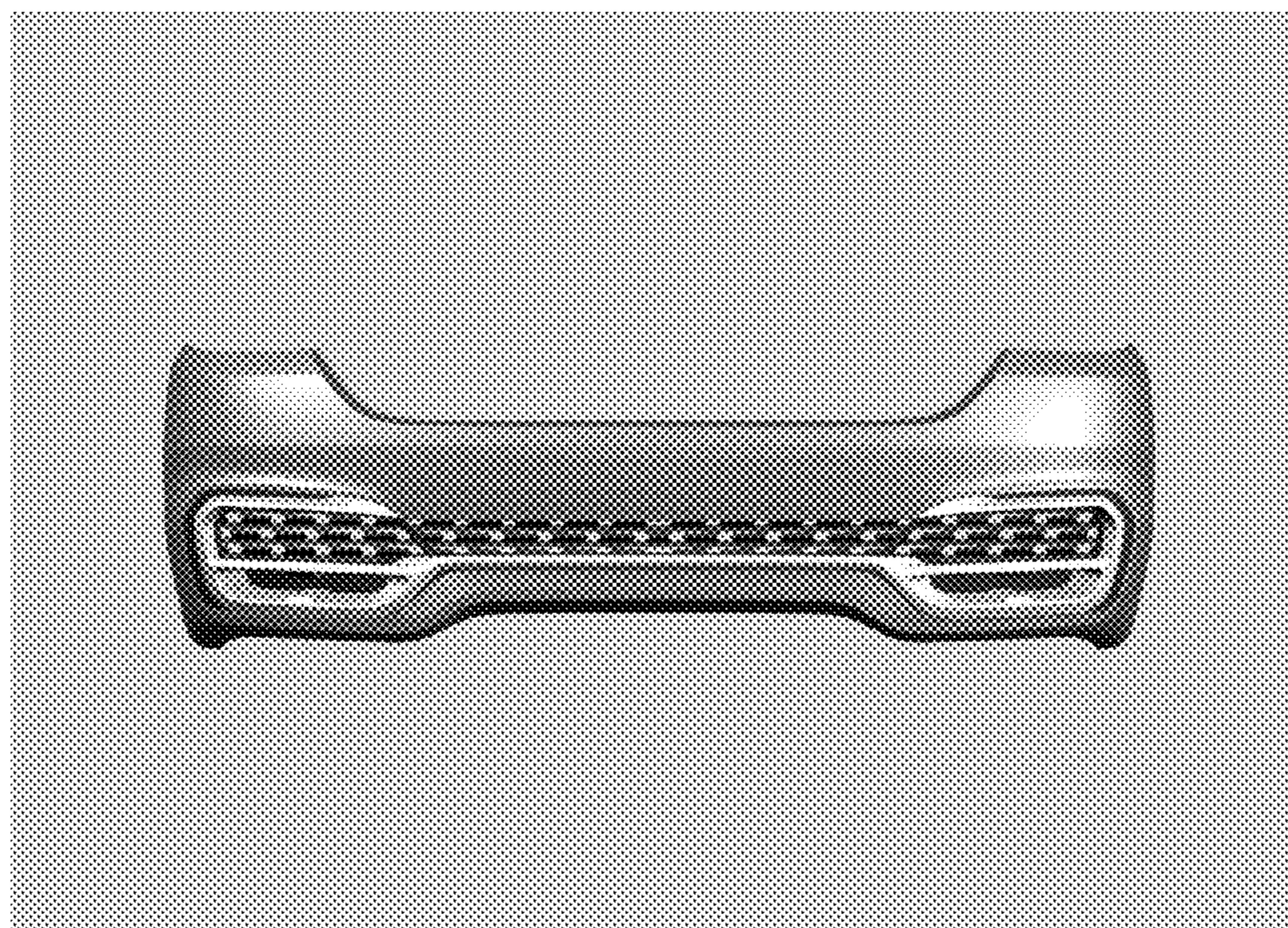
FIG. 4 is a left side view thereof, the right side view being mirror symmetrical;

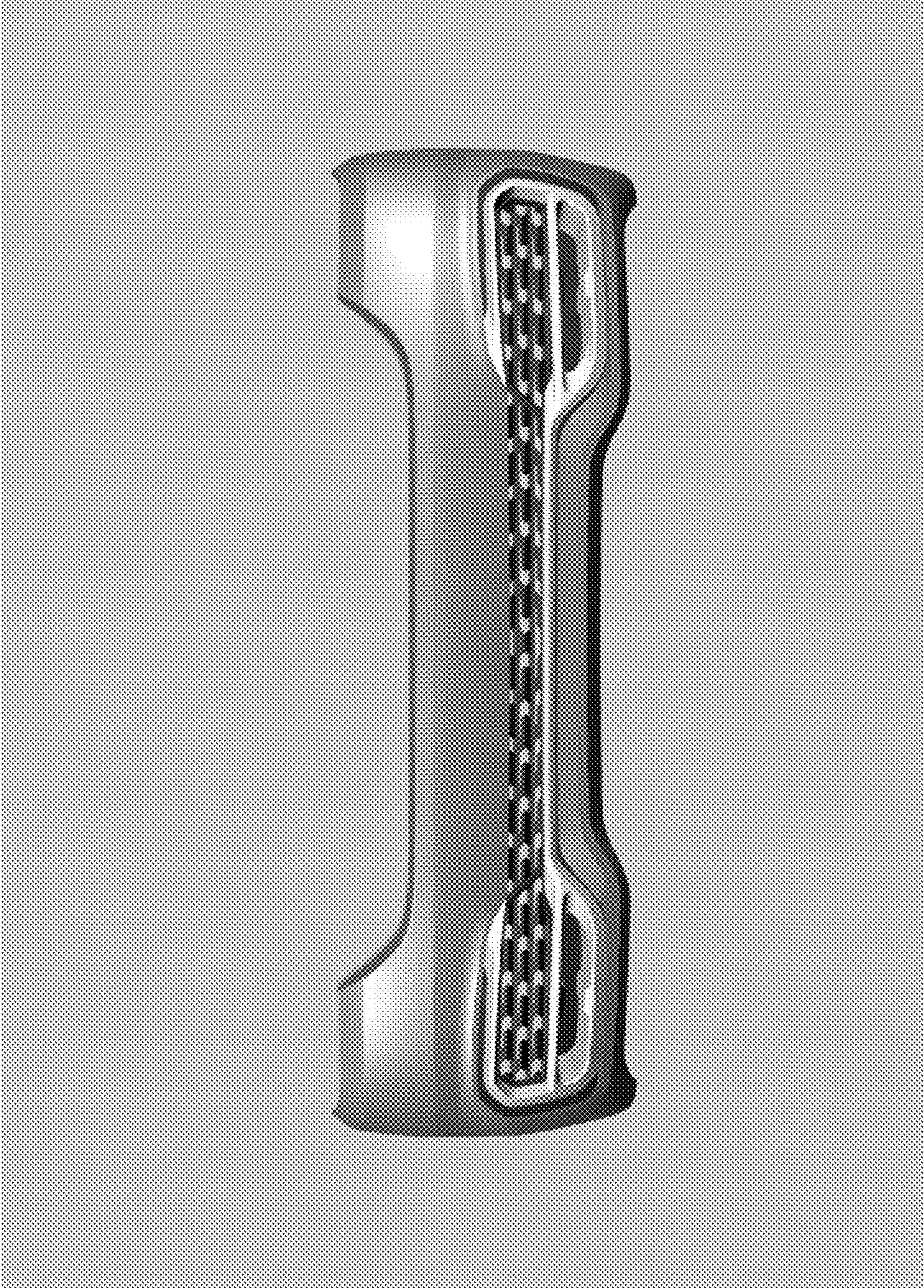

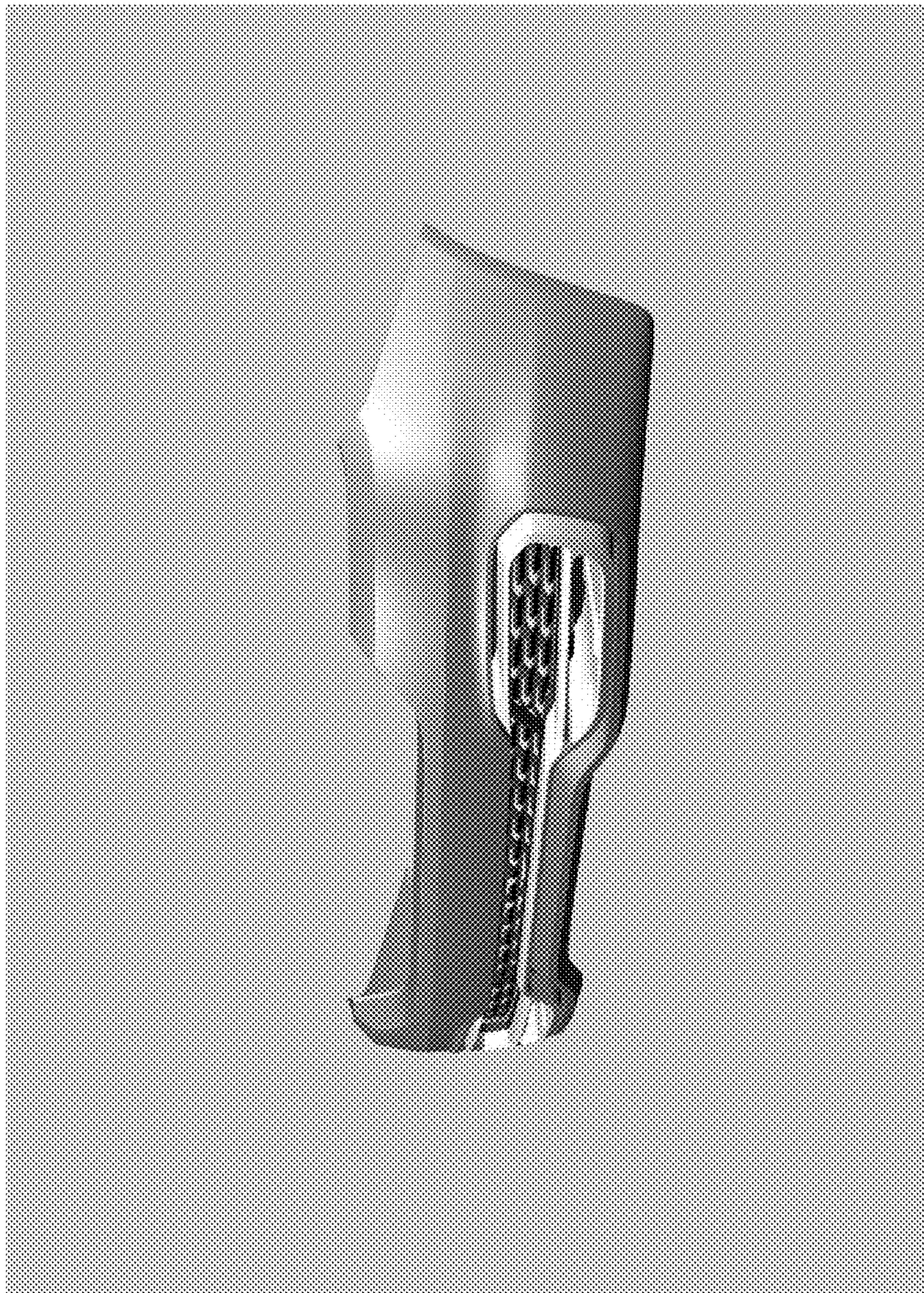

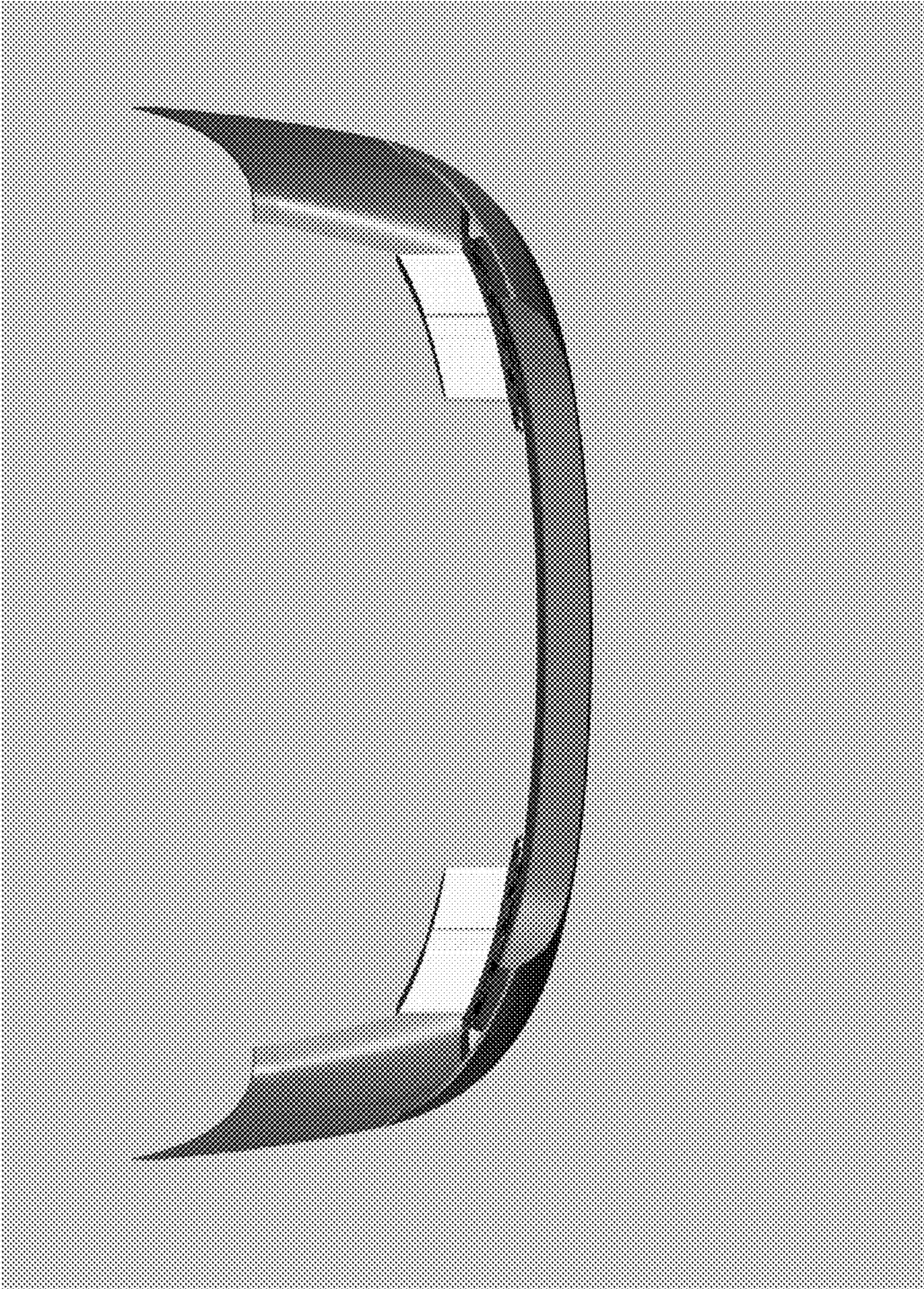
