(57) **CLAIM**

The ornamental design for an automobile tire, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an automobile tire showing our new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a right side view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom view thereof;
FIG. 8 is an enlarged view of a portion defined by lines 8-8 shown in FIG. 2; and,
FIG. 9 is a sectional view taken along lines 9-9 shown in FIG. 8.
The broken lines shown are included for the purpose of illustrating the unclaimed portions of the automobile tire and form no part of the claimed design.

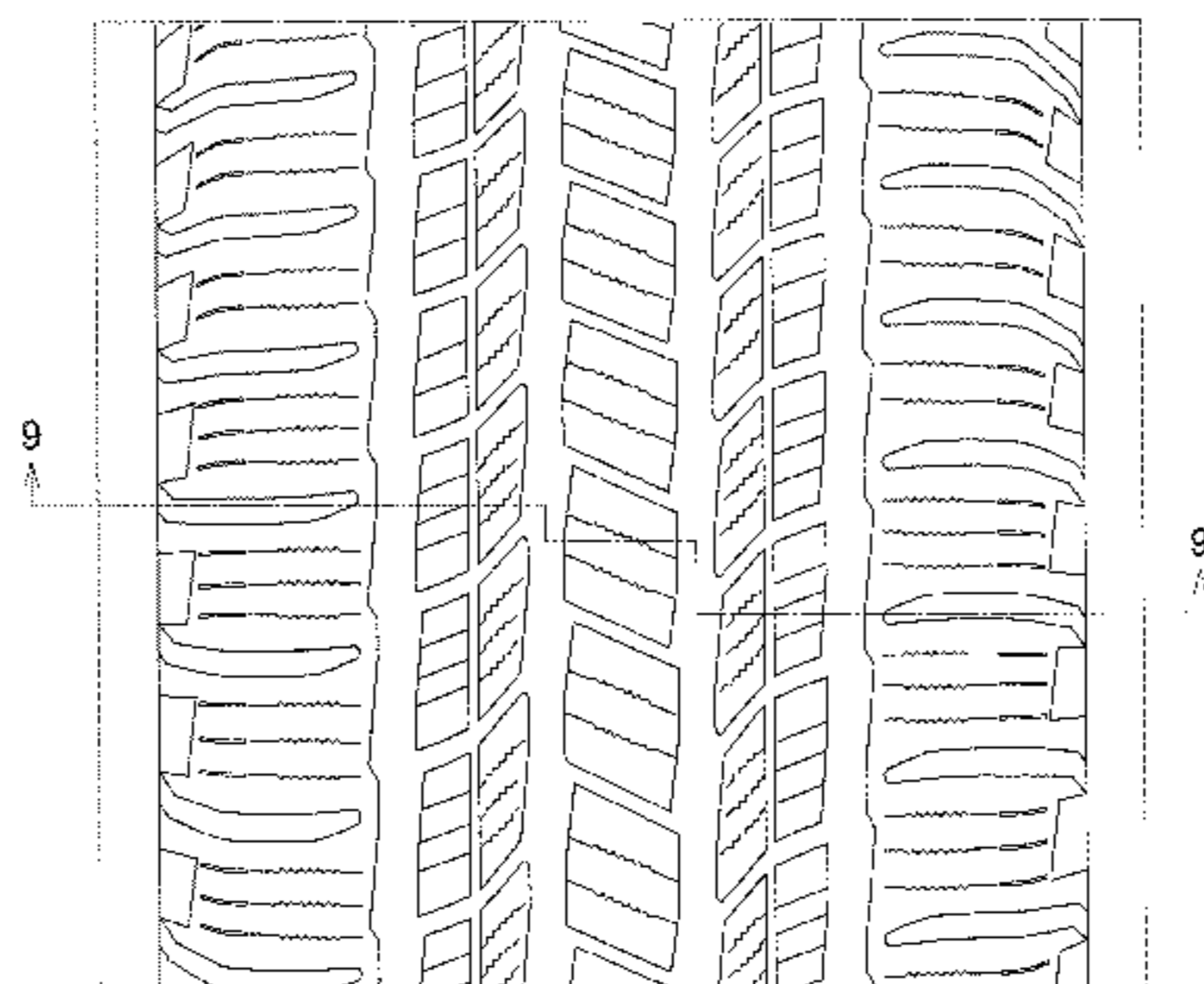
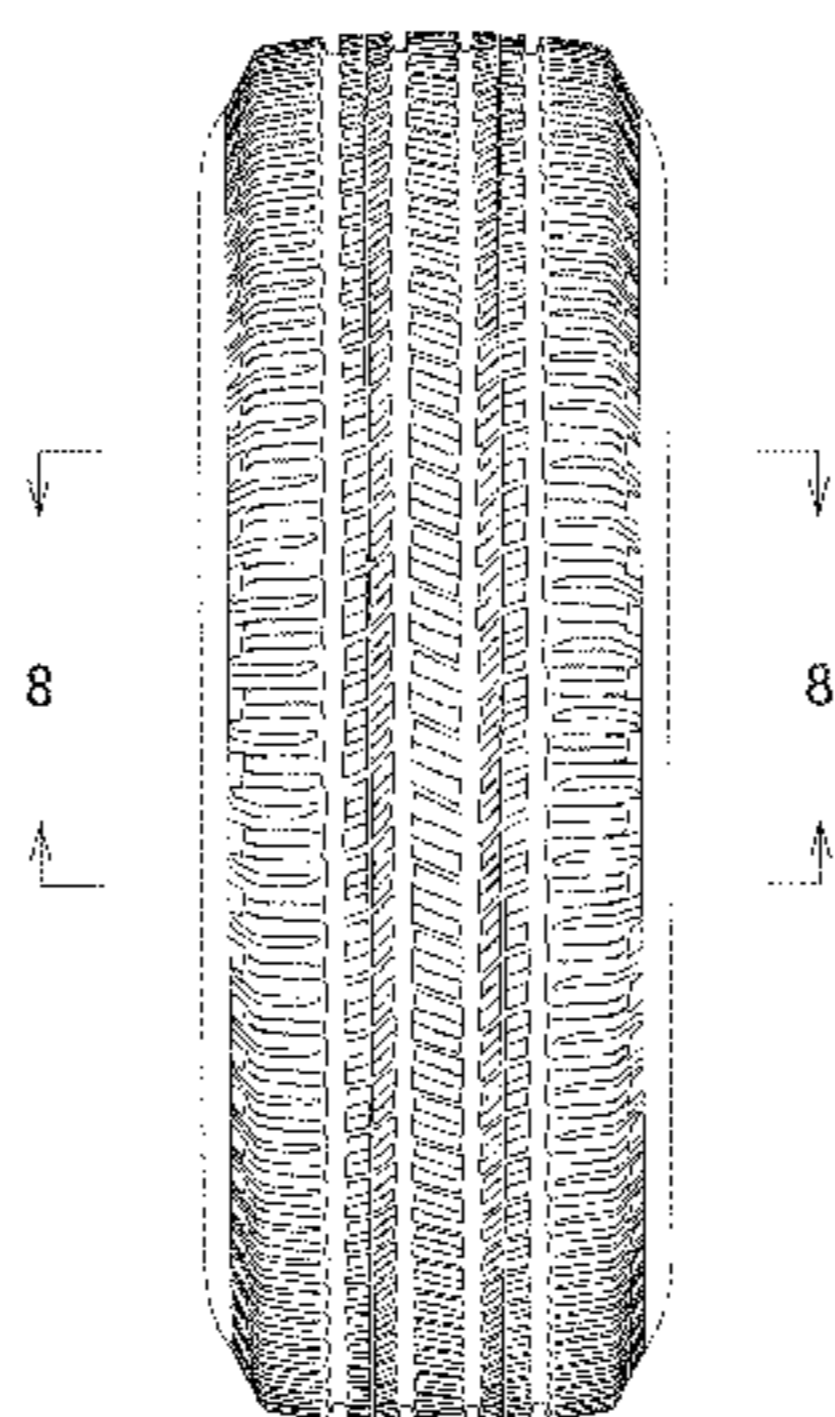

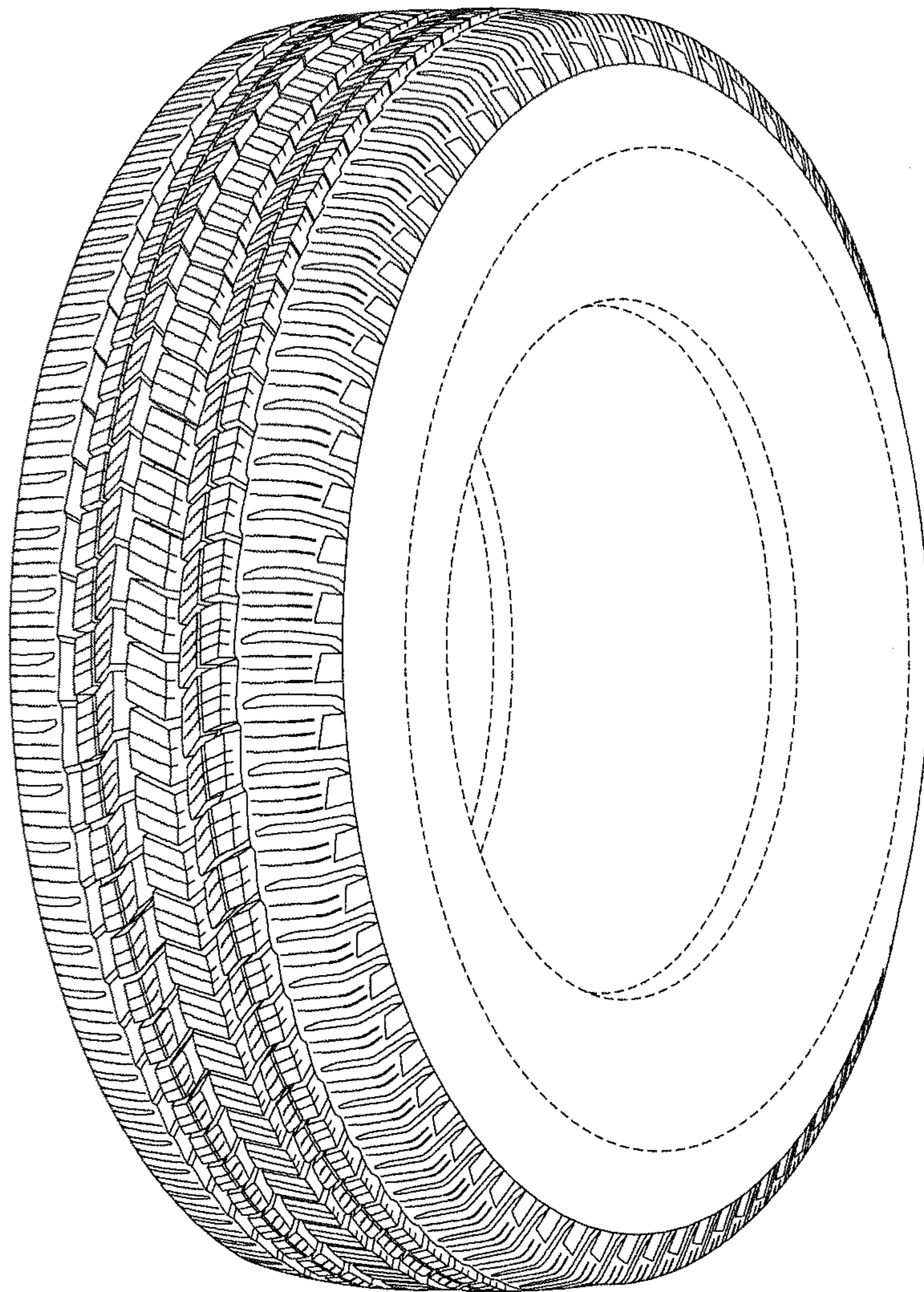

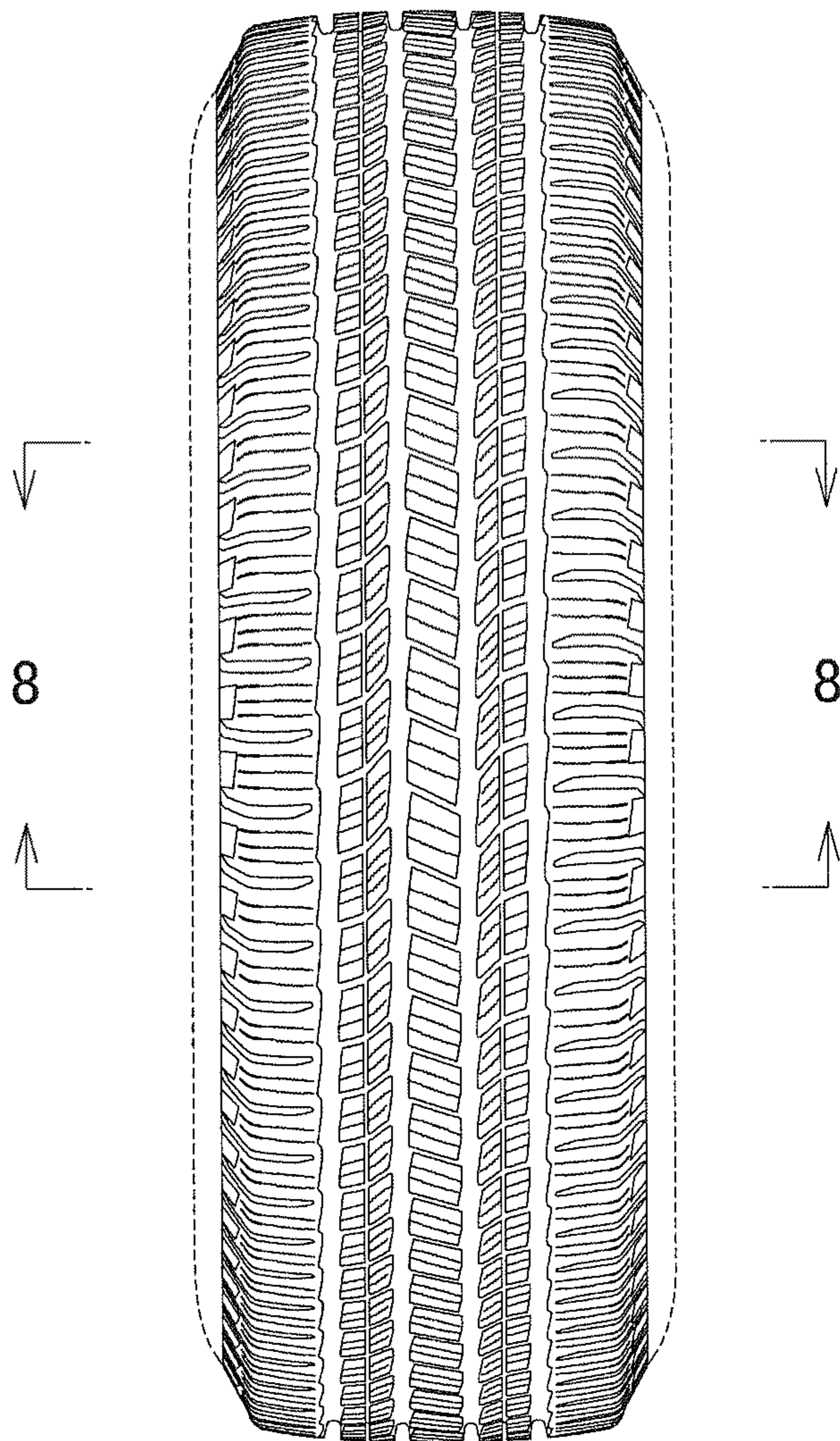

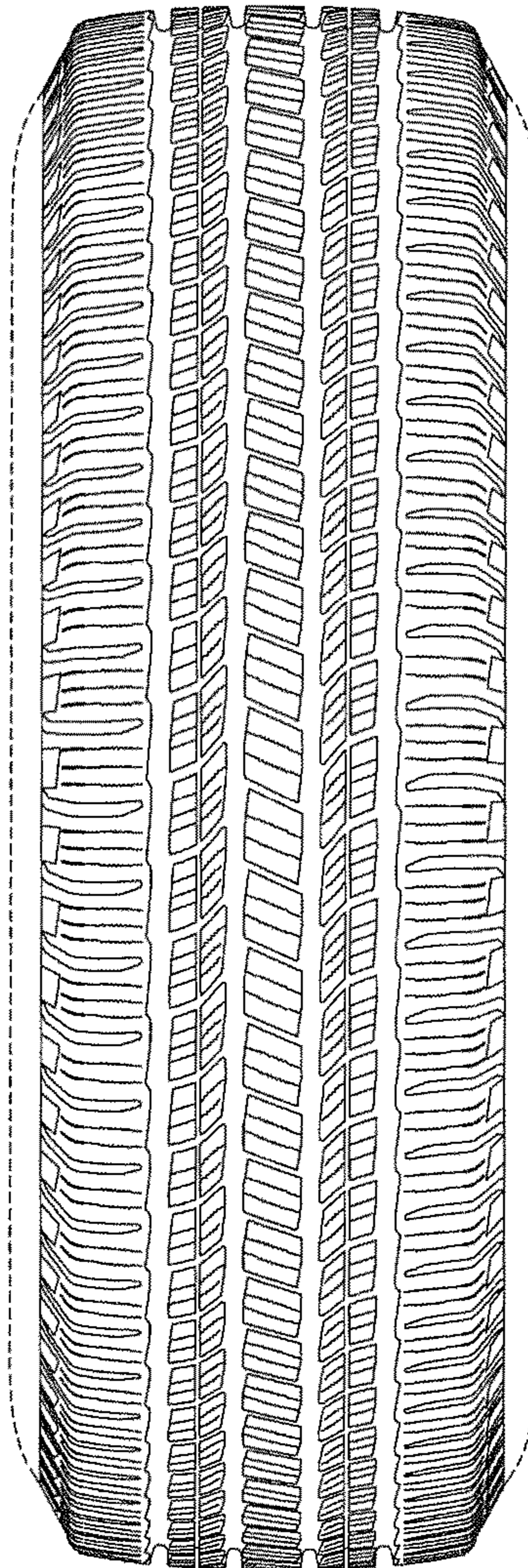

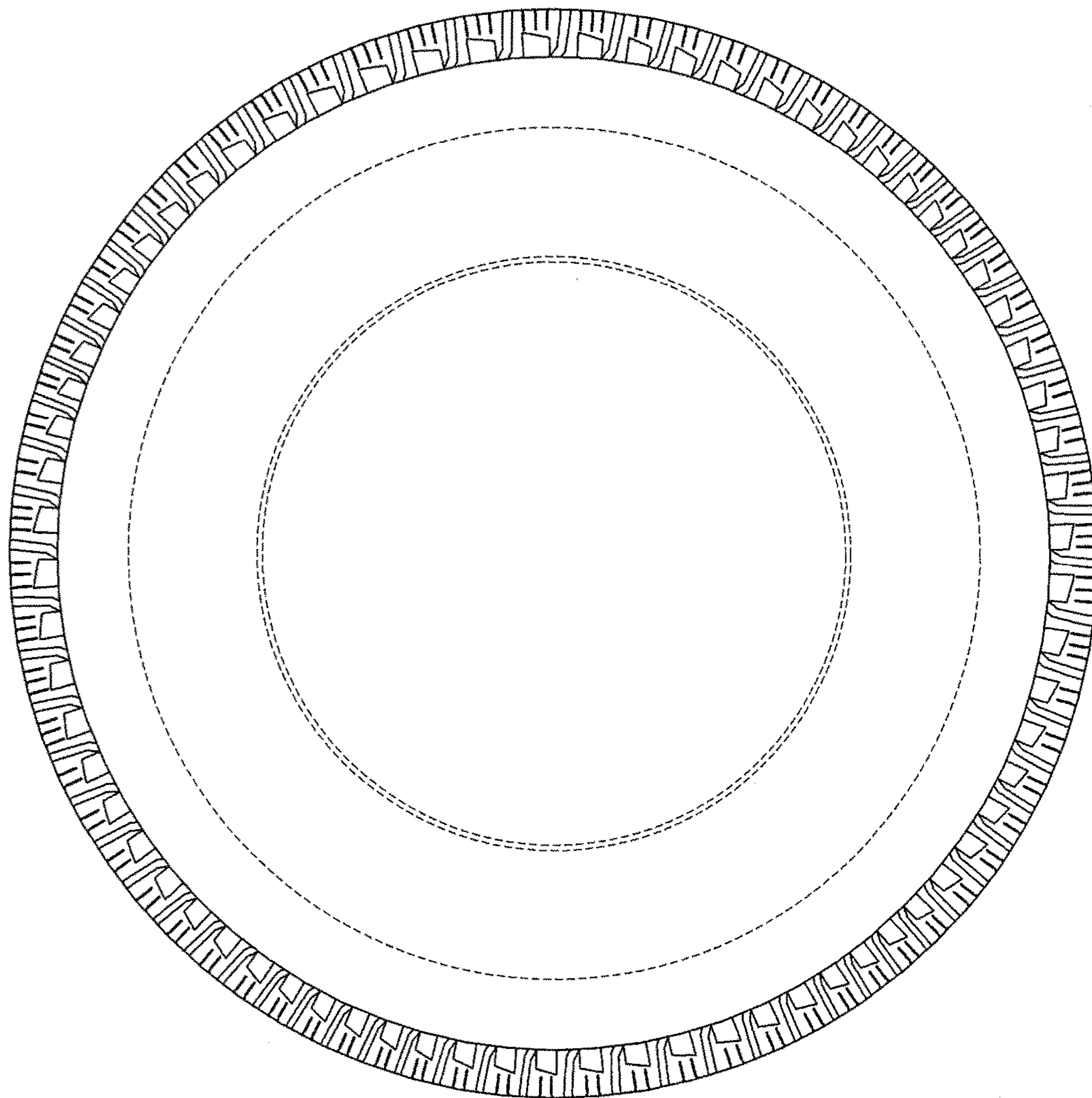

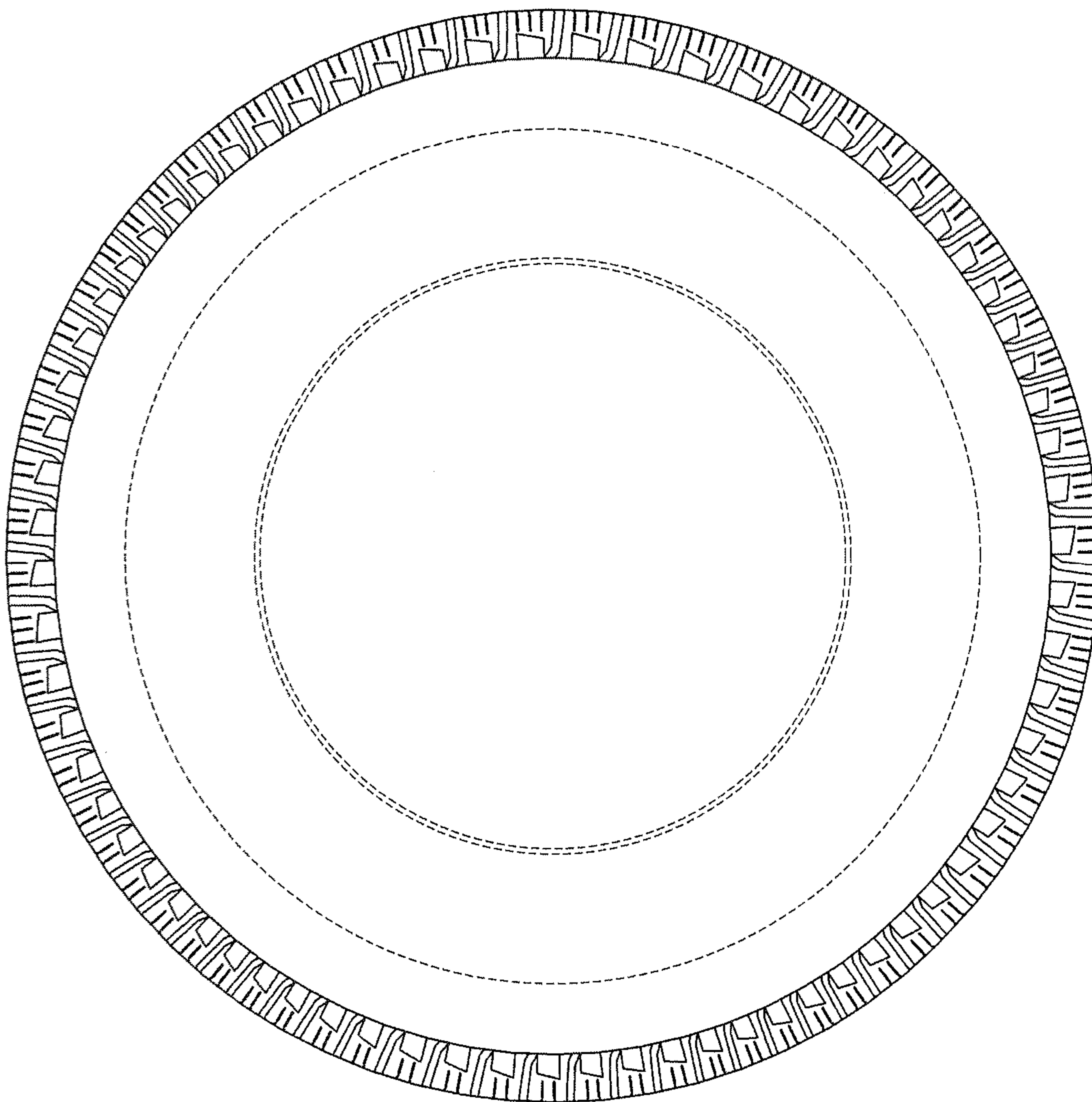

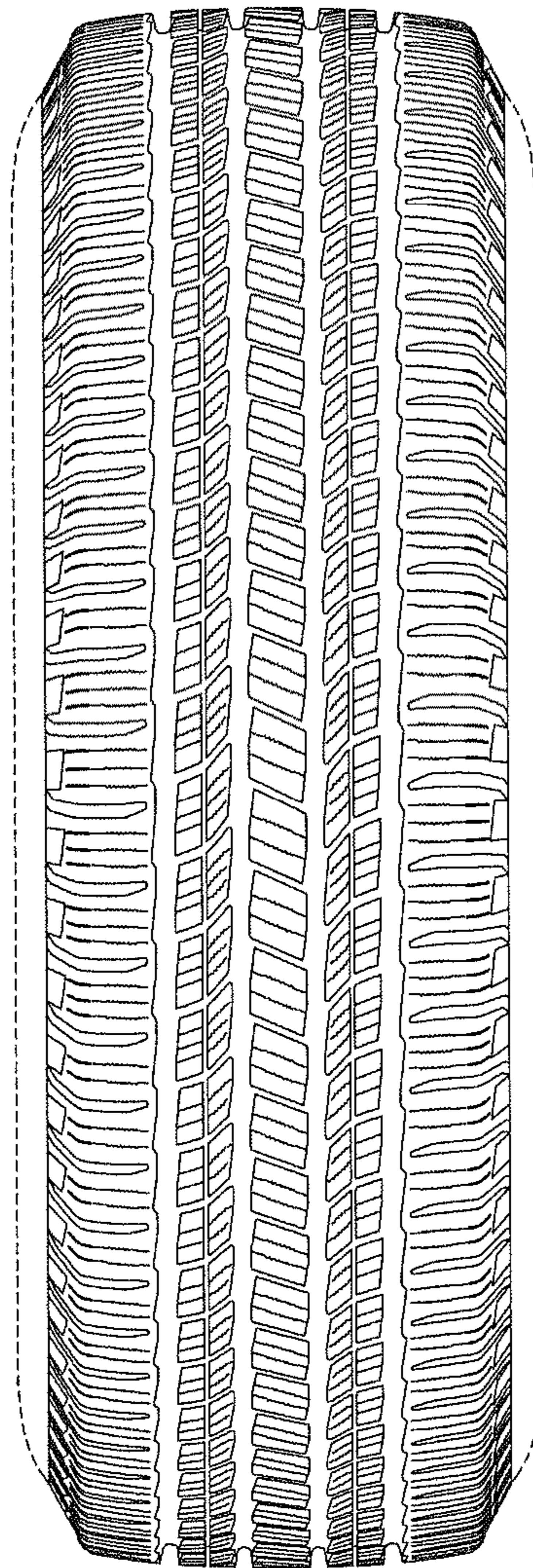

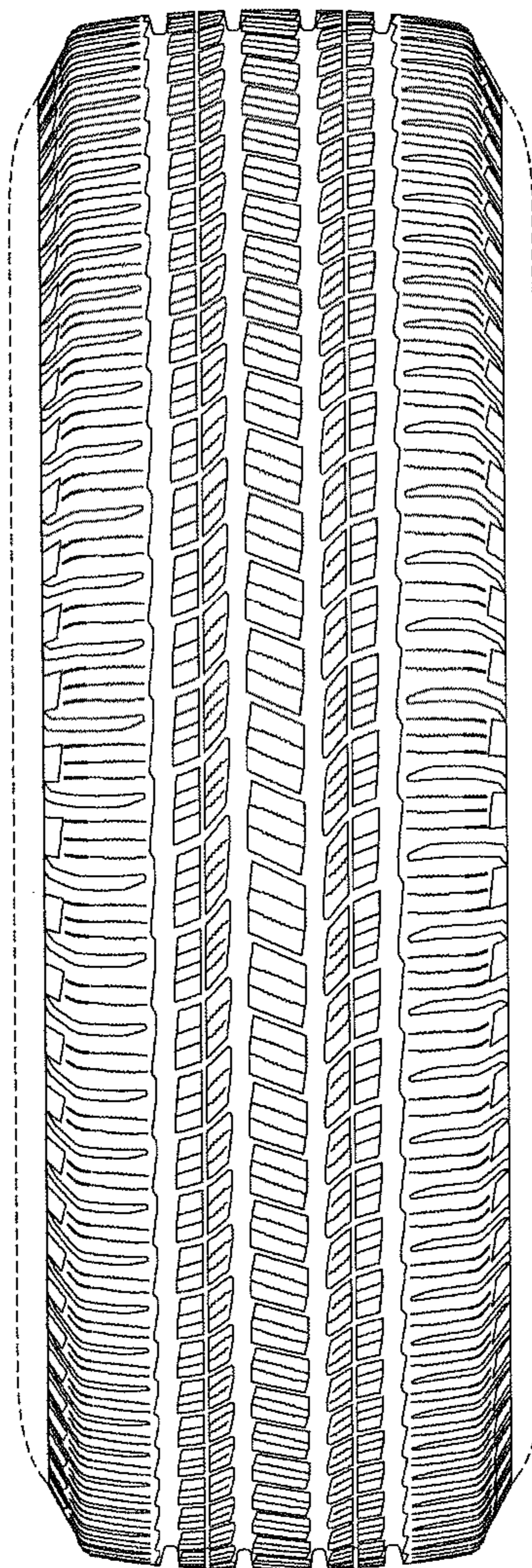

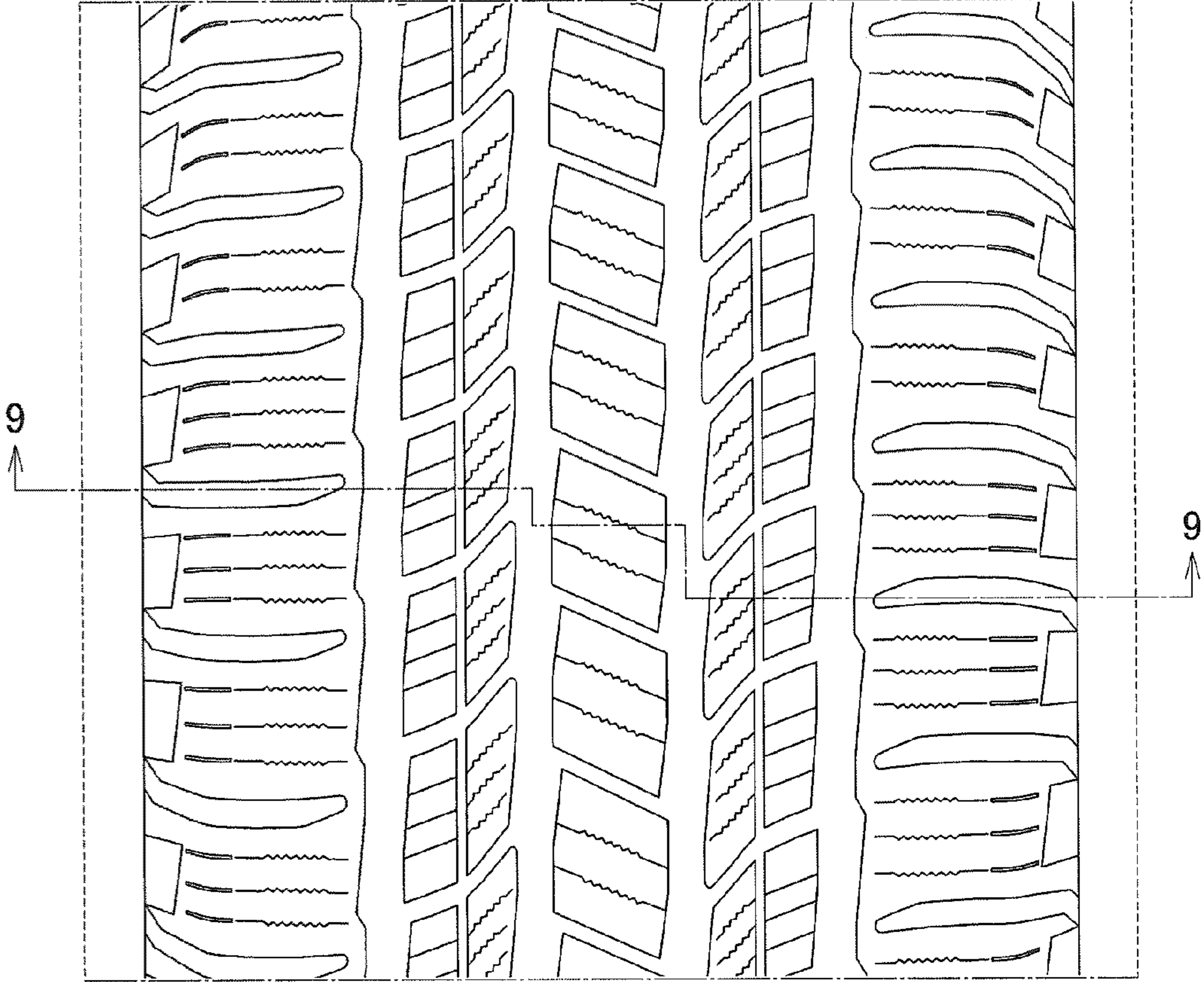
