FIG. 7 is a left view thereof.

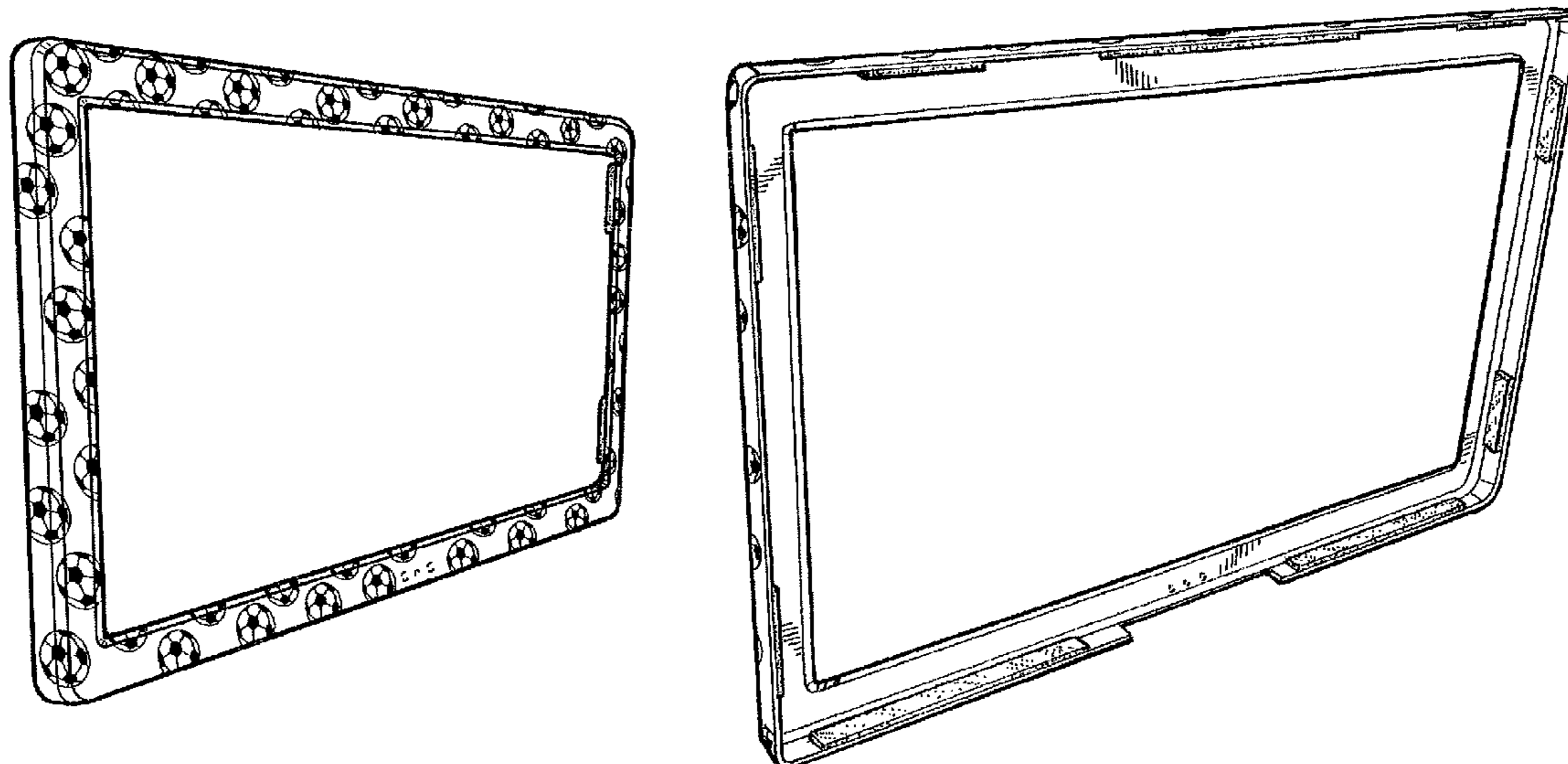
FIG. 8 is a bottom view thereof.

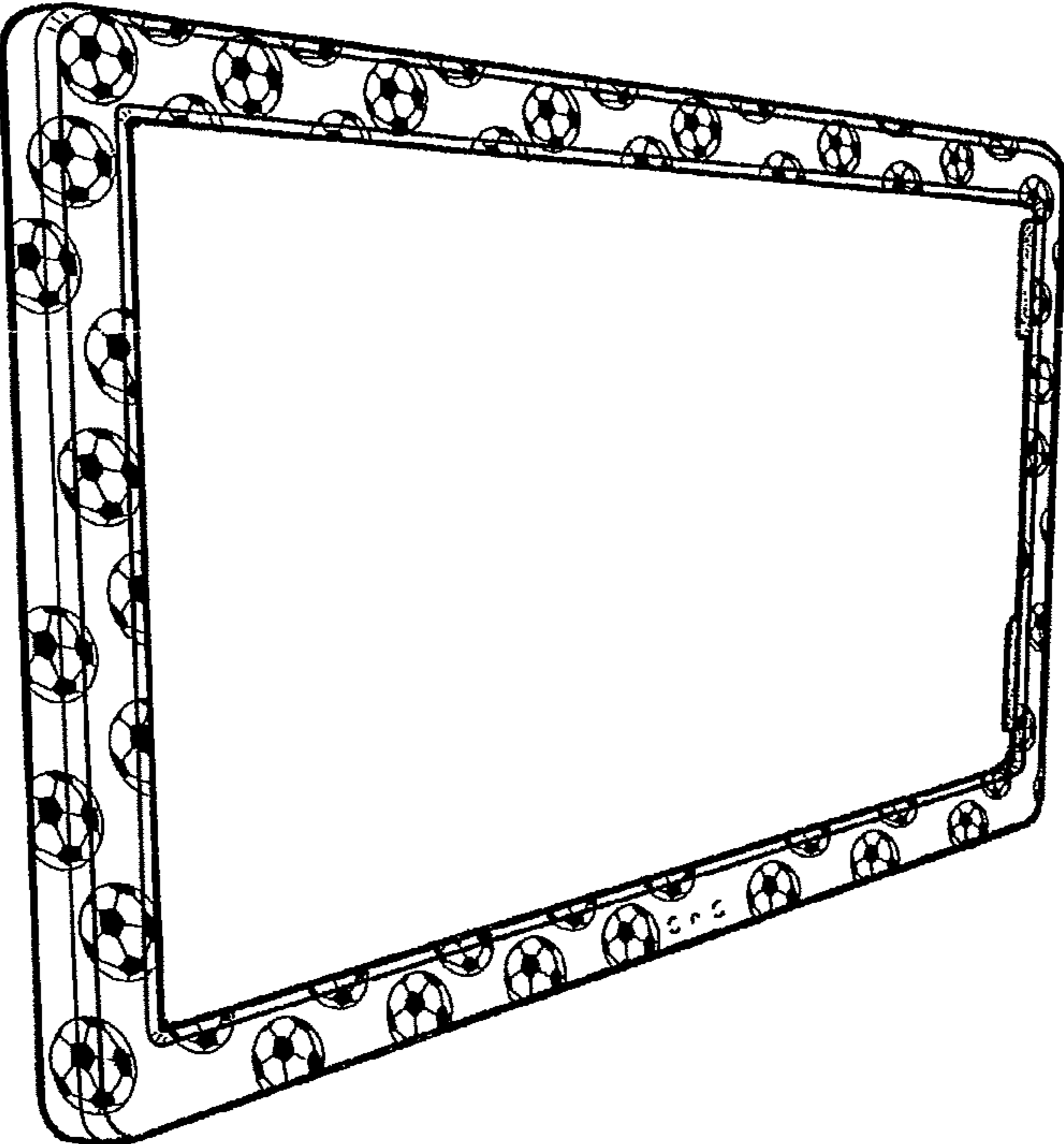

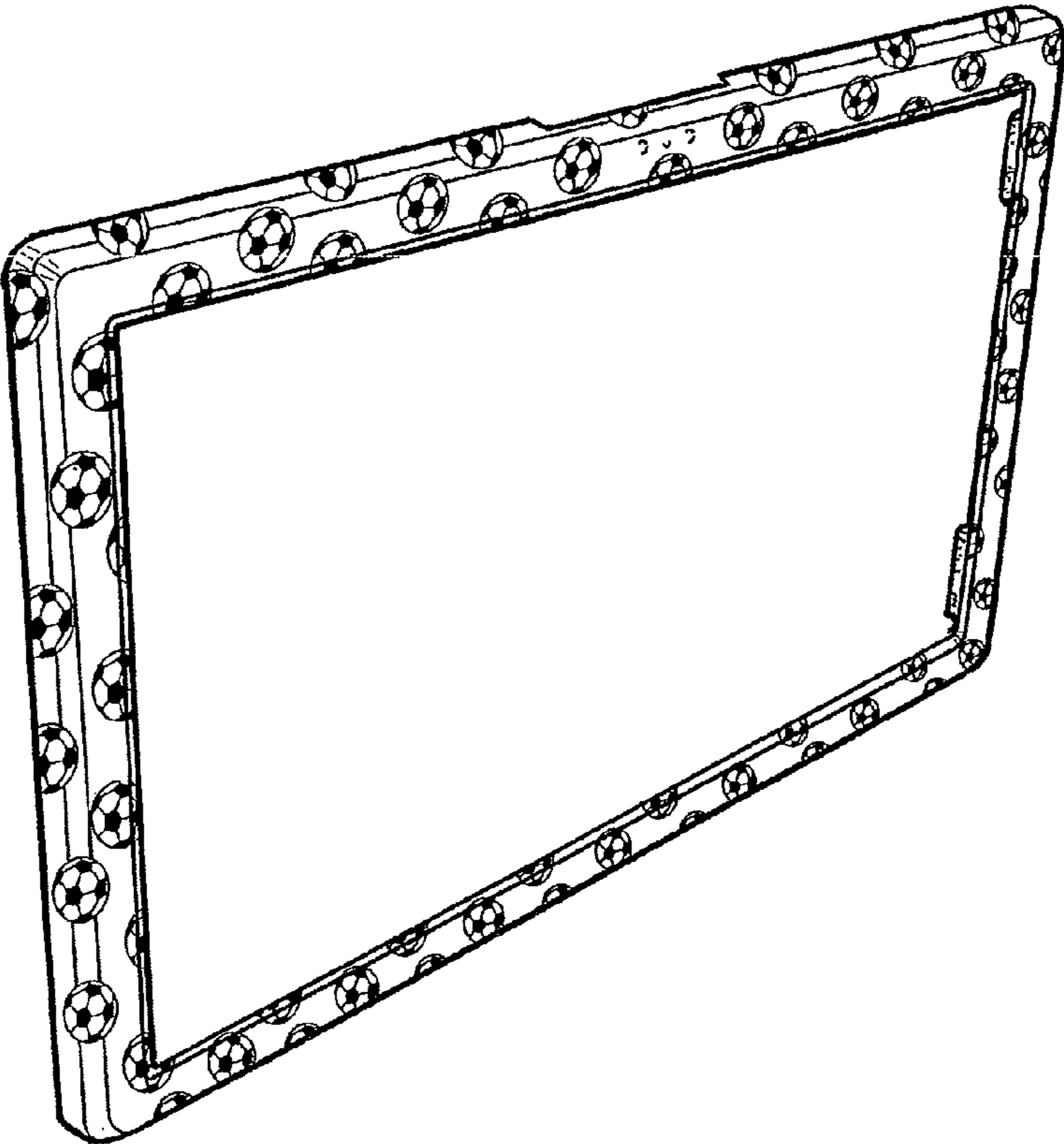

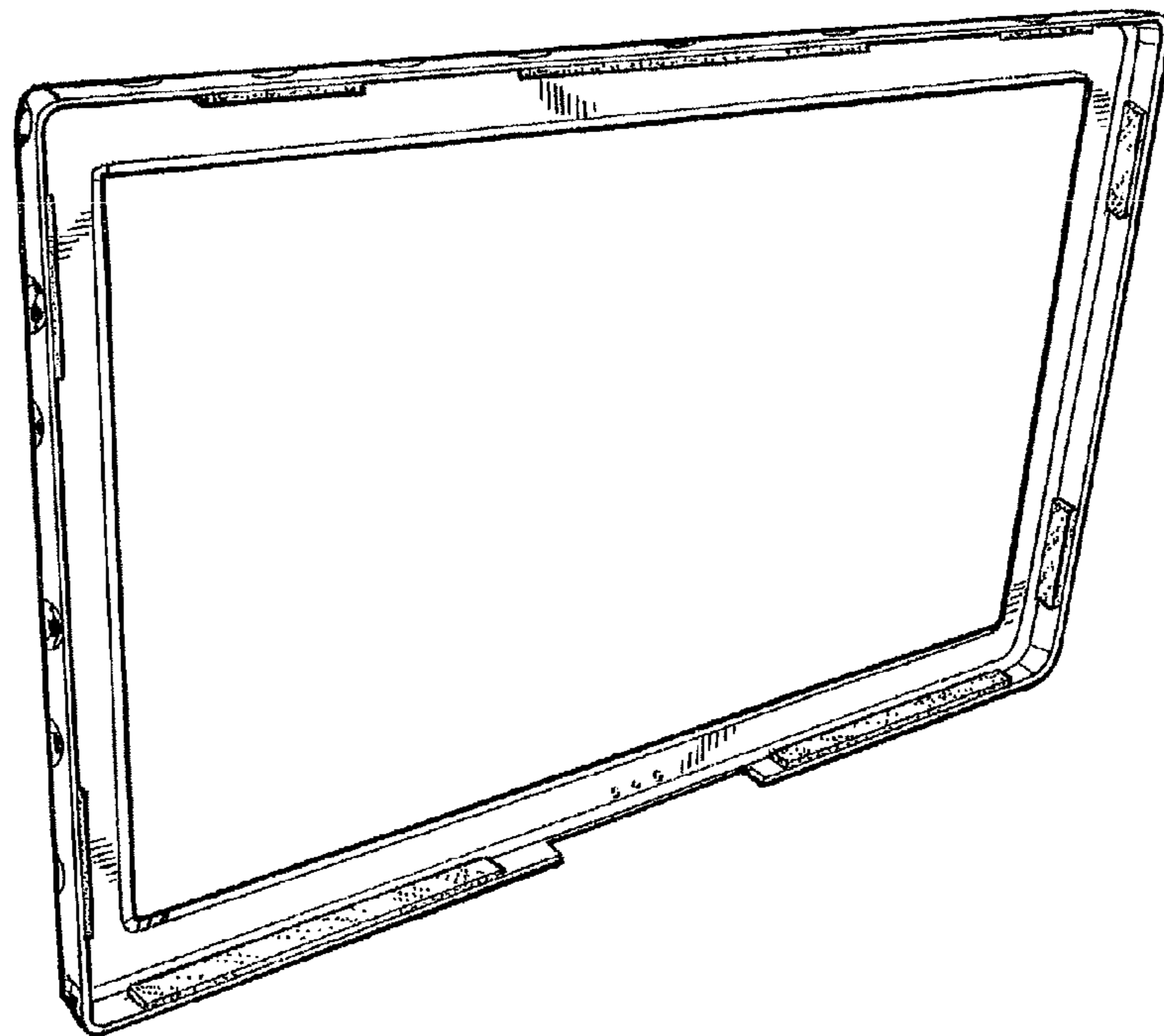

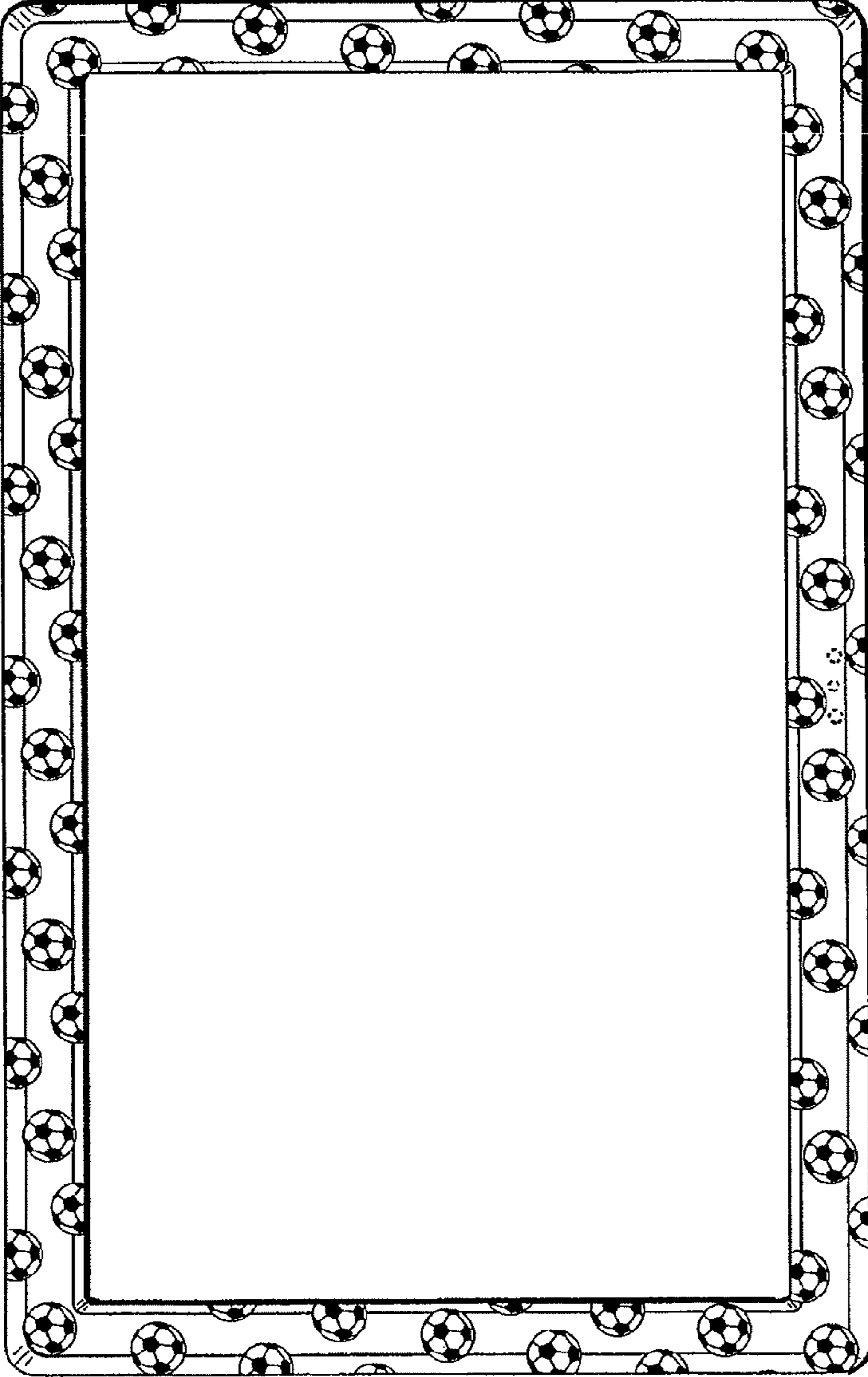

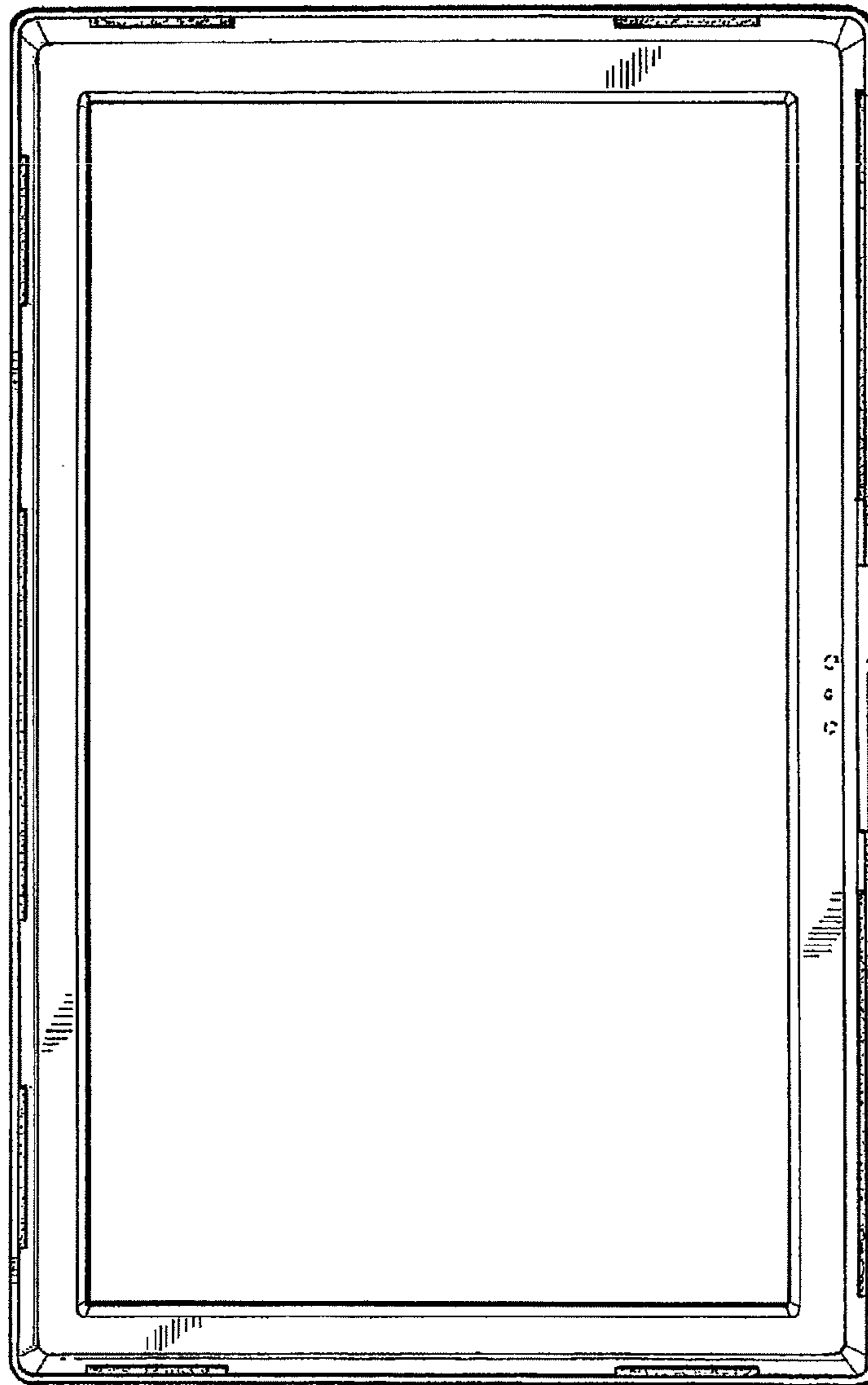

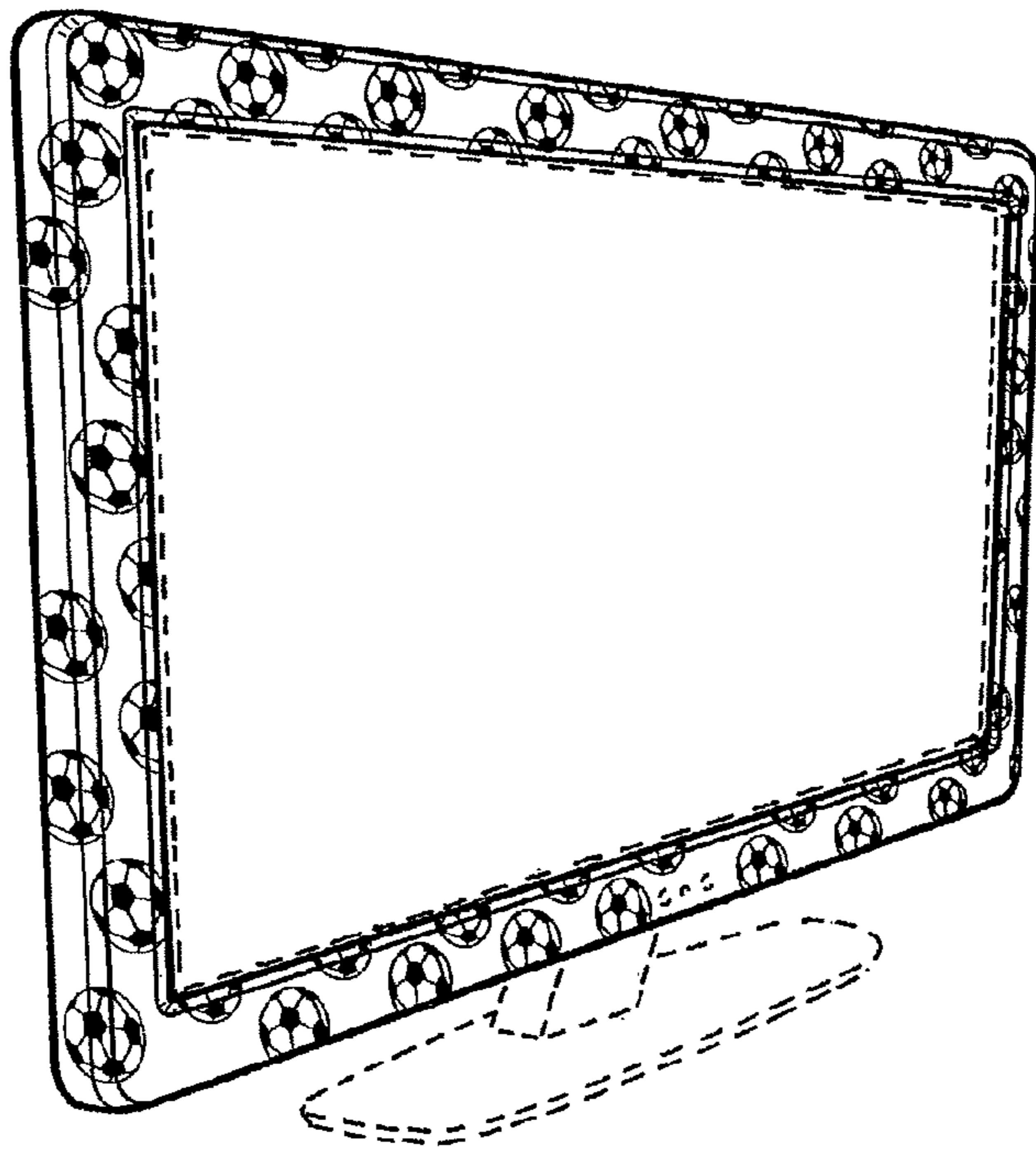
