DESCRIPTION

FIG. 1 is a front, bottom and right side perspective view of a speaker showing my new design;
FIG. 2 is a rear, top and left side perspective view thereof;
FIG. 3 is a front view thereof;
FIG. 4 is a rear view thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom plan view thereof; and,

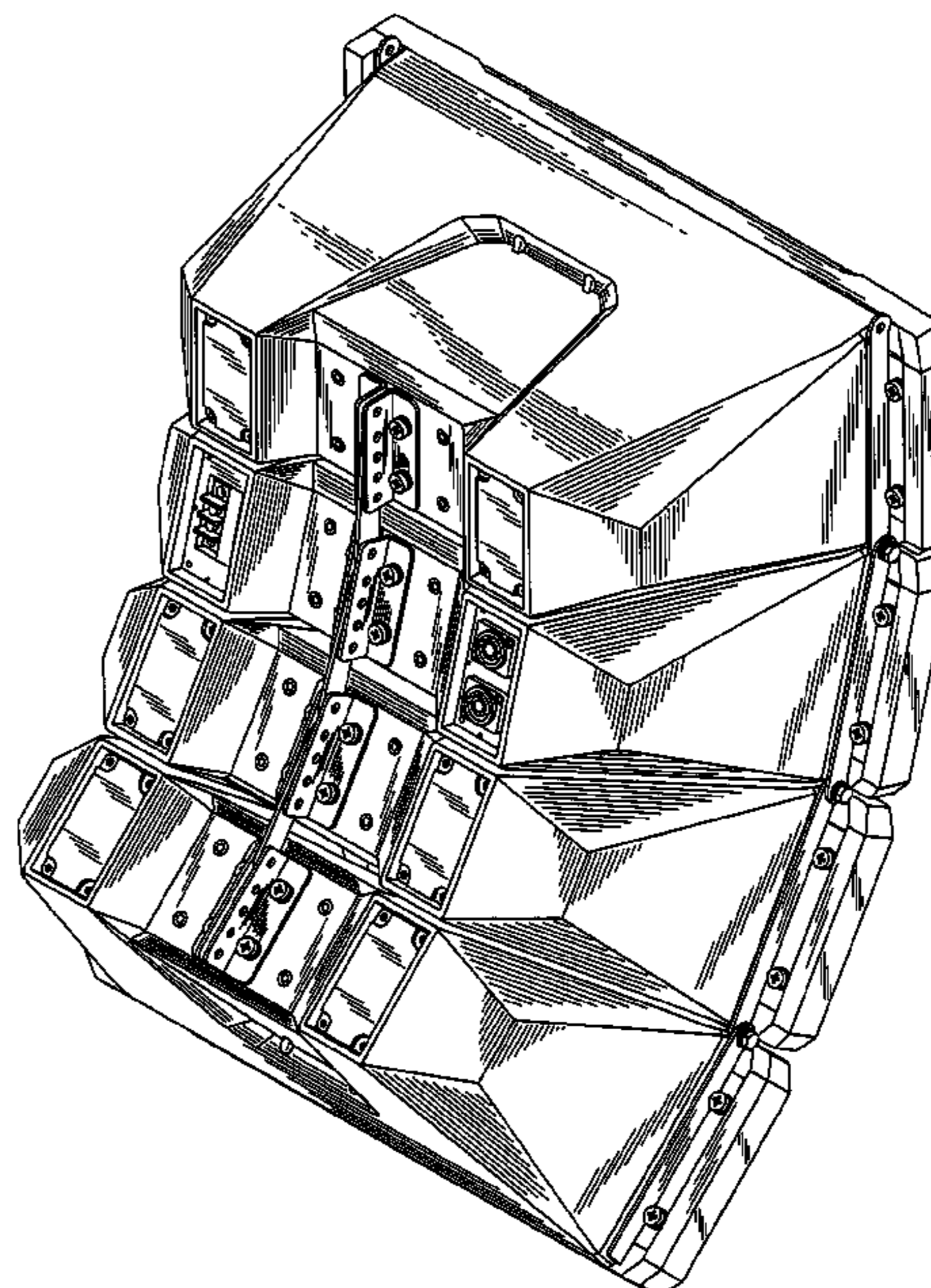
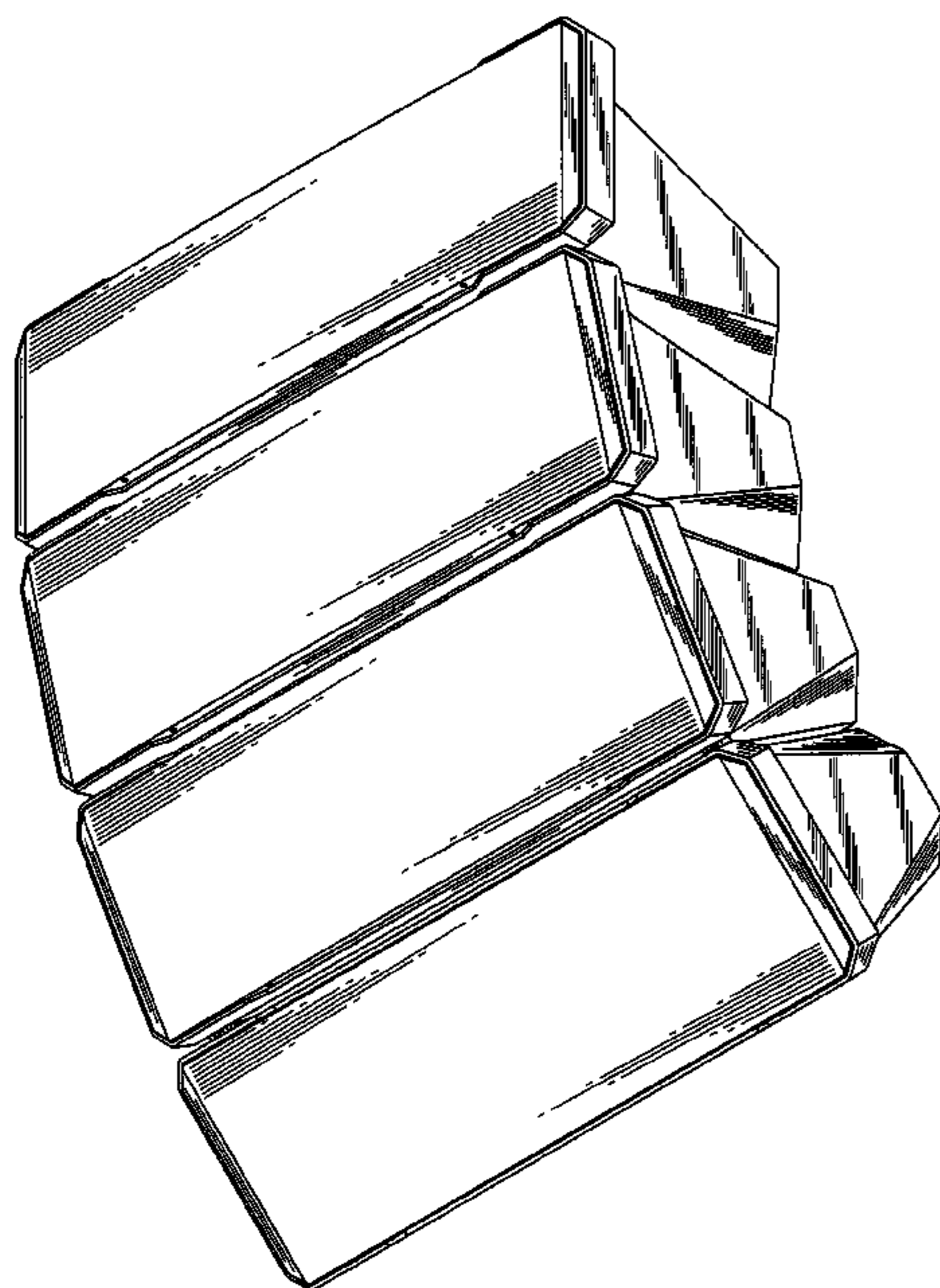

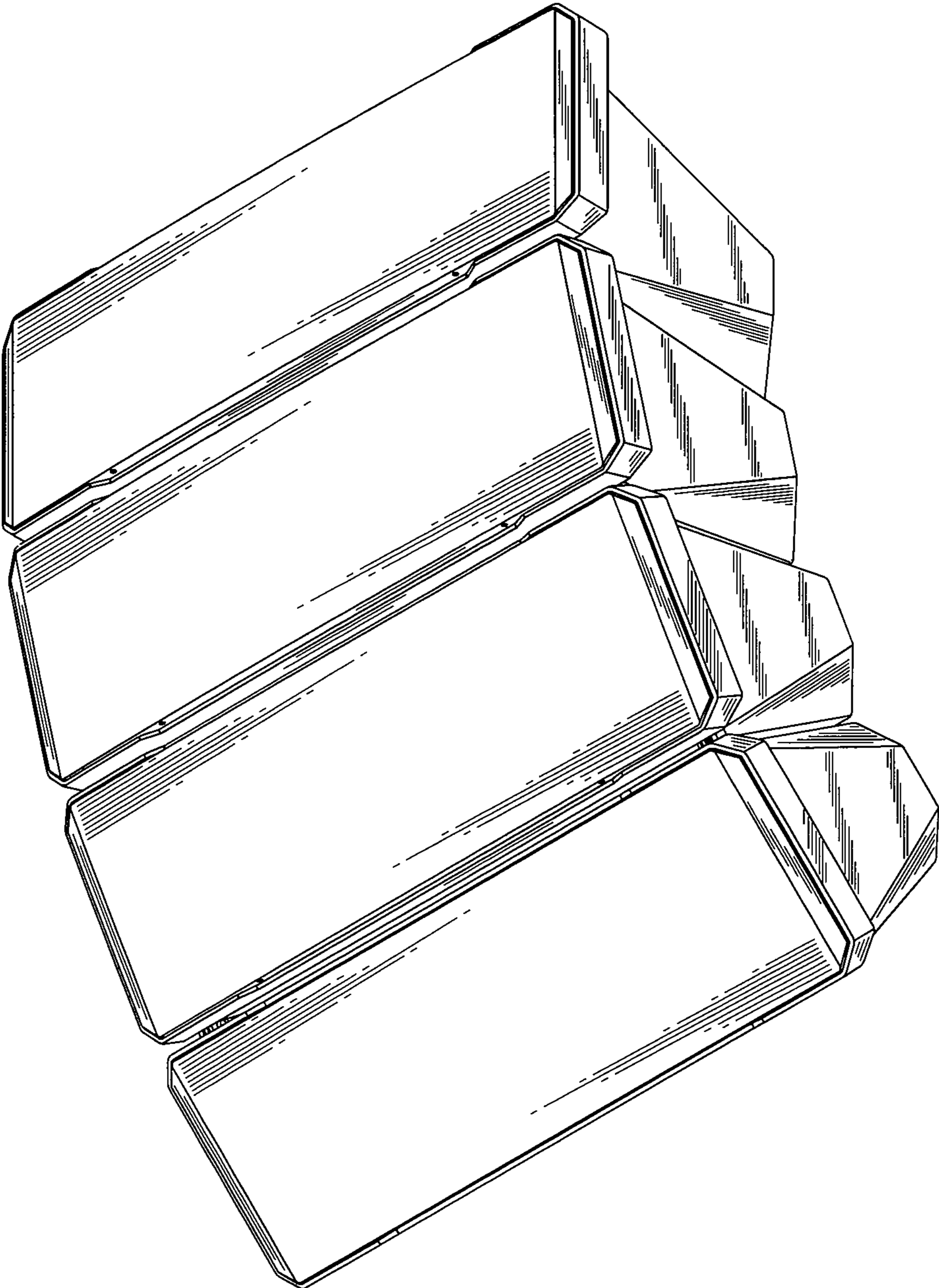

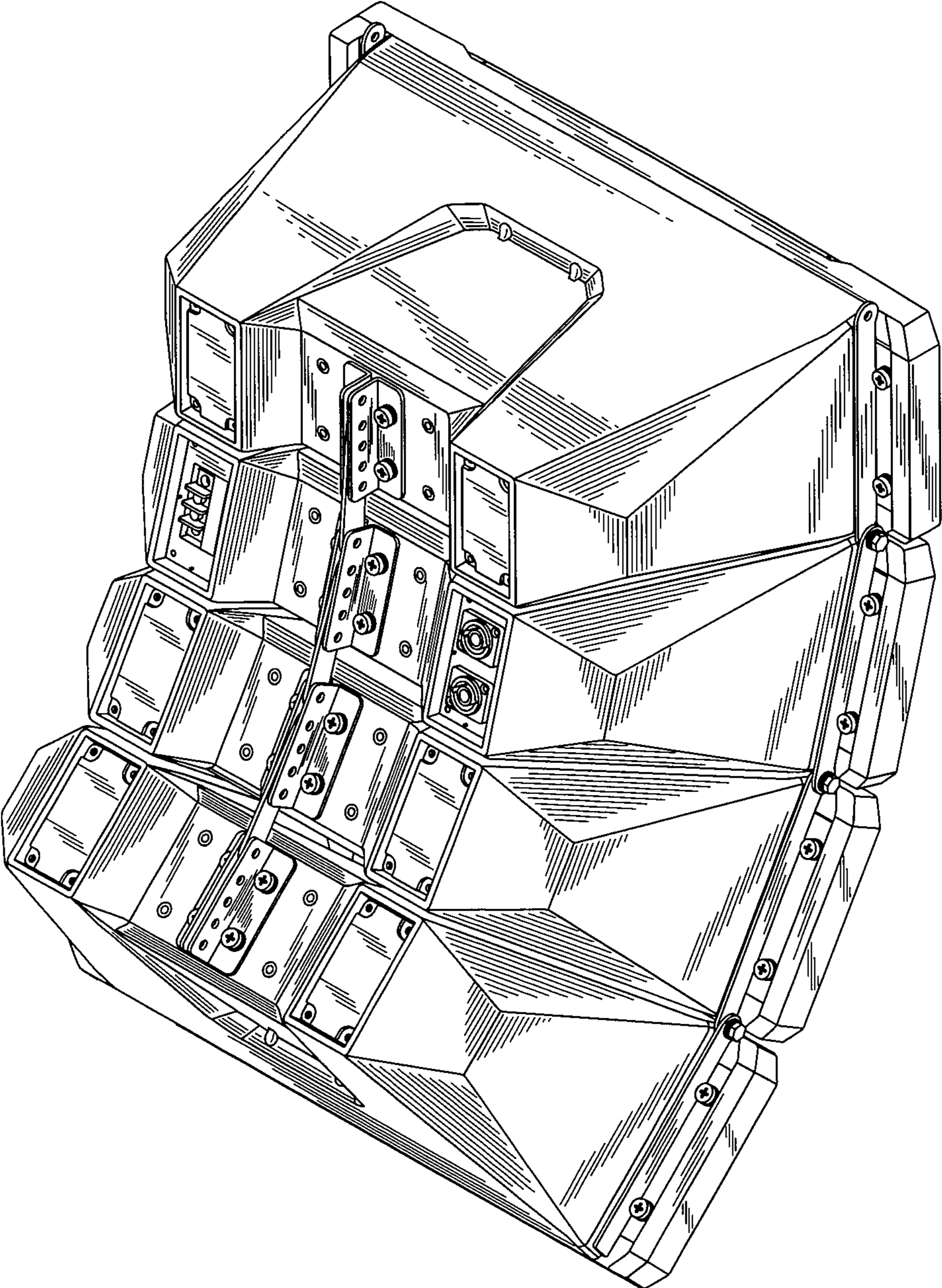

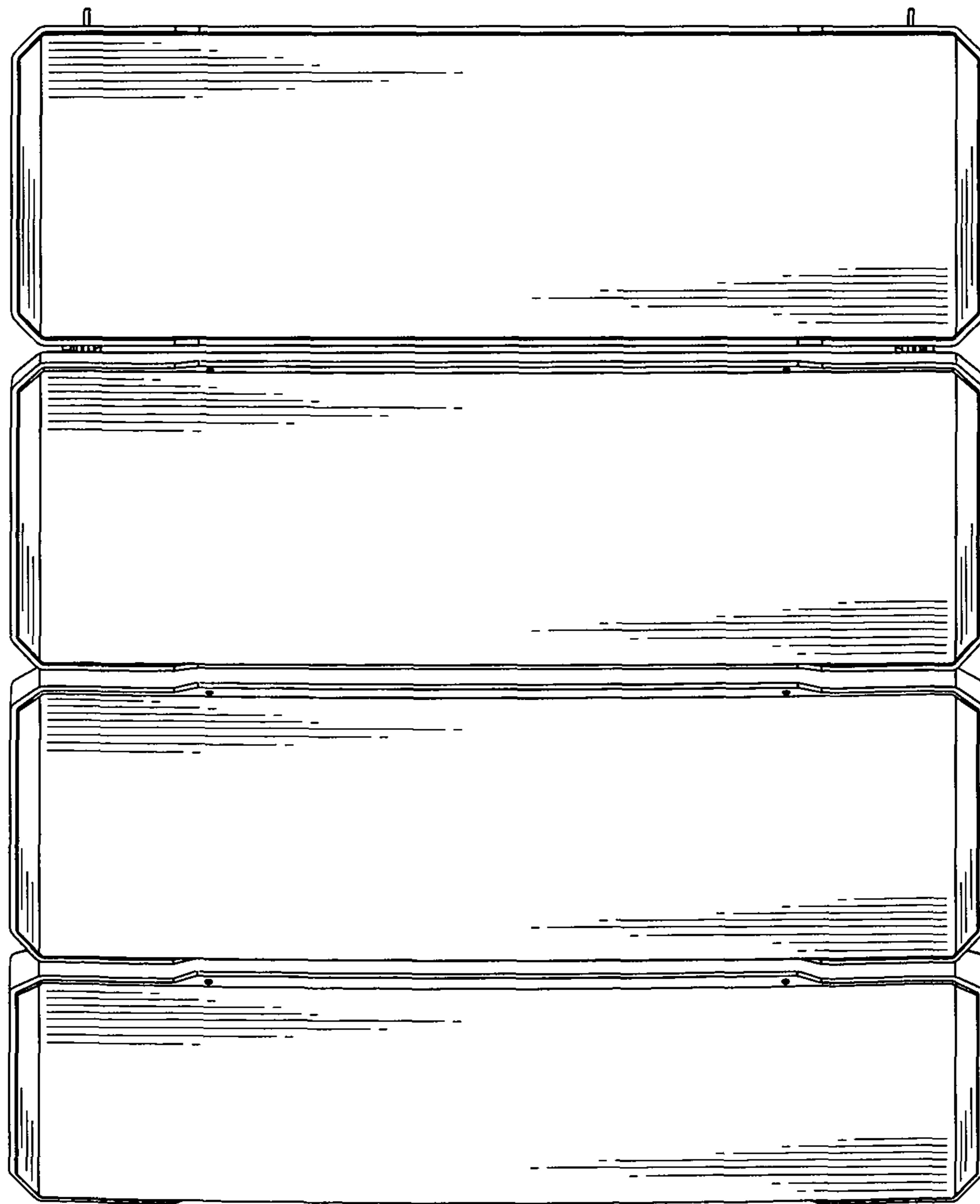

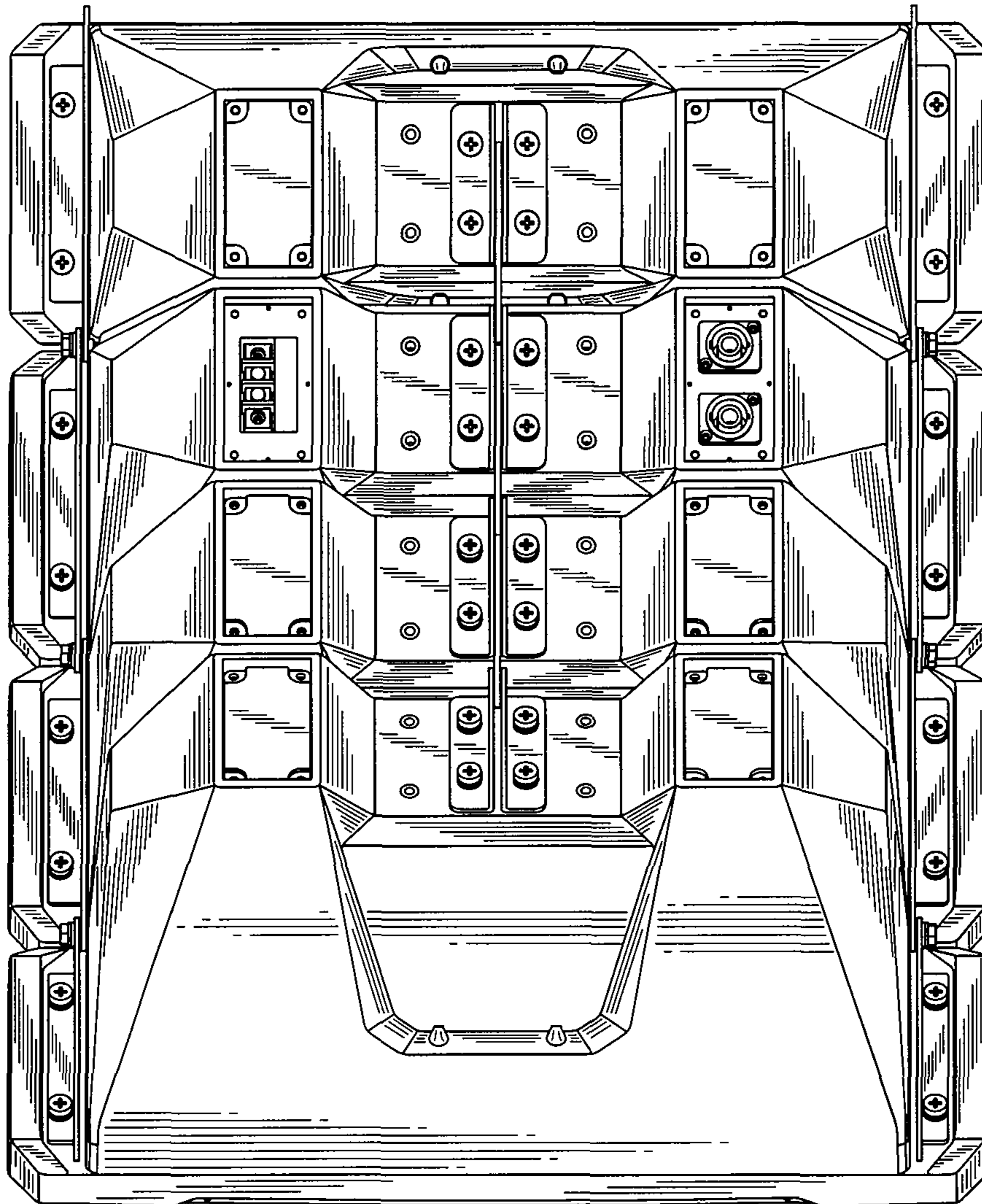

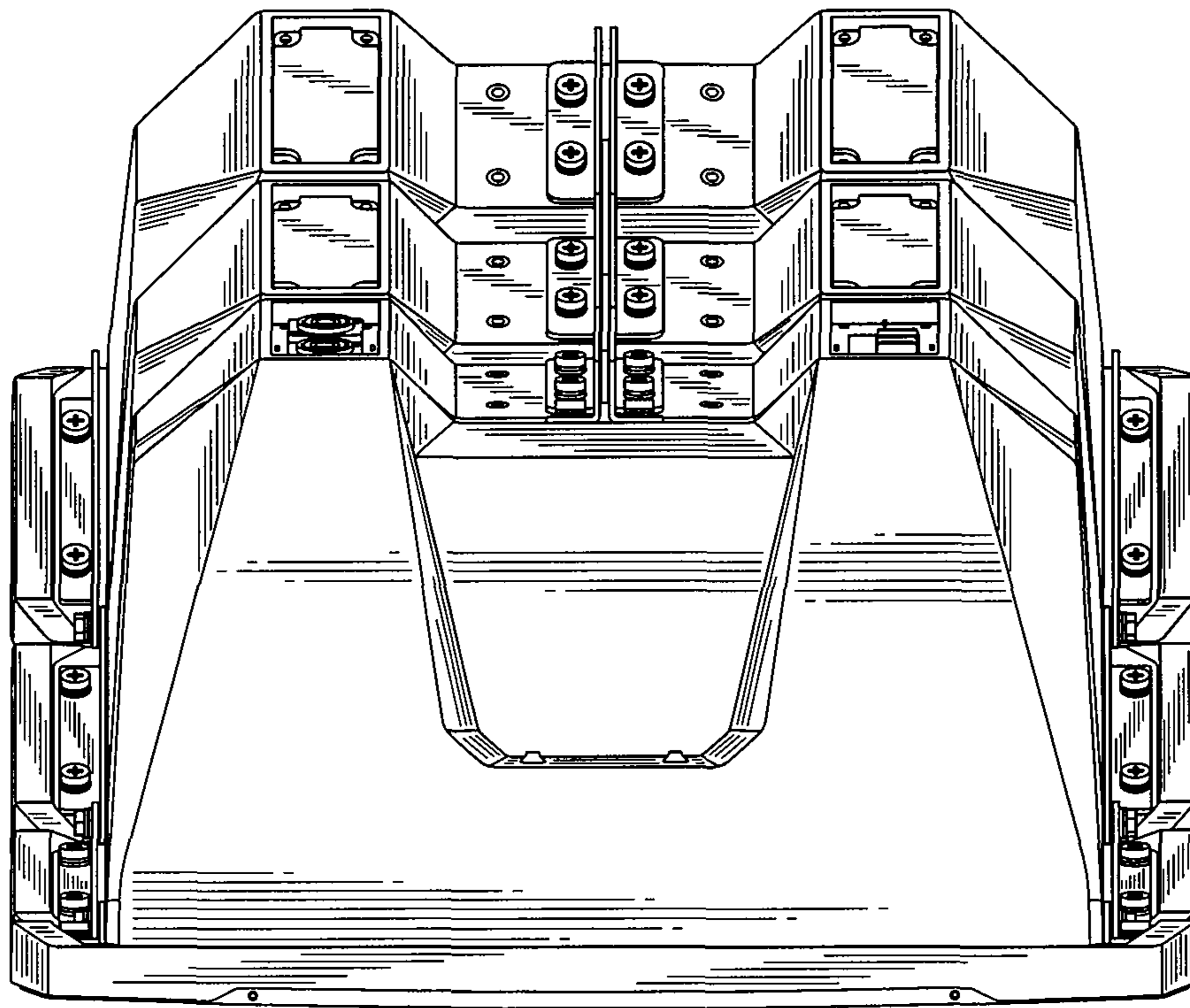

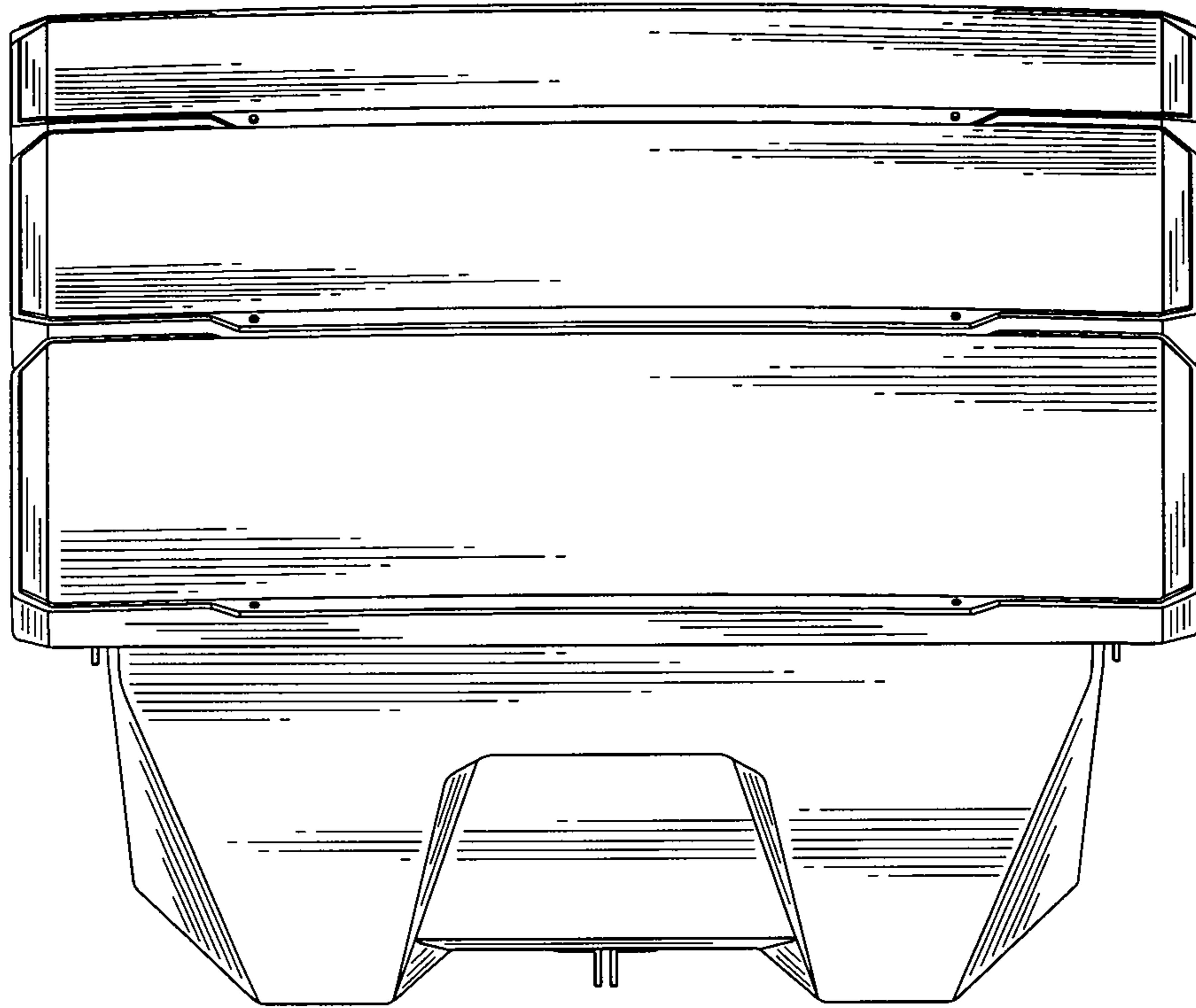
