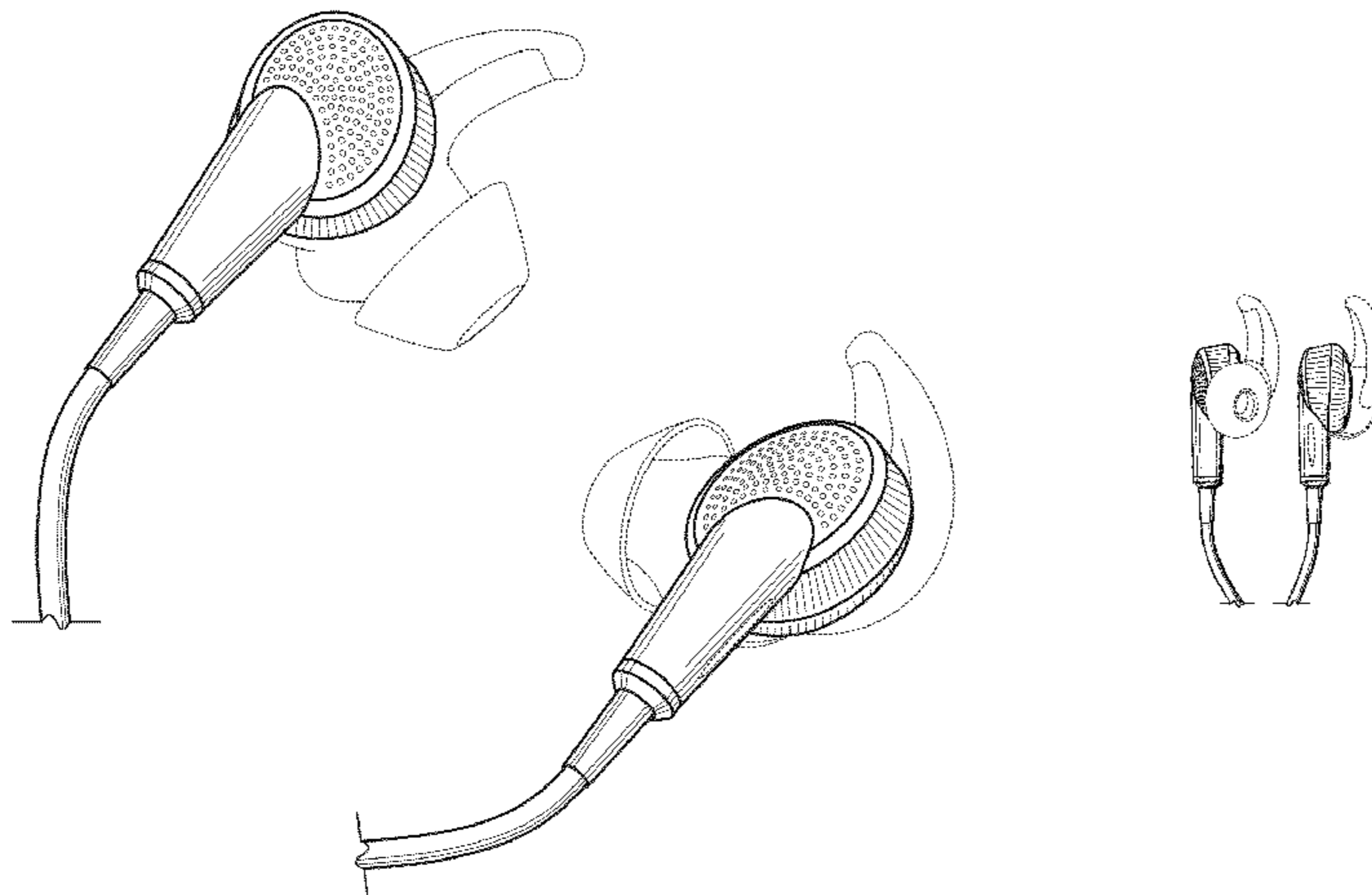
(57) **CLAIM**

The ornamental design for a set of headphones, substantially as shown and described.

DESCRIPTION

FIG. 1 is a detailed perspective view of a set of headphones as seen from the front, bottom, and left side;
 FIG. 2 is a front view thereof;
 FIG. 3 is a back view thereof;
 FIG. 4 is a right side view thereof;
 FIG. 5 is a left side view thereof;
 FIG. 6 is a top end view thereof; and,
 FIG. 7 is a bottom end view thereof.

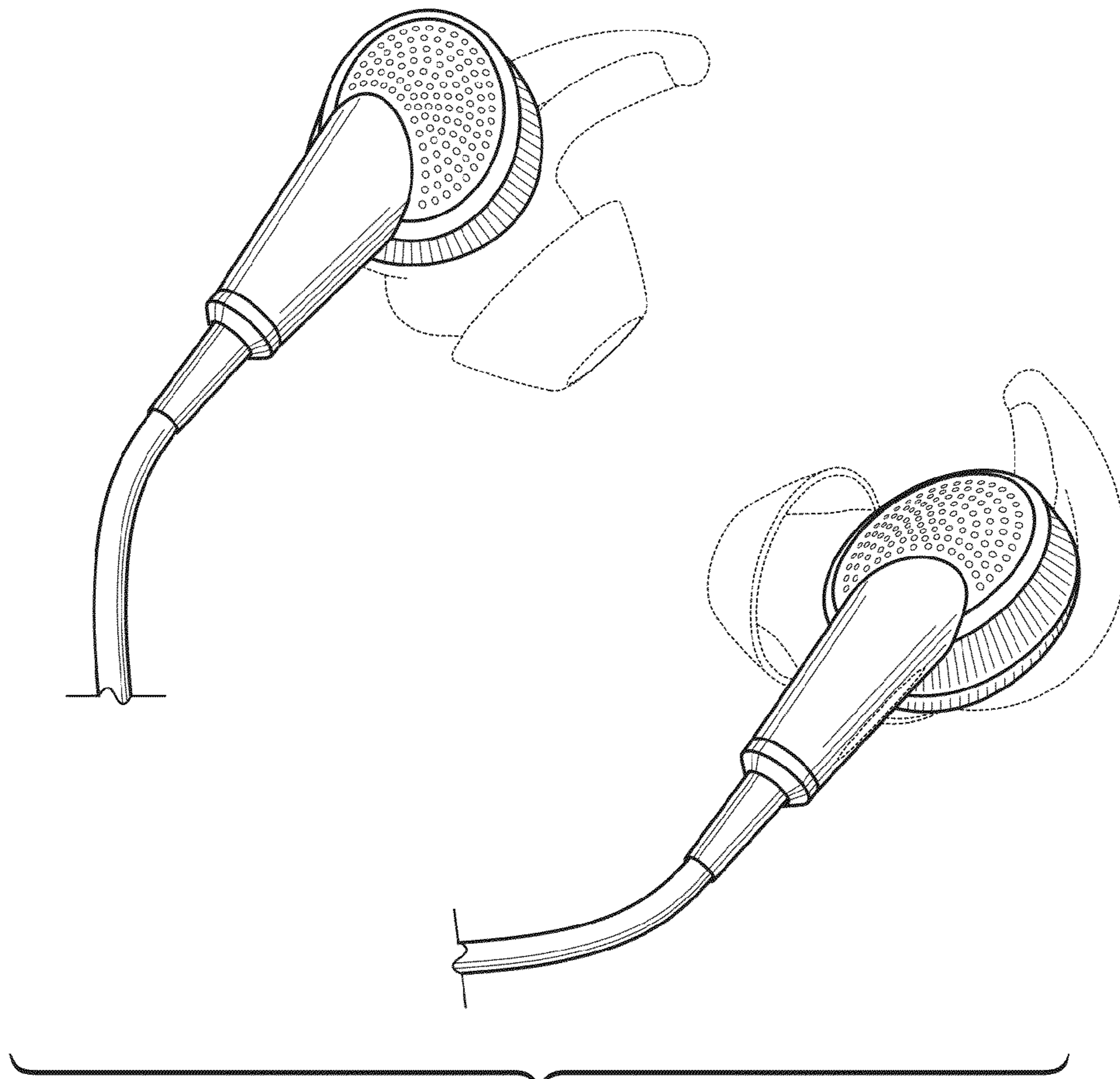

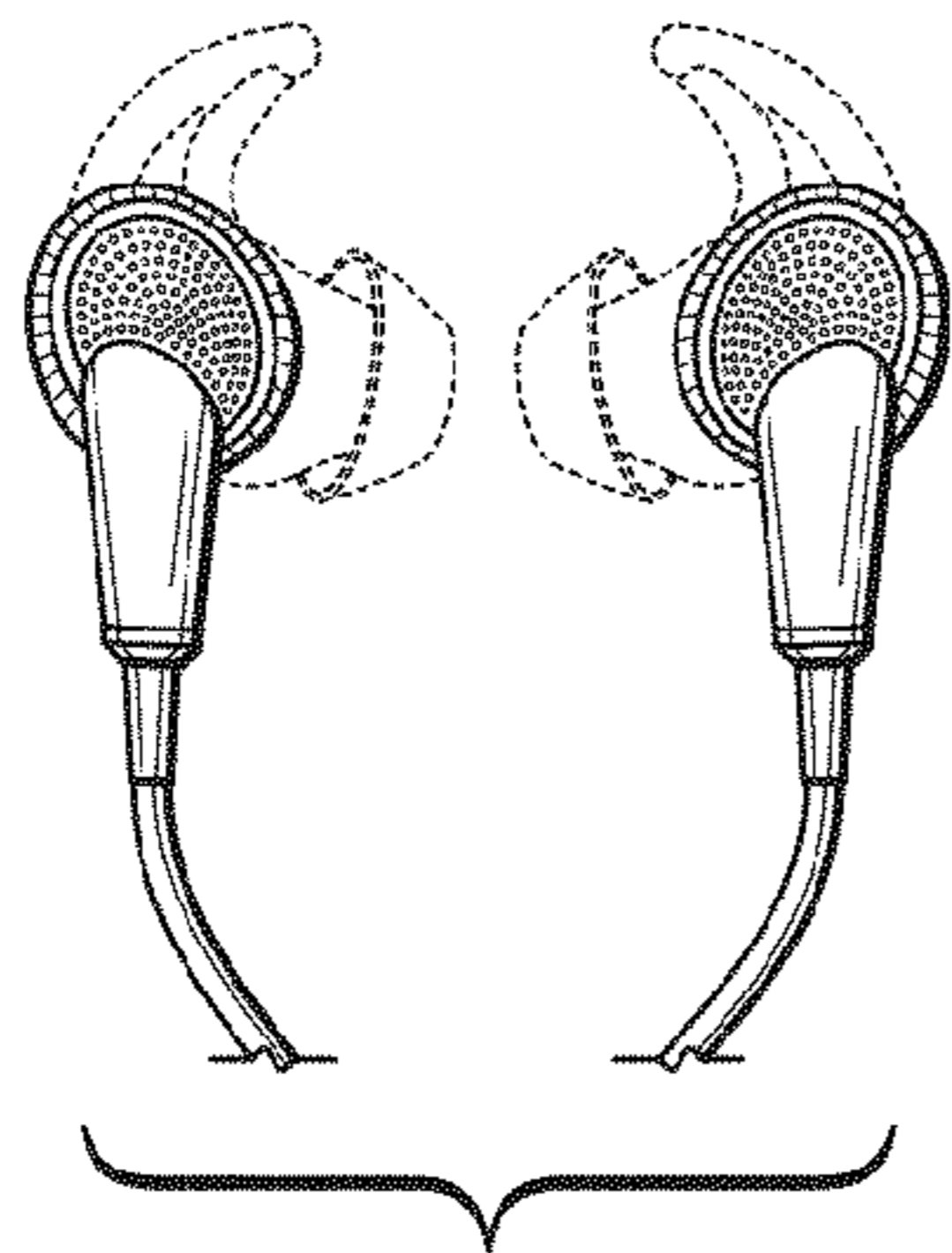

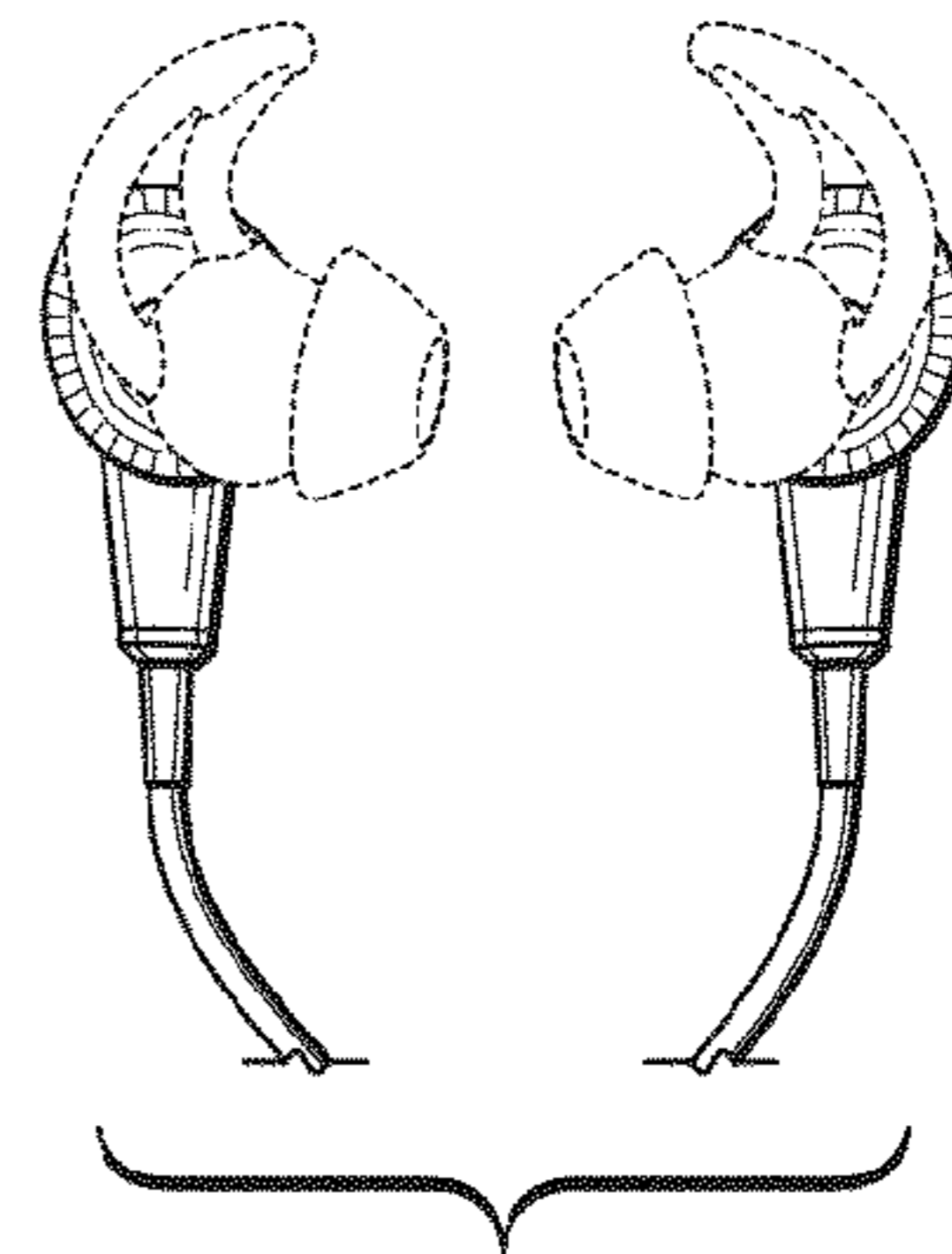

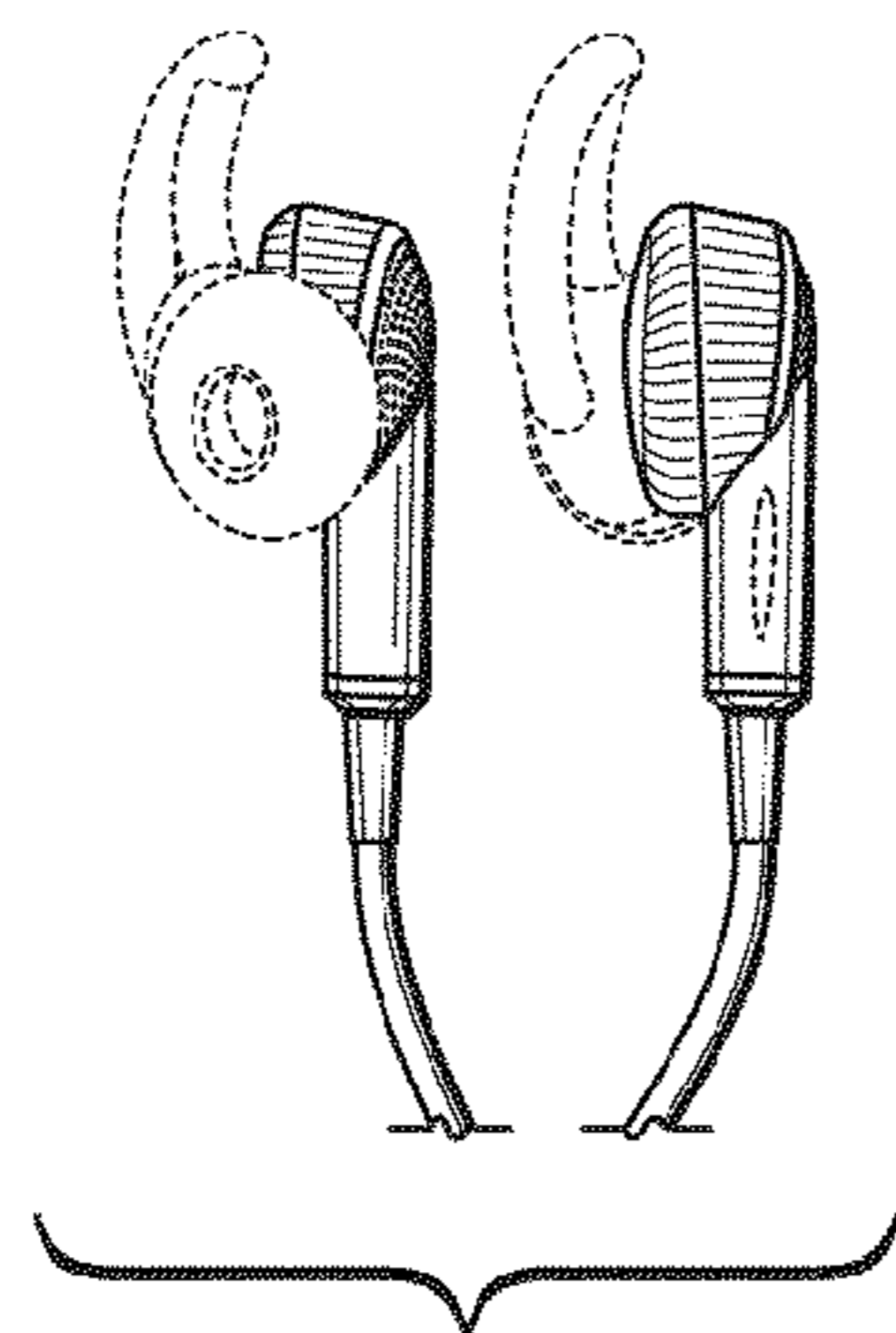

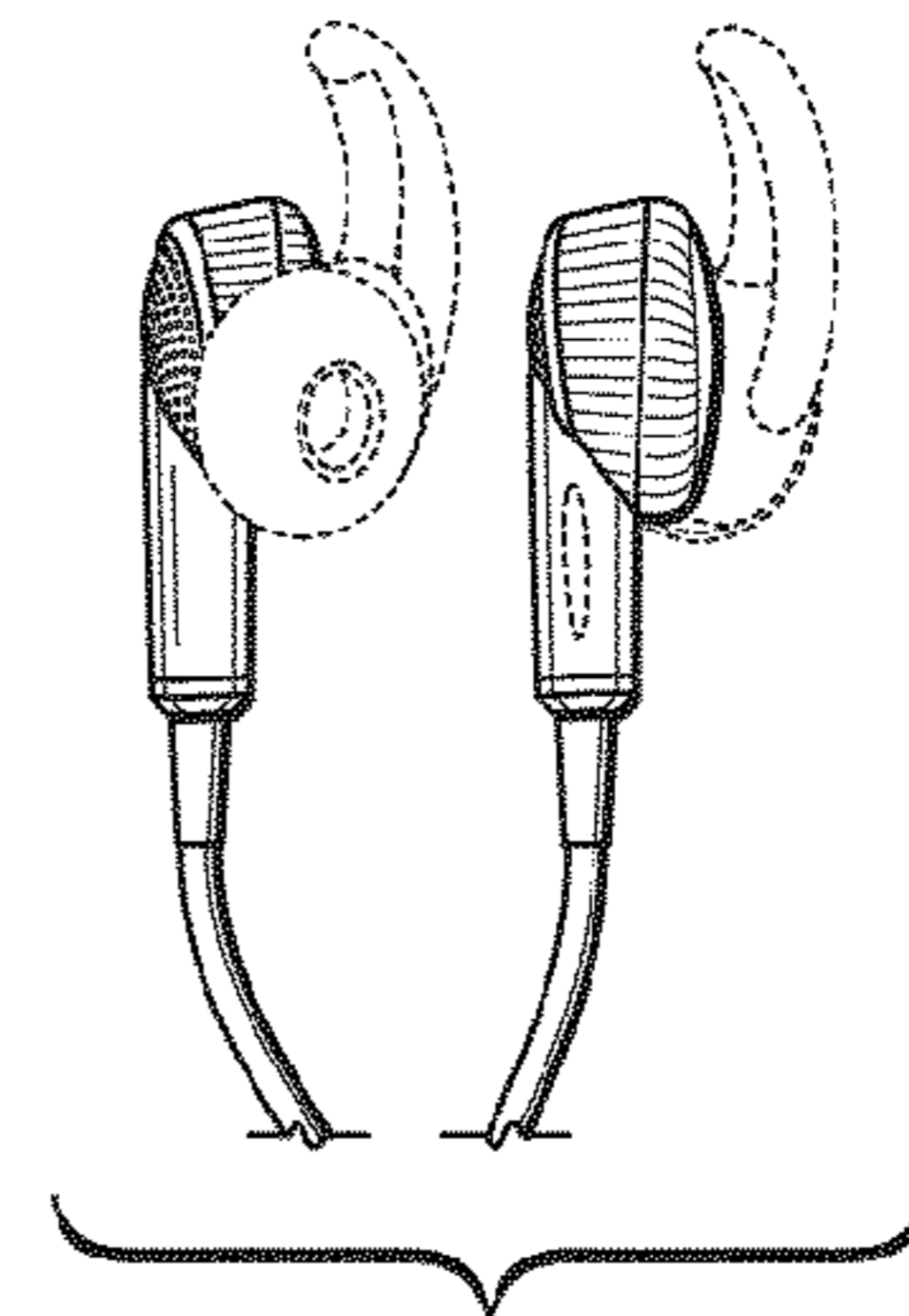

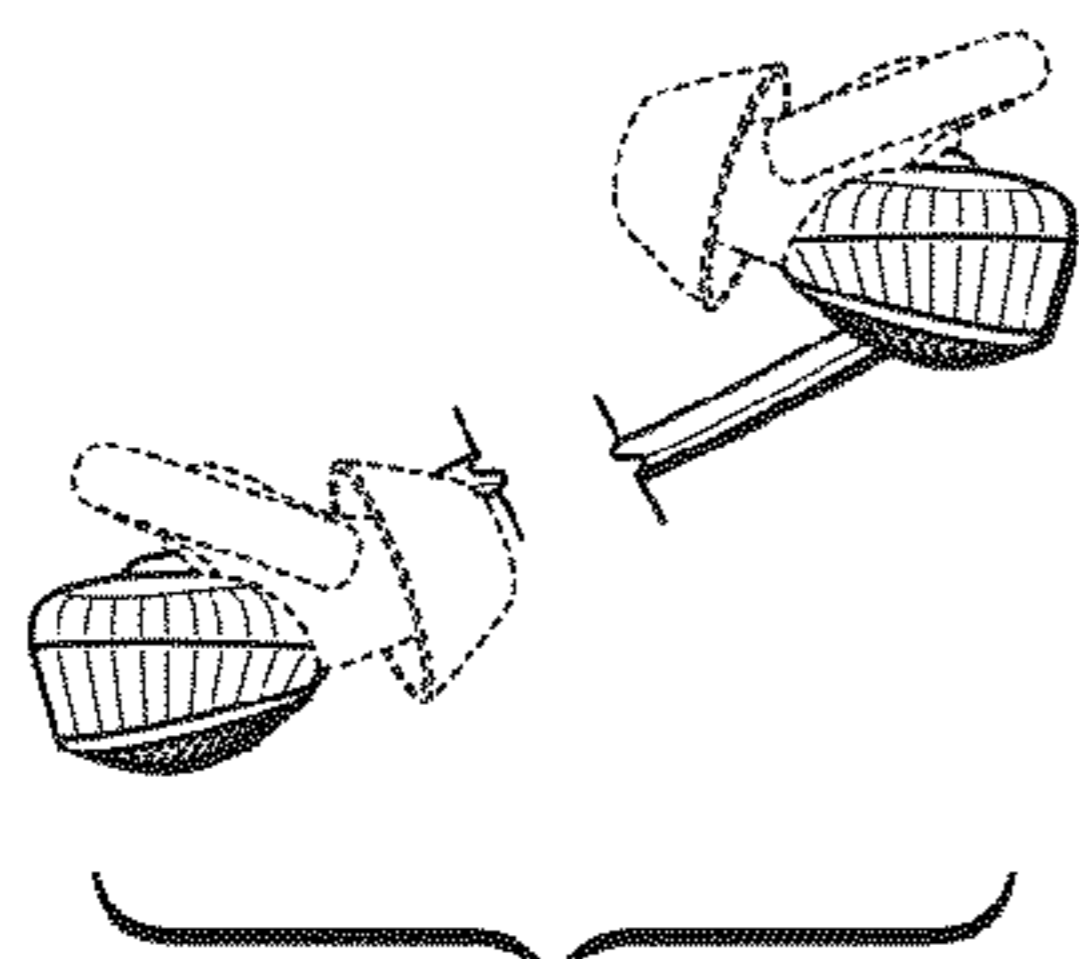

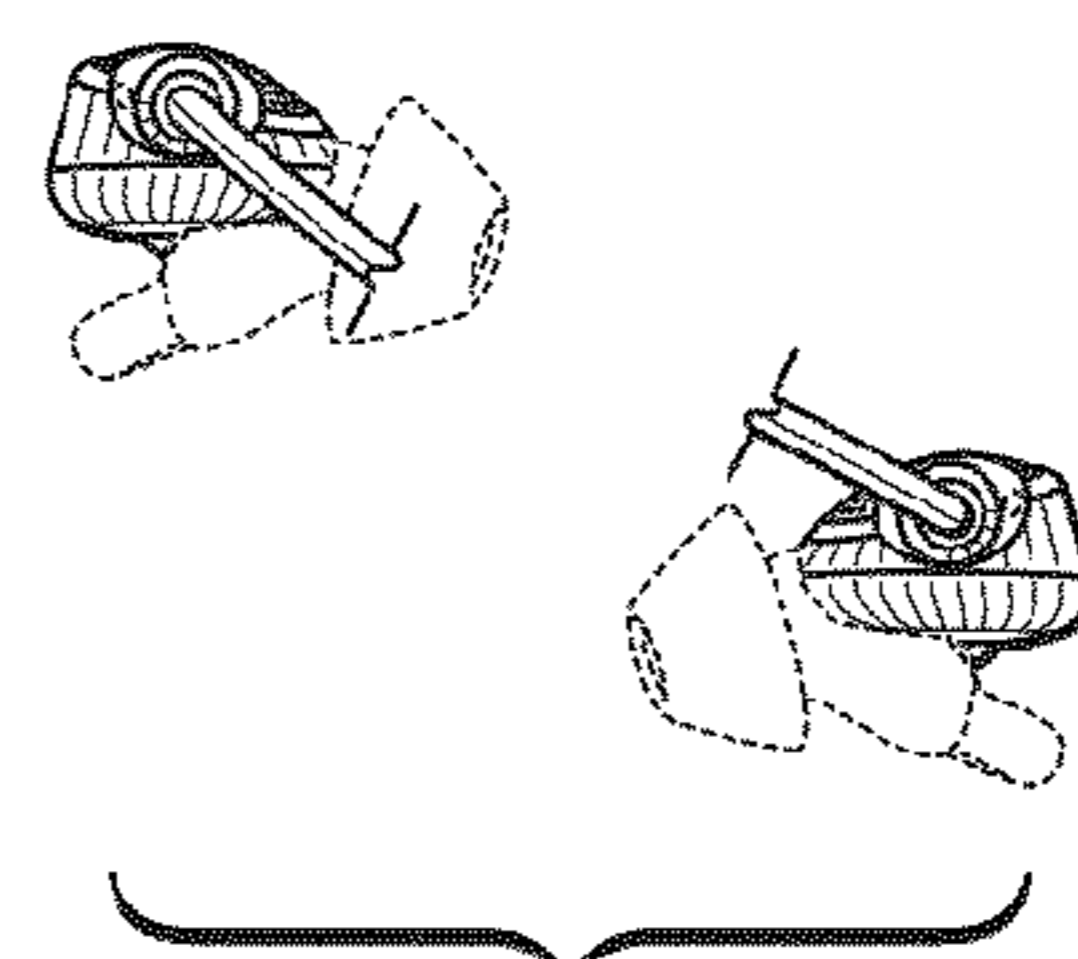
