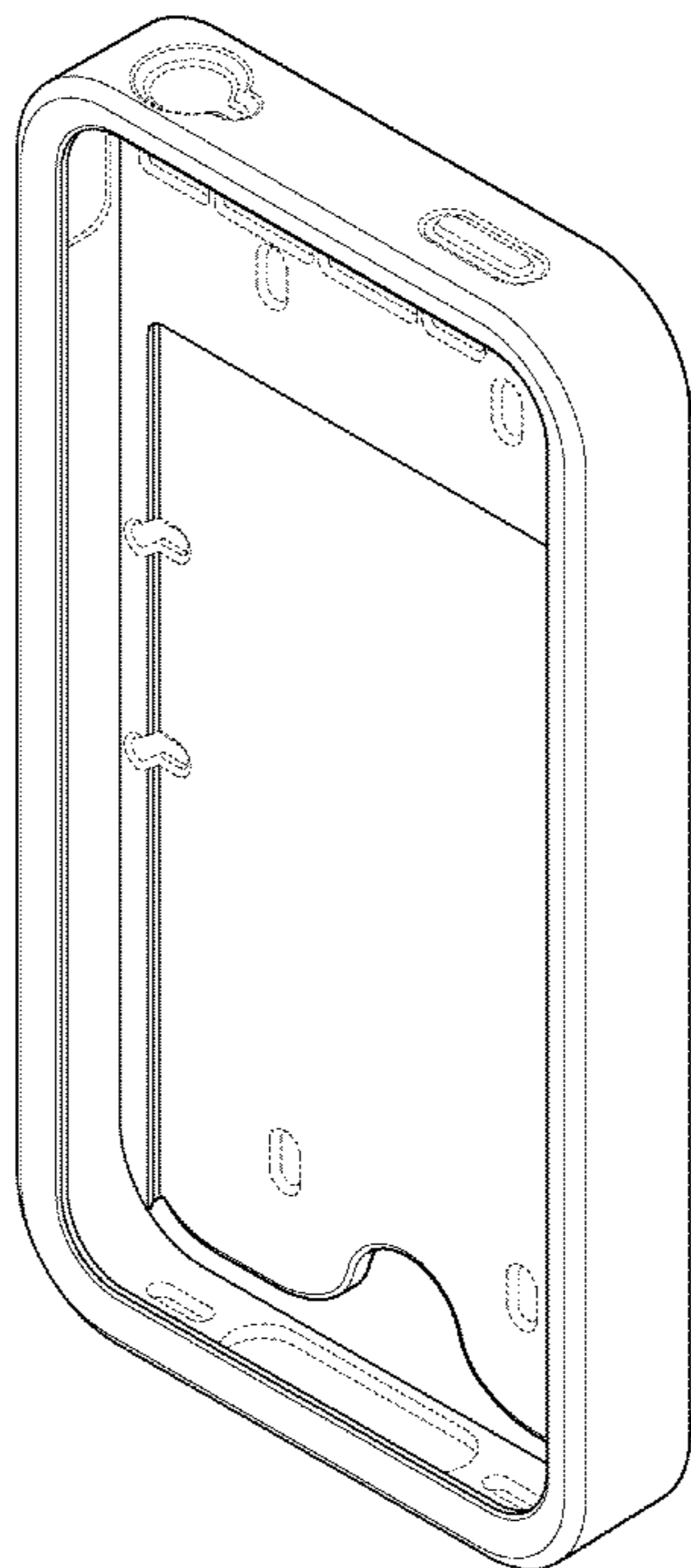
(57) **CLAIM**

The ornamental design for a mirrored, slotted phone case, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a mirrored, slotted phone case showing the design;
FIG. 2 is a rear view showing the mirror of the phone case of FIG. 1;
FIG. 3 is a top view of the phone case of FIG. 1;
FIG. 4 is a bottom view of the phone case of FIG. 1;
FIG. 5 is a front view of the phone case of FIG. 1;

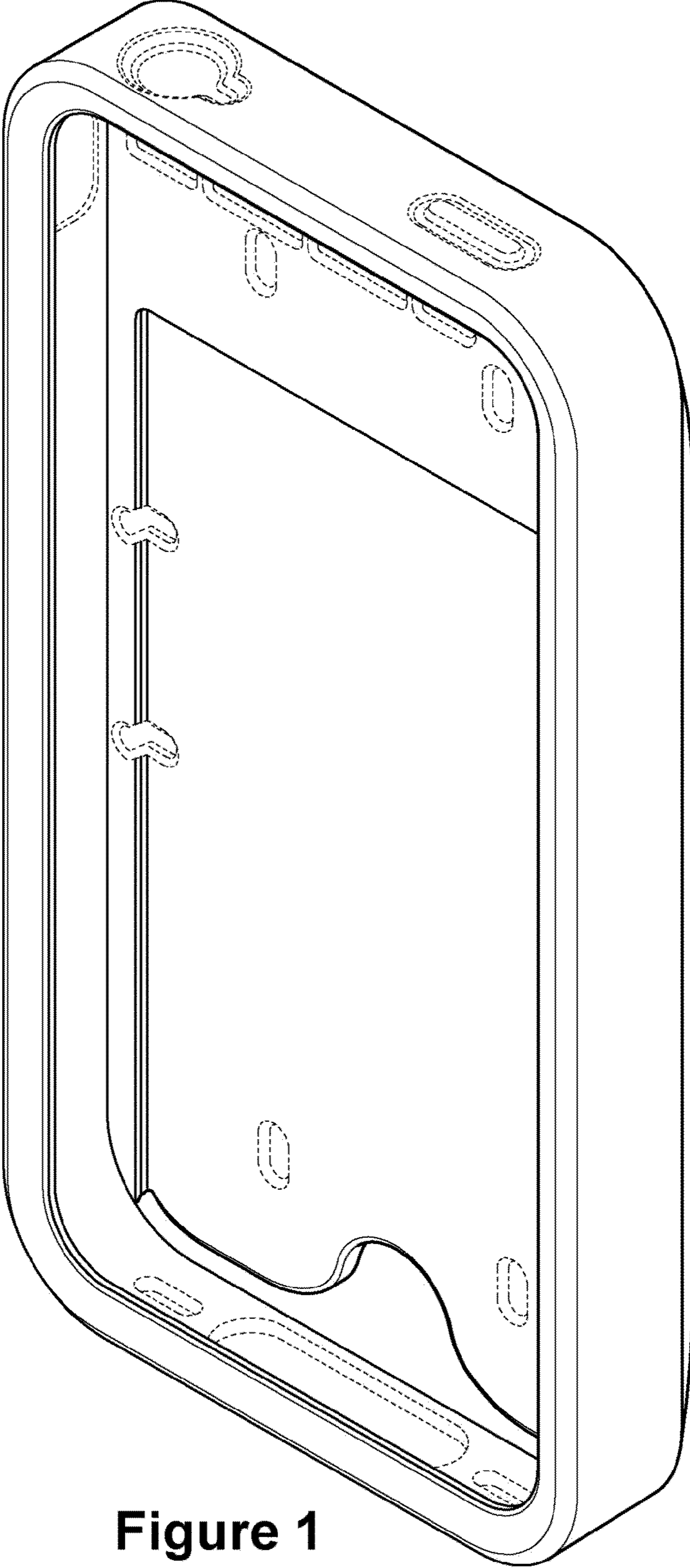

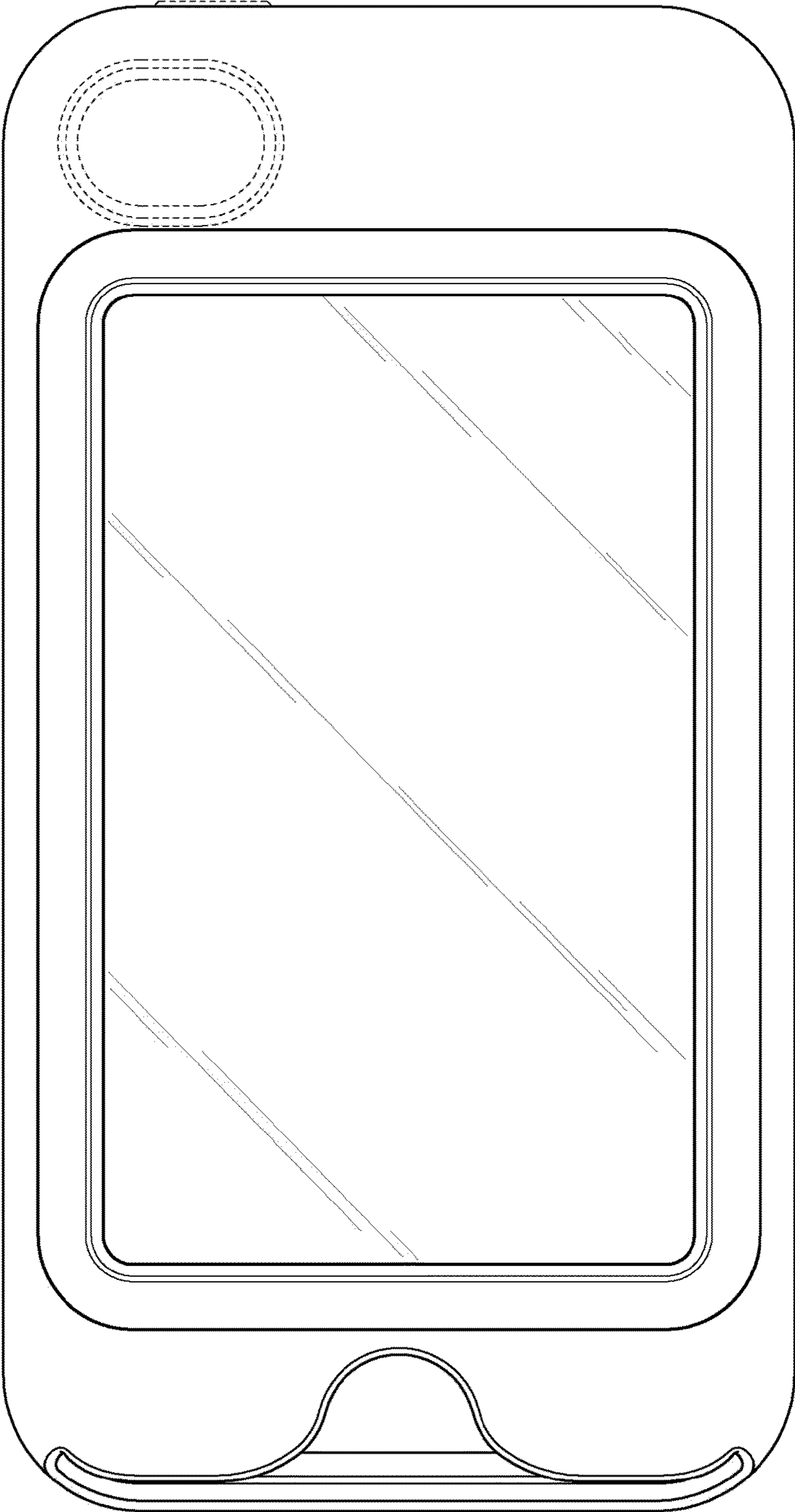

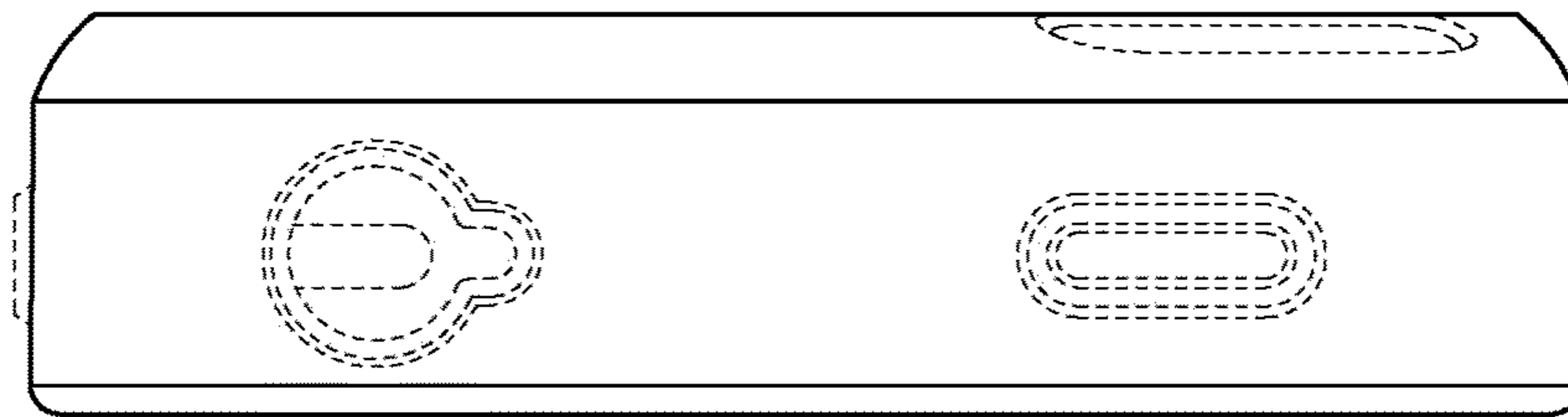

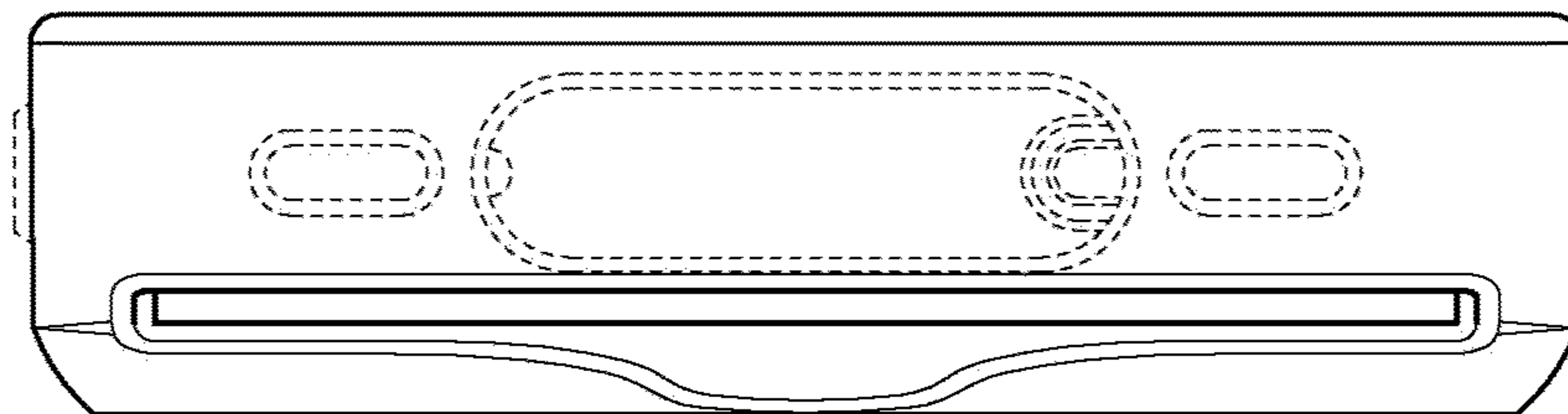

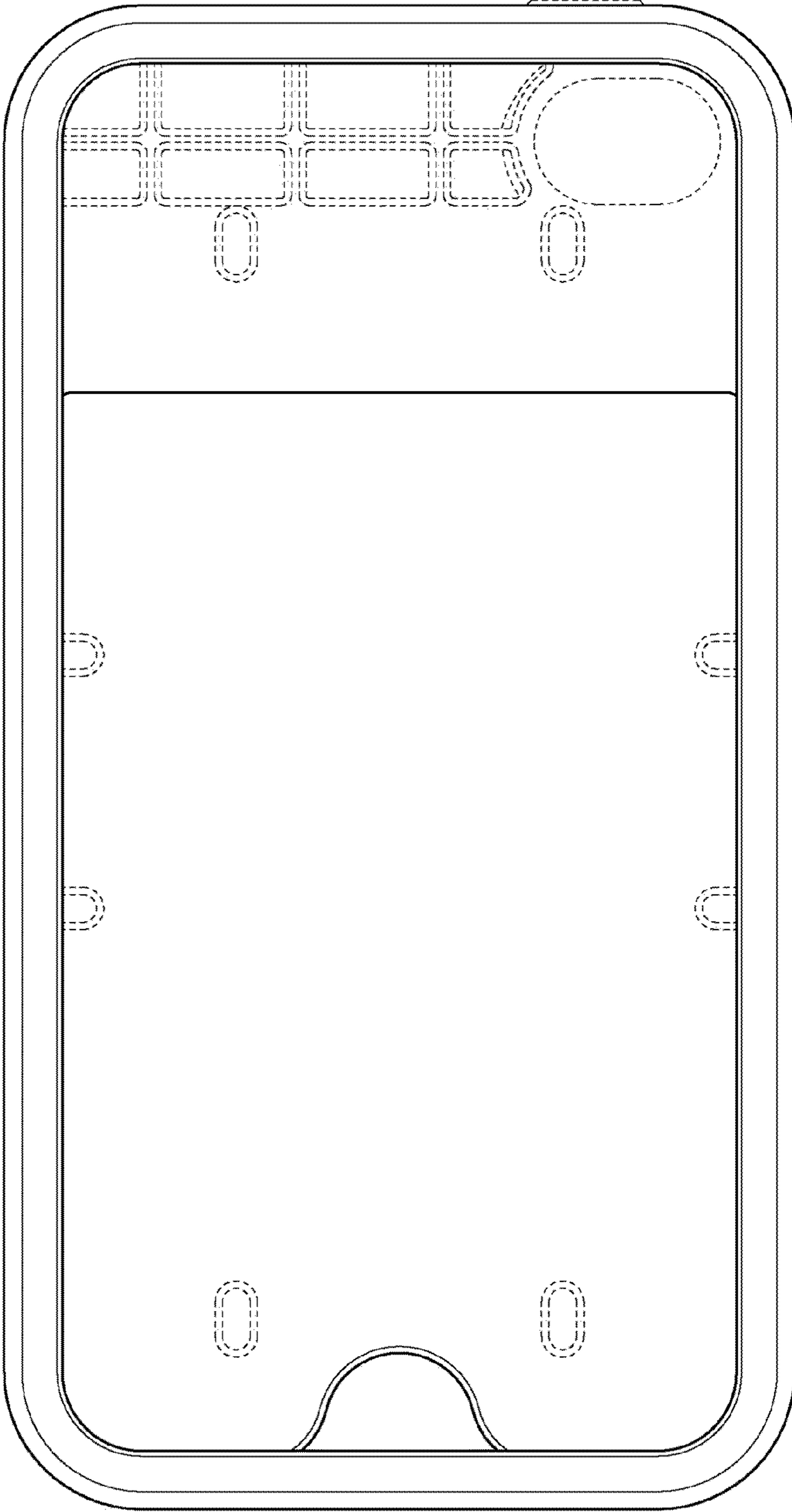

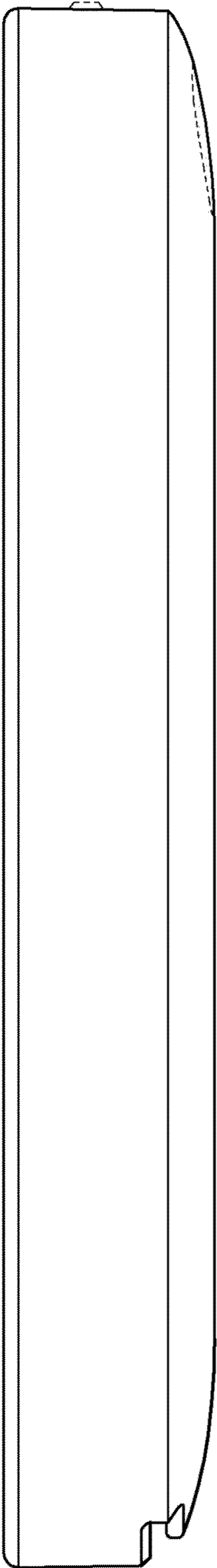

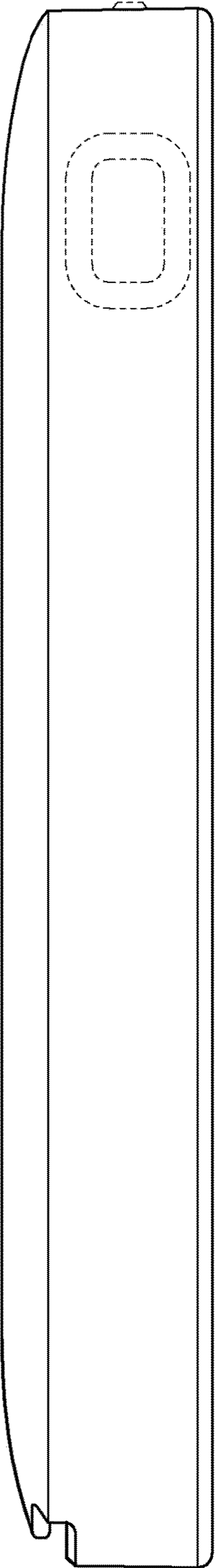
