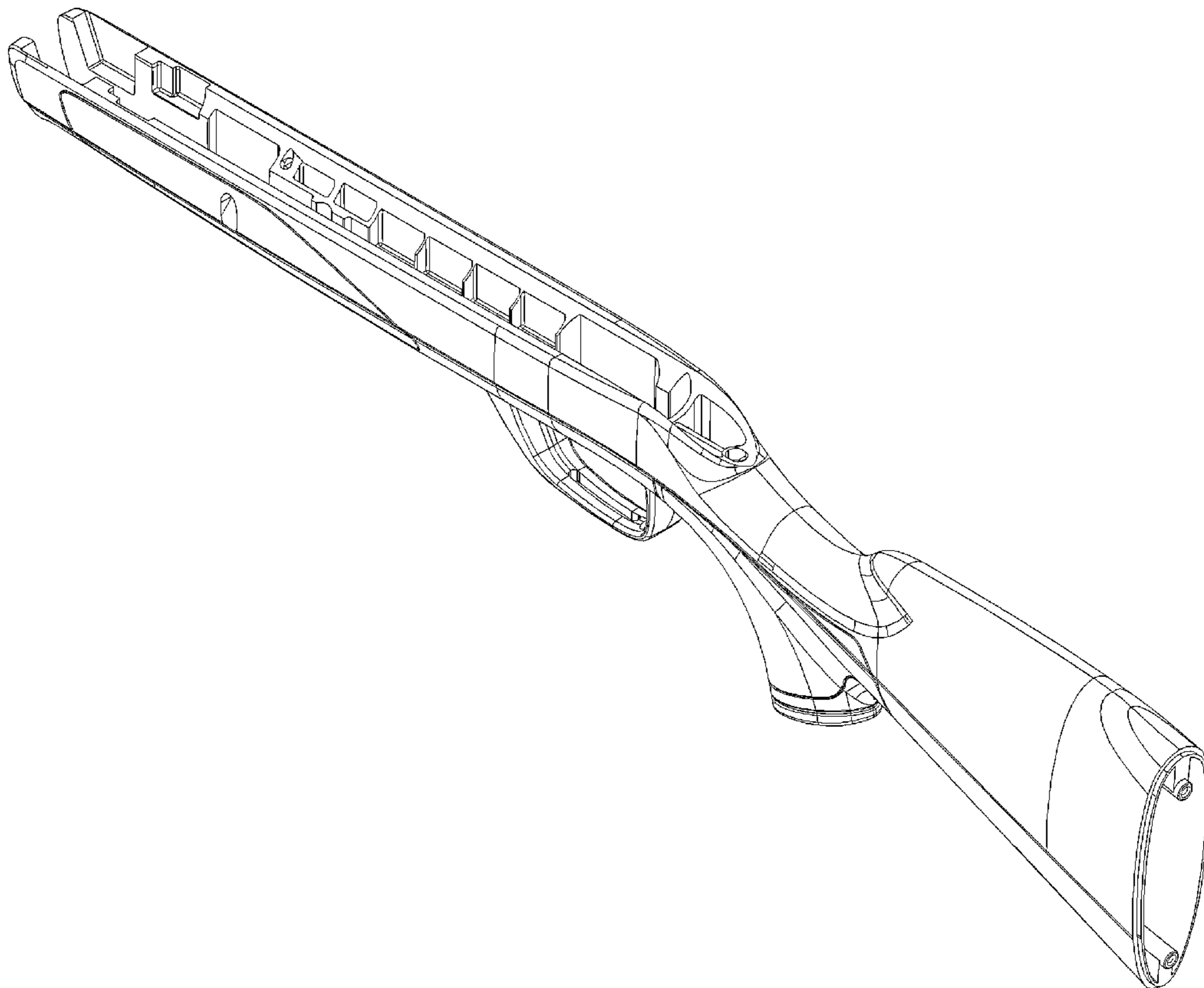
(57) **CLAIM**

The ornamental design for a firearm stock, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view facing rearward of a left hand side of a firearm stock in accordance with this invention; FIG. 2 is a left hand side view of the firearm stock of FIG. 1; FIG. 3 is a right hand side view of the firearm stock of FIG. 1; FIG. 4 is a front view of the firearm stock of FIG. 1; FIG. 5 is a rear view of the firearm stock of FIG. 1; FIG. 6 is a top view of the firearm stock of FIG. 1; and, FIG. 7 is a bottom view of the firearm stock of FIG. 1.

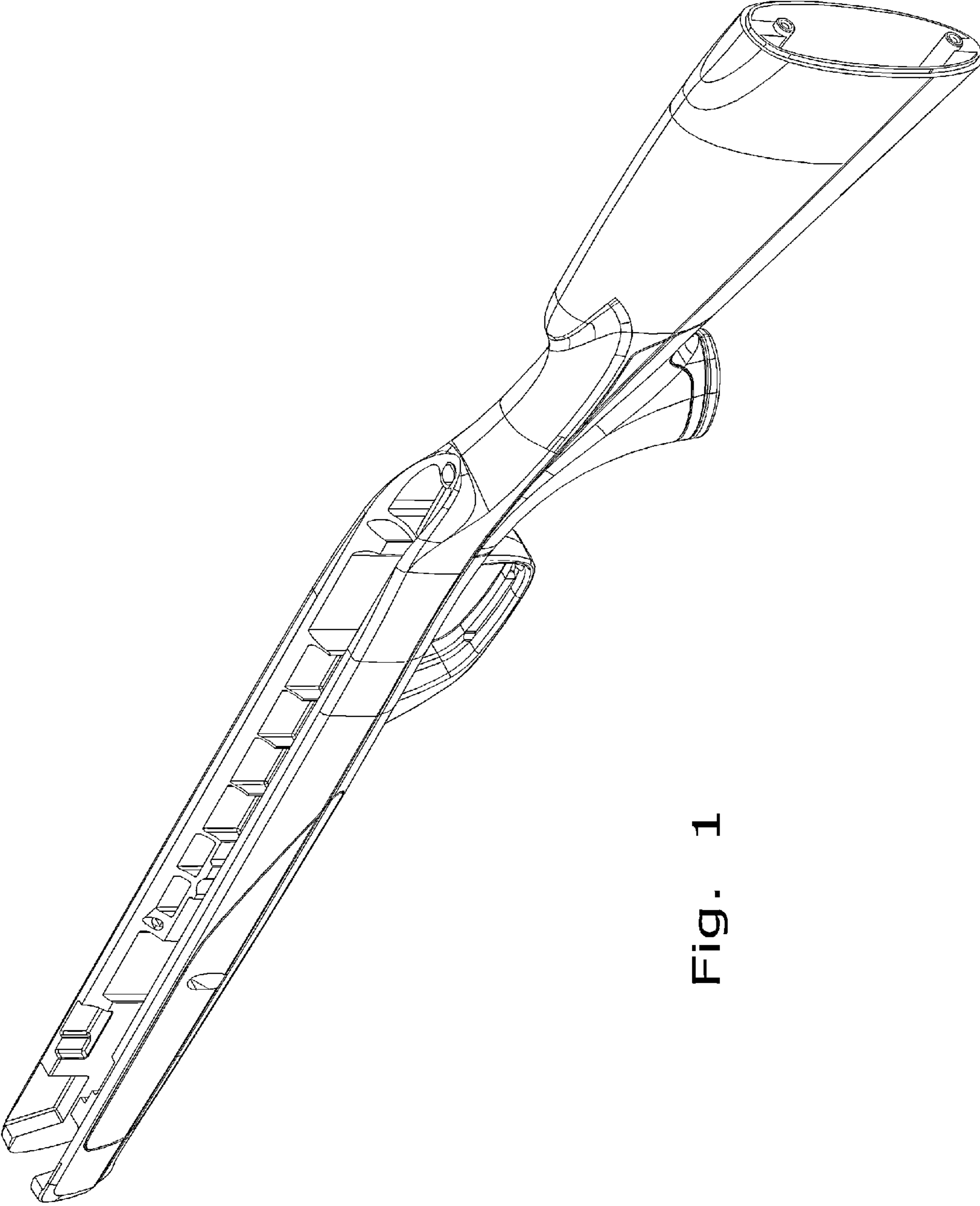

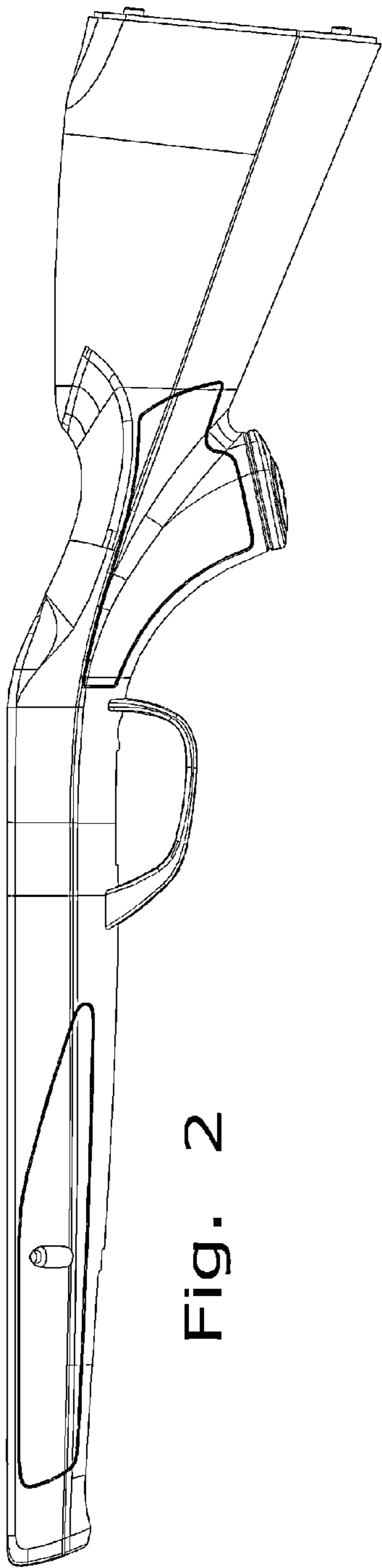

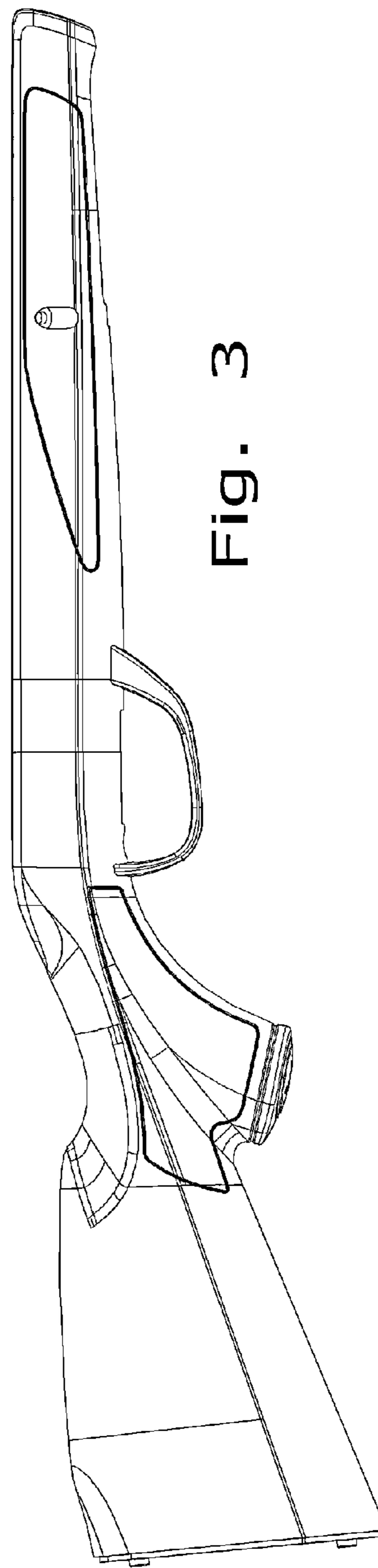

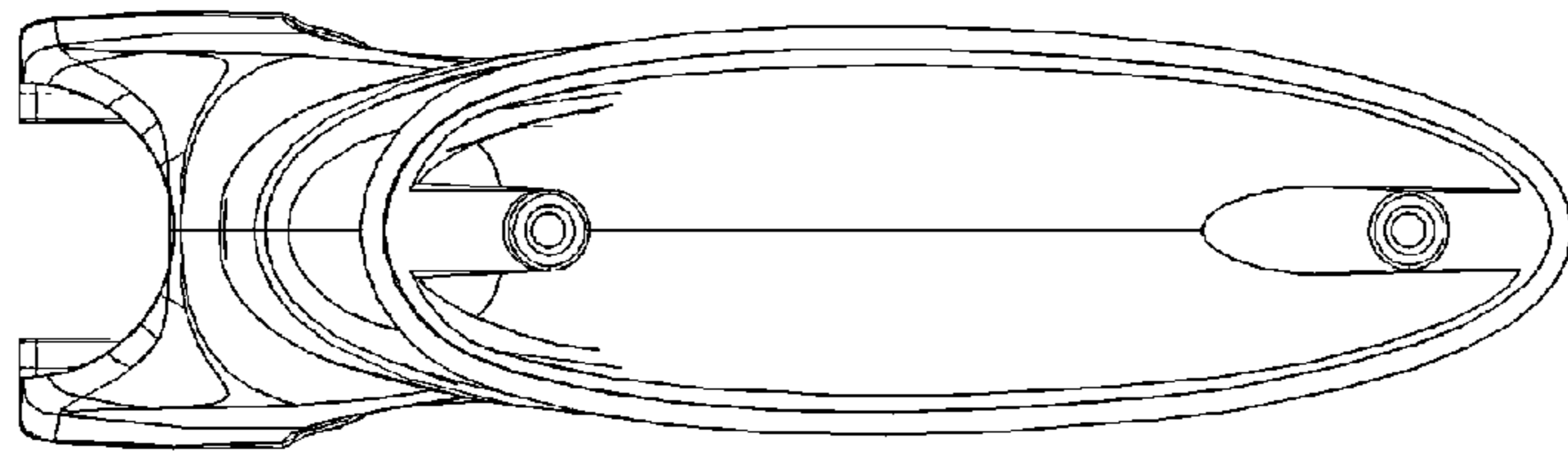

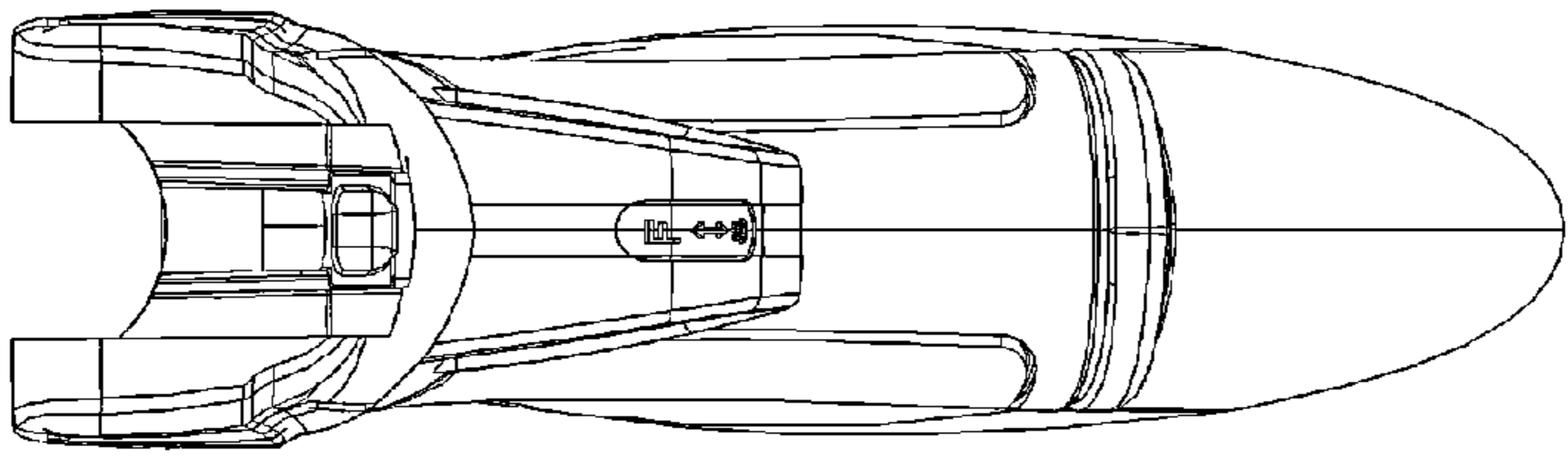

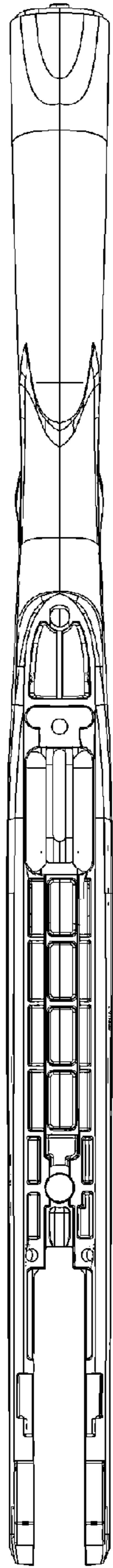

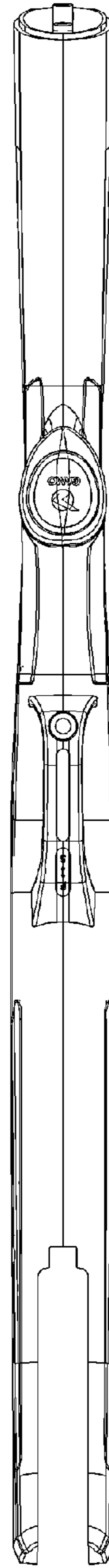
