(57) **CLAIM**

The ornamental design for a no or low water use latrine pan assembly, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a no or low water use latrine pan assembly;  
 FIG. 2 is a side view of the no or low water use latrine pan assembly of FIG. 1;  
 FIG. 3 is a top plan view of the no or low water use latrine pan assembly of FIG. 1;  
 FIG. 4 is a front view of the no or low water use latrine pan assembly of FIG. 1;  
 FIG. 5 is a bottom view of the no or low water use latrine pan assembly of FIG. 1;  
 FIG. 6 is a side oriented perspective view of the no or low water use latrine pan assembly of FIG. 1 wherein a portion is cut away along DR-DR;  
 FIG. 7 is a right side view of the no or low water use latrine pan assembly of FIG. 1, in a cross section taken along DR-DR, in a closed position; and,  
 FIG. 8 is a right side view of the no or low water use latrine pan of FIG. 1 in a cross section taken along DR-DR in an open position.

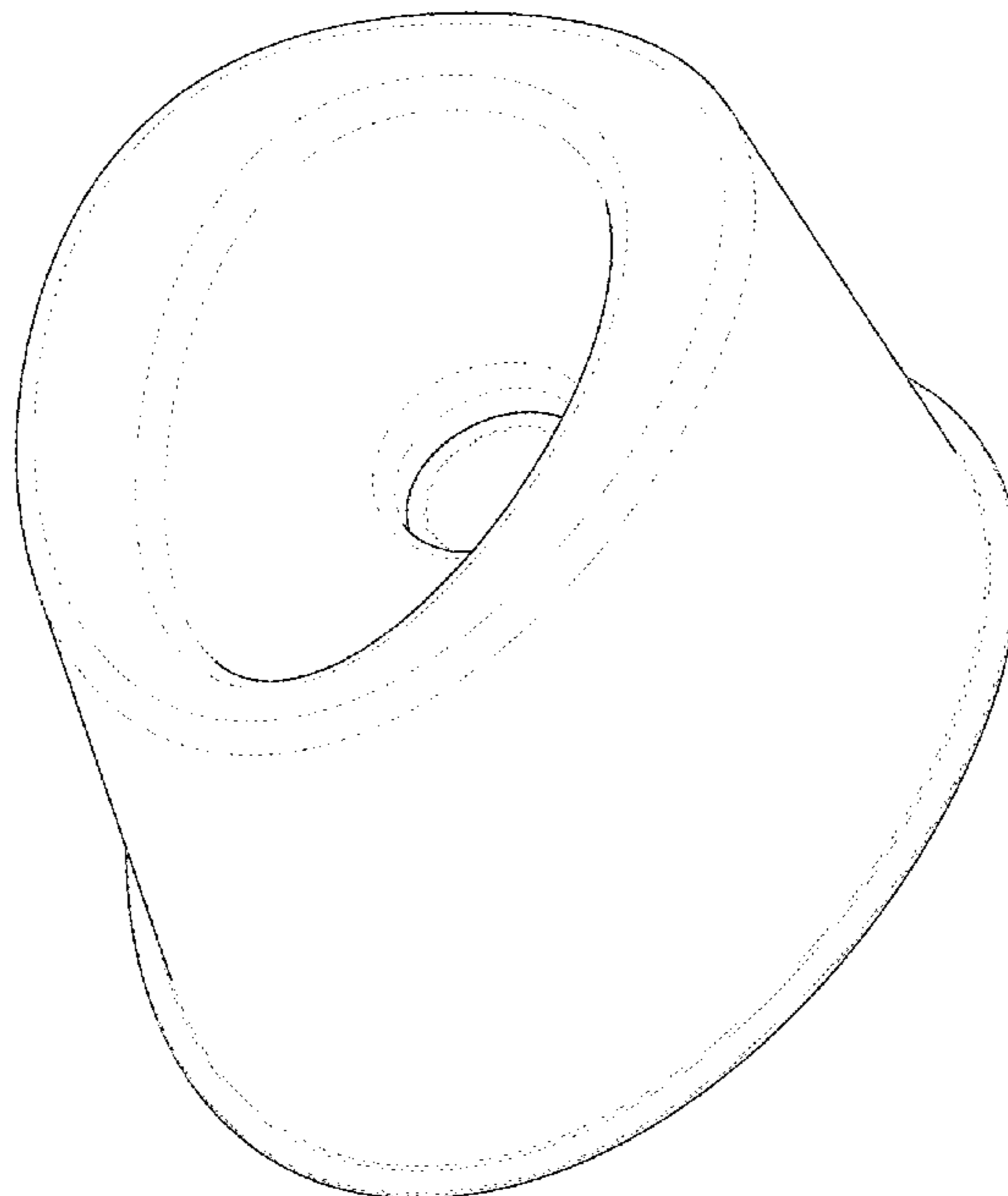

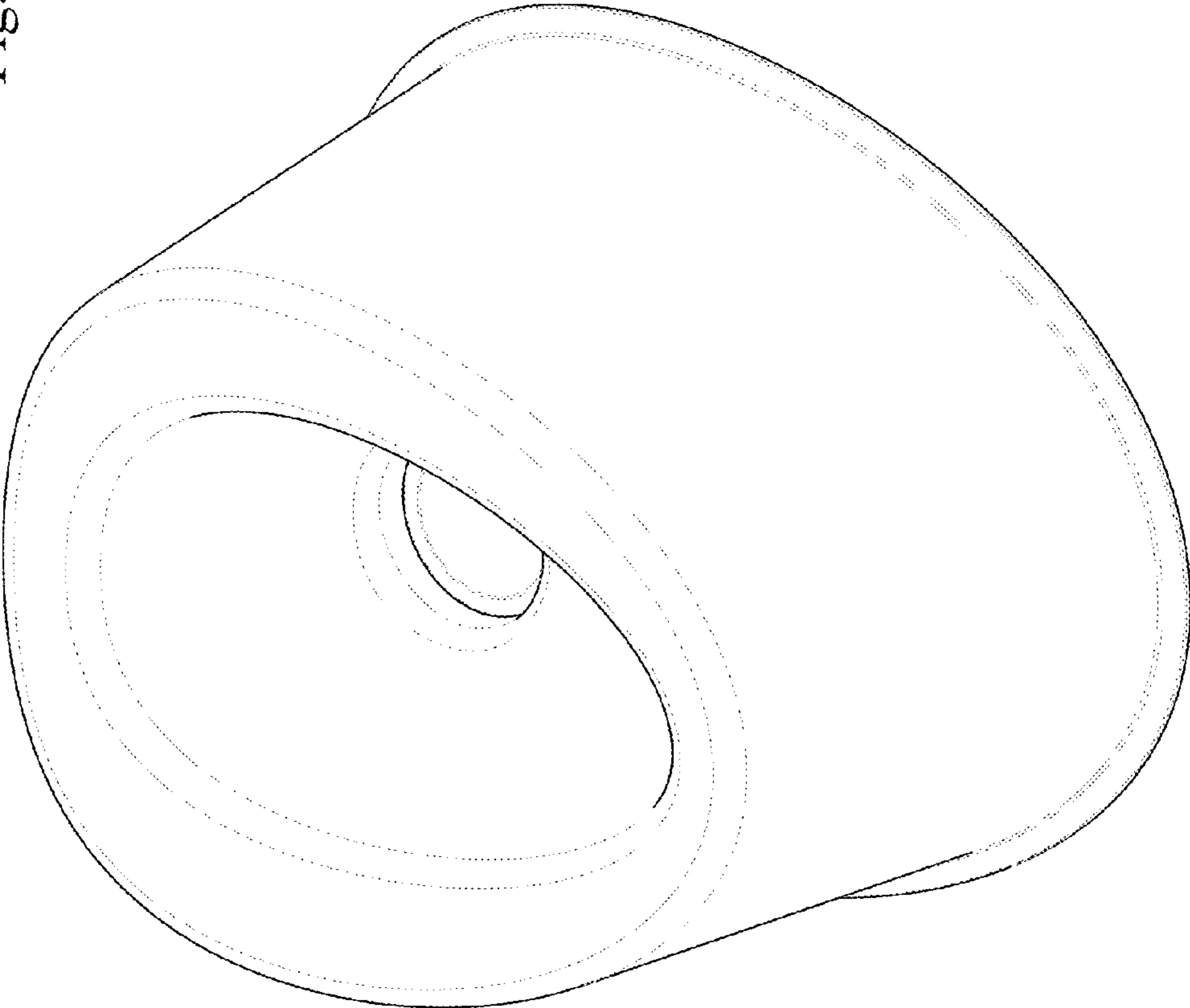

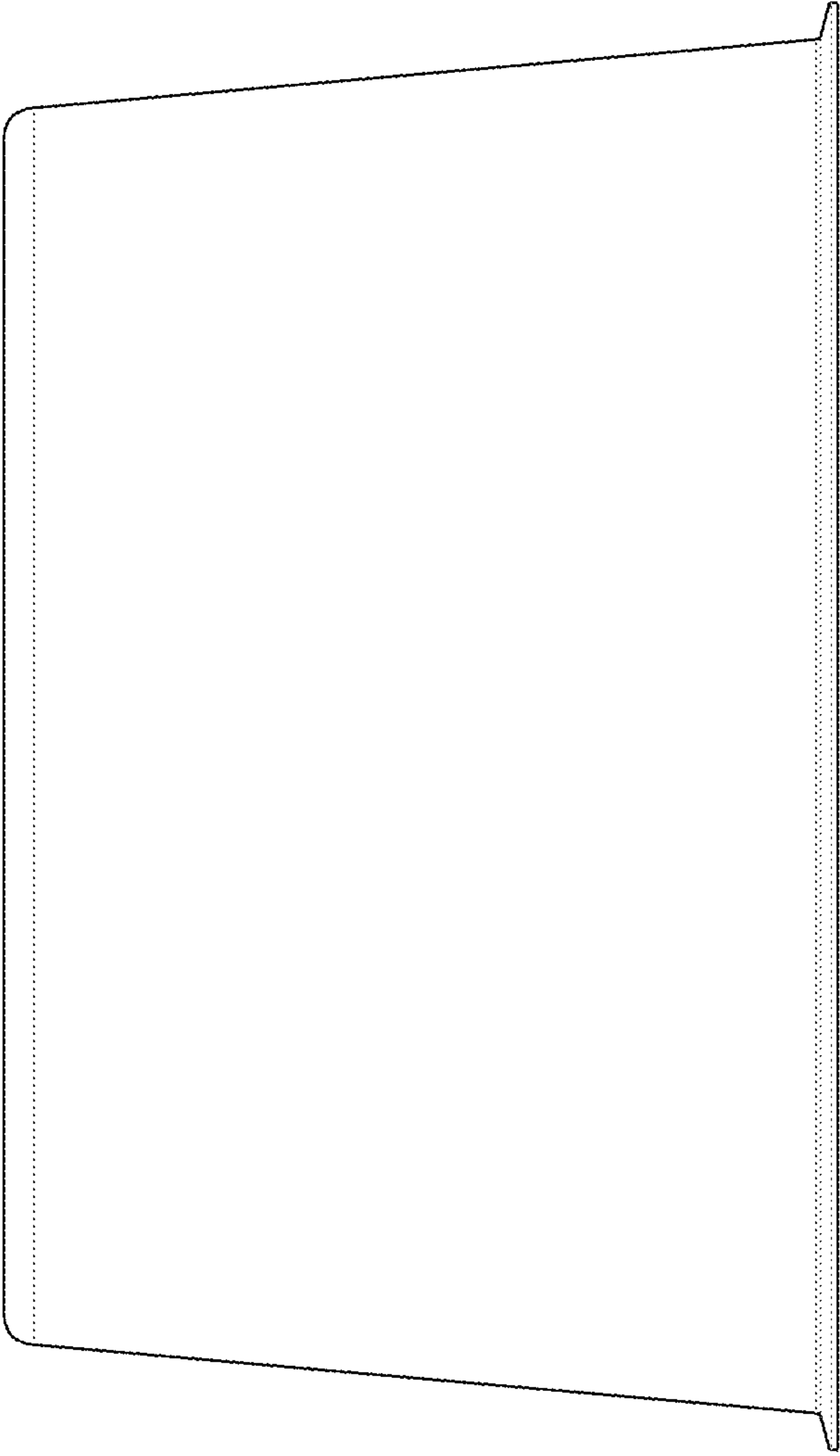

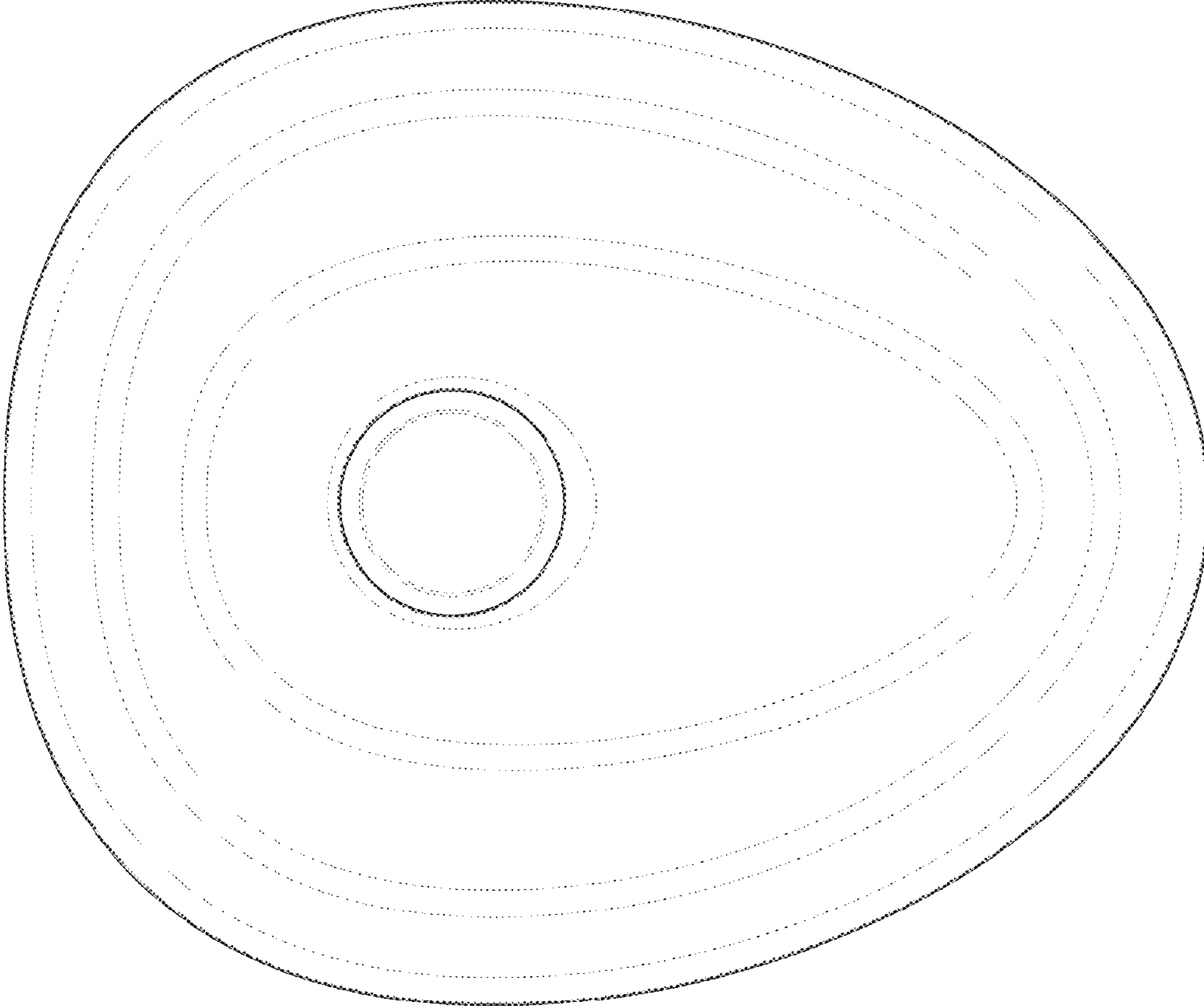

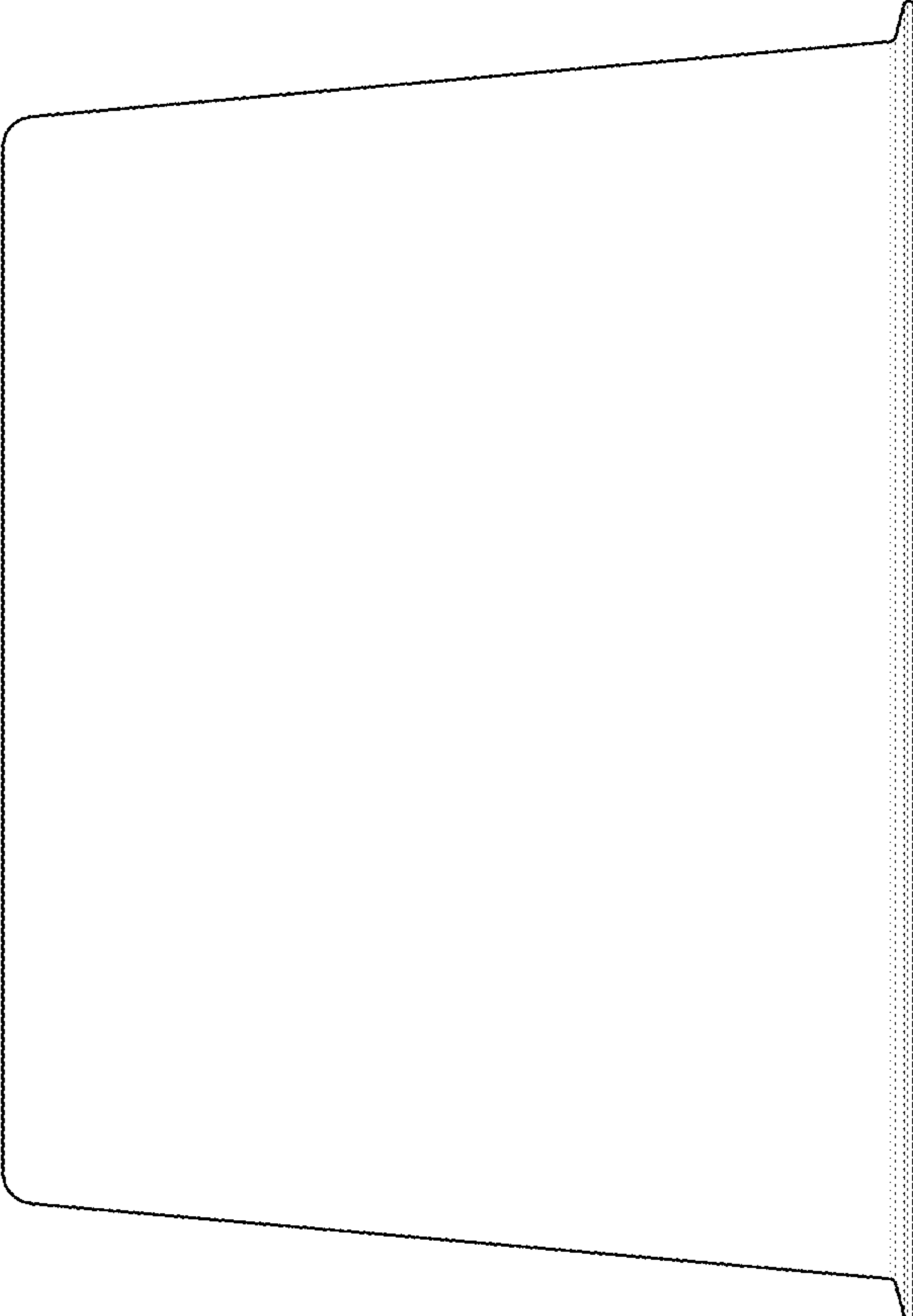
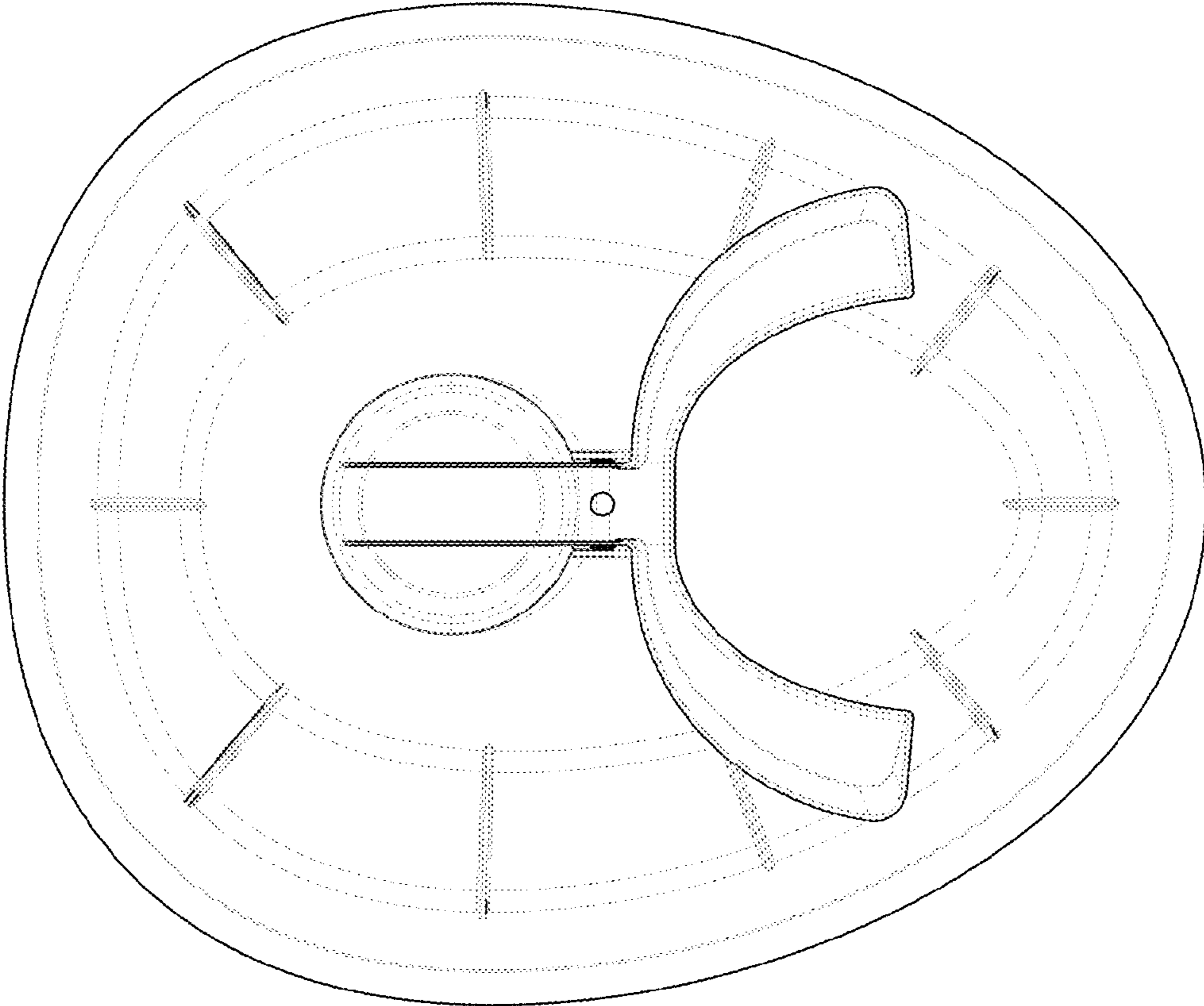

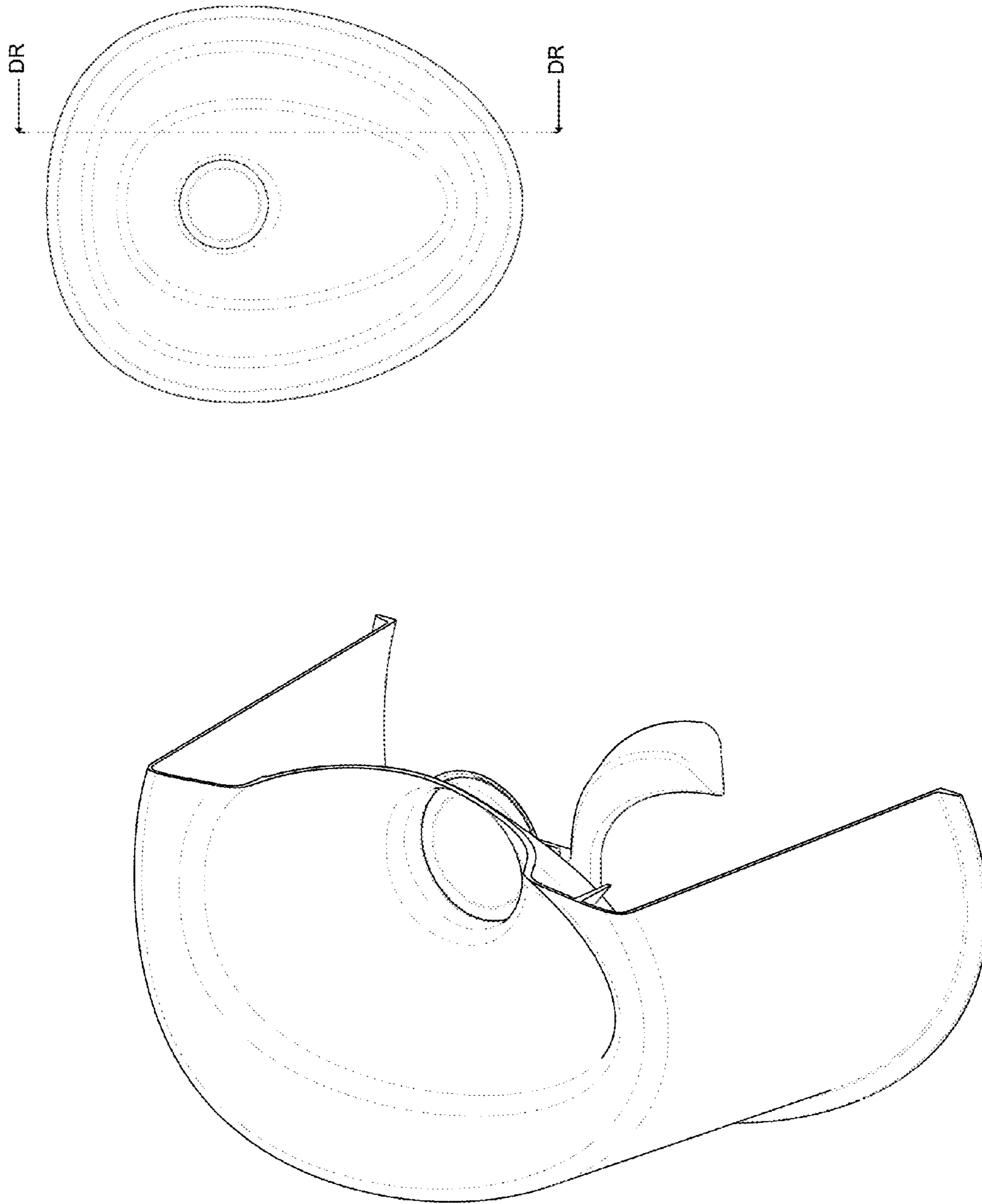

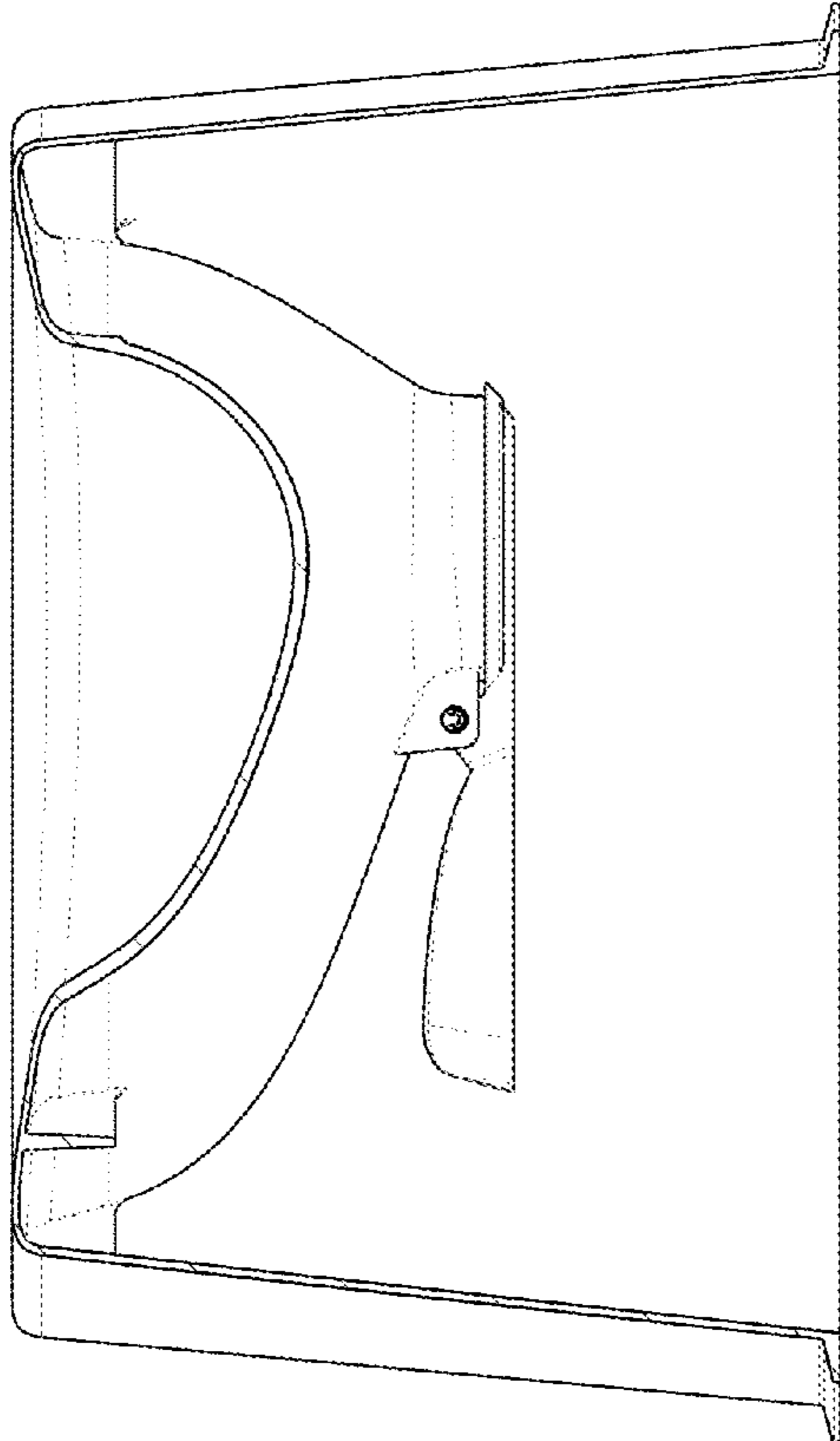

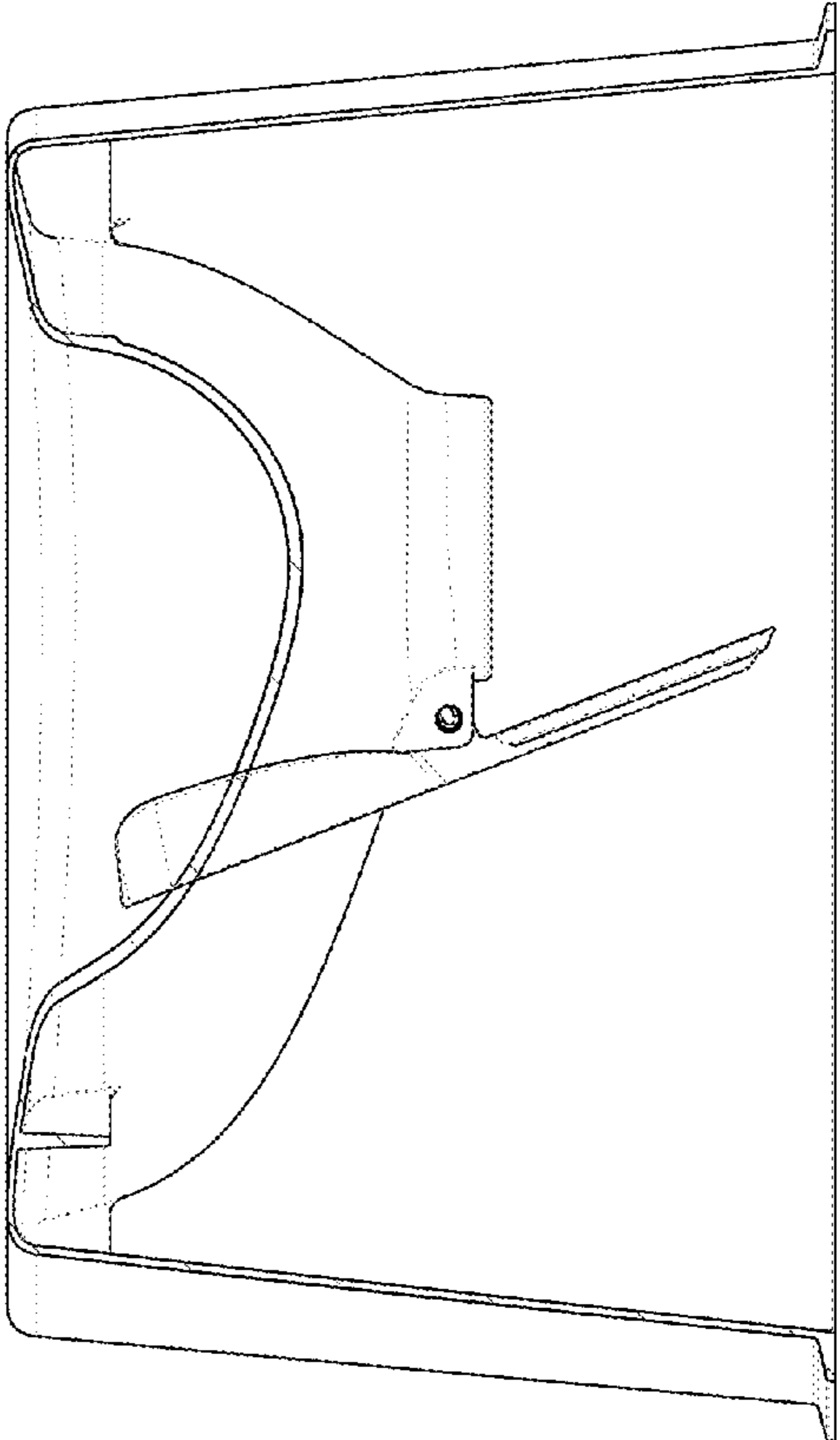
