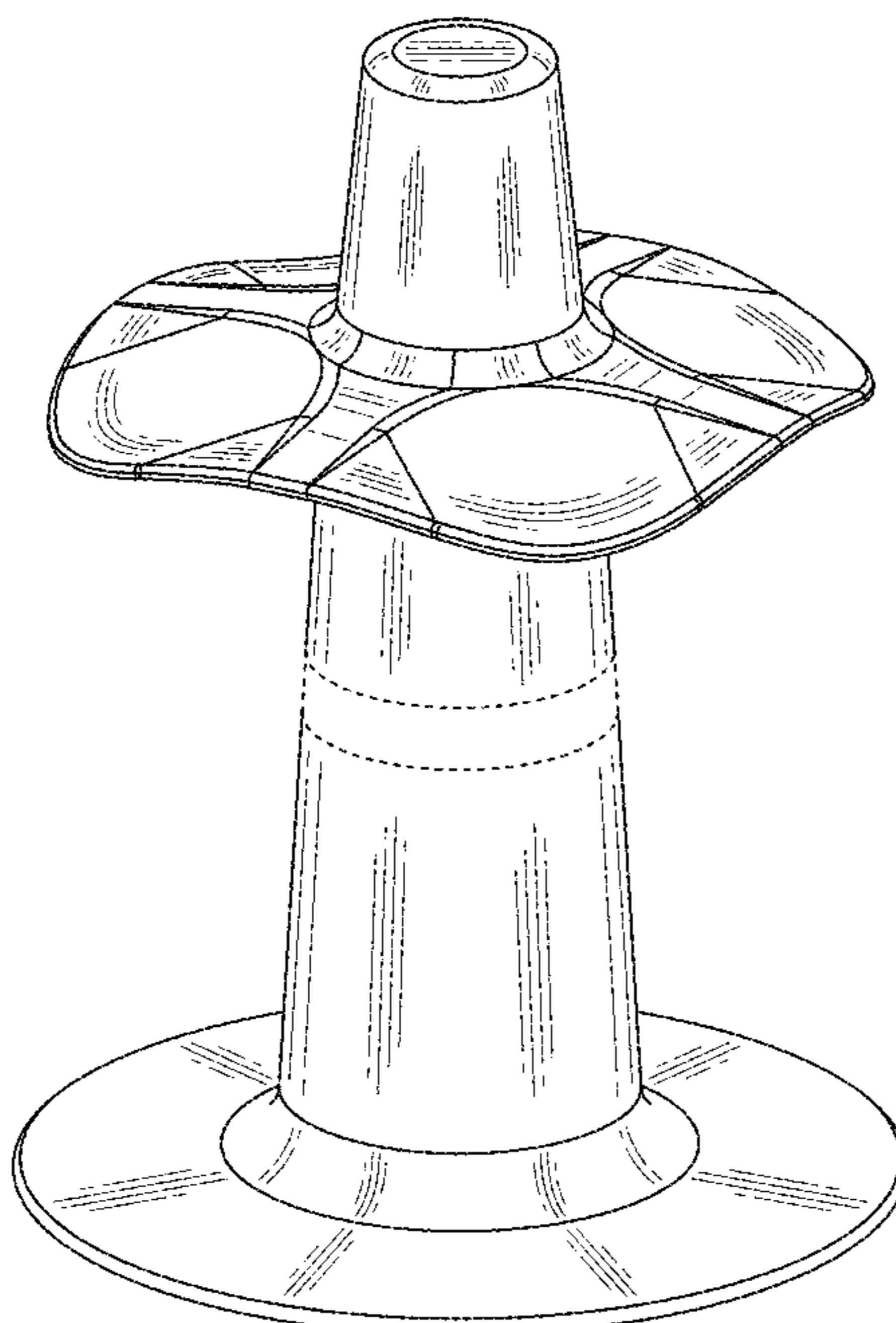
(57) **CLAIM**

The ornamental design for an anal plug, as shown and described.

DESCRIPTION

FIG. 1 is a perspective top view of an anal plug;
FIG. 2 is a bottom plan view of the anal plug of FIG. 1;

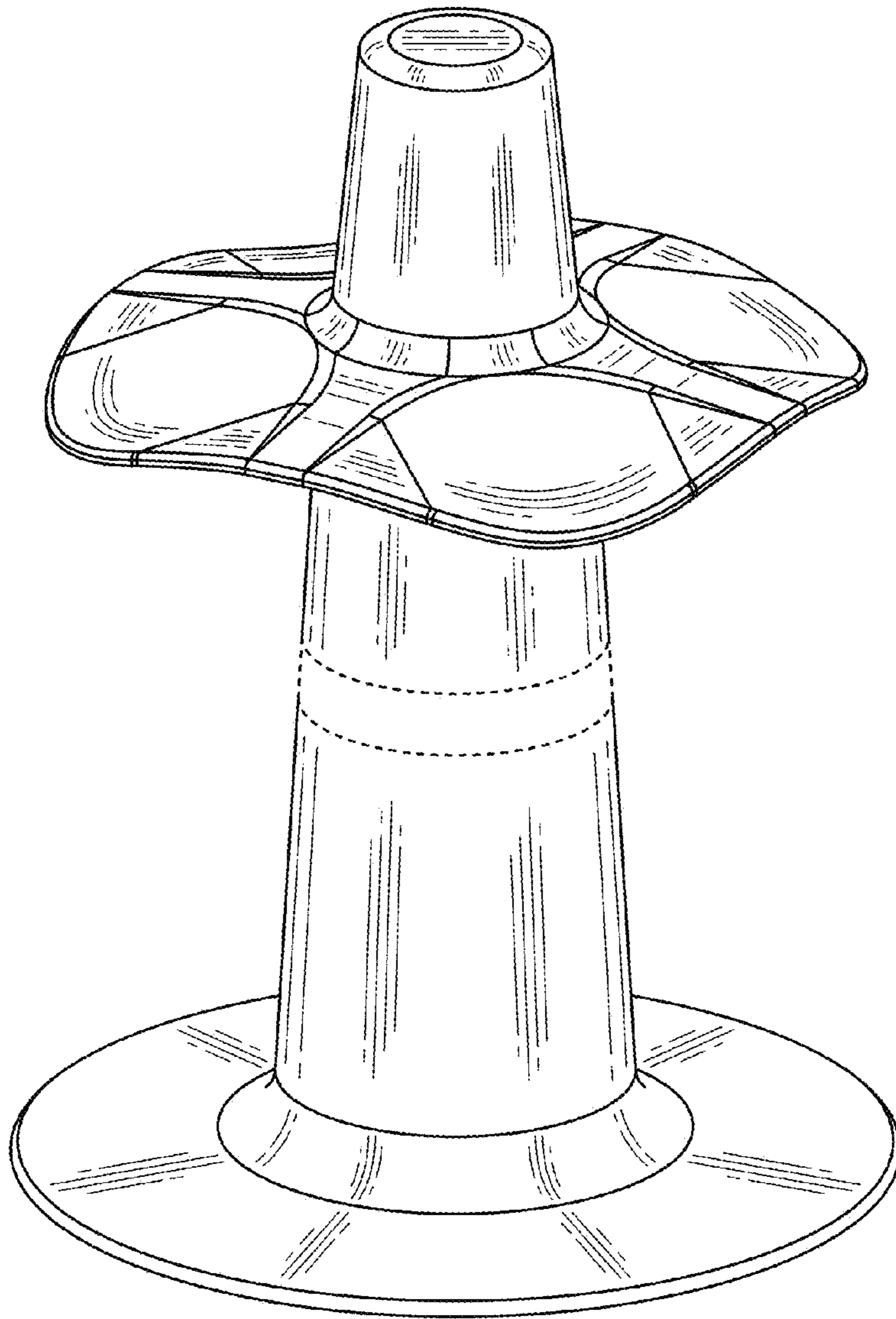

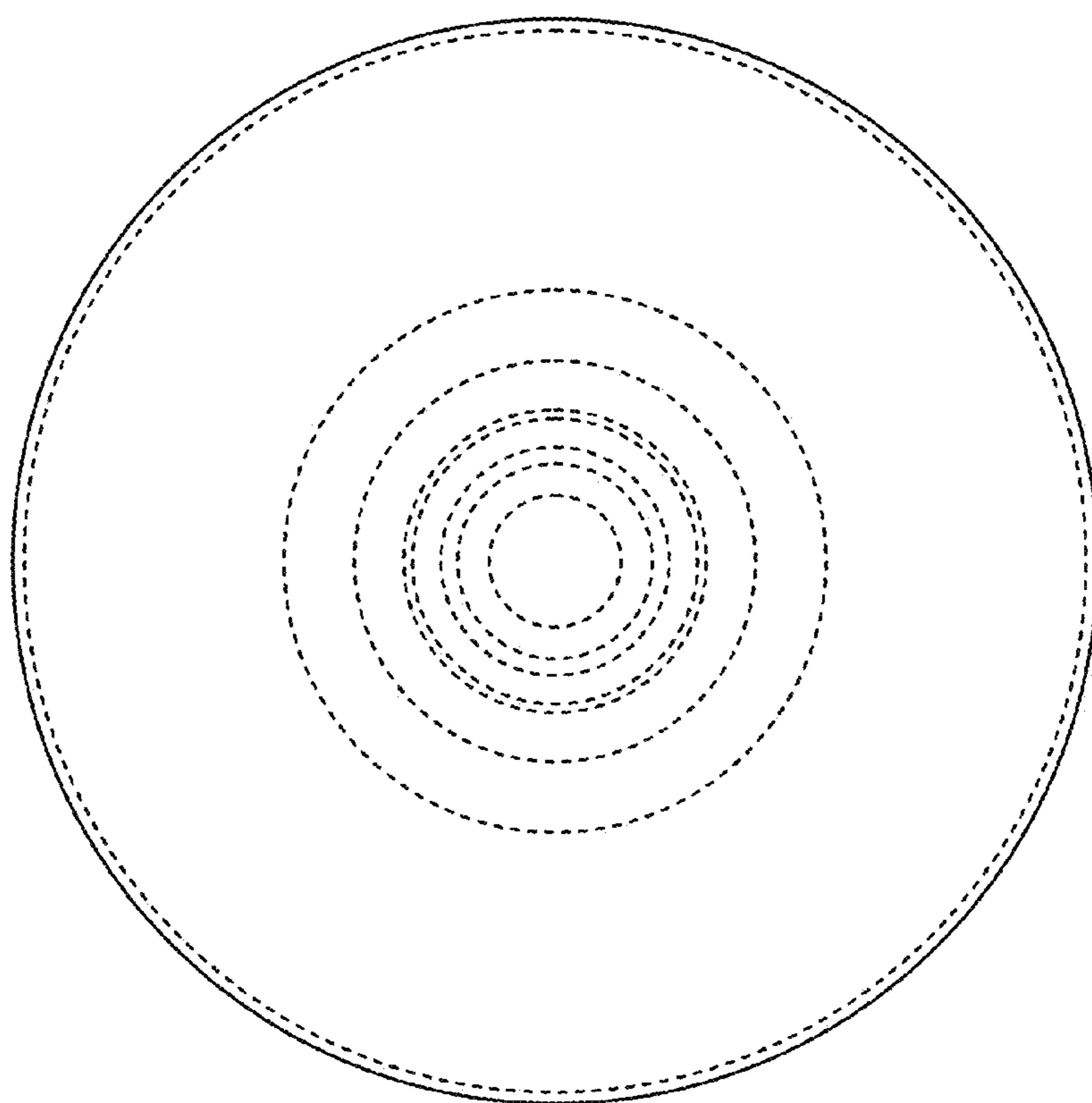

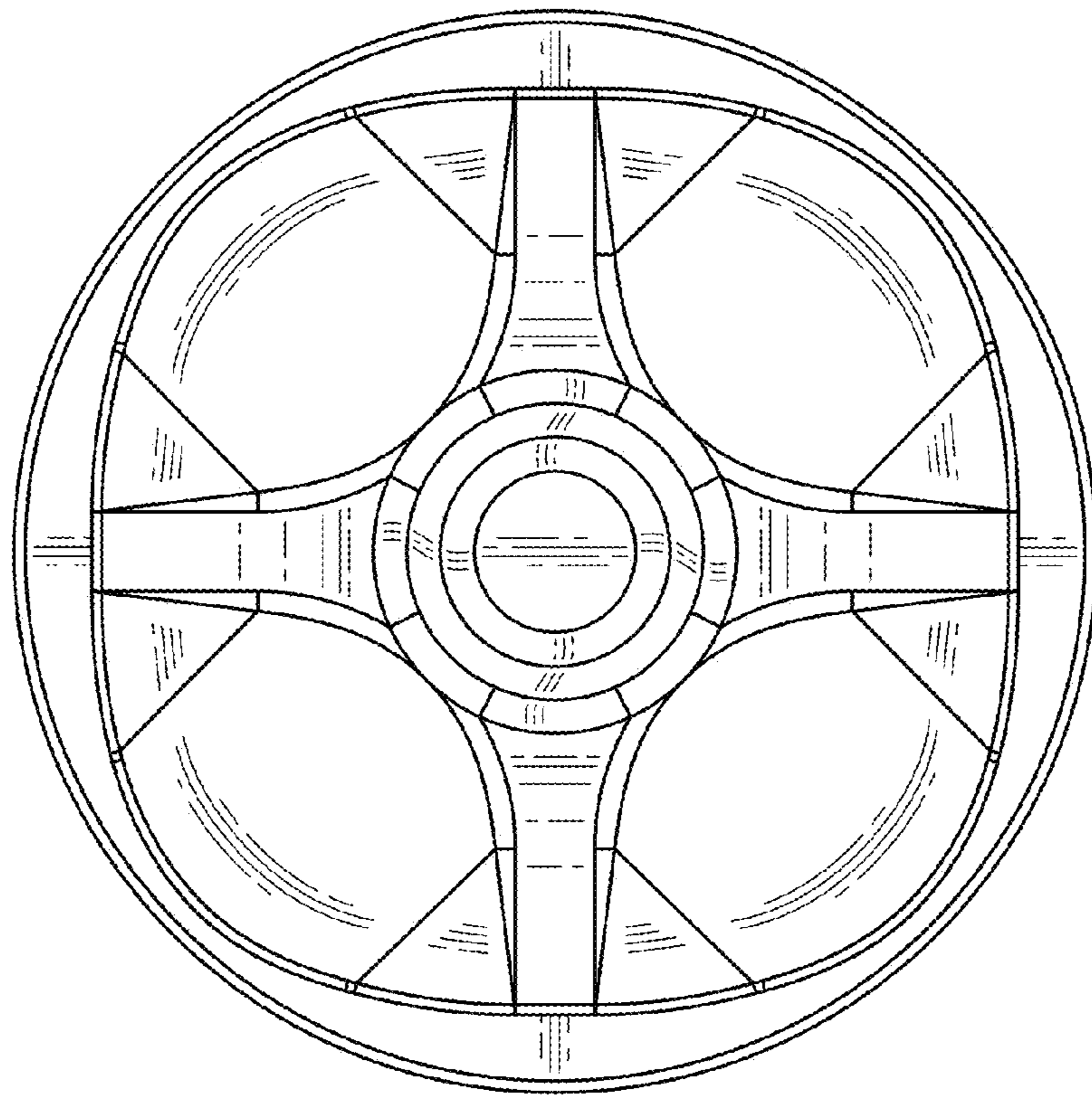

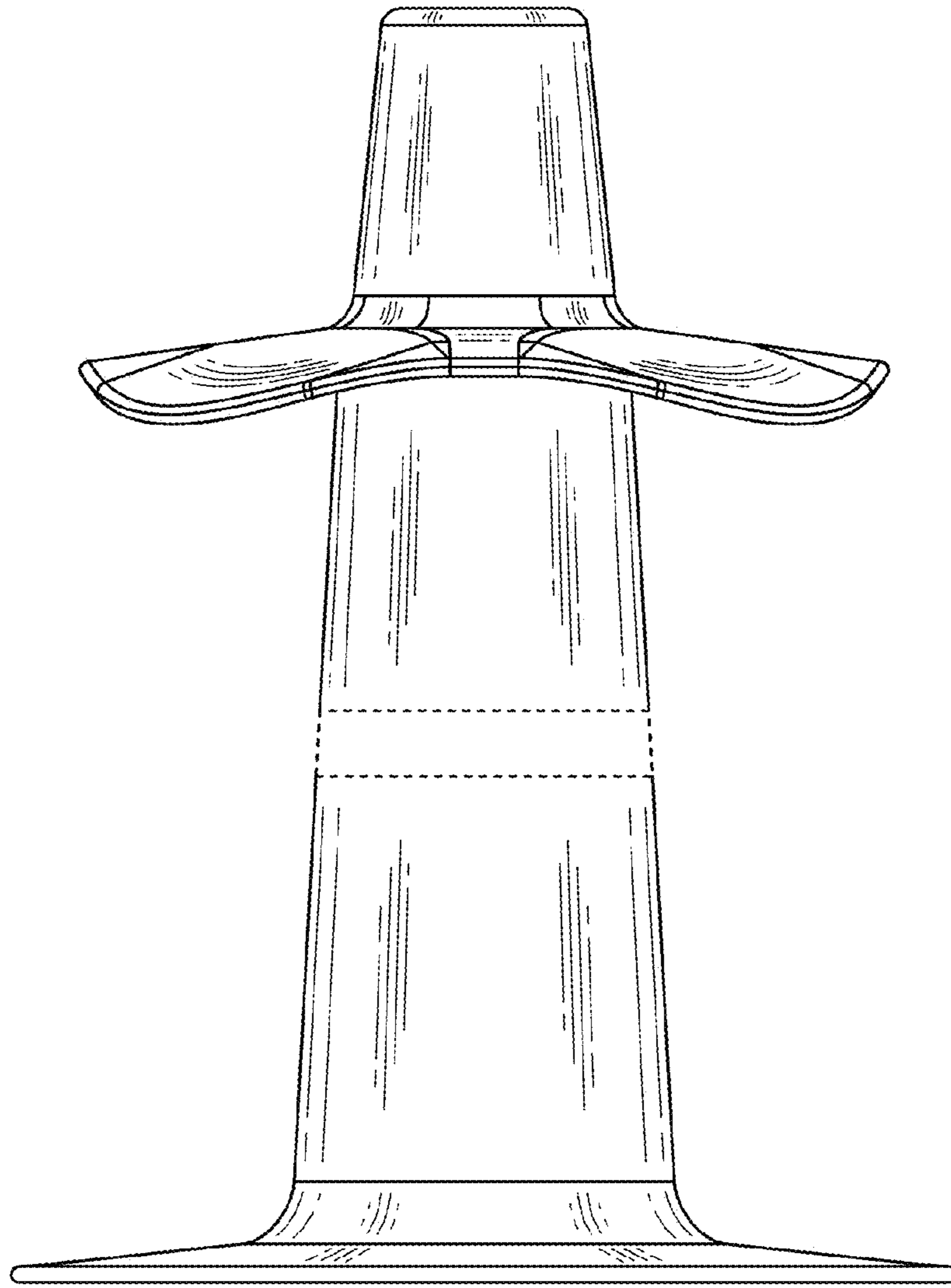
