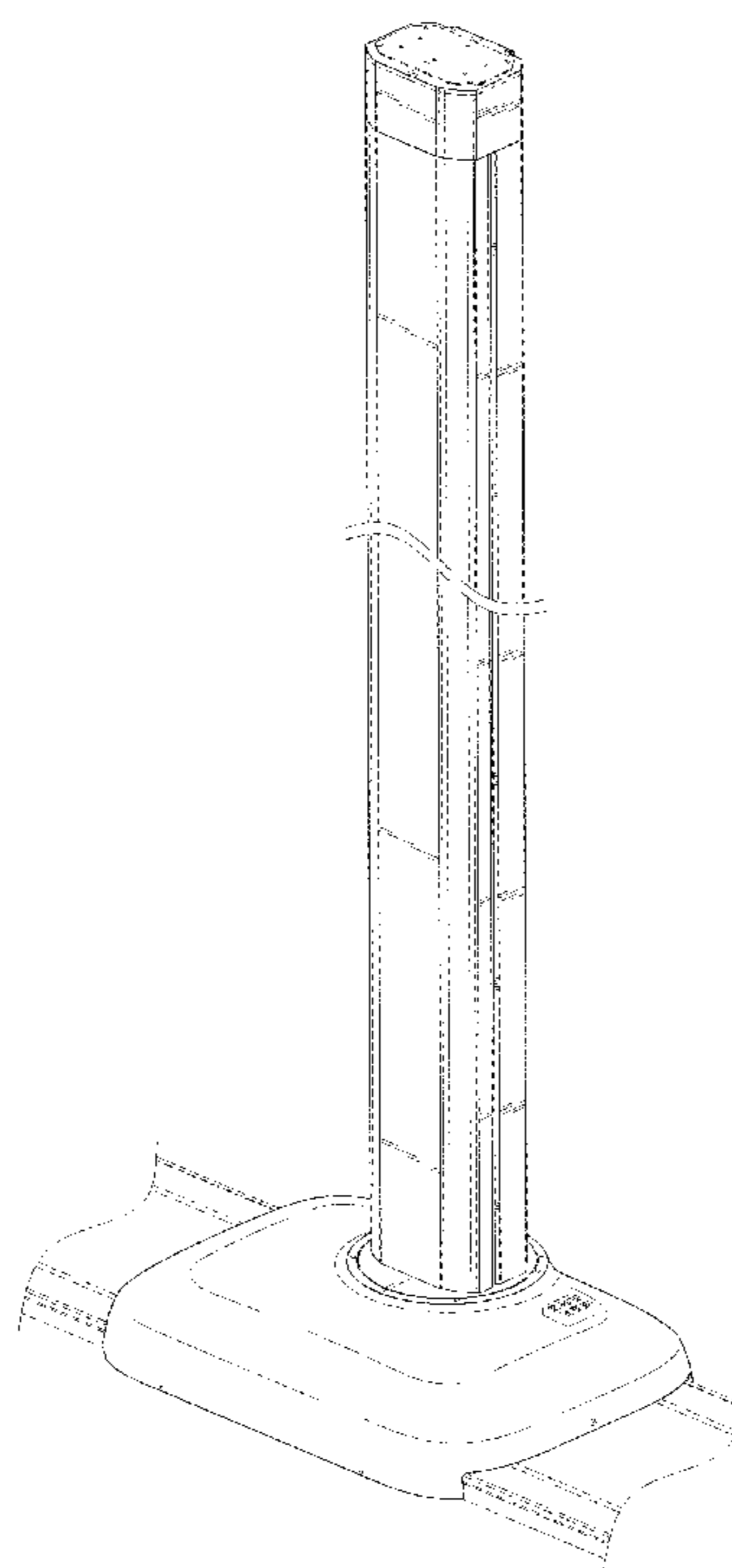
(57) **CLAIM**

The ornamental design for a support for medical device, as shown and described.

DESCRIPTION

FIG. 1 is a top front perspective view of a support for medical device showing my new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a right side view thereof;
FIG. 6 is a top view thereof;
FIG. 7 is a bottom view thereof; and,
FIG. 8 is another top front perspective view thereof, showing the support for medical device in an X-ray environment.
The broken lines illustrating portions of the support for medical device are for environmental purposes only and form no part of the claimed design.
In addition, the dash-dot lines defining a break in the support for medical device show indefinite height or length of the support for medical device.

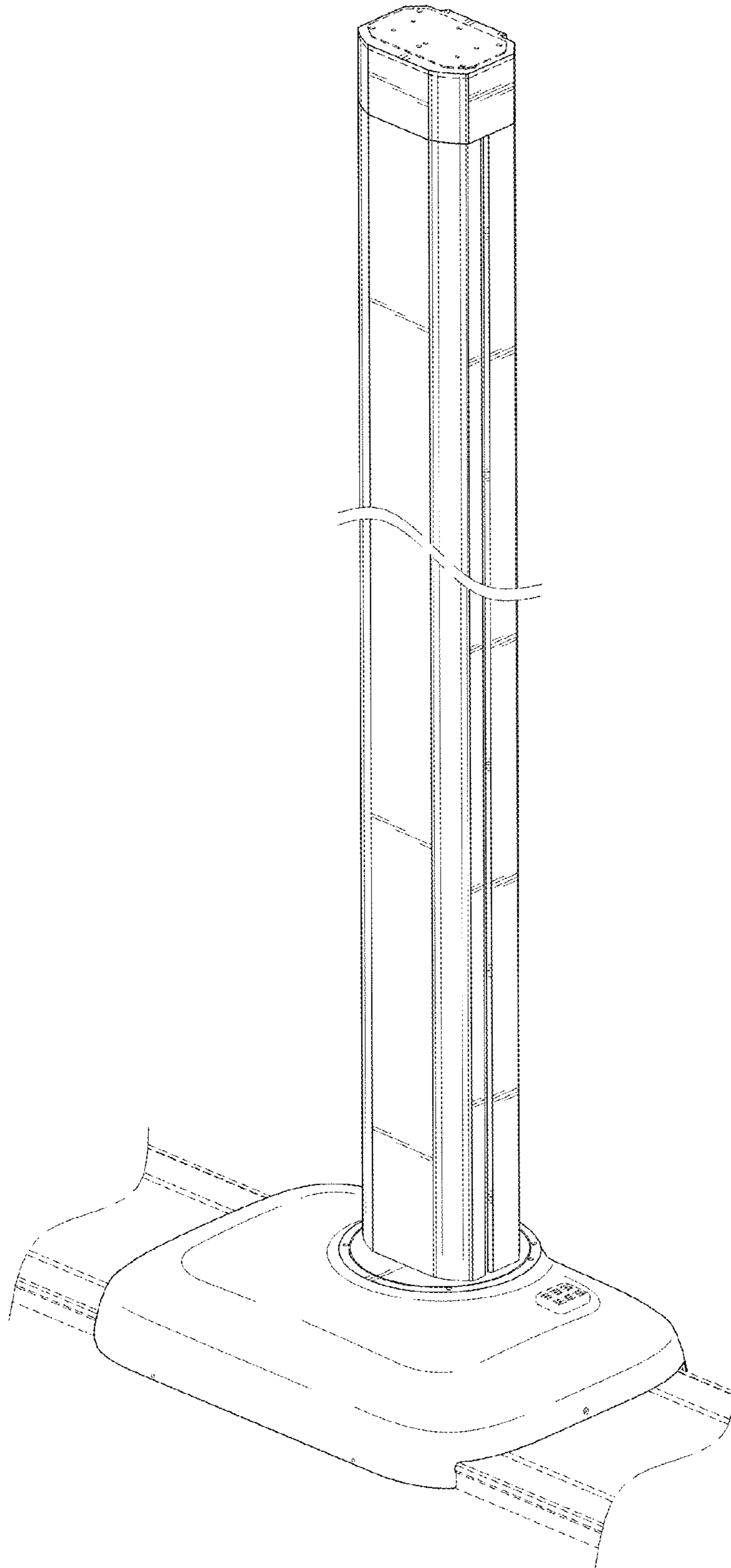

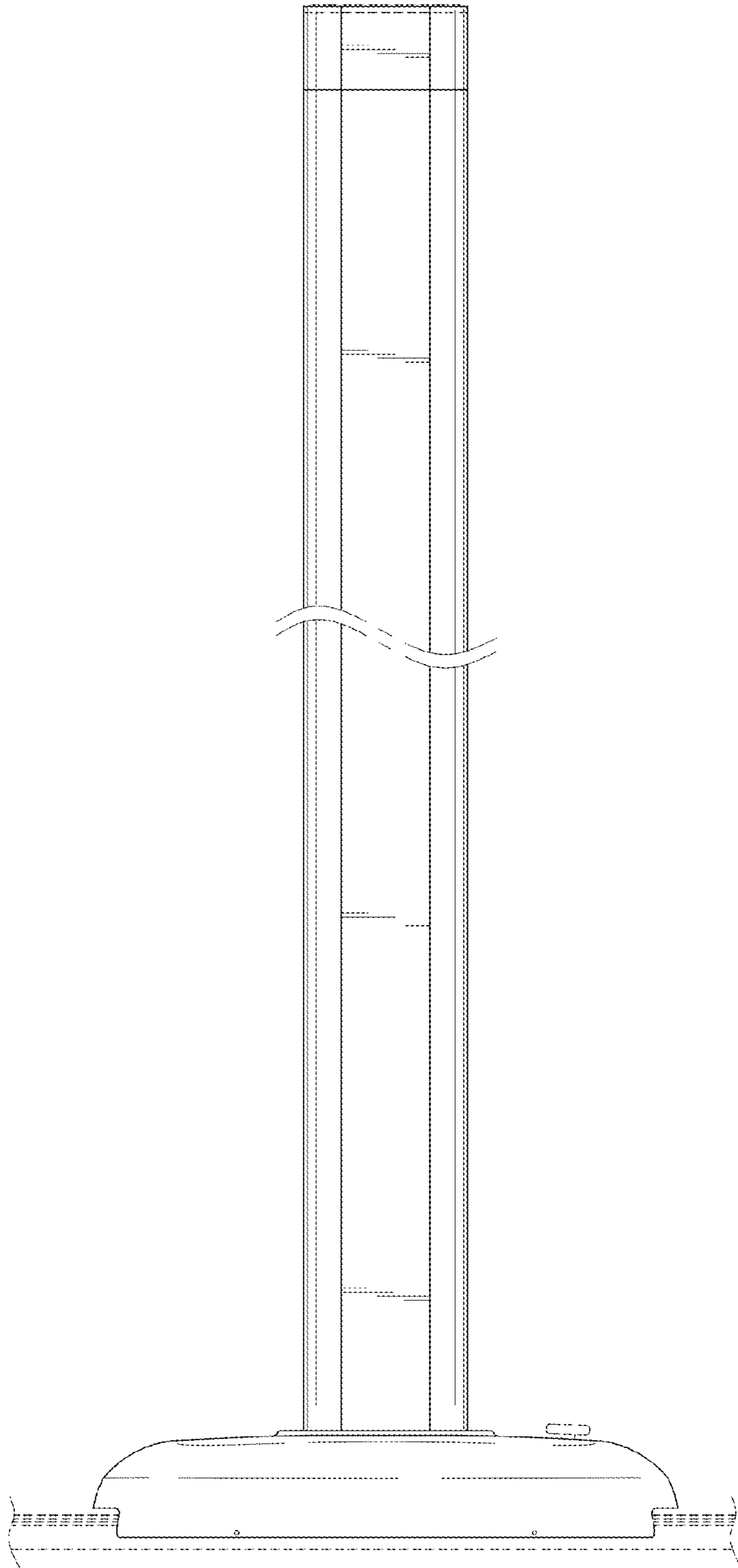

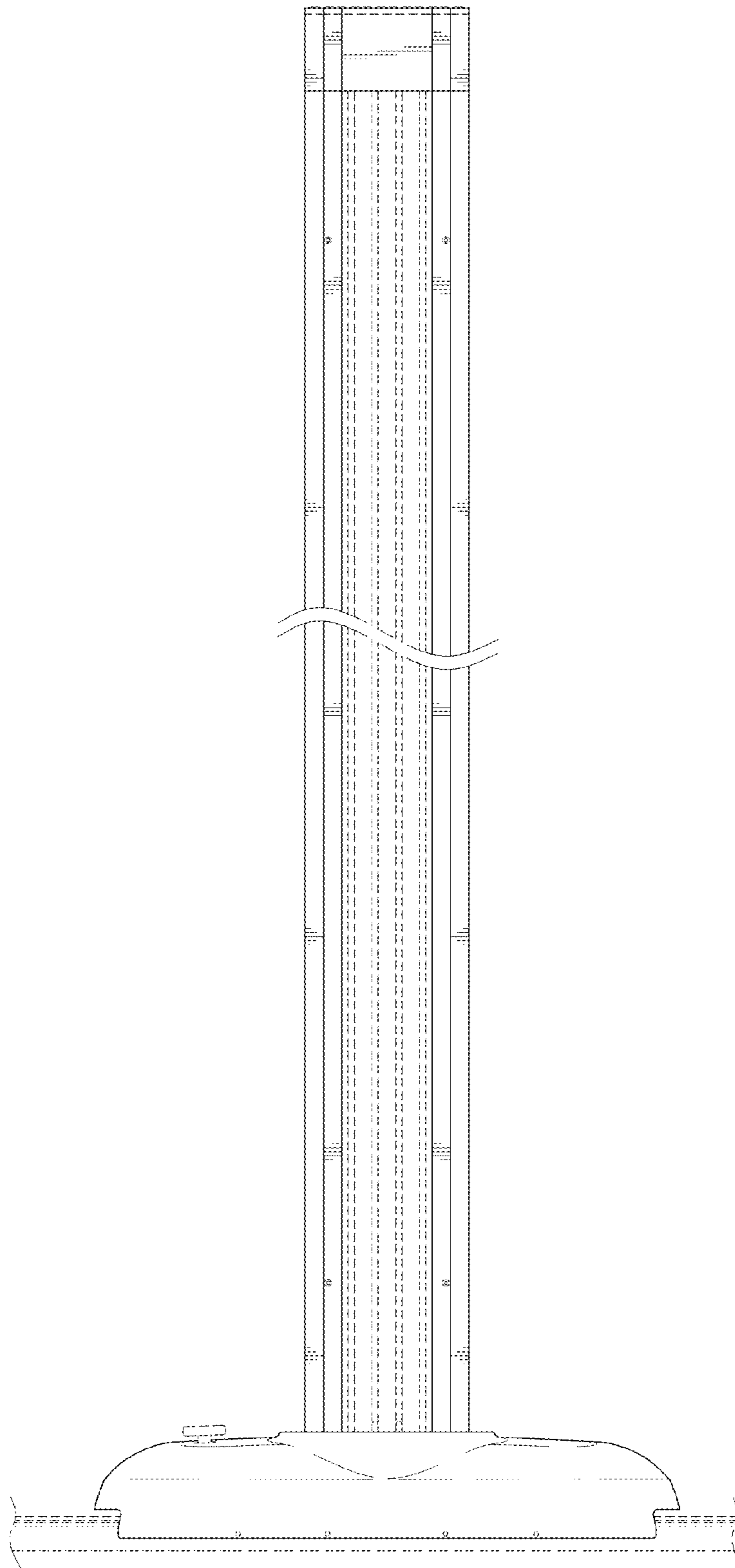

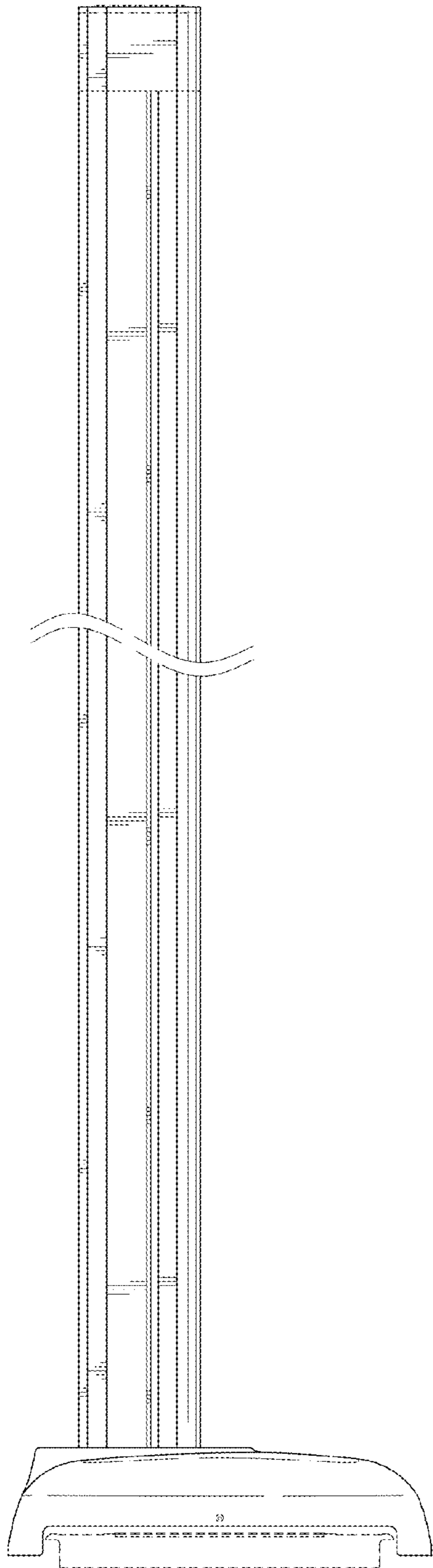

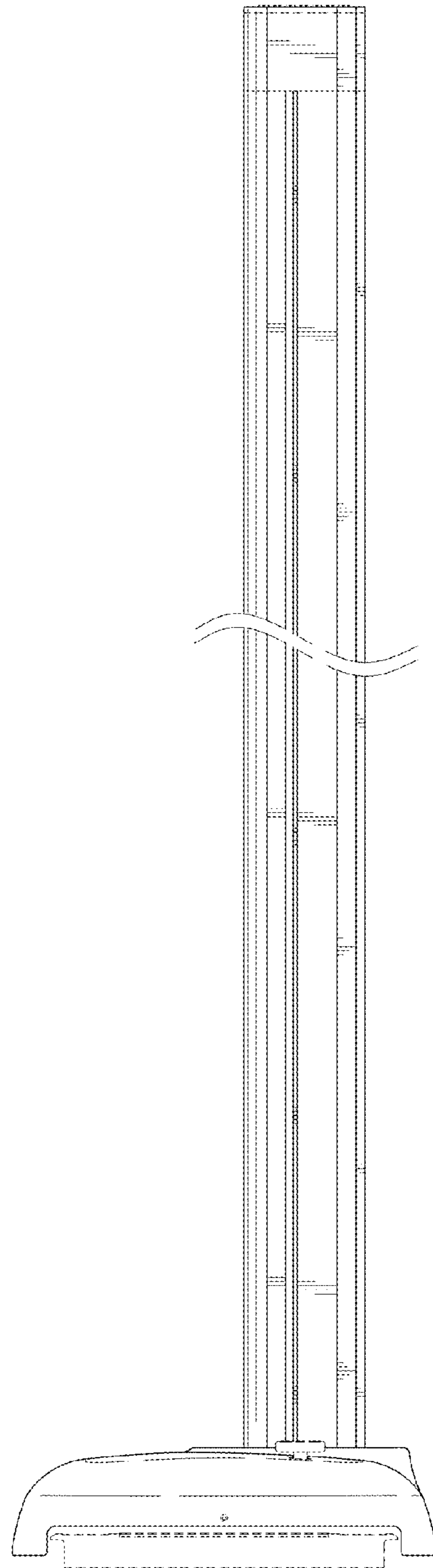

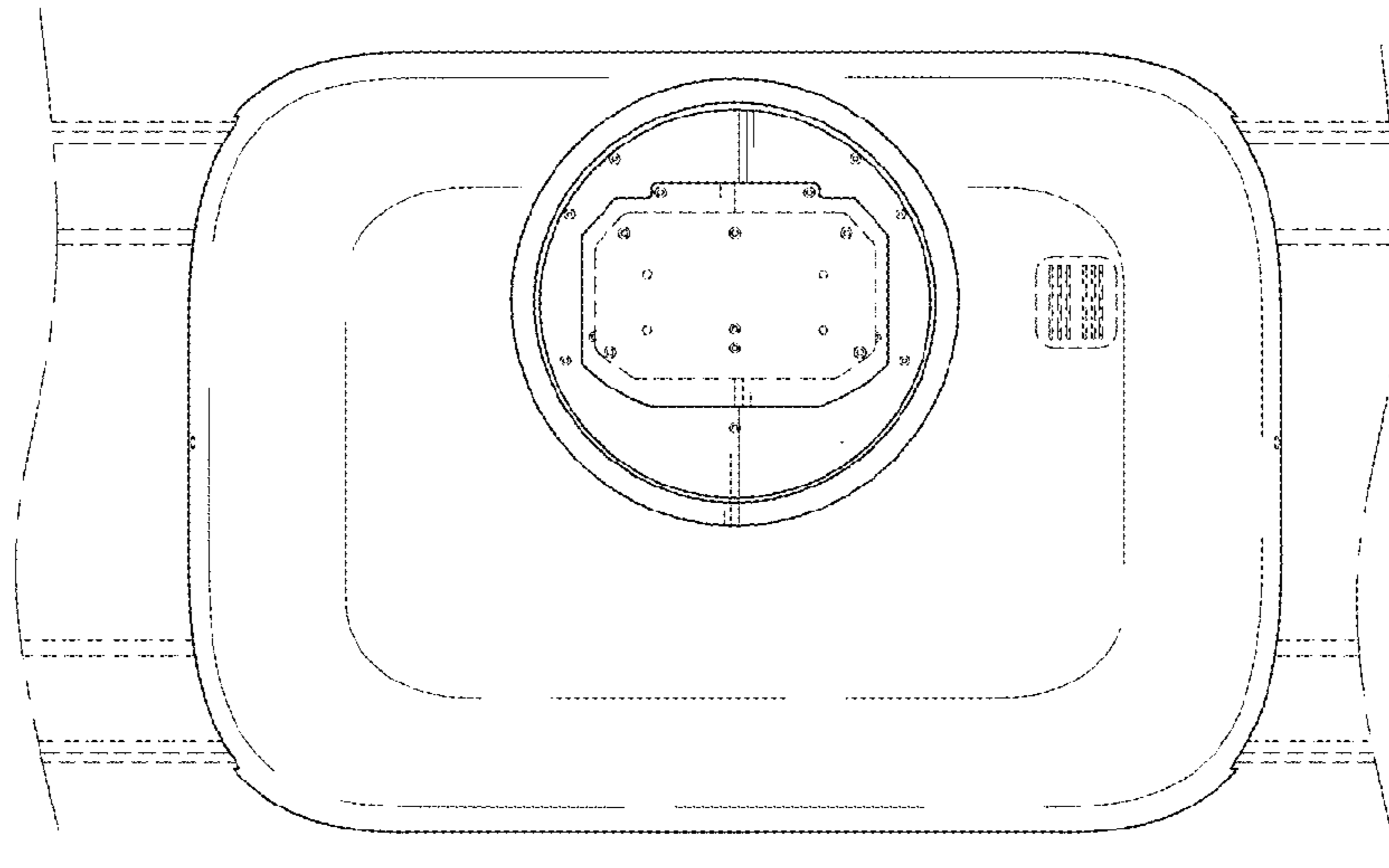

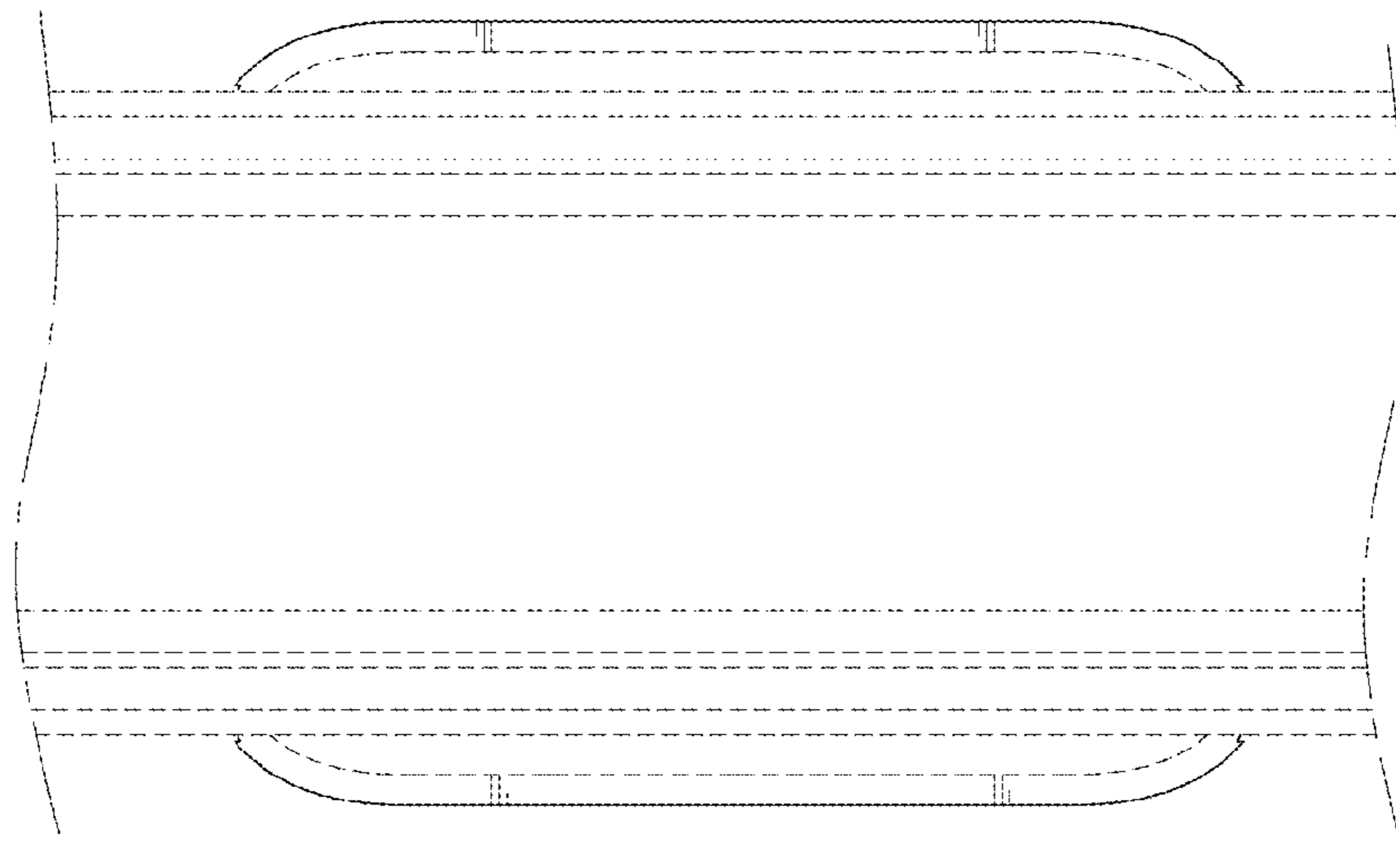

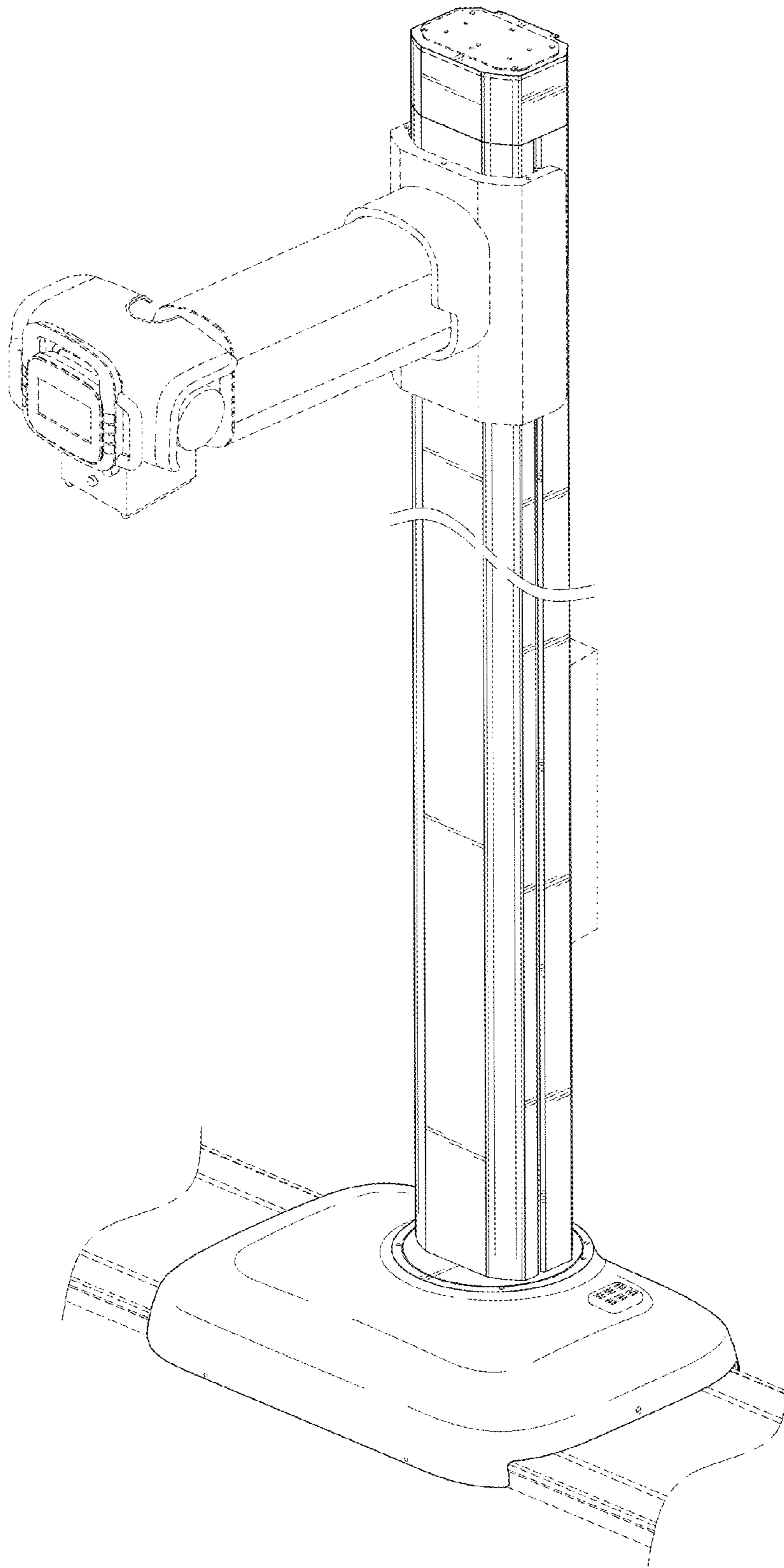
