(57) **CLAIM**

The ornamental design for the dental appliance, as shown and described.

**DESCRIPTION**

FIG. 1 is a top and side perspective view of the bottom piece of the dental appliance, the disclaimed teeth being drawn in dotted lines;

FIG. 2 is a top view of the bottom piece of the dental appliance;

FIG. 3 is a bottom view of the bottom piece of the dental appliance;

FIG. 4 is a side view of the bottom piece of the dental appliance, the reverse side being a mirror image thereof;

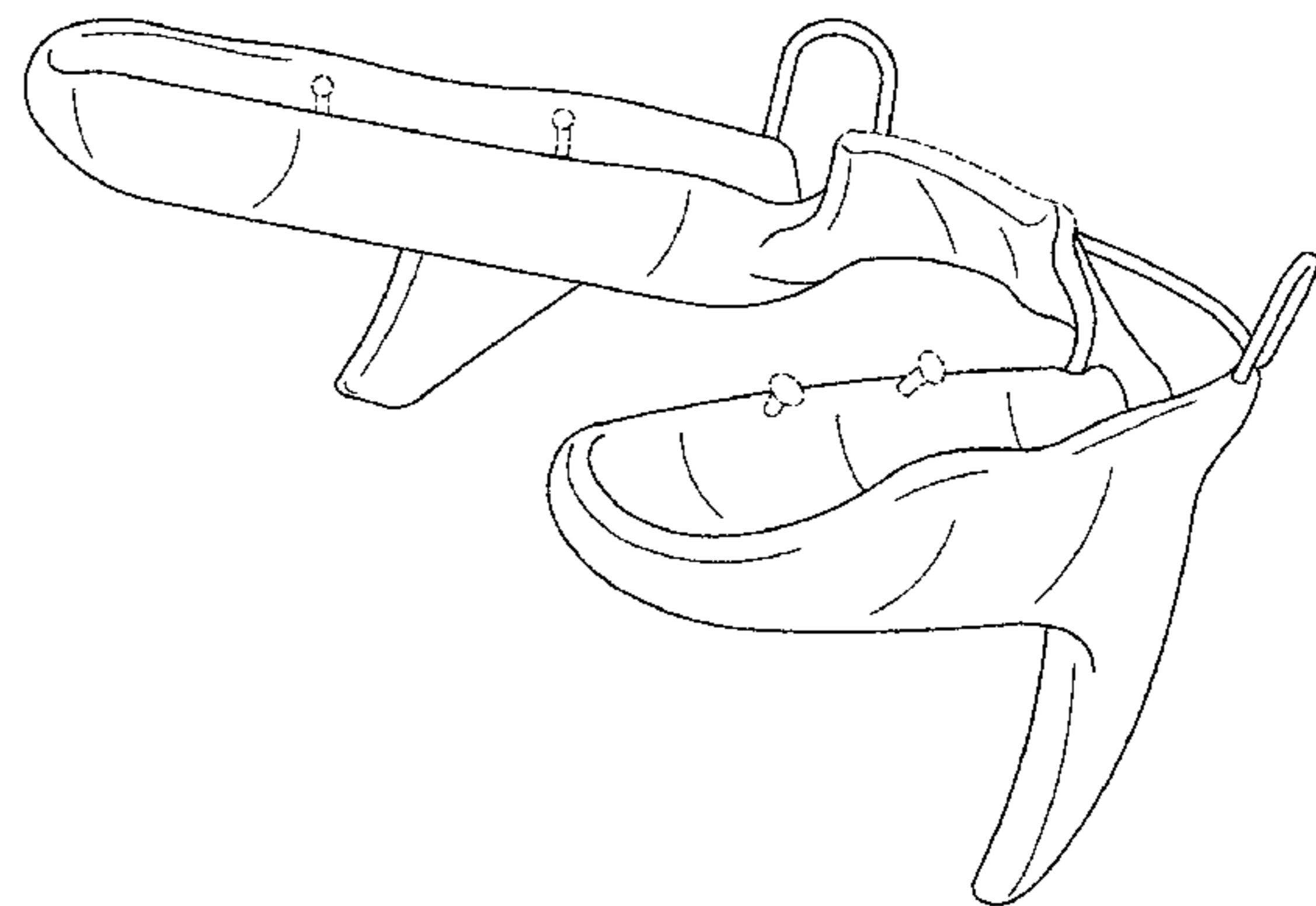
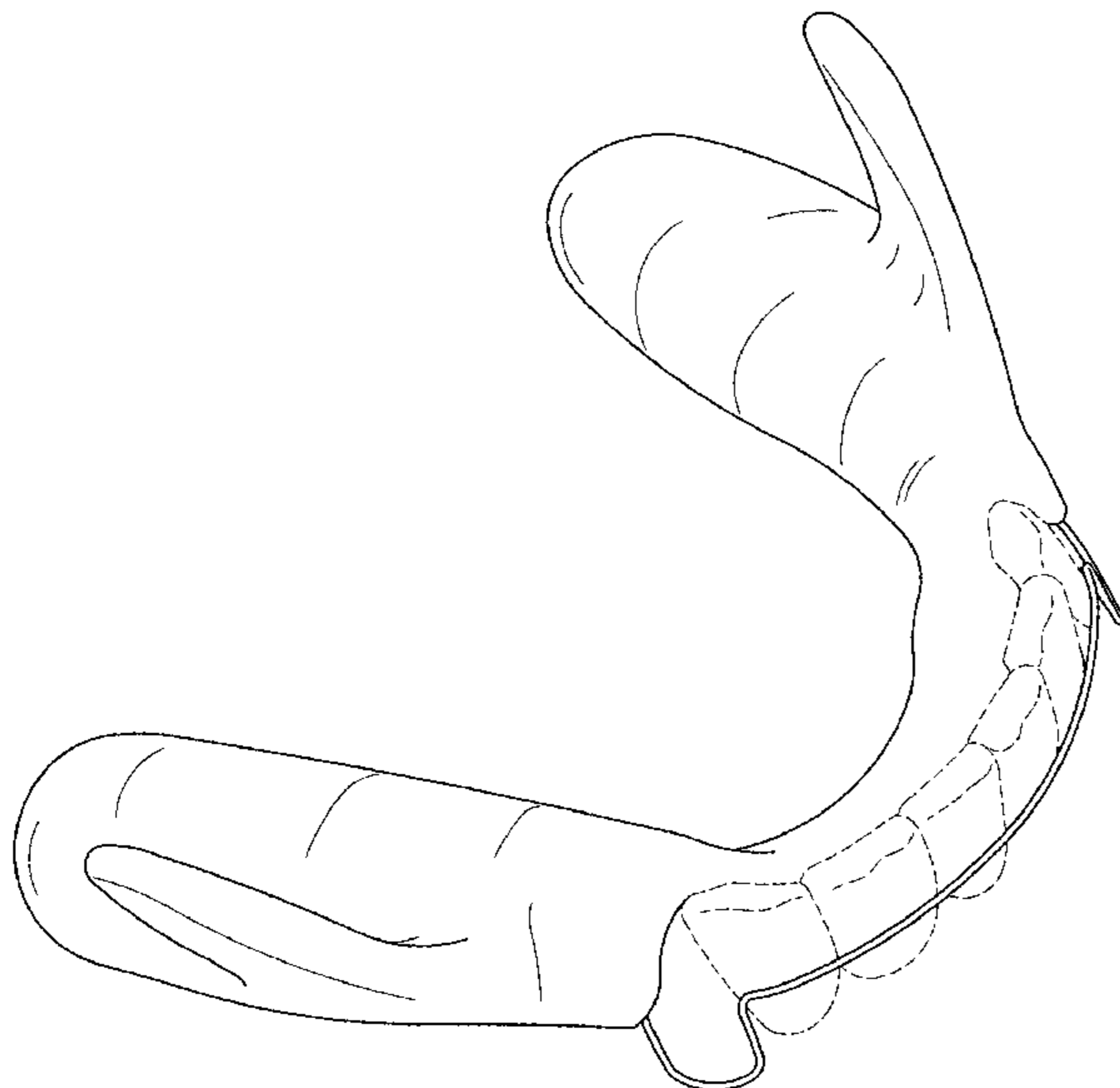
FIG. 5 is a bottom and side perspective view of the bottom piece of the dental appliance;

FIG. 6 is a back elevation view of the bottom piece of the dental appliance; and,

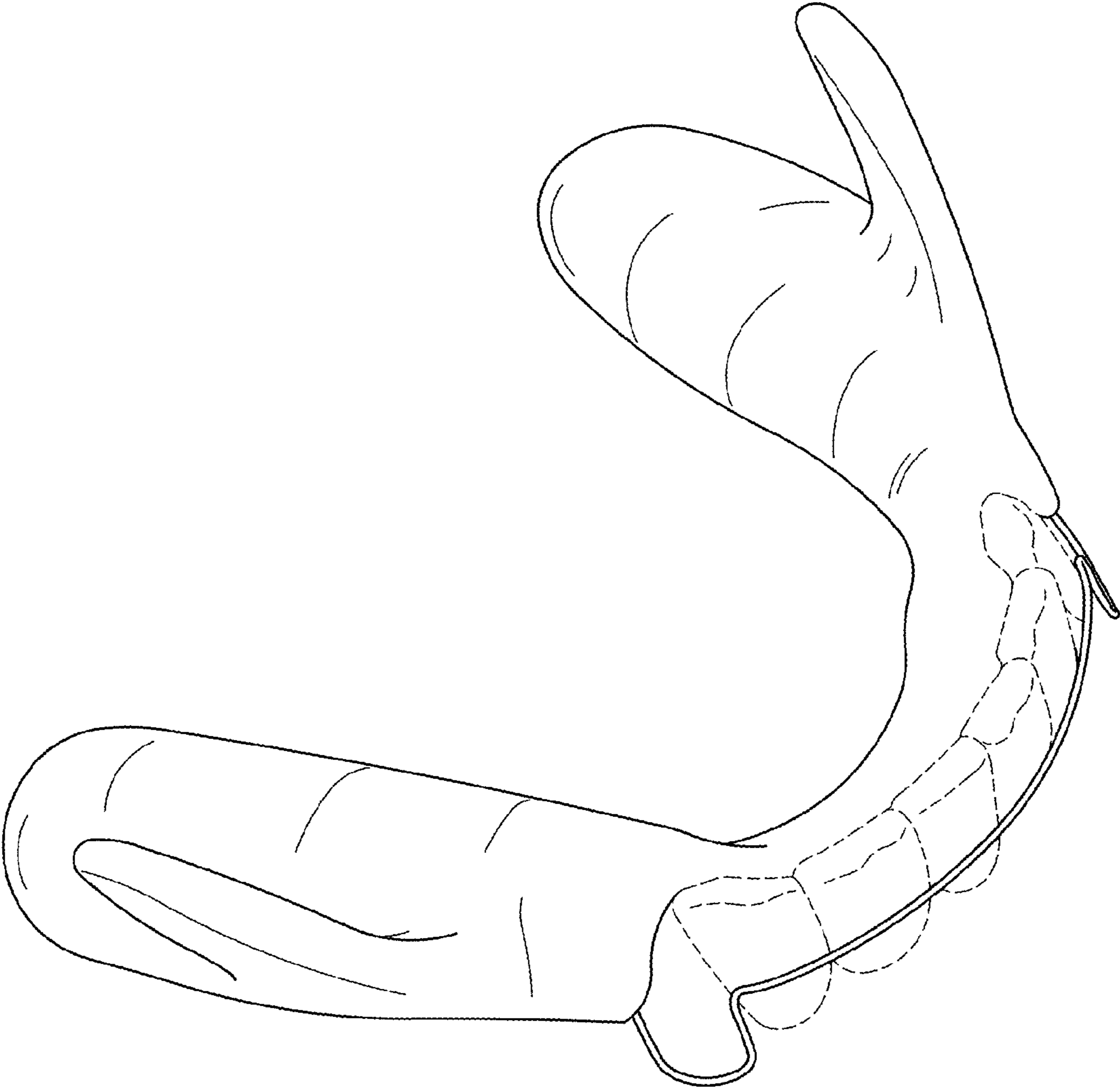

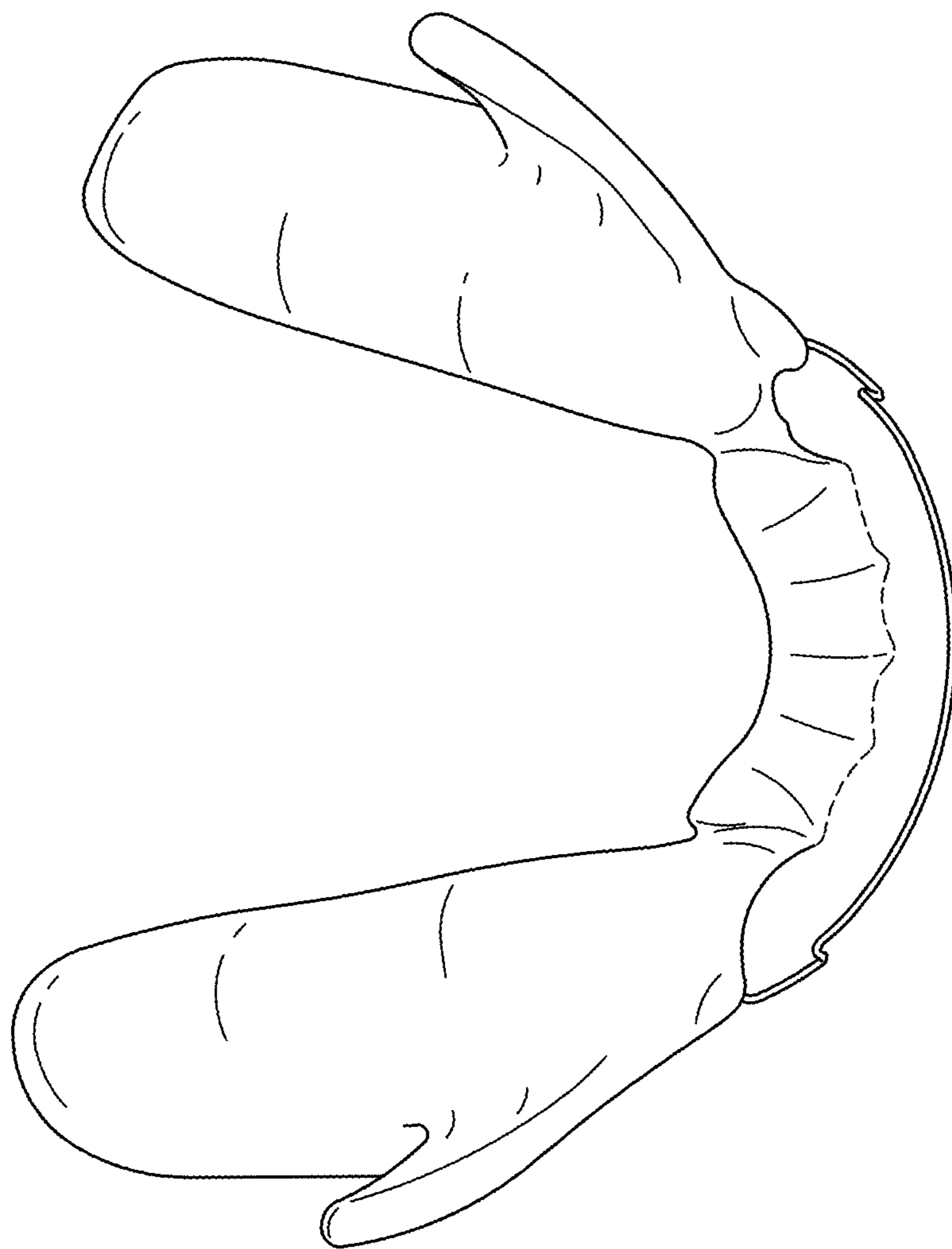

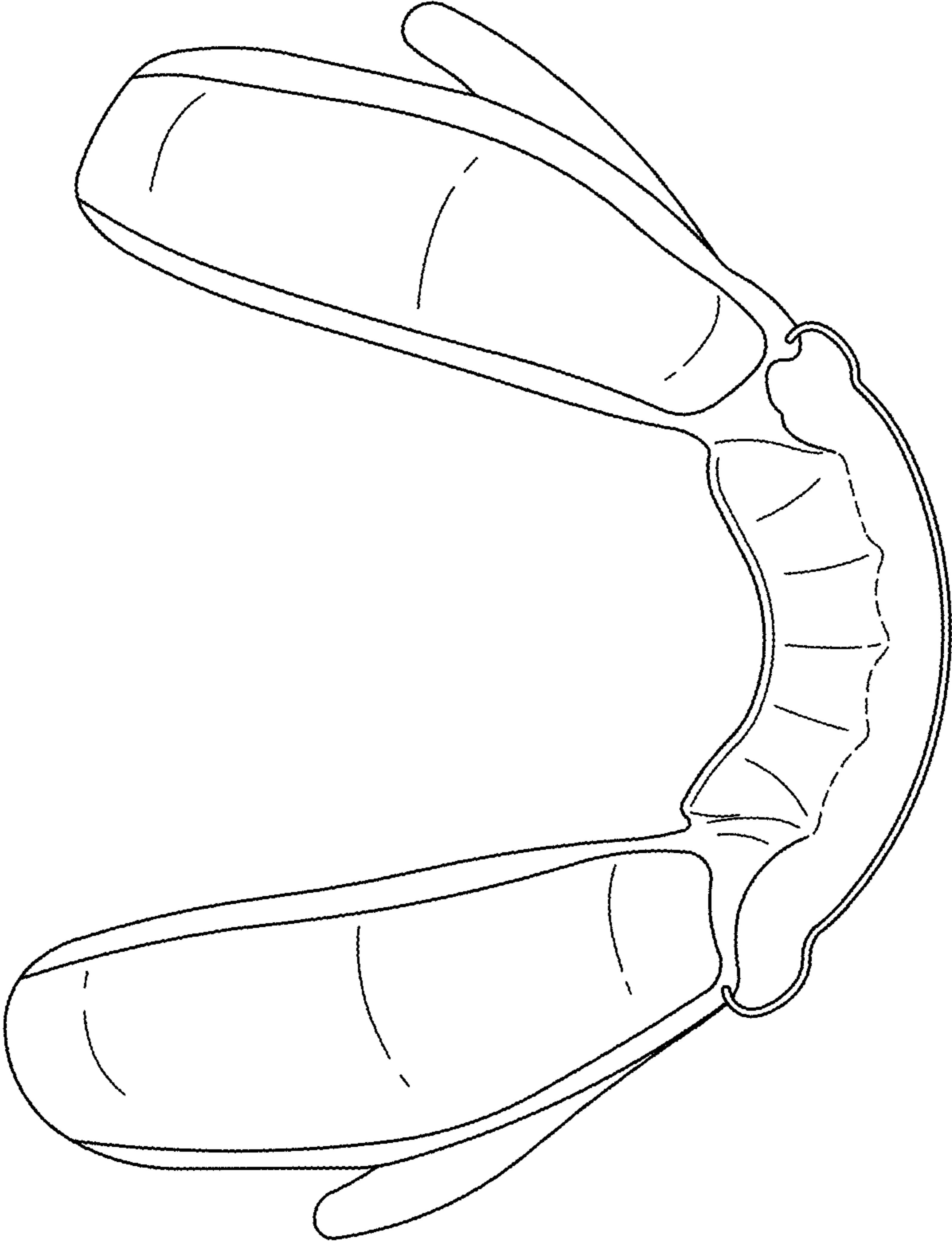

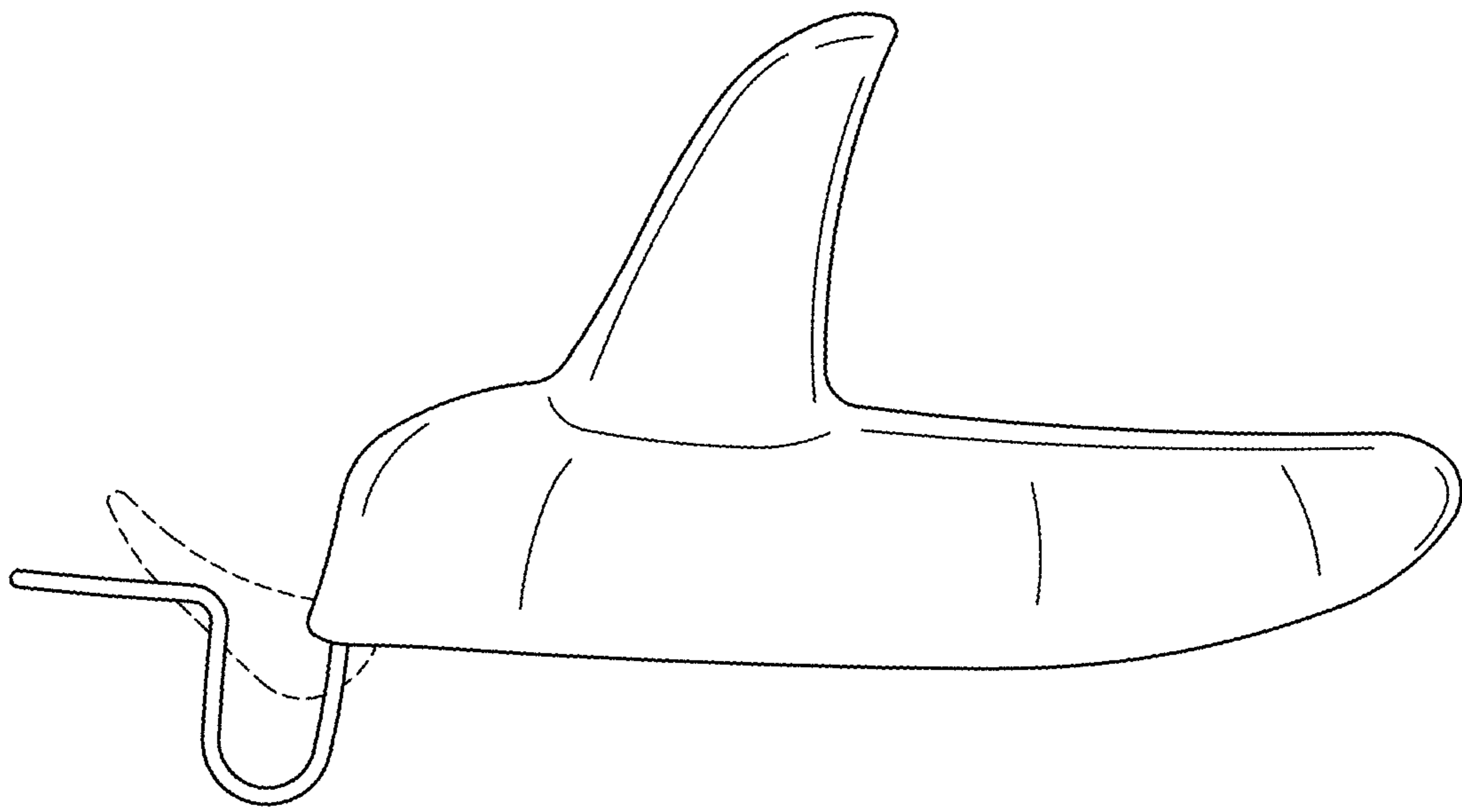

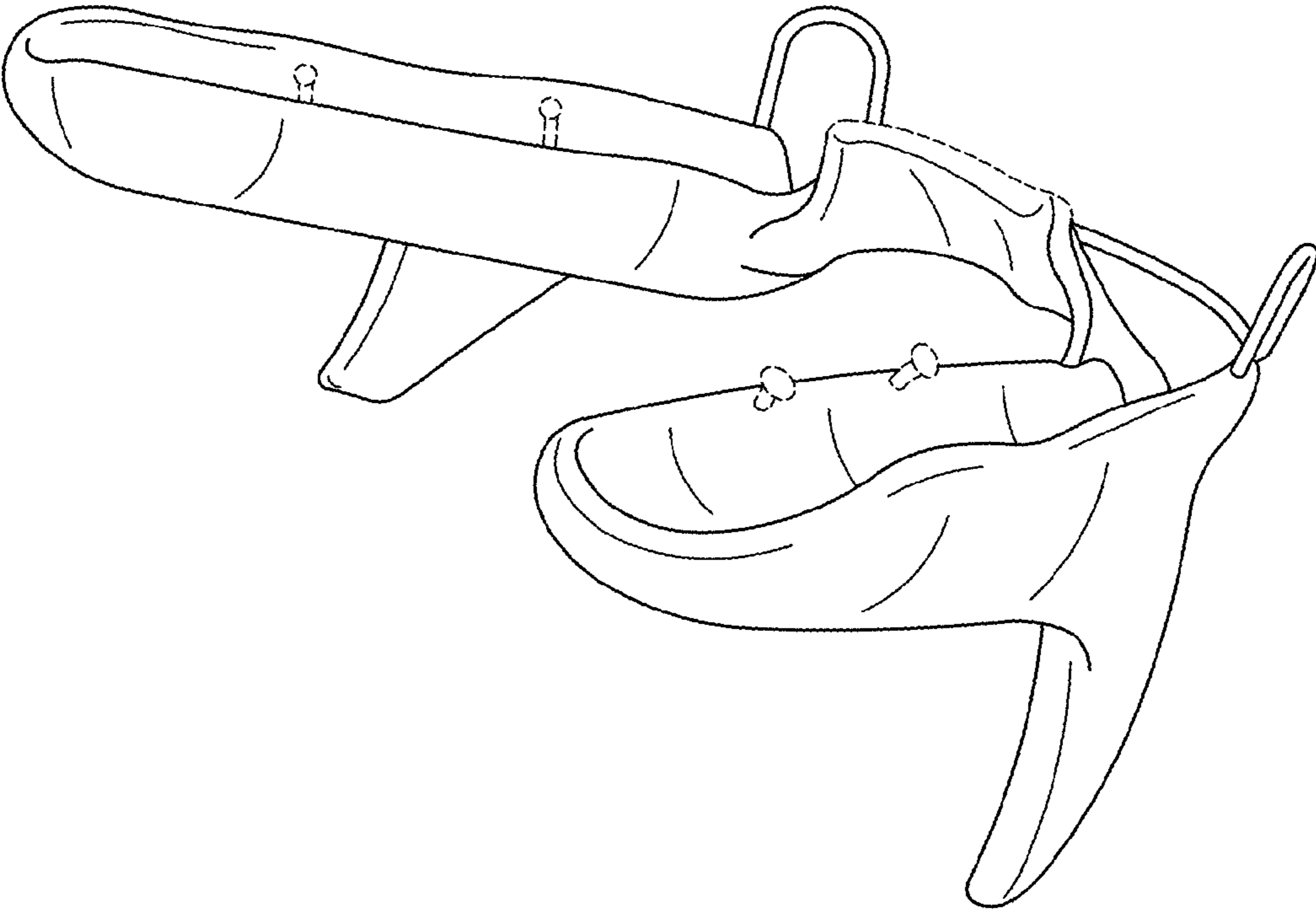

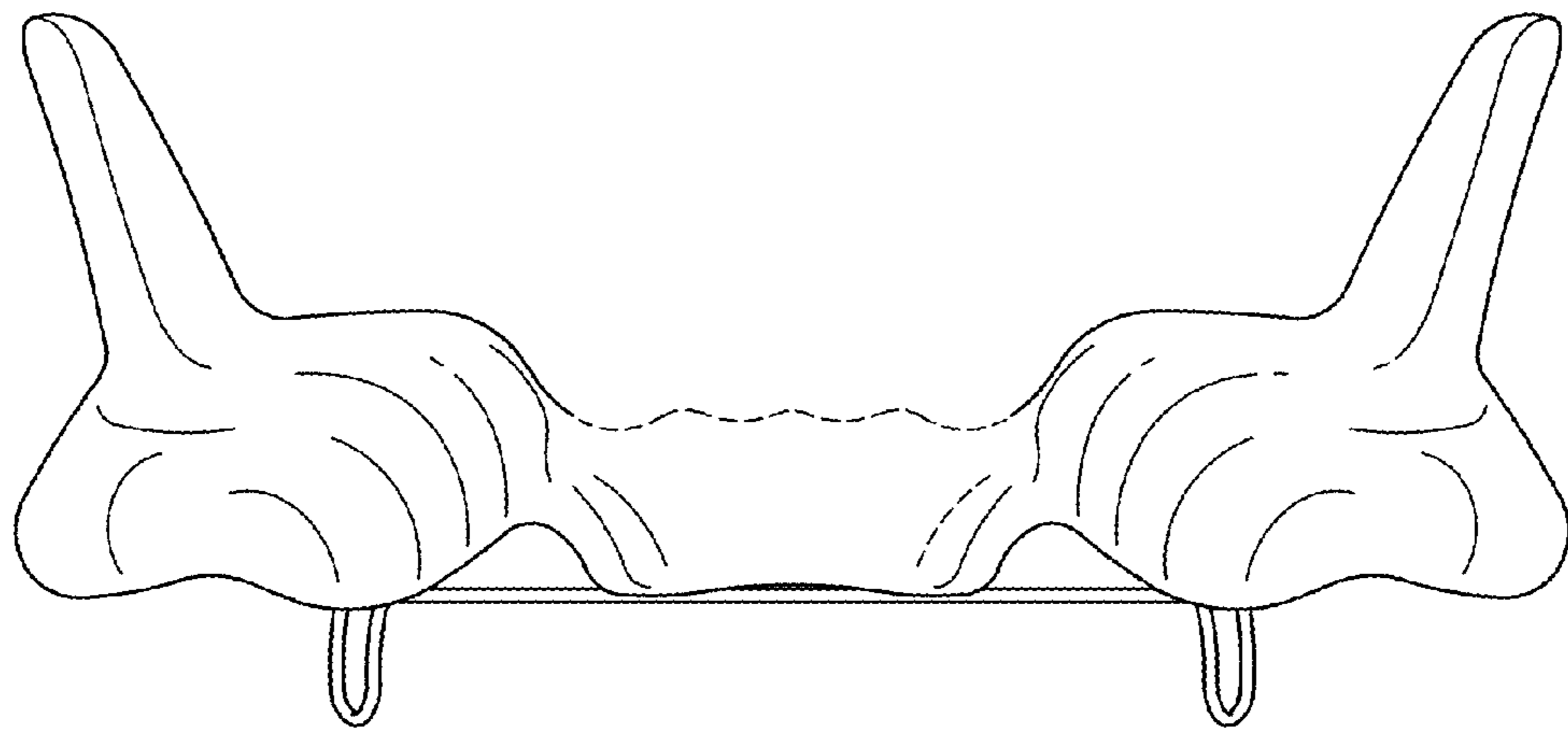

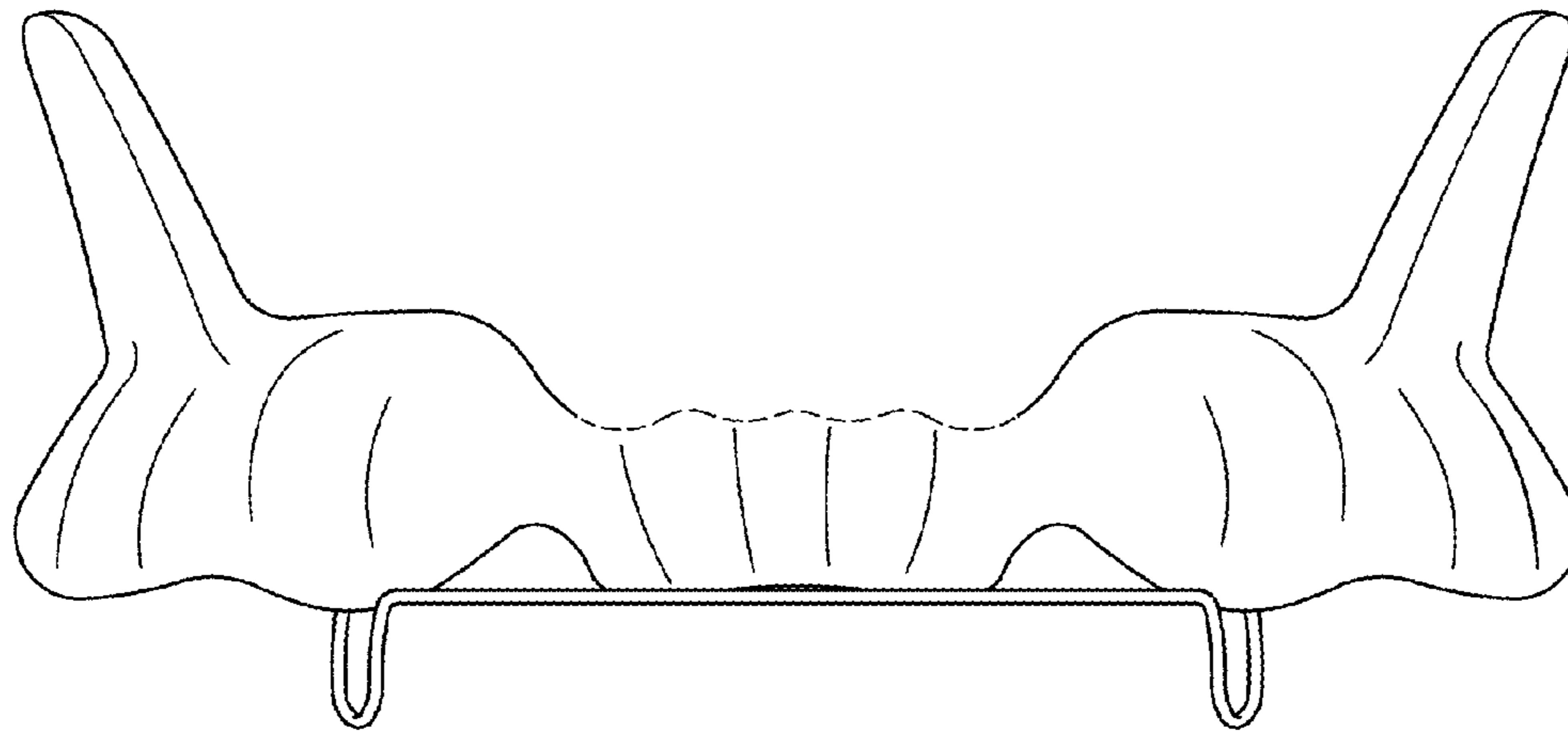
