(57) **CLAIM**

The ornamental design for a light fixture, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a light fixture embodying the design of the present invention.

FIG. 2 is a front side elevational view of the light fixture illustrated in FIG. 1.

FIG. 3 is a back side elevational view of the light fixture illustrated in FIG. 1.

FIG. 4 is a right side elevational view of the light fixture illustrated in FIG. 1.

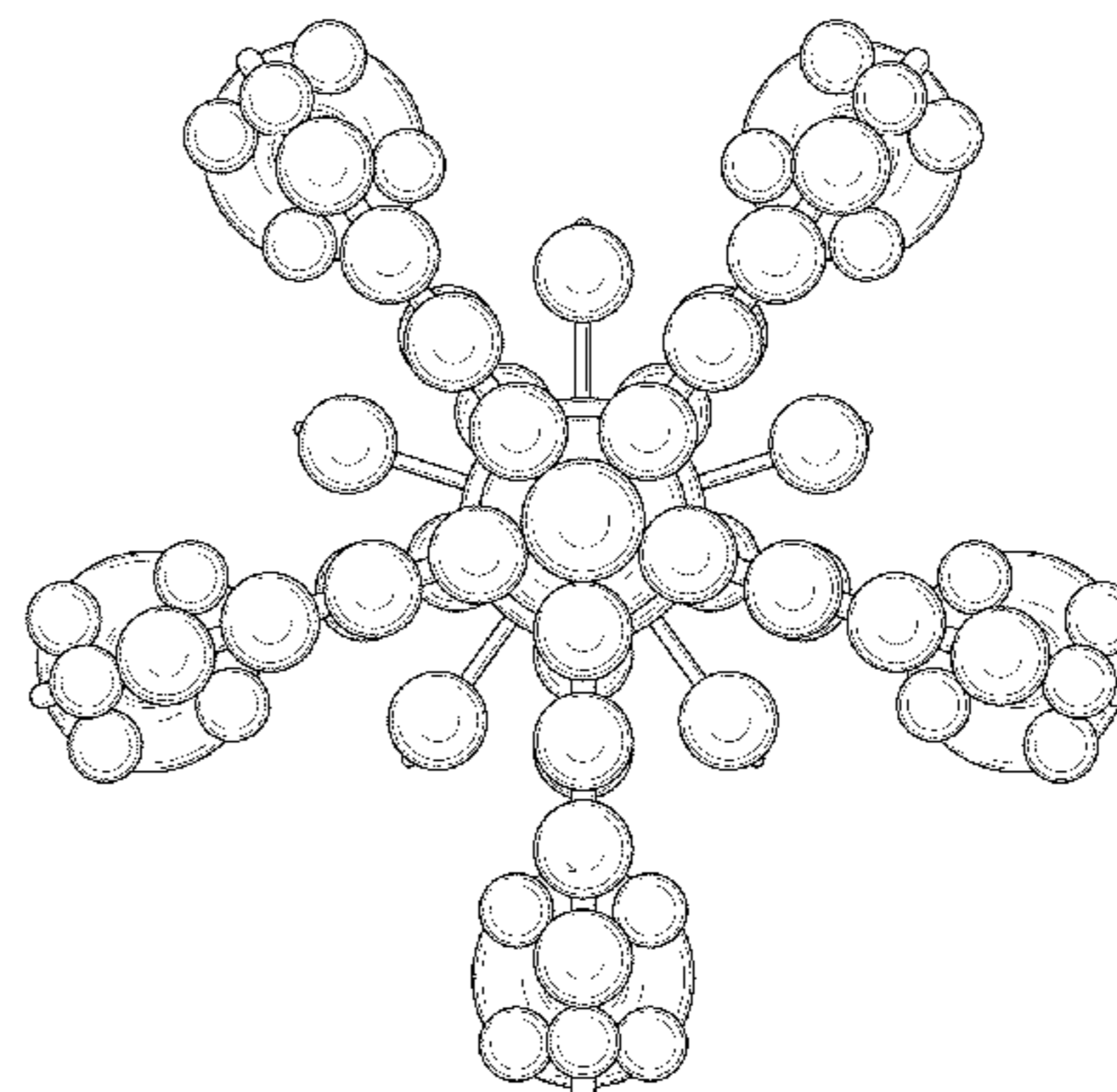
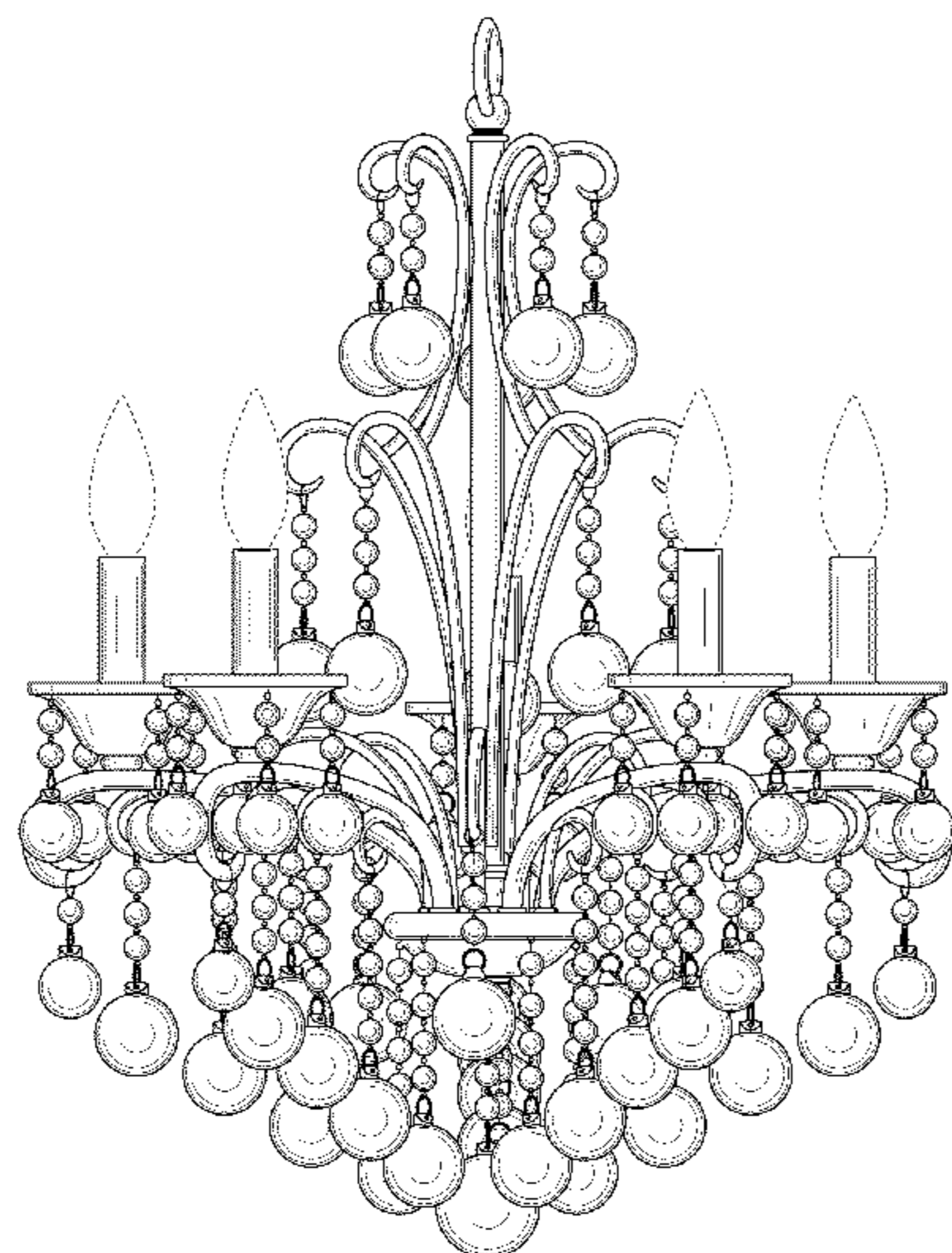
FIG. 5 is a left side elevational view of the light fixture illustrated in FIG. 1.

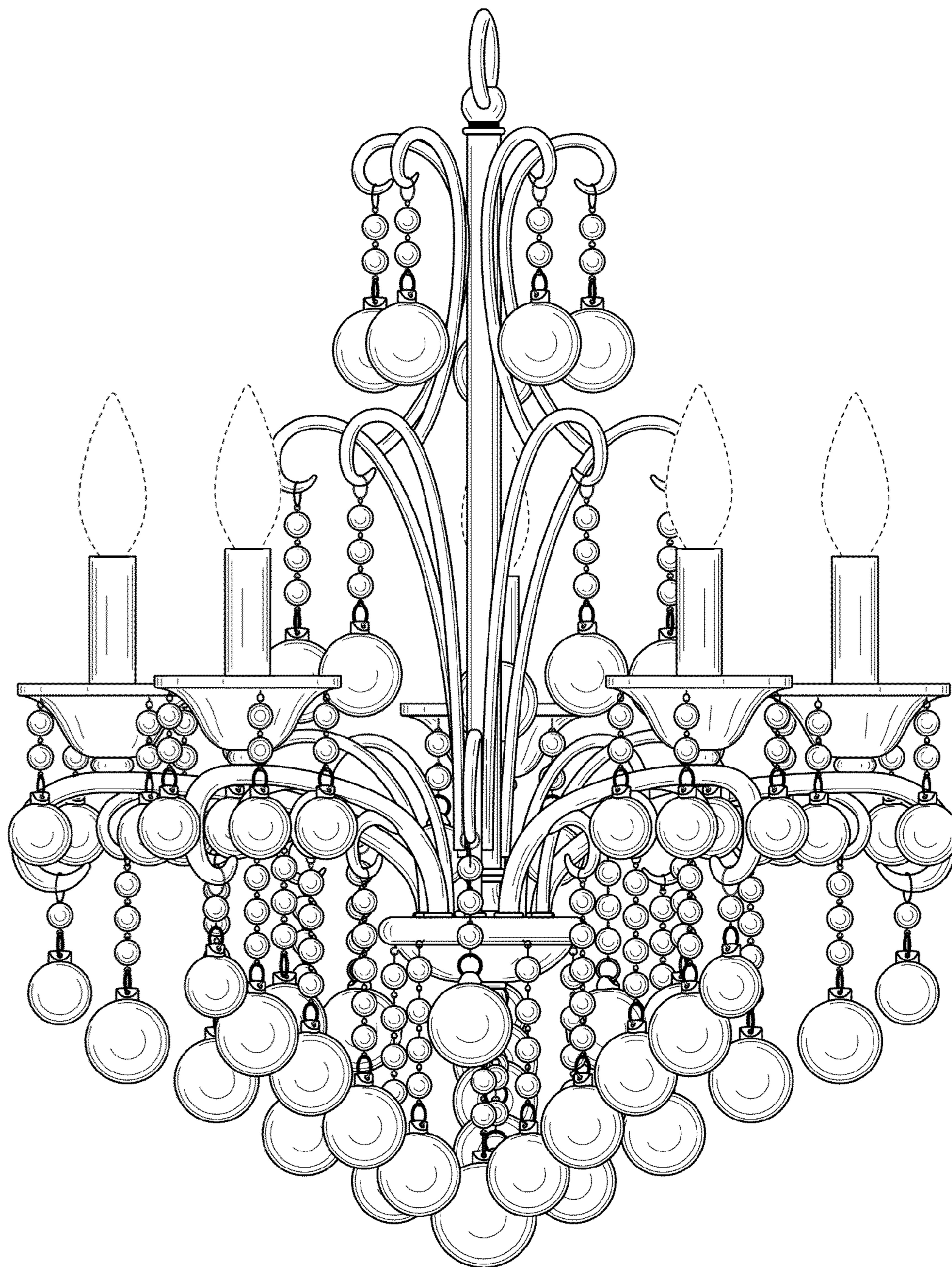
FIG. 6 is a top view of the light fixture illustrated in FIG. 1; and,

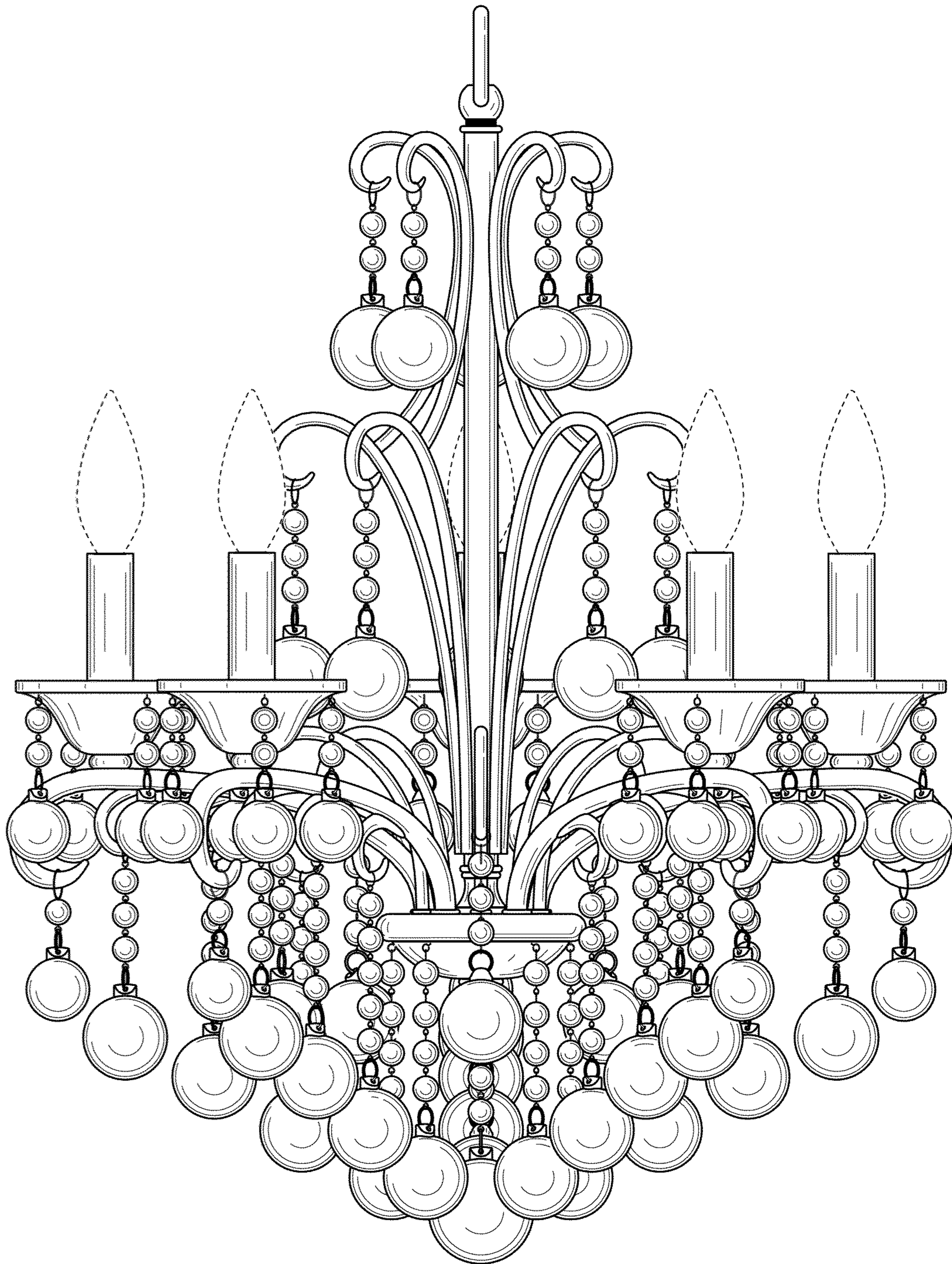

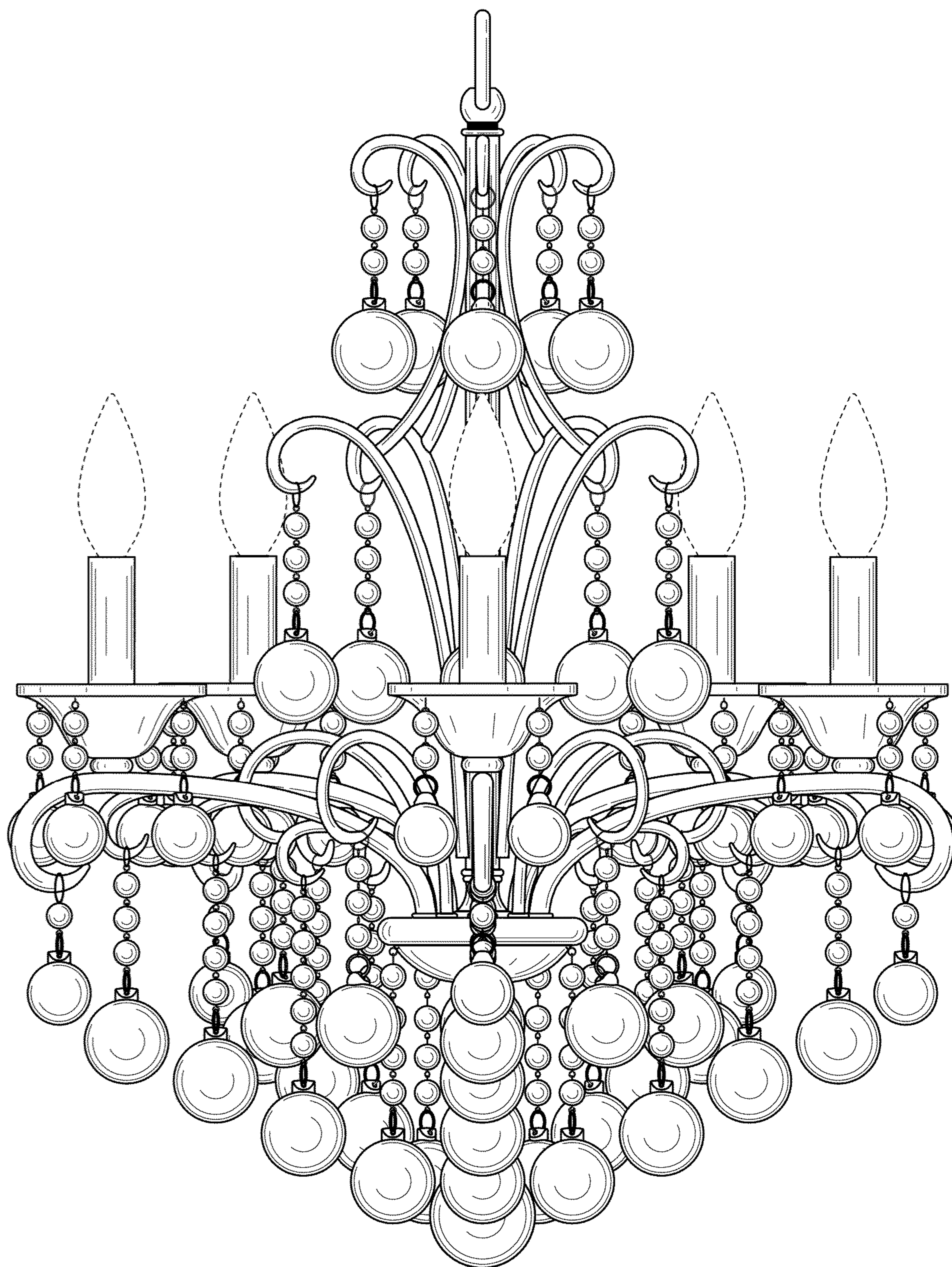

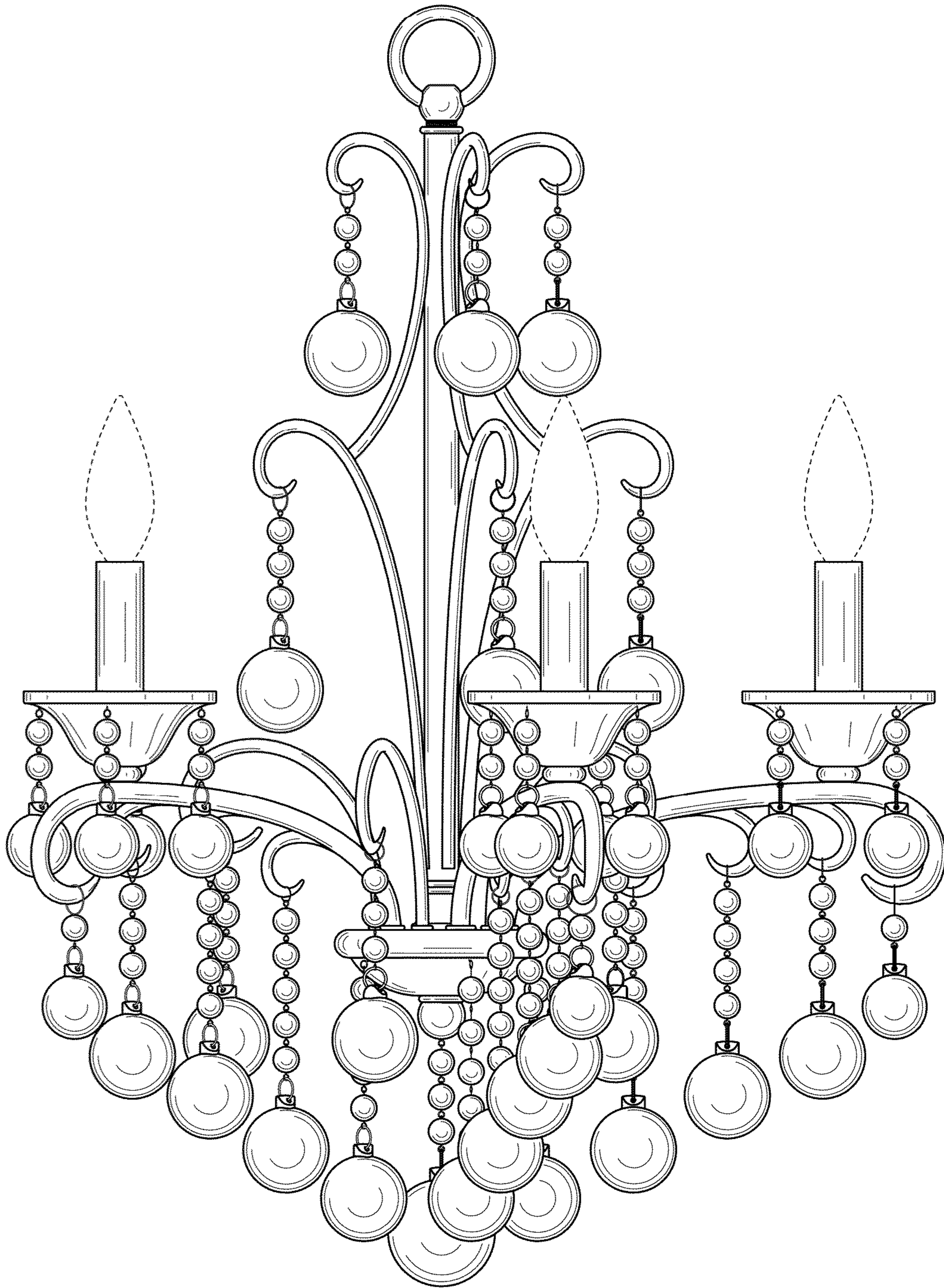

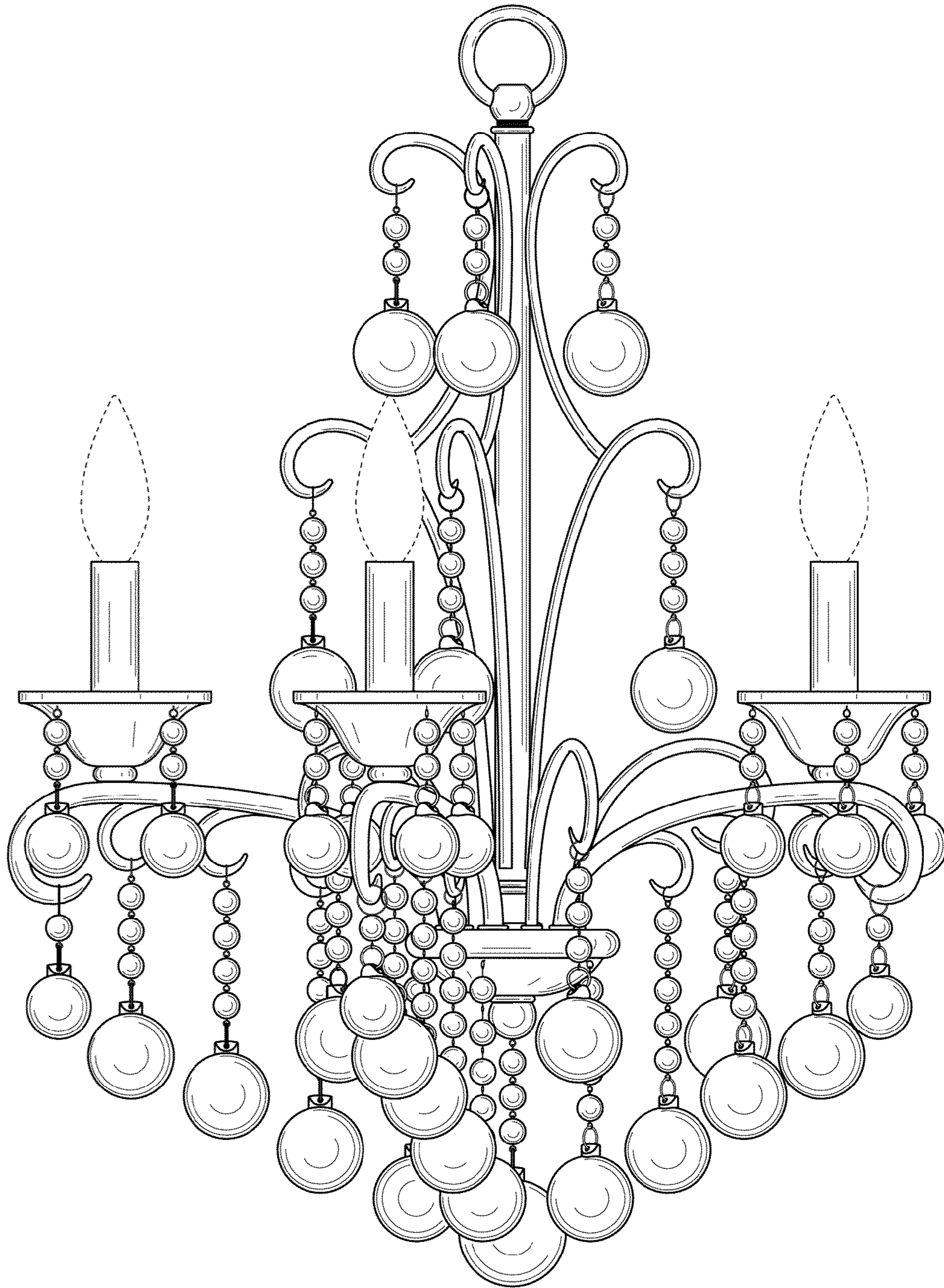
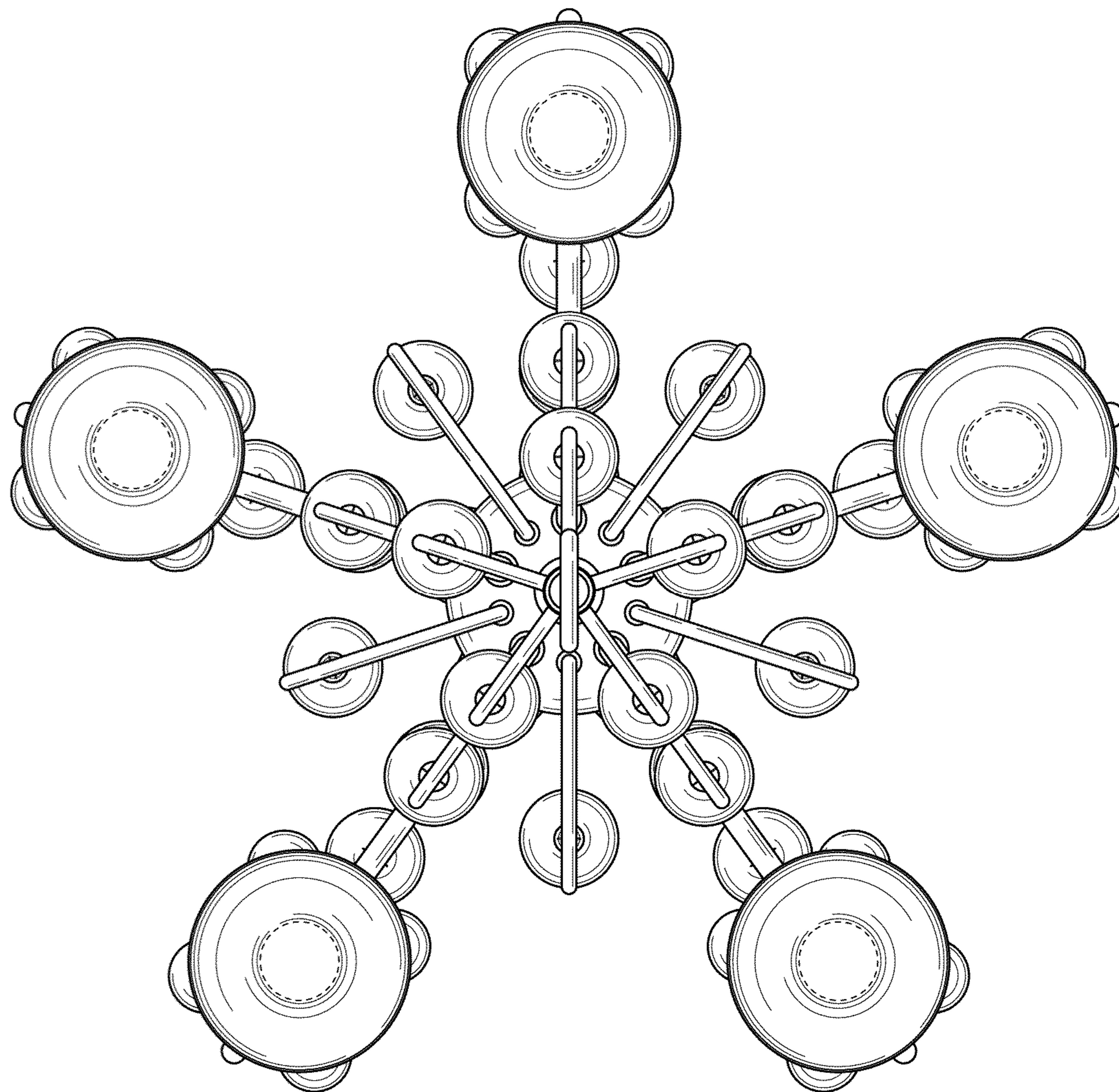
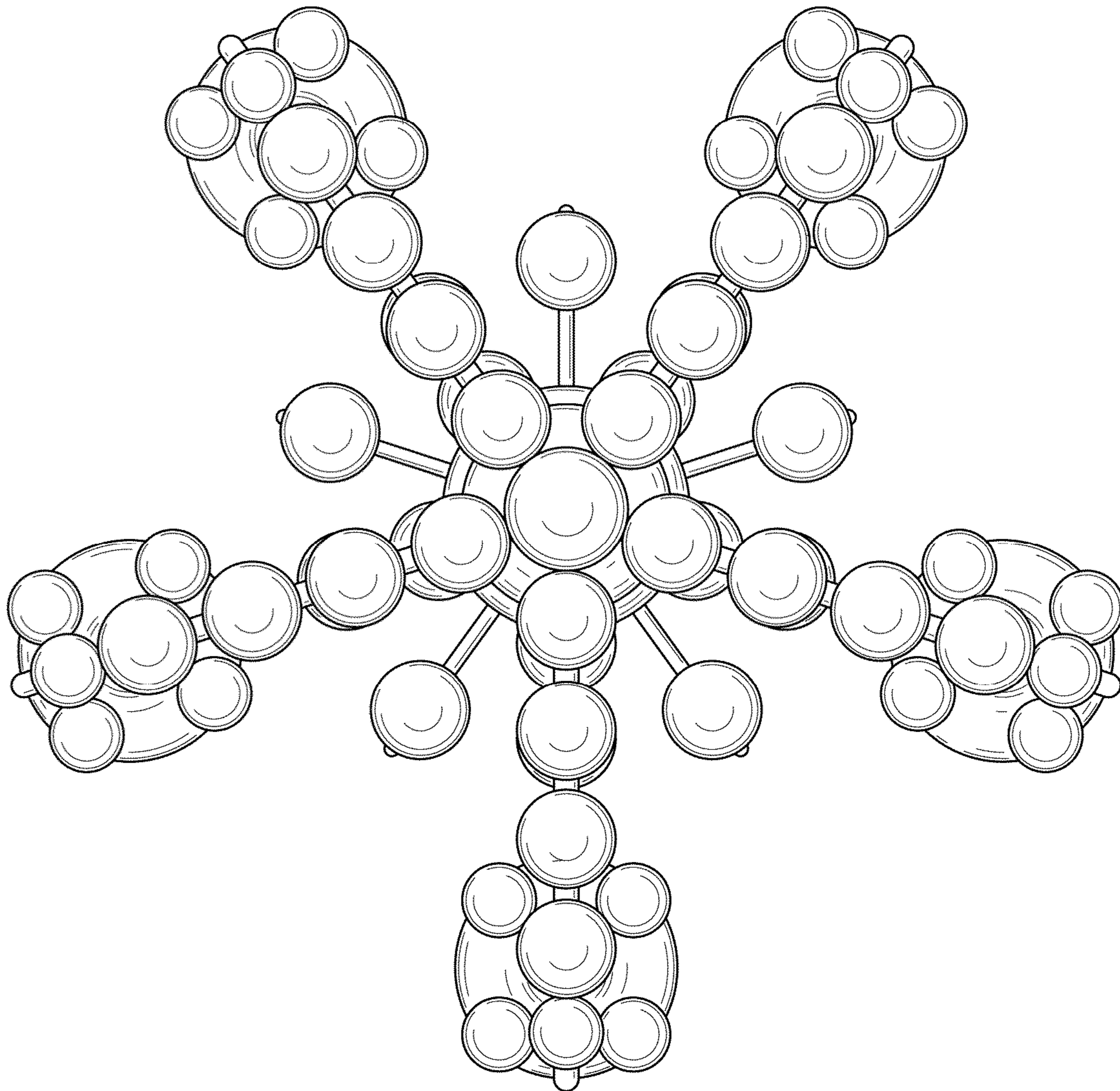
