FIG. 7 is a perspective view of the electric apparatus for preparing cosmetics of FIG. 1.

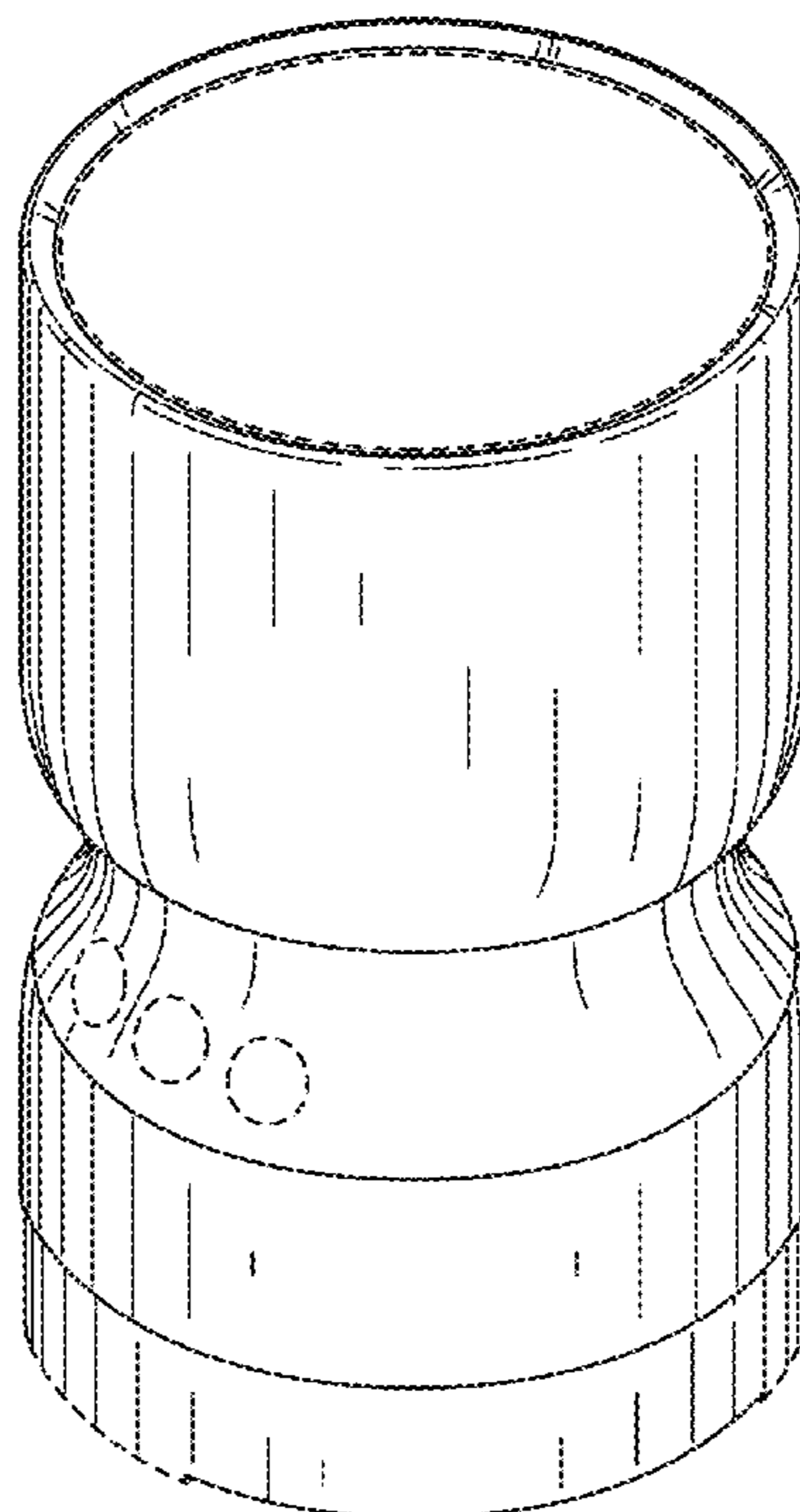

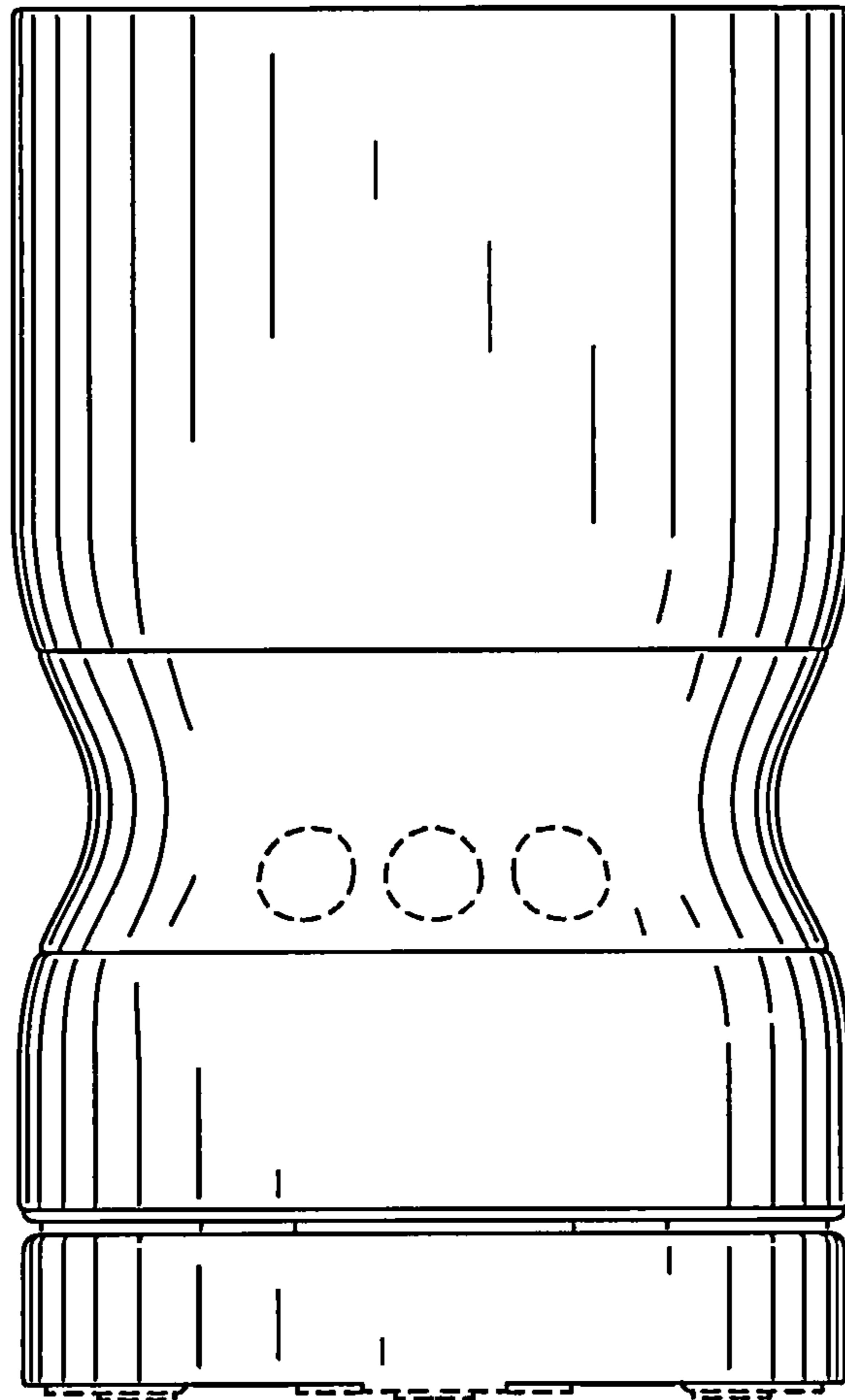

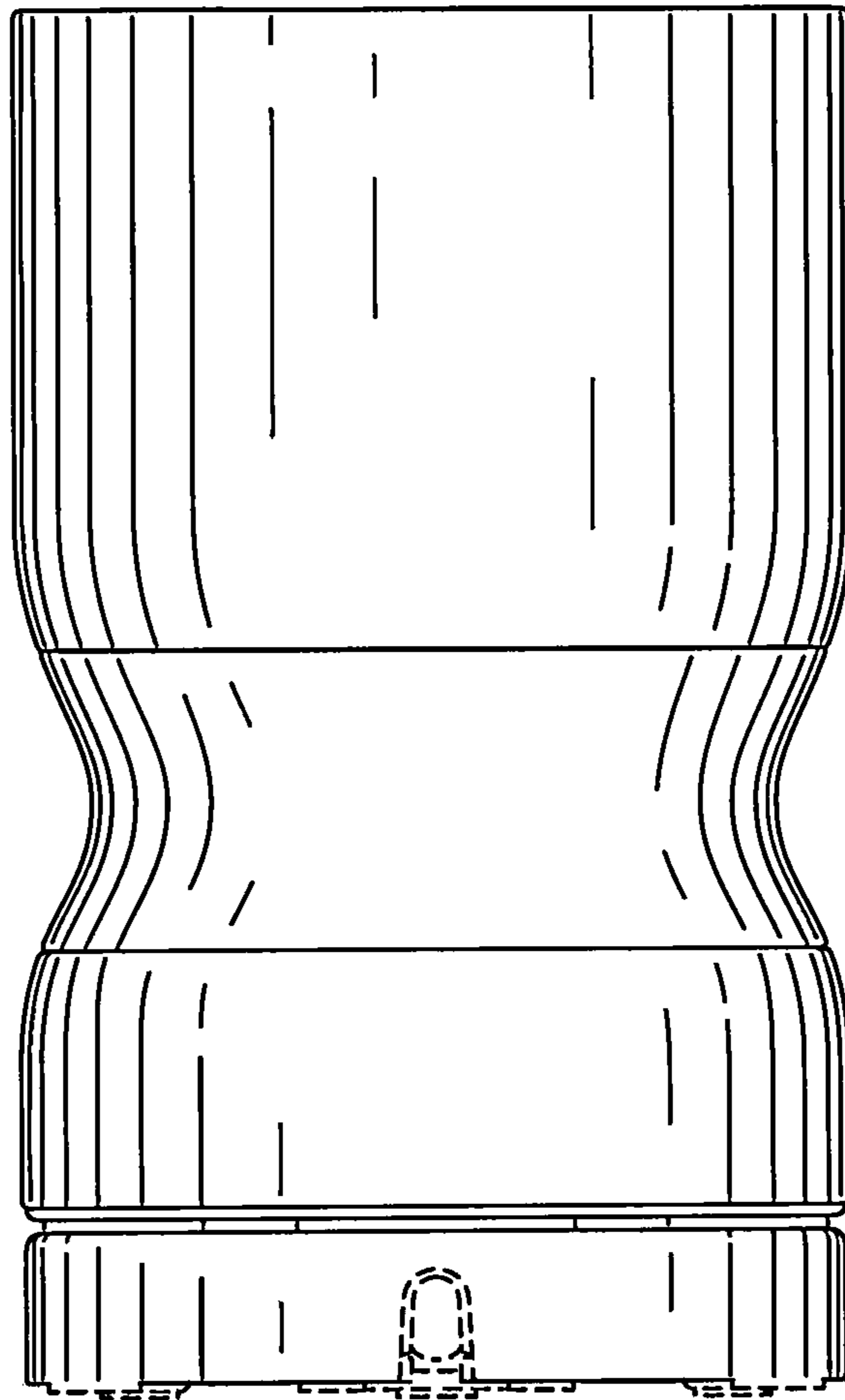

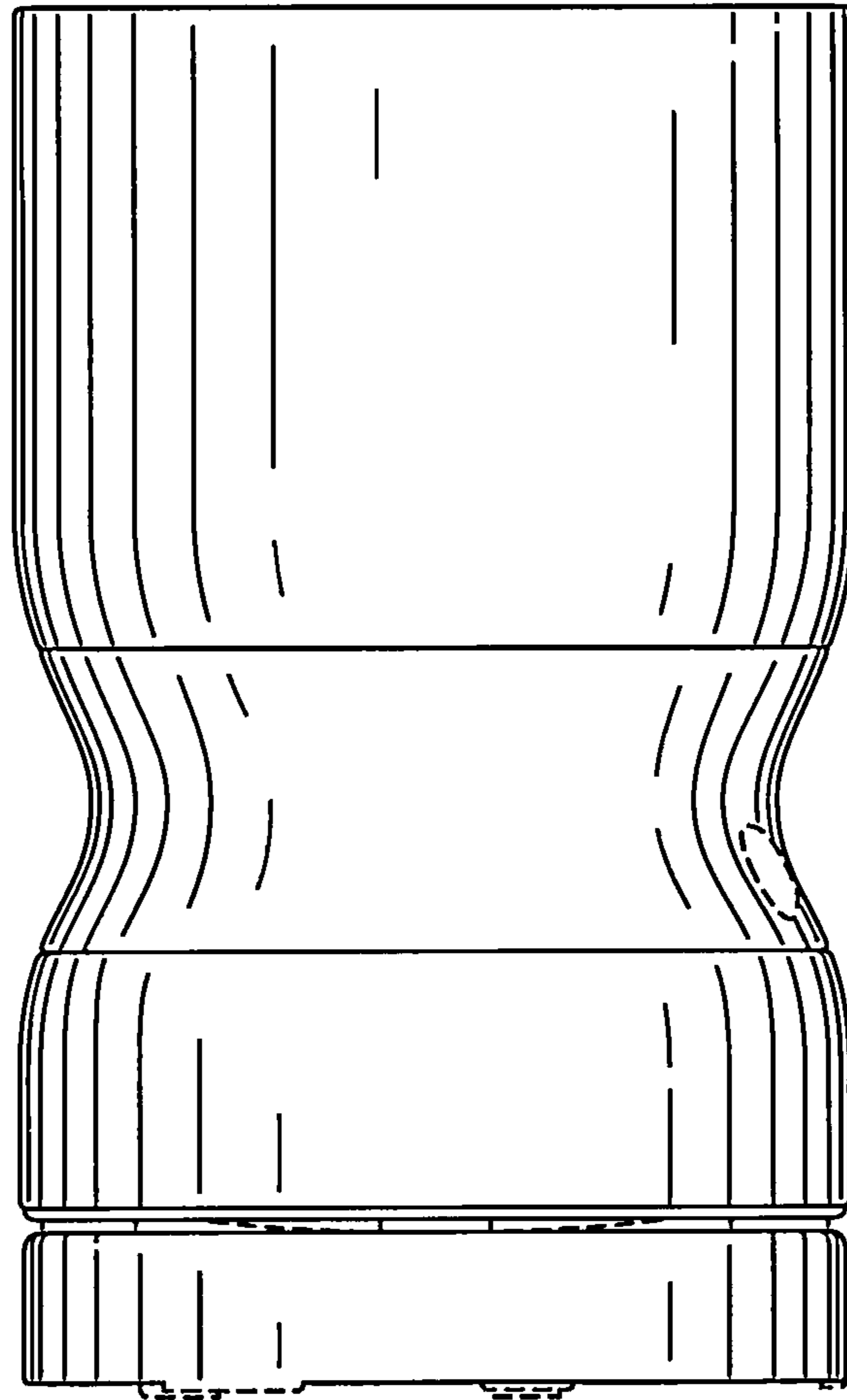

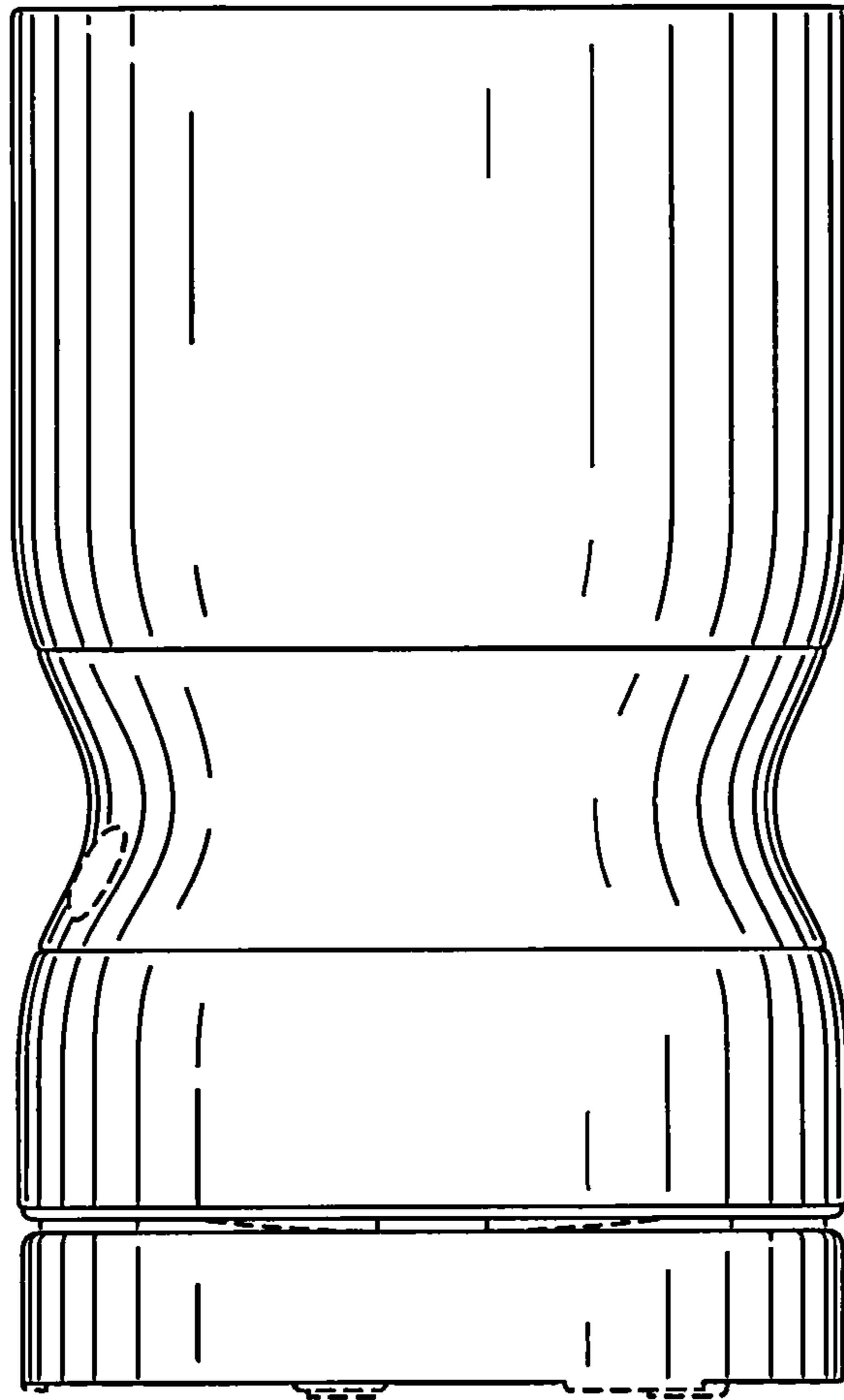

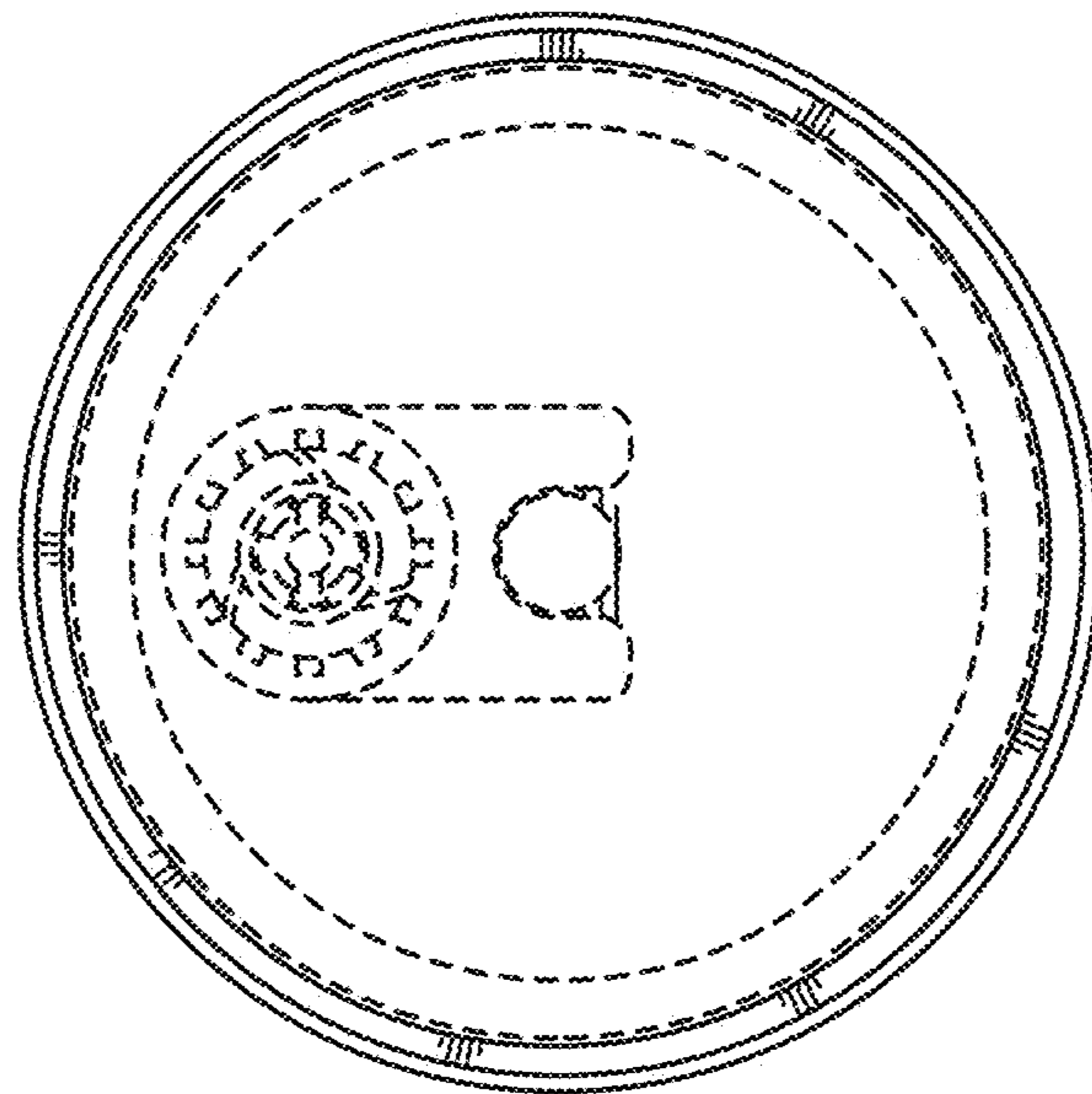

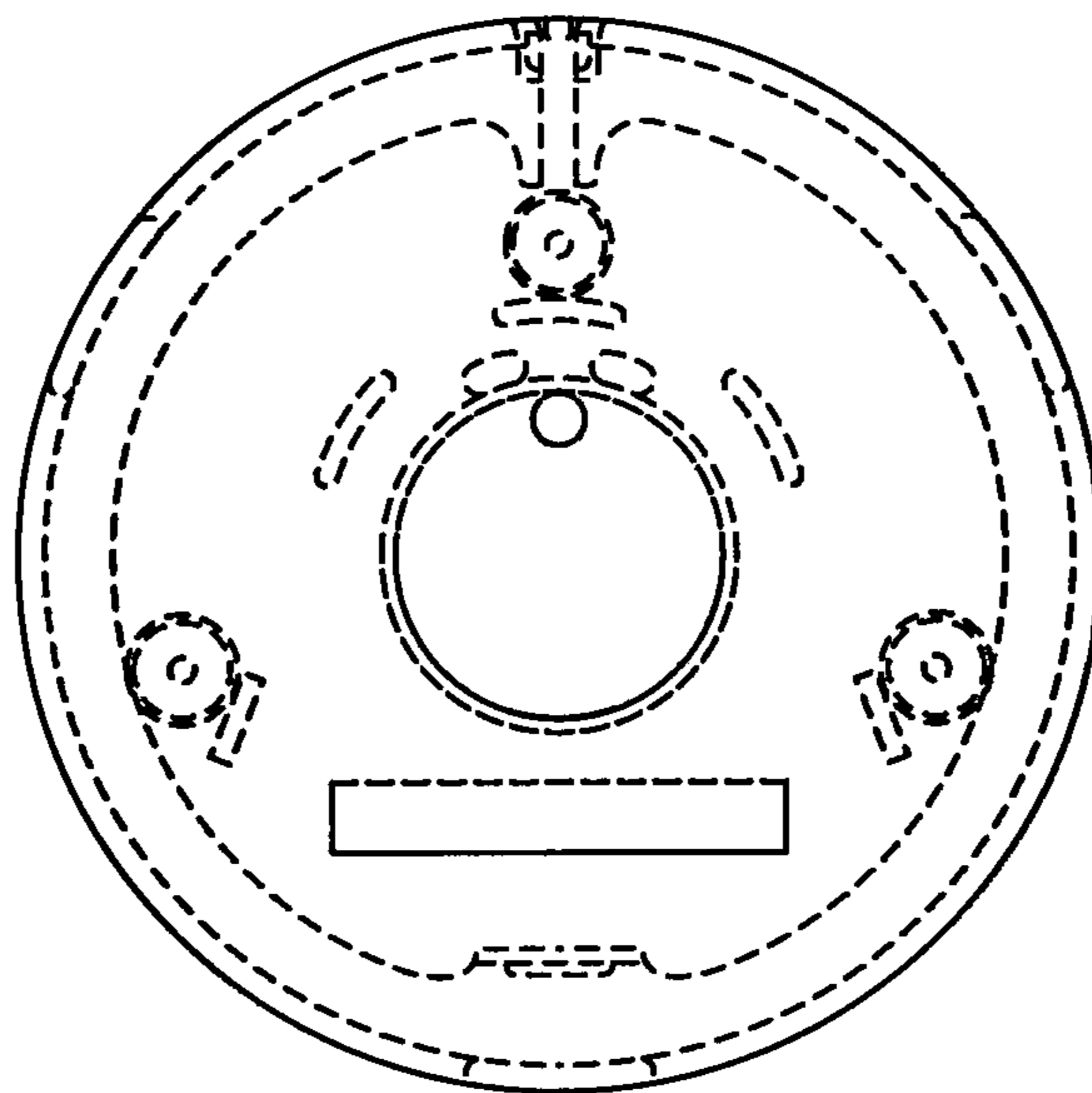

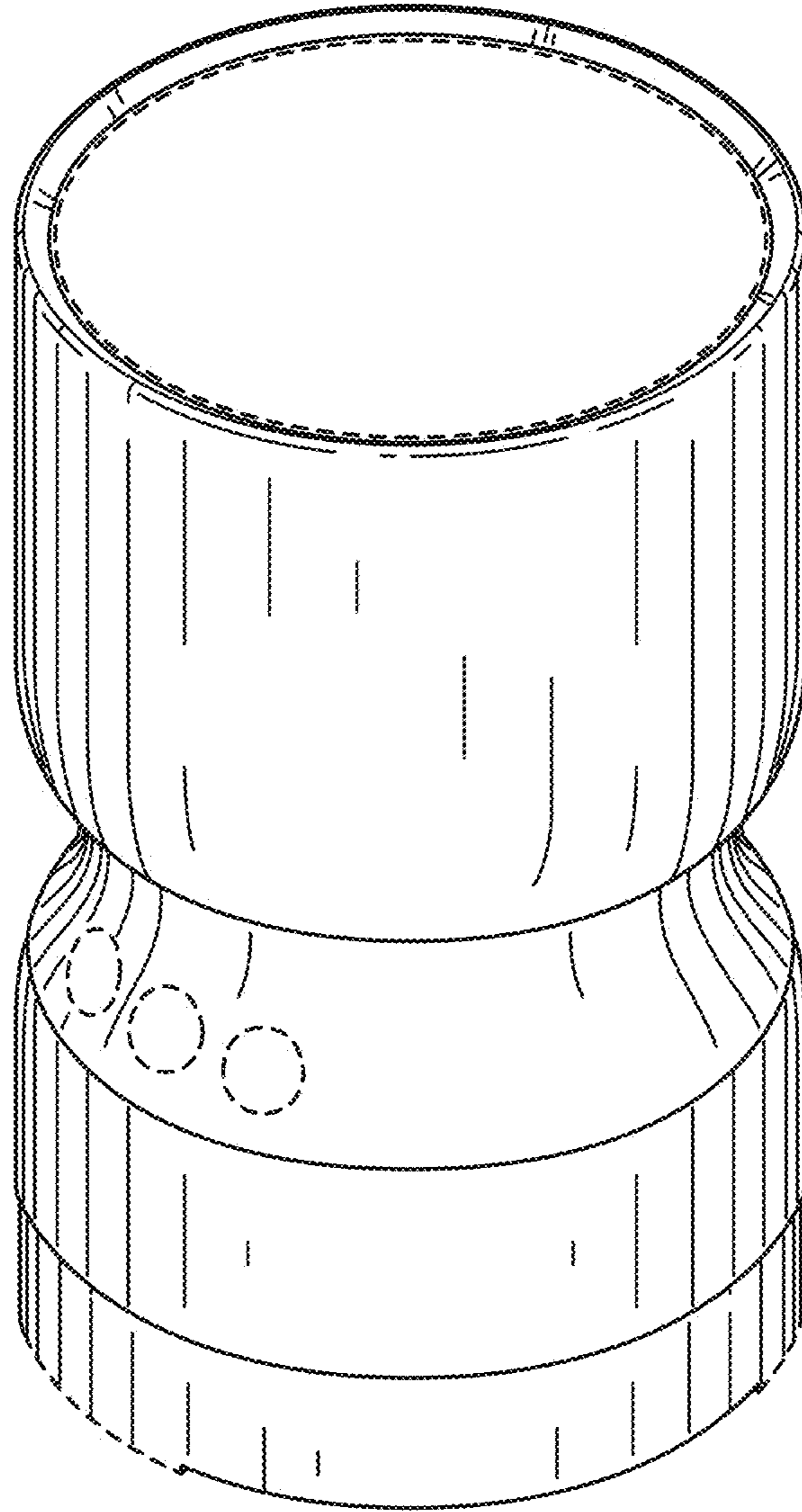
