DESCRIPTION

FIG. 1 is a top perspective view of a mouthpiece showing my new design;

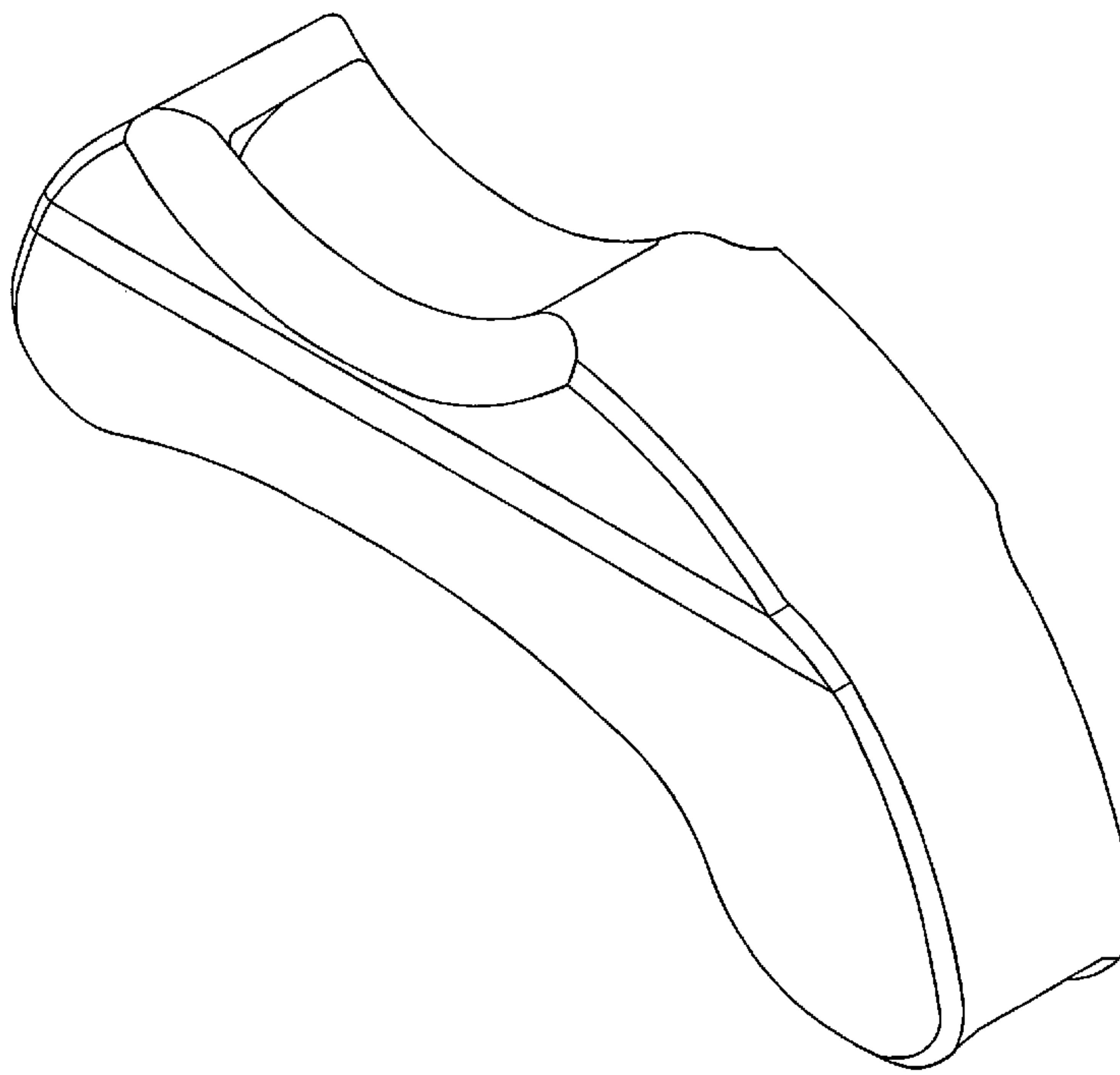

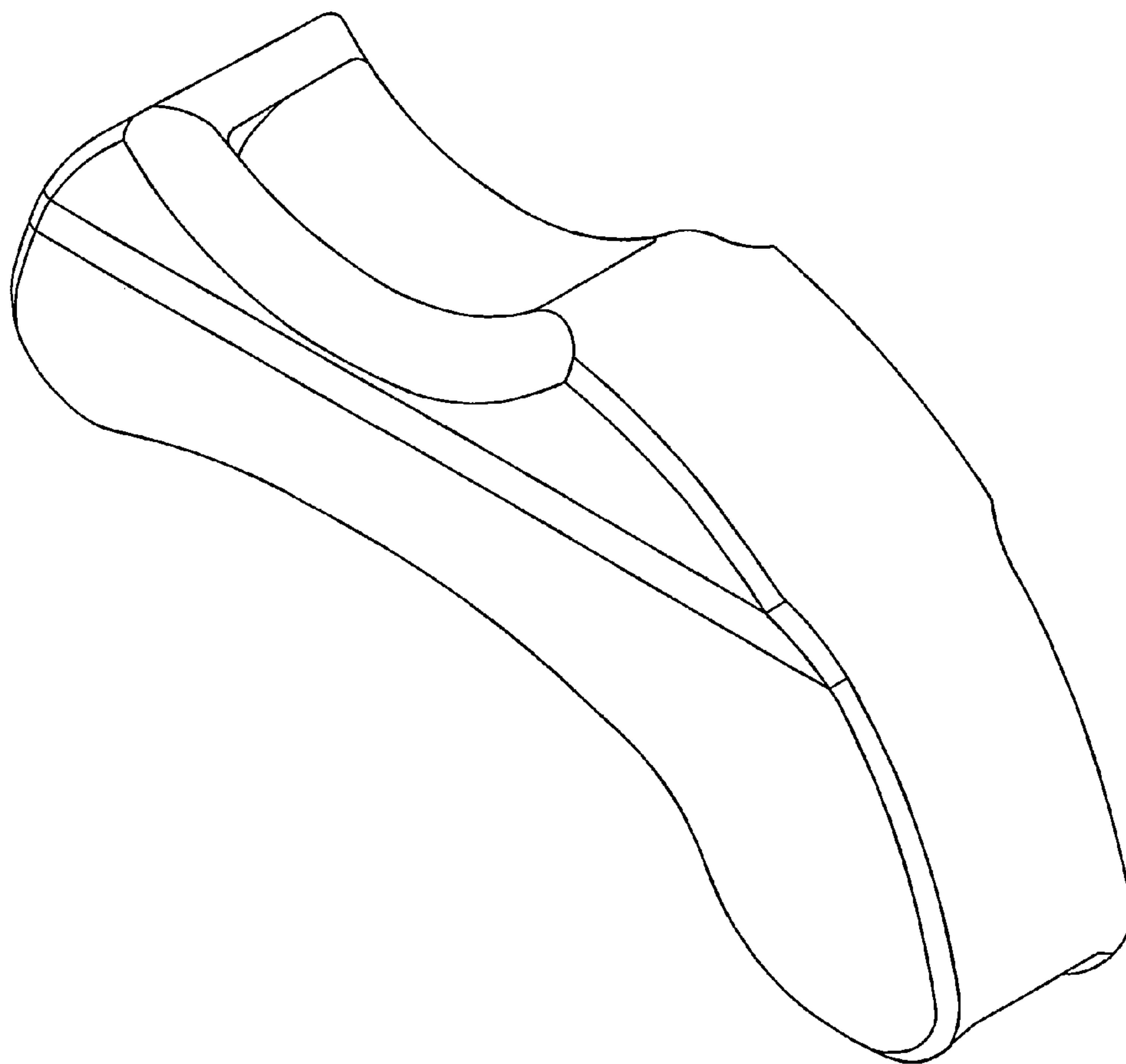

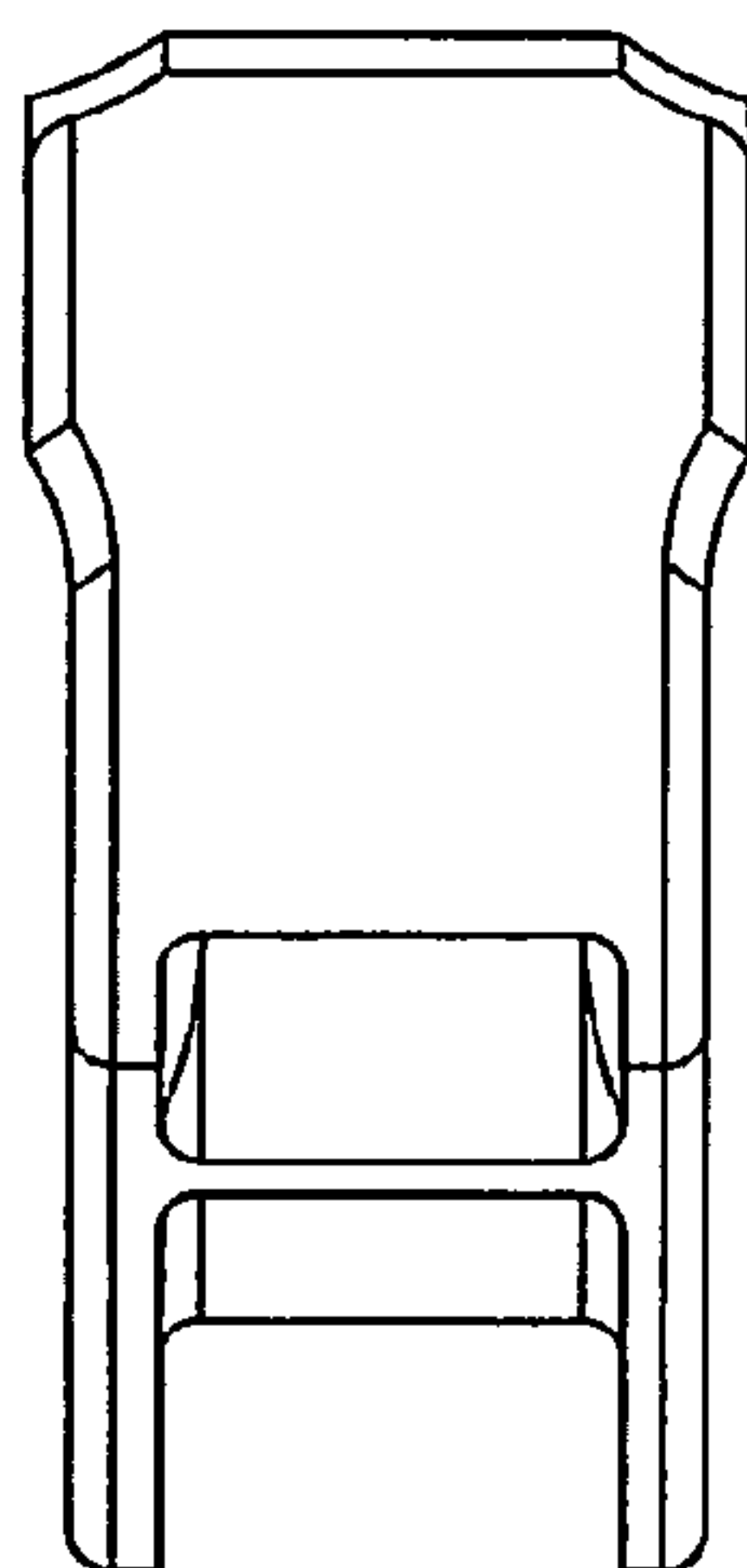

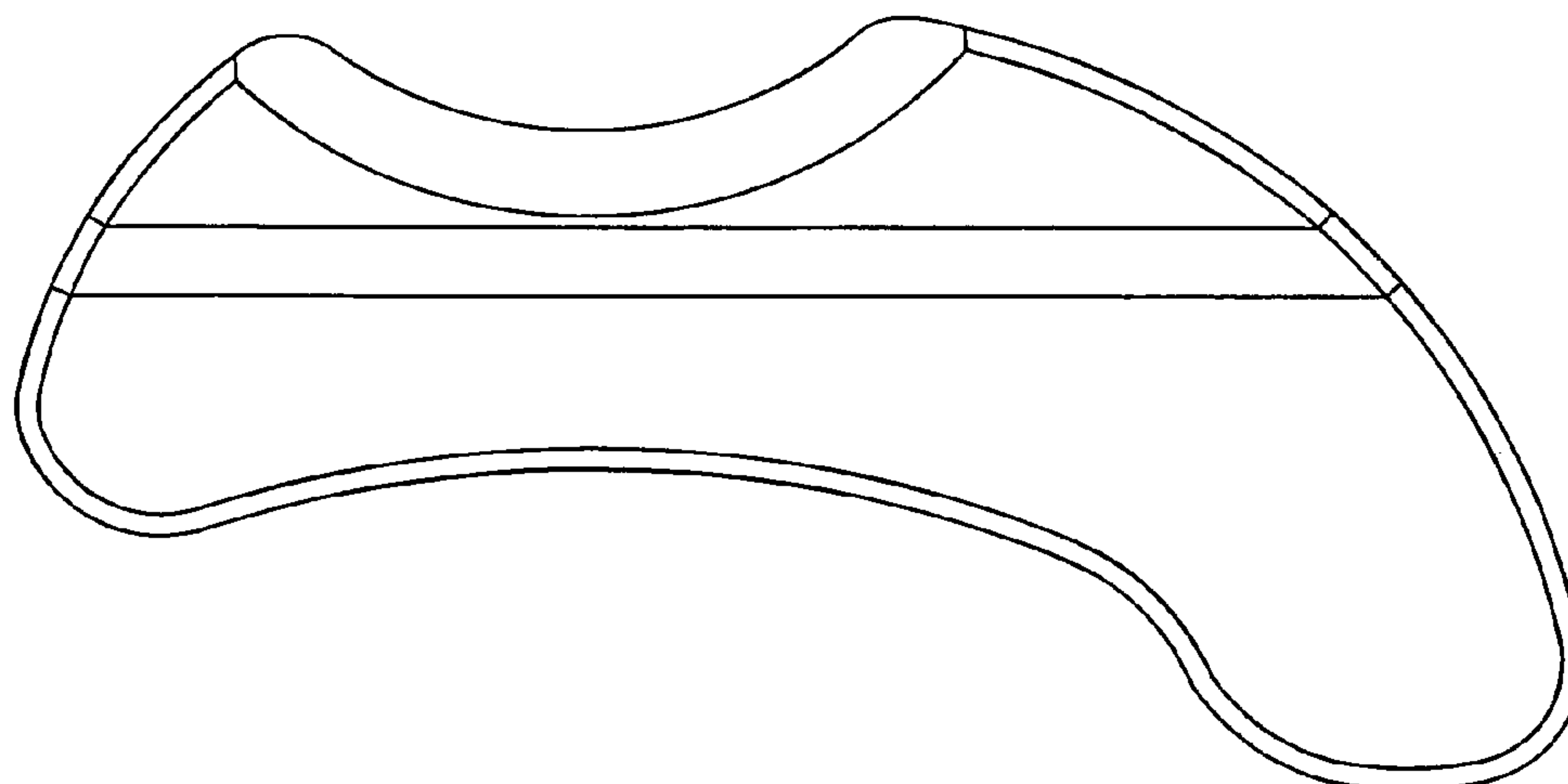

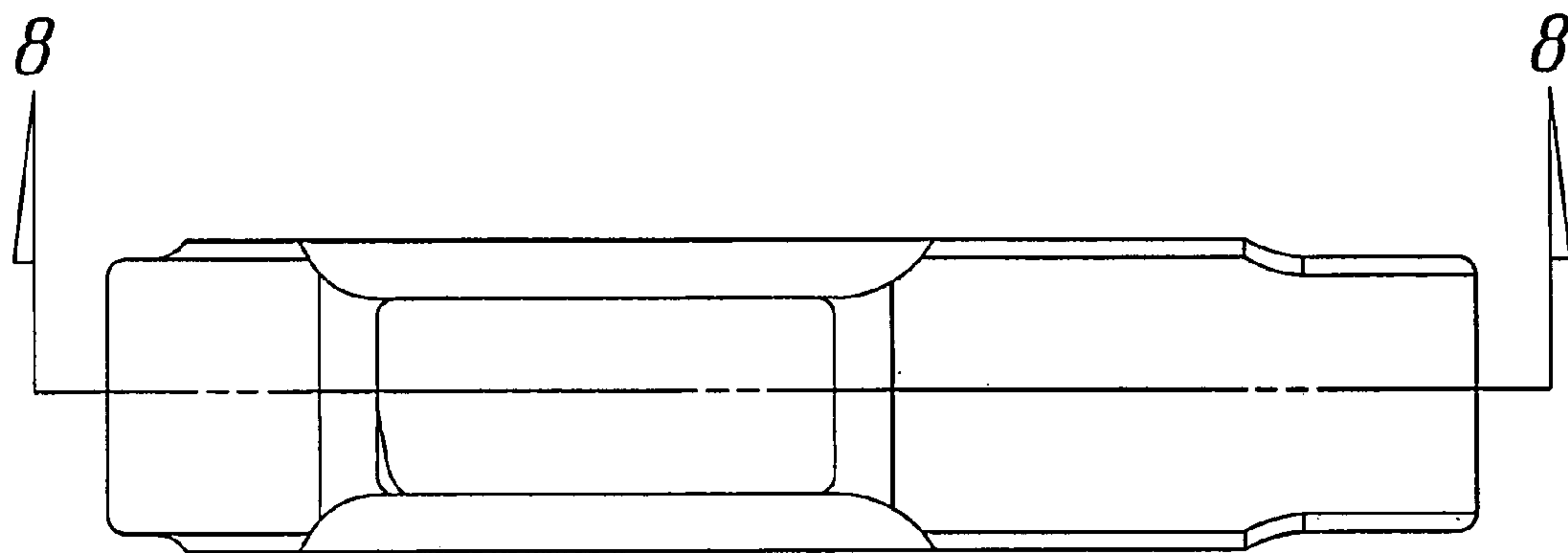

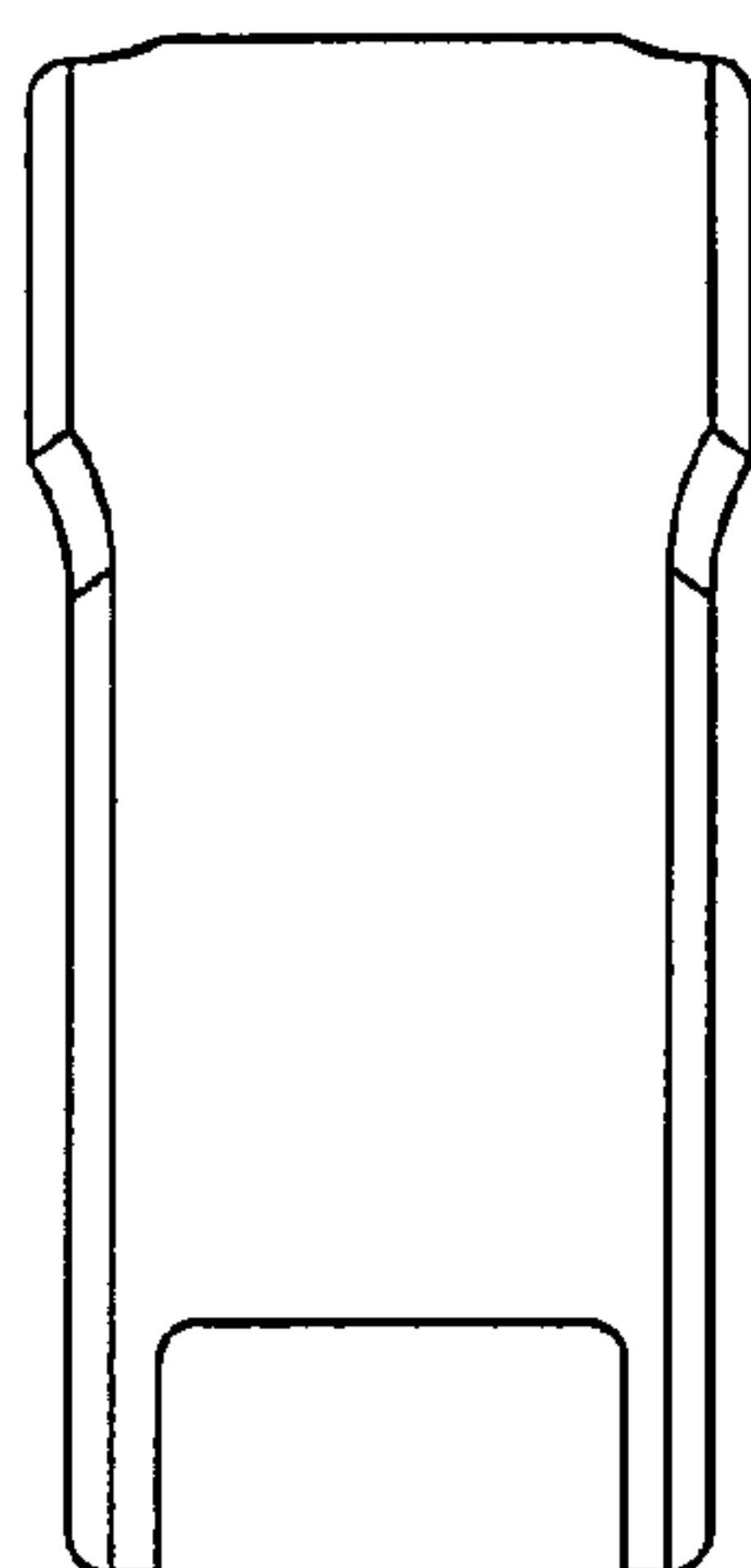

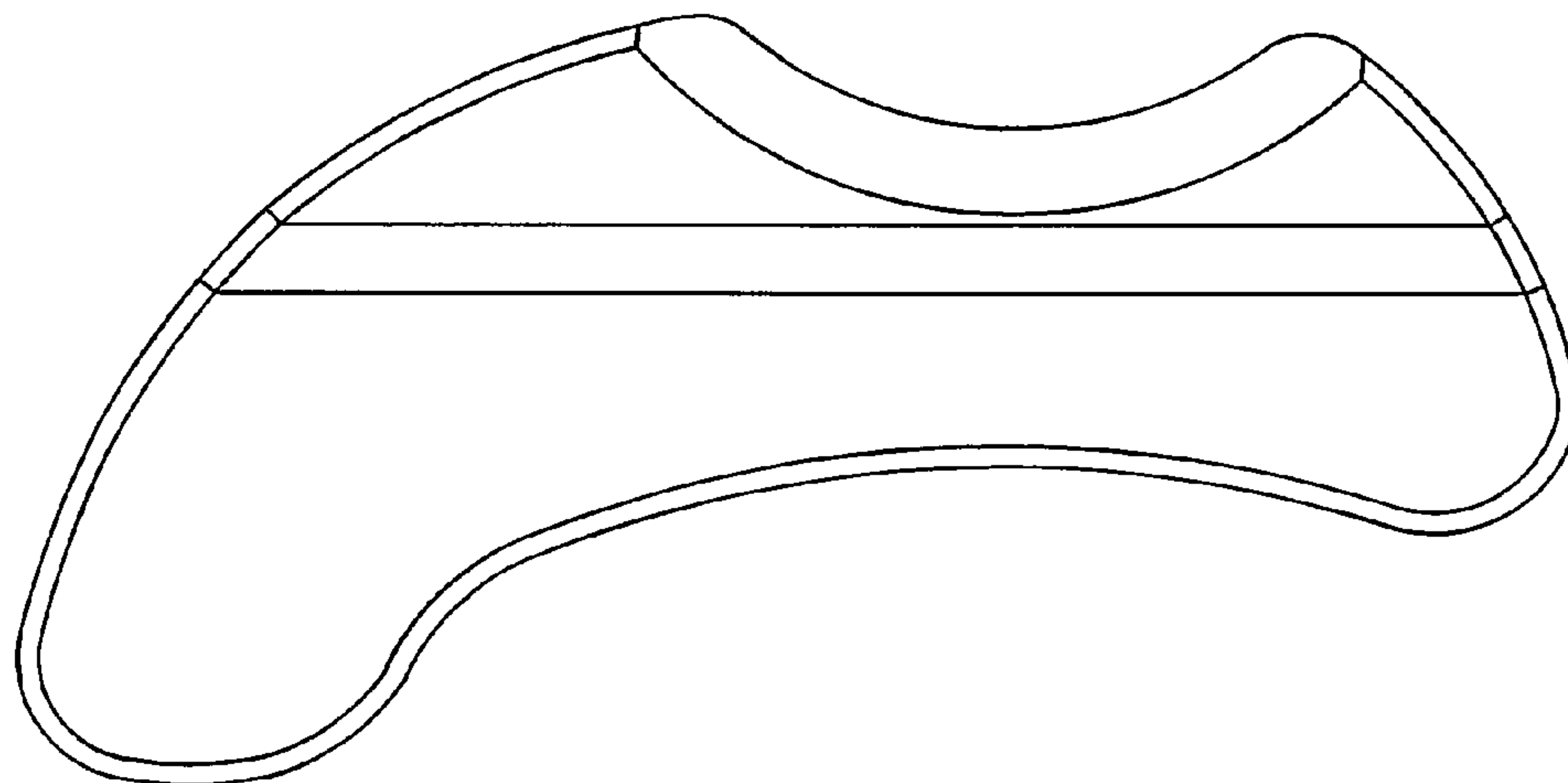

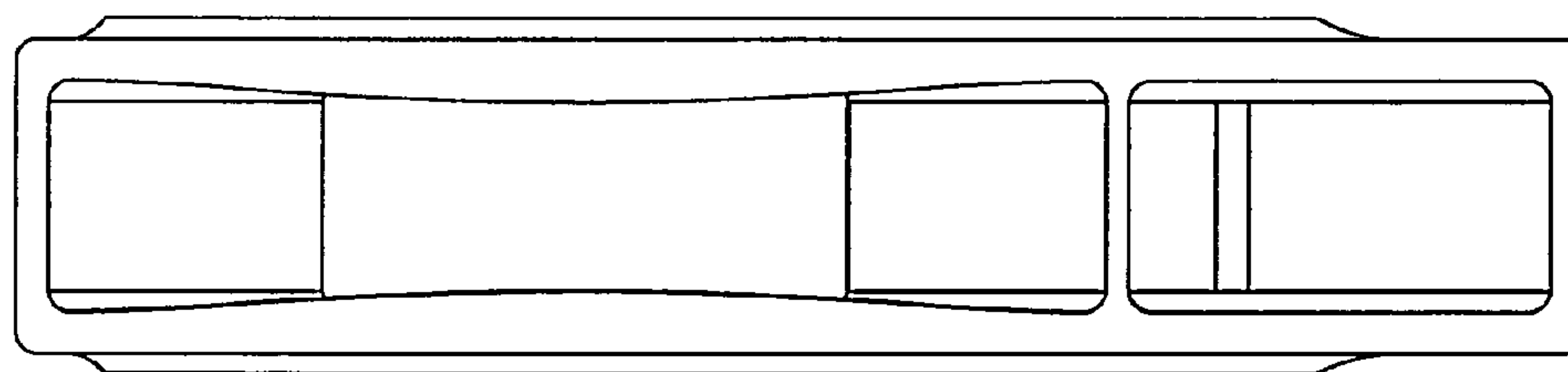
