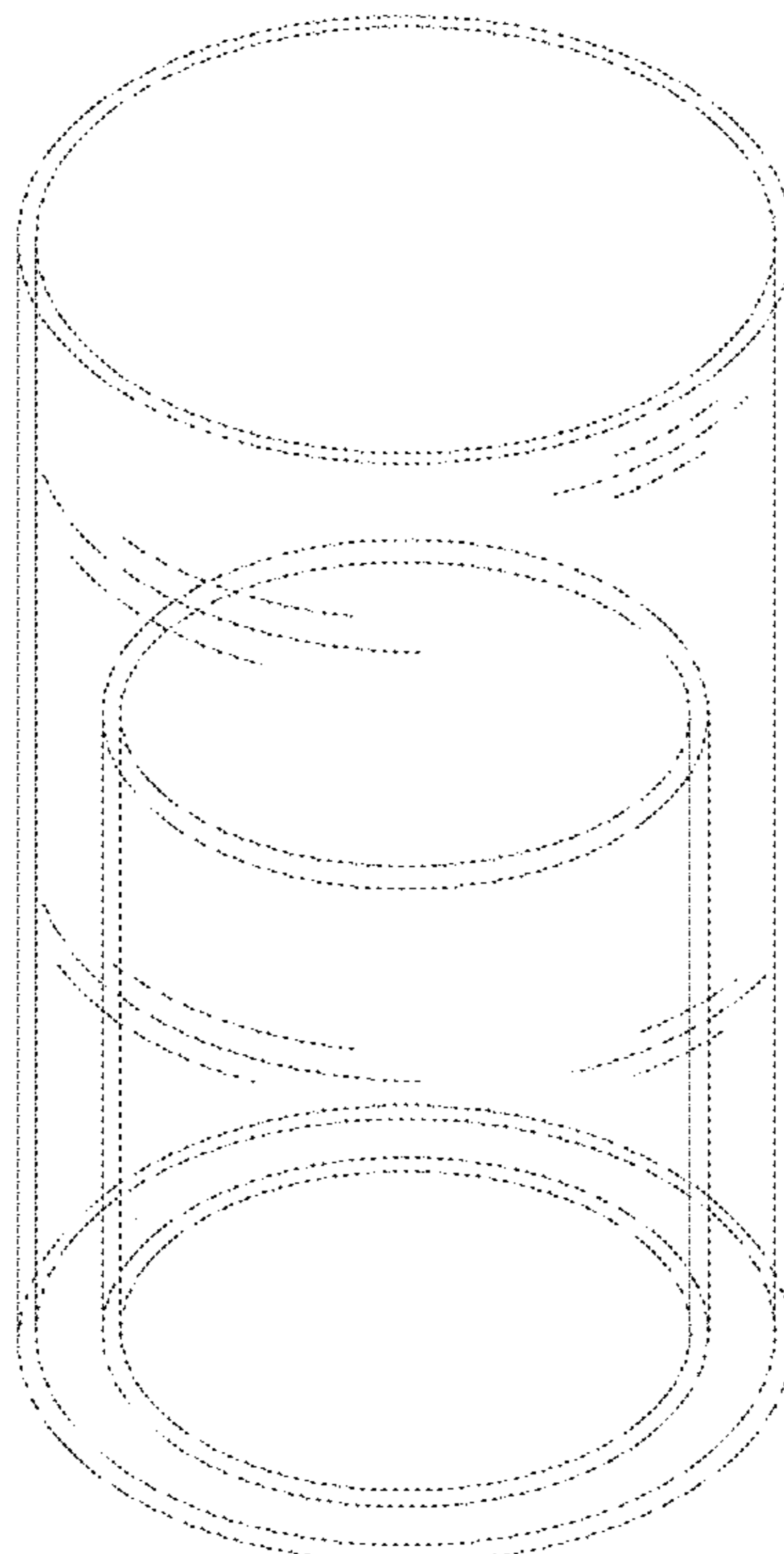
(57) **CLAIM**

The ornamental design for a transparent cylindrical ant farm, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a transparent cylindrical ant farm showing our new design; FIG. 2 is a top view thereof; FIG. 3 is a bottom view thereof; and, FIG. 4 is a front view thereof, the right side, left side and rear views are identical.

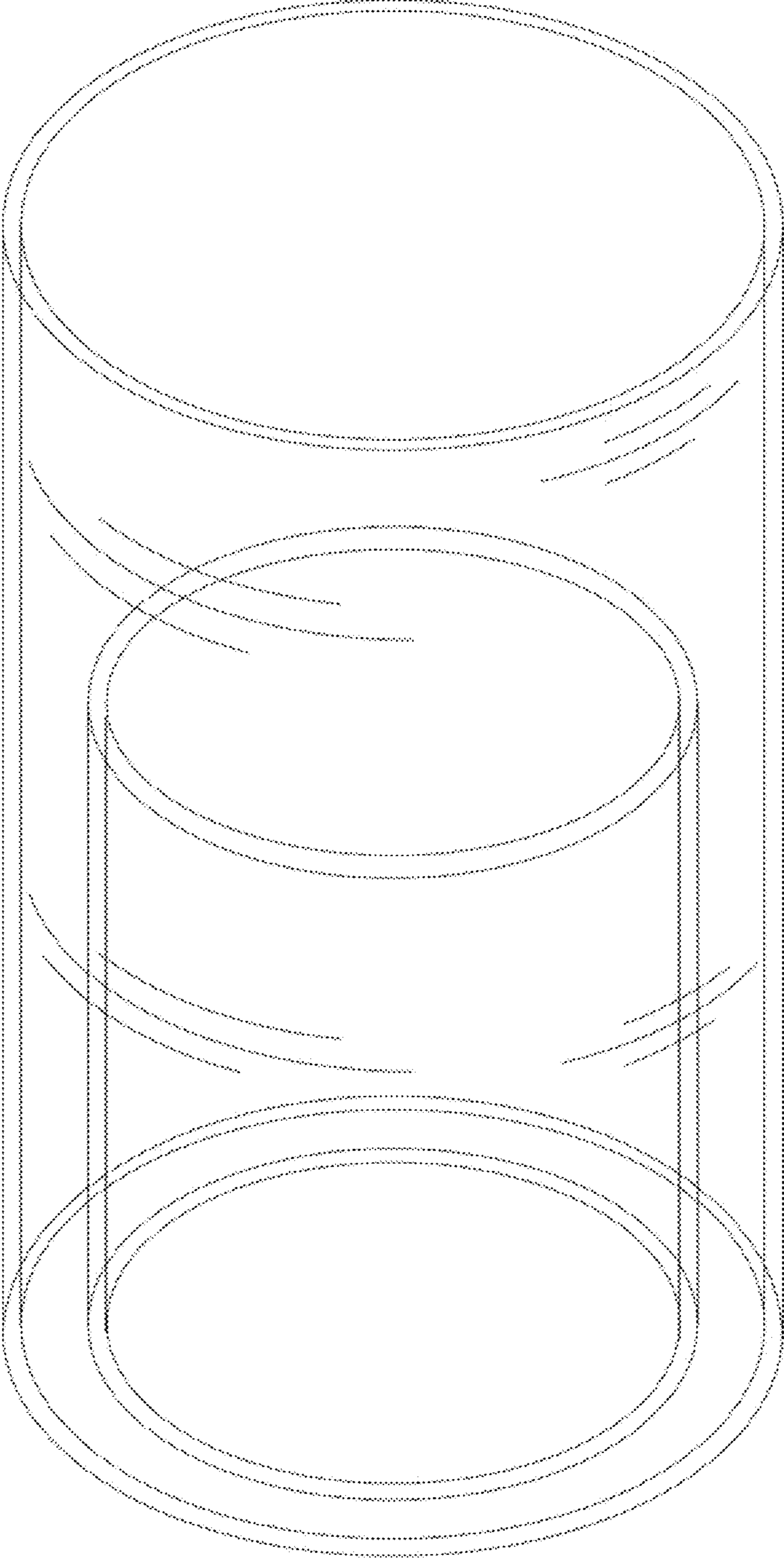

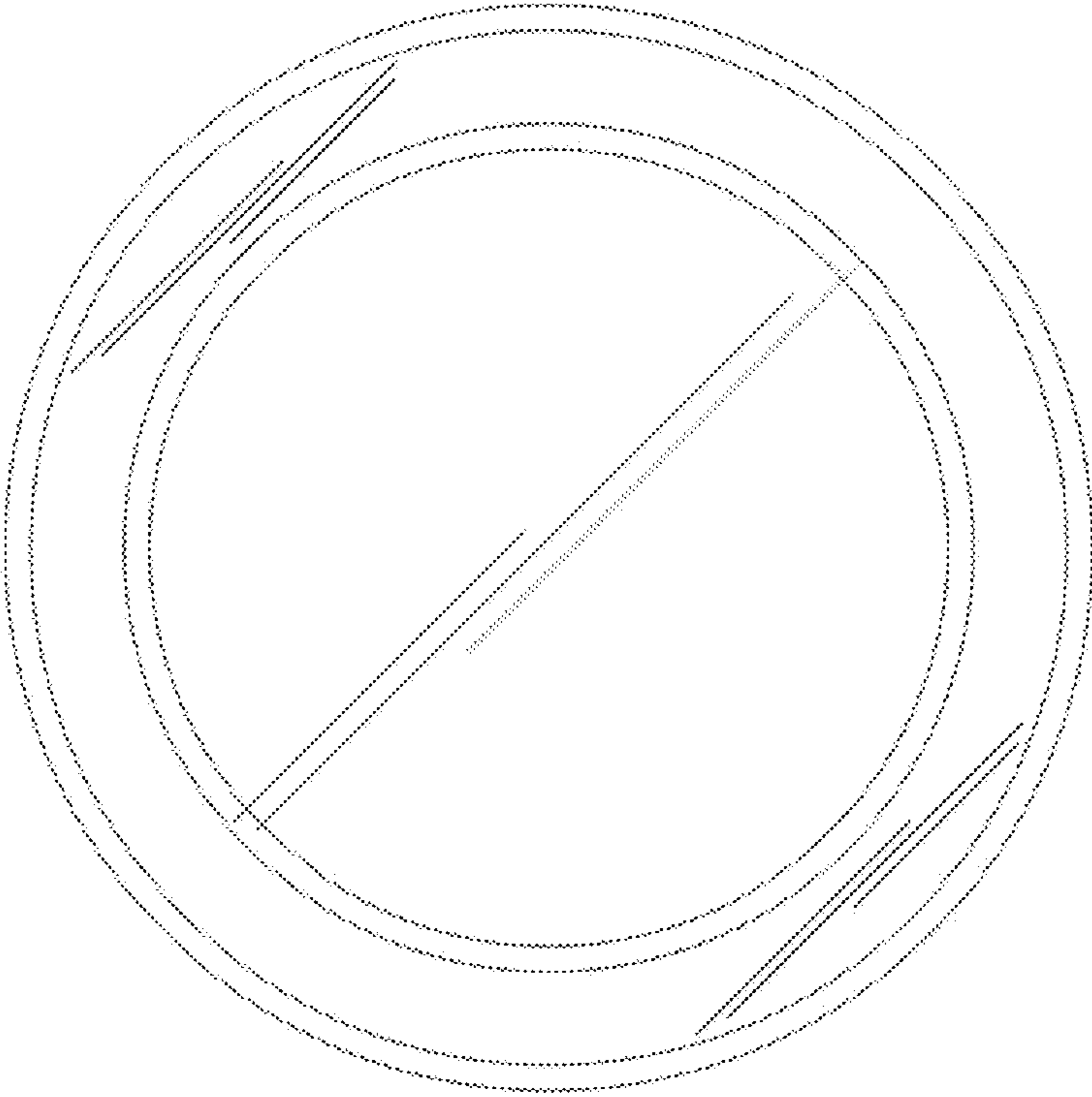

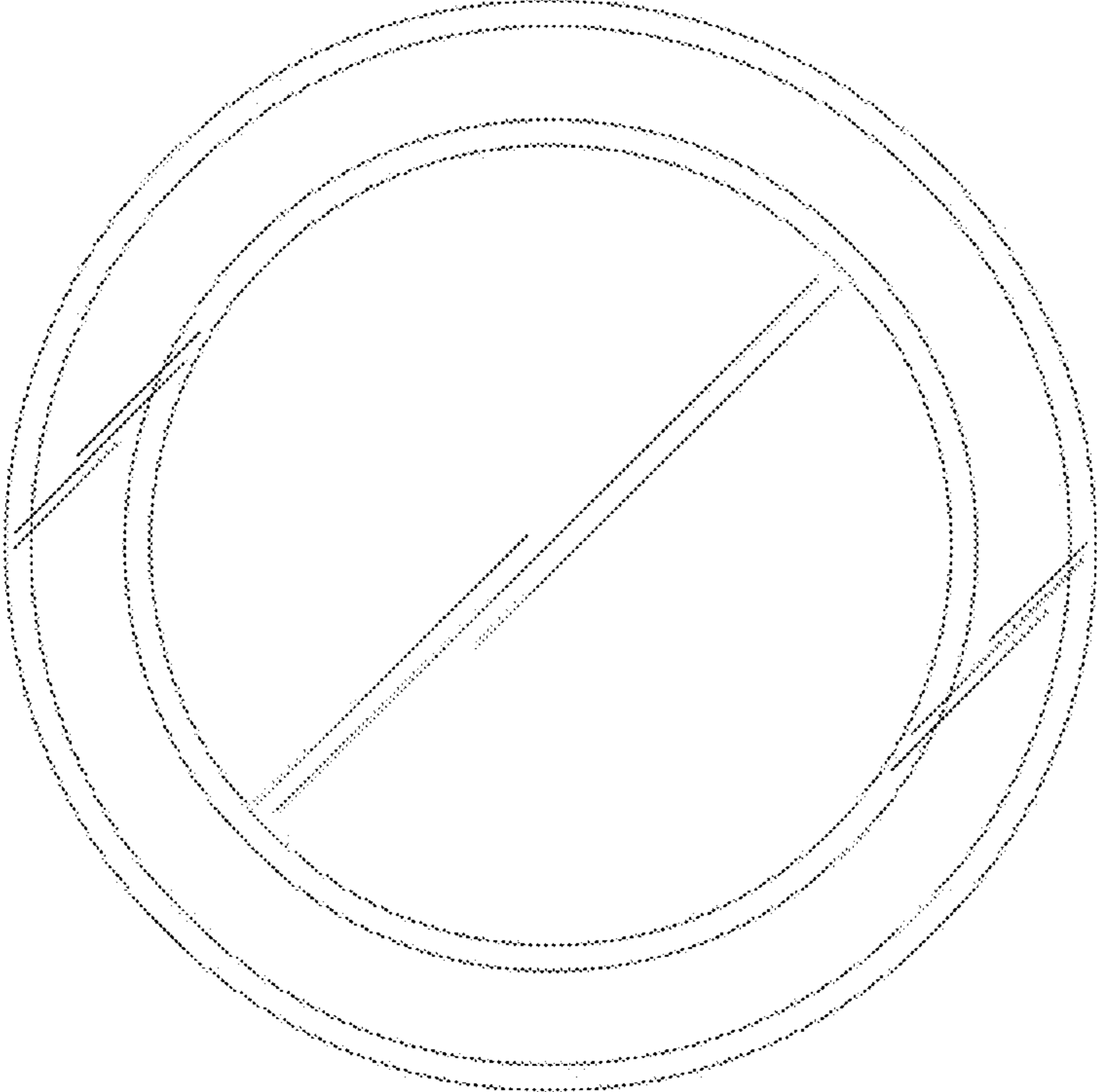

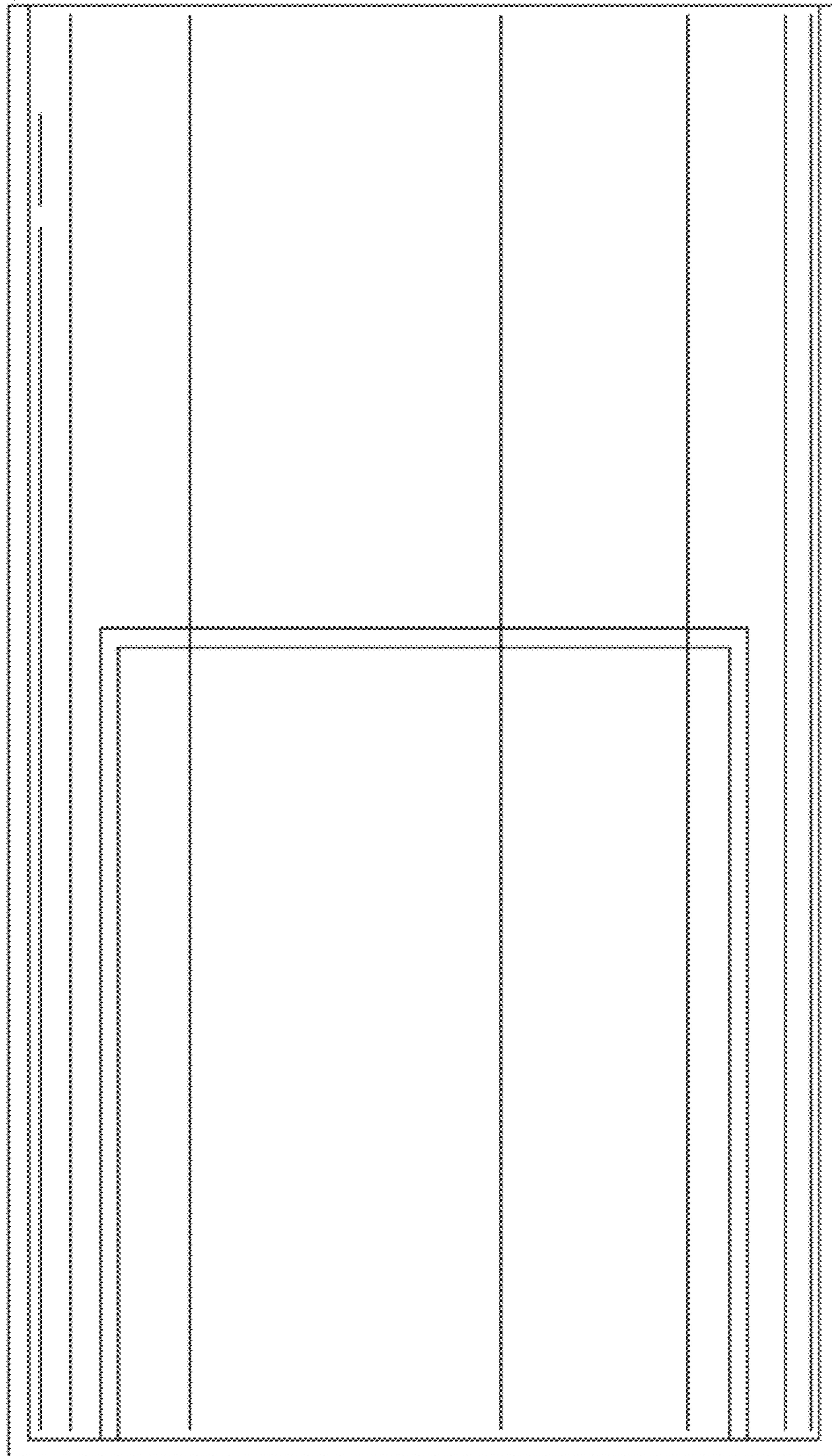
