The ornamental design for a huggable plush seatbelt cover, as shown and described.

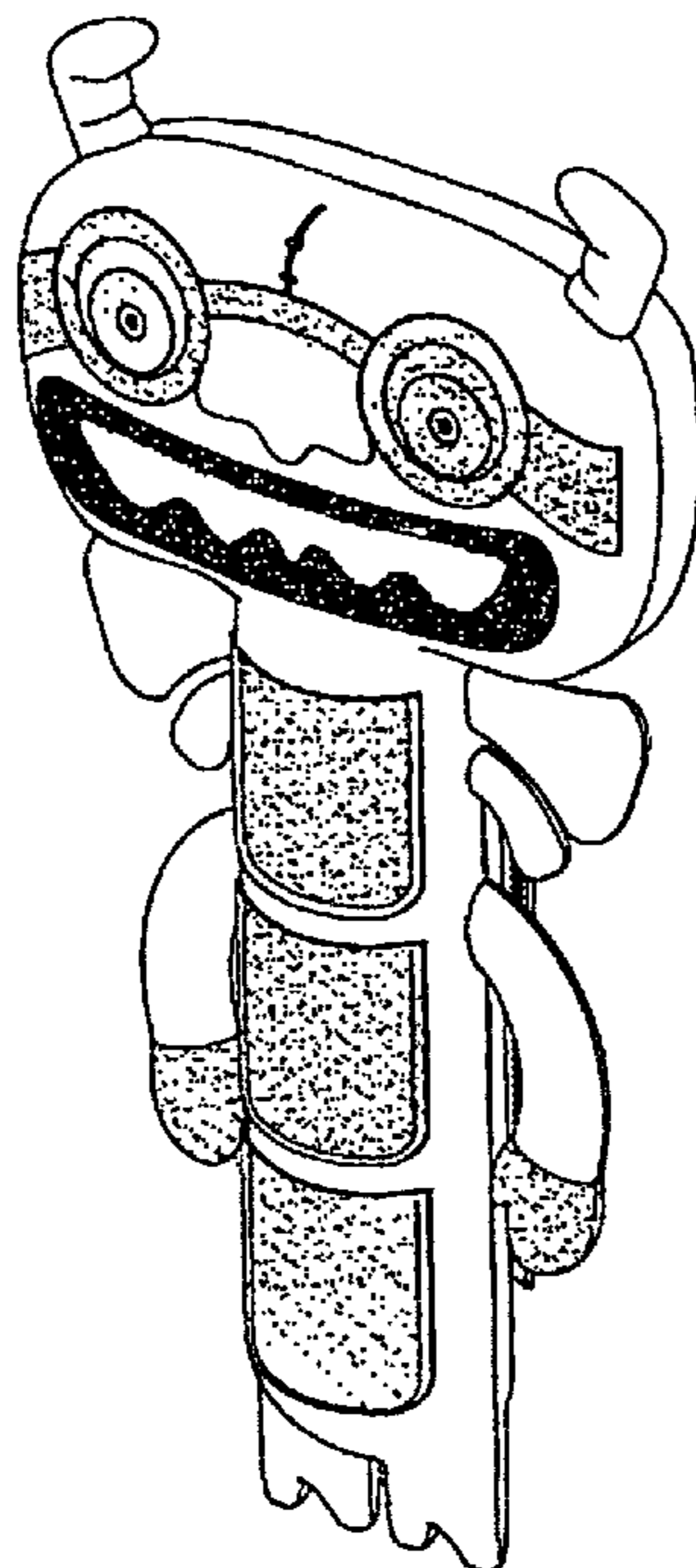
DESCRIPTION

FIG. 1 is a frontal isometric view of my new design;

 A feature of the design is the incorporation of a fantasy character into the outer layer of the cover.

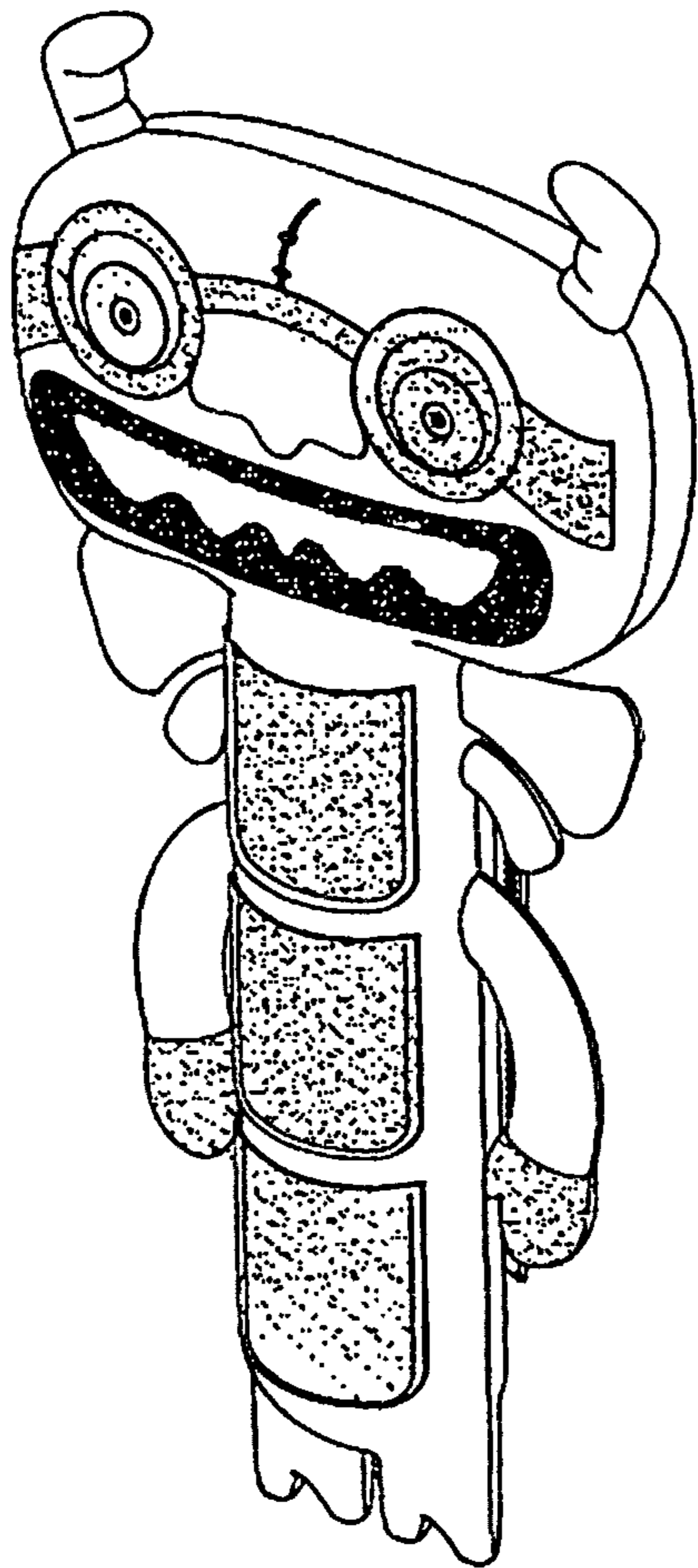

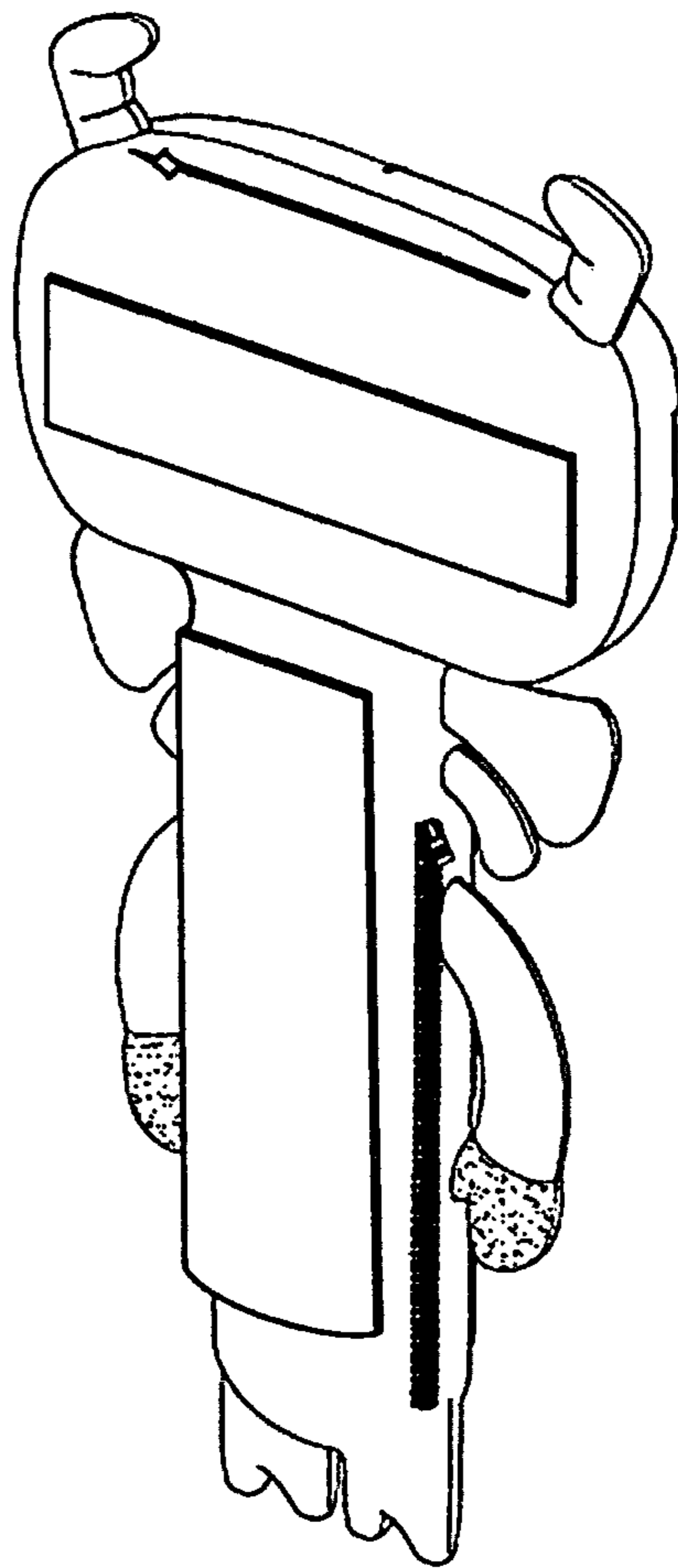

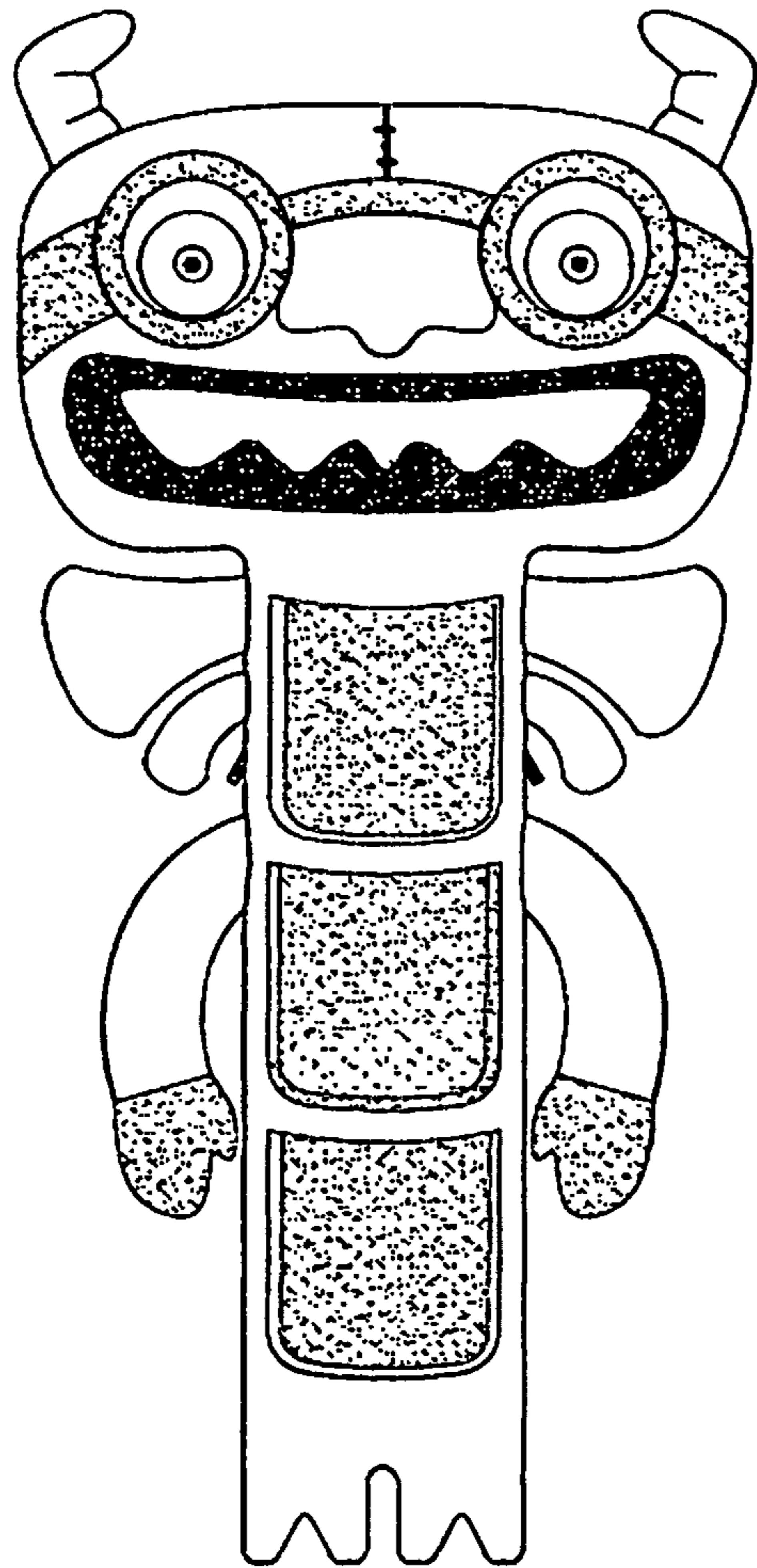

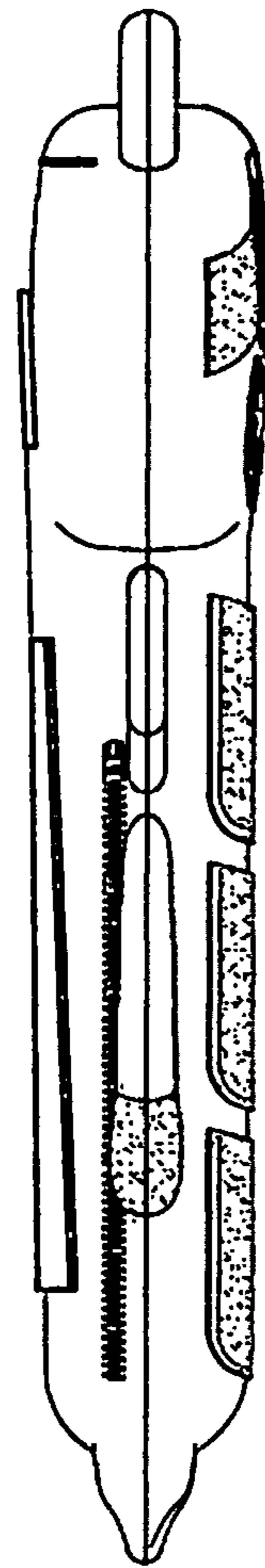

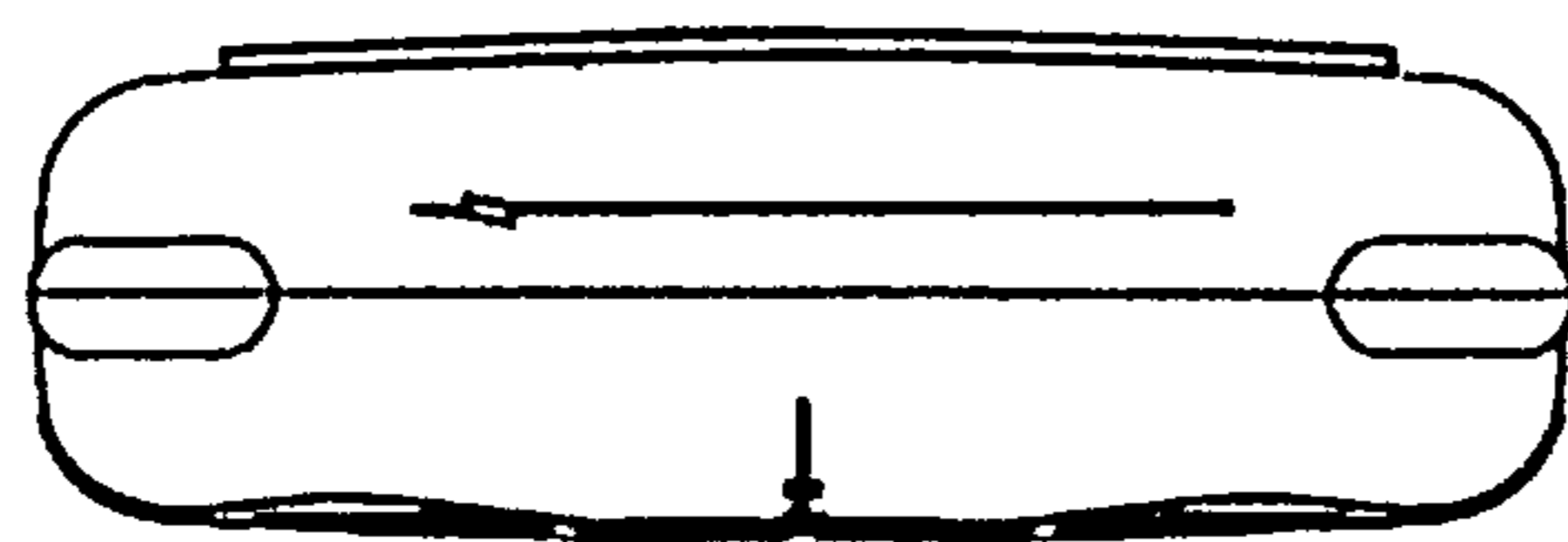

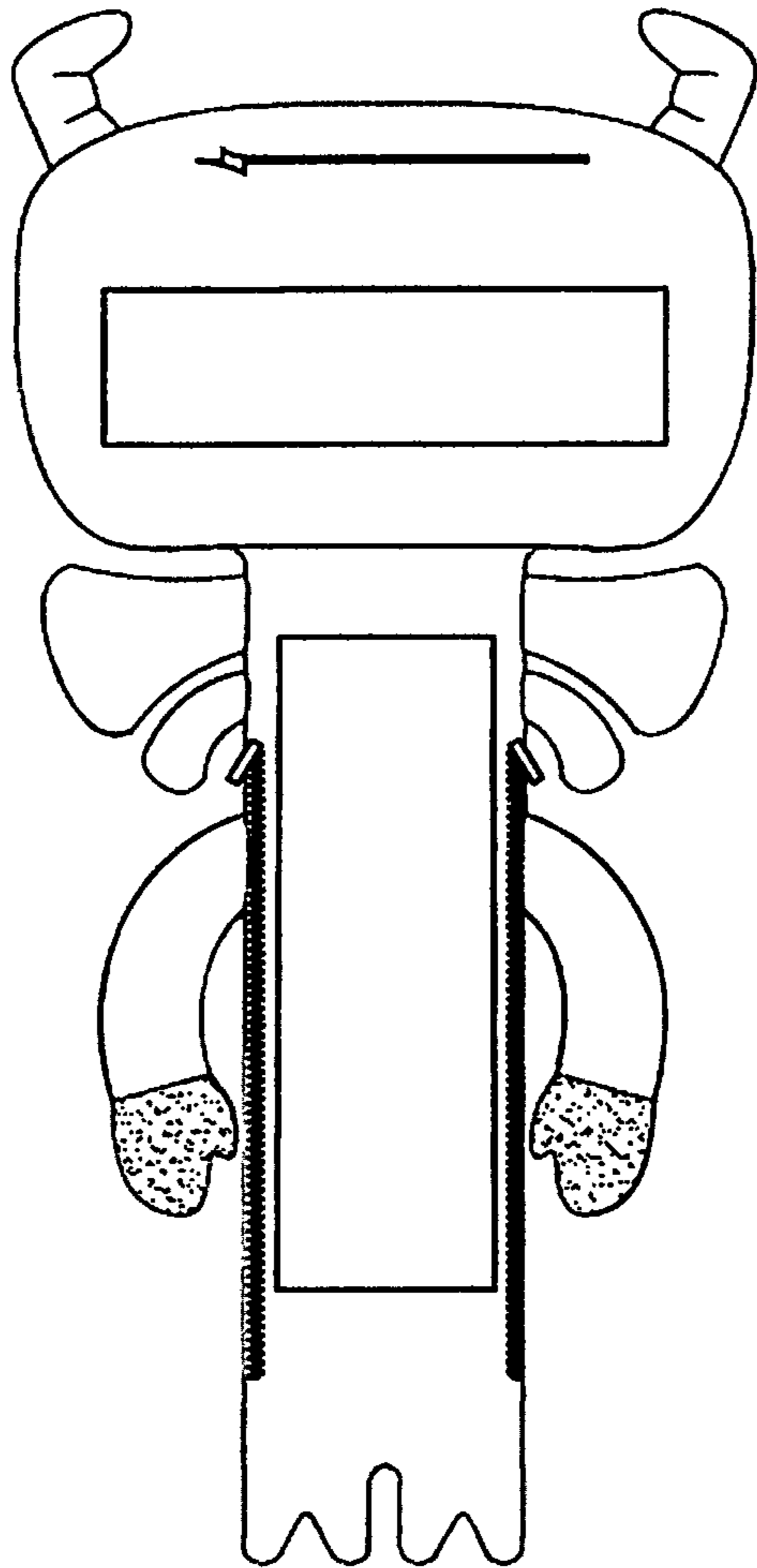

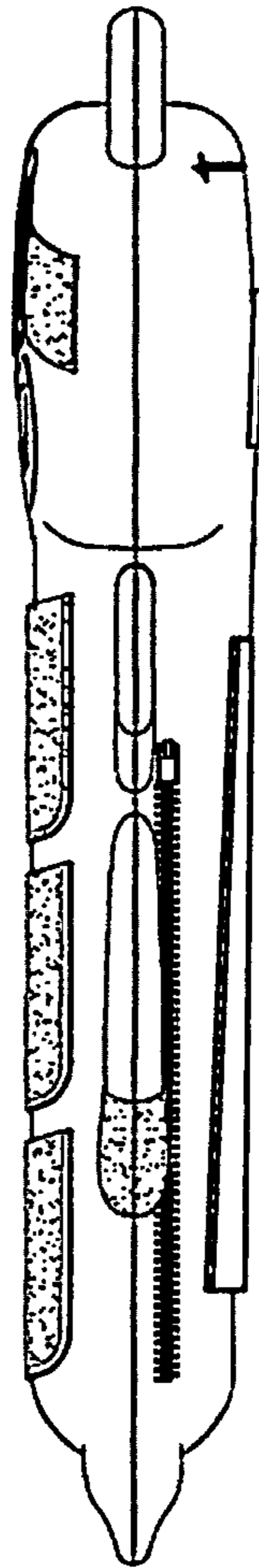

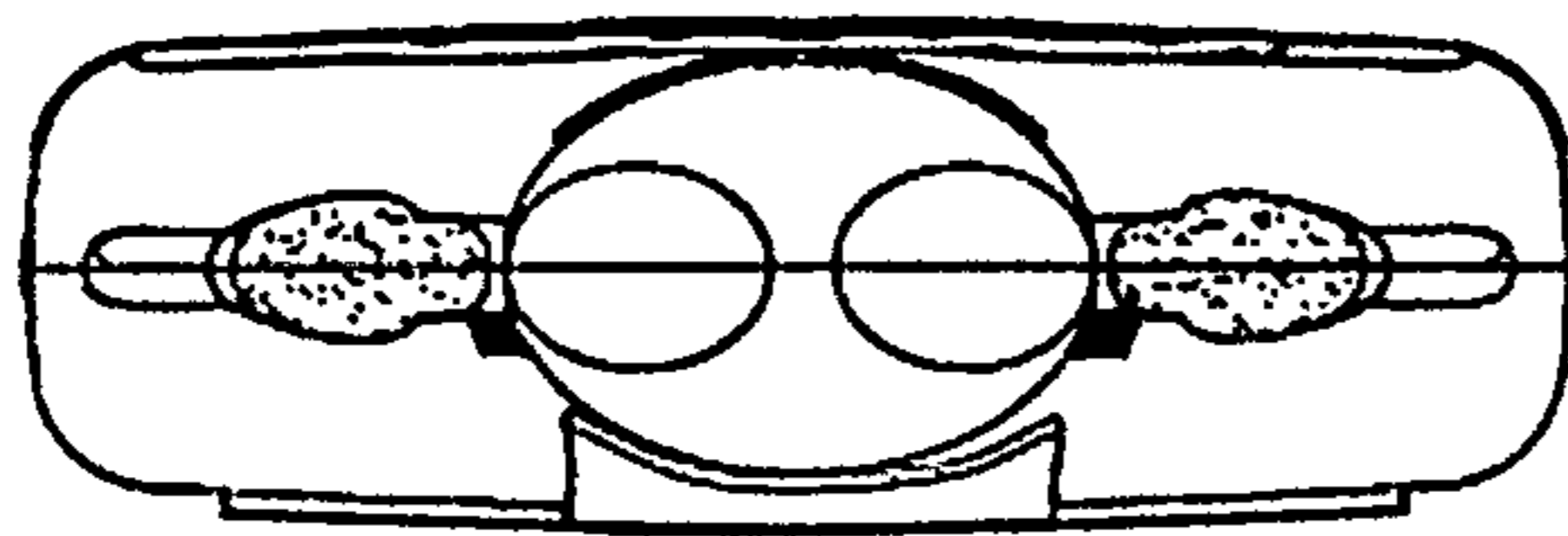
