FIG. 10 is right side view thereof;

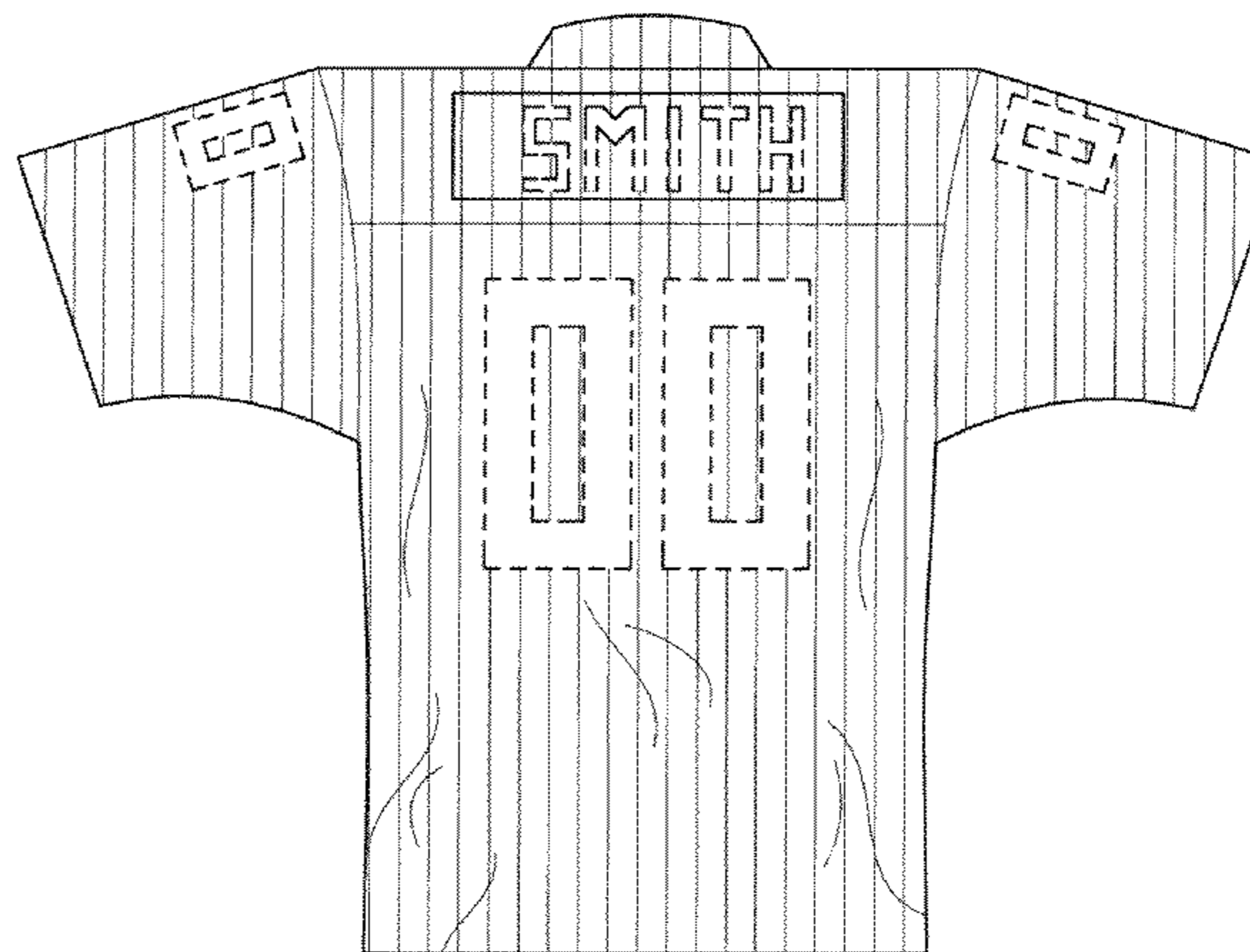
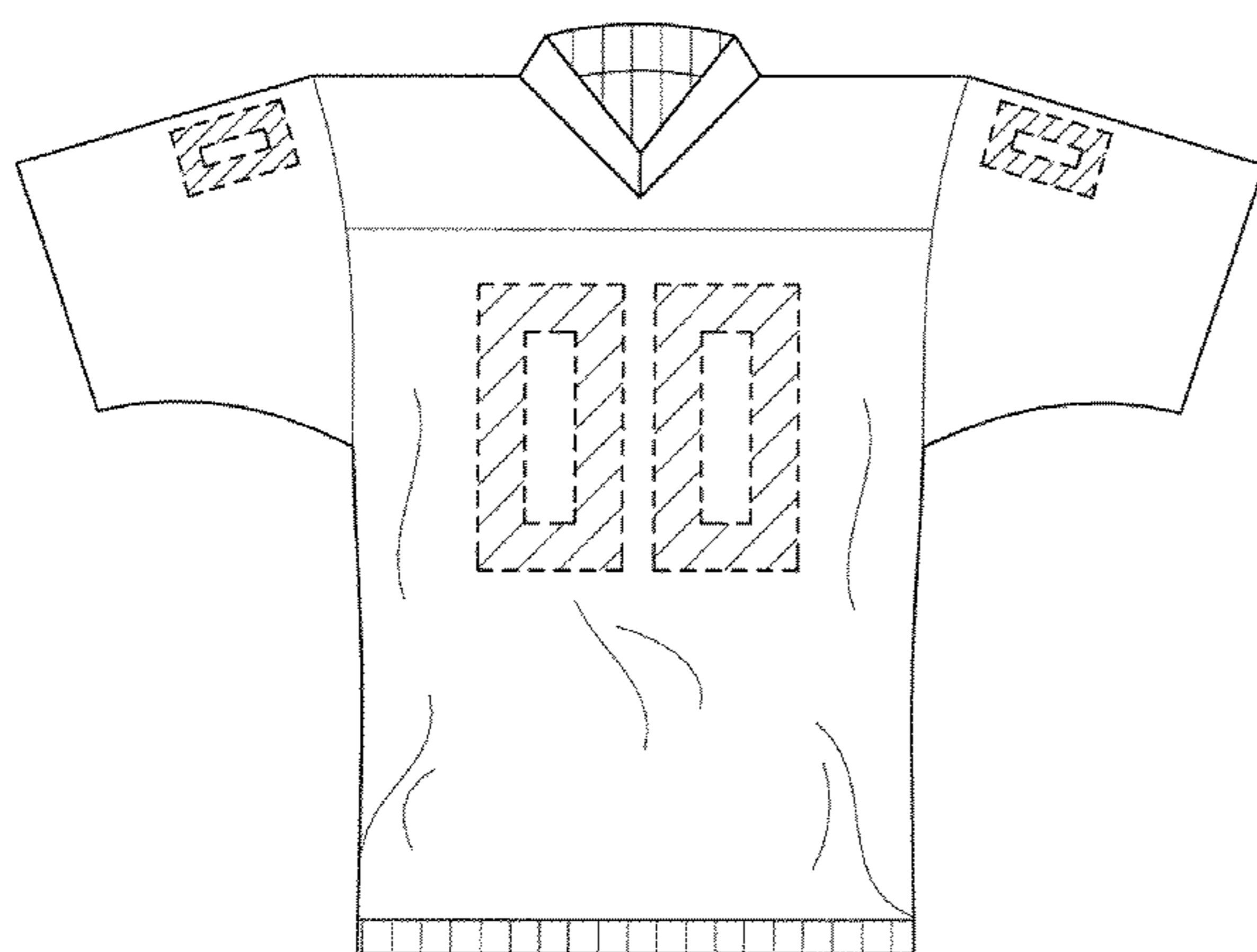
FIG. 11 is a top view thereof; and,
