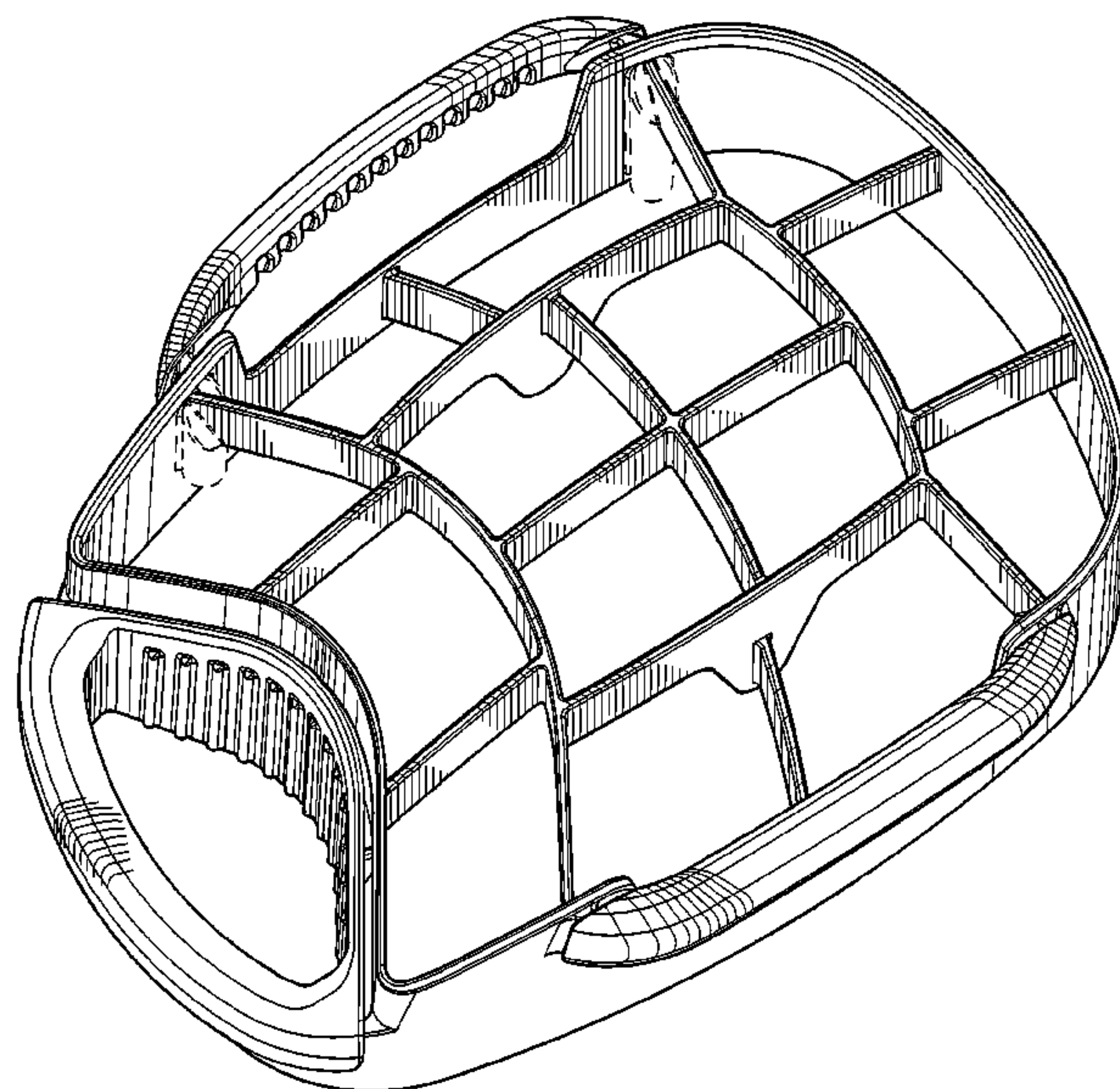
(57) **CLAIM**

The ornamental design for a golf bag top, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a golf bag top;  
FIG. 2 is a bottom perspective view of the golf bag top of FIG. 1;  
FIG. 3 is a front view of the golf bag top of FIG. 1;  
FIG. 4 is a rear view of the golf bag top of FIG. 1;  
FIG. 5 is a top view of the golf bag top of FIG. 1;  
FIG. 6 is a bottom view of the golf bag top of FIG. 1;  
FIG. 7 is a left side view of the golf bag top of FIG. 1; and,  
FIG. 8 is a right side view of the golf bag top of FIG. 1.  
The broken lines in FIGS. 1, 2, 5 and 6 illustrate portions of the golf bag top which form no part of the claimed design.

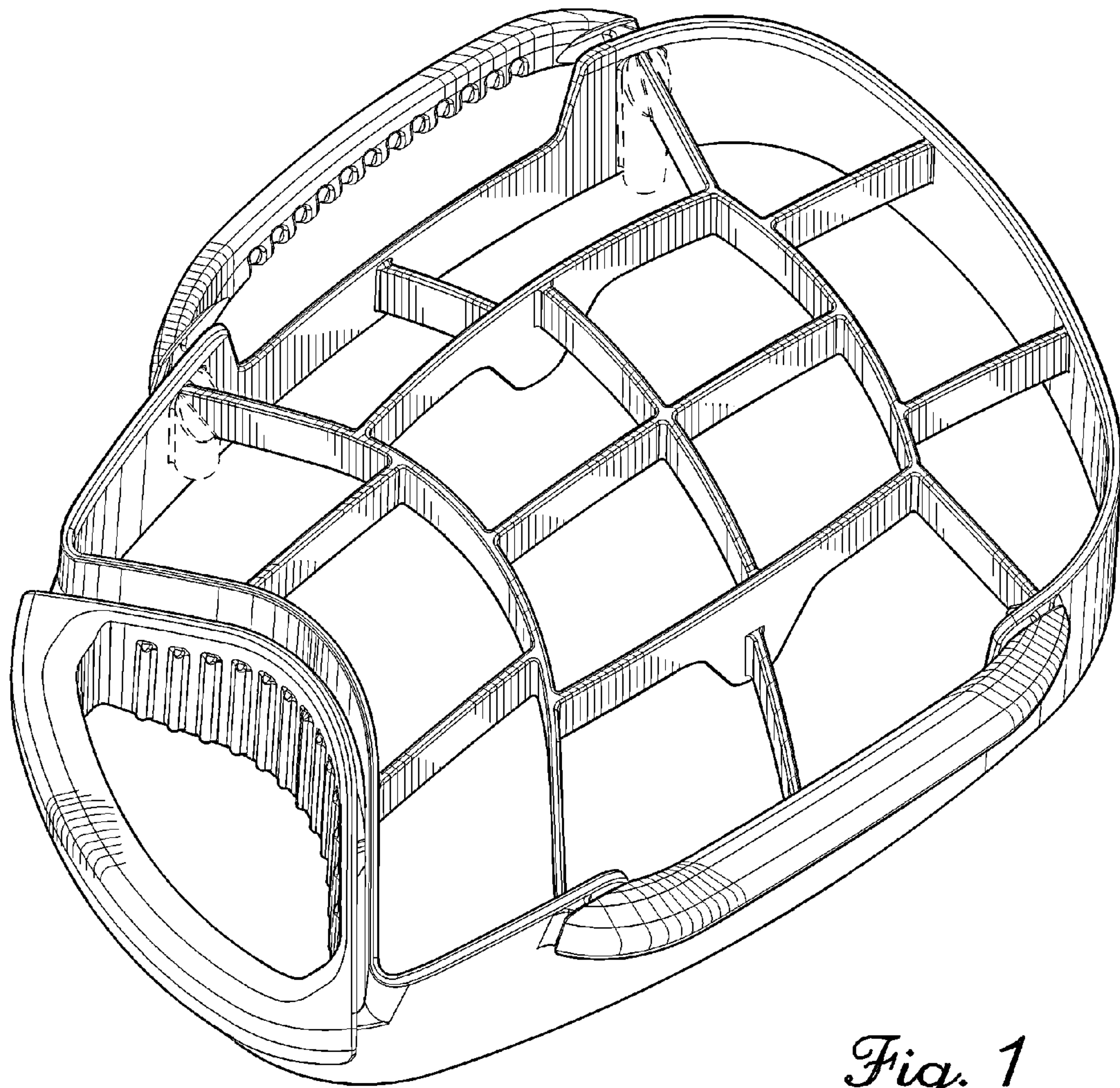

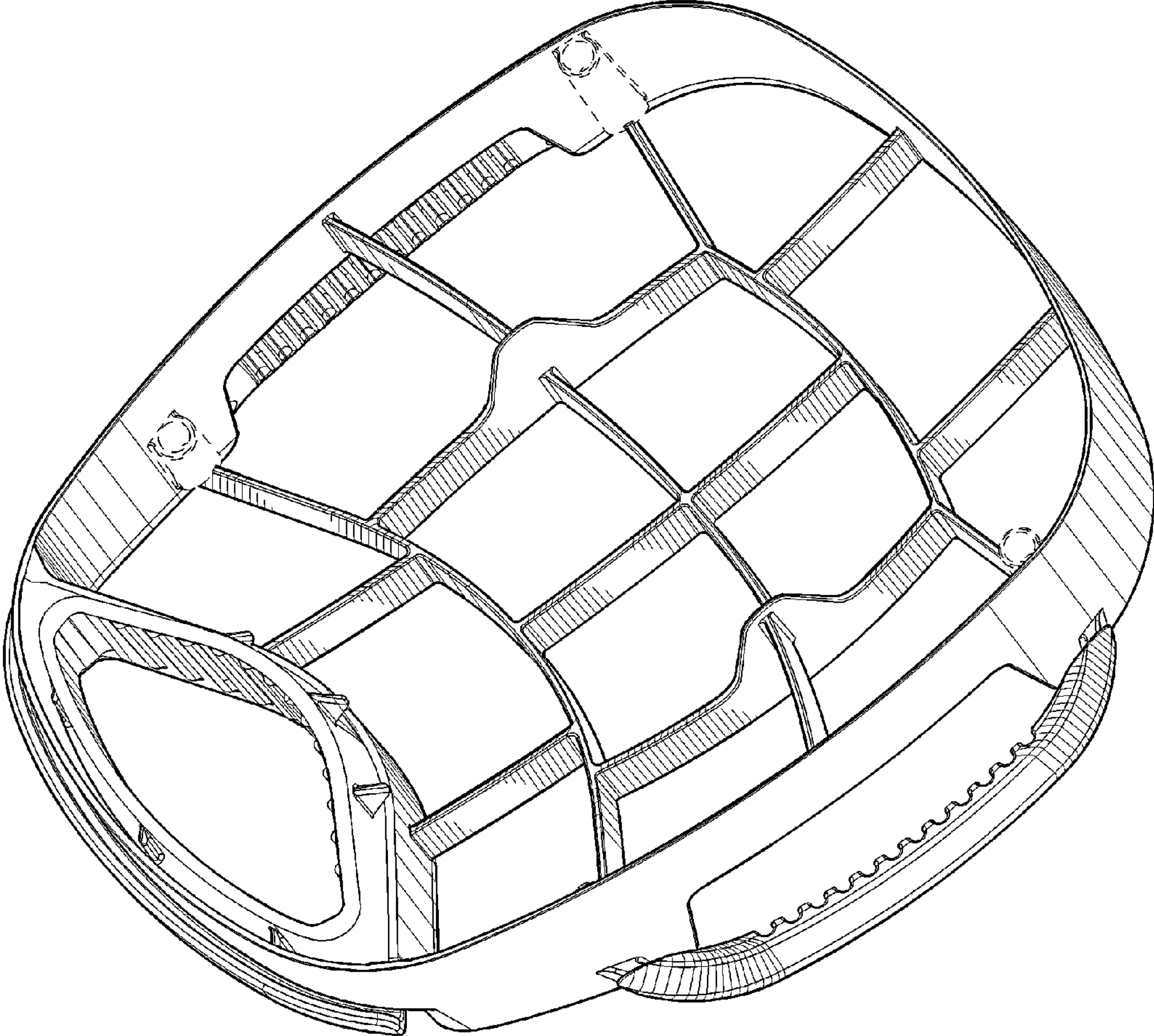

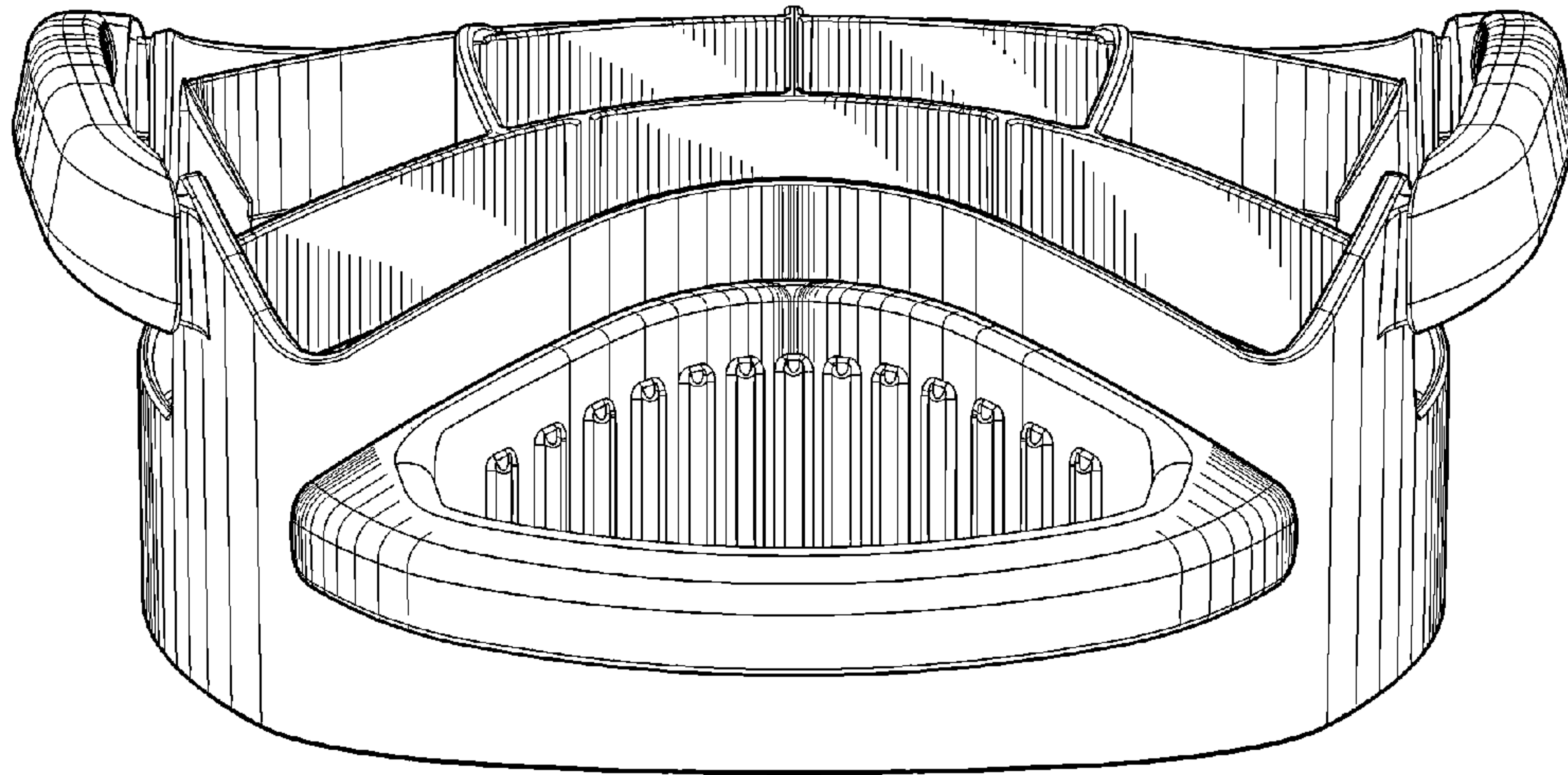




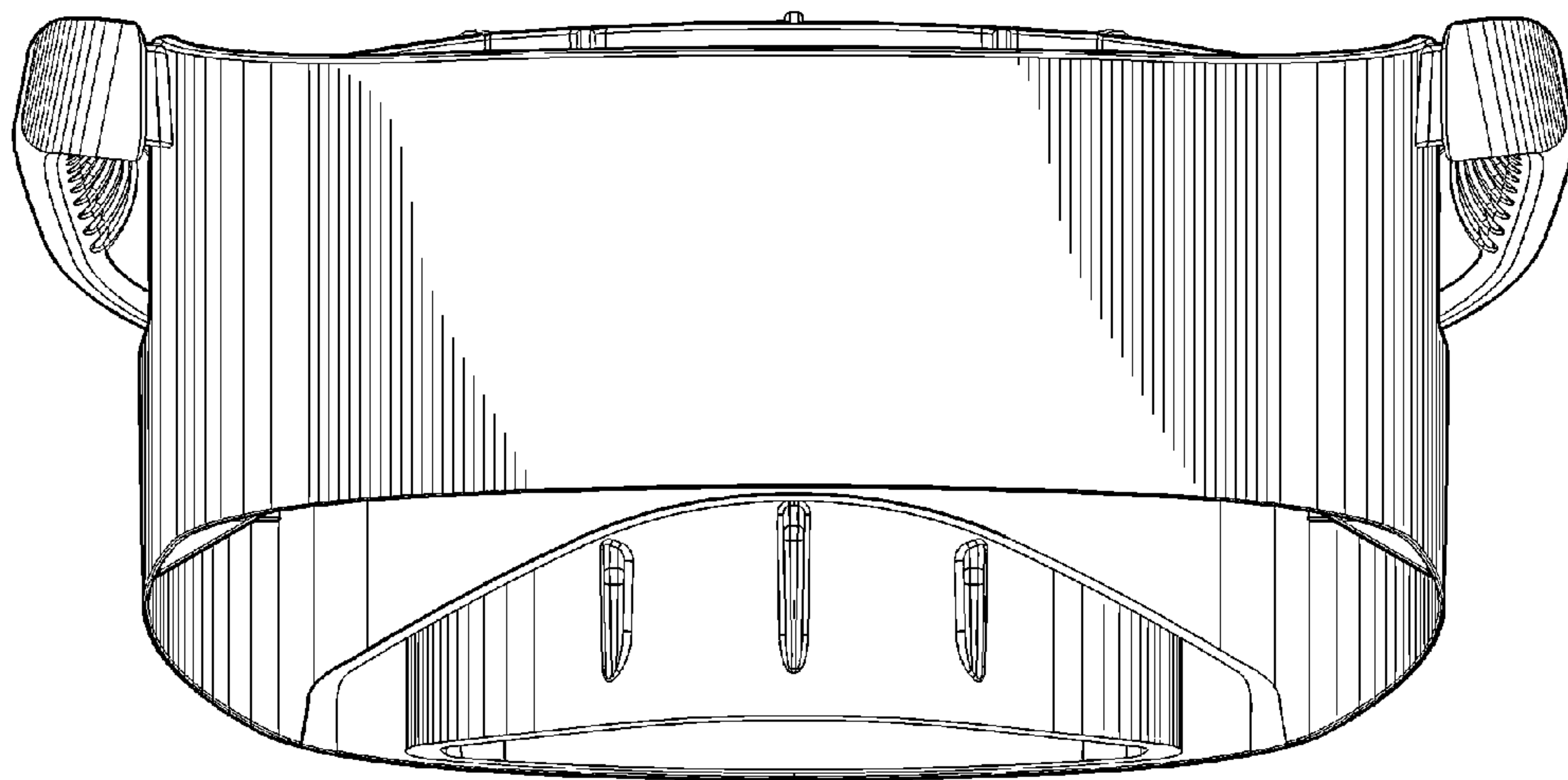

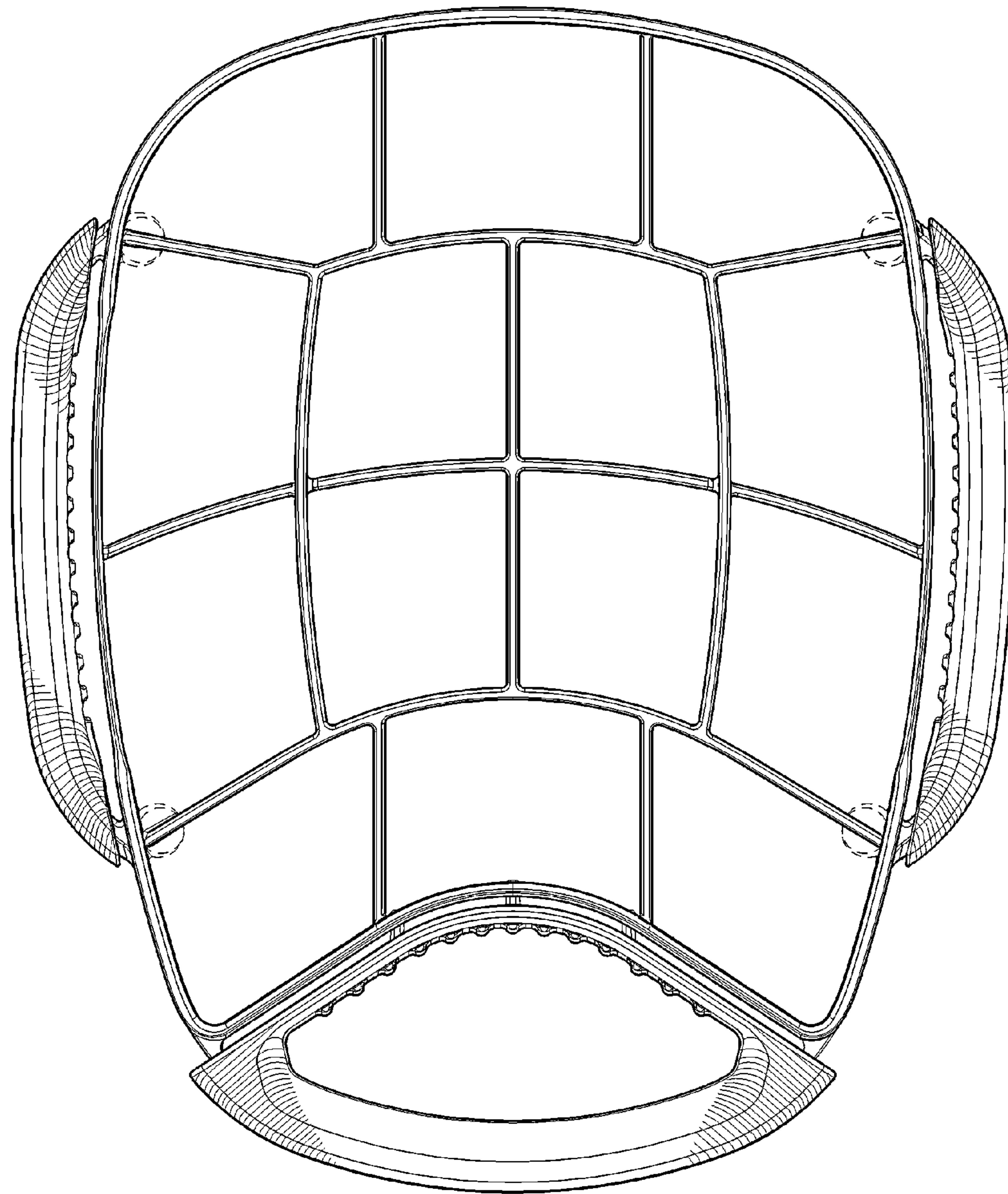

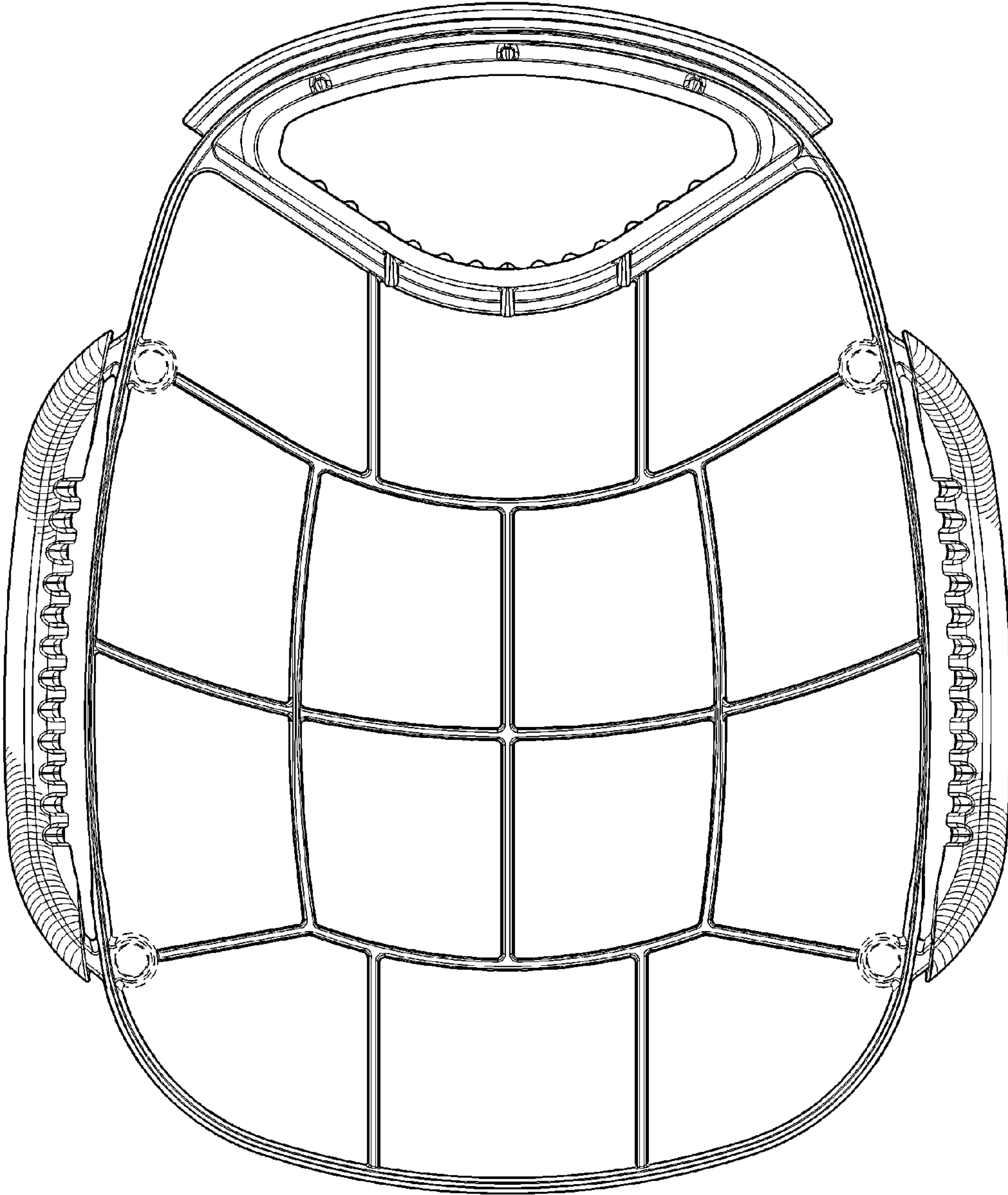

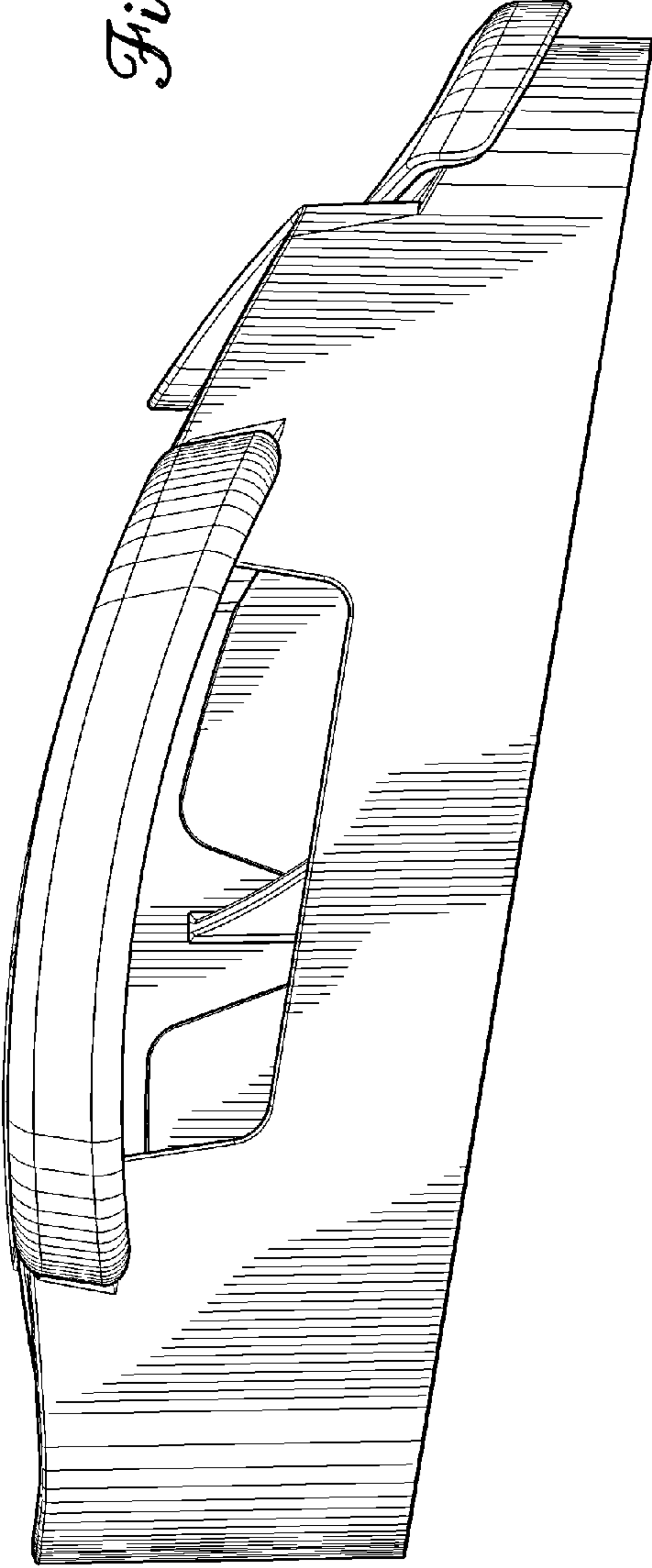
