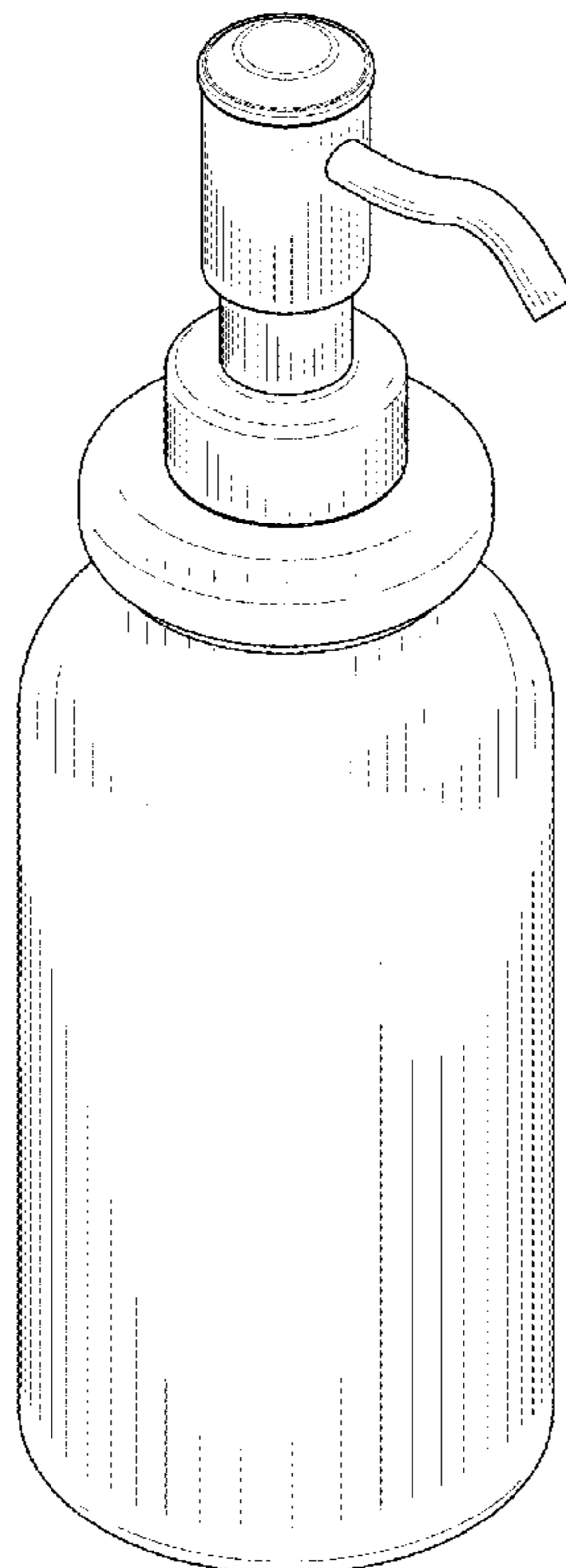
(57) **CLAIM**

I claim the ornamental design a dispenser, as shown and described.

**DESCRIPTION**

FIG. 1 is a rear/right/bottom perspective view of a dispenser; FIG. 2 is a front/left/top perspective view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a right side elevational view thereof; FIG. 6 is a left side elevational view thereof; FIG. 7 is a top plan view thereof; and, FIG. 8 is a bottom plan view thereof. 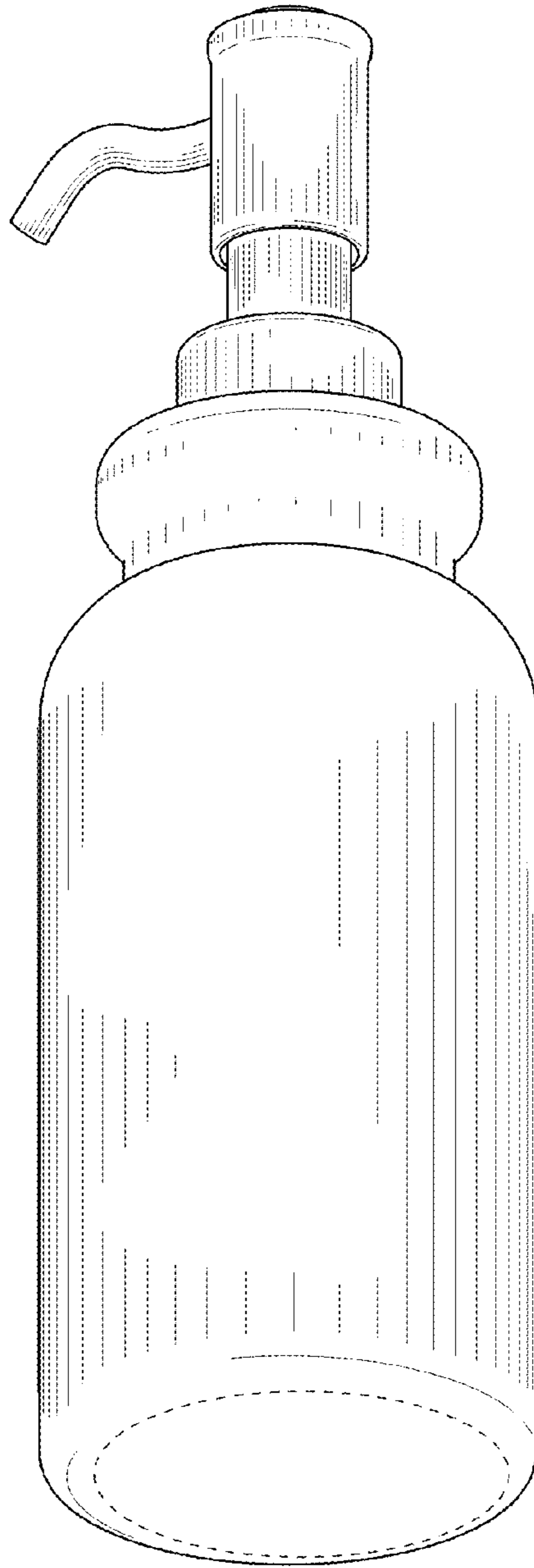

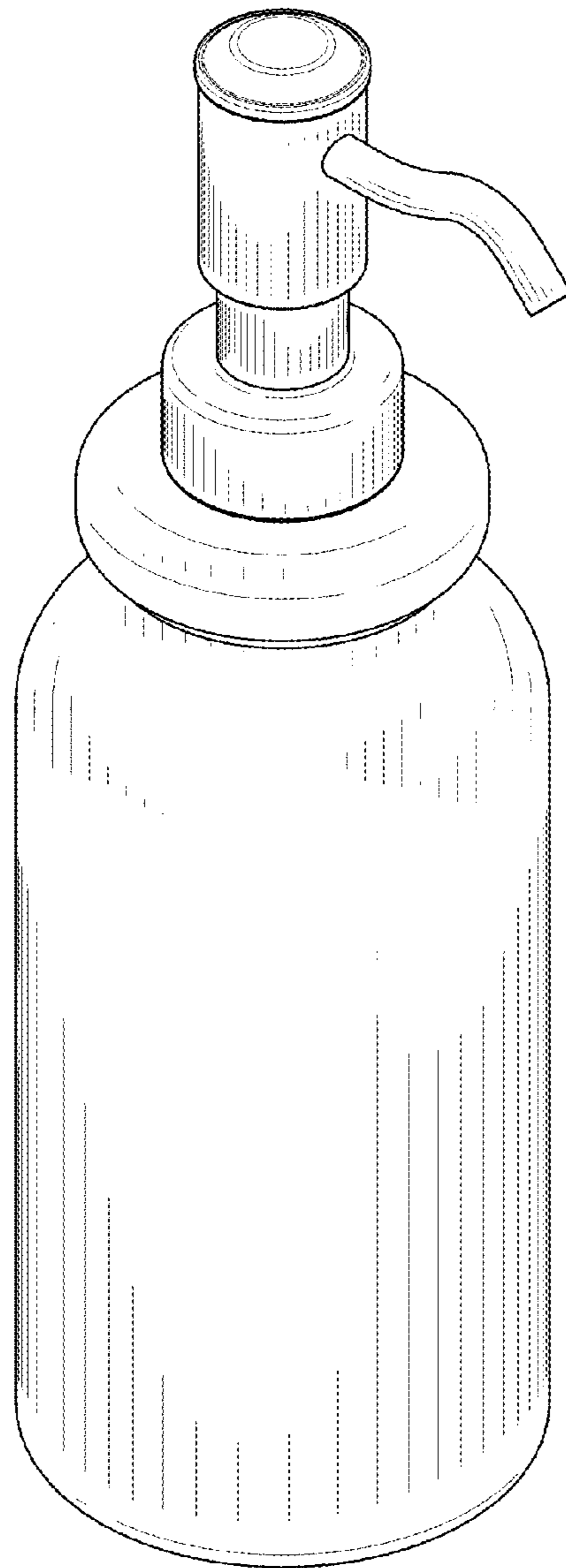

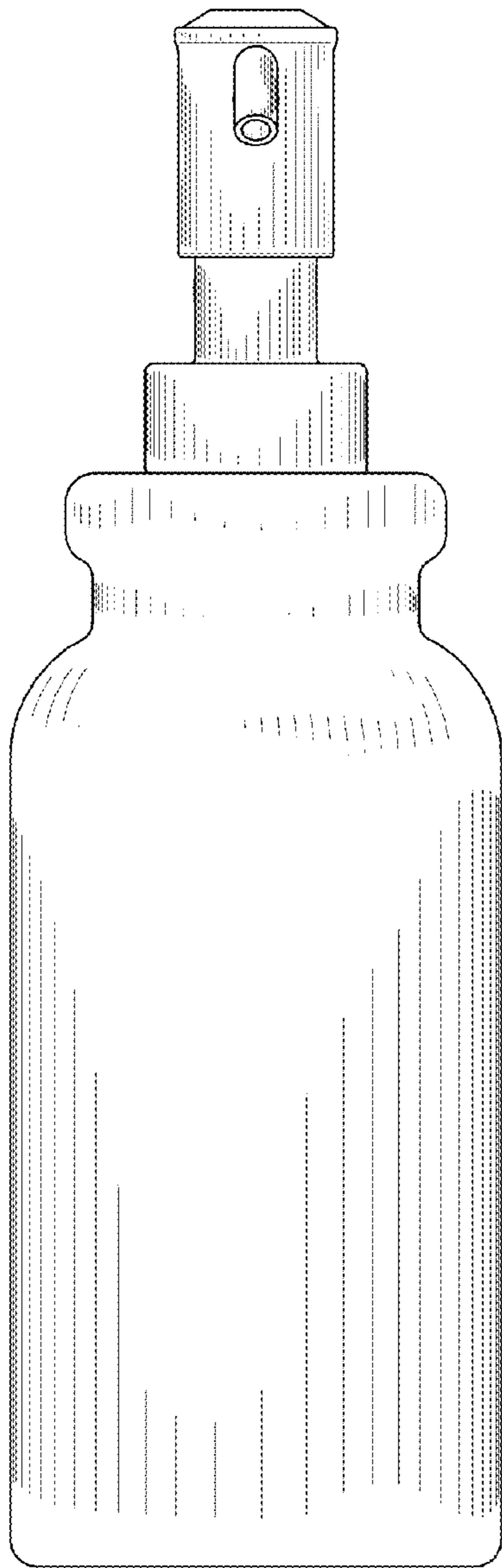

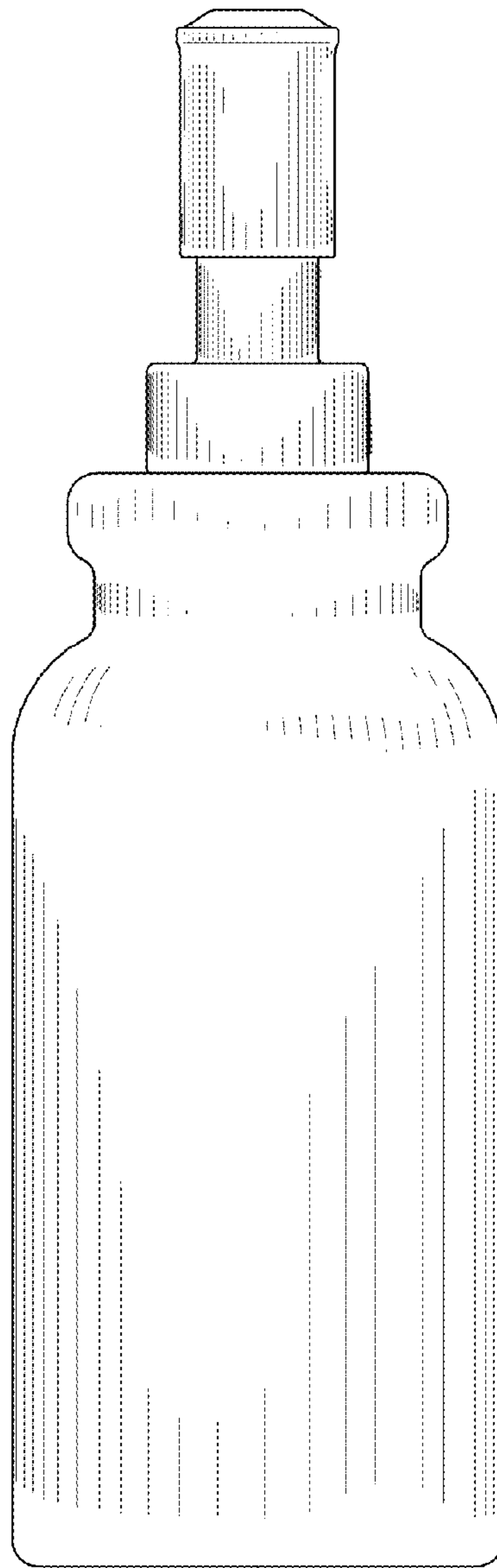

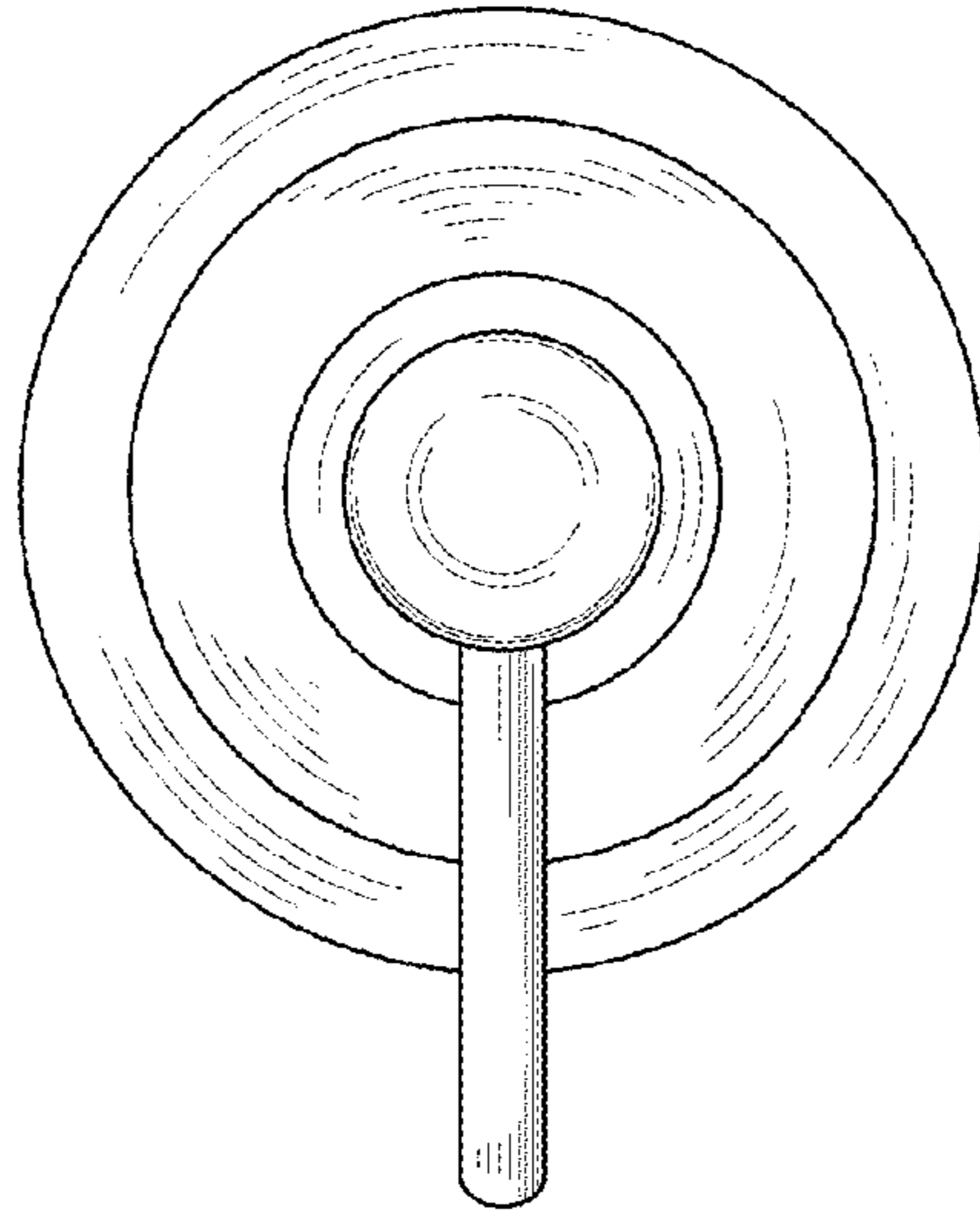

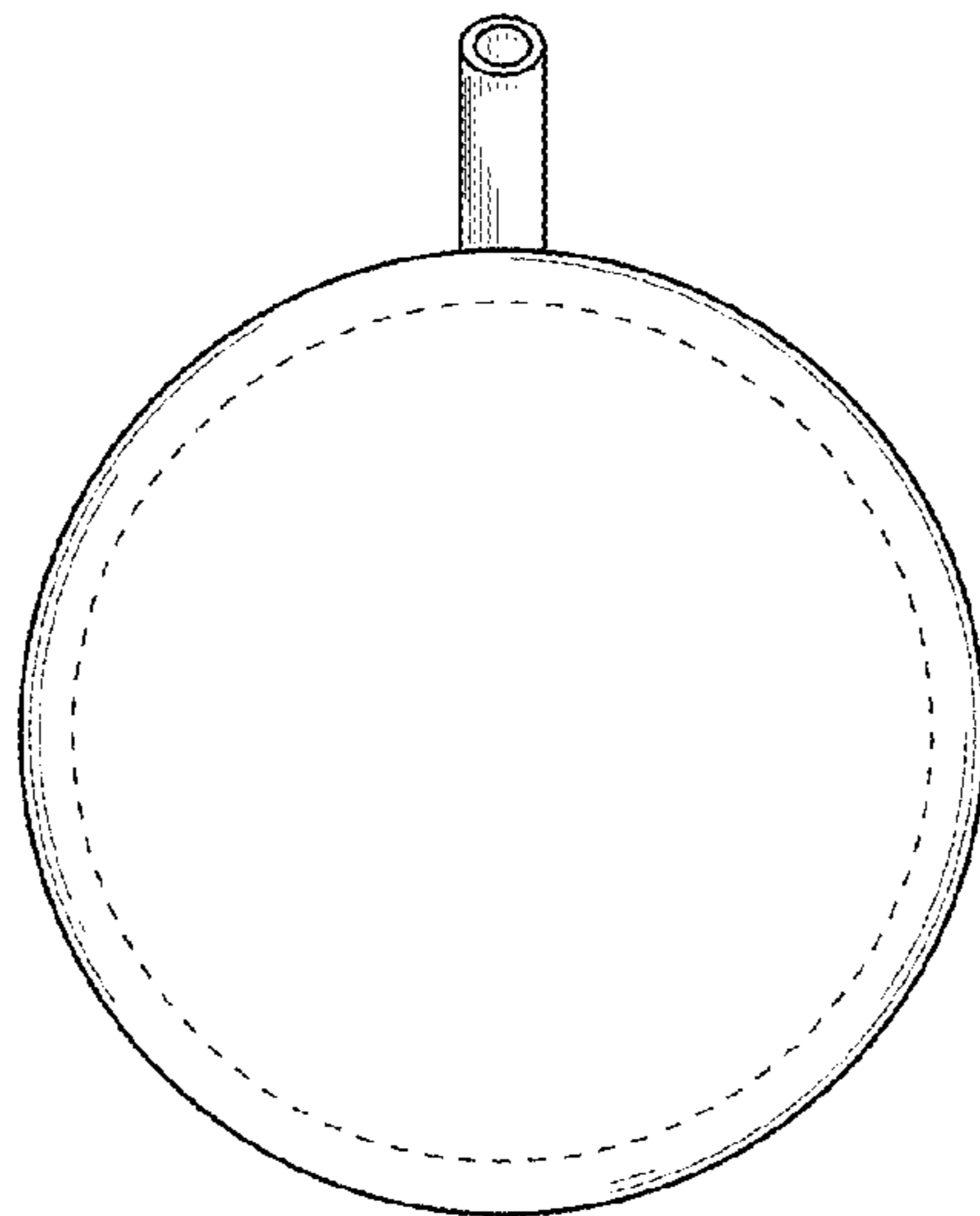
