**DESCRIPTION**

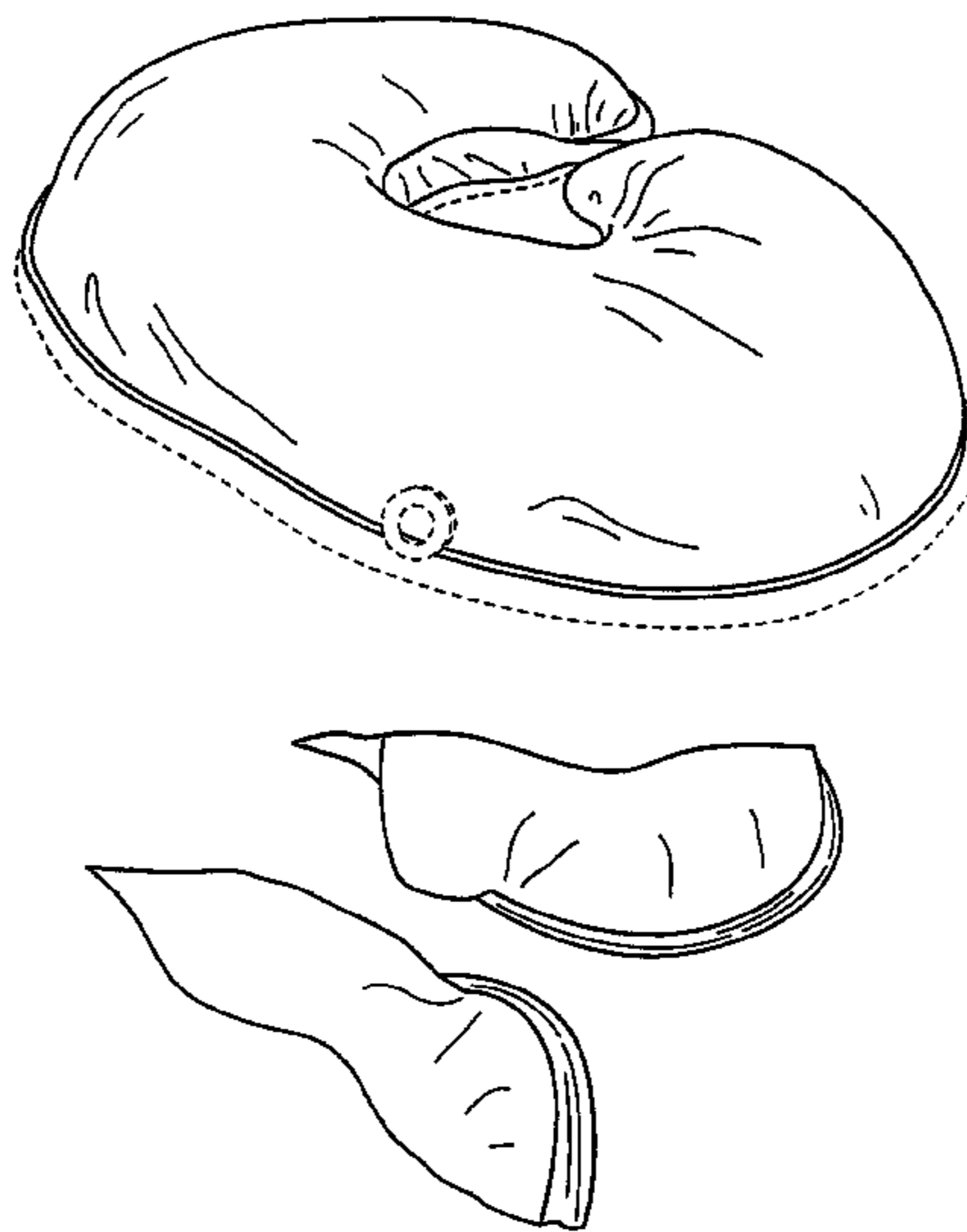
FIG. 1 is a perspective view of the pillow with edging from the front.  
 FIG. 2 is a view of two ends of the arms of the pillow with edging of FIG. 1.  
 FIG. 3 is another perspective view from the front showing a user in phantom line; and,

 The portions shown in phantom line are not included as part of the claimed design.  
 Areas not shown, including the bottom and the sides in the inner well region, form no part of the claimed design.

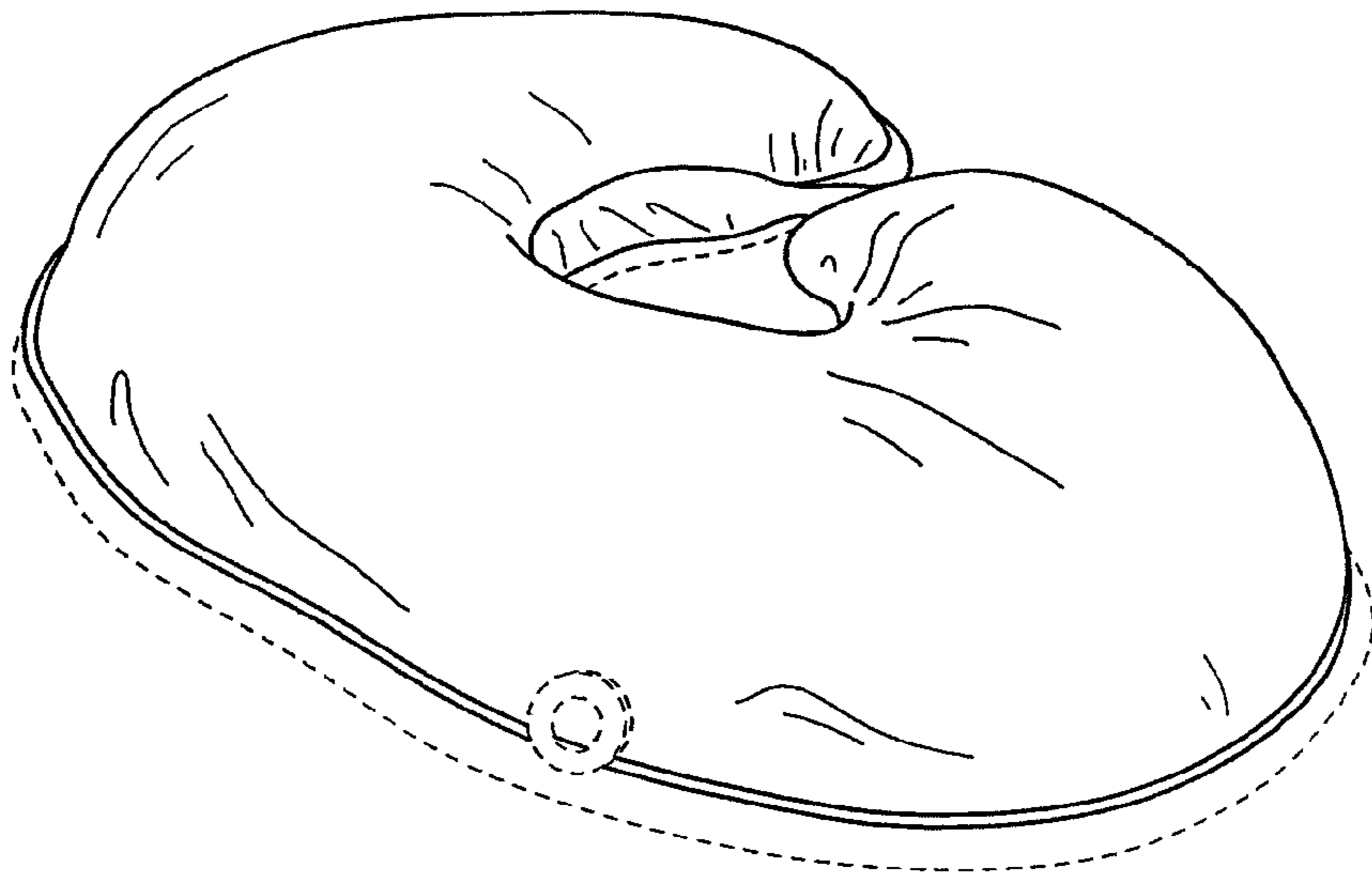

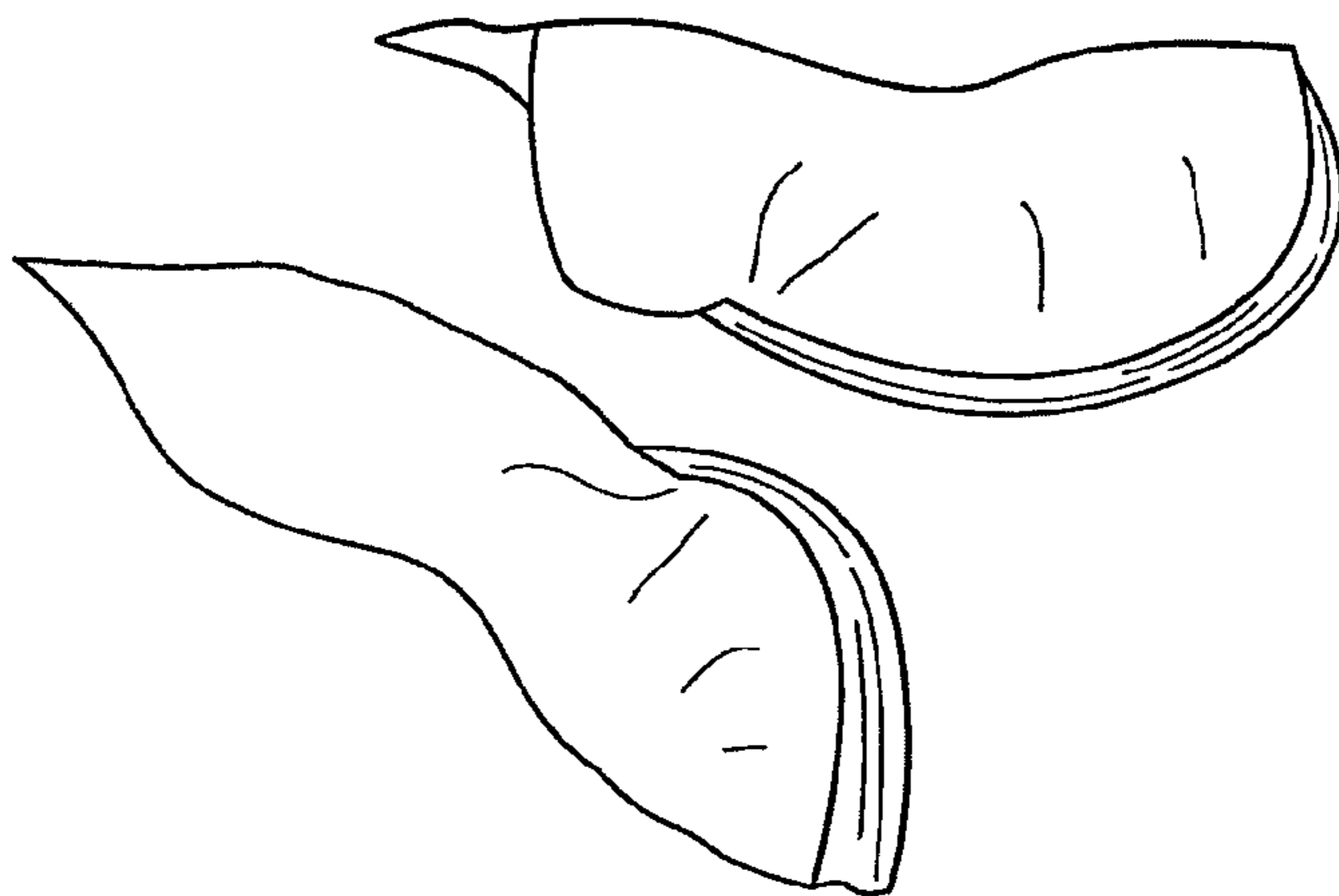

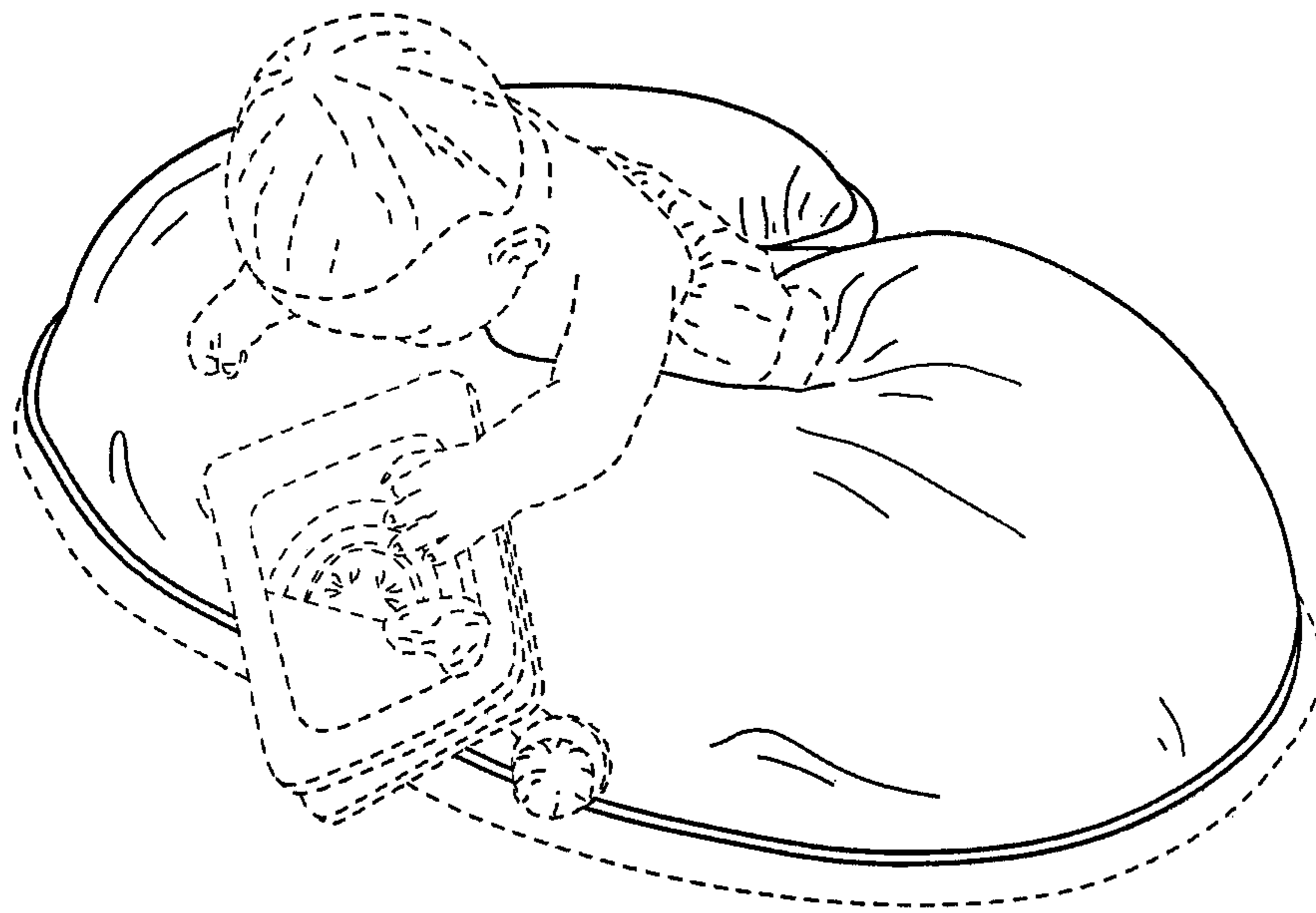

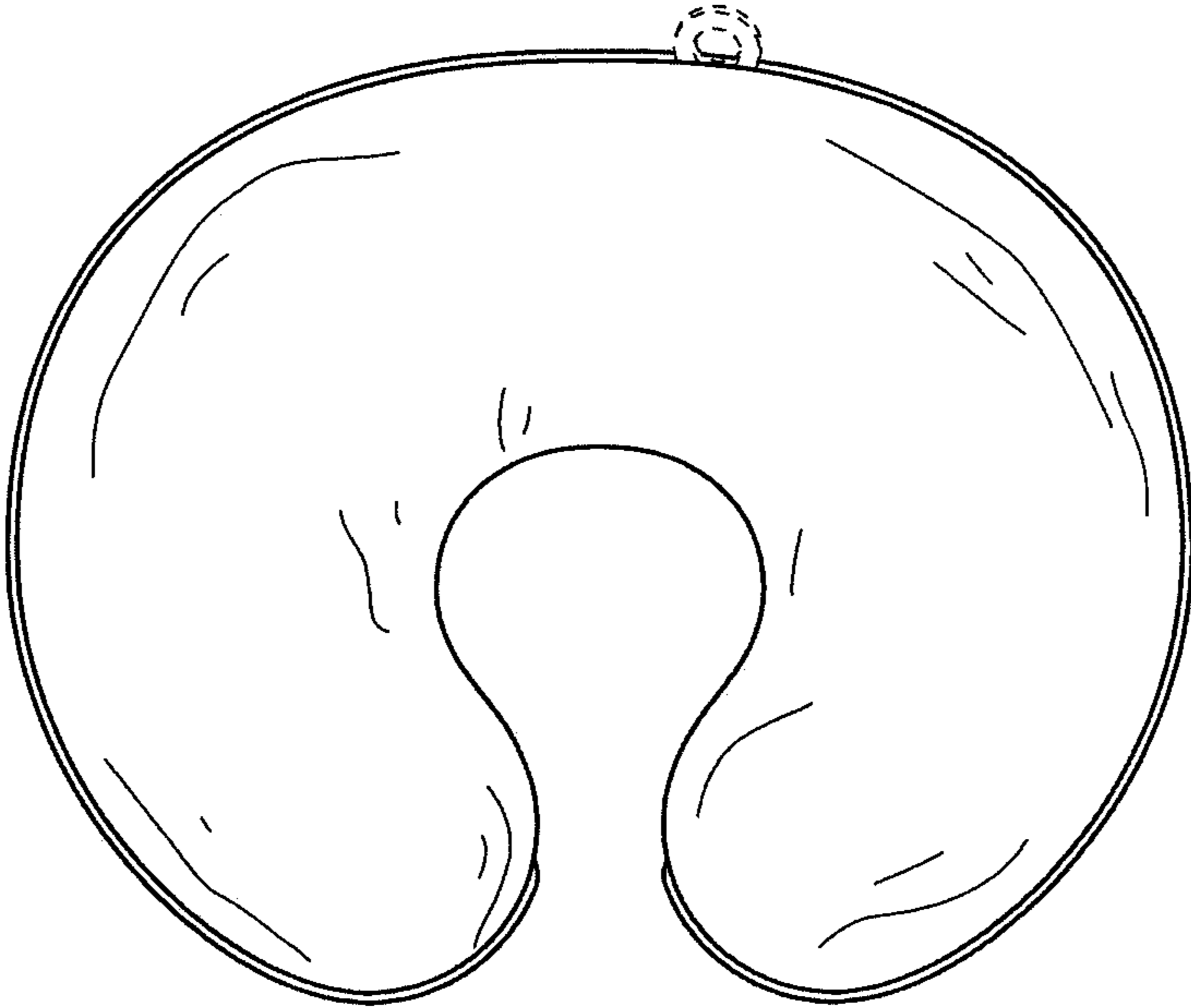
