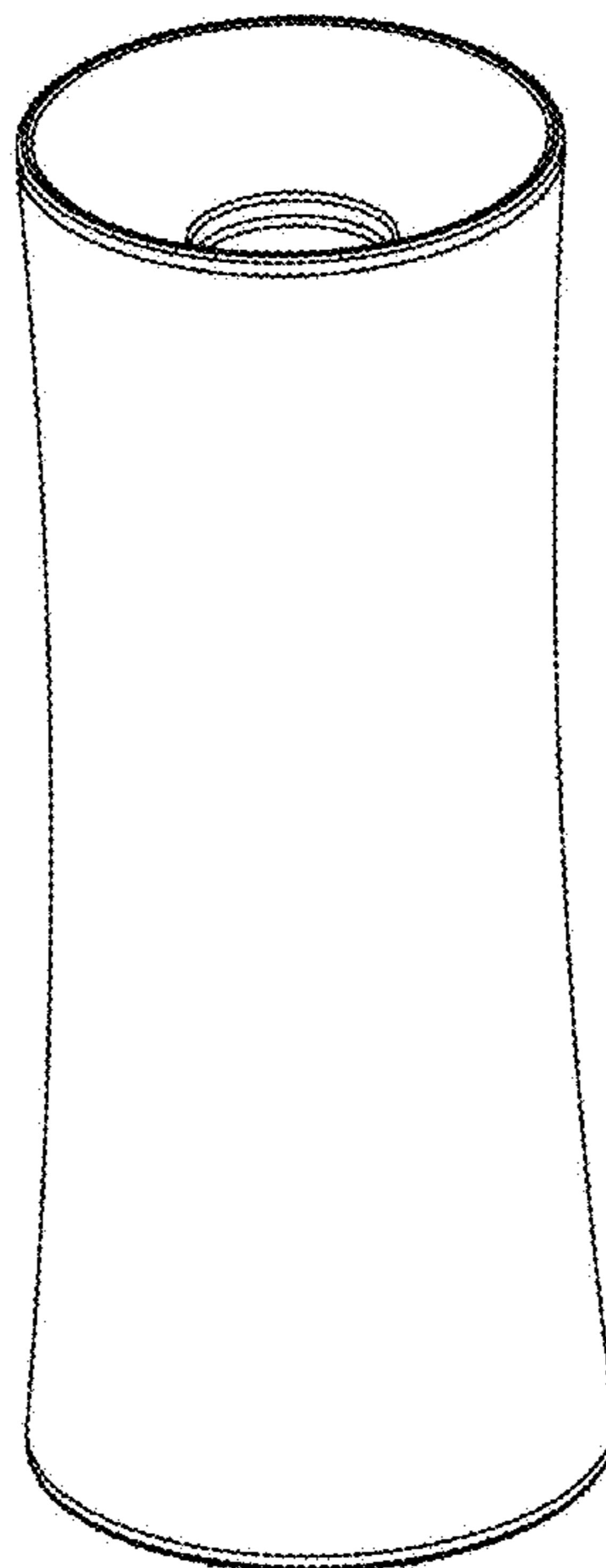
The ornamental design for an egg cooker, as shown and described.

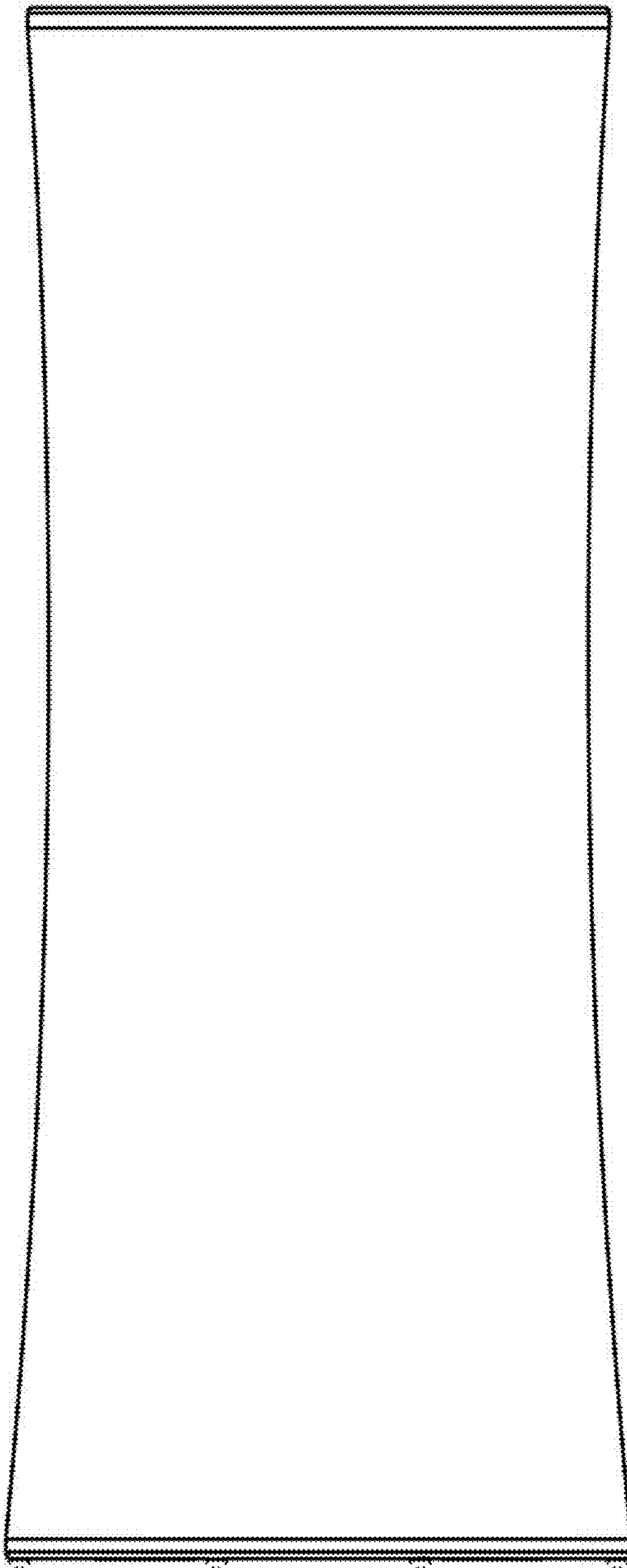

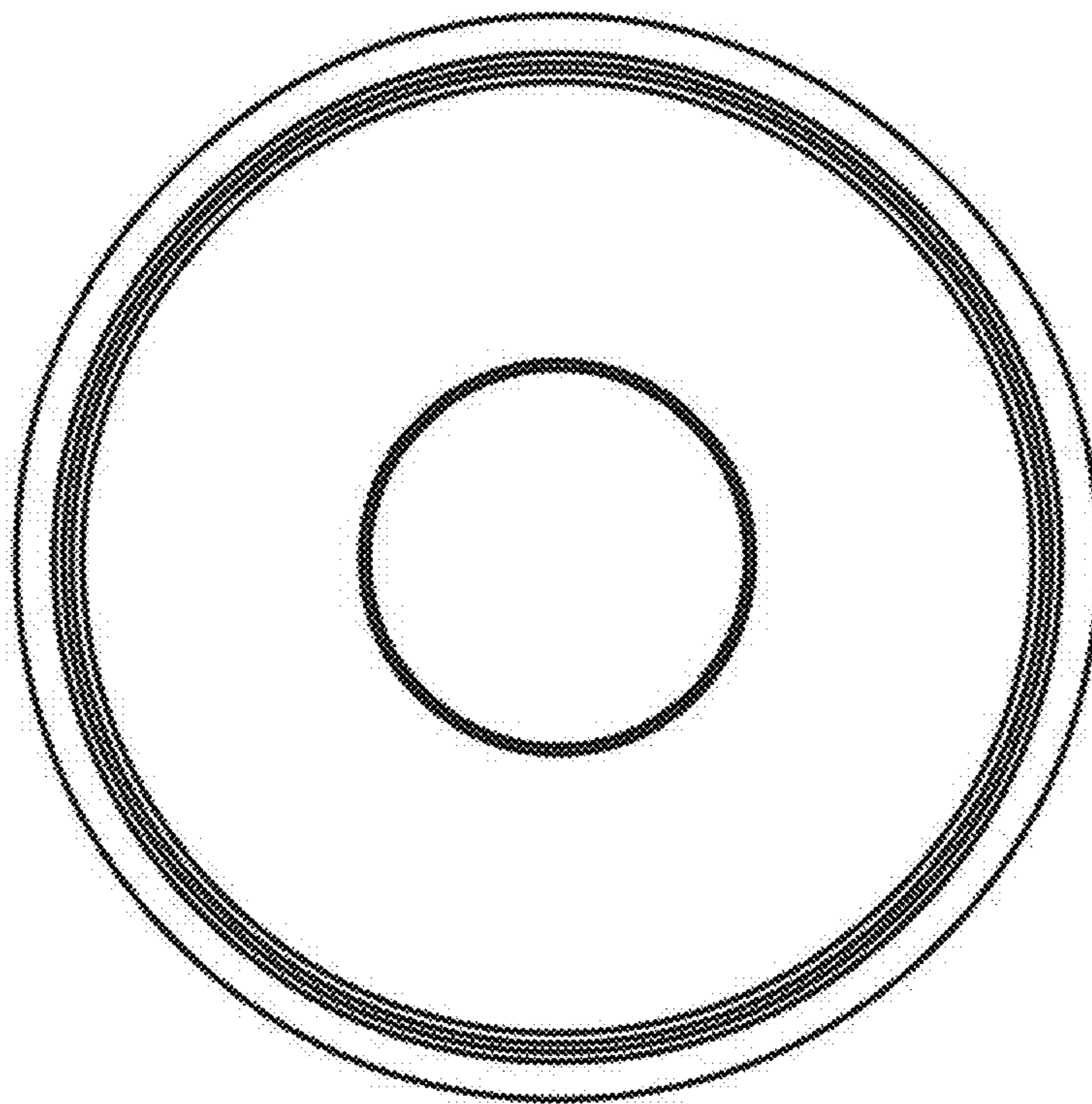

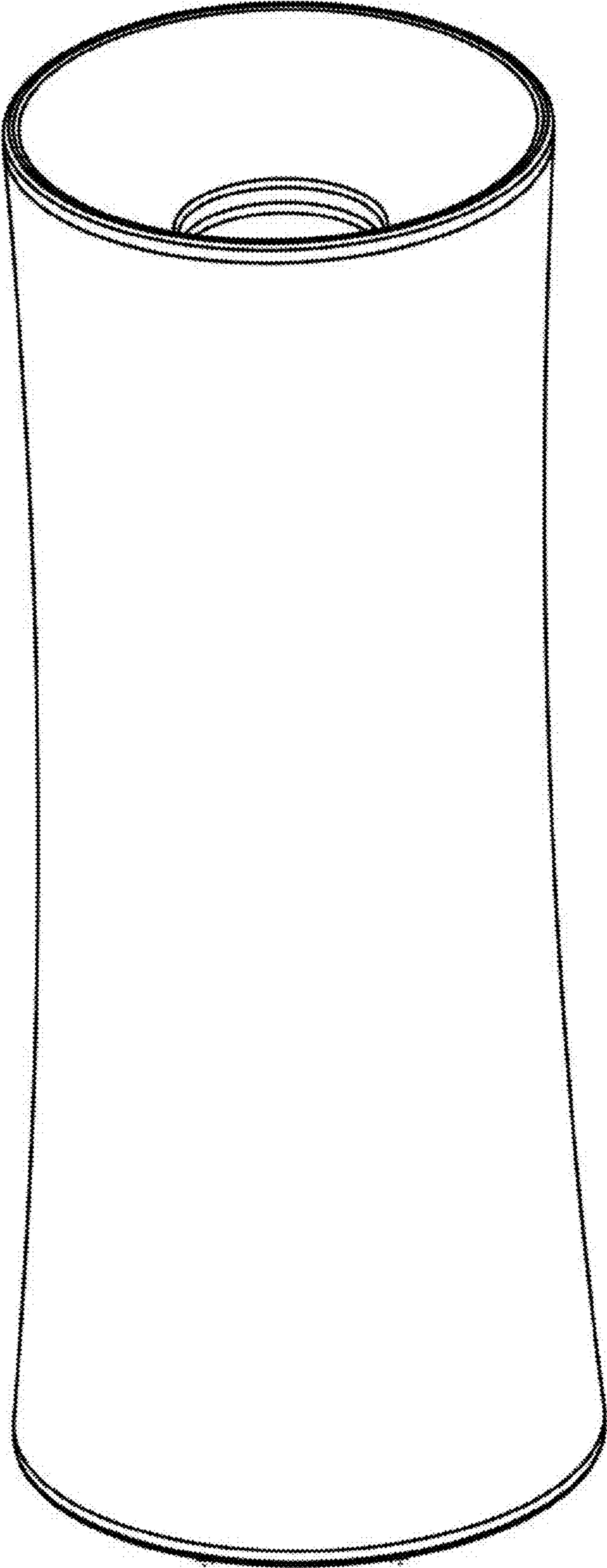
