**DESCRIPTION**

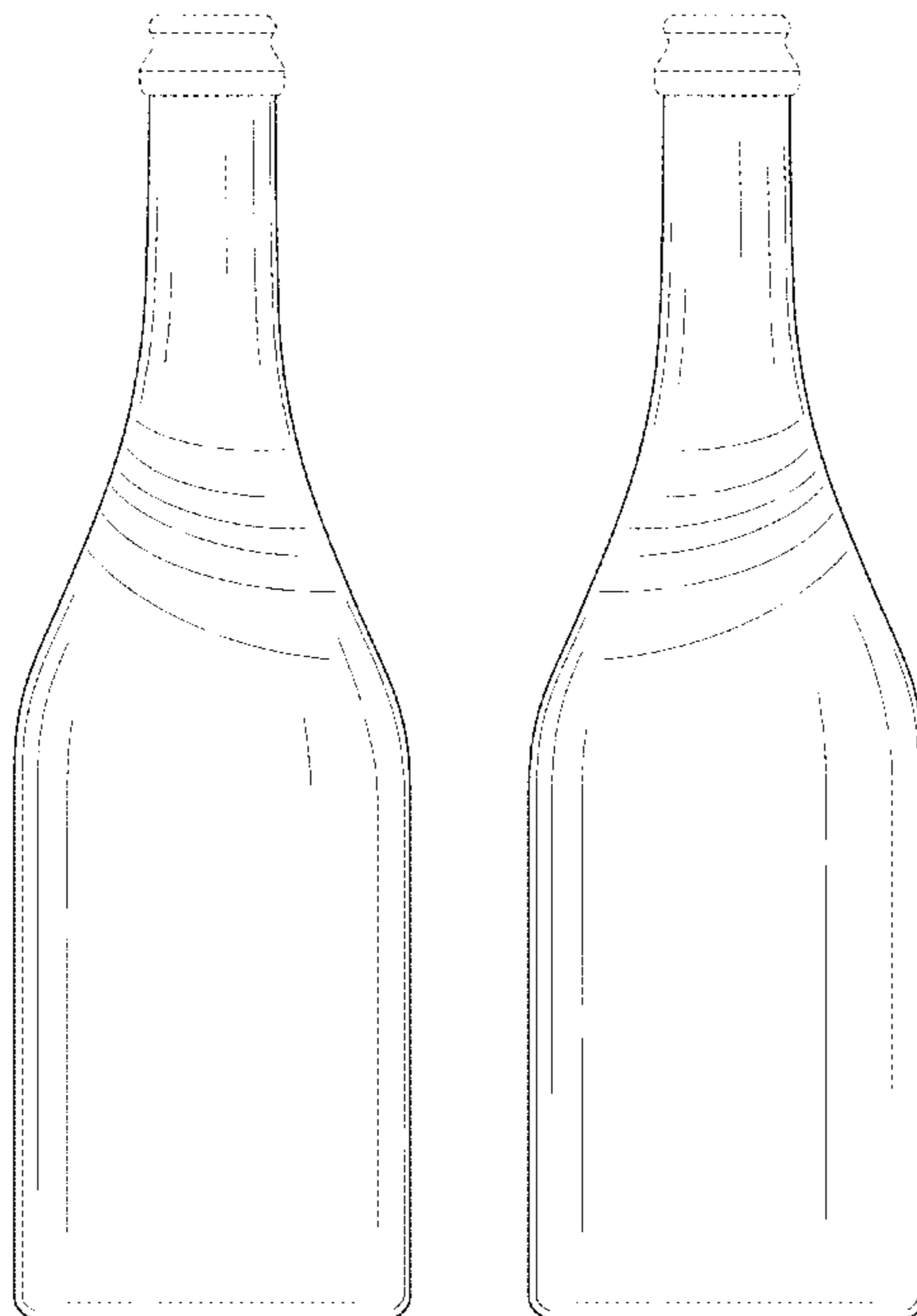
The broken line depicting the bottle top shows unclaimed subject matter.

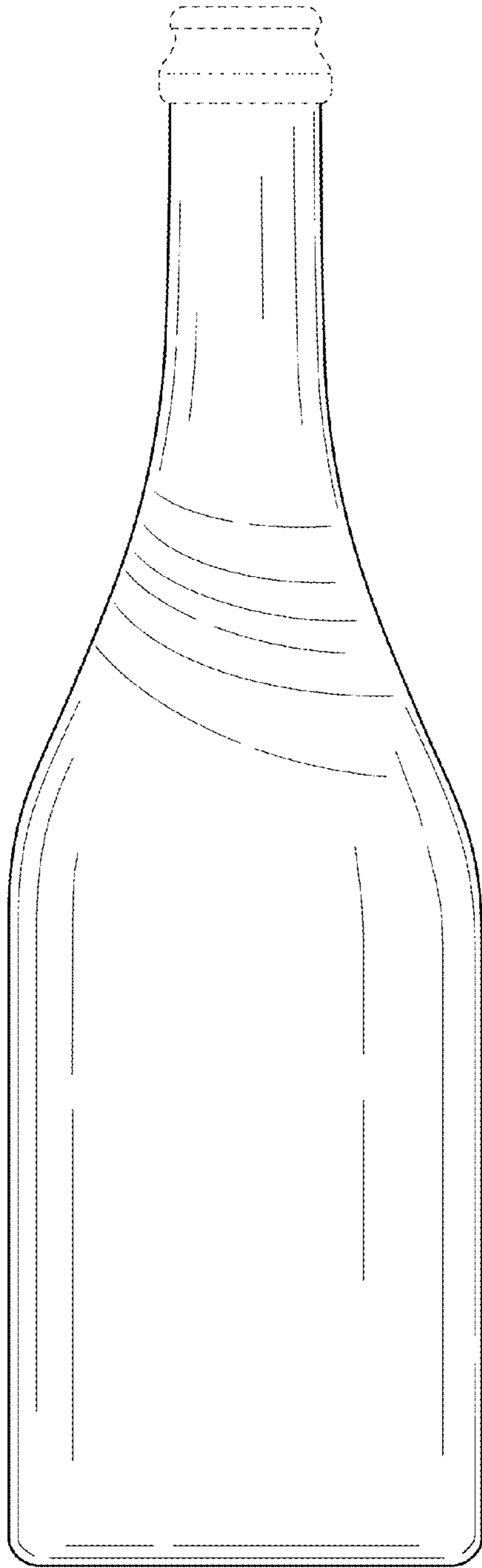

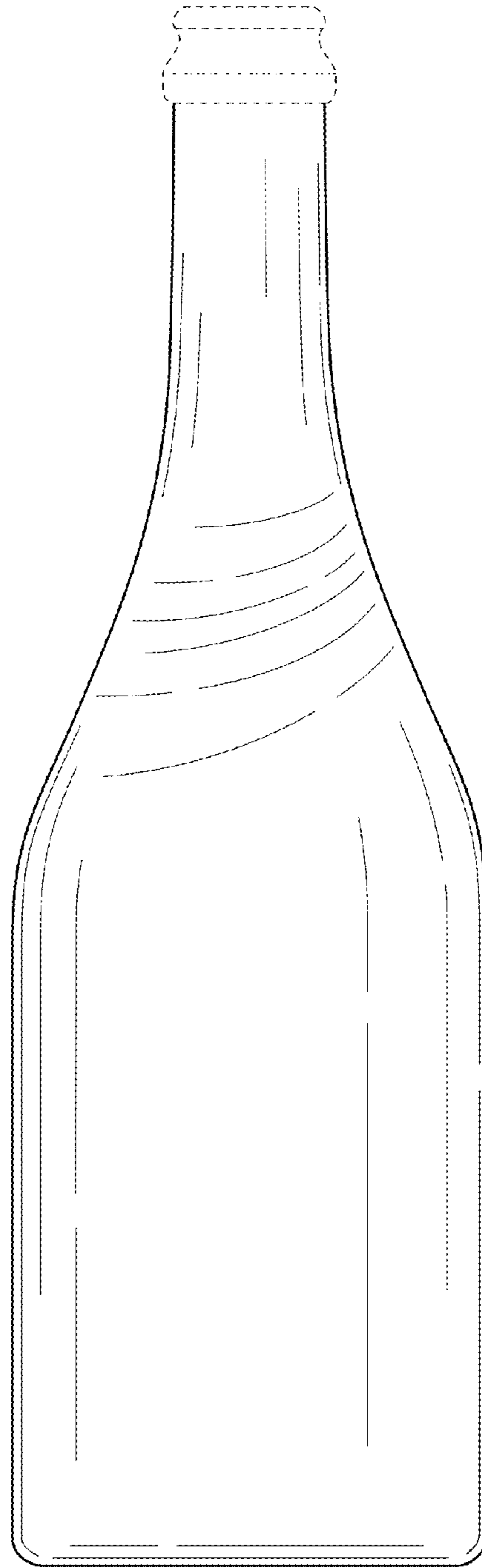

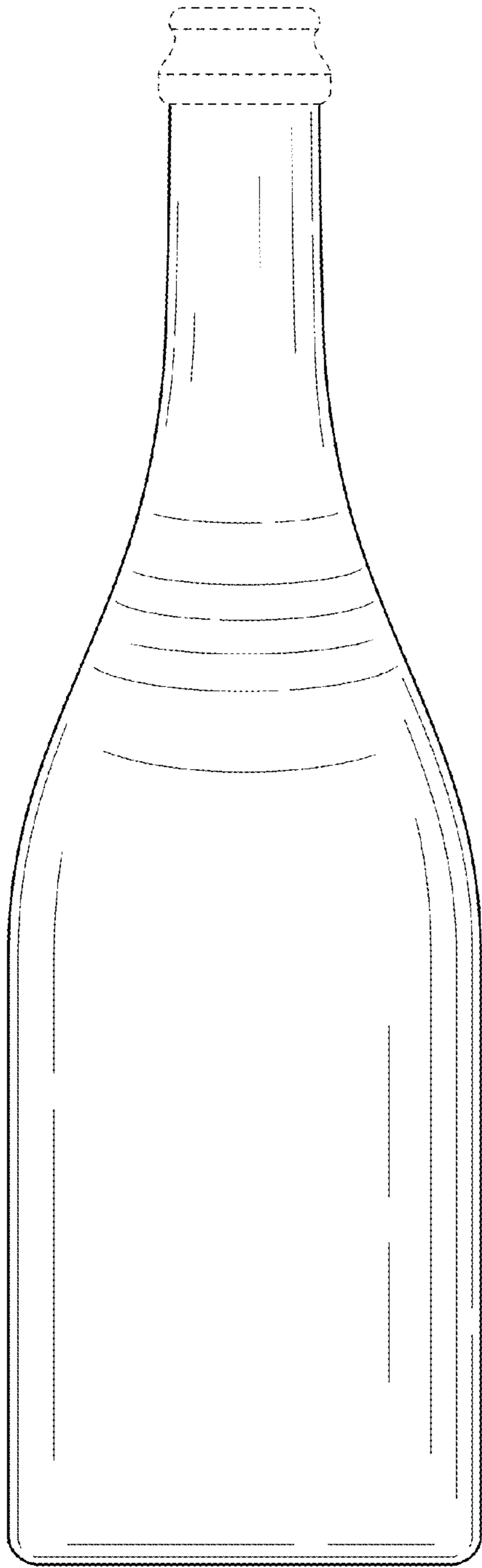

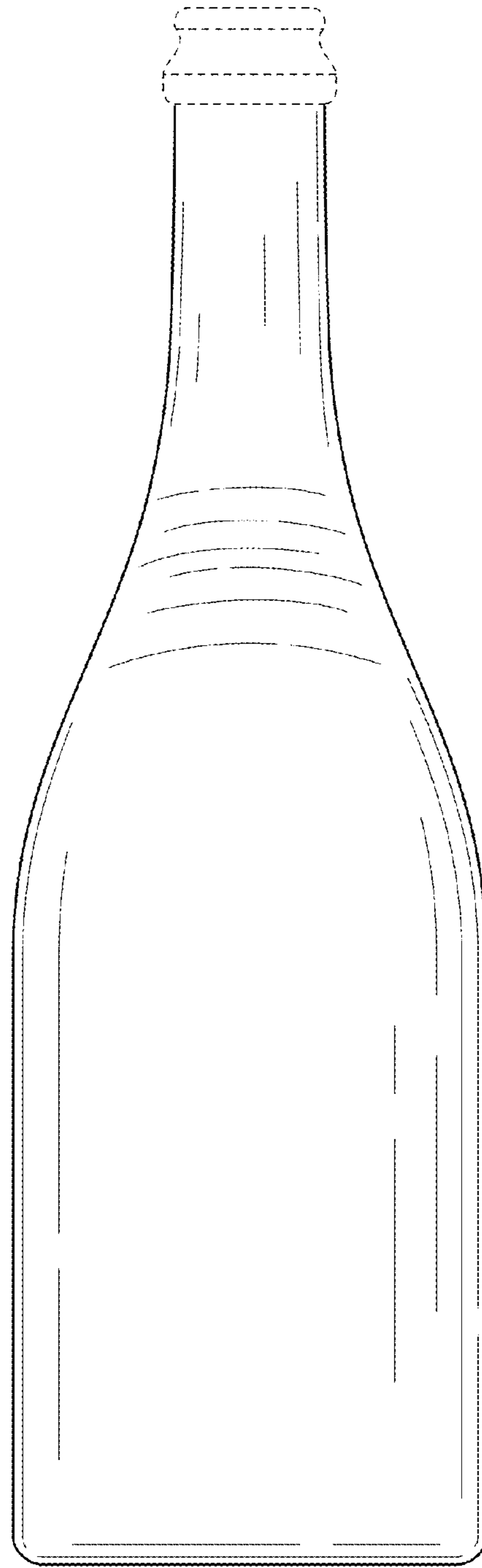
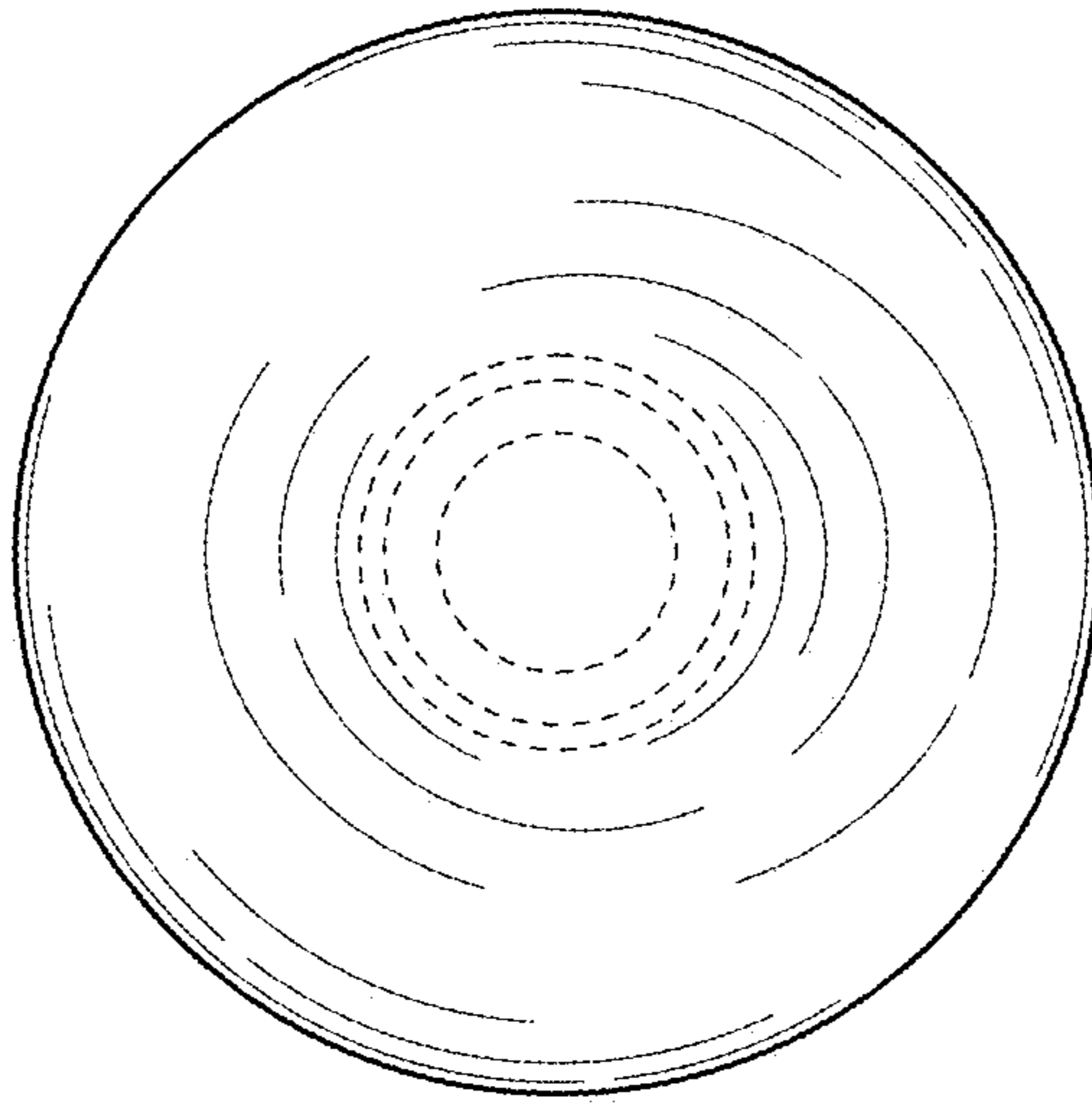

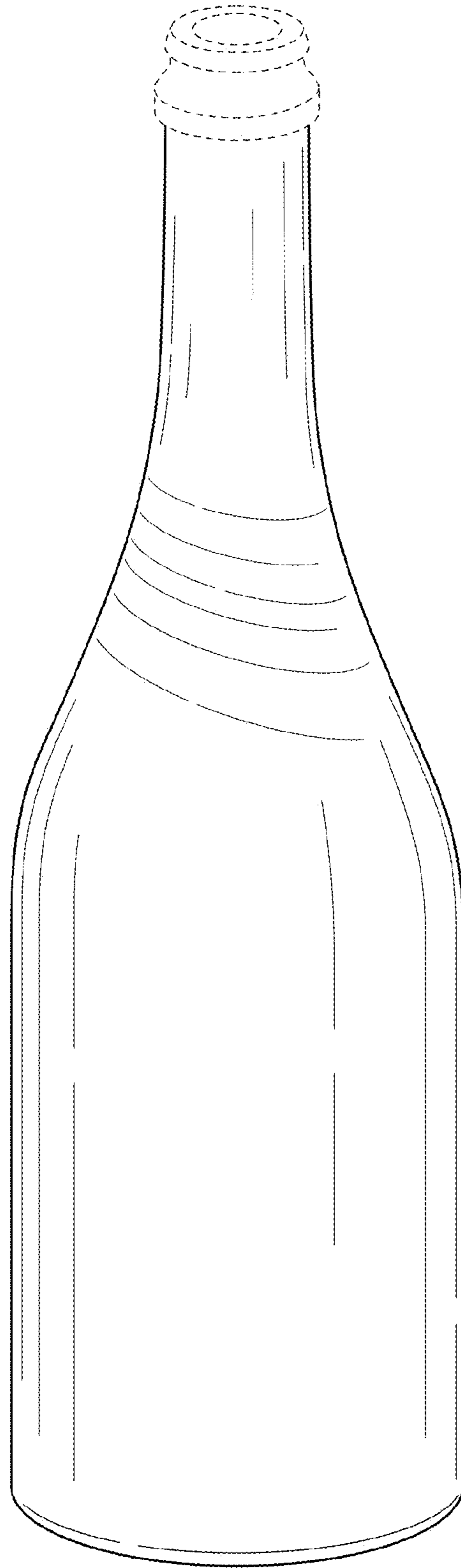
