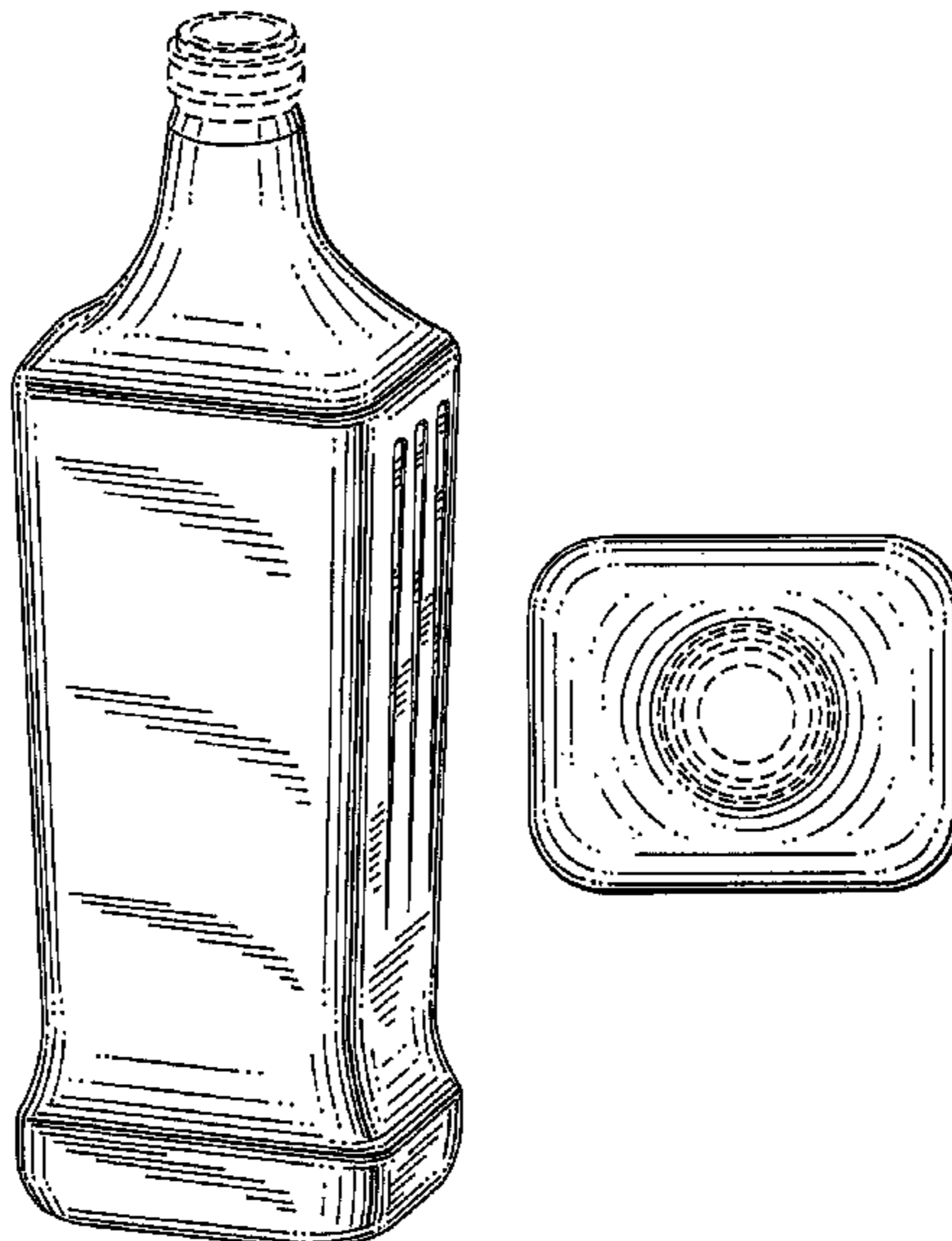
(57) **CLAIM**

The ornamental design for a liquor bottle, as shown and described.

DESCRIPTION

FIG. 1 is a right front perspective view of a liquor bottle showing my new design;
FIG. 2 is a front elevational view thereof, the rear elevational view thereof being a mirror image;
FIG. 3 is a top plan view thereof;
FIG. 4 is a right side elevational view thereof, the left side elevational view being a mirror image thereof; and,
FIG. 5 is a bottom plan view thereof.
The broken lines in the drawings illustrate the portions of the design that form no part of the claim.

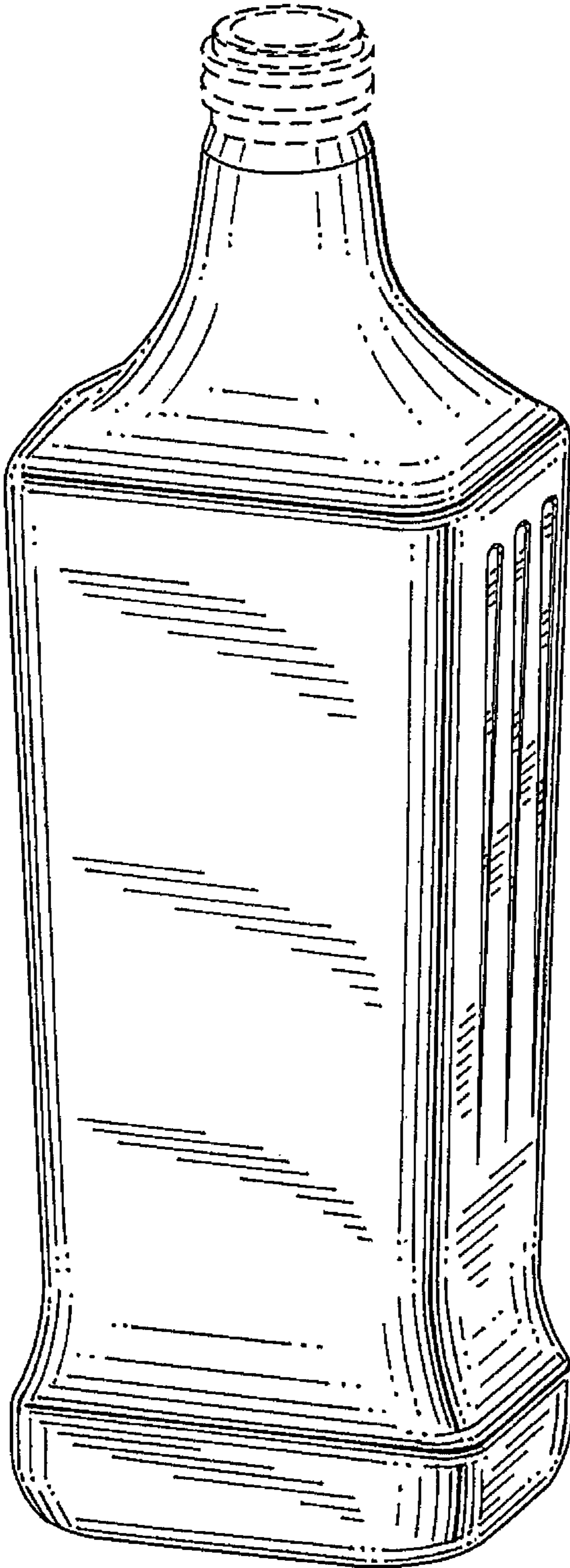

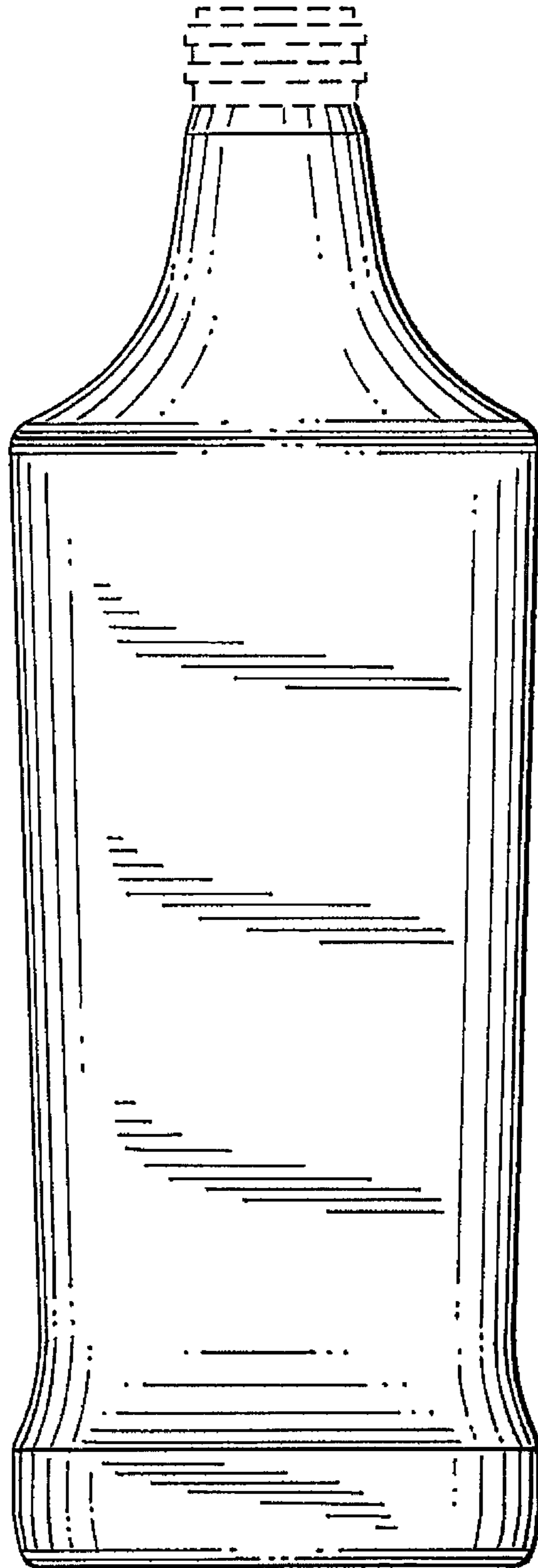

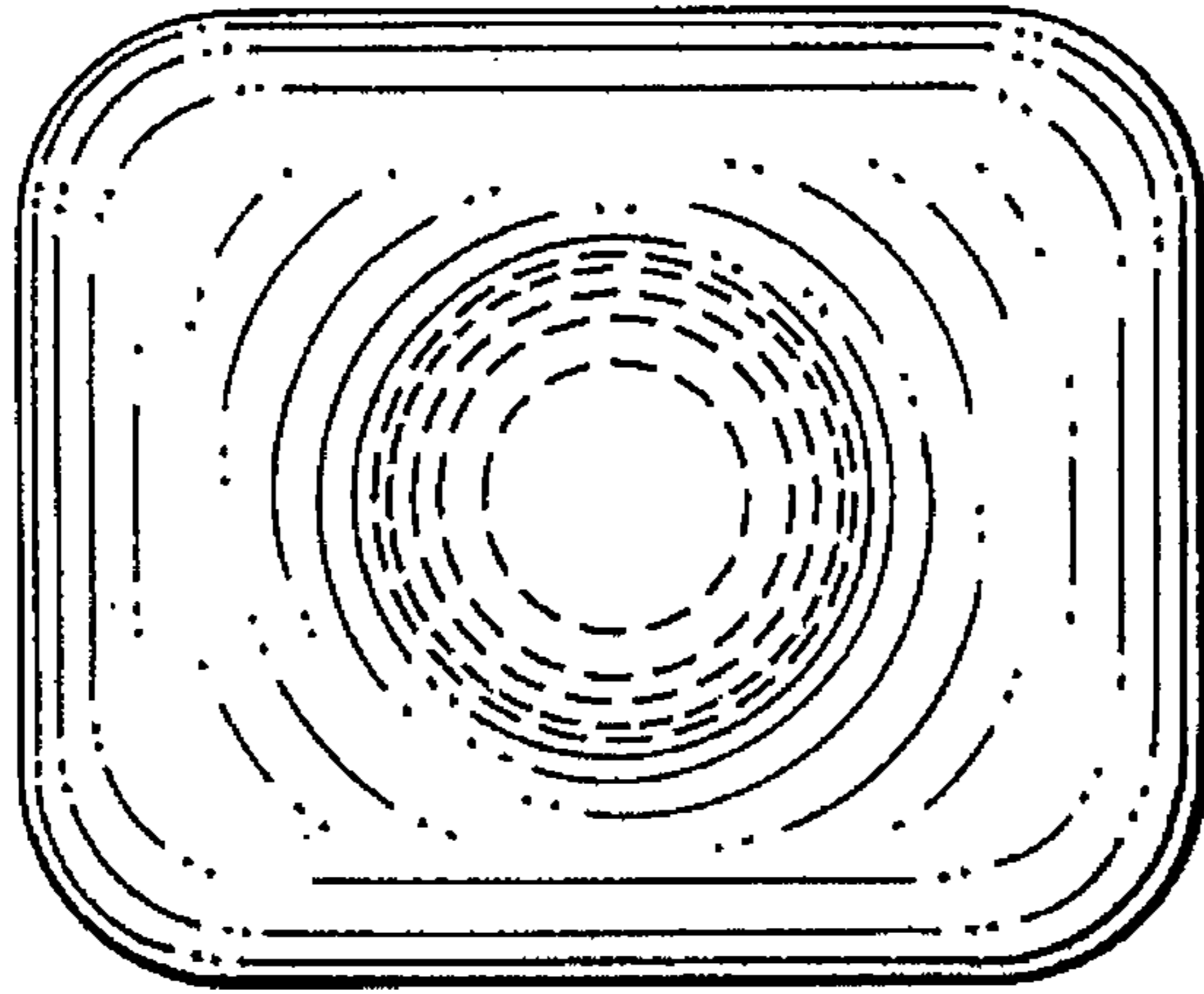

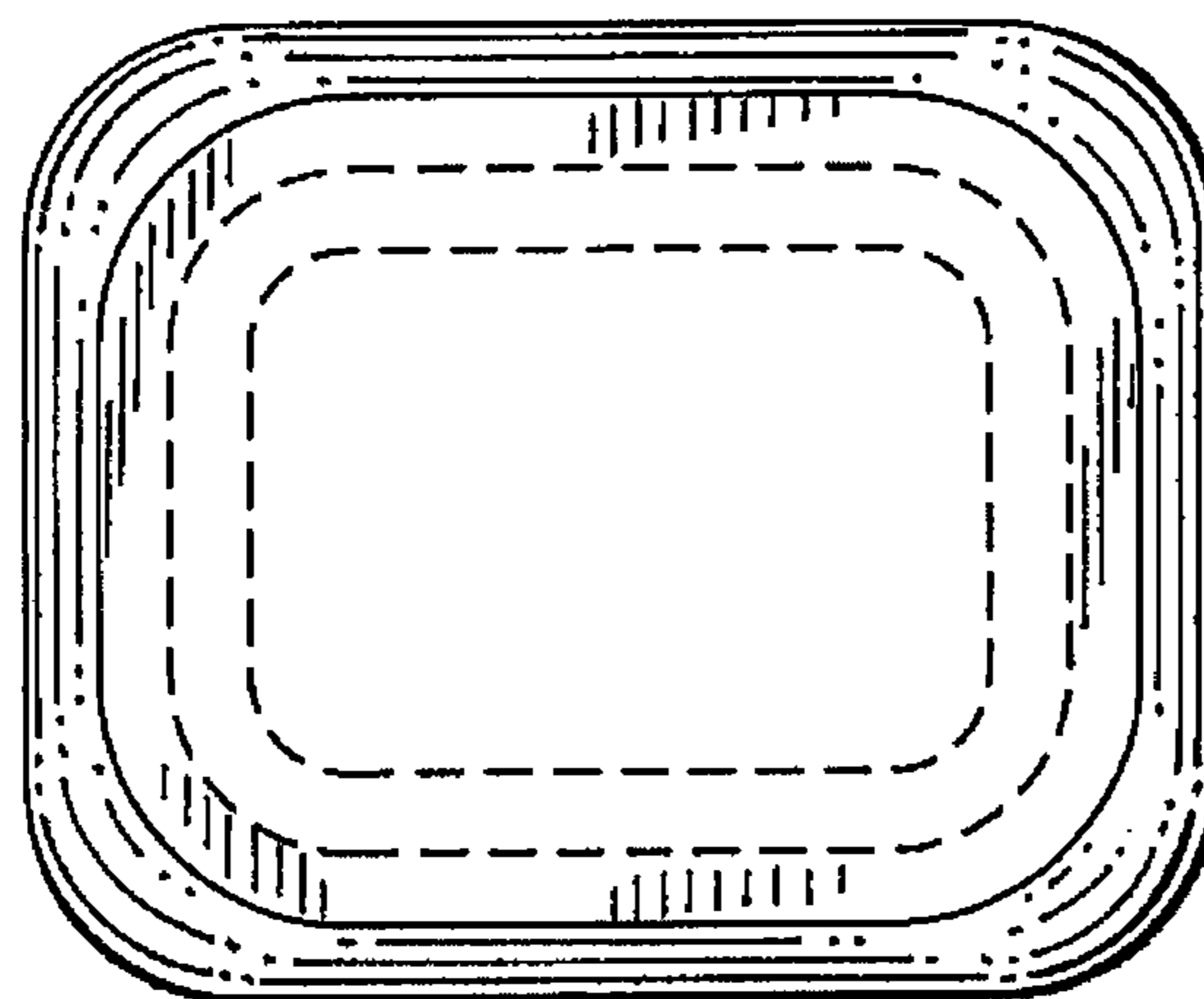

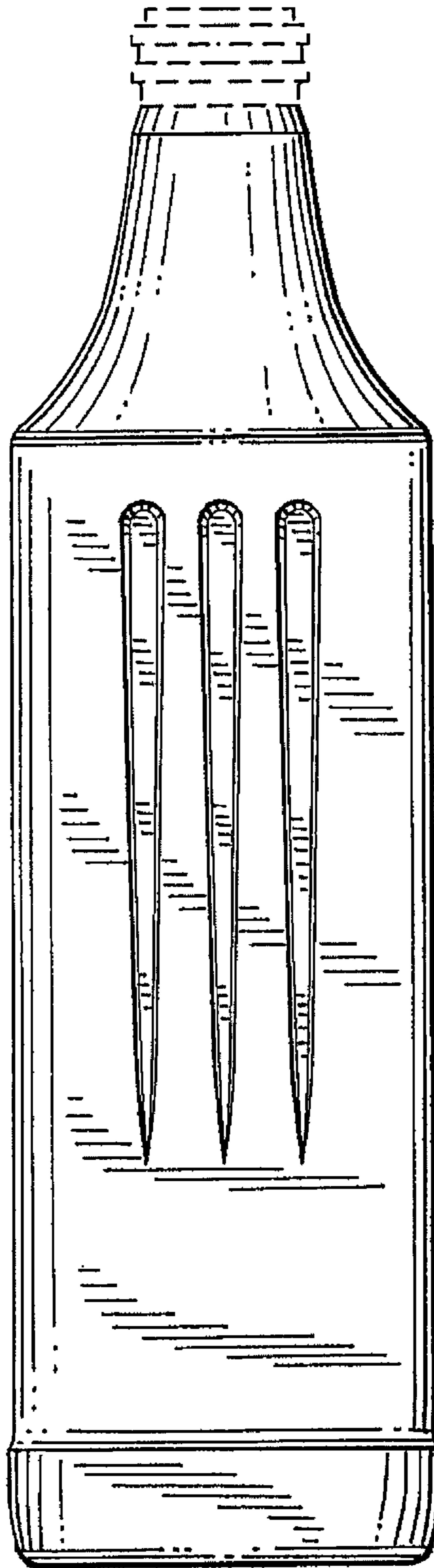
