FIG. 1 is a front and side perspective view showing my new liquor bottle design;

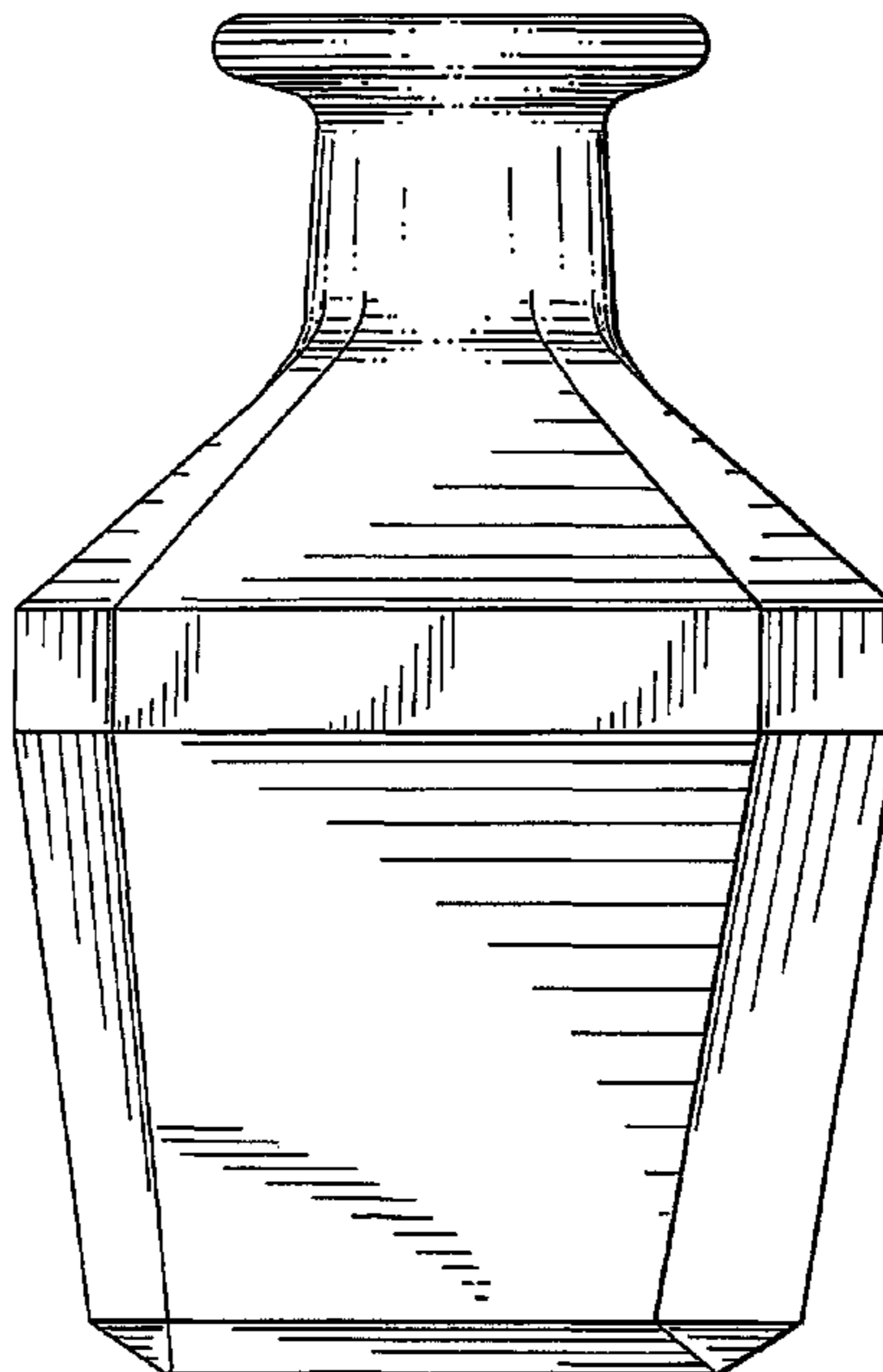
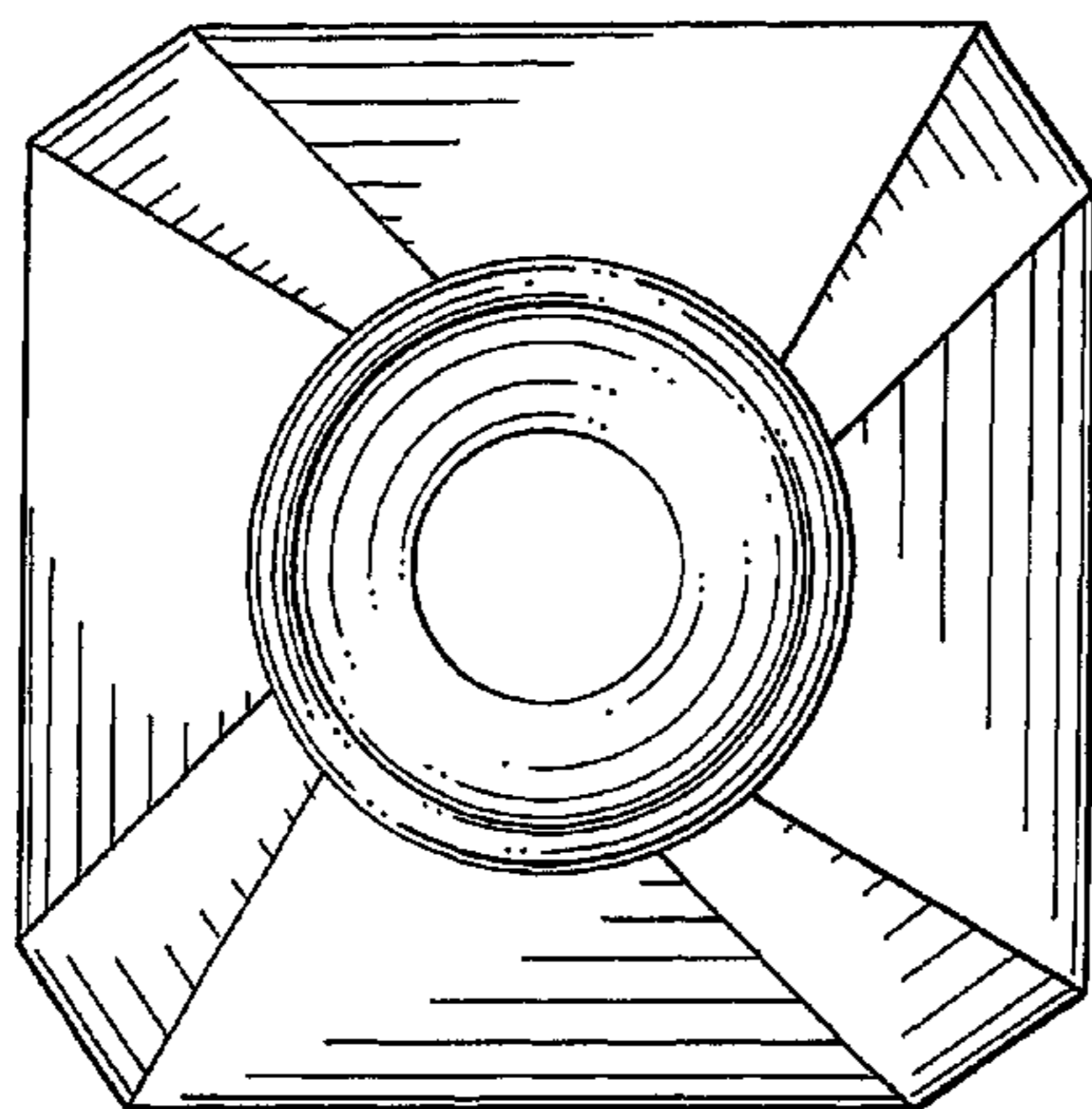
FIG. 2 is a top plan view thereof;

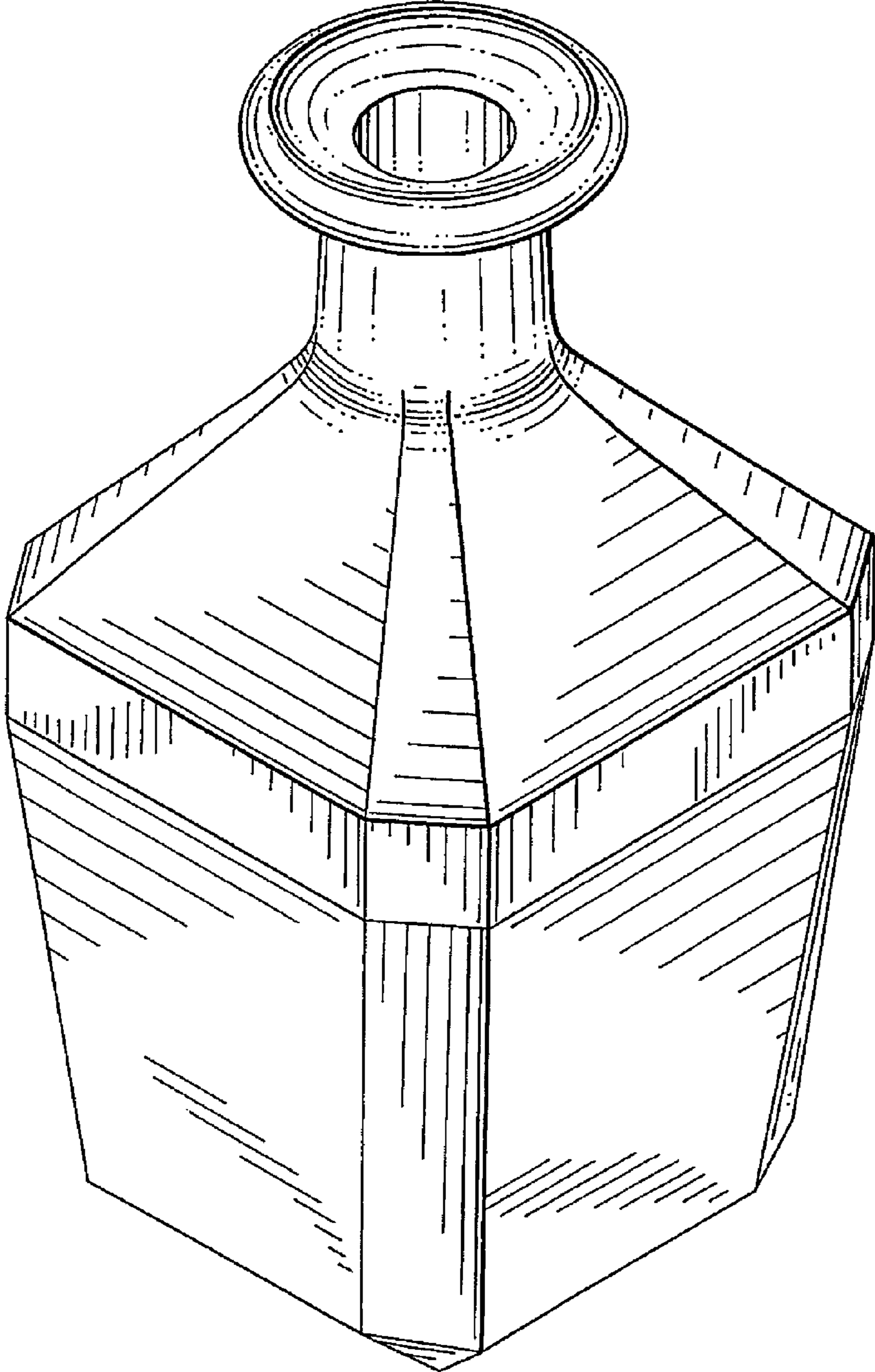

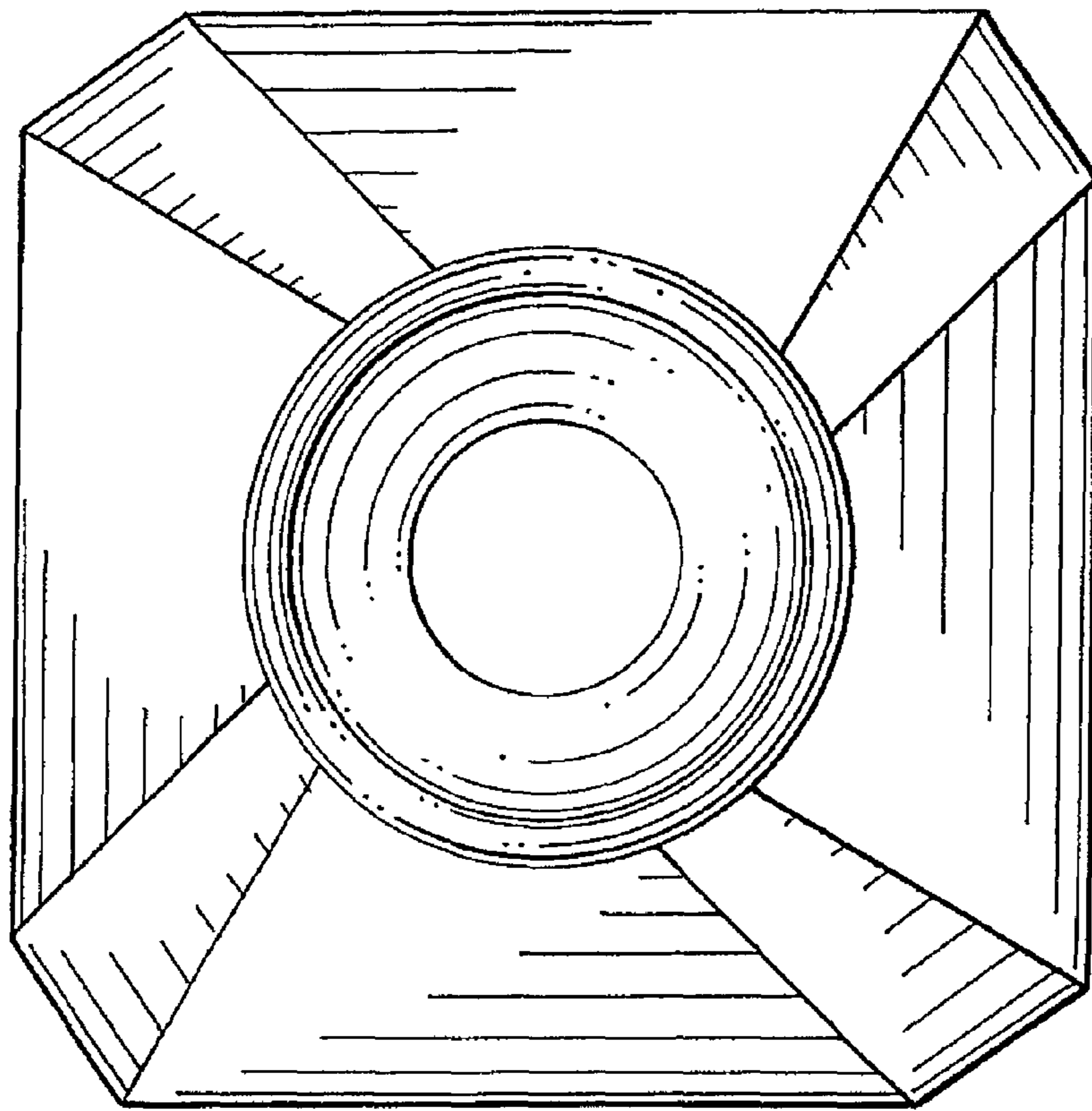

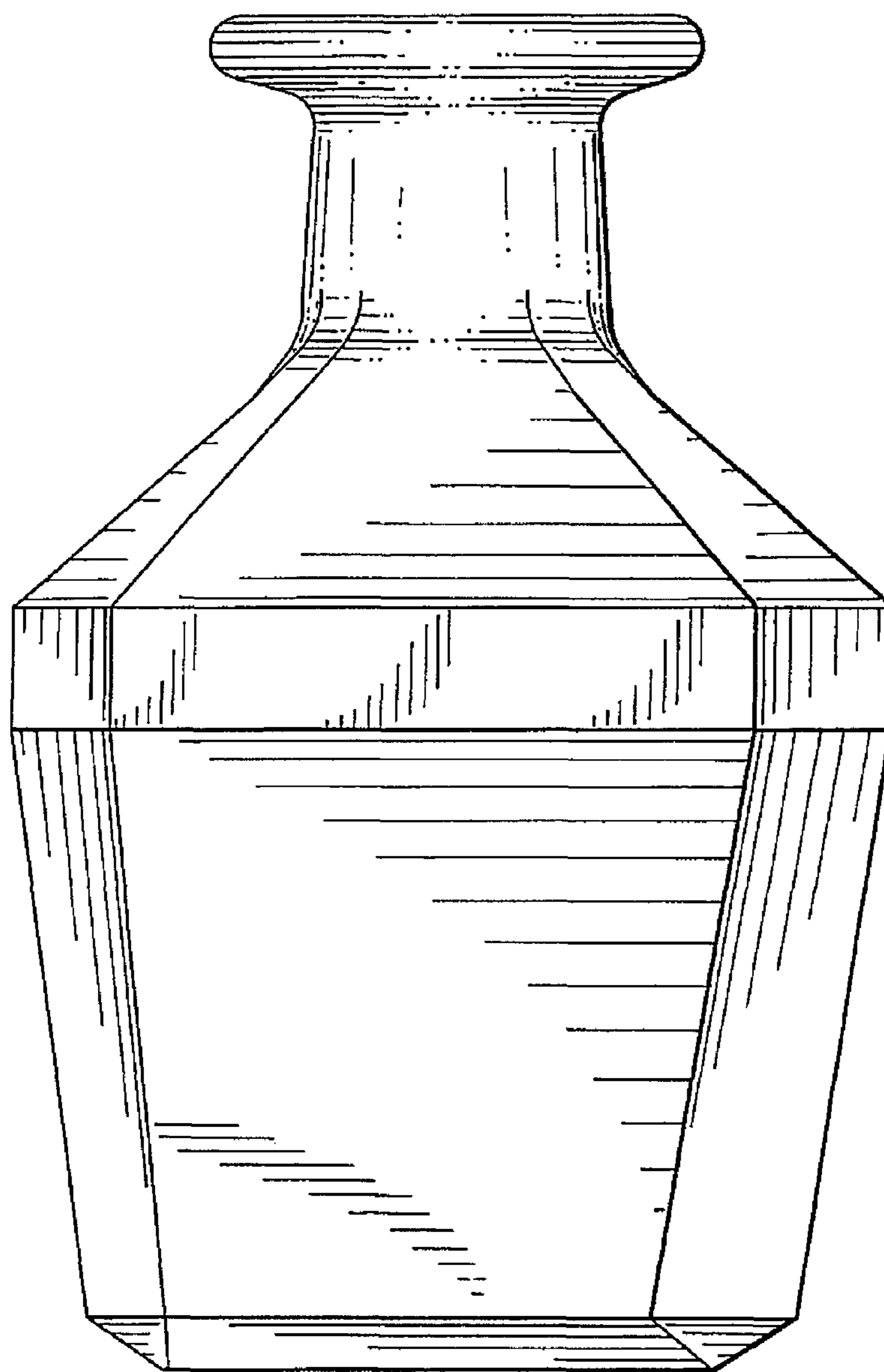

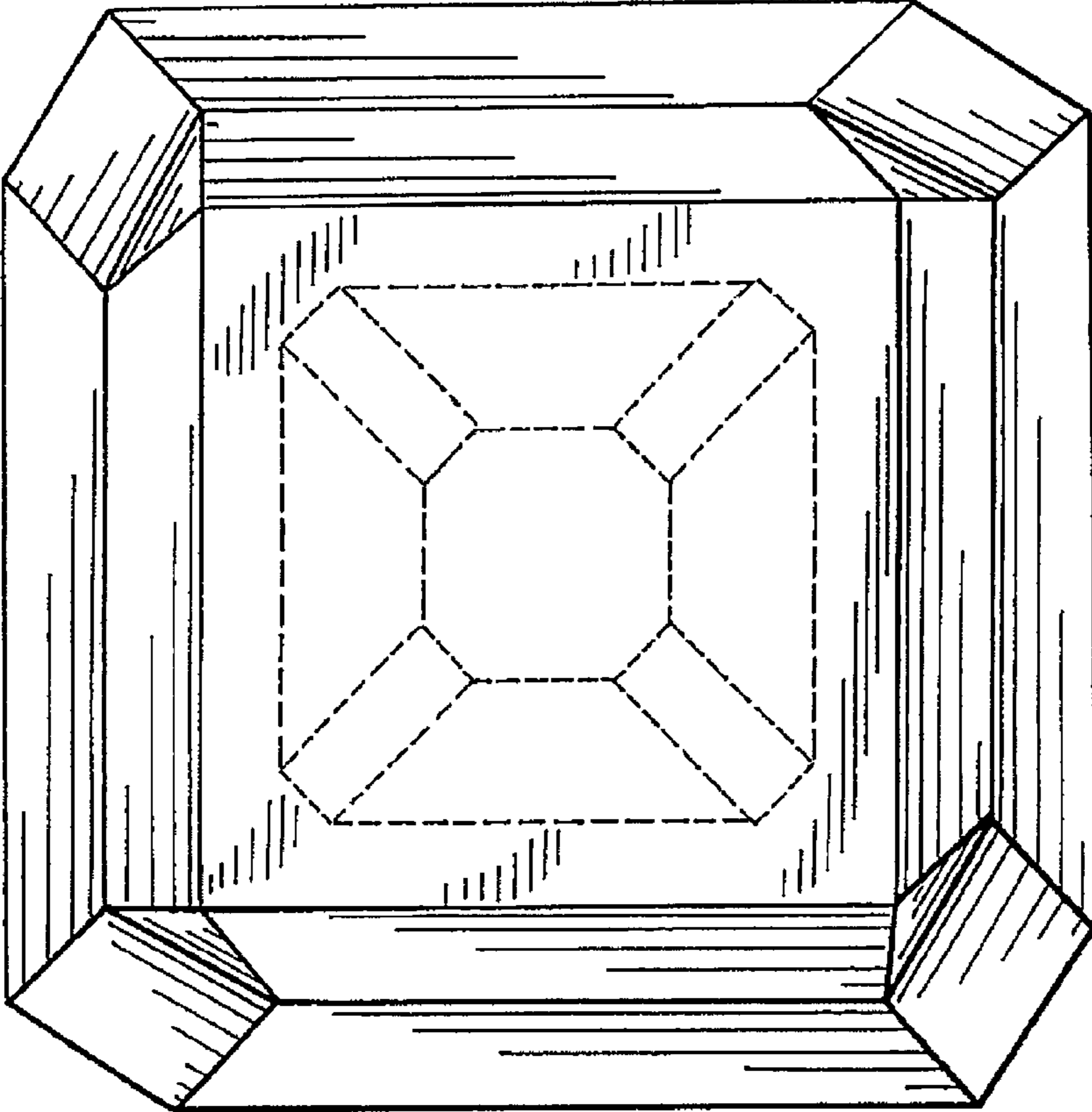
