The ornamental design for a home stereo speaker system, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, and side perspective view of a home stereo speaker system showing my new design, shown in a closed position:

FIG. 2 is a top, front, and side perspective view thereof, shown in open position.

FIG. 3 is a right side elevational view thereof;

FIG. 8 is a front elevational view of FIG. 2;

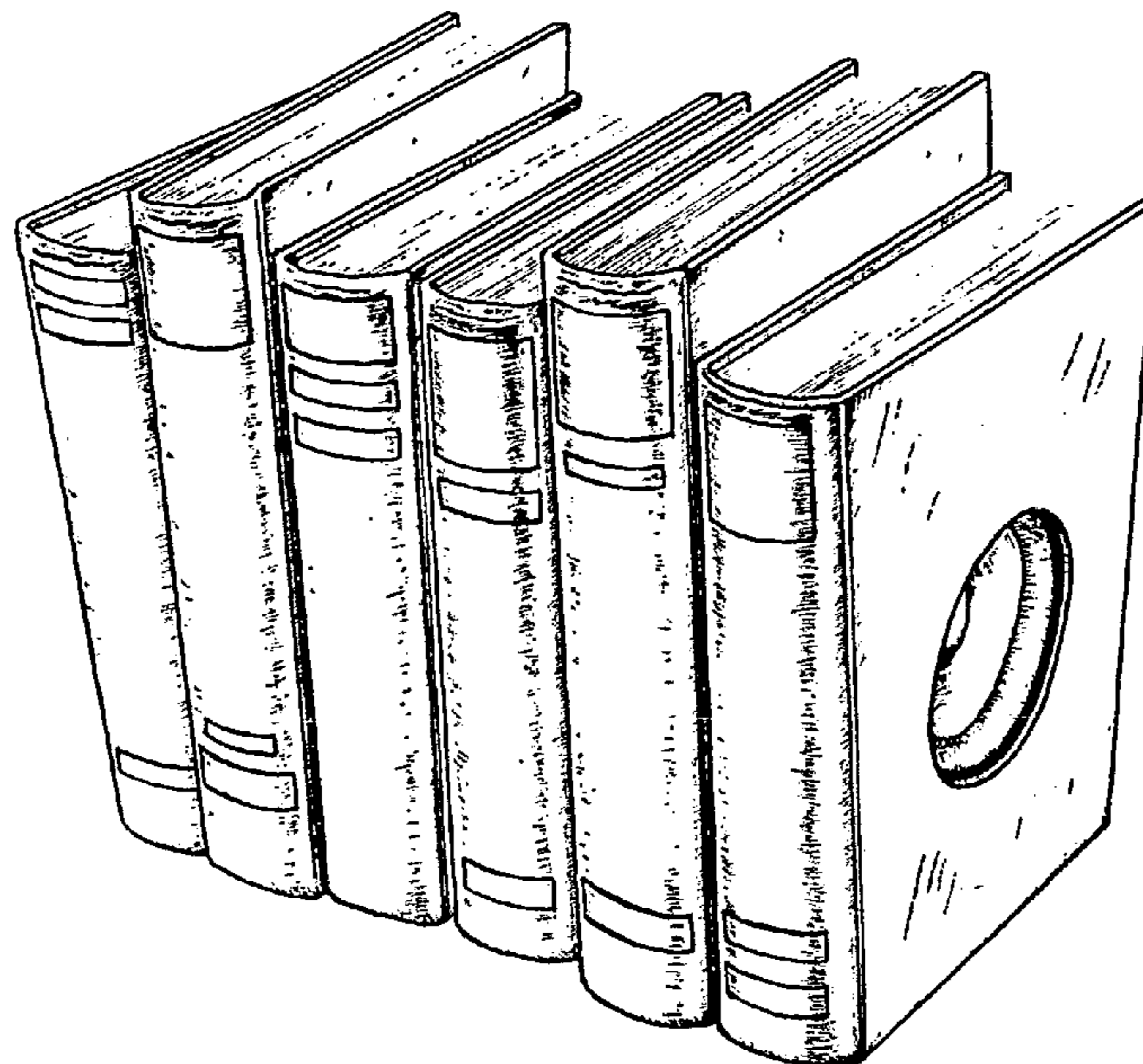
FIG. 9 is a top, rear, and side perspective view of FIG. 1;

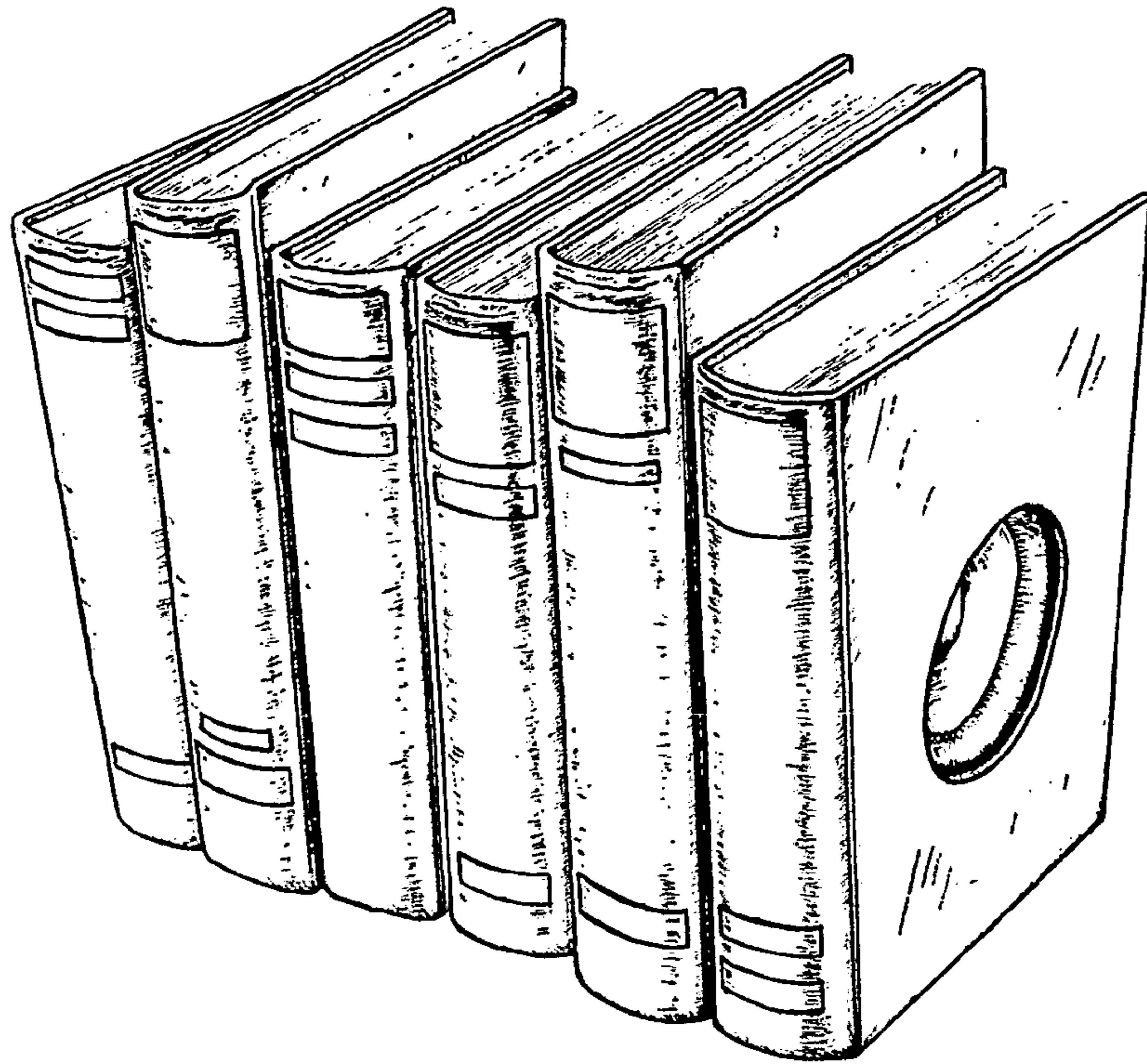

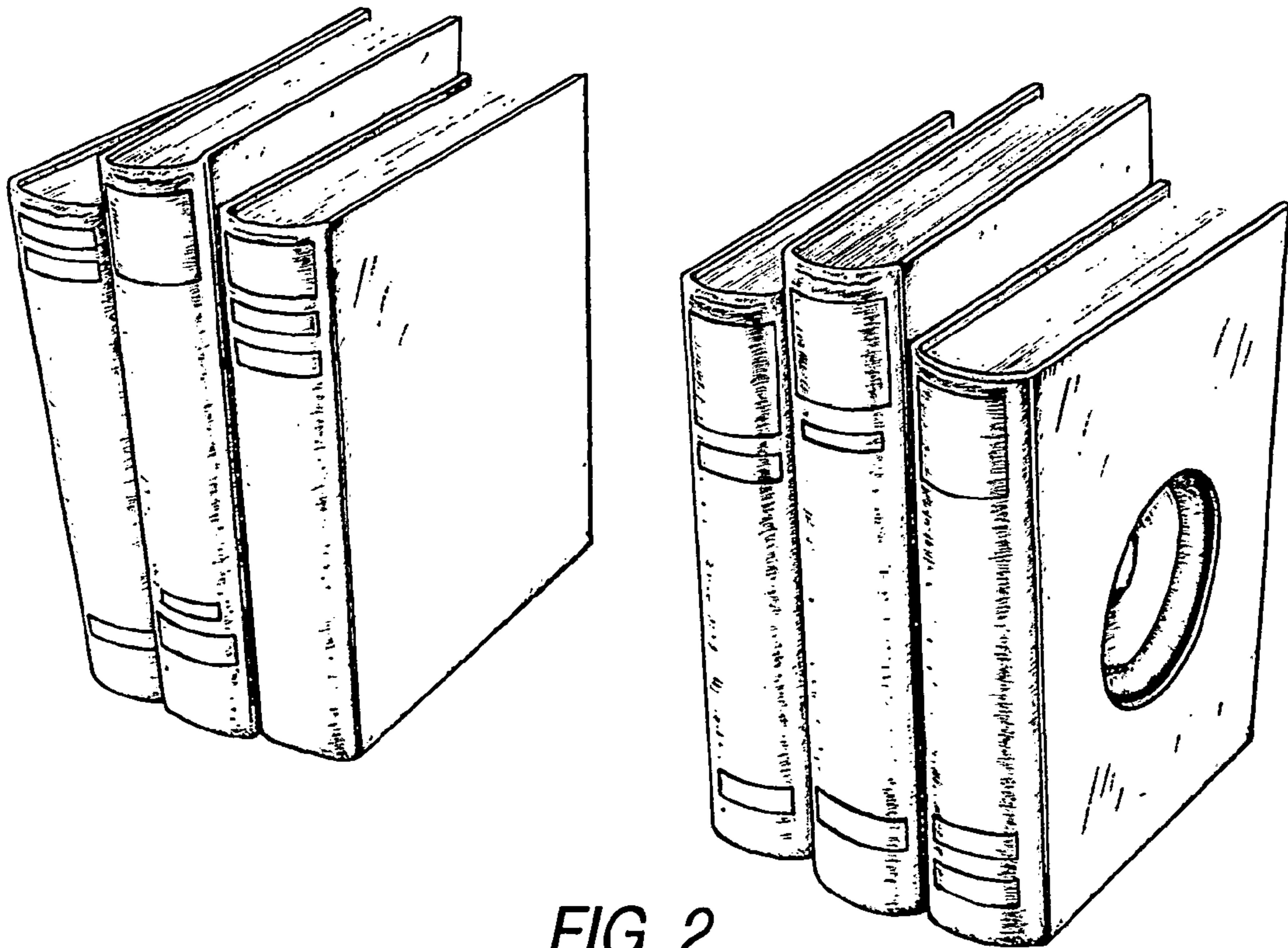

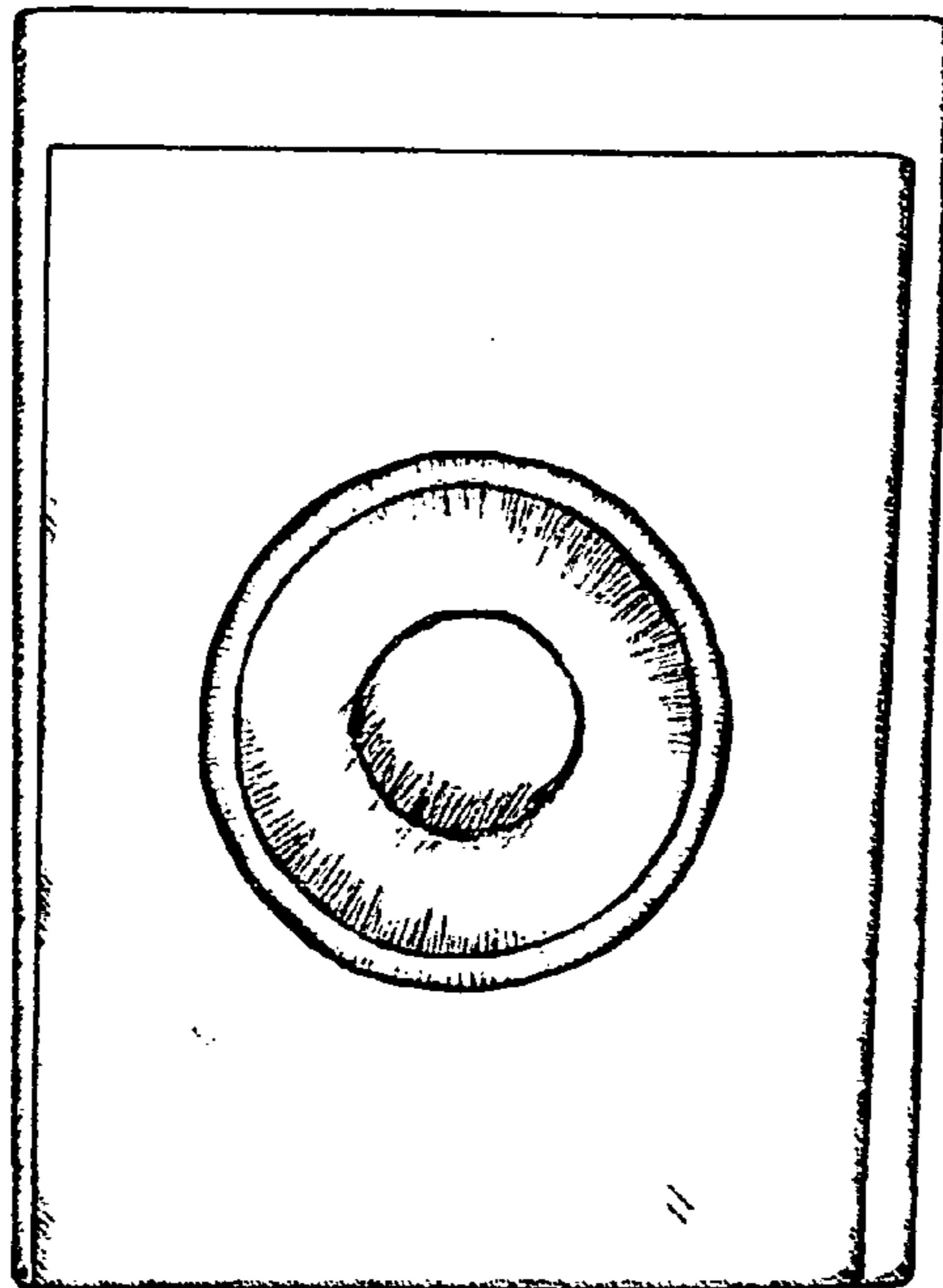

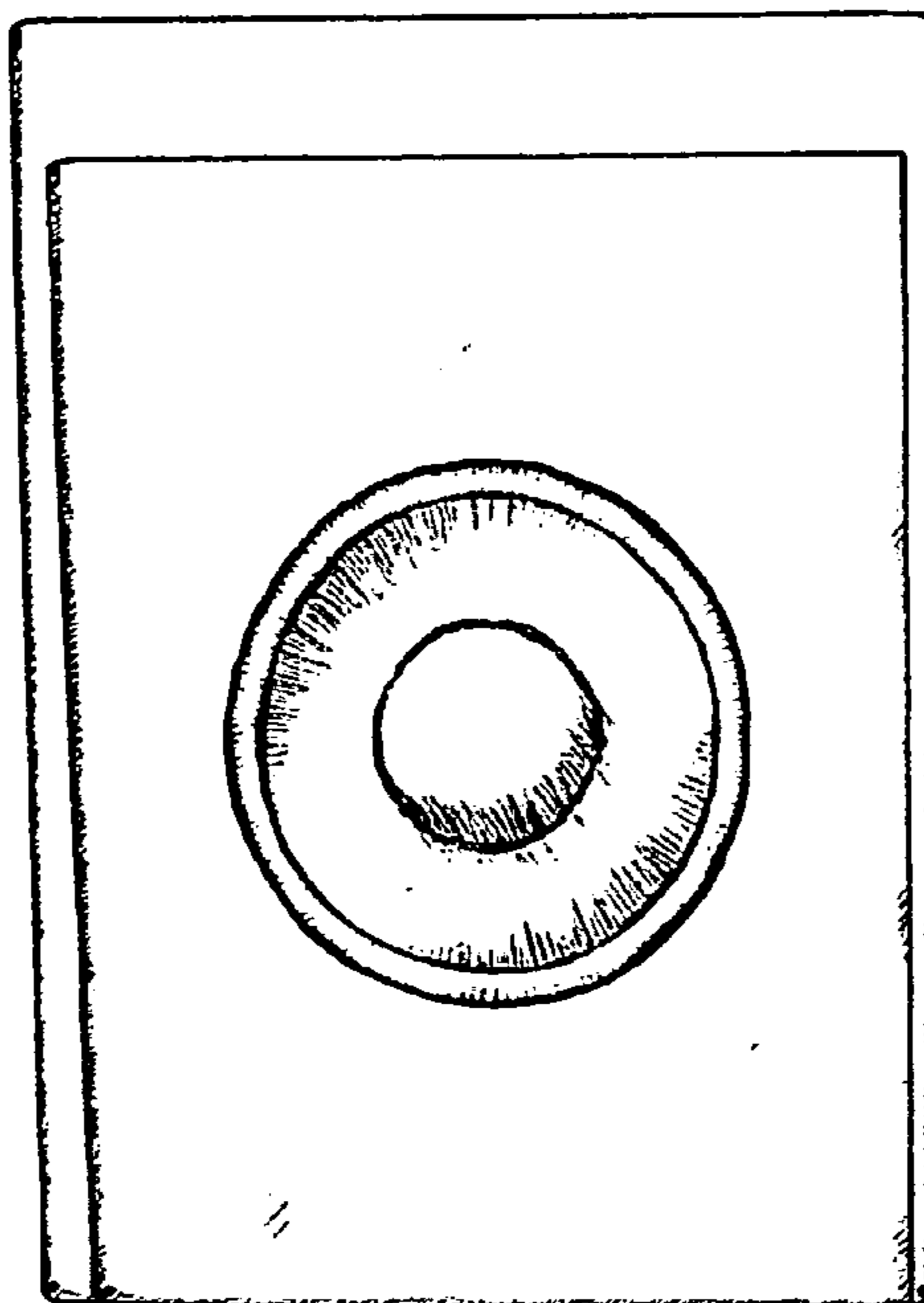

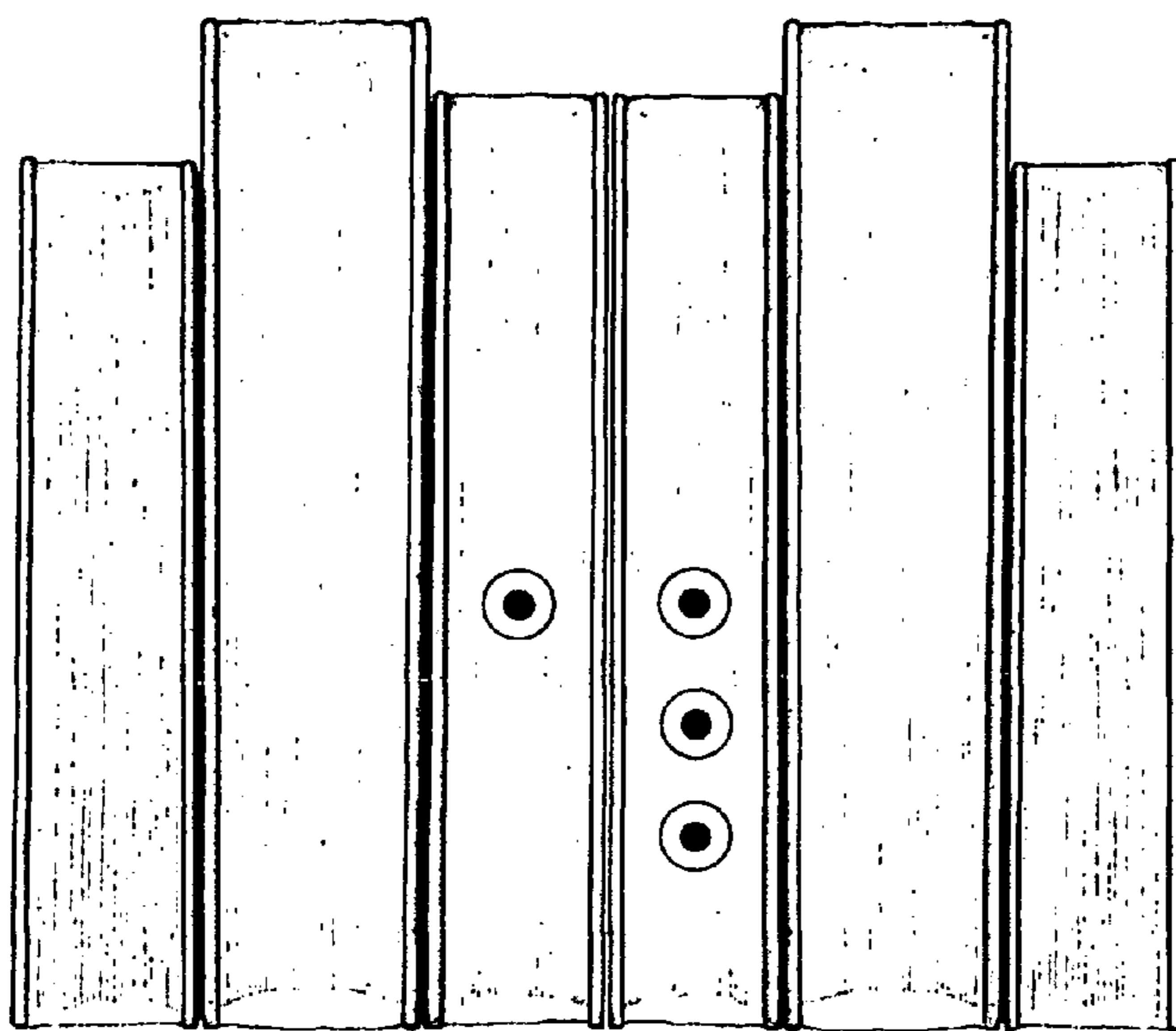

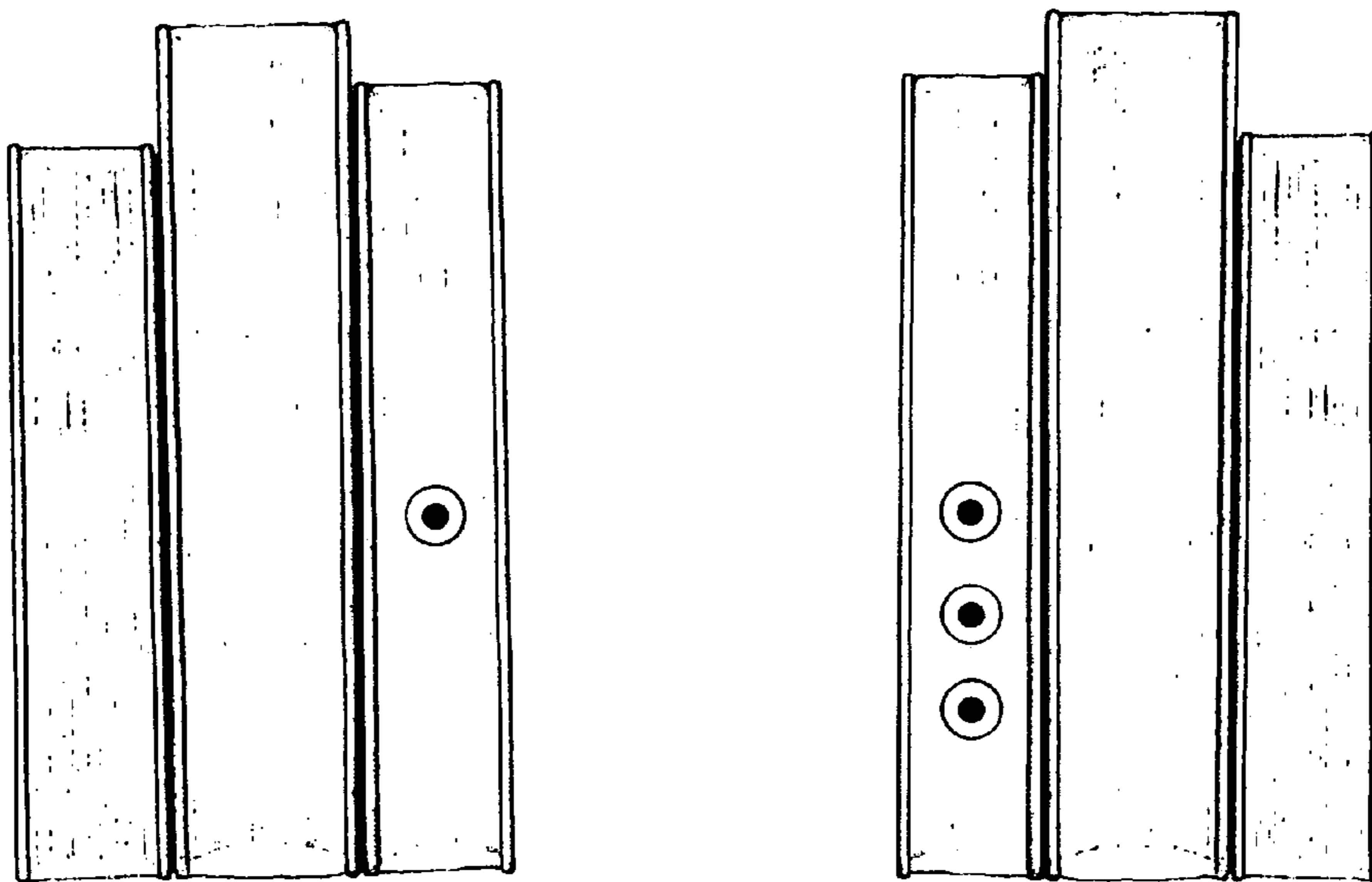

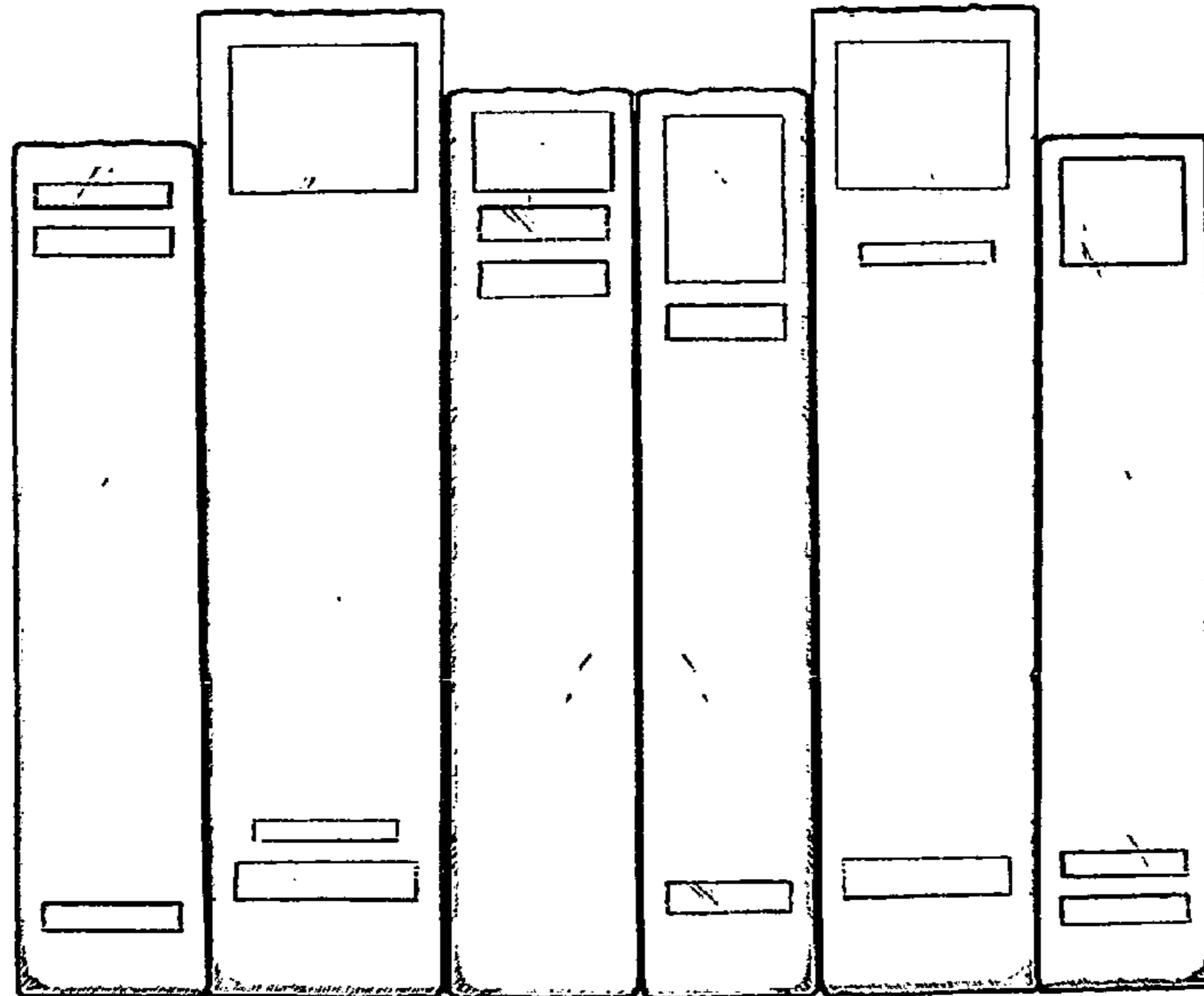

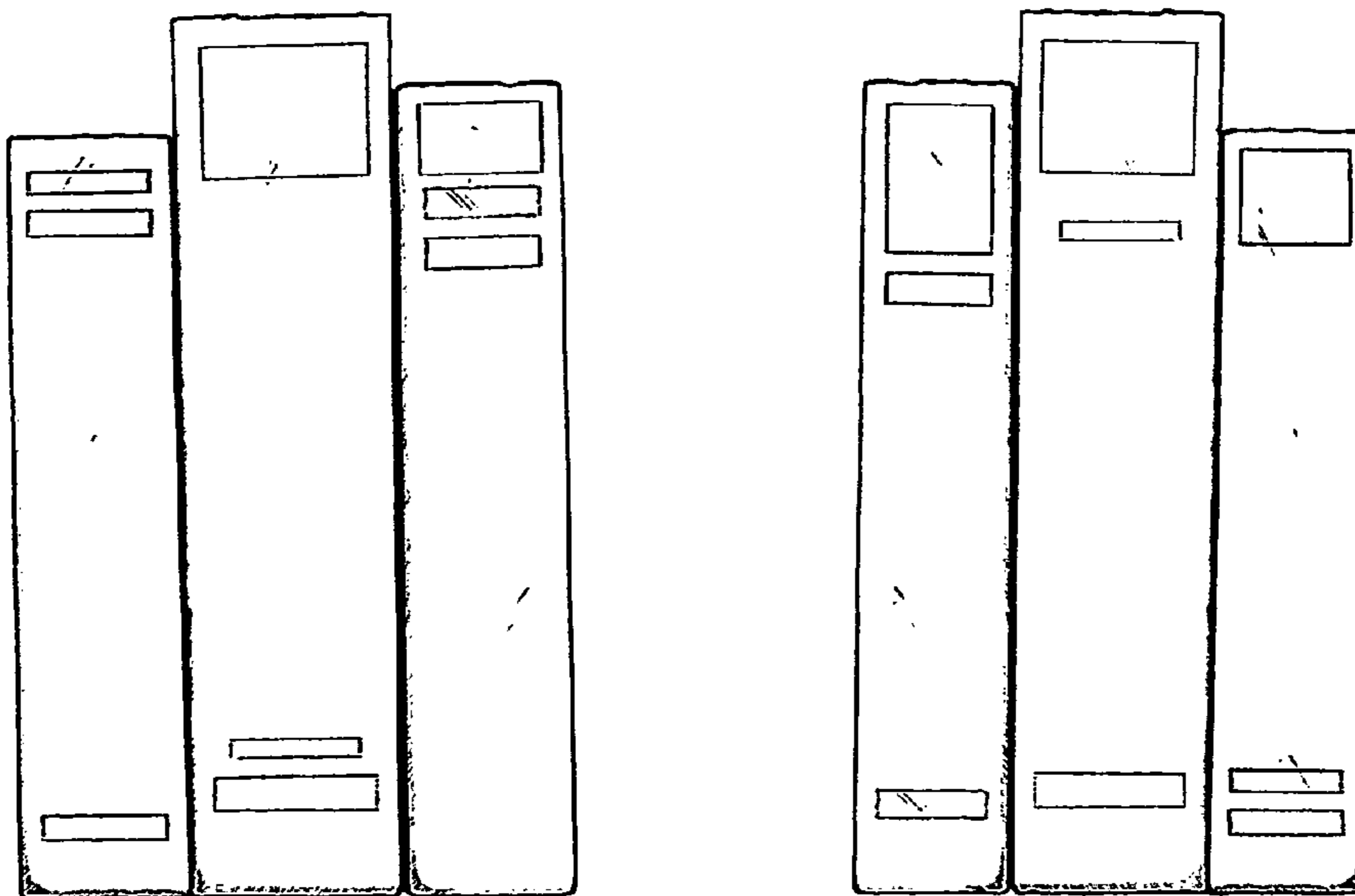

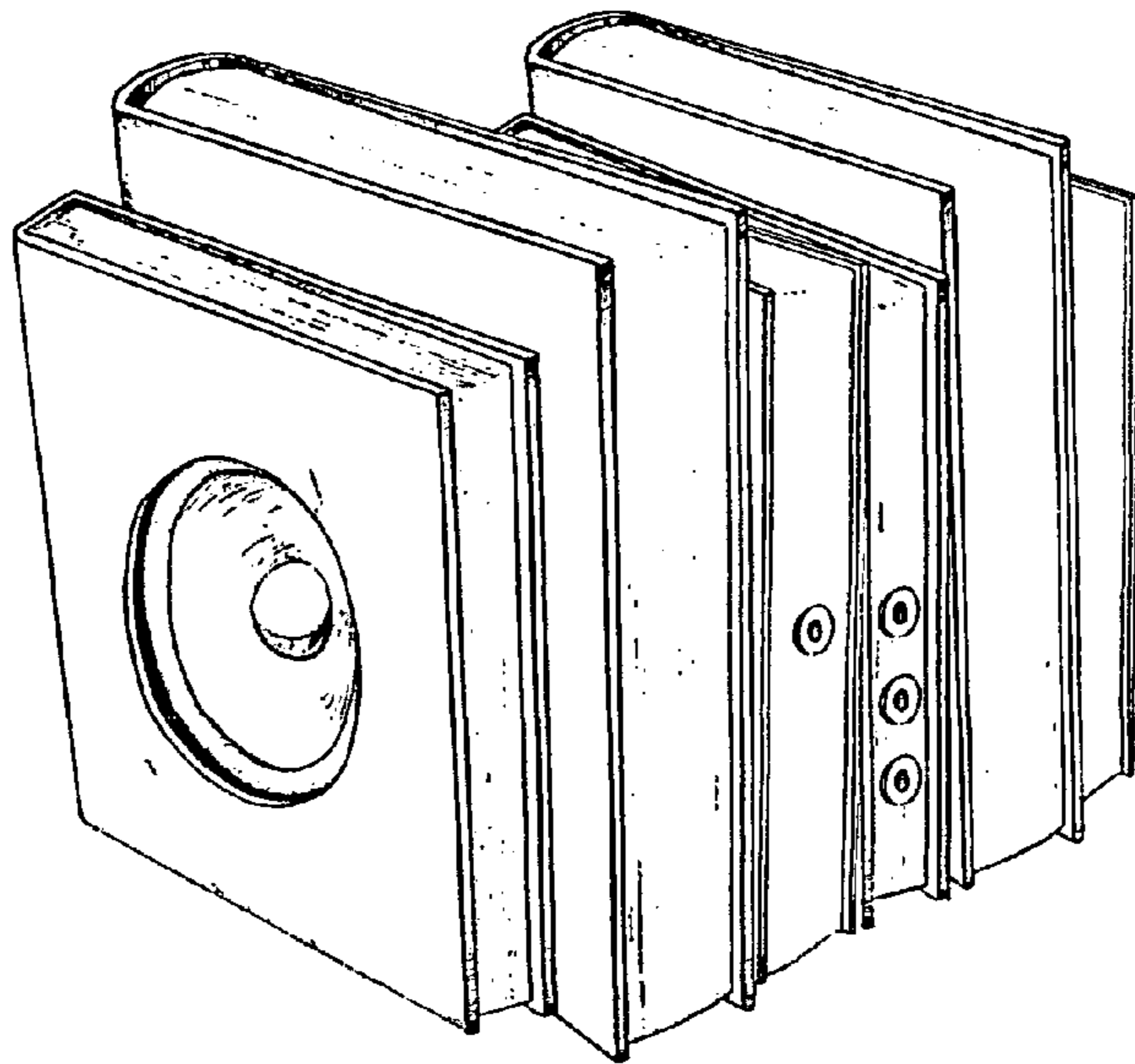

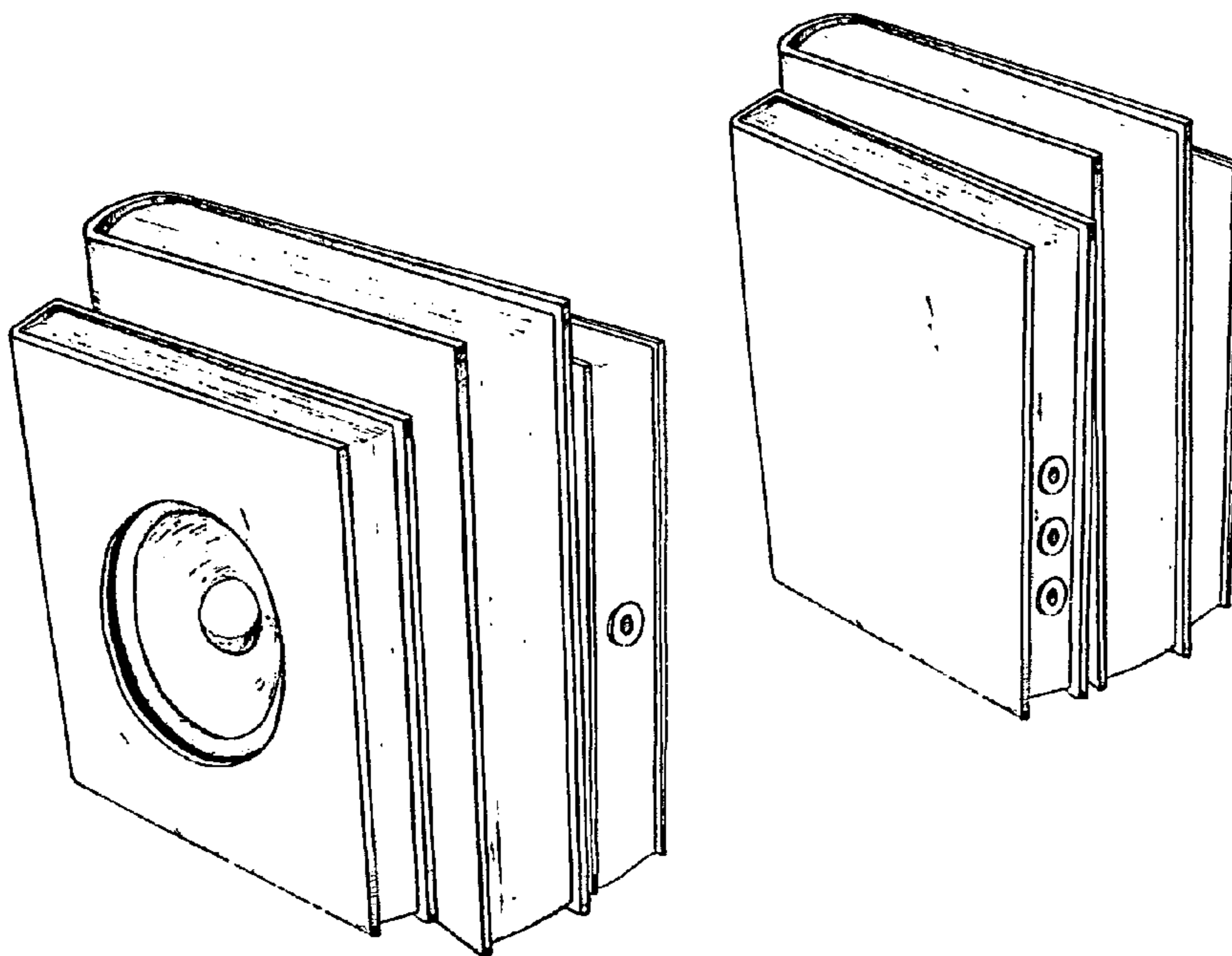

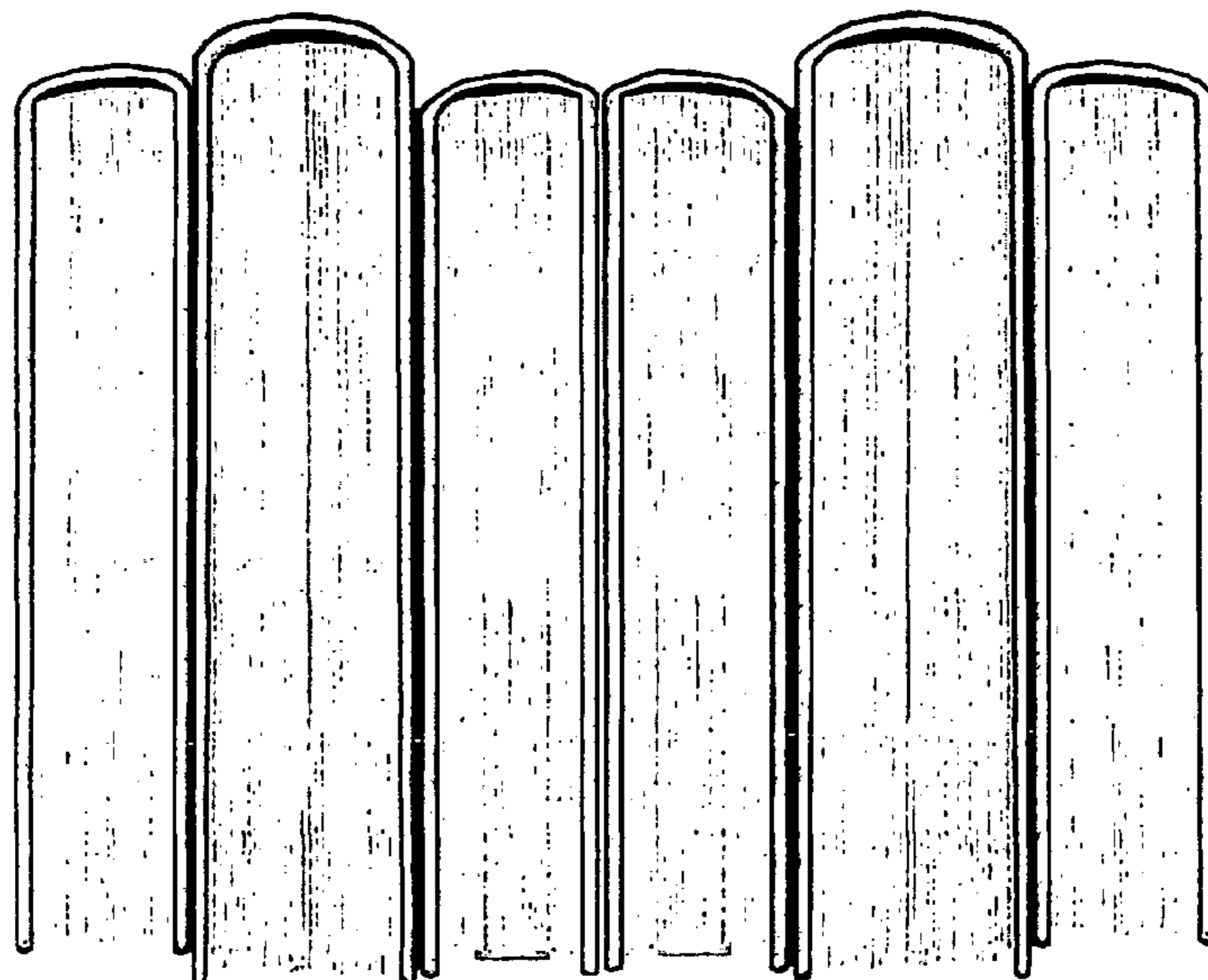

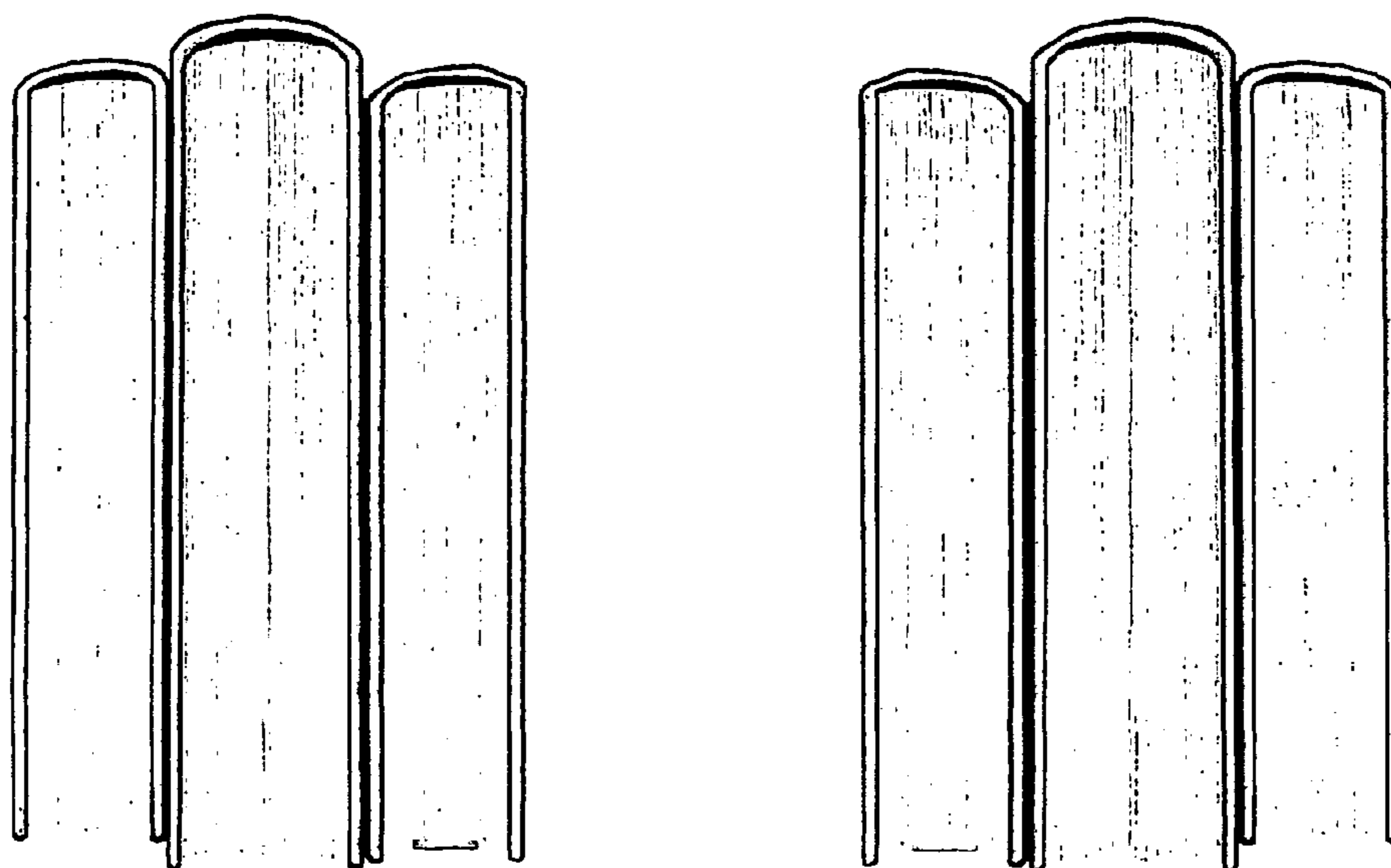
