(57) **CLAIM**

The ornamental design for a camera mount base bracket, as shown and described.

DESCRIPTION

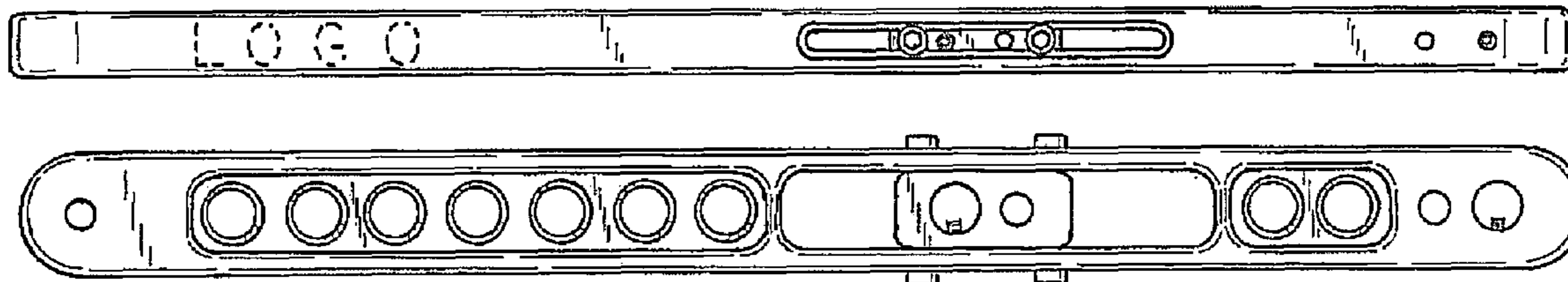

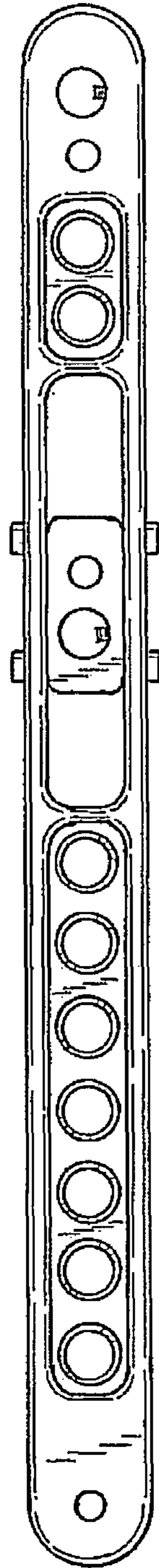

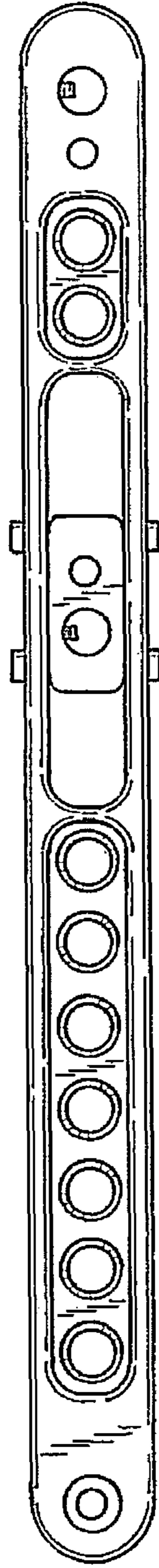

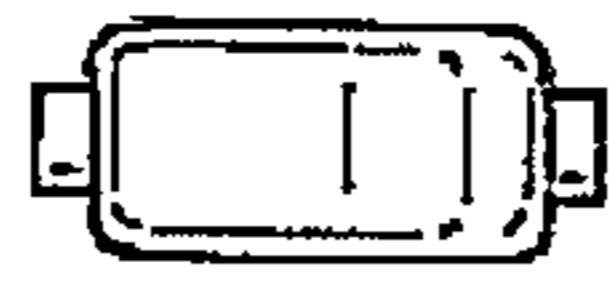
