(57) **CLAIM**

The ornamental design for a fluid delivery wand, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a fluid delivery wand showing our new design;

FIG. 2 is a front elevational view showing the design for the fluid delivery wand of FIG. 1;

FIG. 3 is a rear elevational view showing the design for the fluid delivery wand of FIG. 1;

FIG. 4 is a left side elevational view showing the design for the fluid delivery wand of FIG. 1;

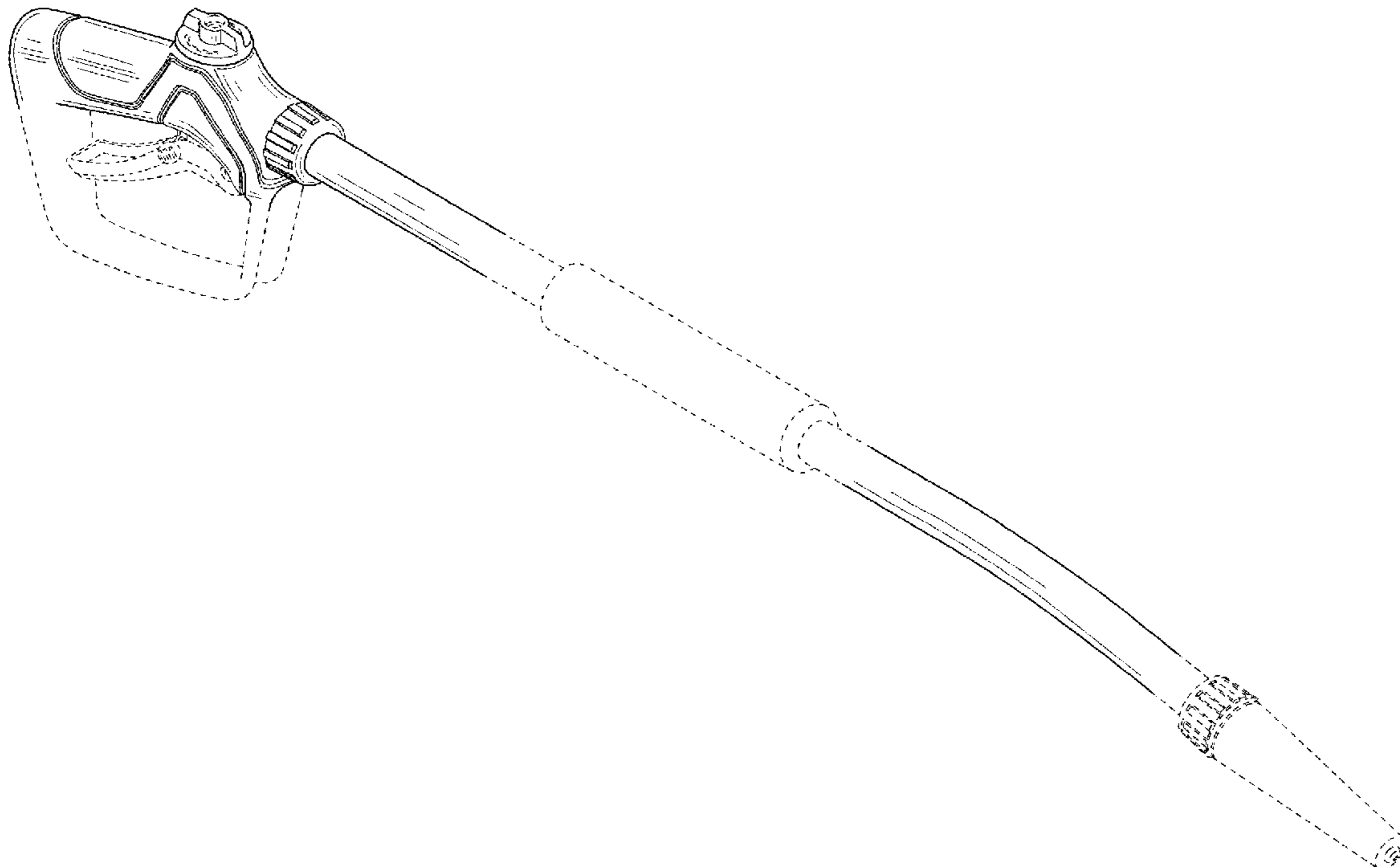
FIG. 5 is a right side elevational view showing the design for the fluid delivery wand of FIG. 1;

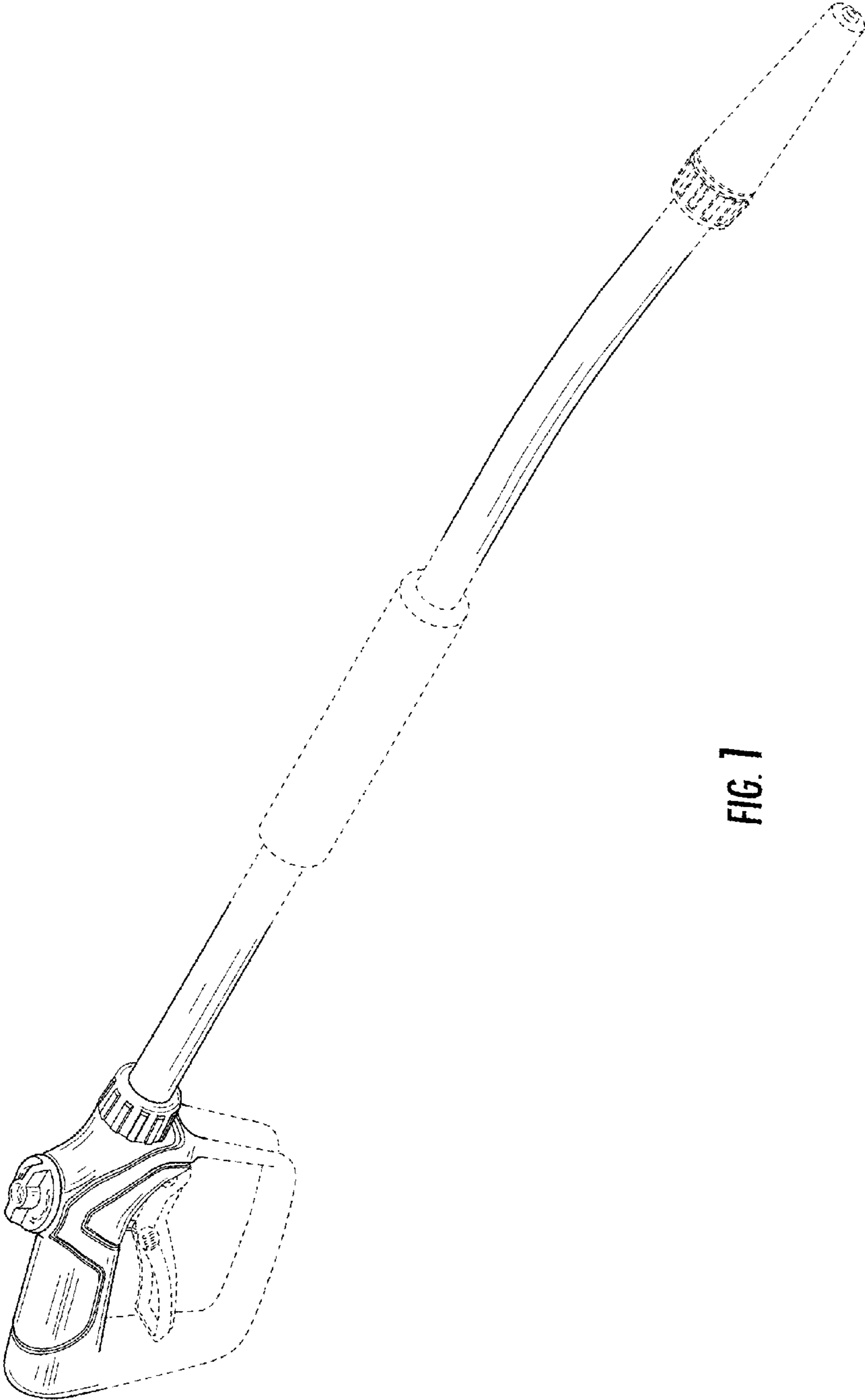

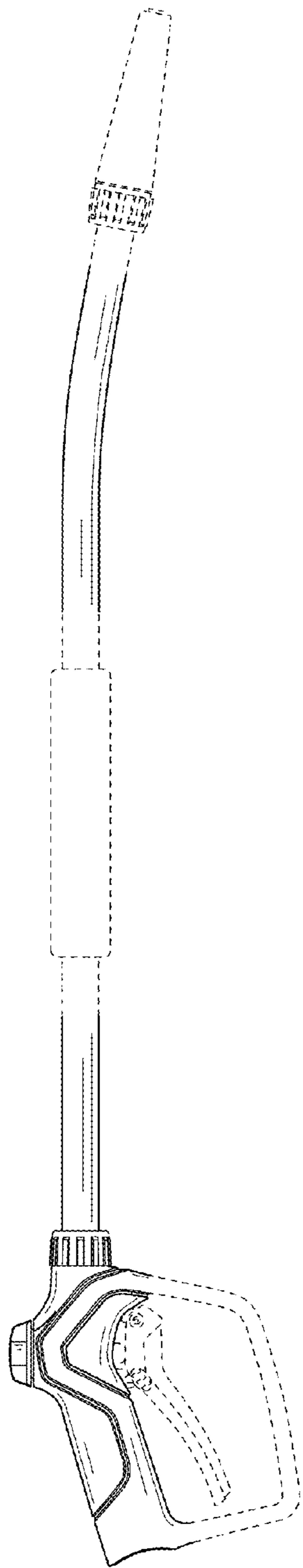

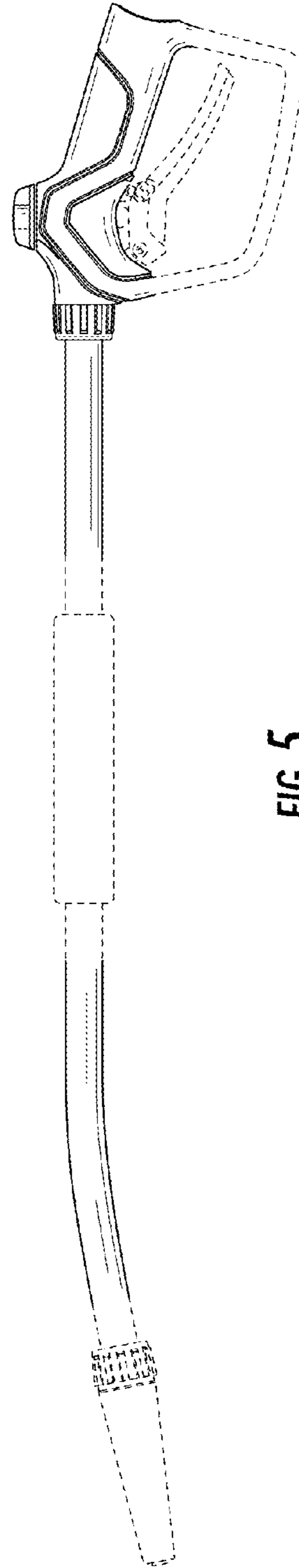

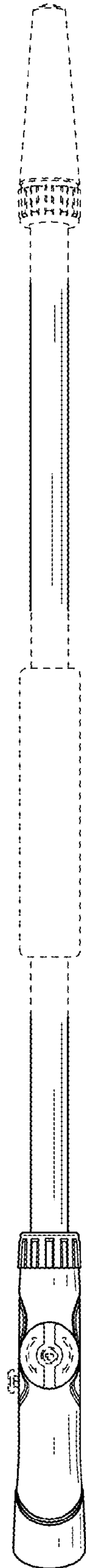

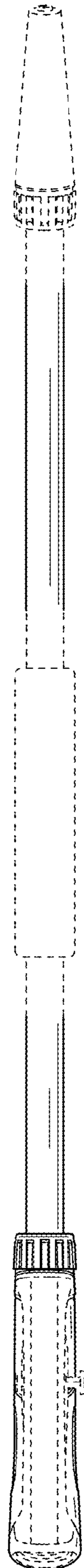
