What is claimed is the ornamental design for a faucet, as shown and described.

DESCRIPTION

FIG. 1—perspective view of our new design with the spray head in broken lines;

 FIG. 3—is the left side elevational view of the design shown in FIG. 1;
 FIG. 4—is a top view of the design shown in FIG. 1;
 FIG. 5—is a bottom view of the design shown in FIG. 1;
 FIG. 6—is a front elevational view of the design shown in FIG. 1; and,
 FIG. 7—is a rear elevational view of the design shown in FIG. 1.

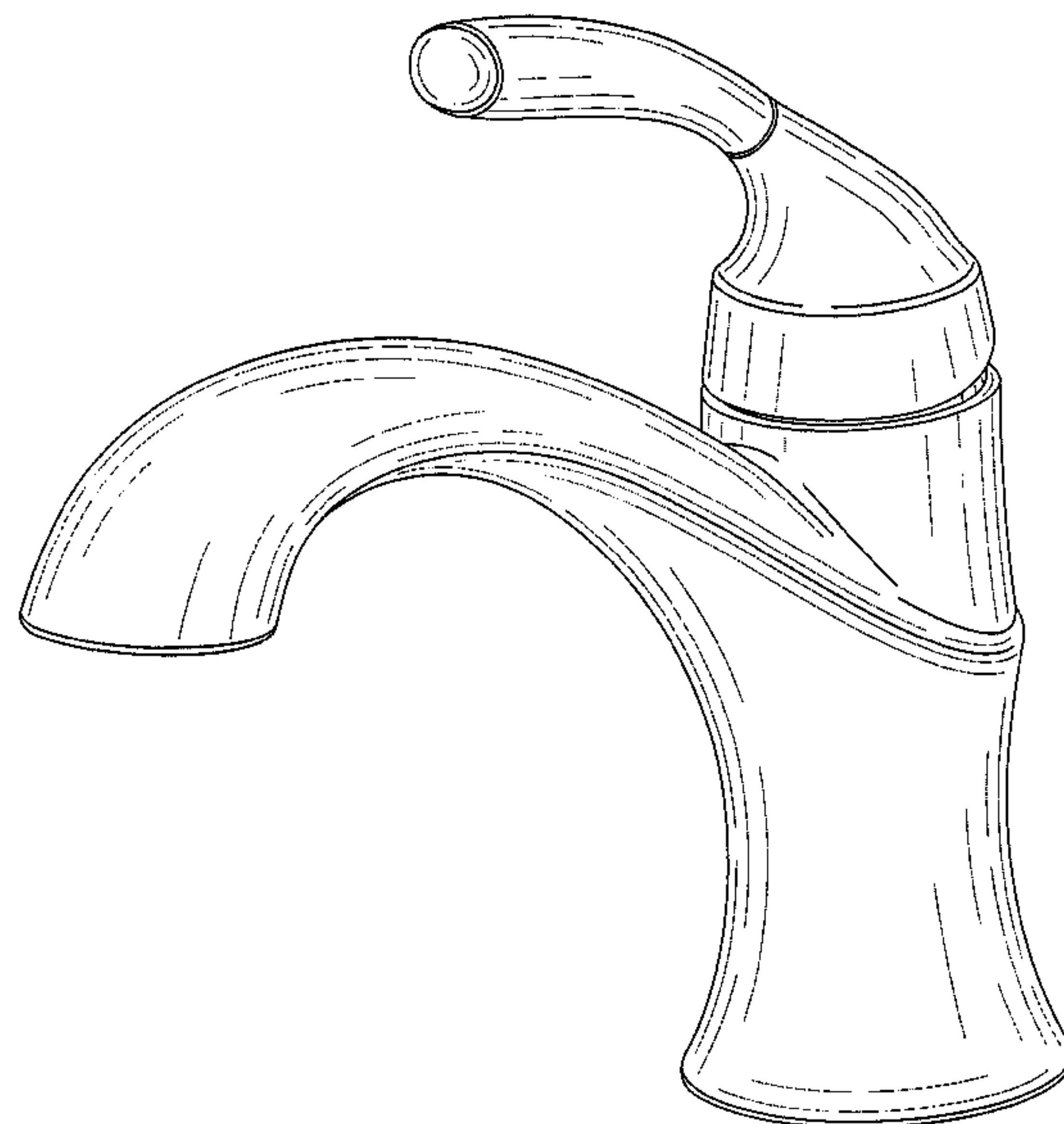
The broken lines shown in the drawings are for purposes of illustrating portions of the design and form no part of the claimed design.

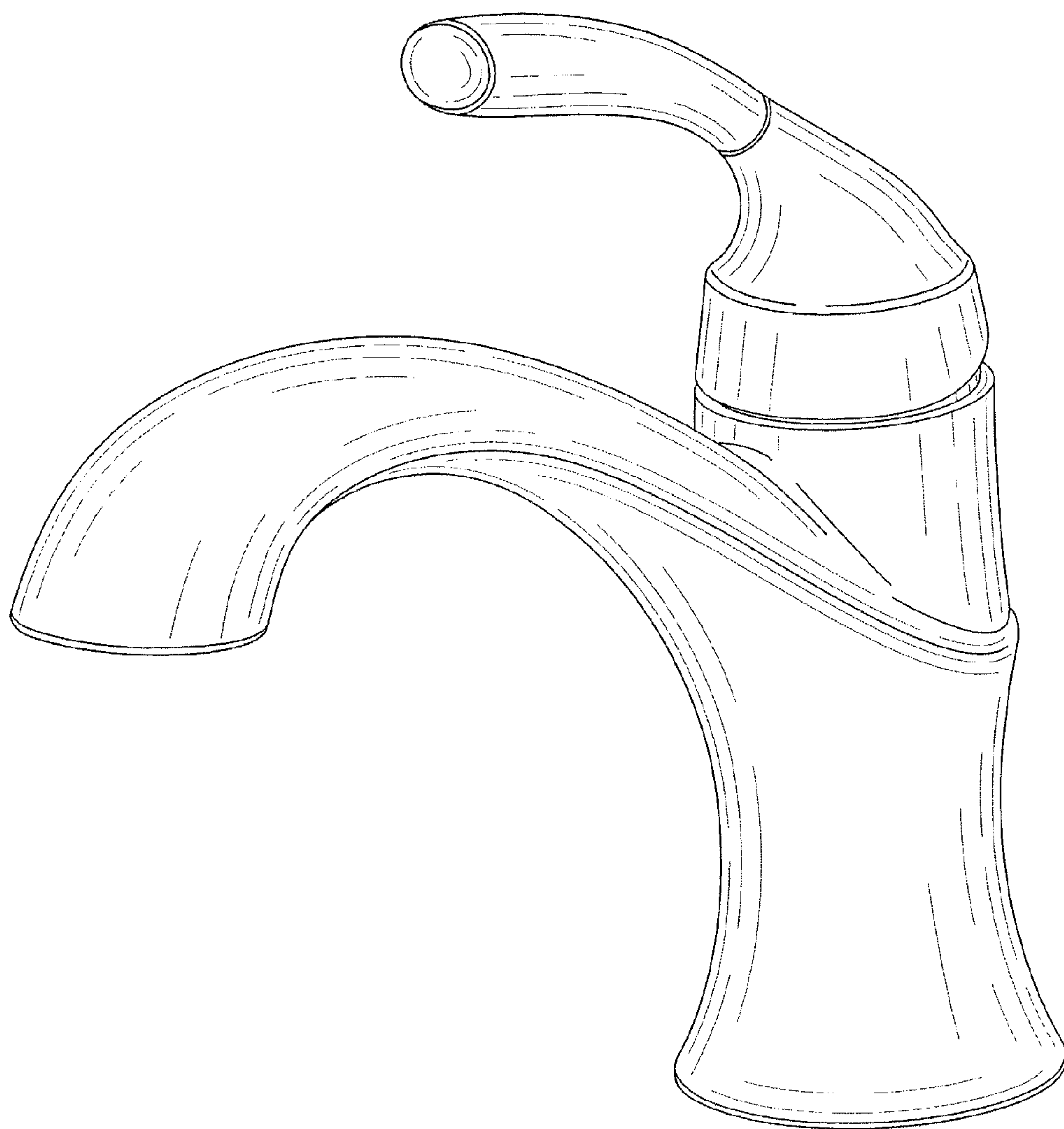

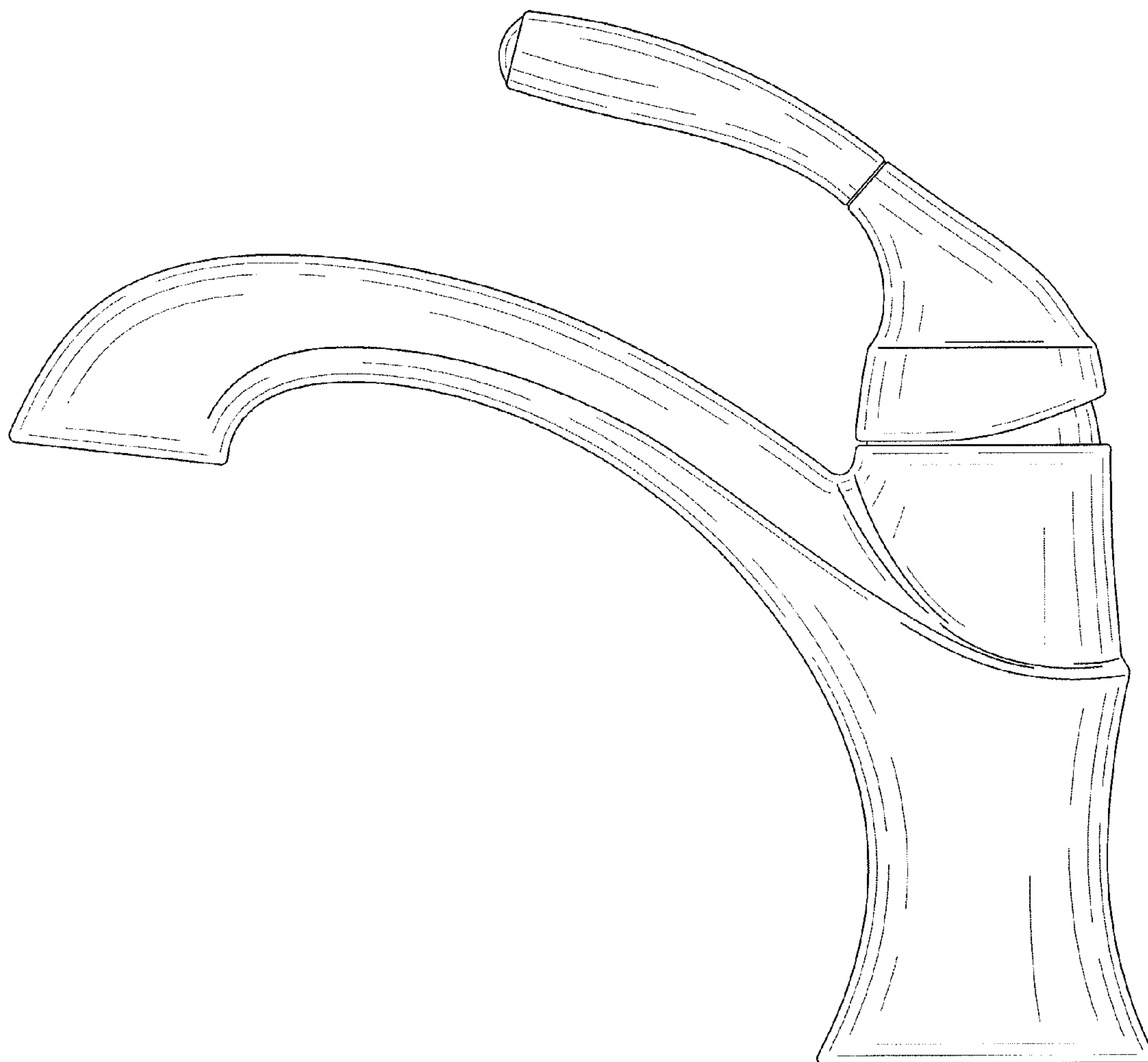

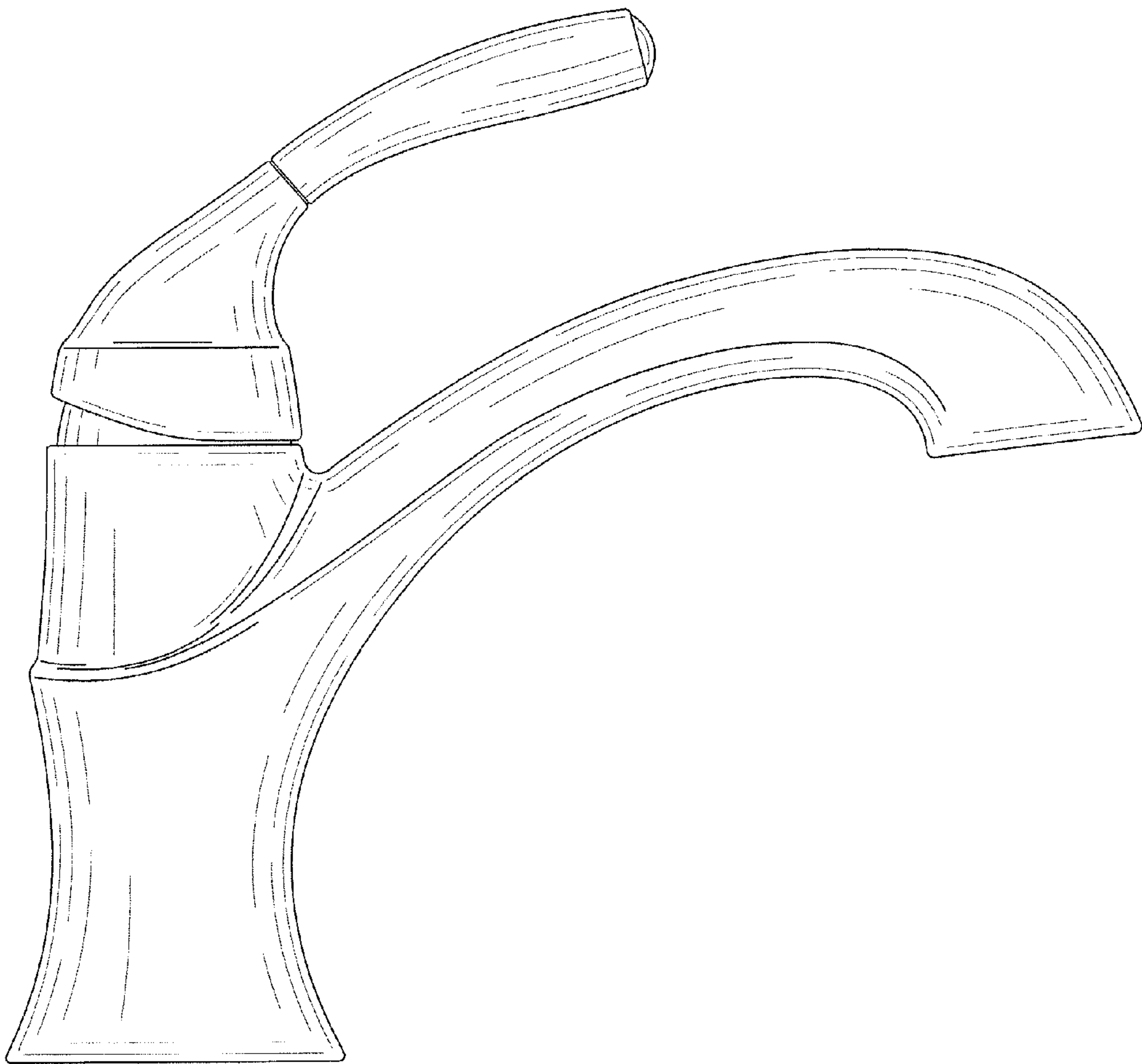

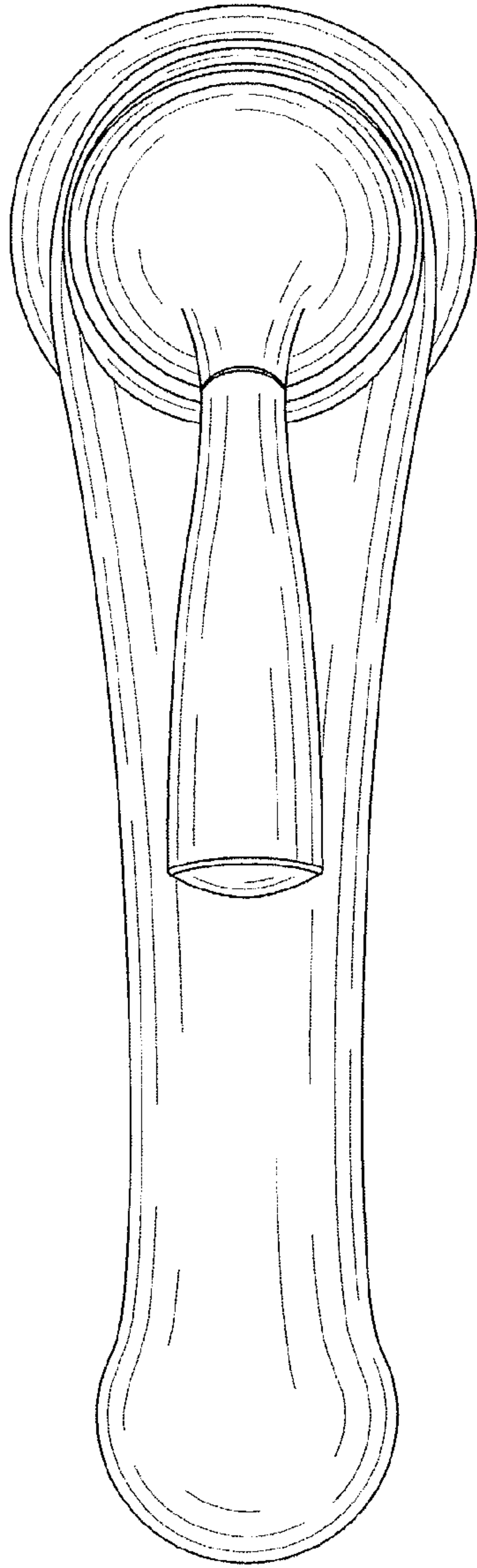

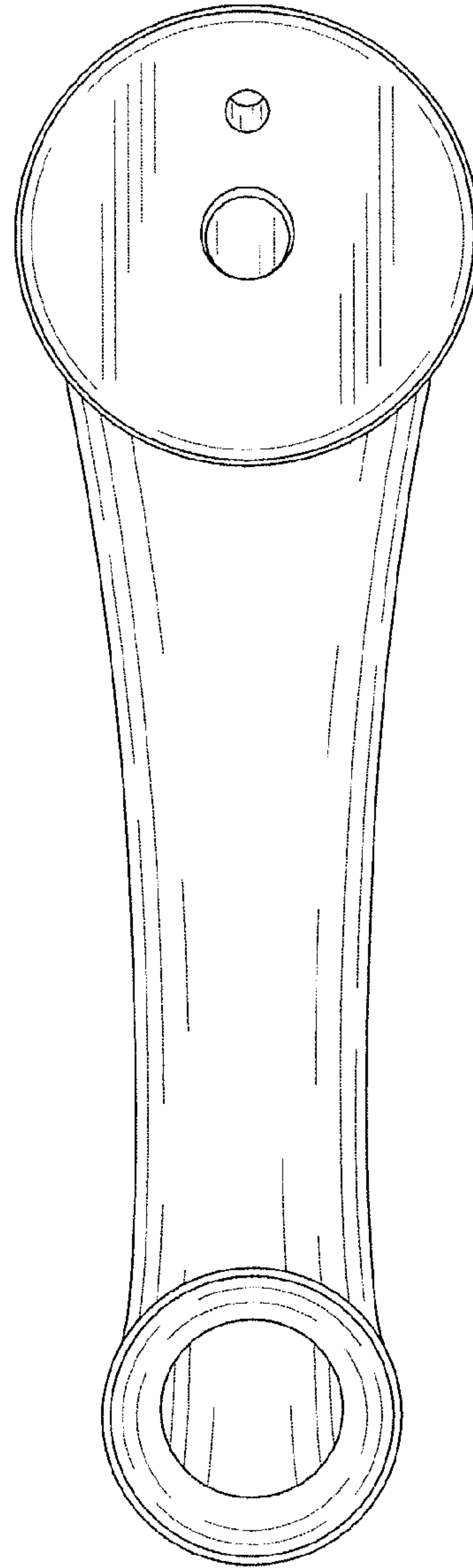

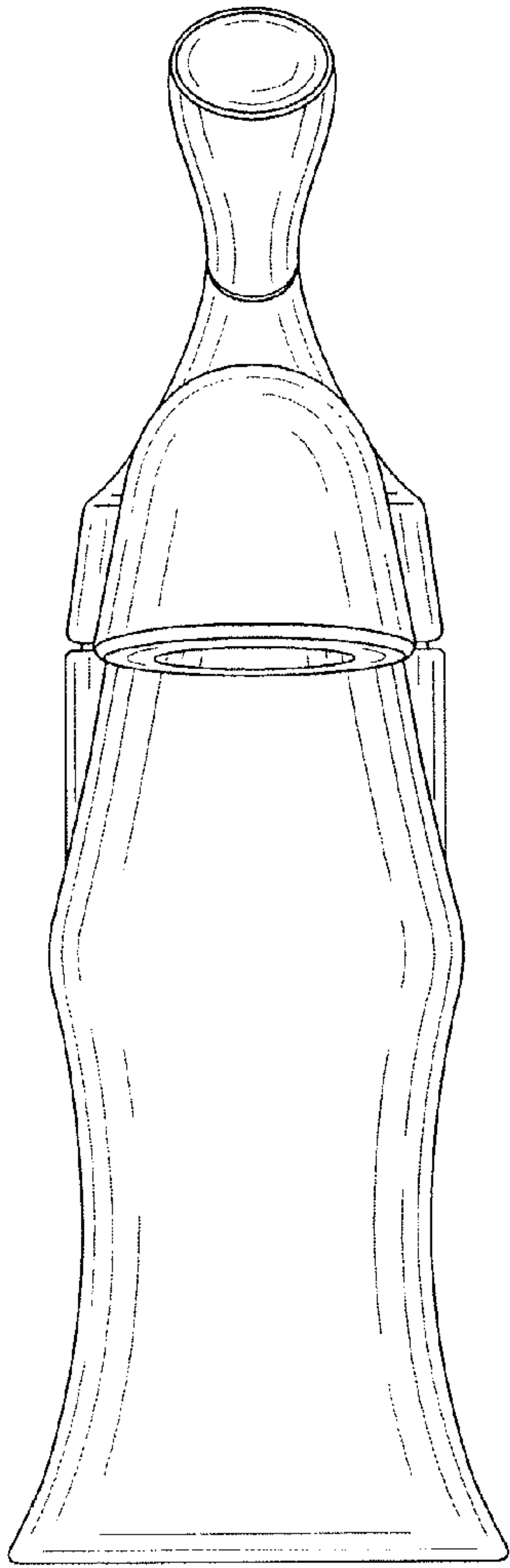

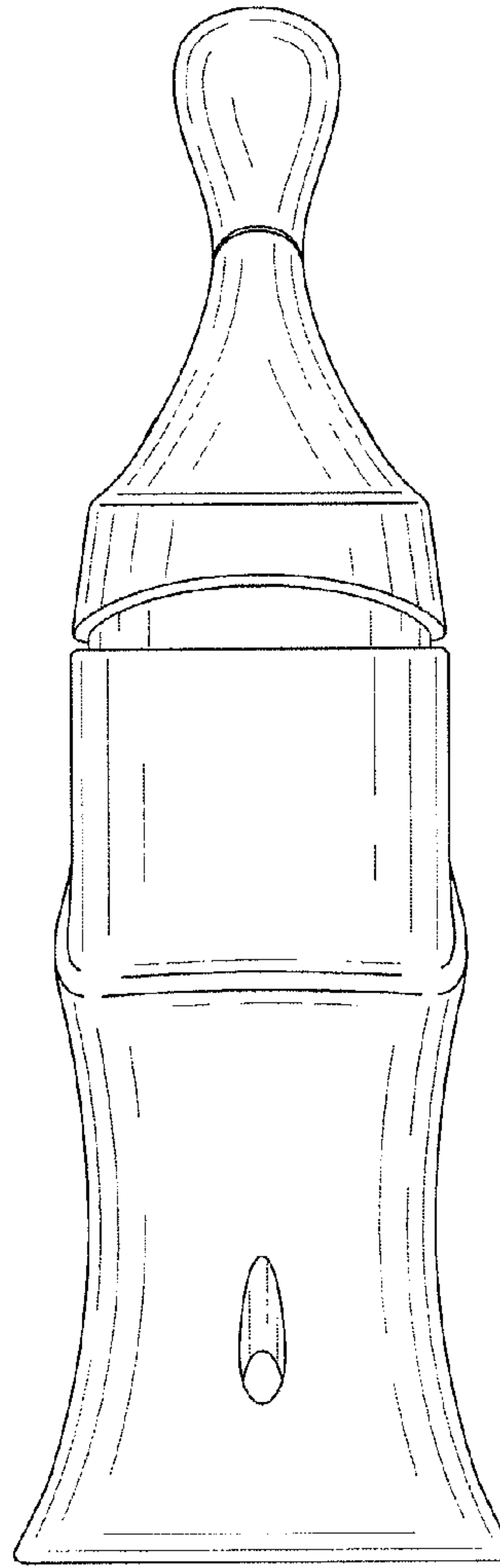
