(57) **CLAIM**

The ornamental design for a scalloped exterior of a garage door seal, as shown and described.

**DESCRIPTION**

FIG. 1 is a side perspective view showing my new design for the scalloped exterior of a garage door seal, the broken lines being for illustrative purposes only and forming no part of the claimed design;

FIG. 2 is a front elevational view thereof, the broken lines being for illustrative purposes only and forming no part of the claimed design;

FIG. 3 is rear elevational view thereof, the broken lines being for illustrative purposes only and forming no part of the claimed design;

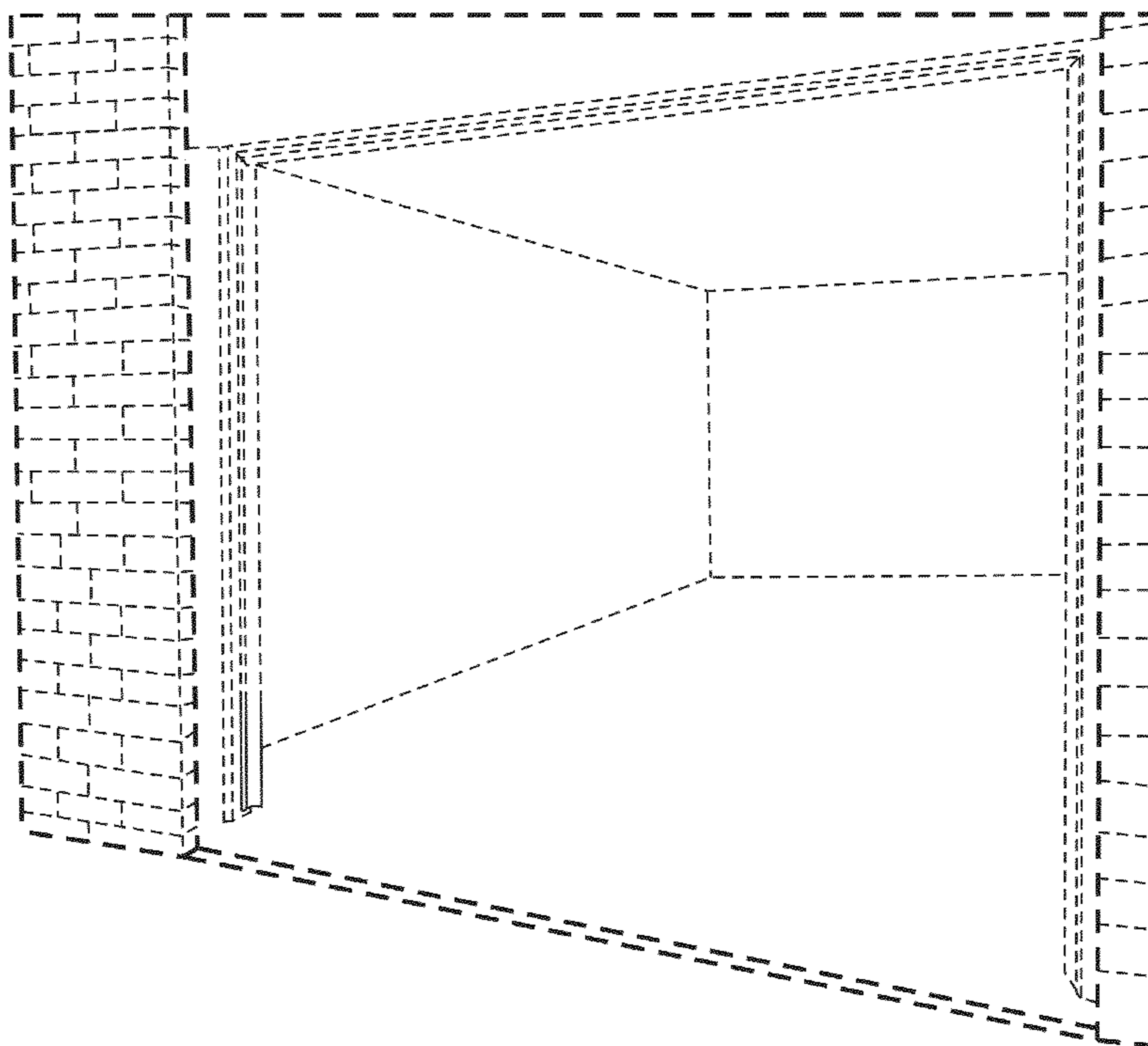
FIG. 4 is a right side view thereof. the broken lines being for illustrative purposes only and forming no part of the claimed design;

FIG. 5 is a left side view thereof, the broken lines being for illustrative purposes only and forming no part of the claimed design;

FIG. 6 is a top plan view illustrating the present invention affixed to the sidewall of a garage door opening, the sidewall and top wall of the garage door opening illustrated in broken lines and forming no part of the claimed design; and,

FIG. 7 is a perspective view of the invention installed on both sidewalls and the top wall of a garage door opening, the broken lines being for illustrative purposes only and forming no part of the claimed design.

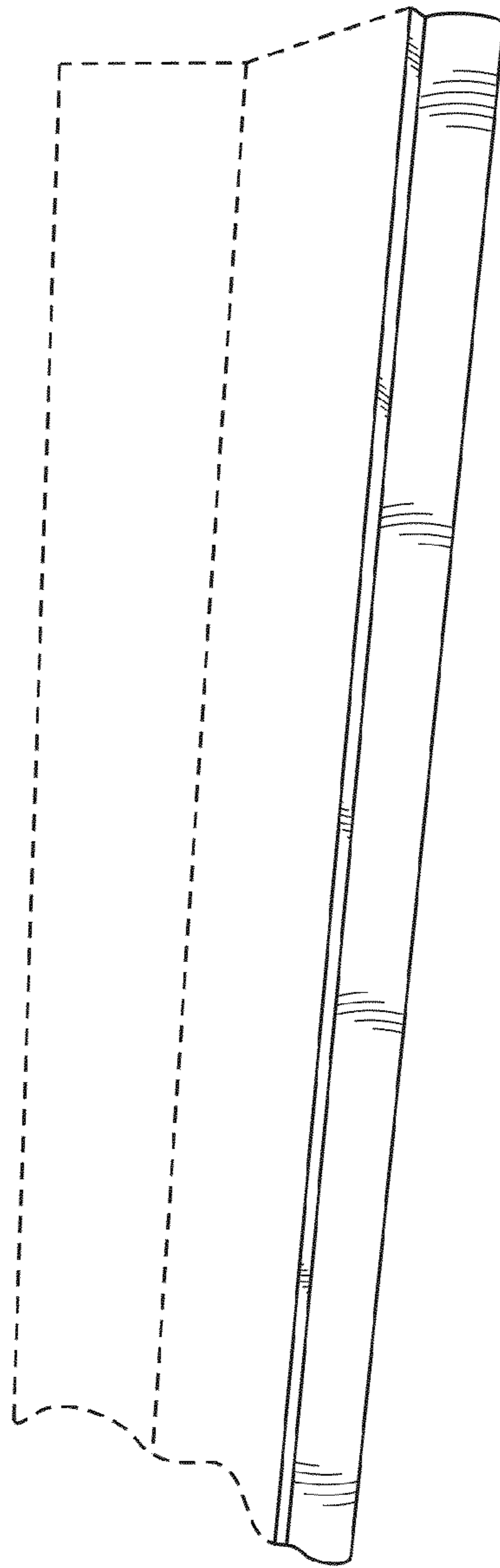

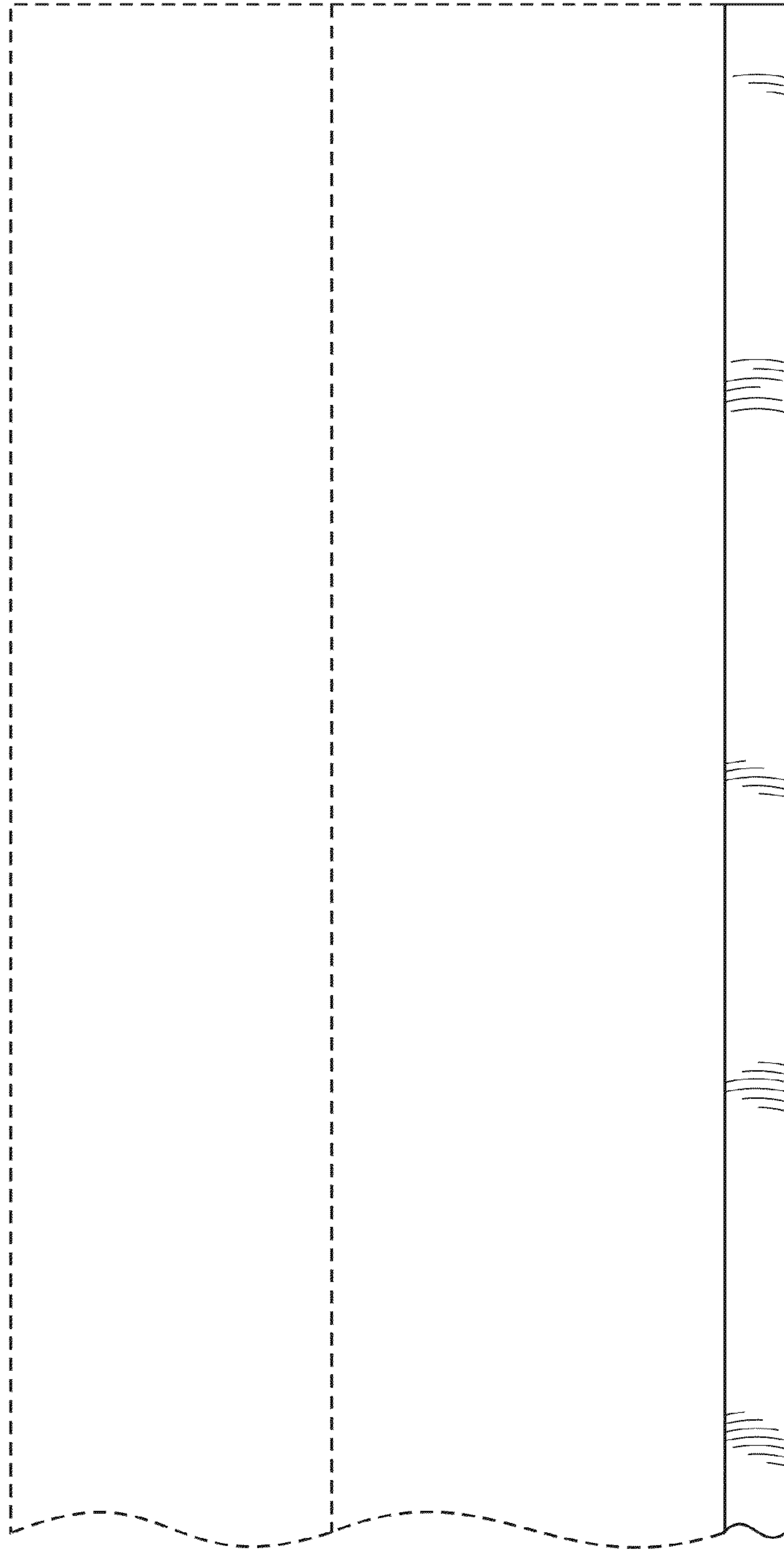

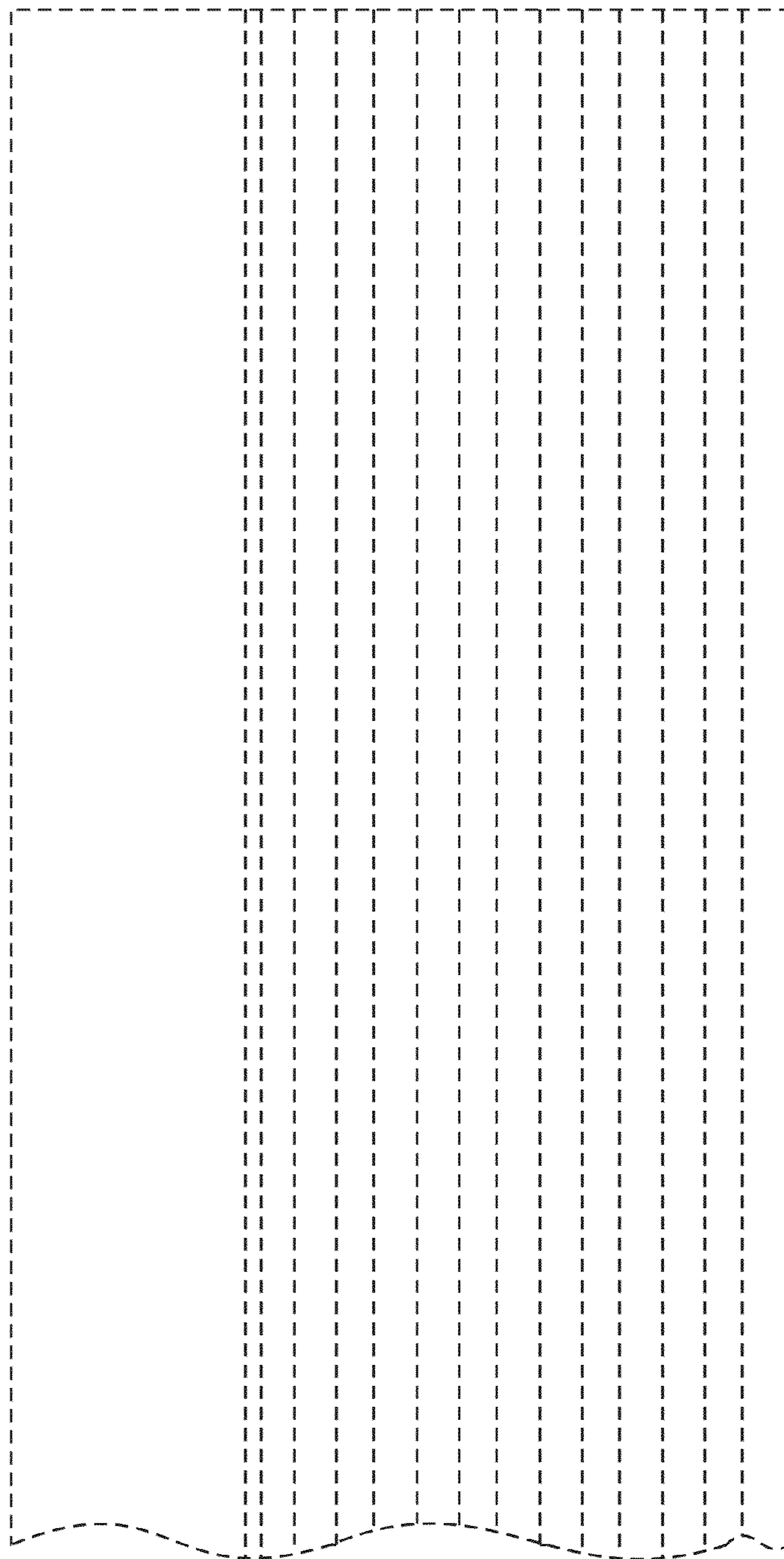

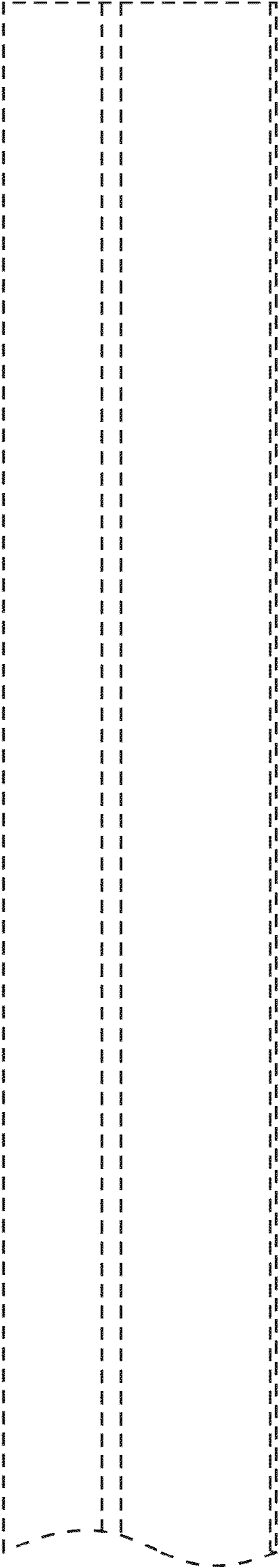

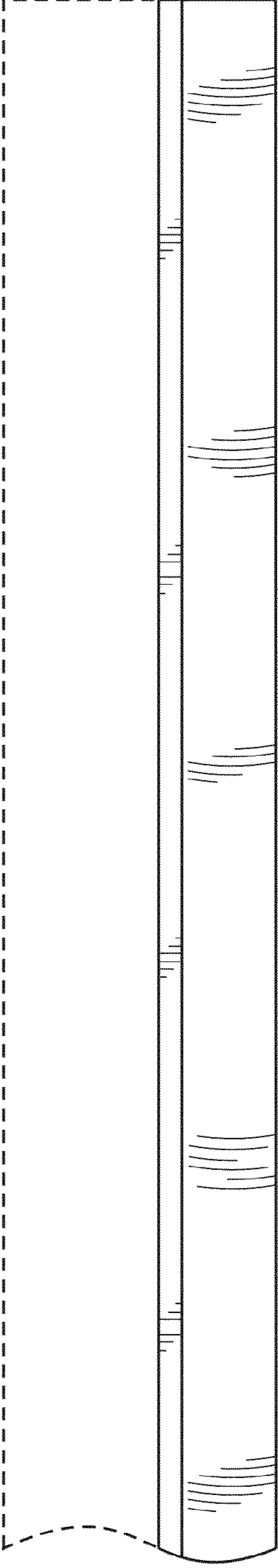

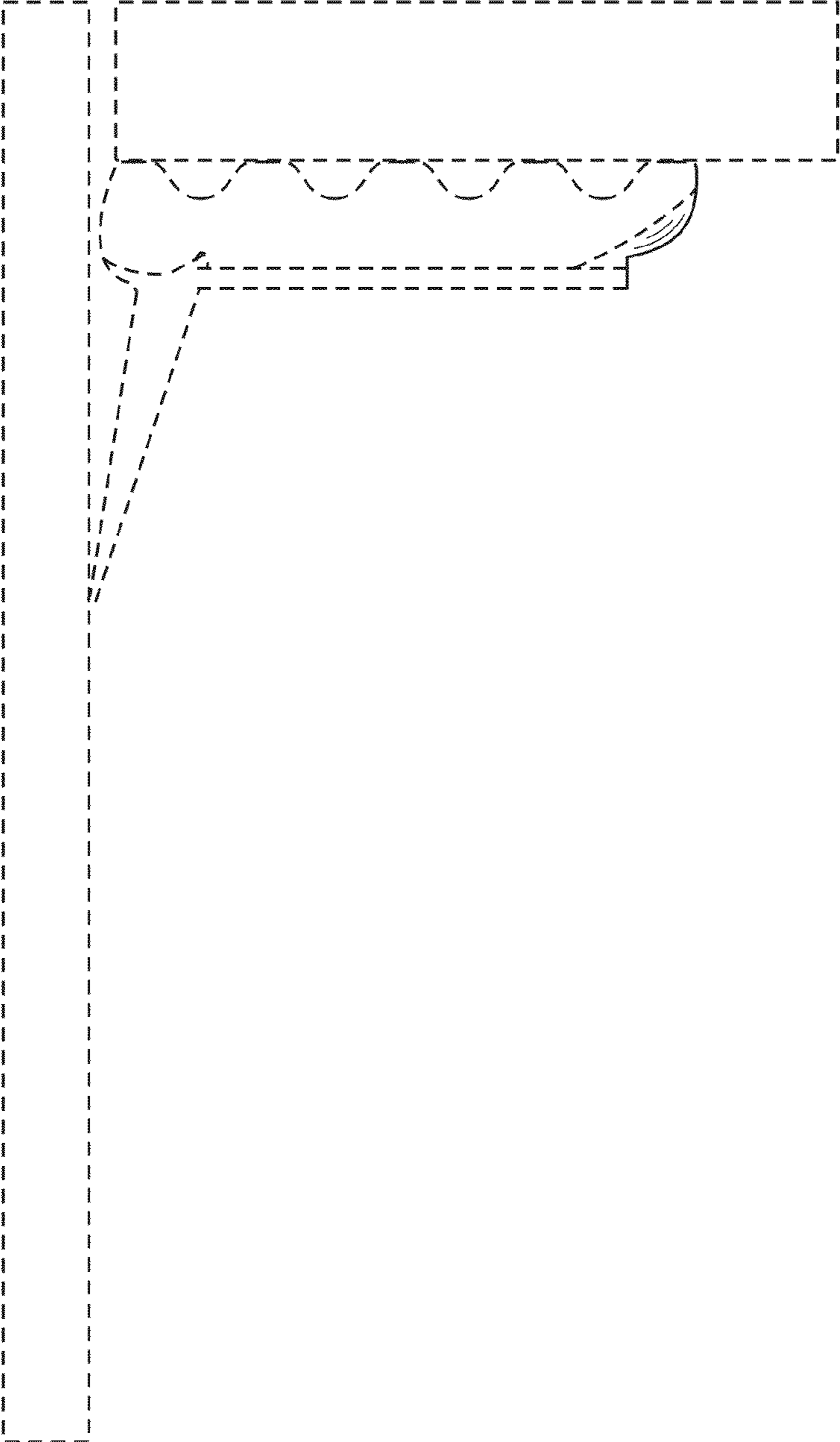

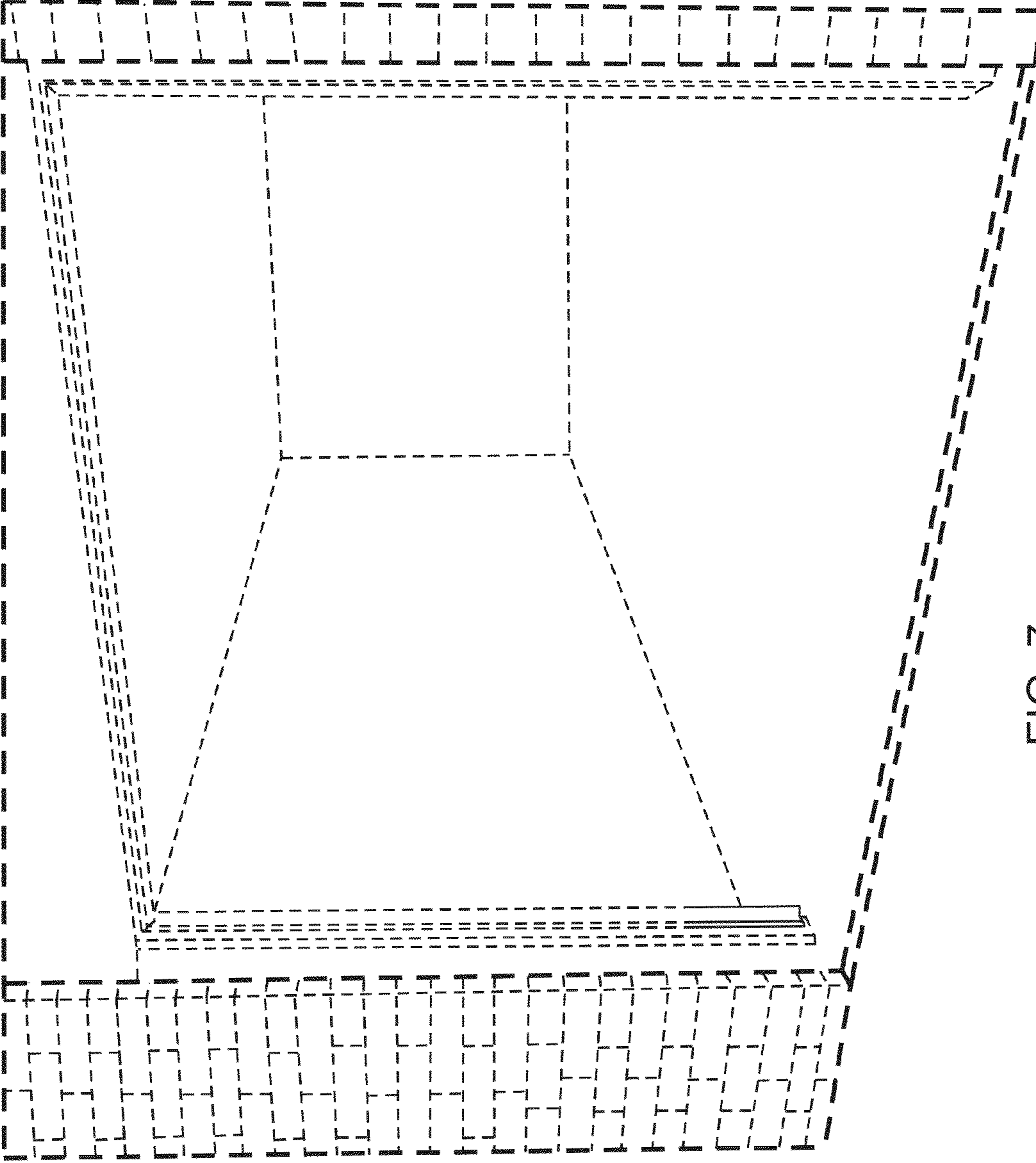
