The ornamental design for an animal carrier, as shown and described.

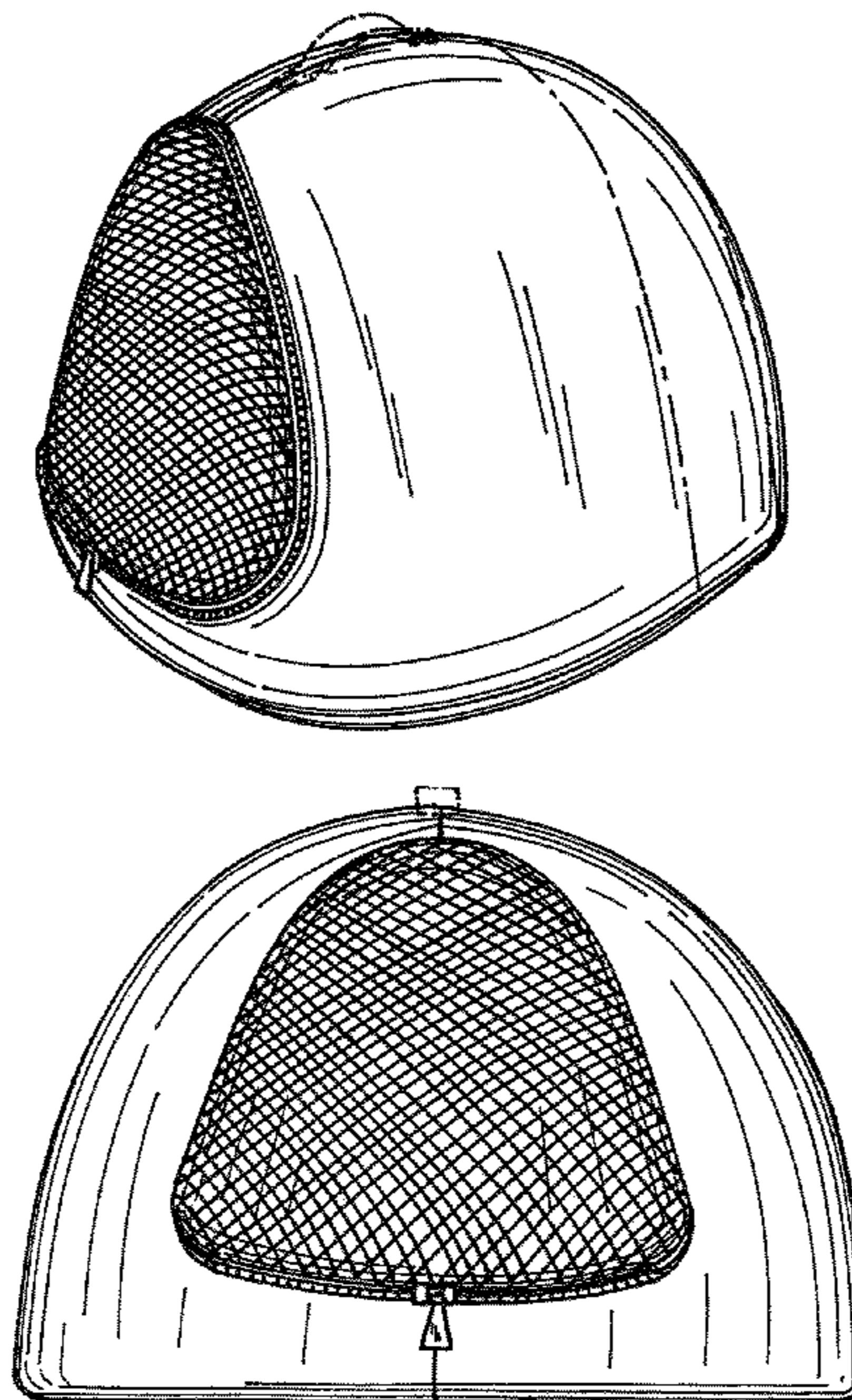
DESCRIPTION

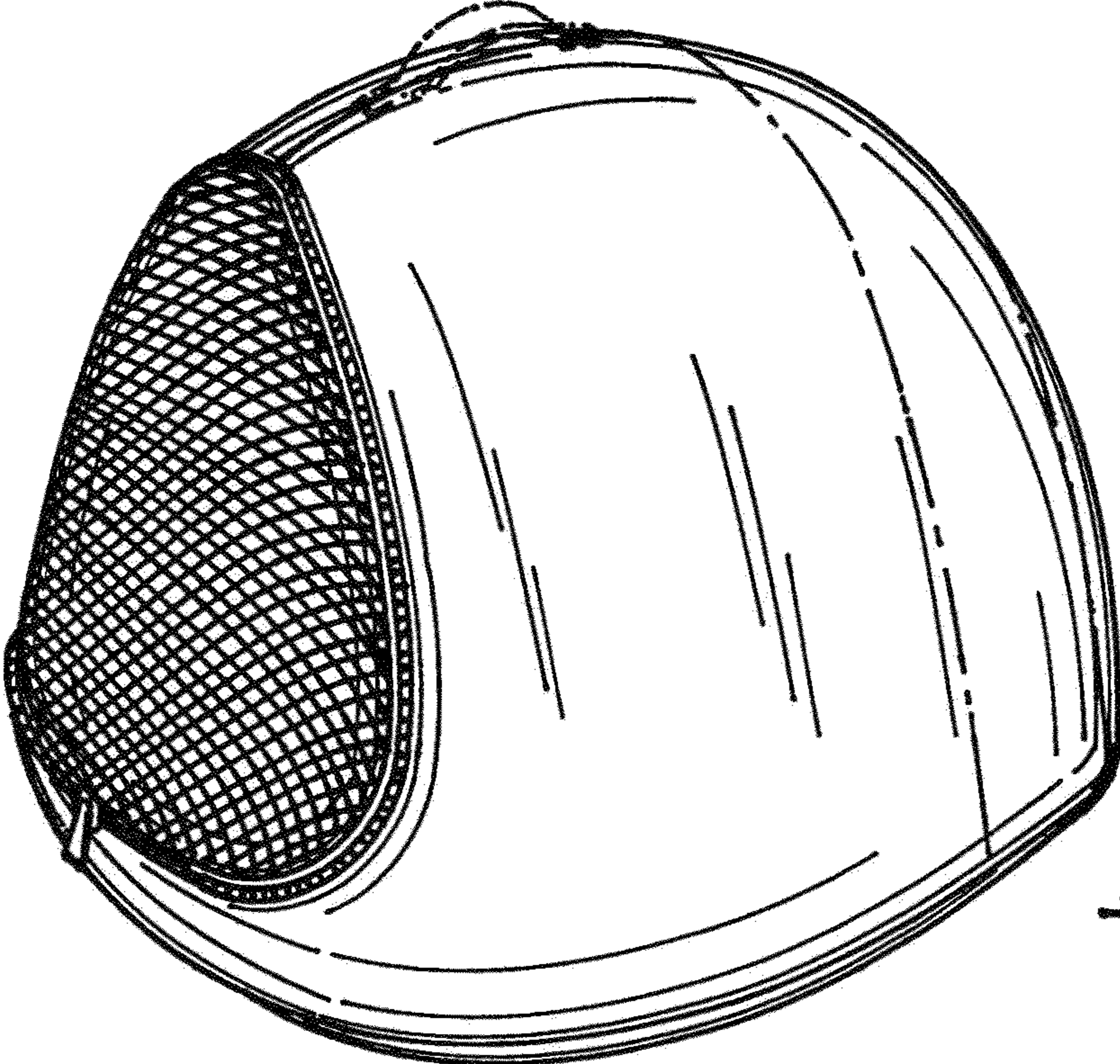

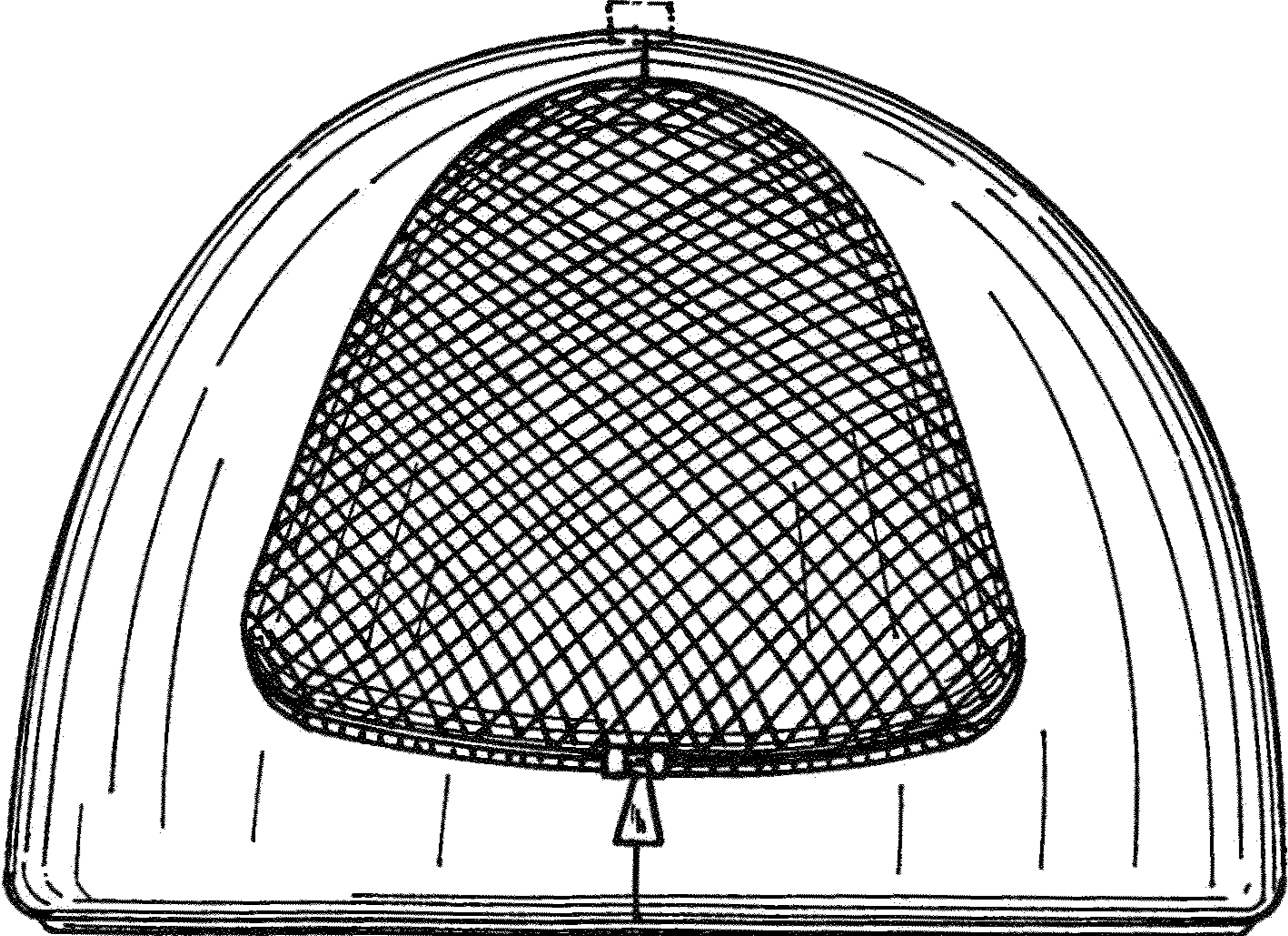

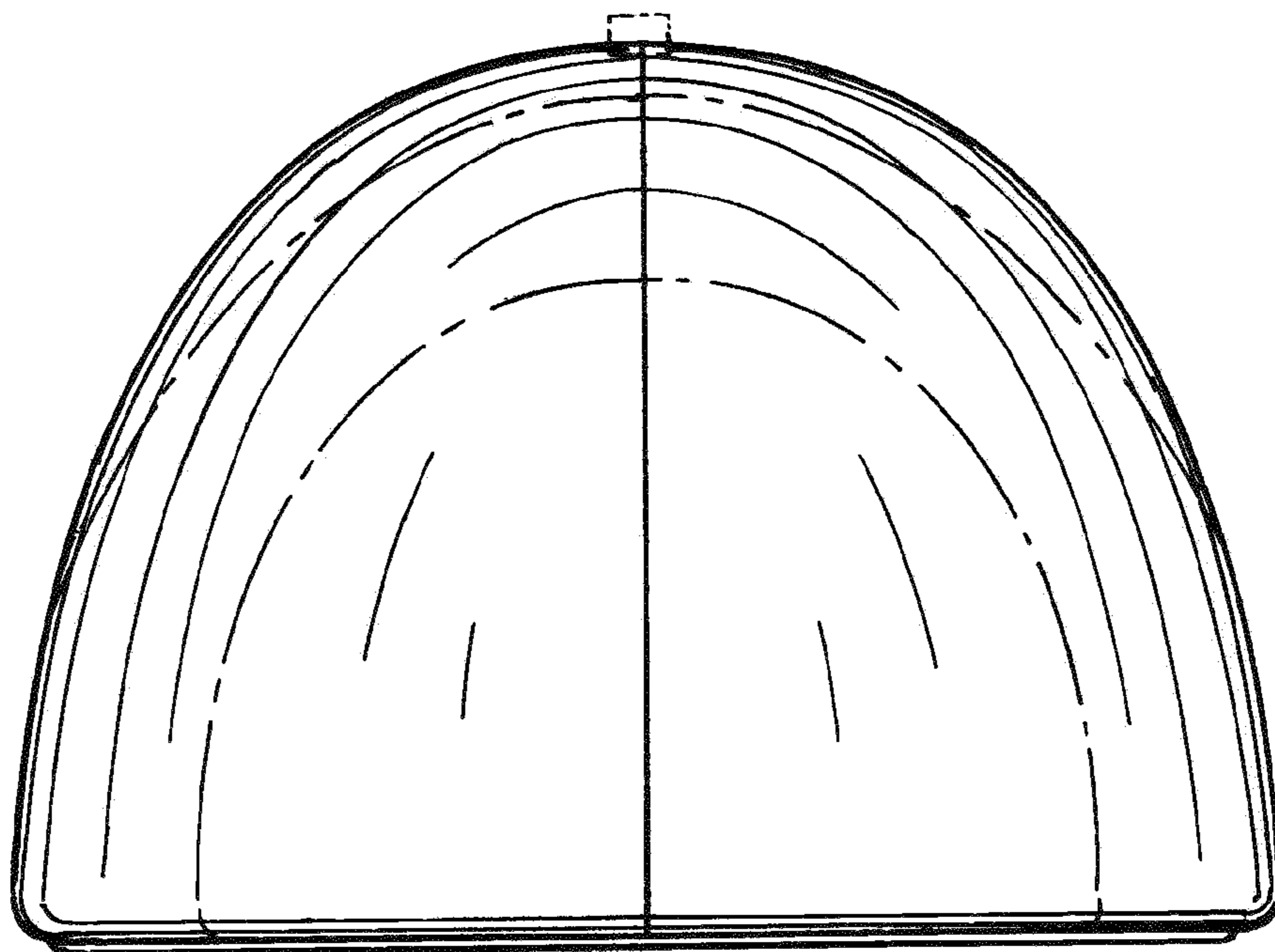

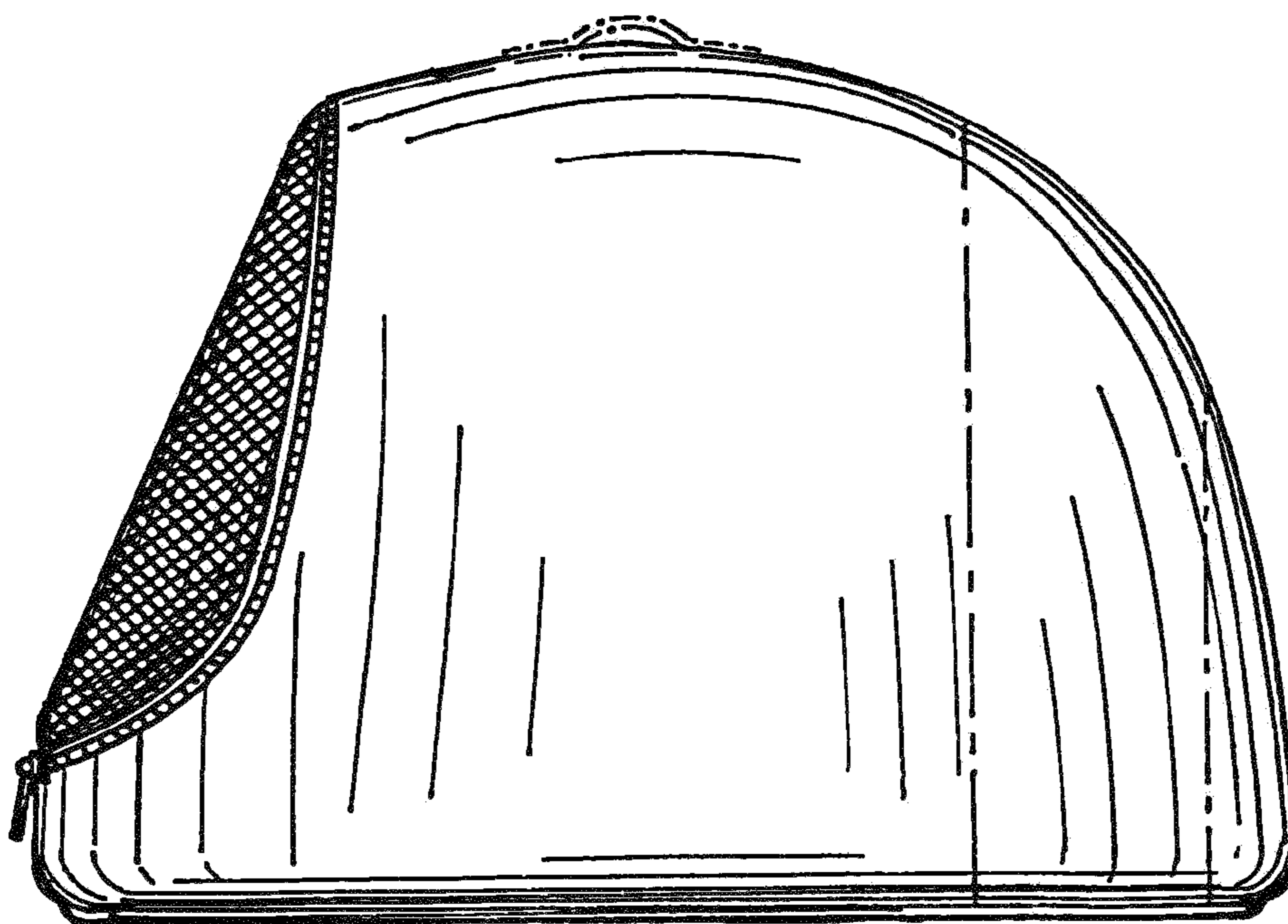

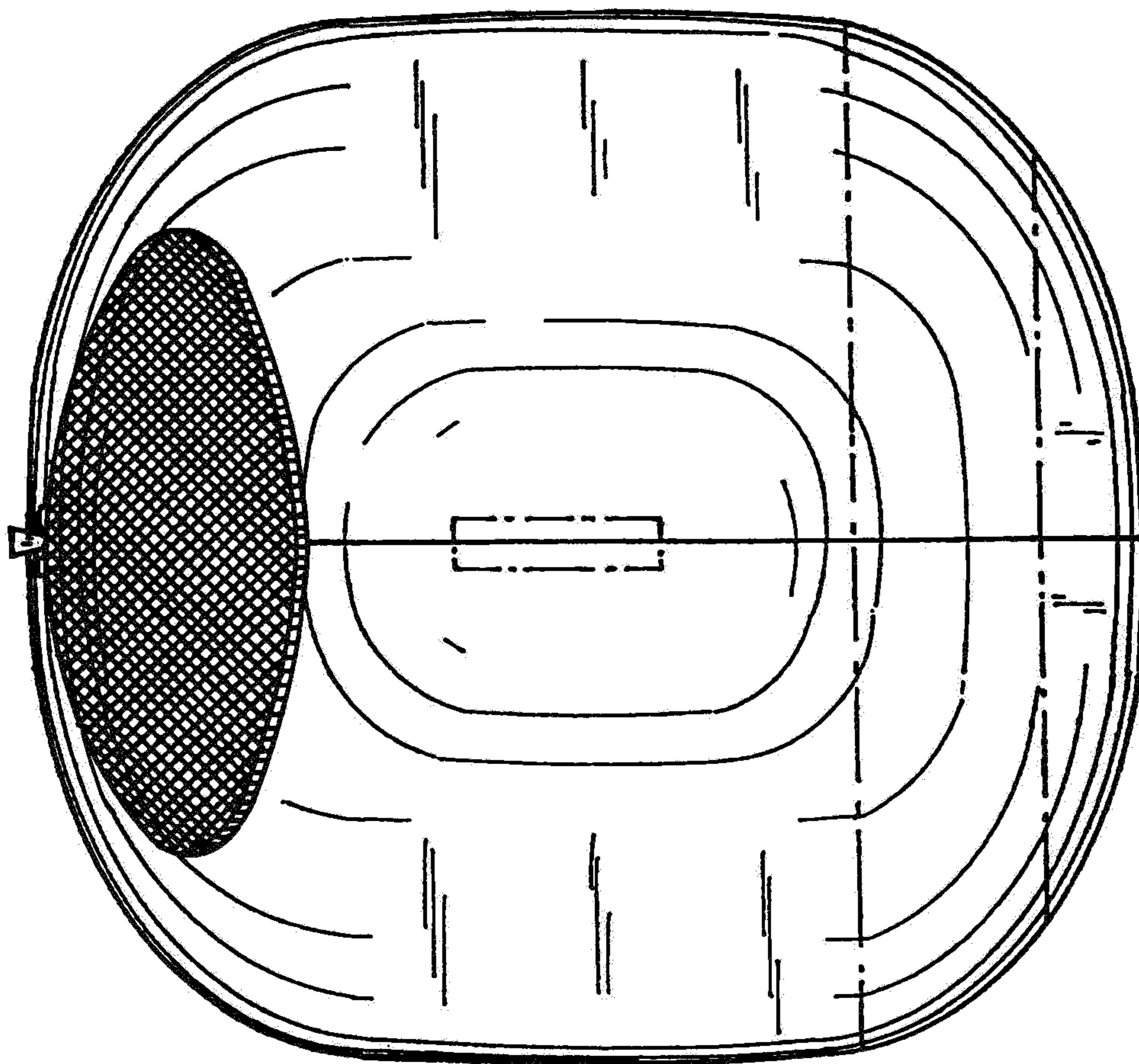

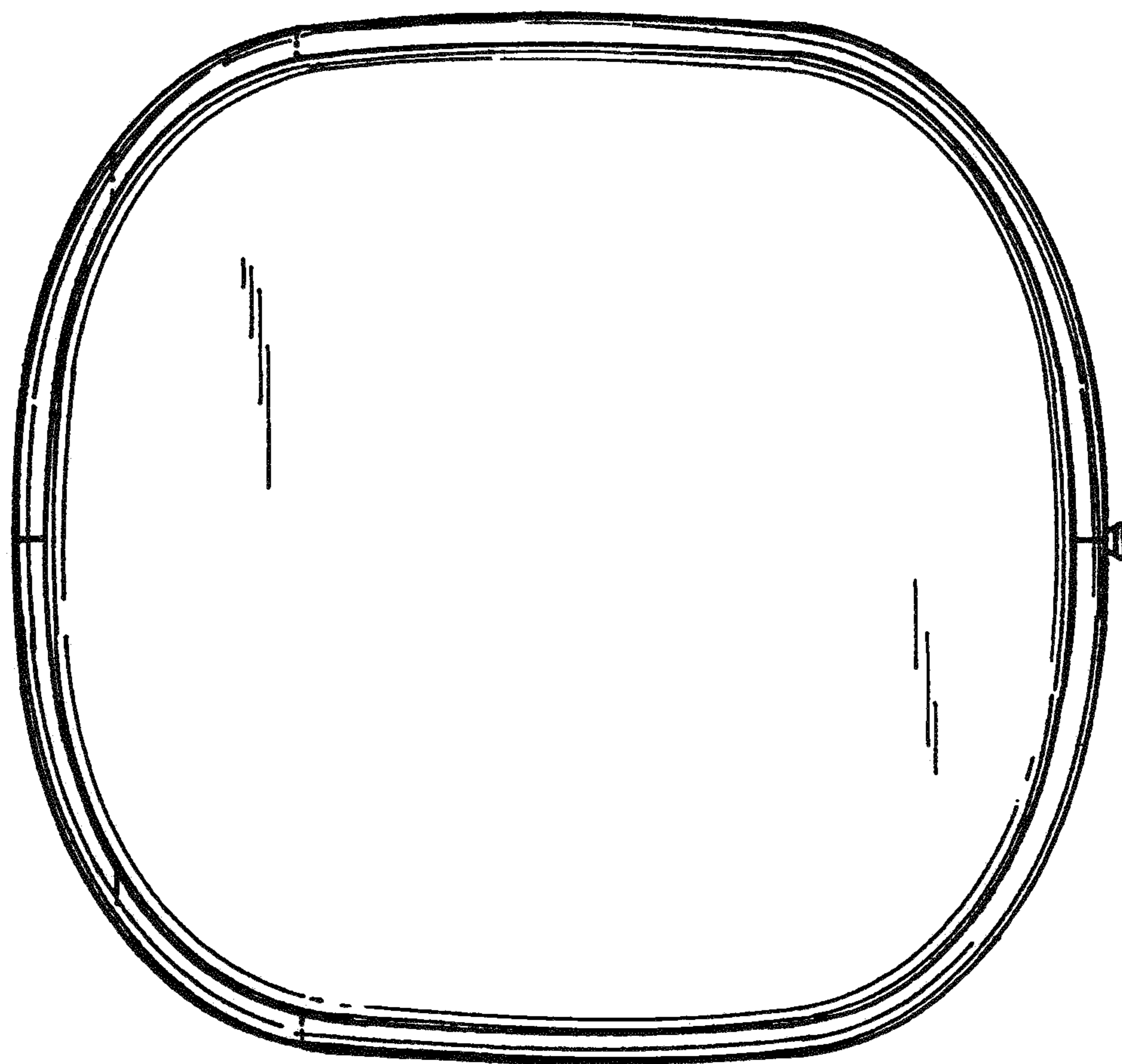
