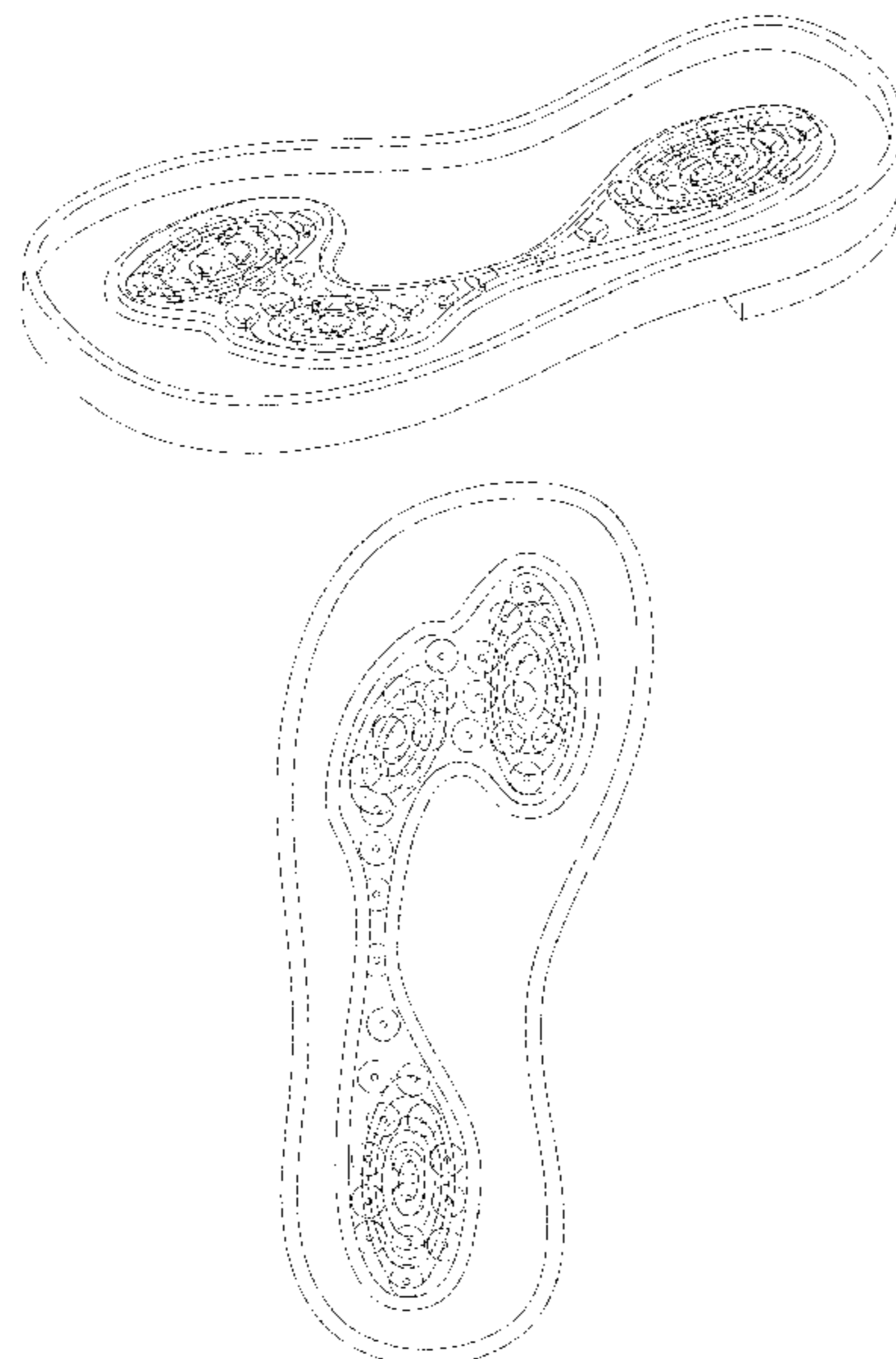

(57) **CLAIM**  
The ornamental design for an outsole portion and midsole portion of a footwear sole, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an outsole portion and midsole portion of a footwear sole showing my new design;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is a bottom plan view thereof;  
FIG. 4 is a left side view thereof;  
FIG. 5 is a right side view thereof;  
FIG. 6 is a front view thereof;  
FIG. 7 is a rear view thereof;  
FIG. 8 is a perspective view of the outsole portion and midsole portion of the footwear sole with a footbed to be fitted therein; and,  
FIG. 9 is a perspective view of the outsole portion and midsole portion of the footwear sole with the footbed fitted therein.  
The broken line showing in FIGS. 8 and 9 is for illustrative purposes only and forms no part of the claimed design.

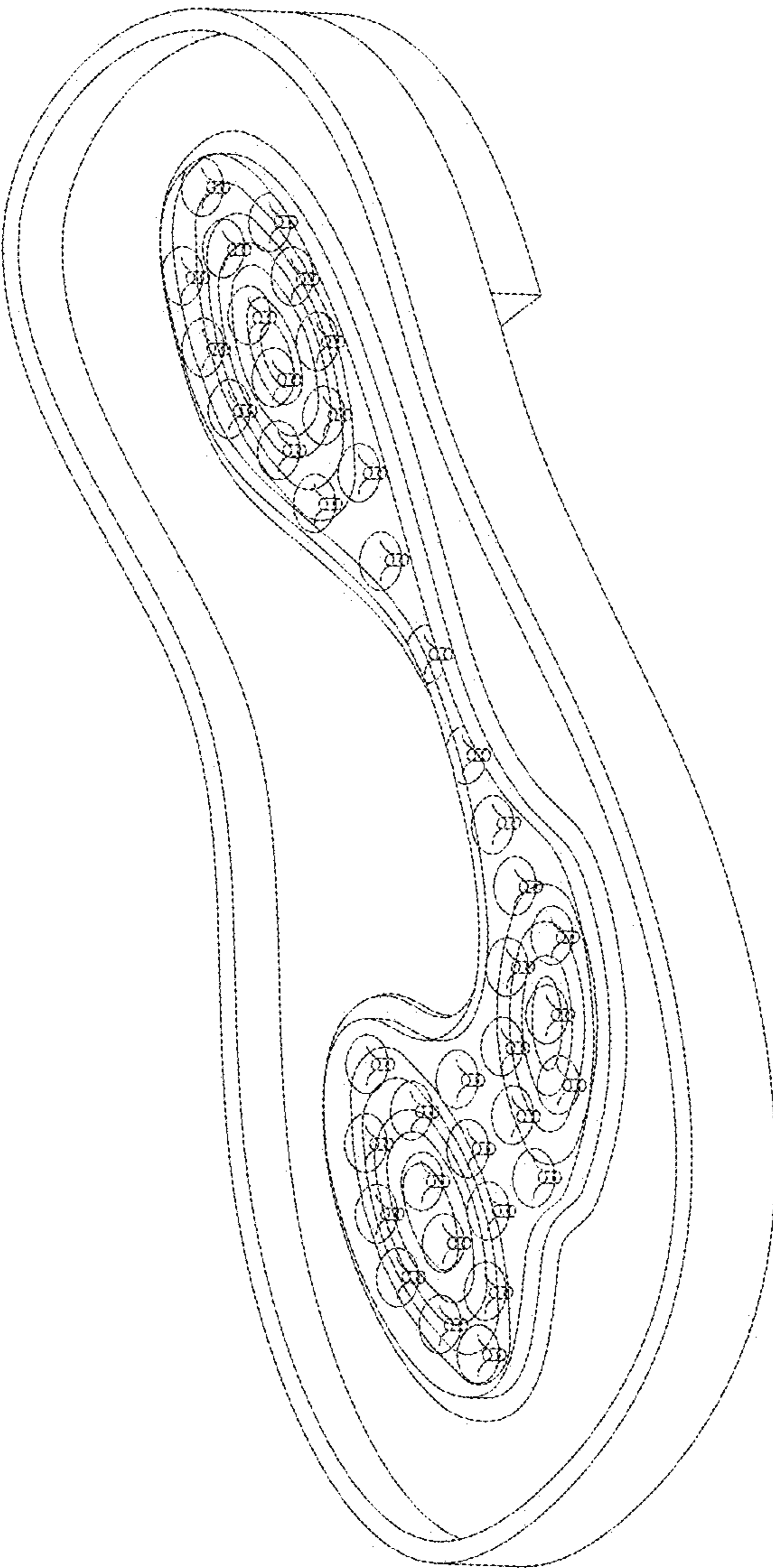

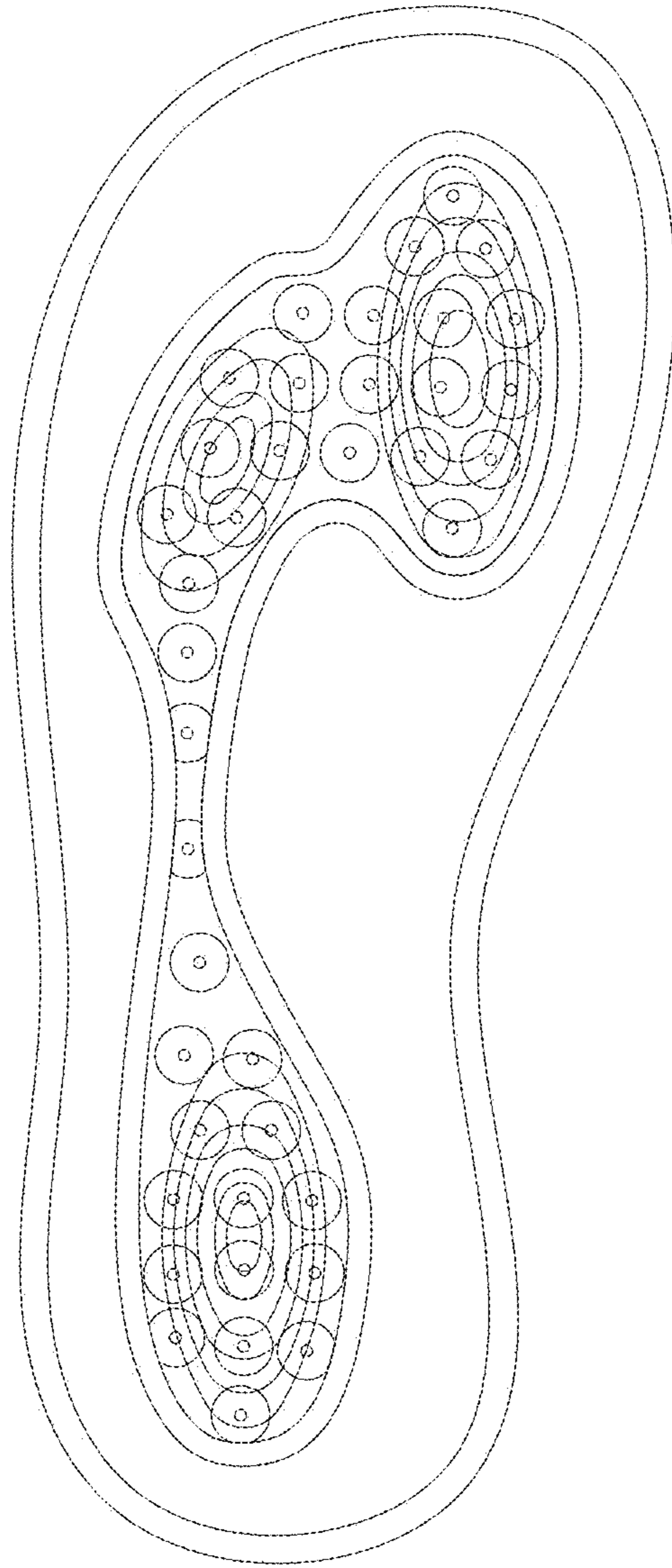

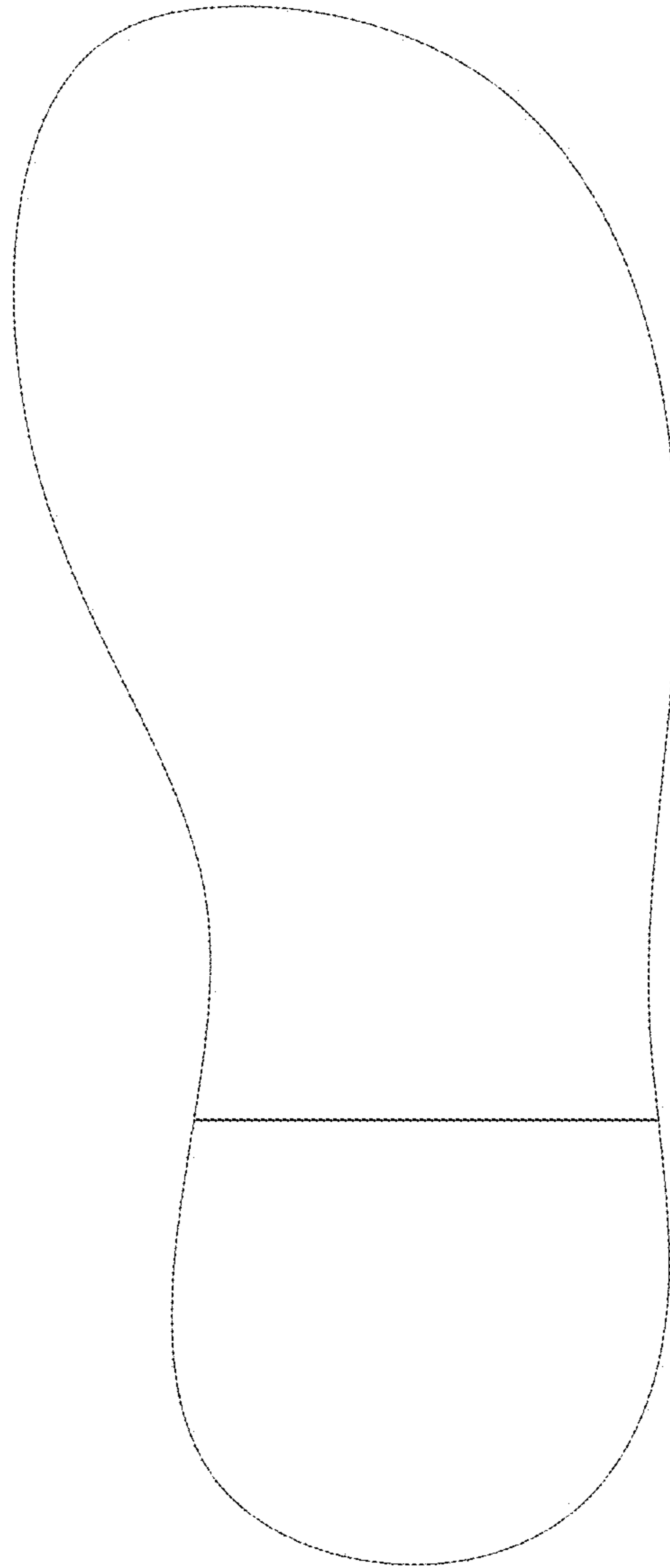

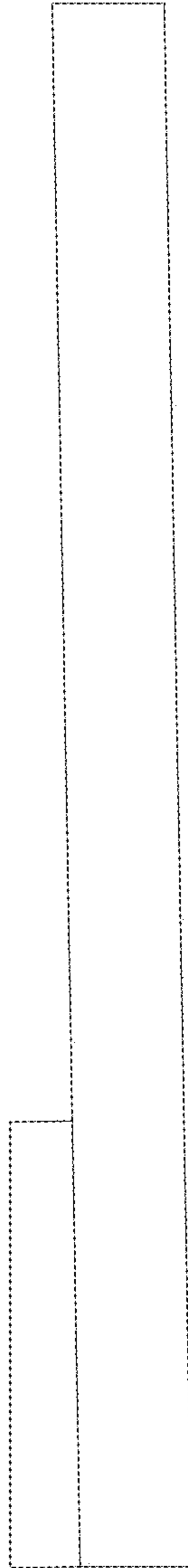

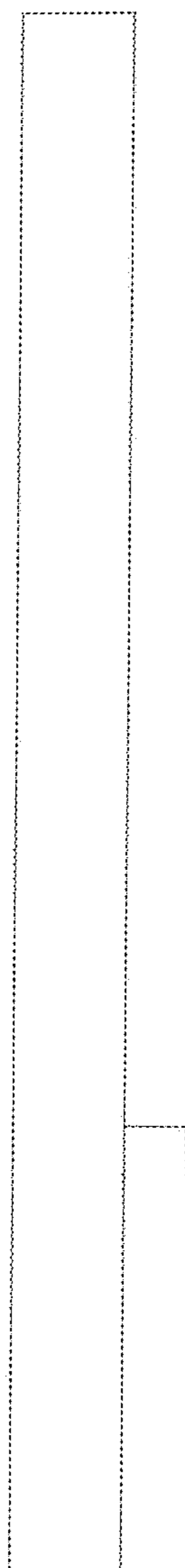

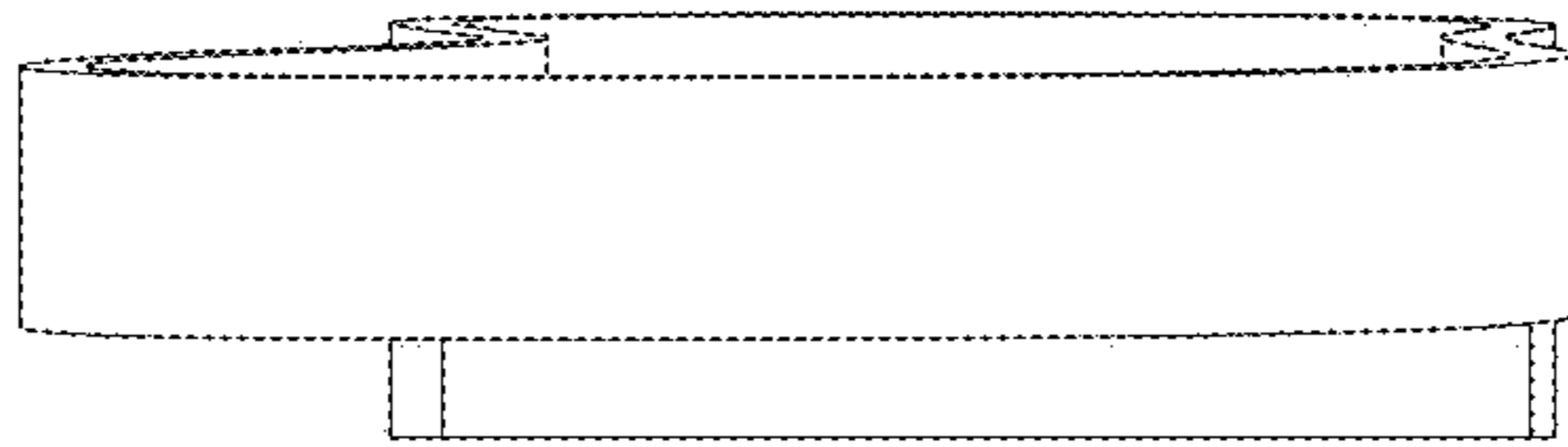

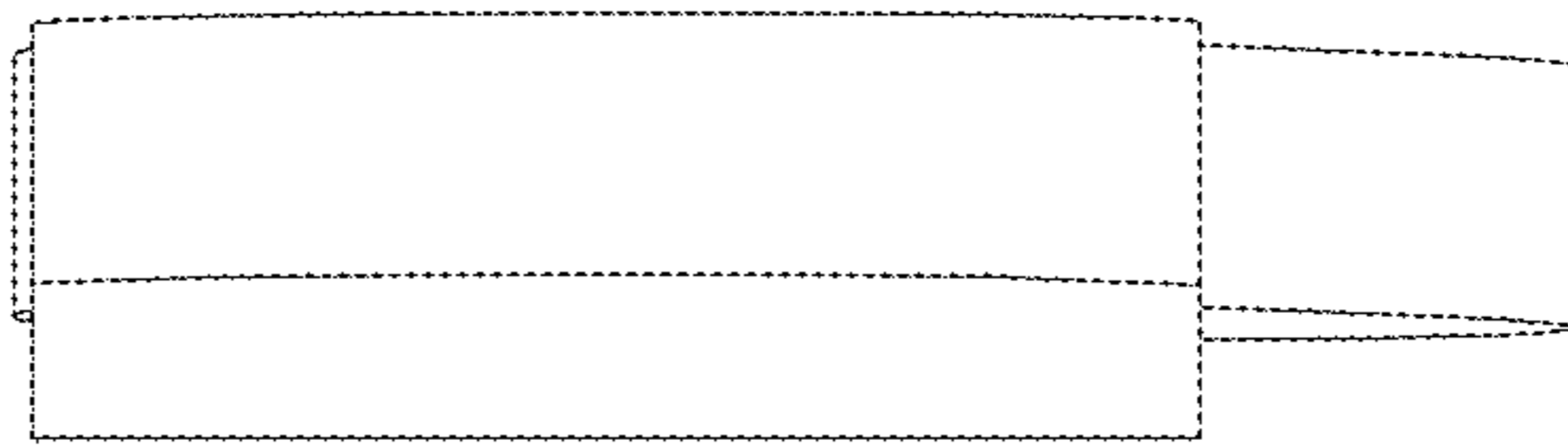

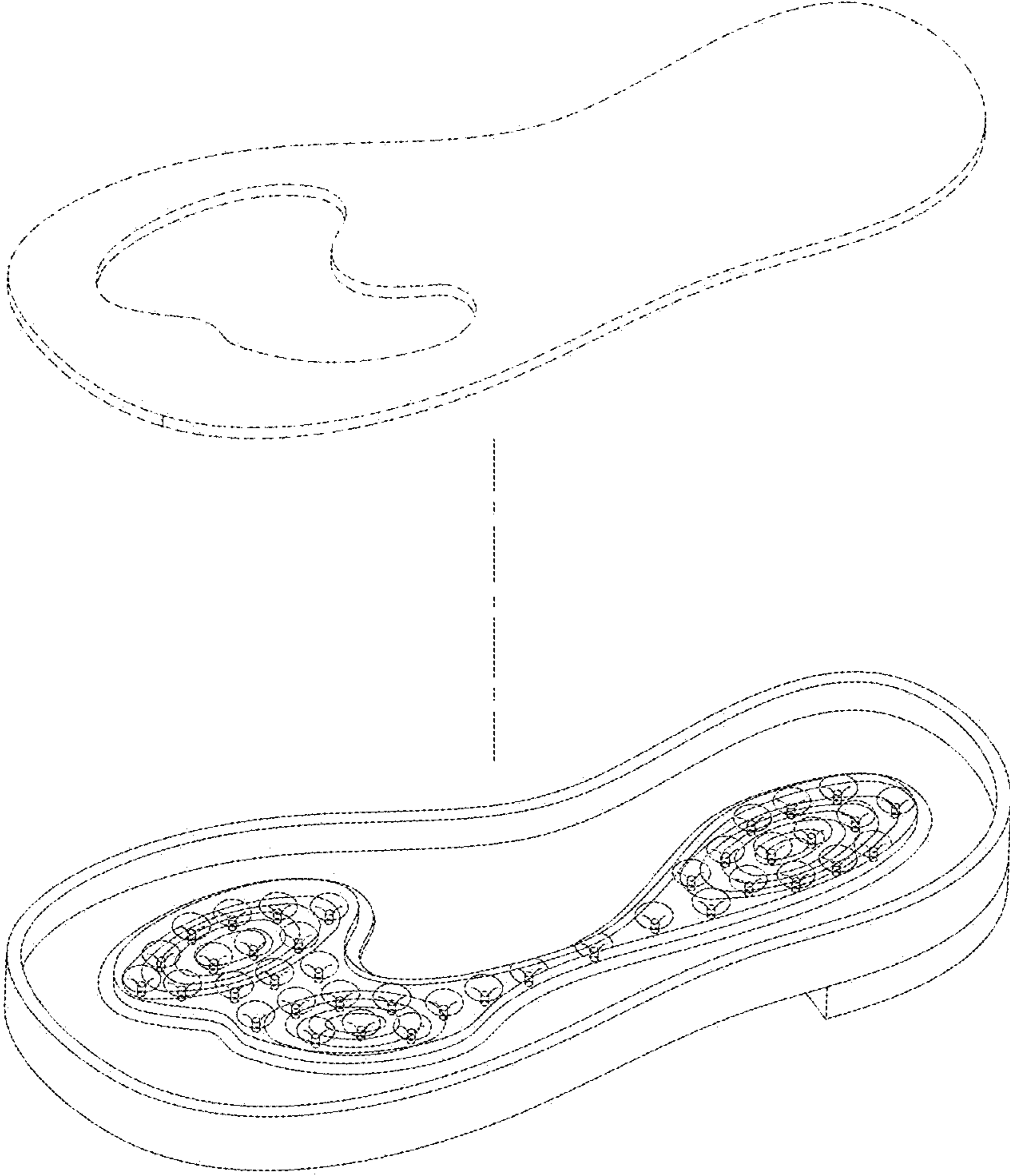

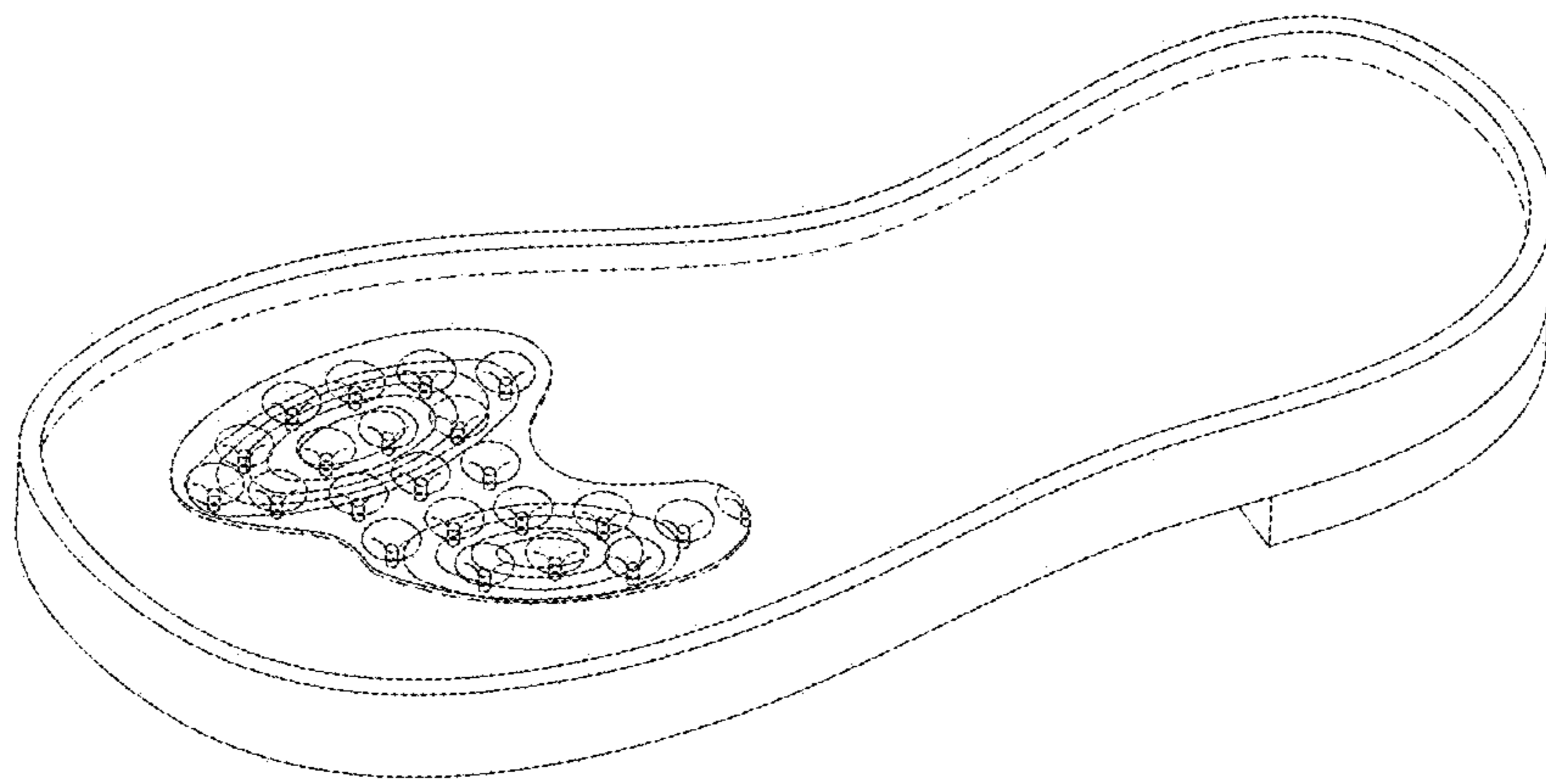
