(57) **CLAIM**

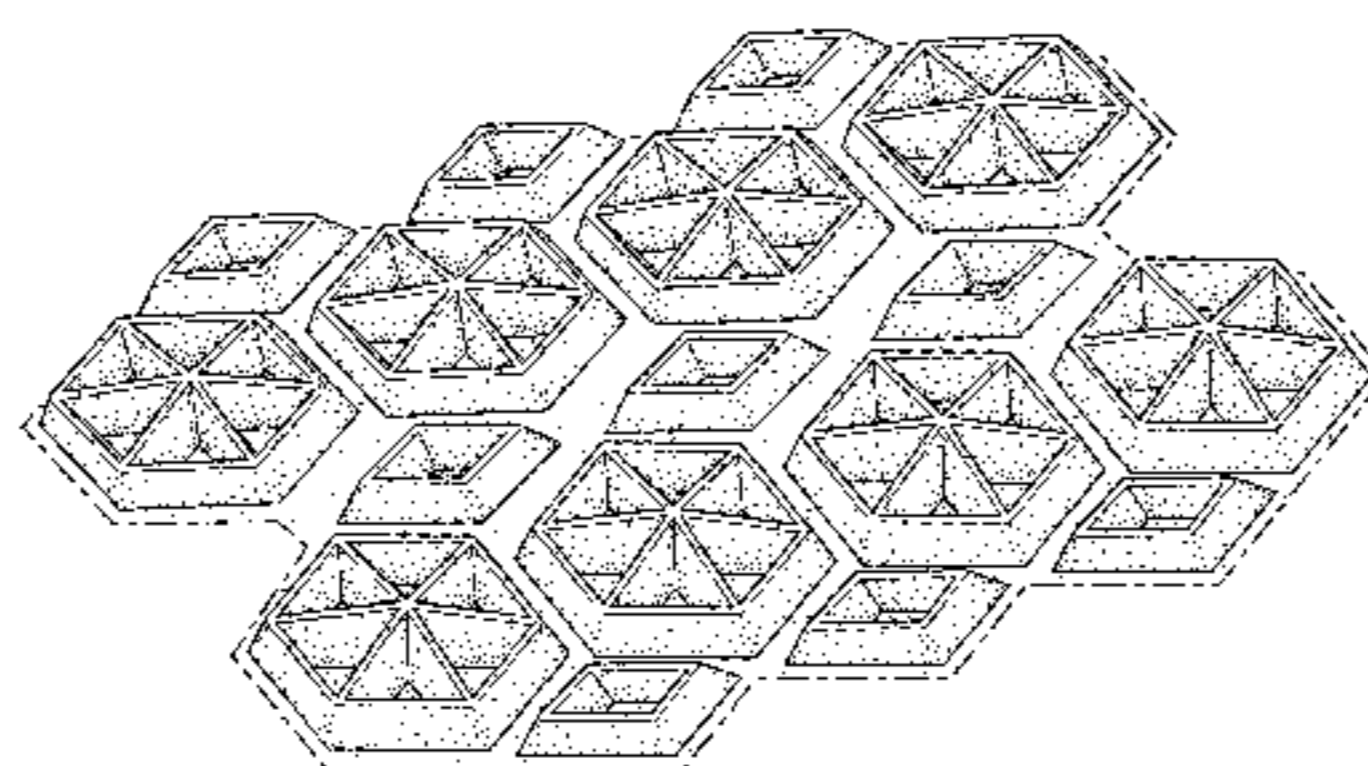
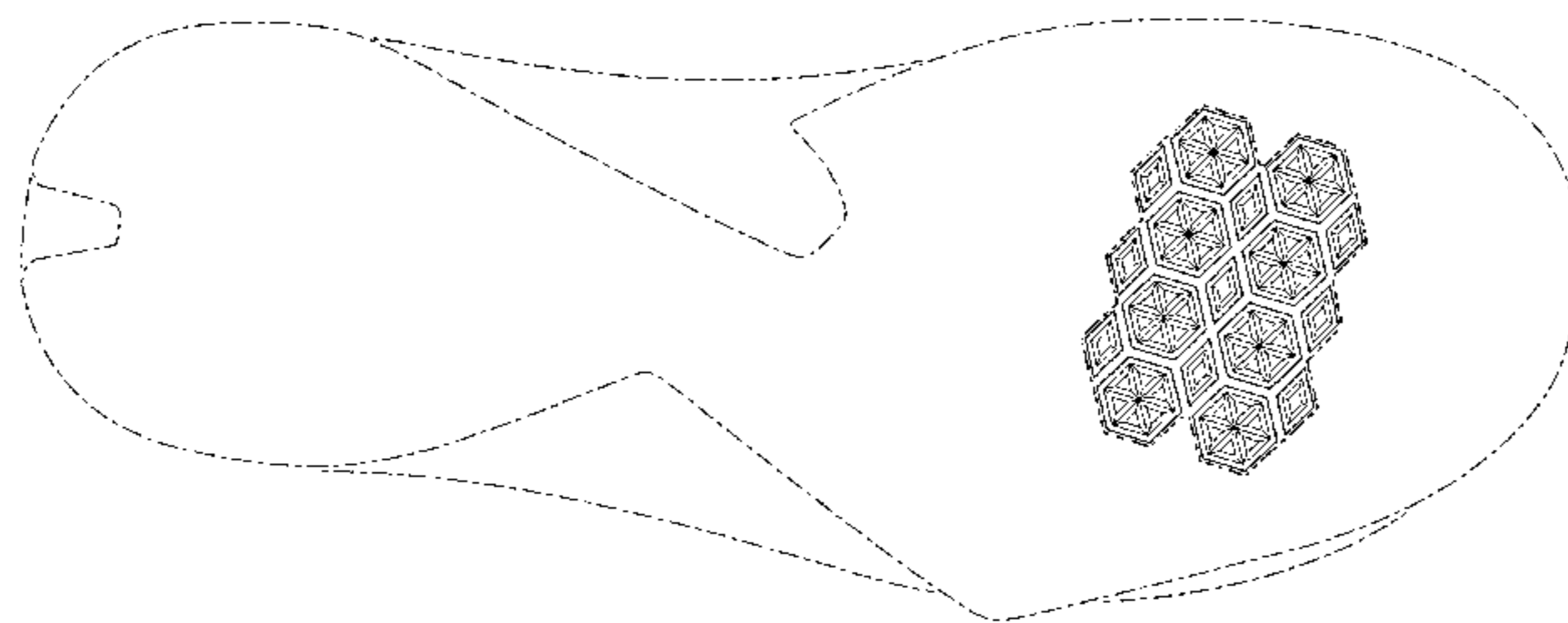
The ornamental design for a shoe outsole, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a shoe outsole showing my new design;  
FIG. 2 is a plan view thereof;  
FIG. 3 is a rear perspective view thereof;  
FIG. 4 is an enlarged view of the claimed region in FIG. 1 shown in isolation and with surface shading included;  
FIG. 5 is an enlarged view of the claimed region in FIG. 2 shown in isolation and with surface shading included; and,  
FIG. 6 is an enlarged view of the claimed region in FIG. 3 shown in isolation and with surface shading included.

The broken line immediately adjacent to and encircling the shaded area represents an unclaimed boundaries of the design. The broken lines showing the remainder of the shoe are for environmental purposes only and form no part of the claimed design.

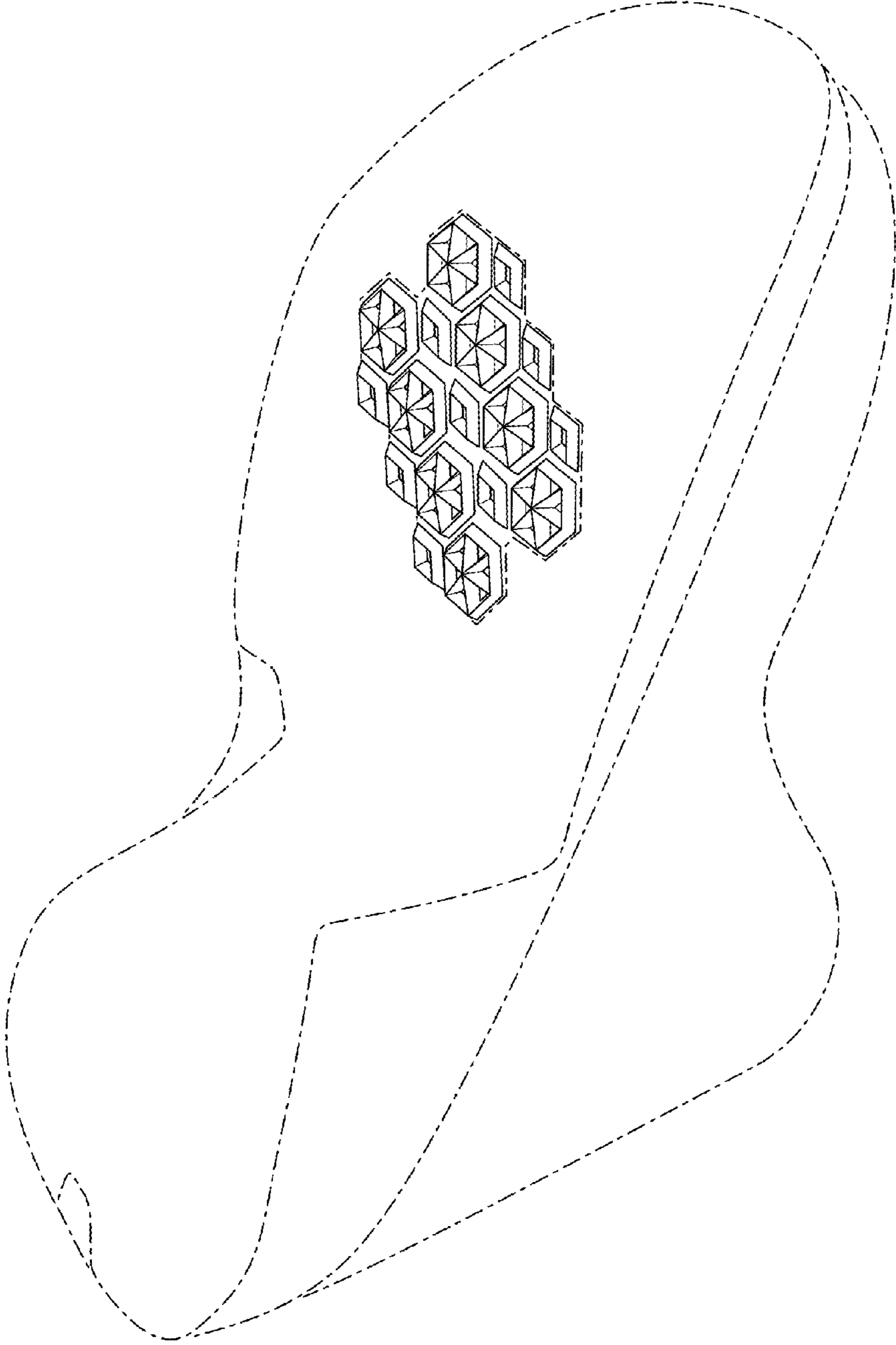

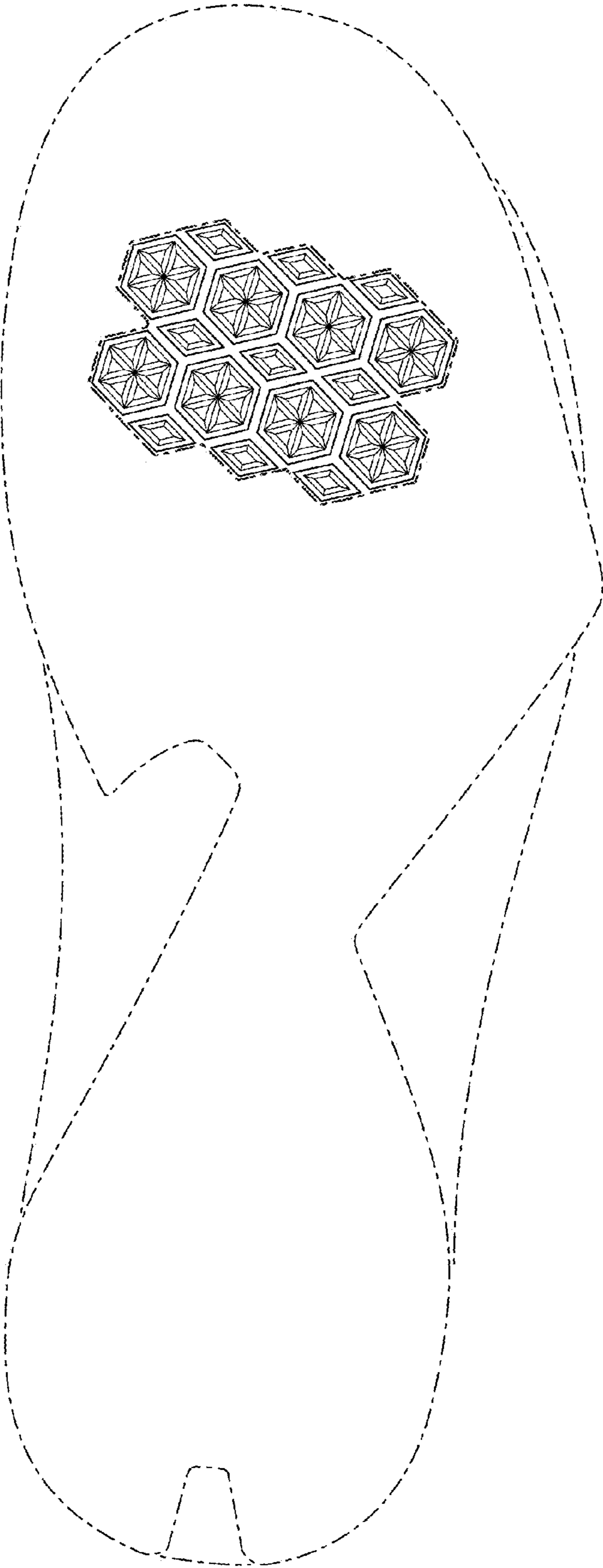

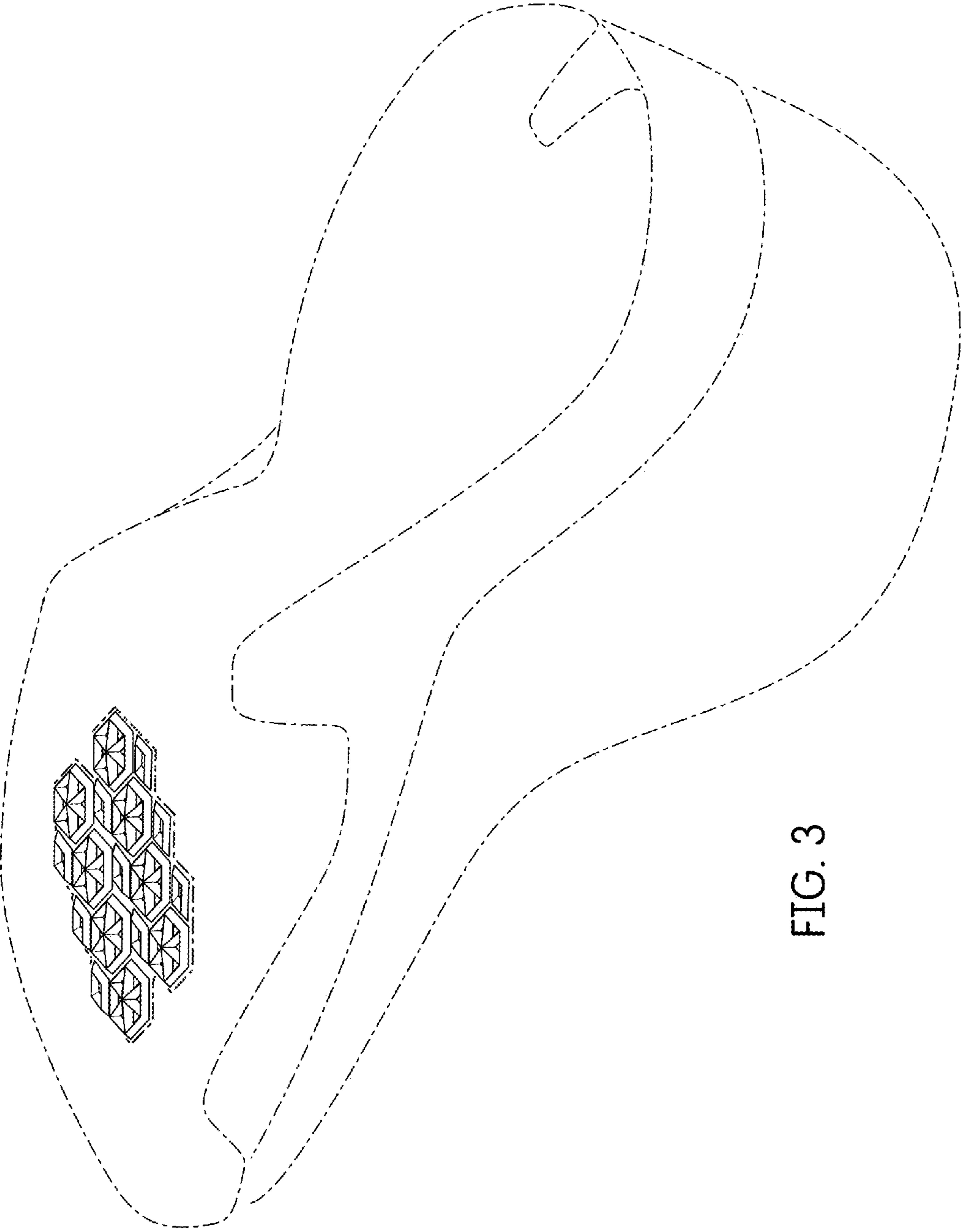

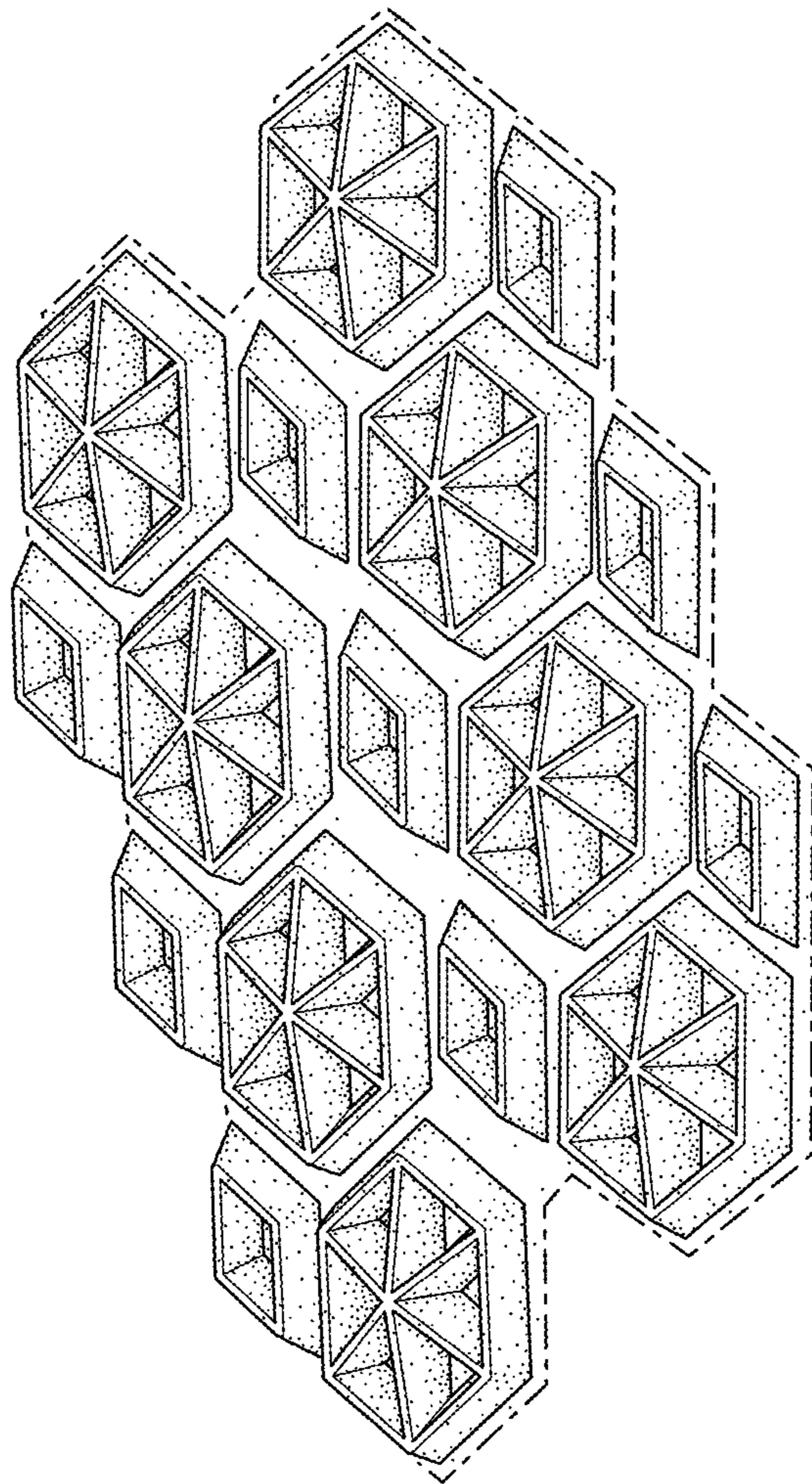

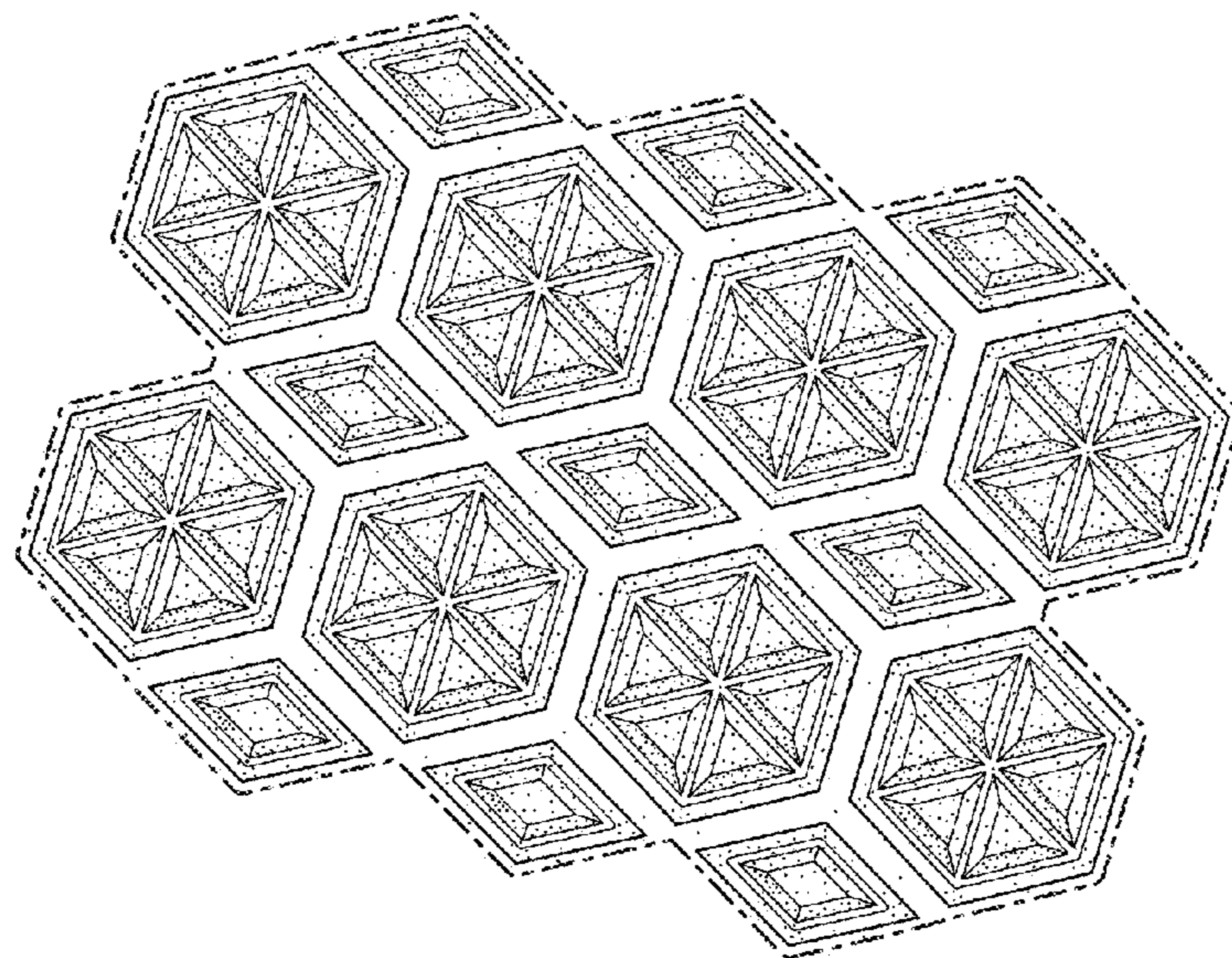

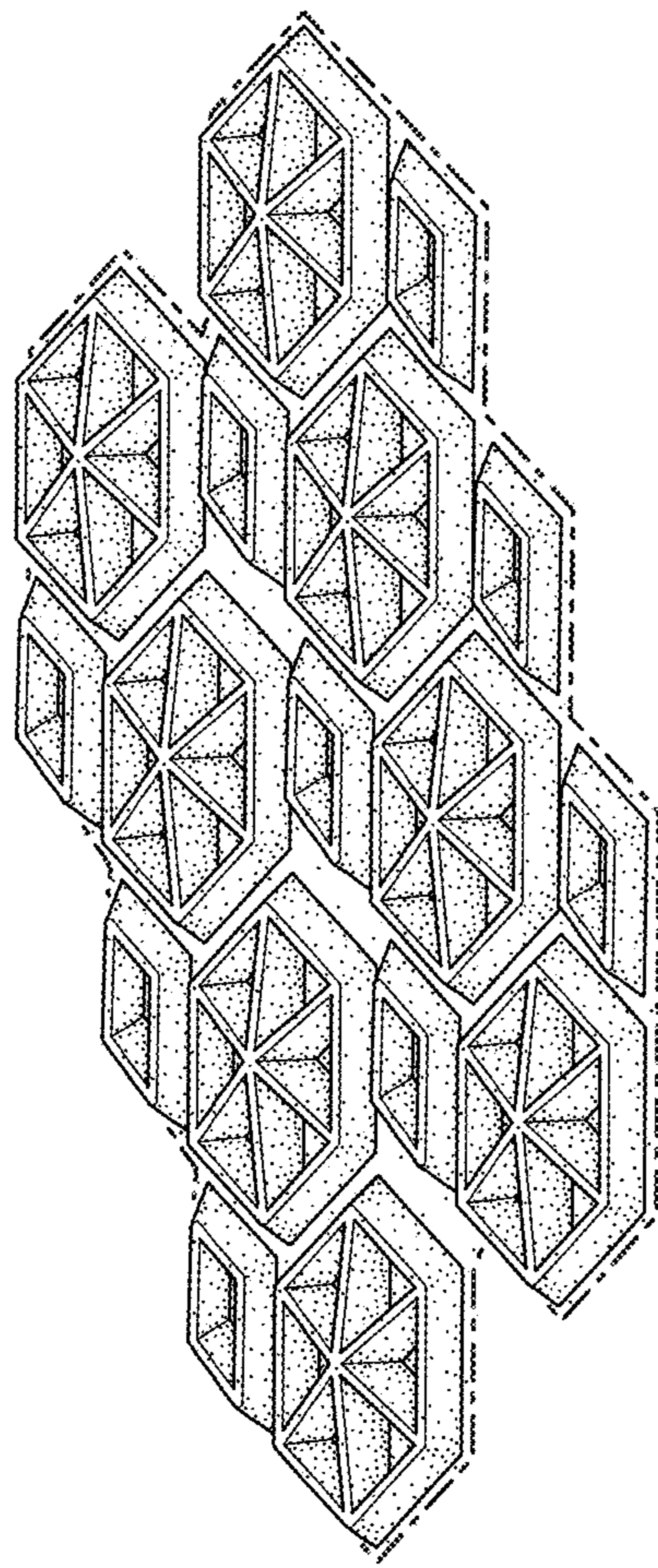
