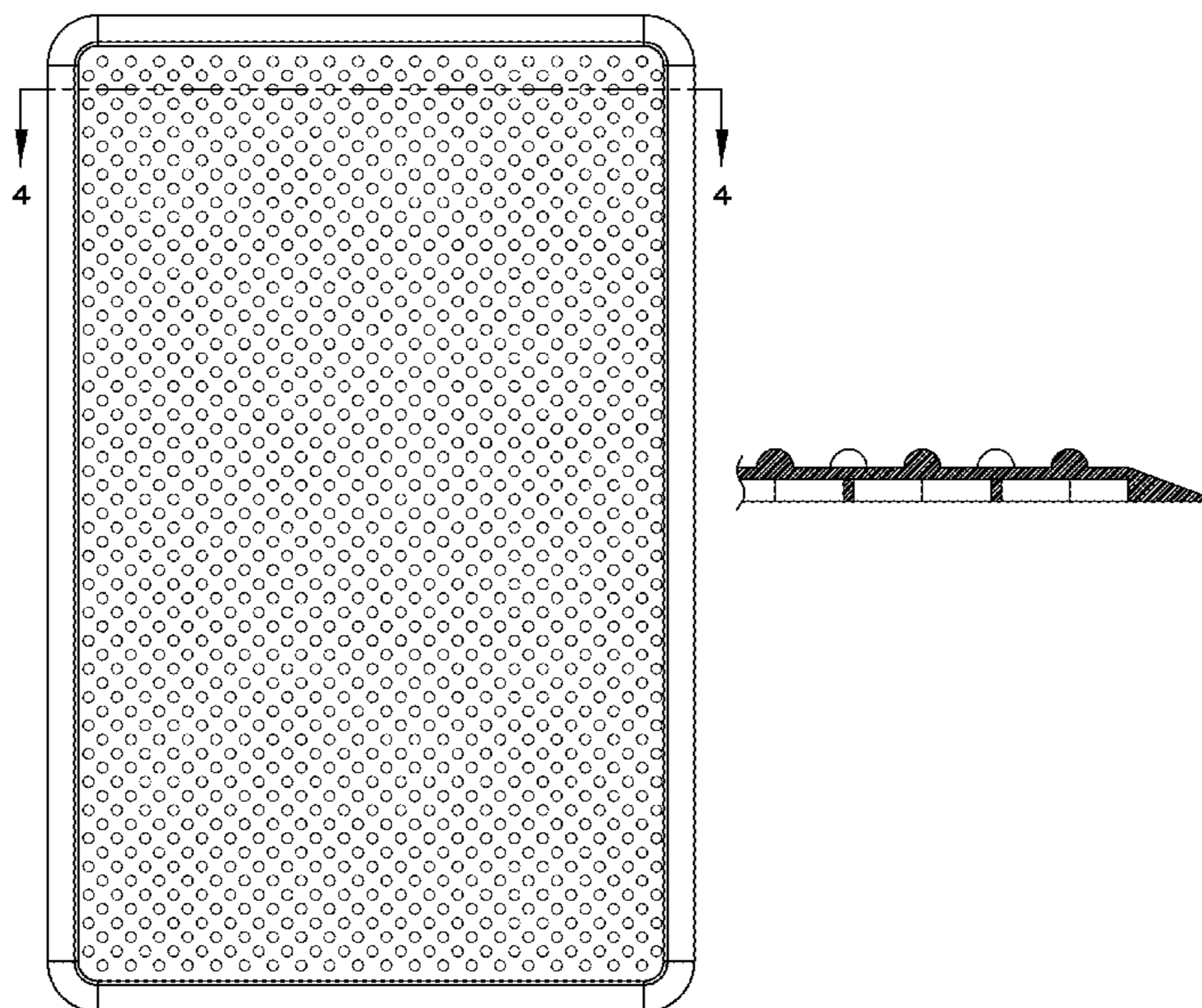

(57) **CLAIM**  
We claim the ornamental design for a molded anti-fatigue mat, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a molded anti-fatigue mat. FIG. 2 is a side elevation view taken from the top of FIG. 1, the opposite side being a mirror image. FIG. 3 is a side elevation view taken from the right side of FIG. 1, the opposite side being a mirror image. FIG. 4 is a sectional view taken along line 4-4 of FIG. 1. FIG. 5 is an enlargement of that portion of FIG. 4 within circle 5. FIG. 6 is a bottom plan view of the molded anti-fatigue mat of FIG. 1; and, FIG. 7 is an enlarged sectional view taken along line 7-7 of FIG. 6.

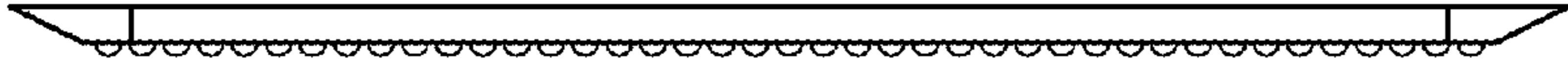

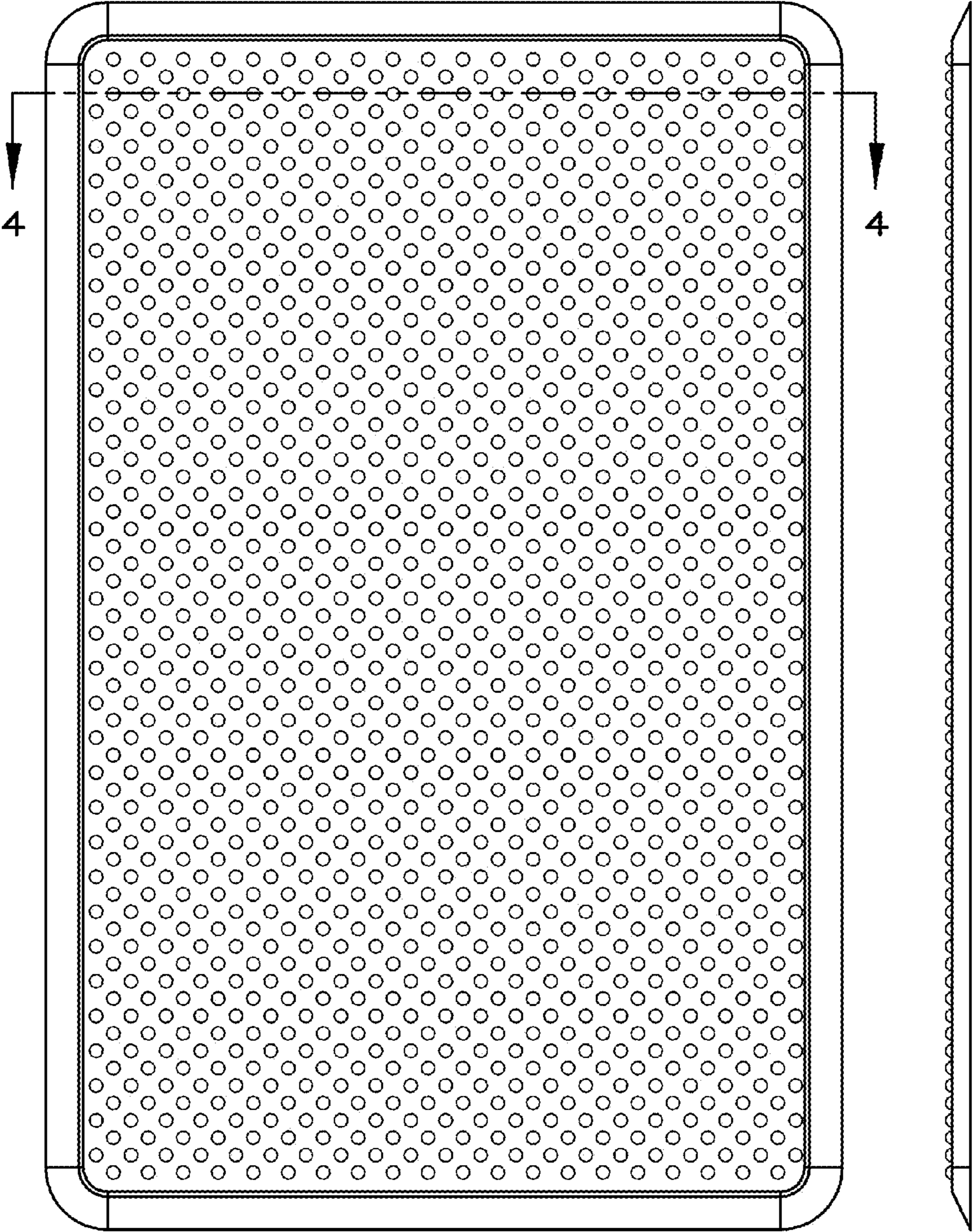

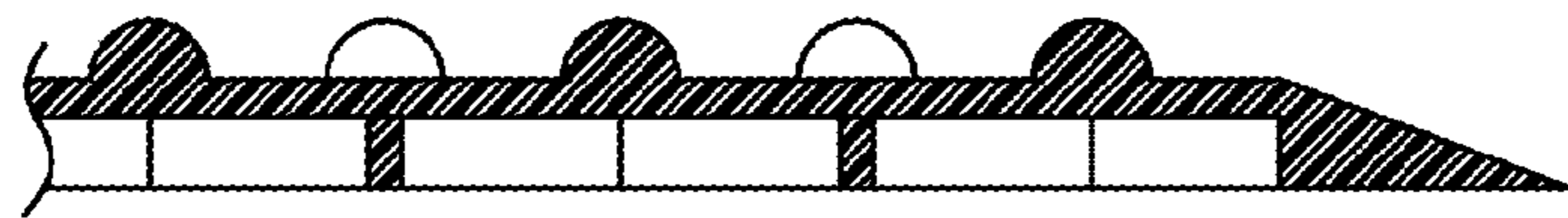

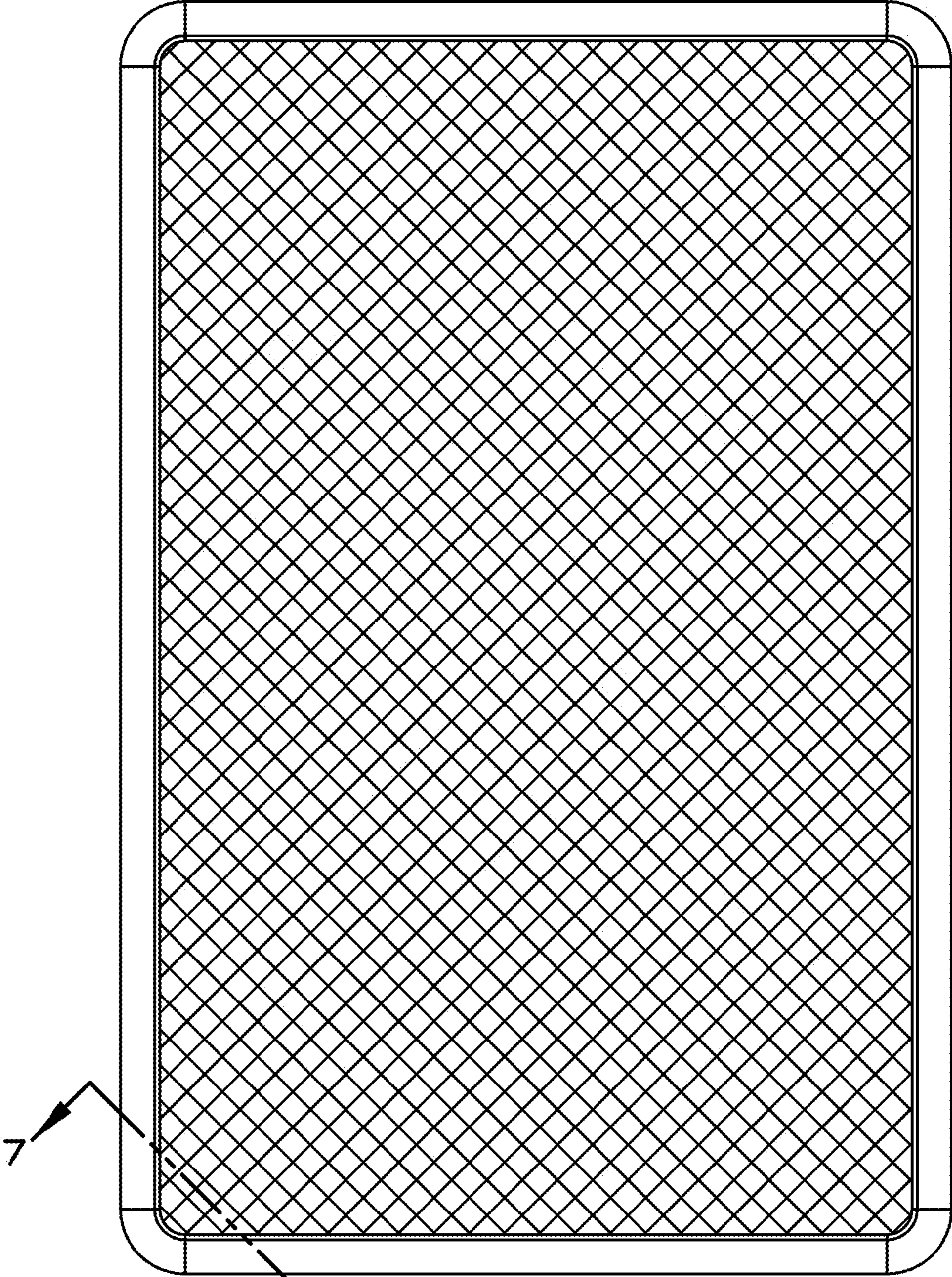

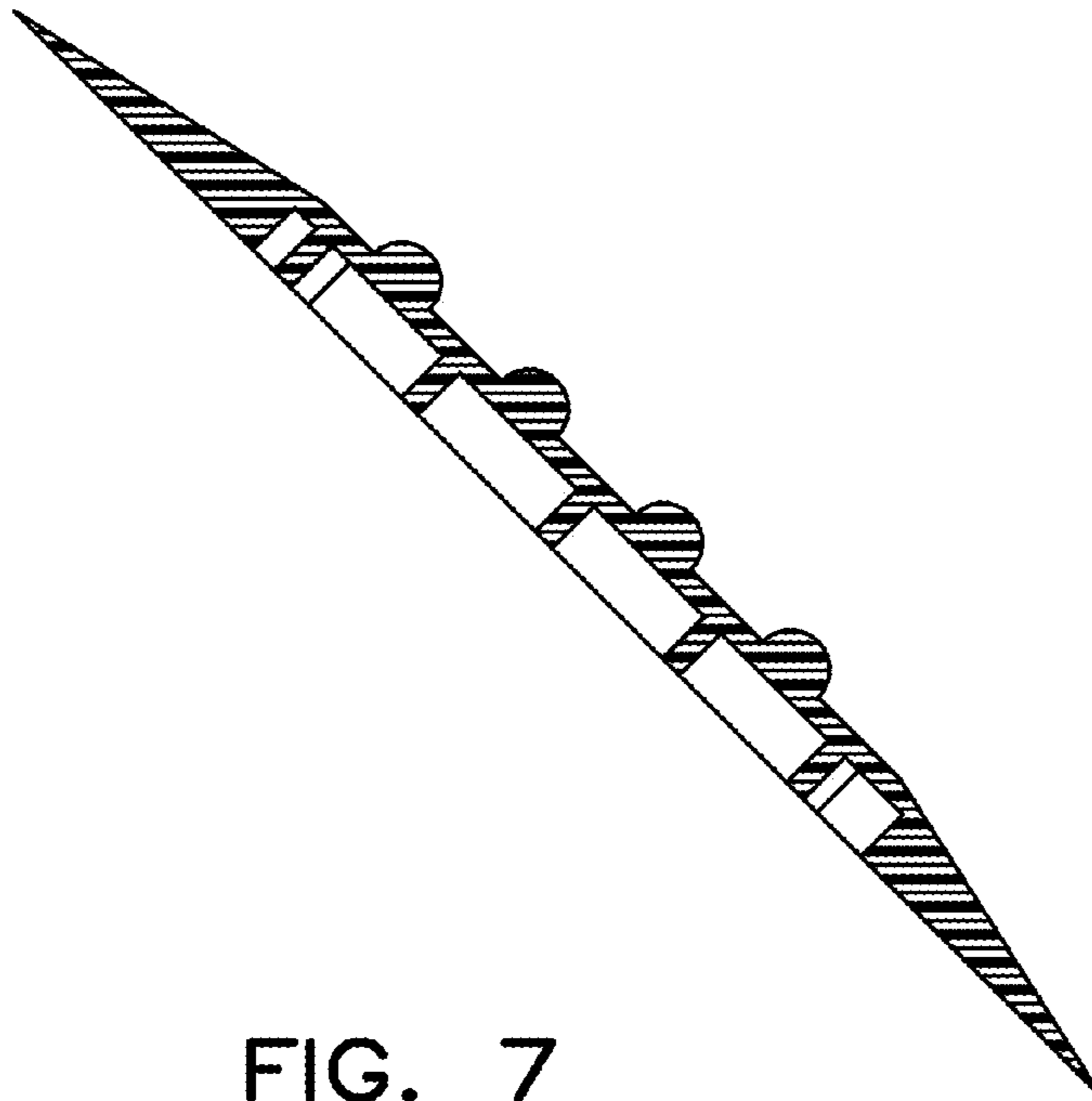
