The ornamental design for a postural system, as shown and described.

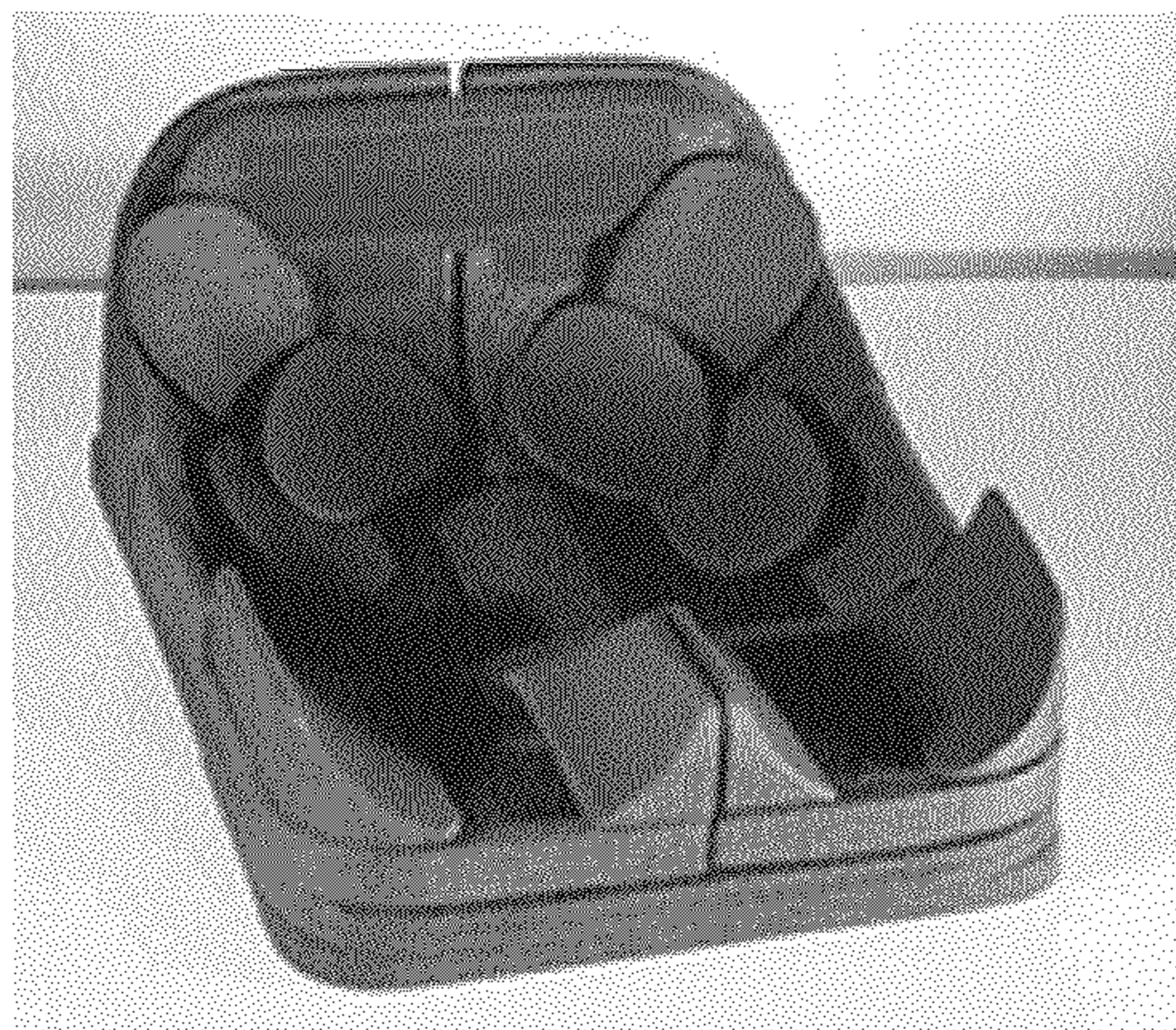
**DESCRIPTION**

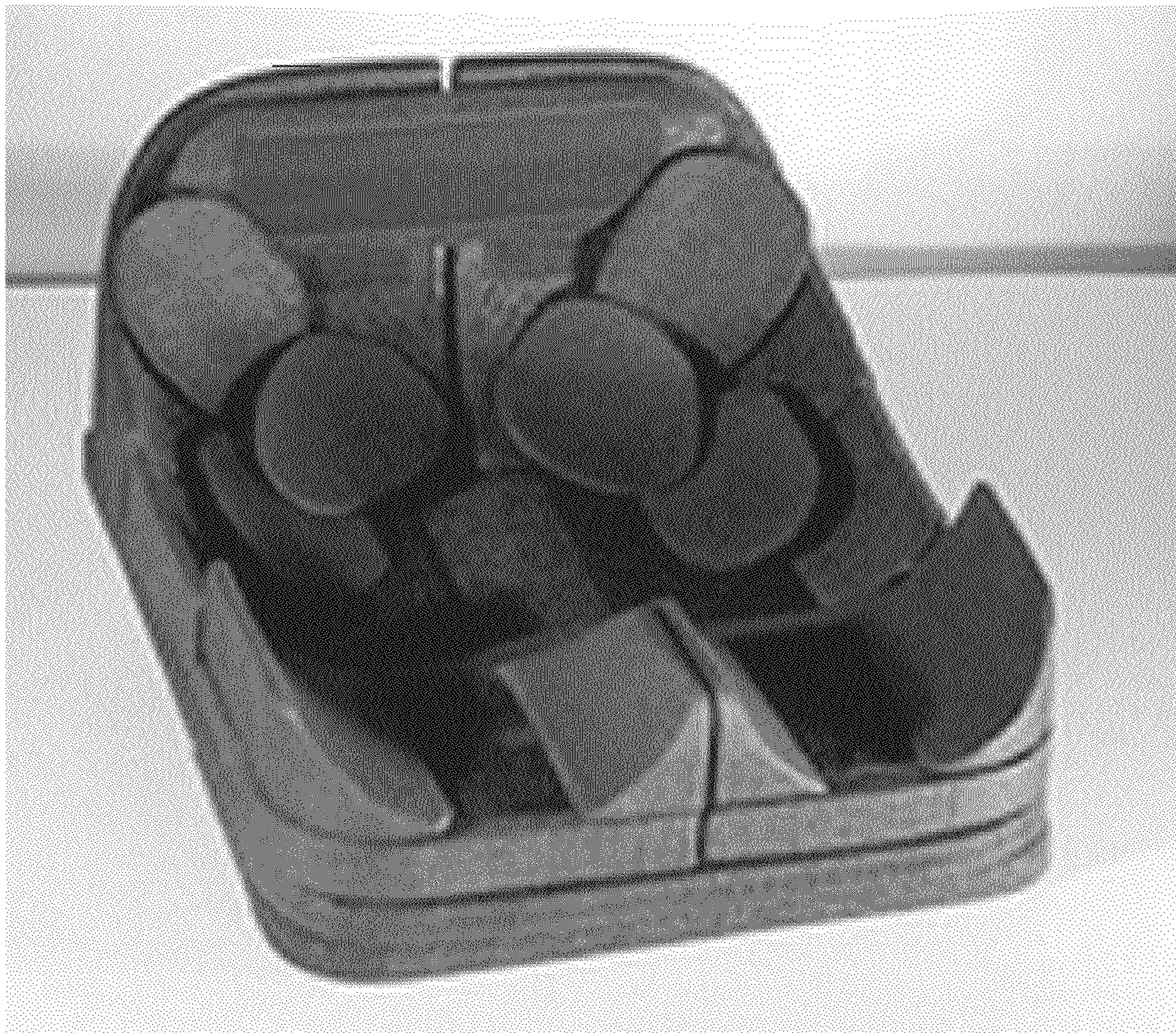

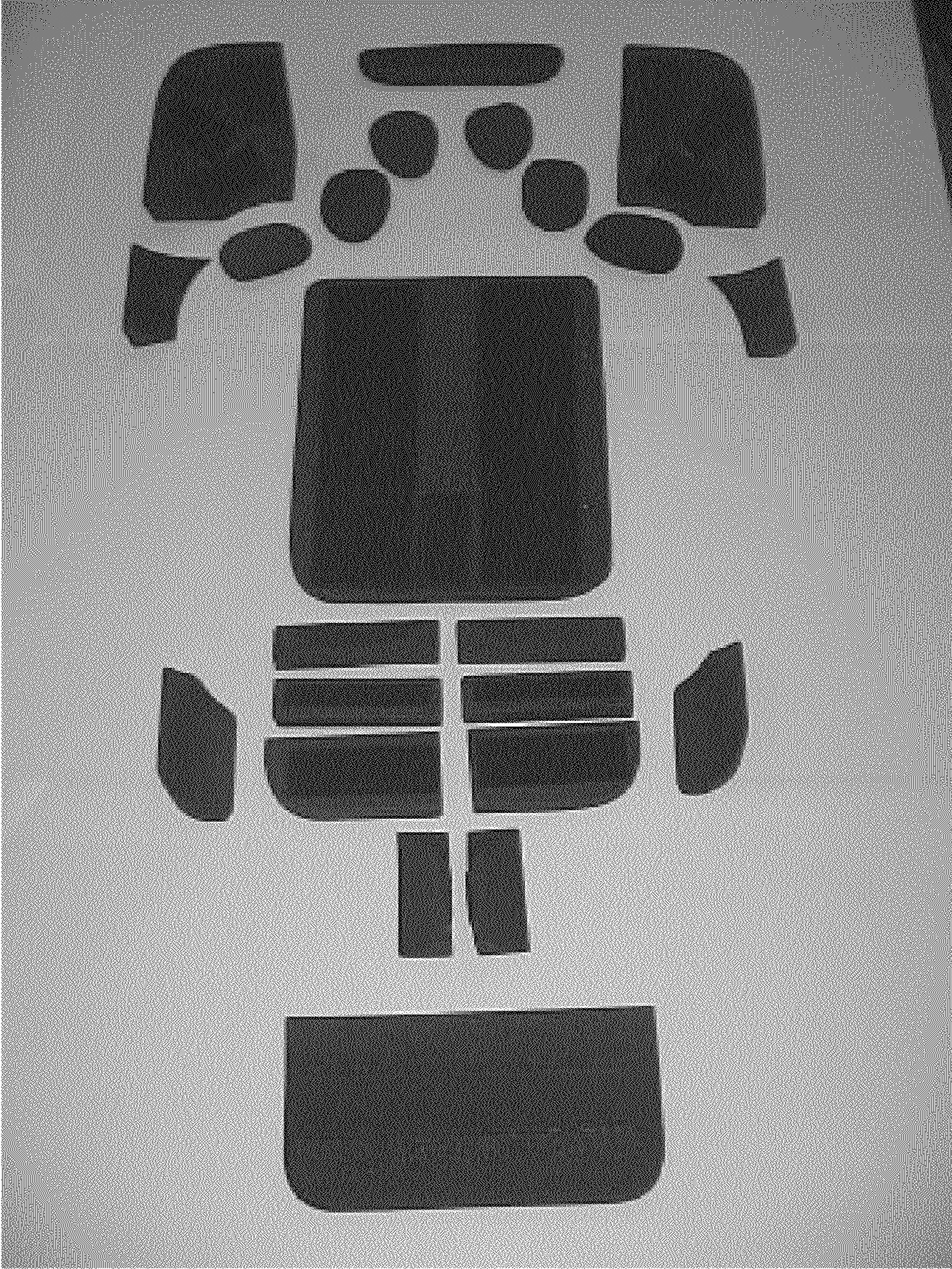
