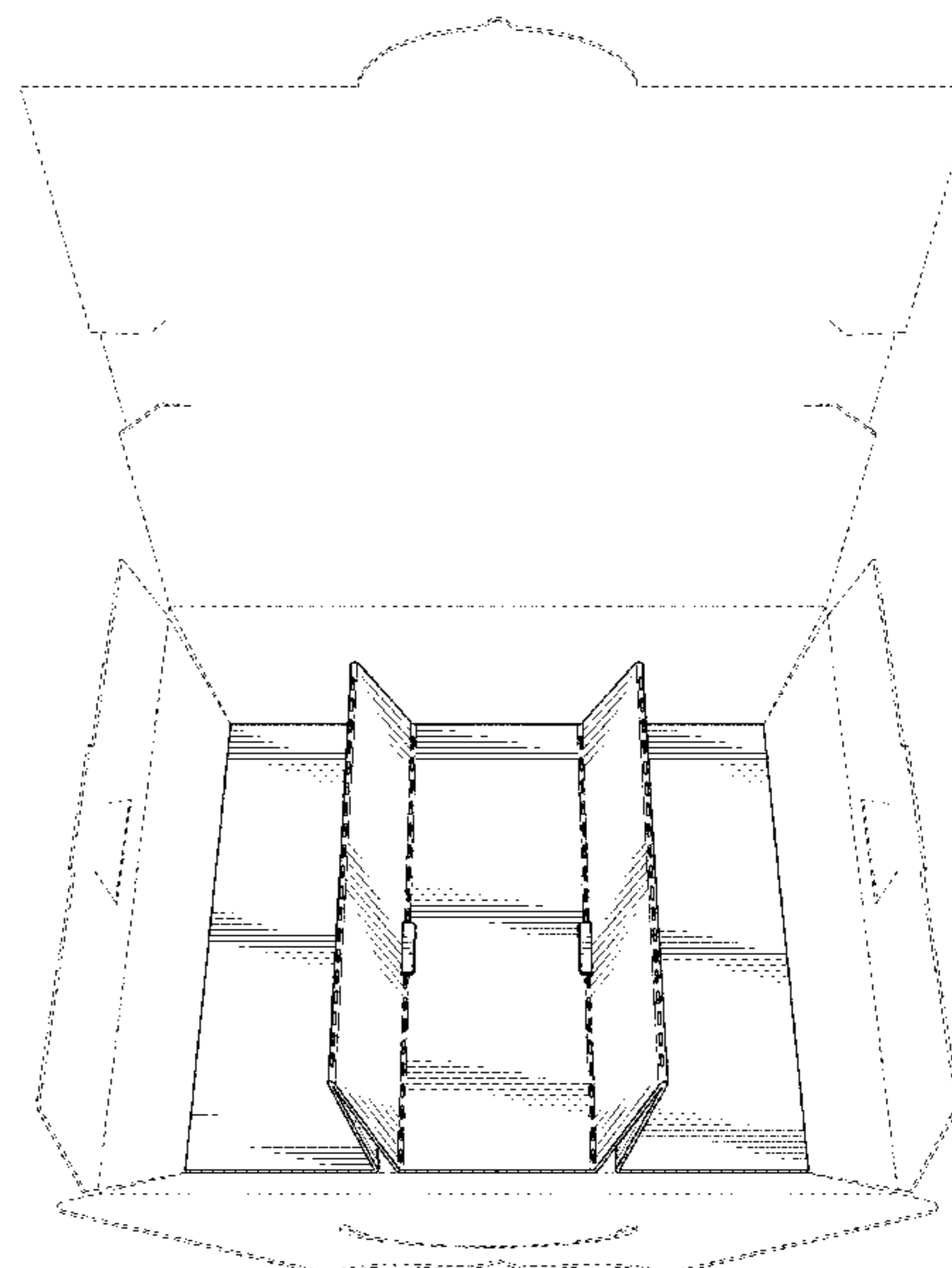
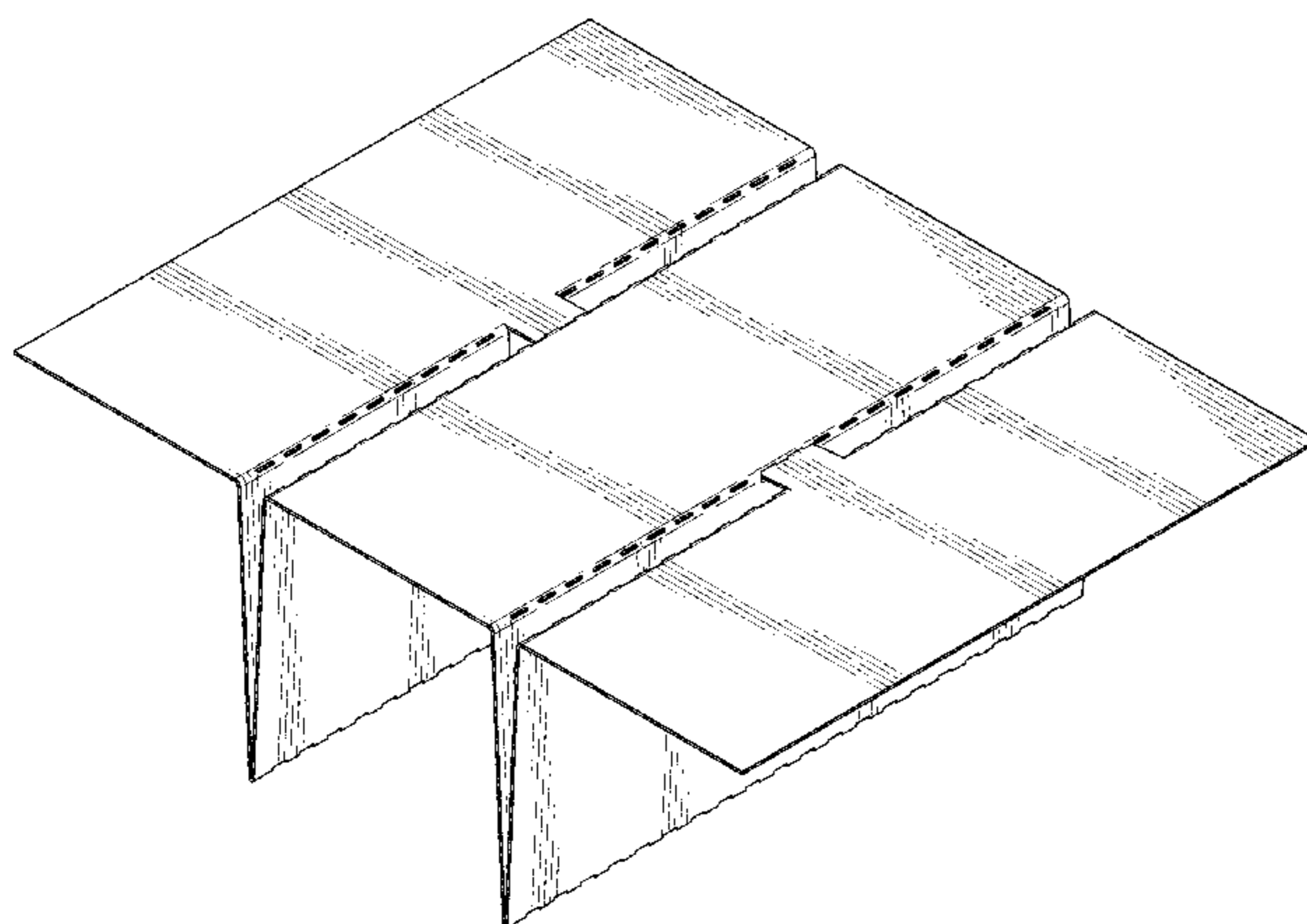
The ornamental design for a food box insert, as shown and described.

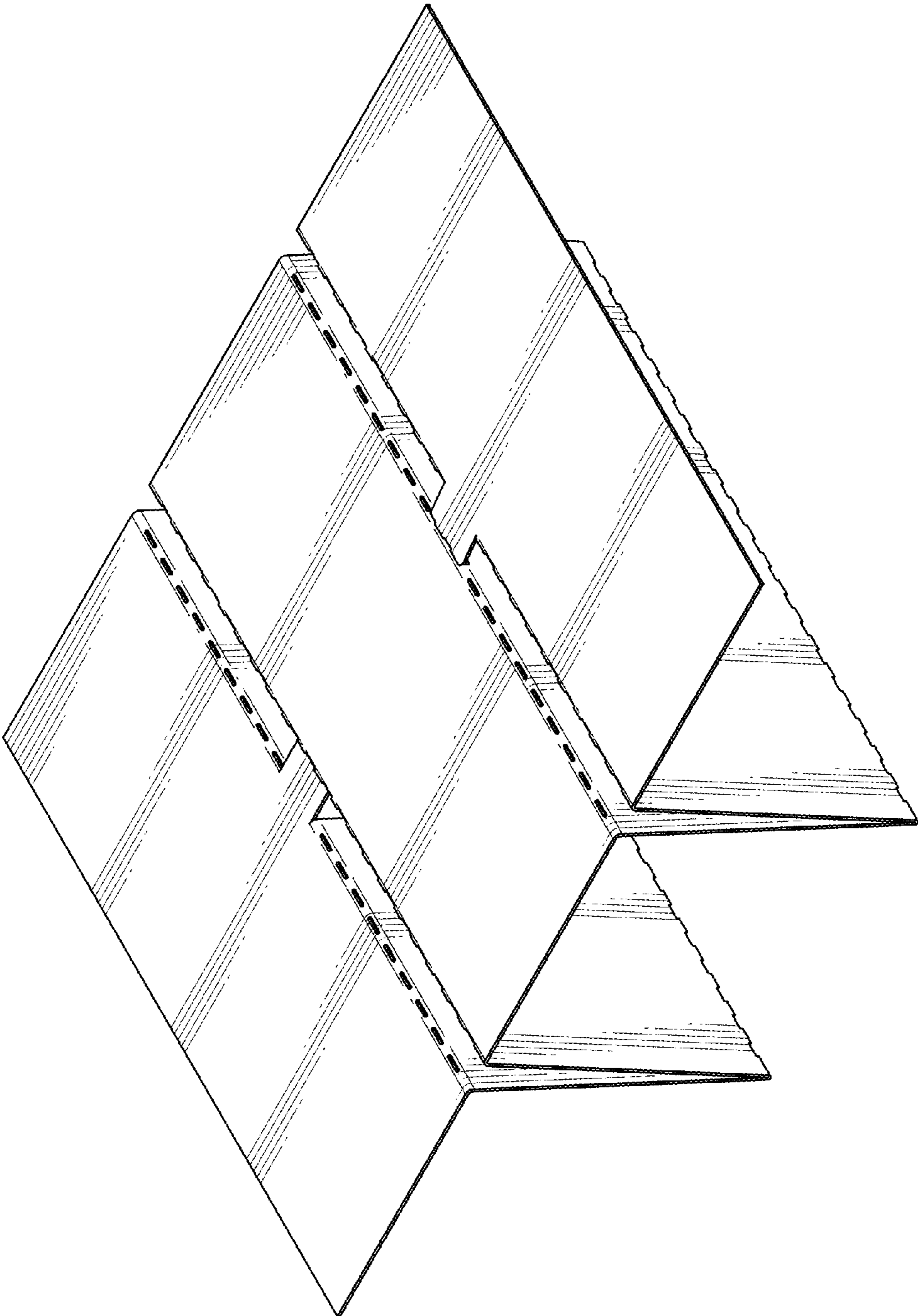

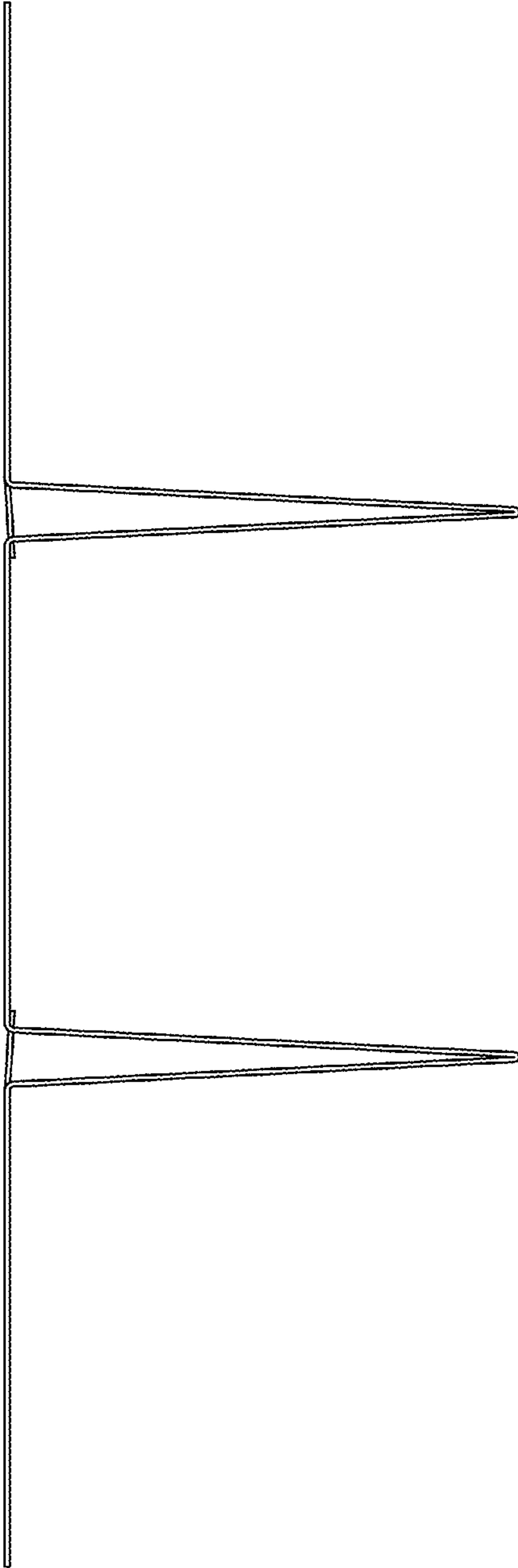

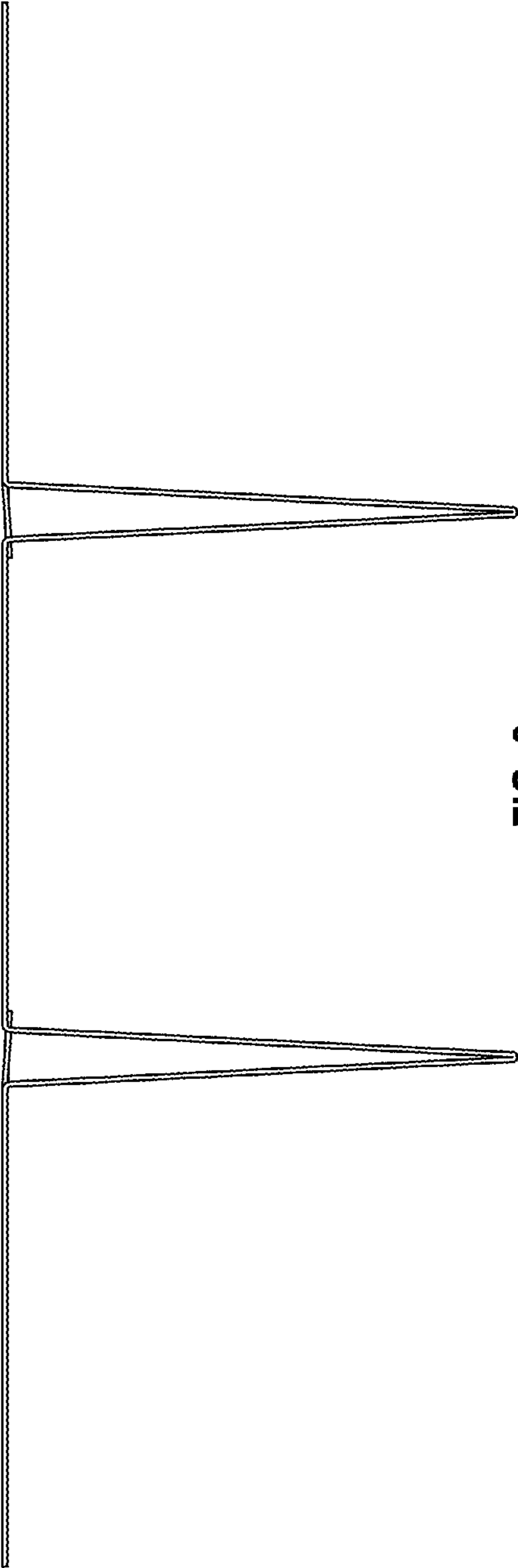

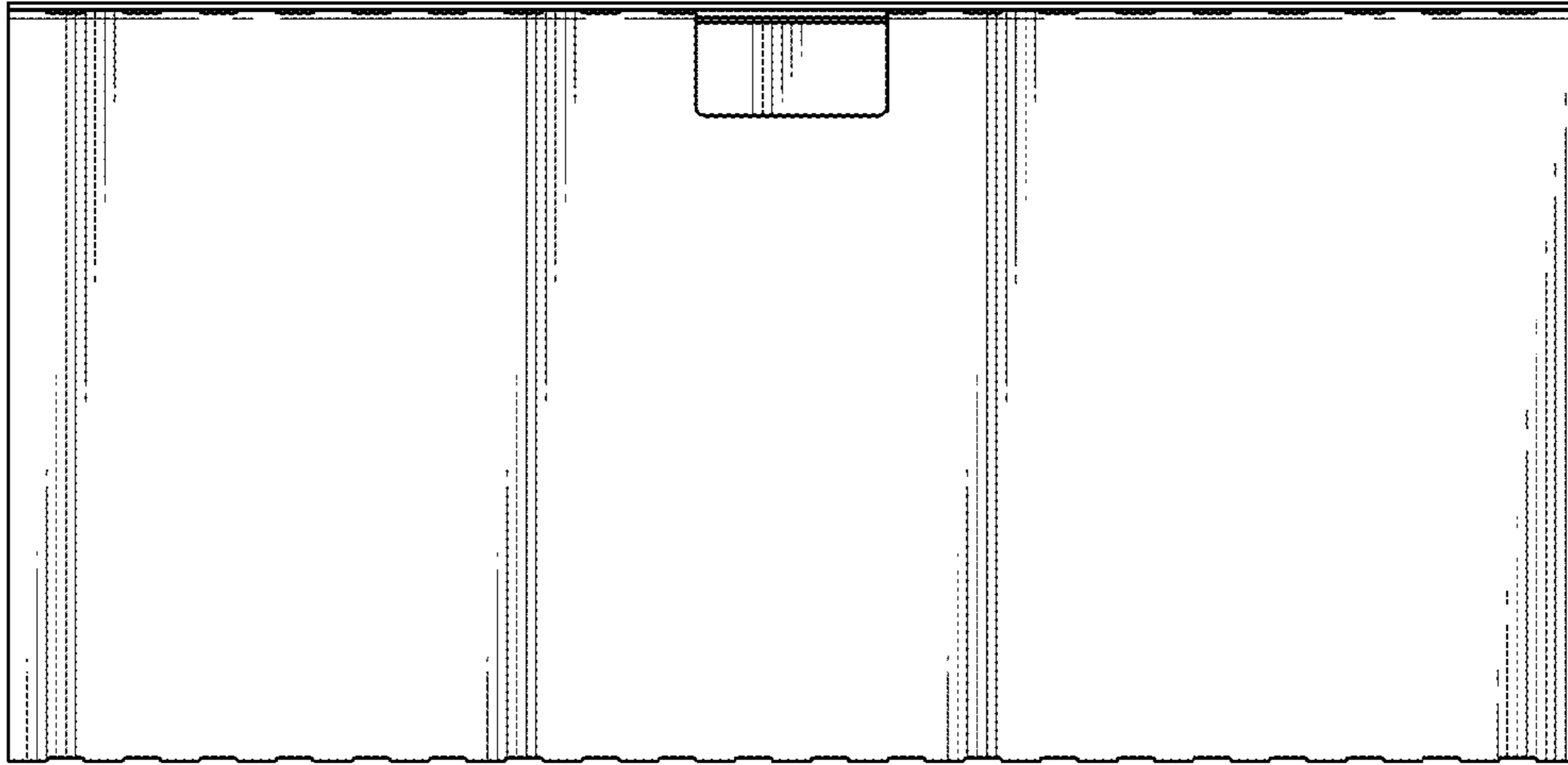

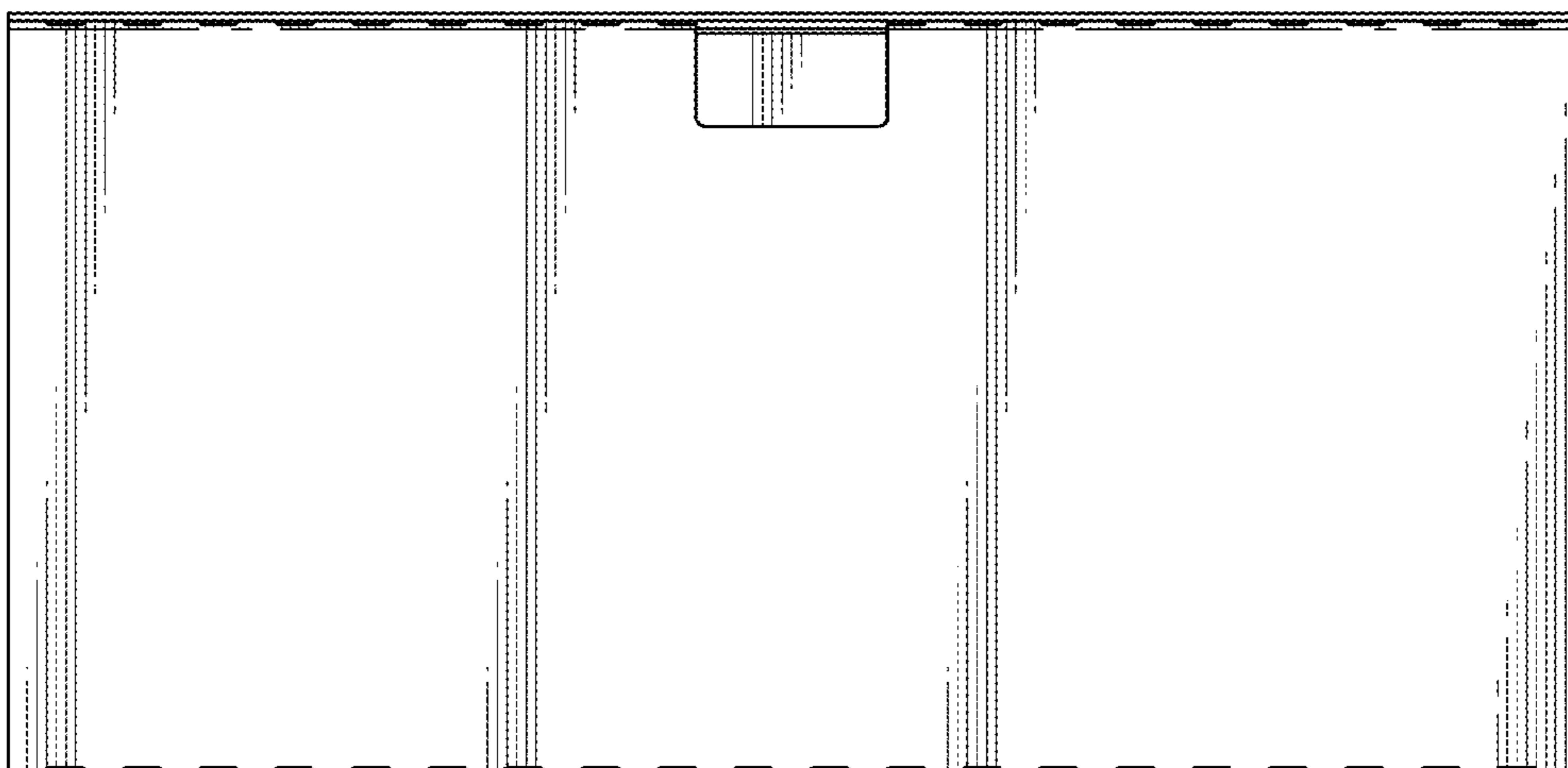

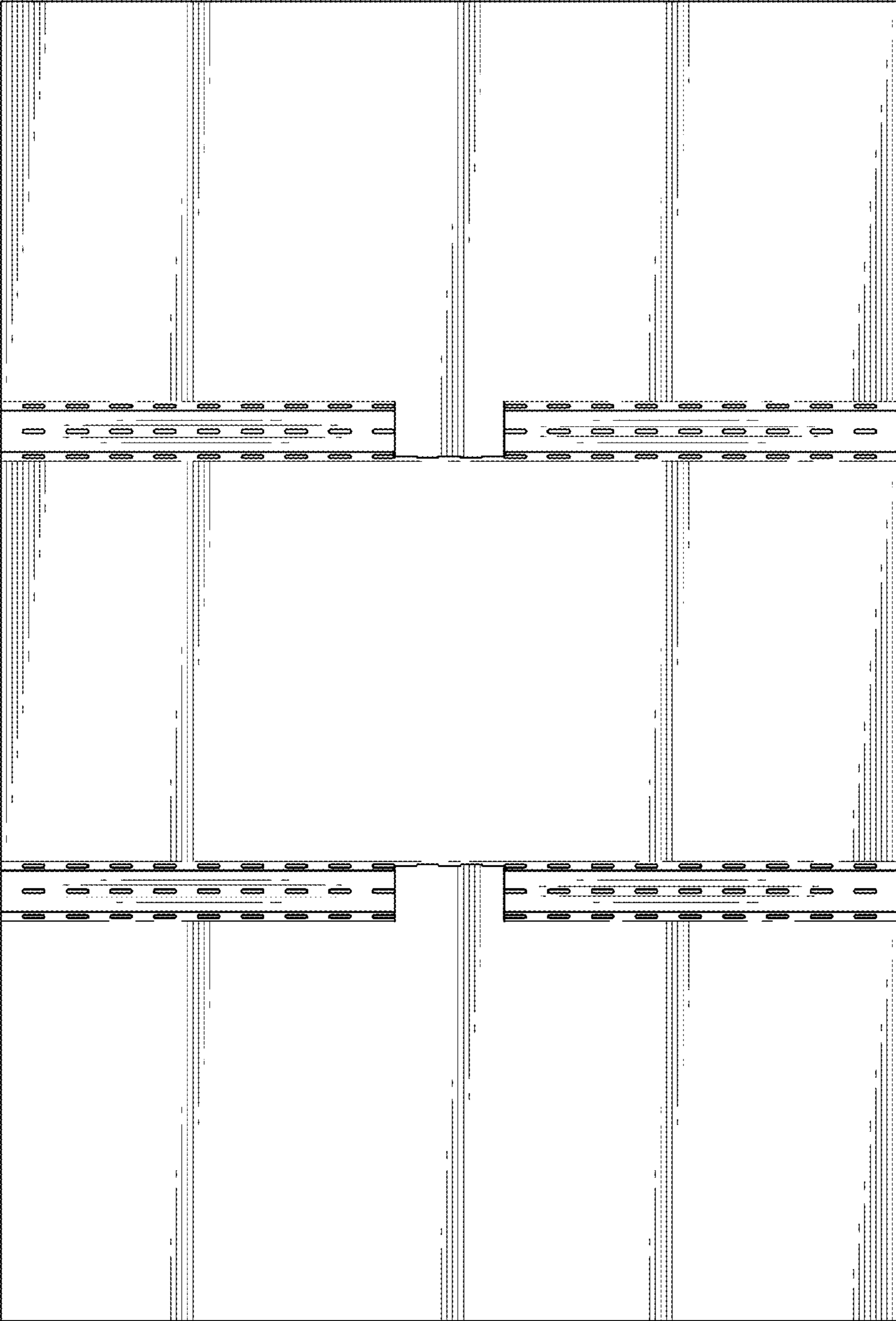

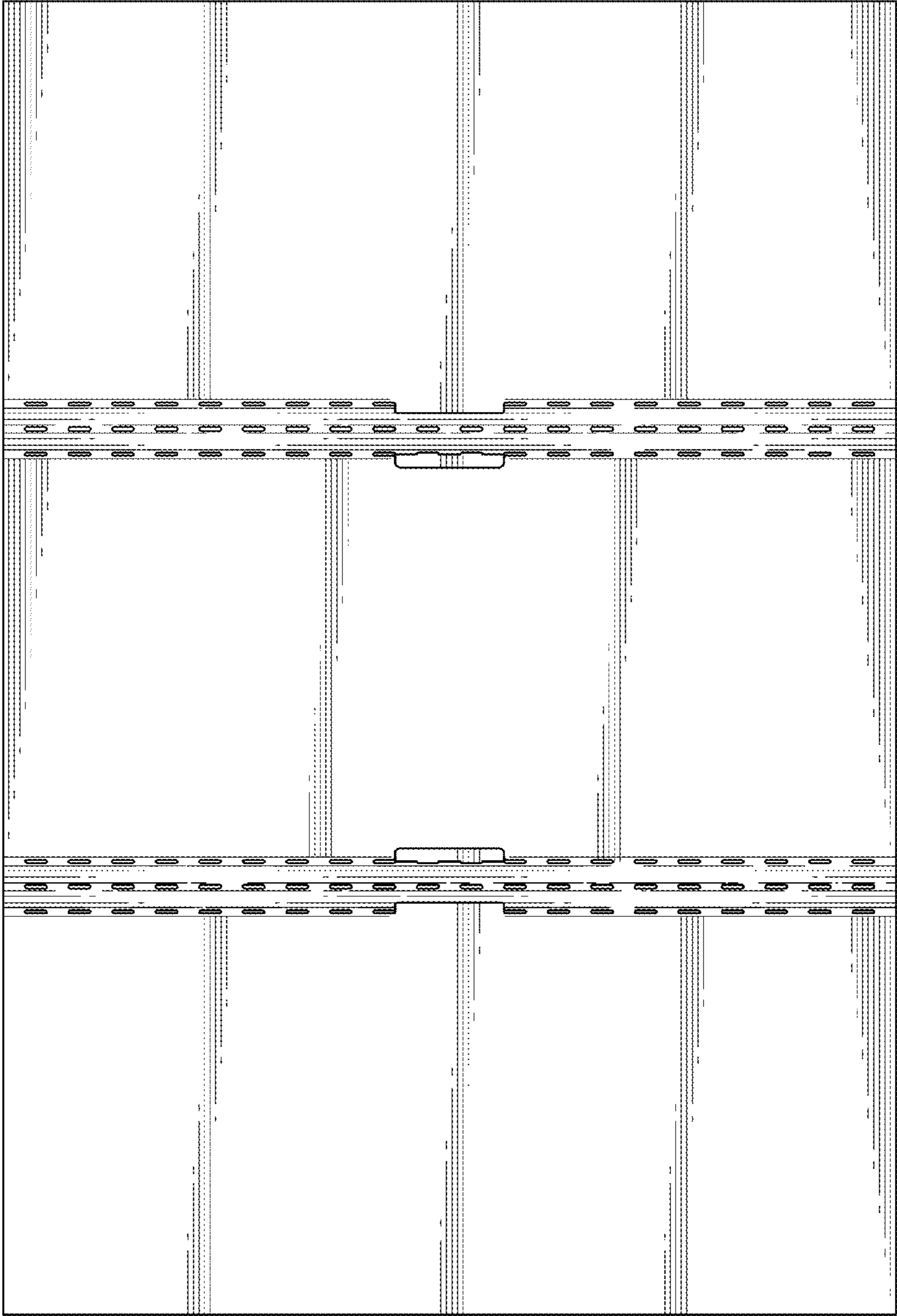

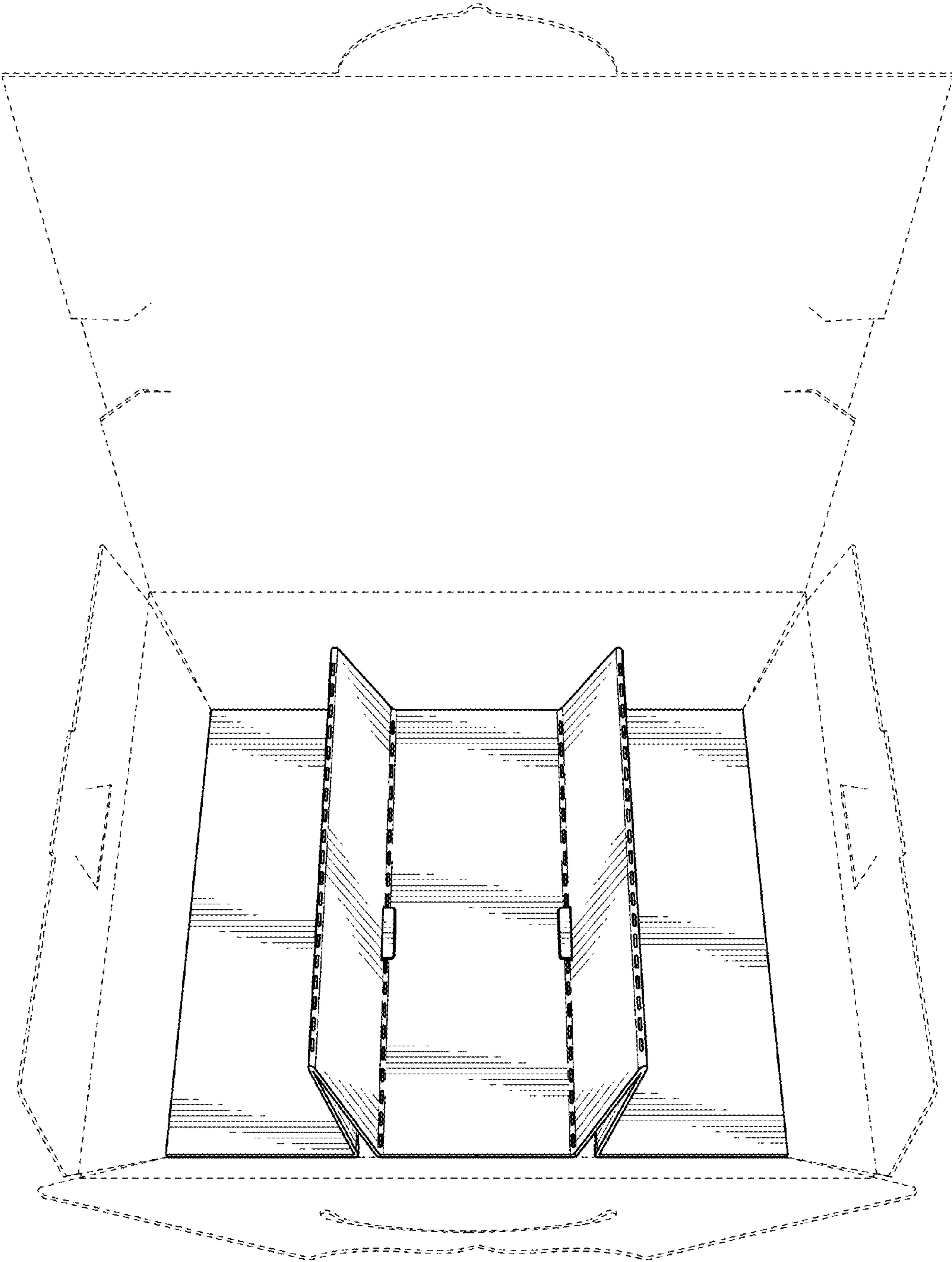
